The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a top front right perspective view of a shoe showing my new design;

FIG. 2 is a top rear left perspective view thereof;

FIG. 4 is a bottom rear right perspective view thereof;

FIG. 5 is a top view thereof;

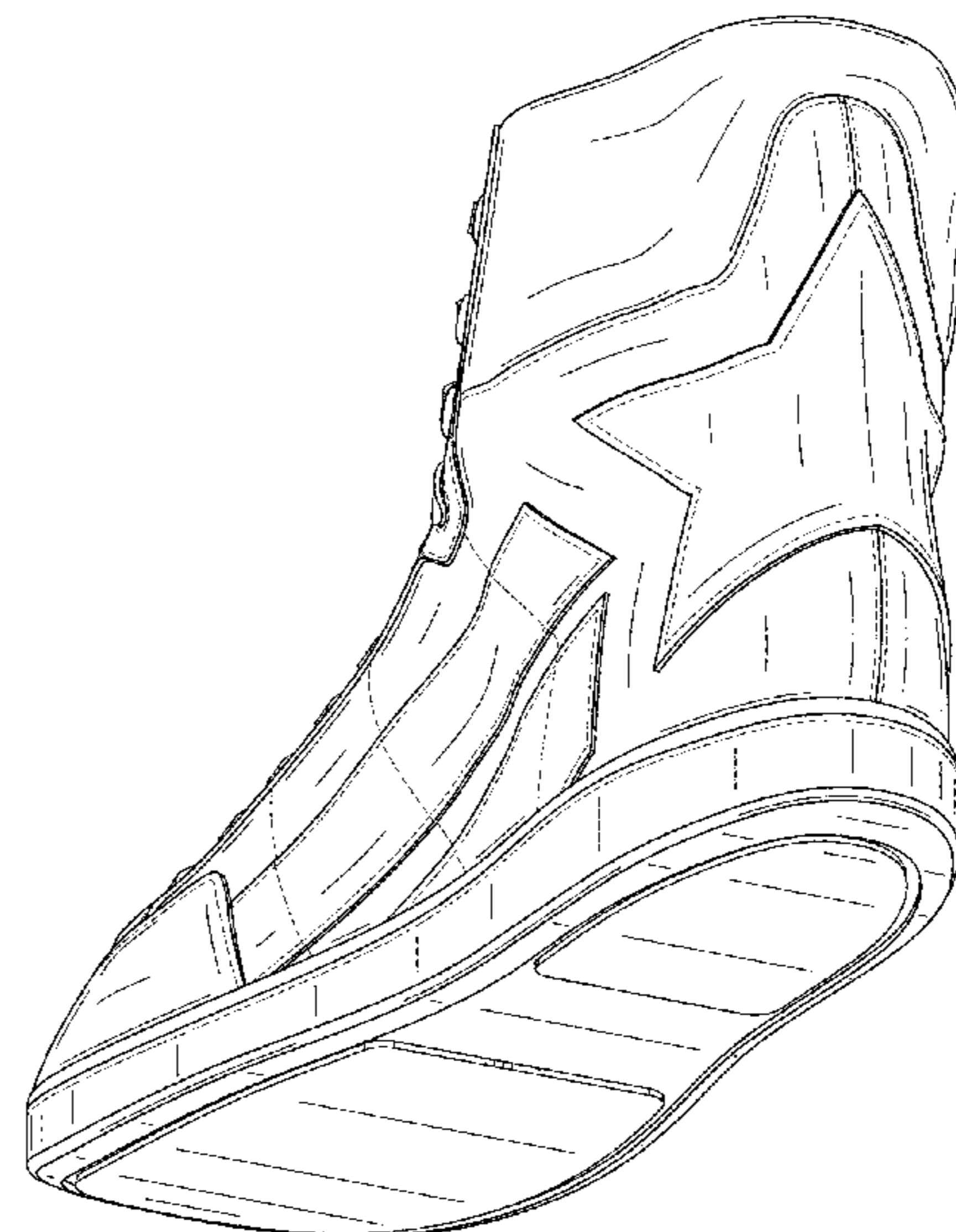

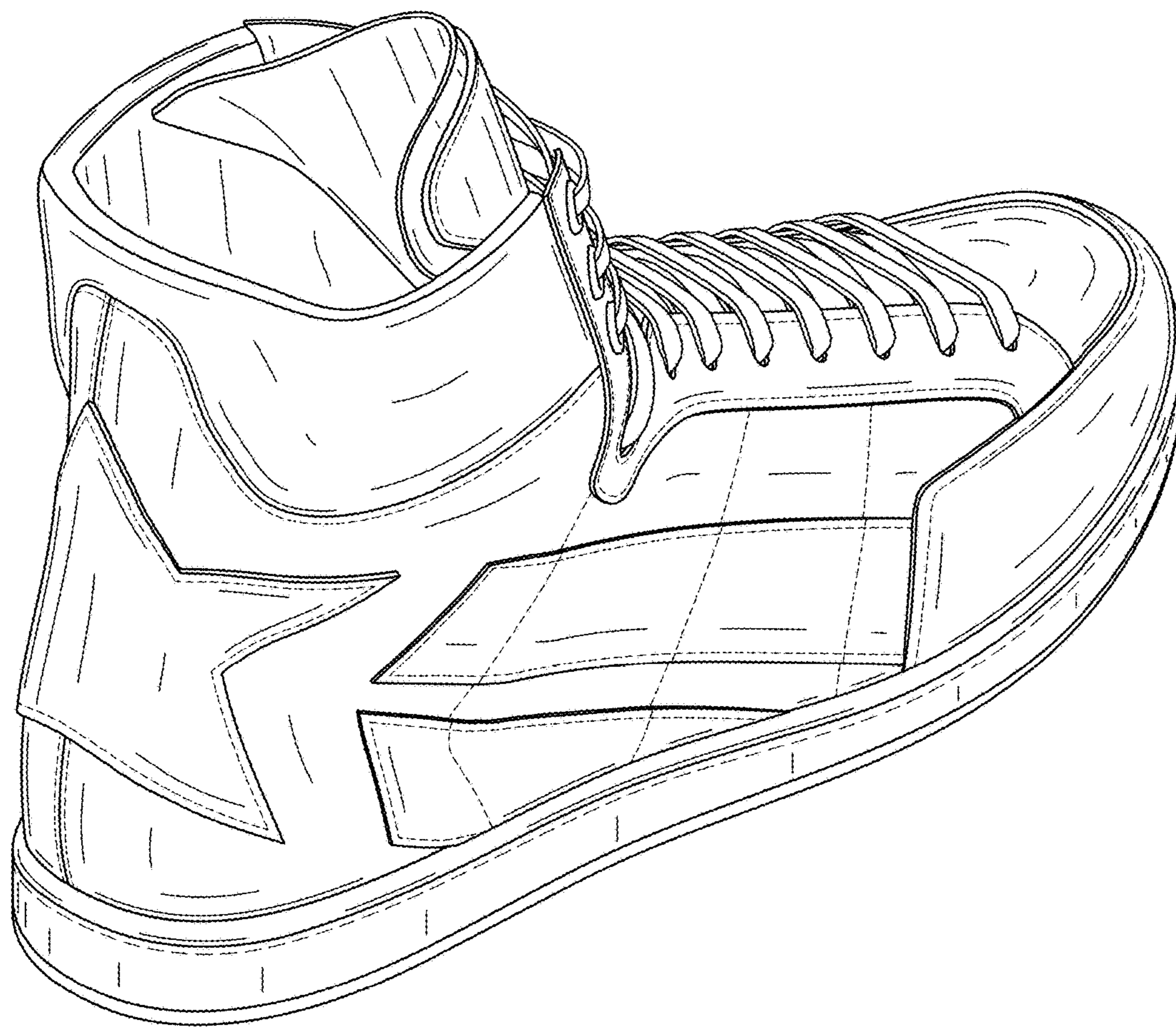

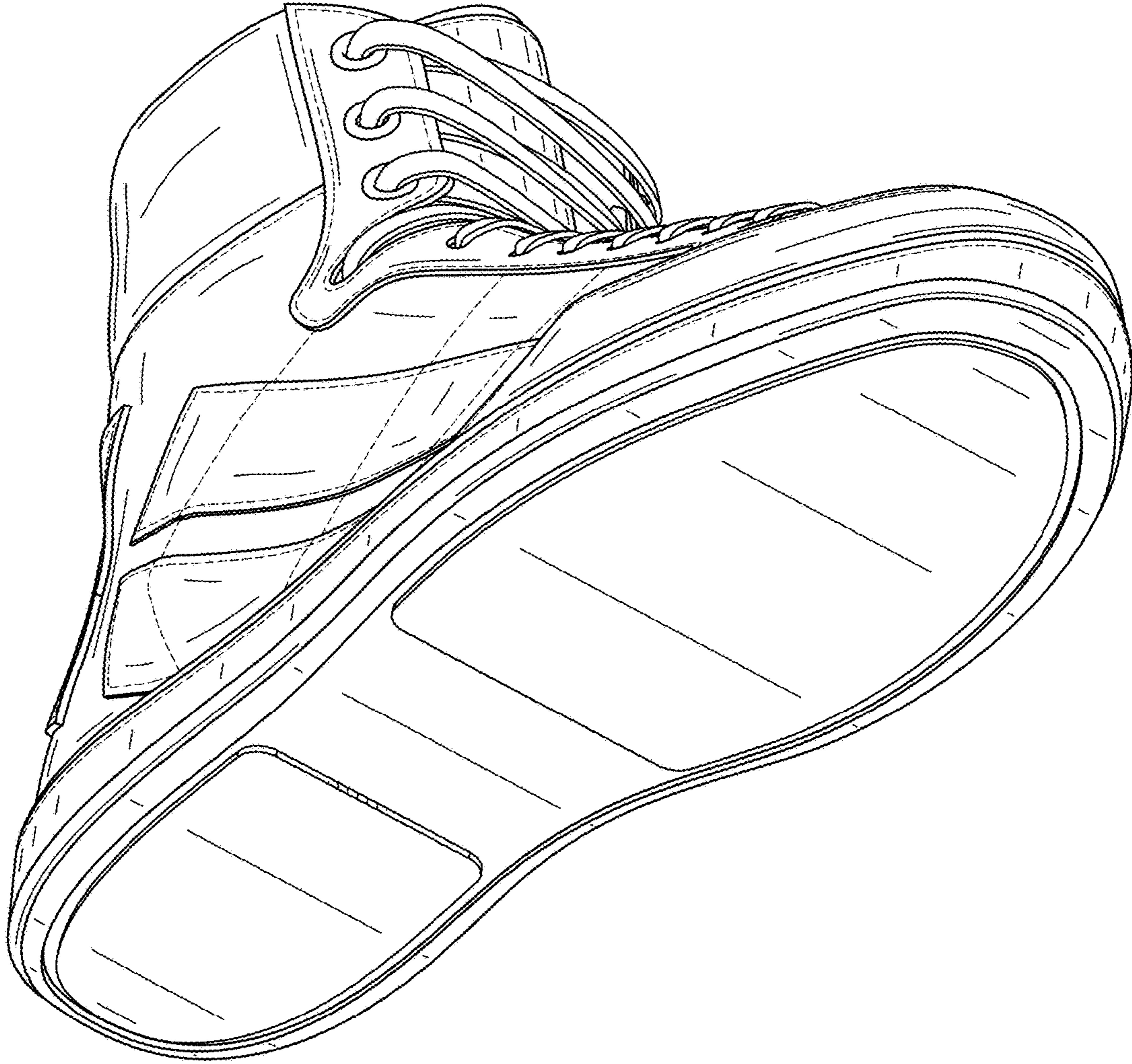

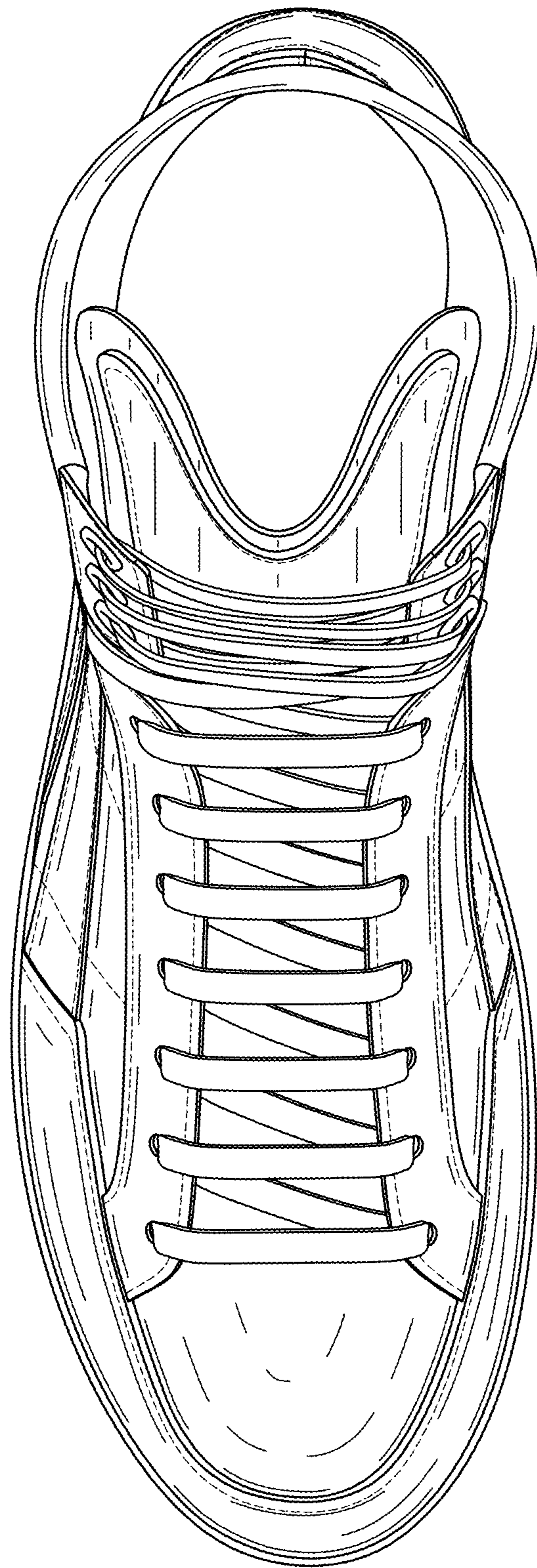

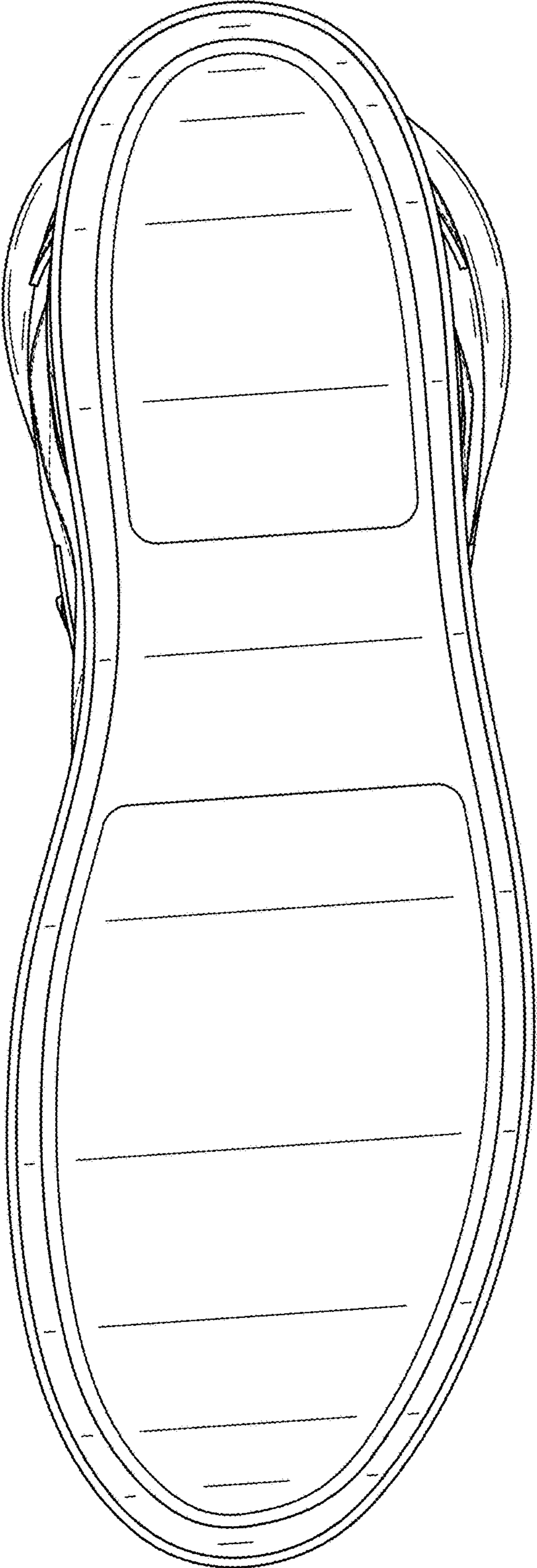

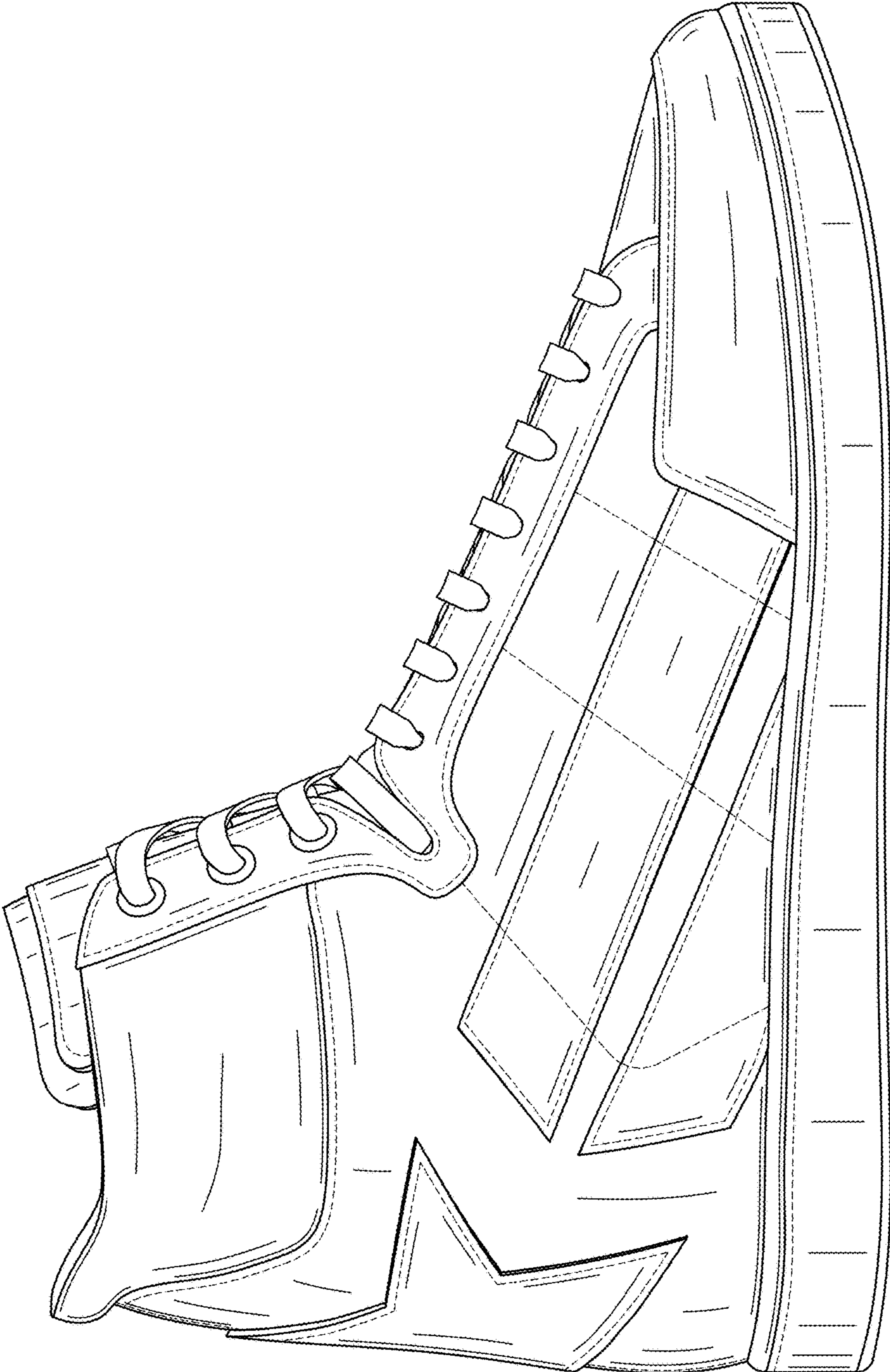

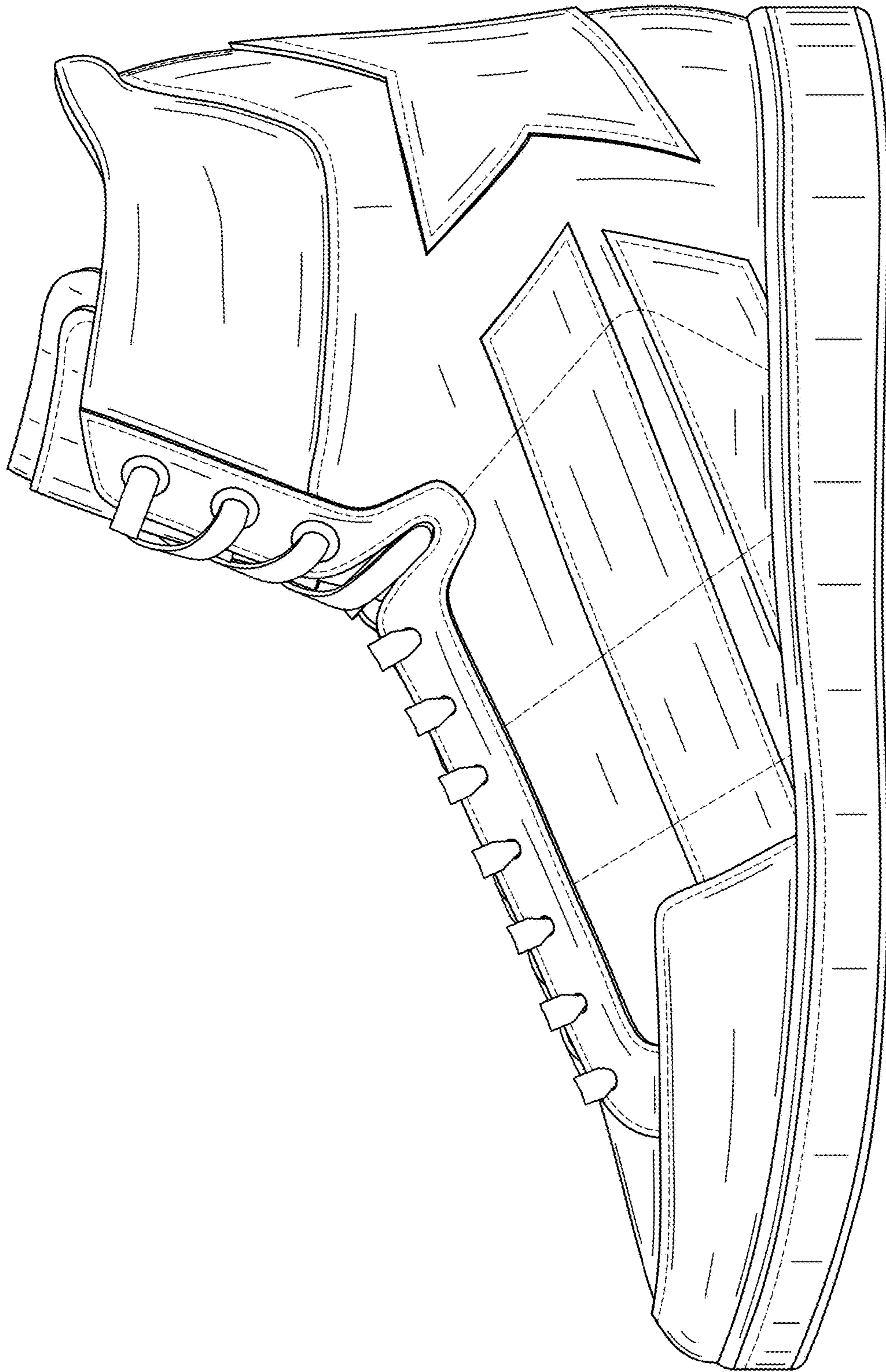

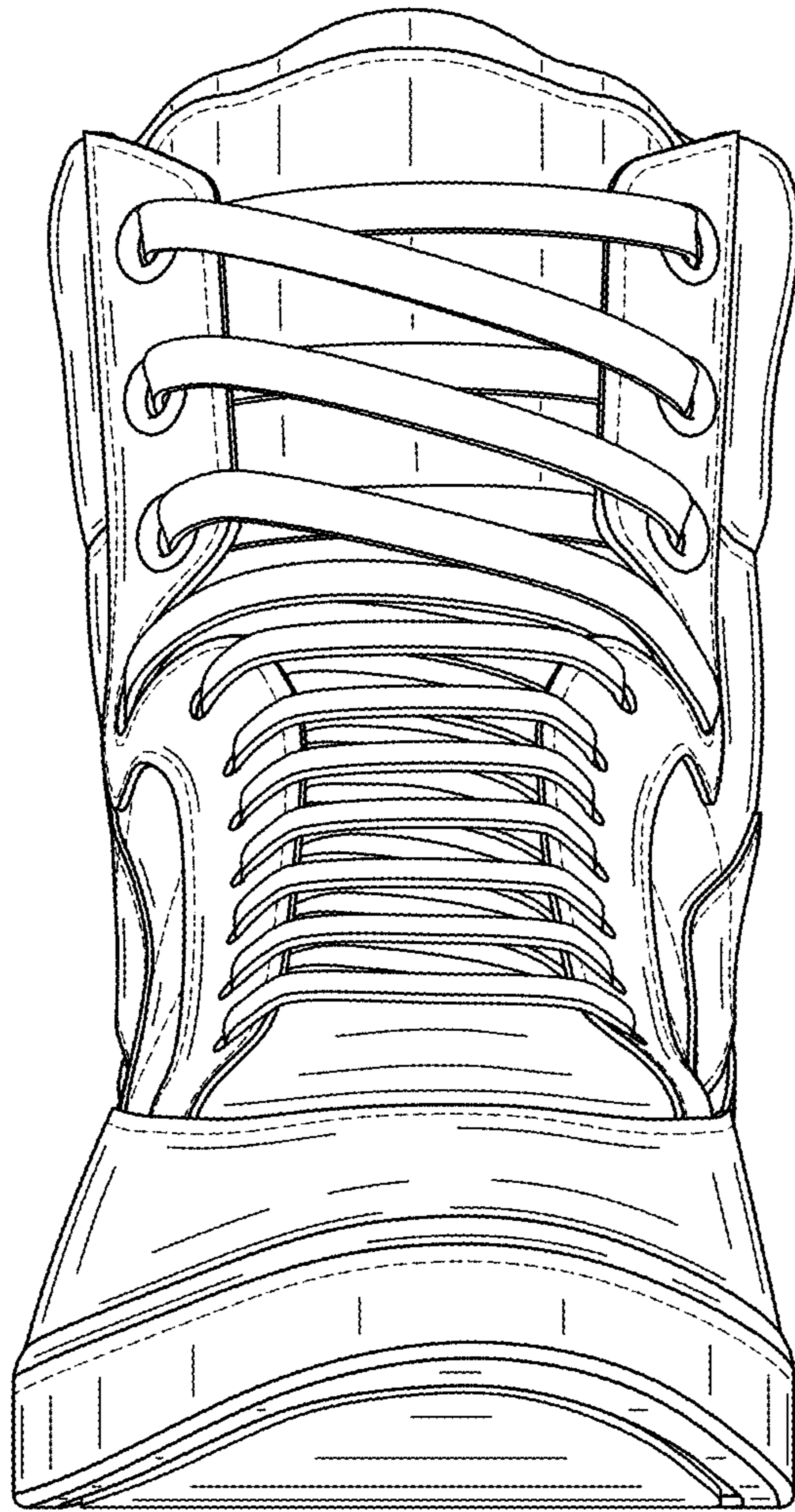

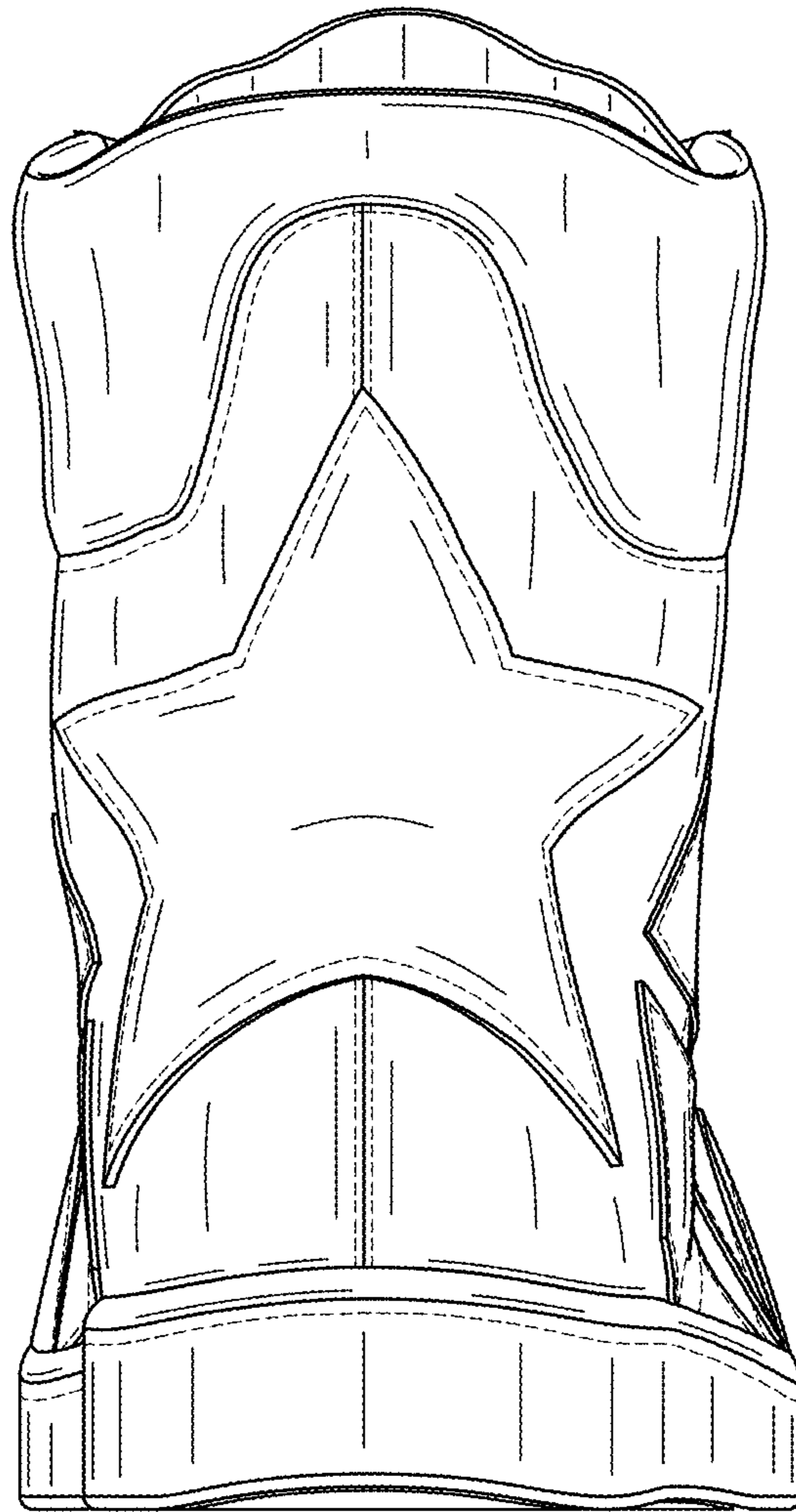
