DESCRIPTION

FIG. 1 is a top front right perspective view of a shoe showing my new design;

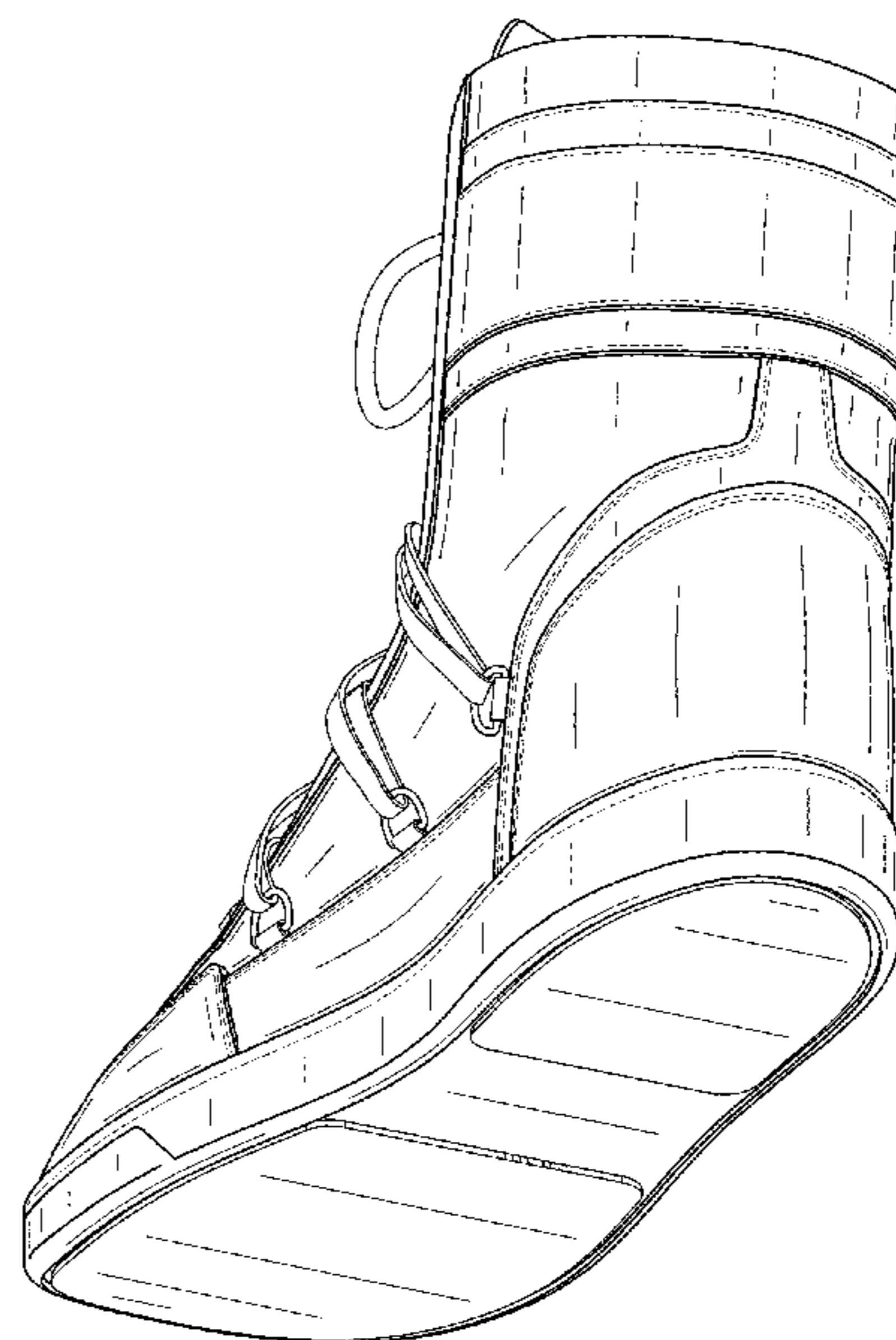

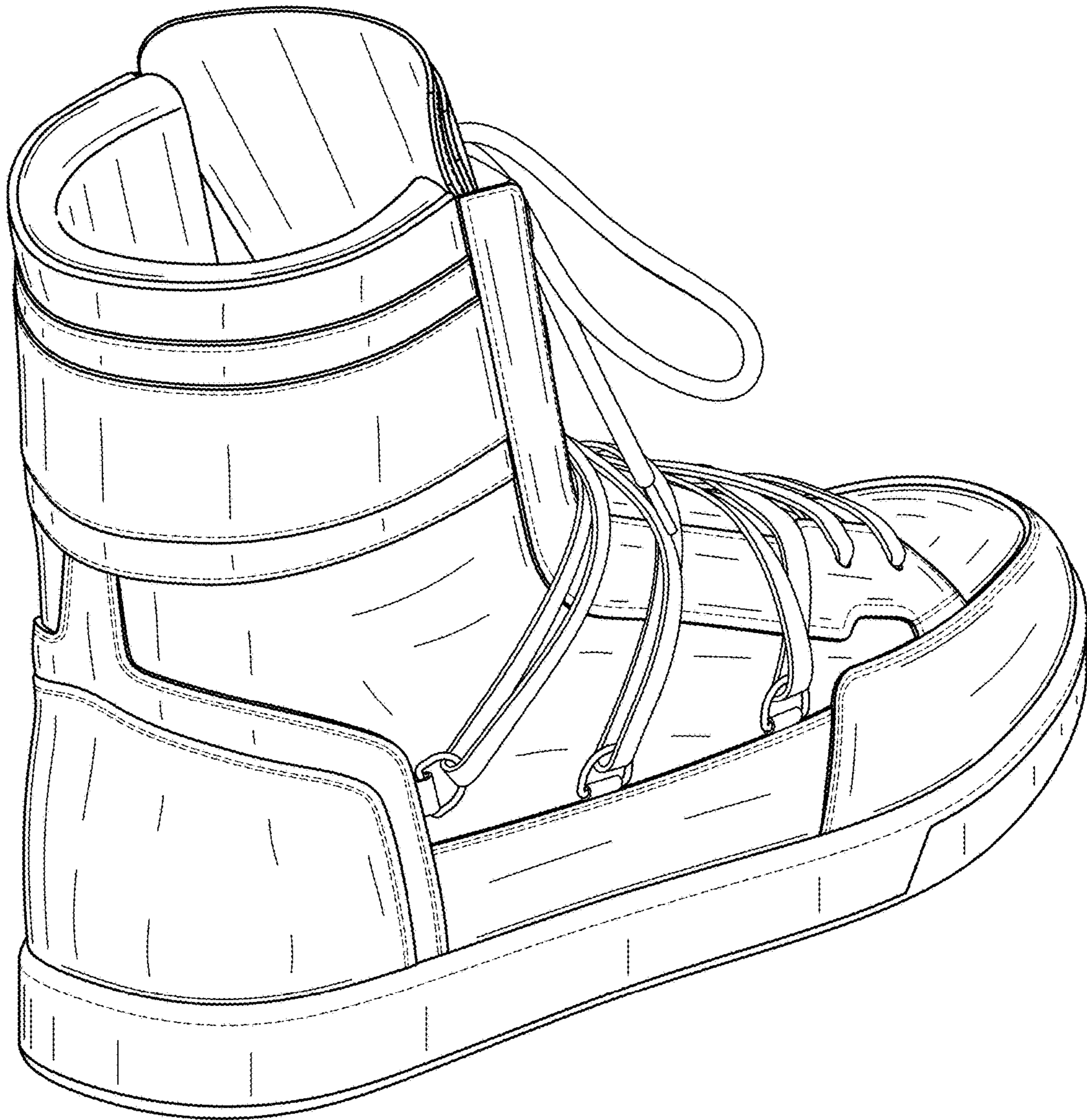

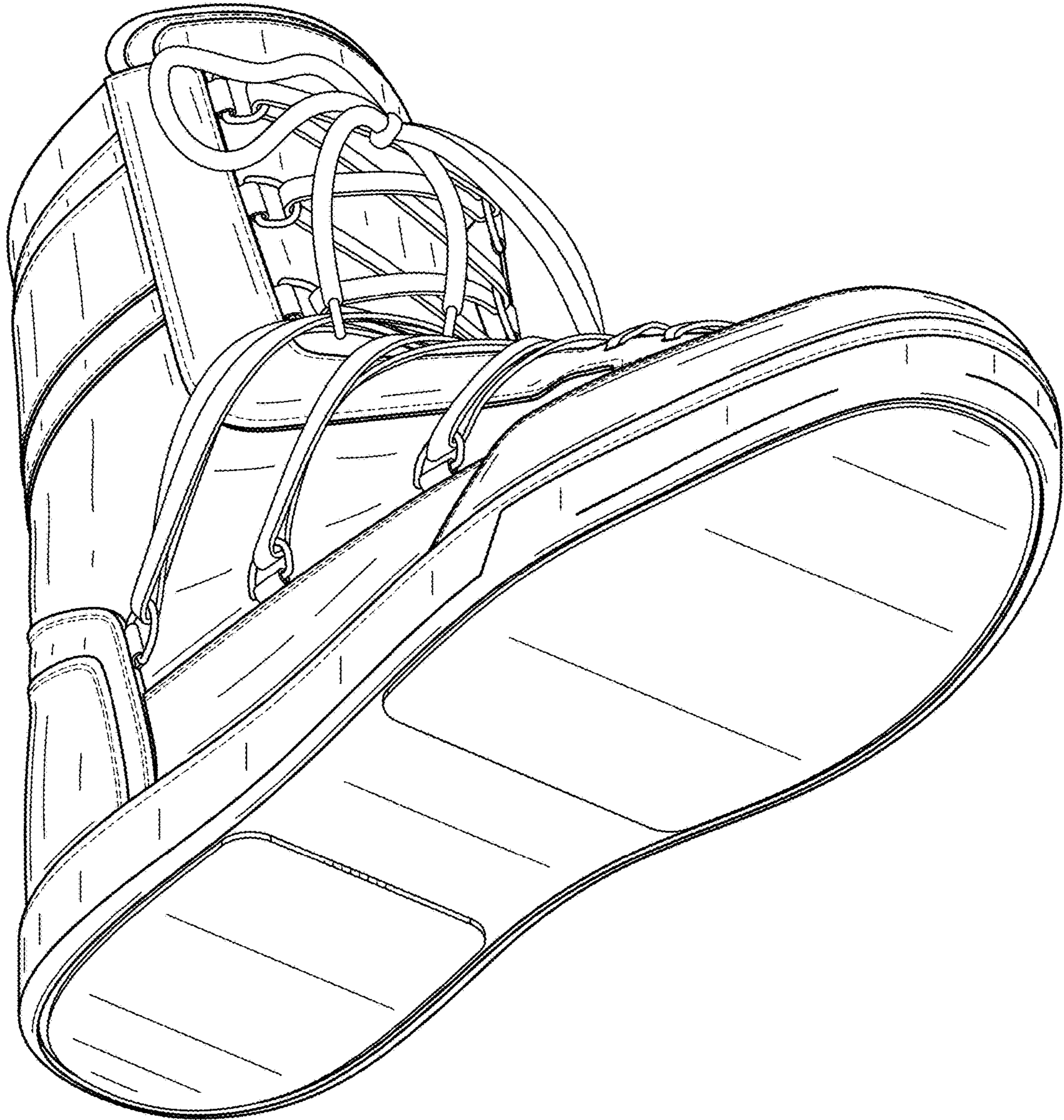

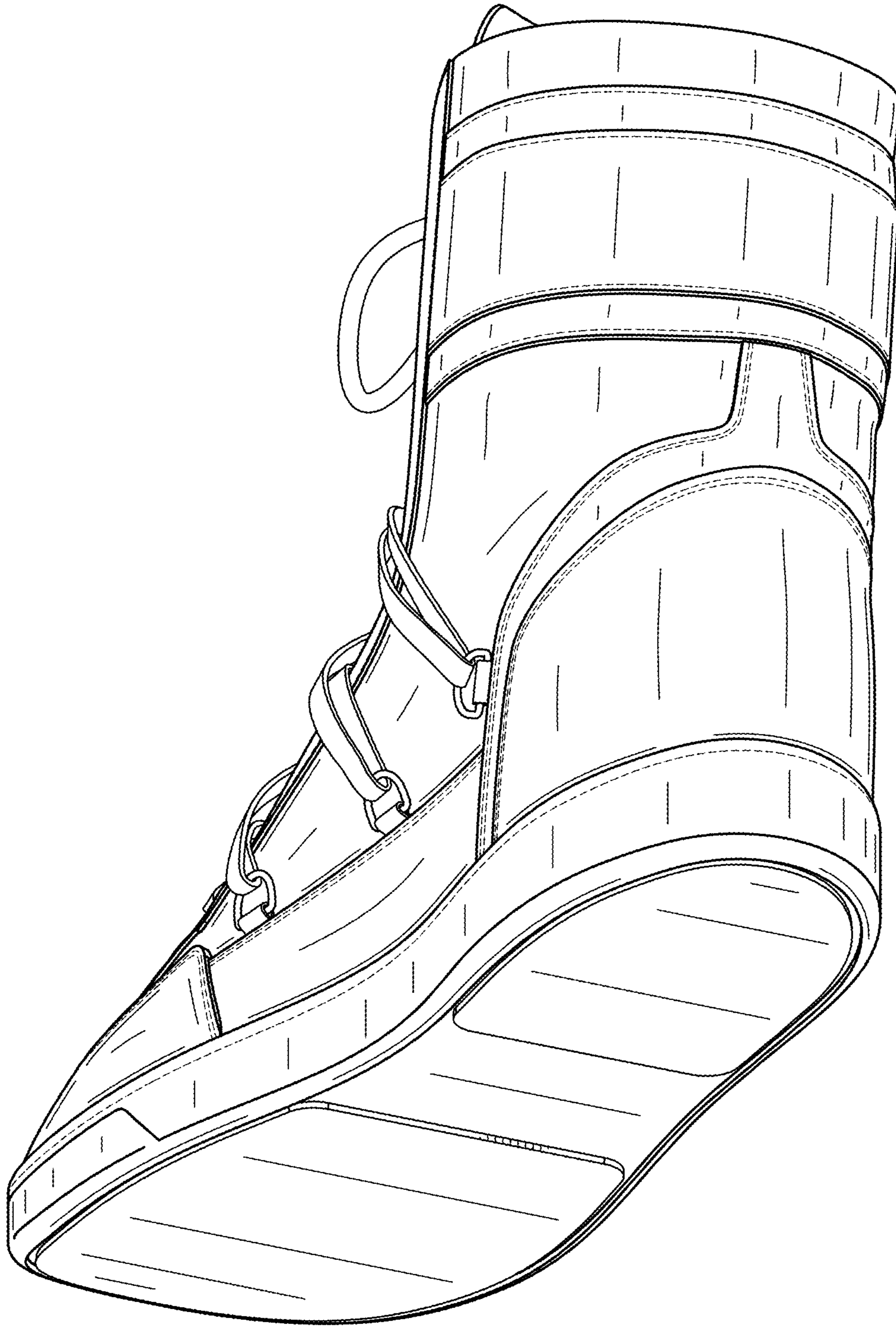

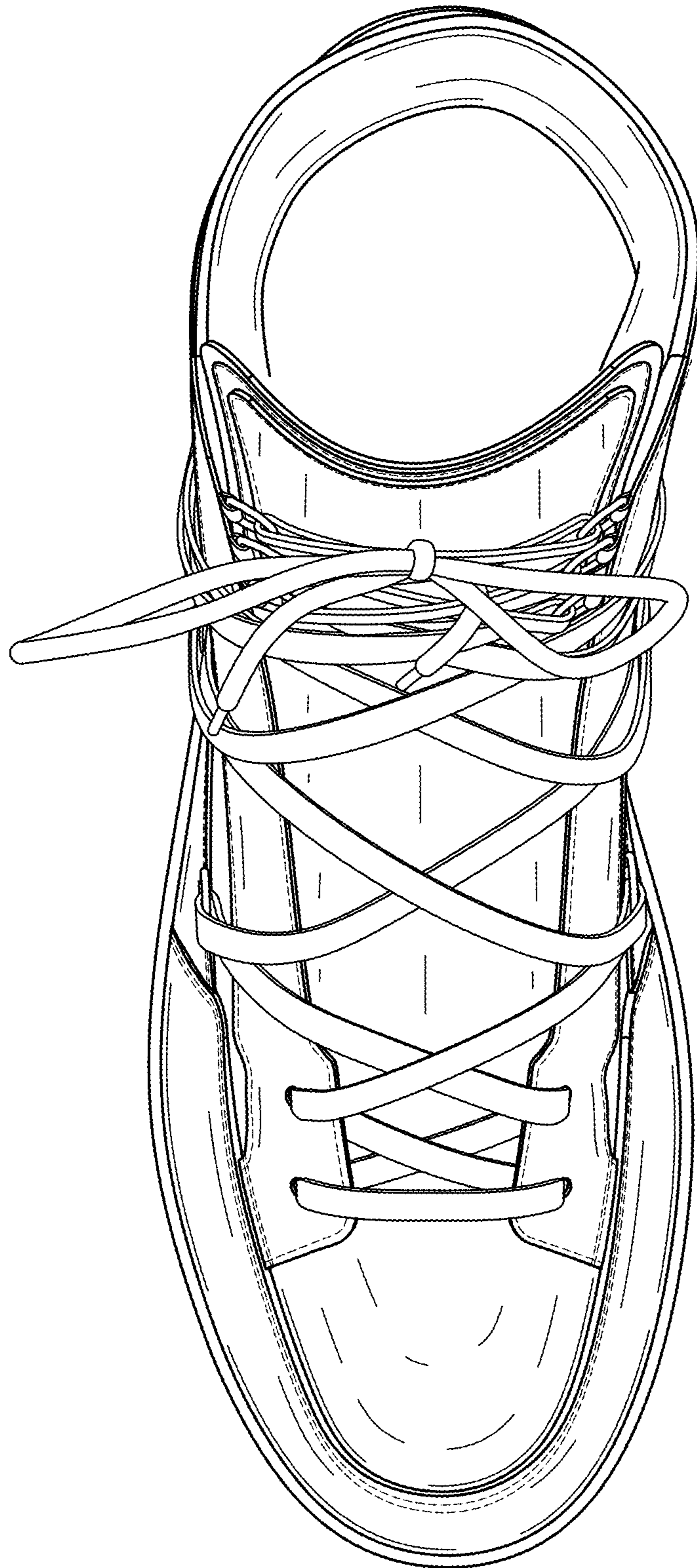

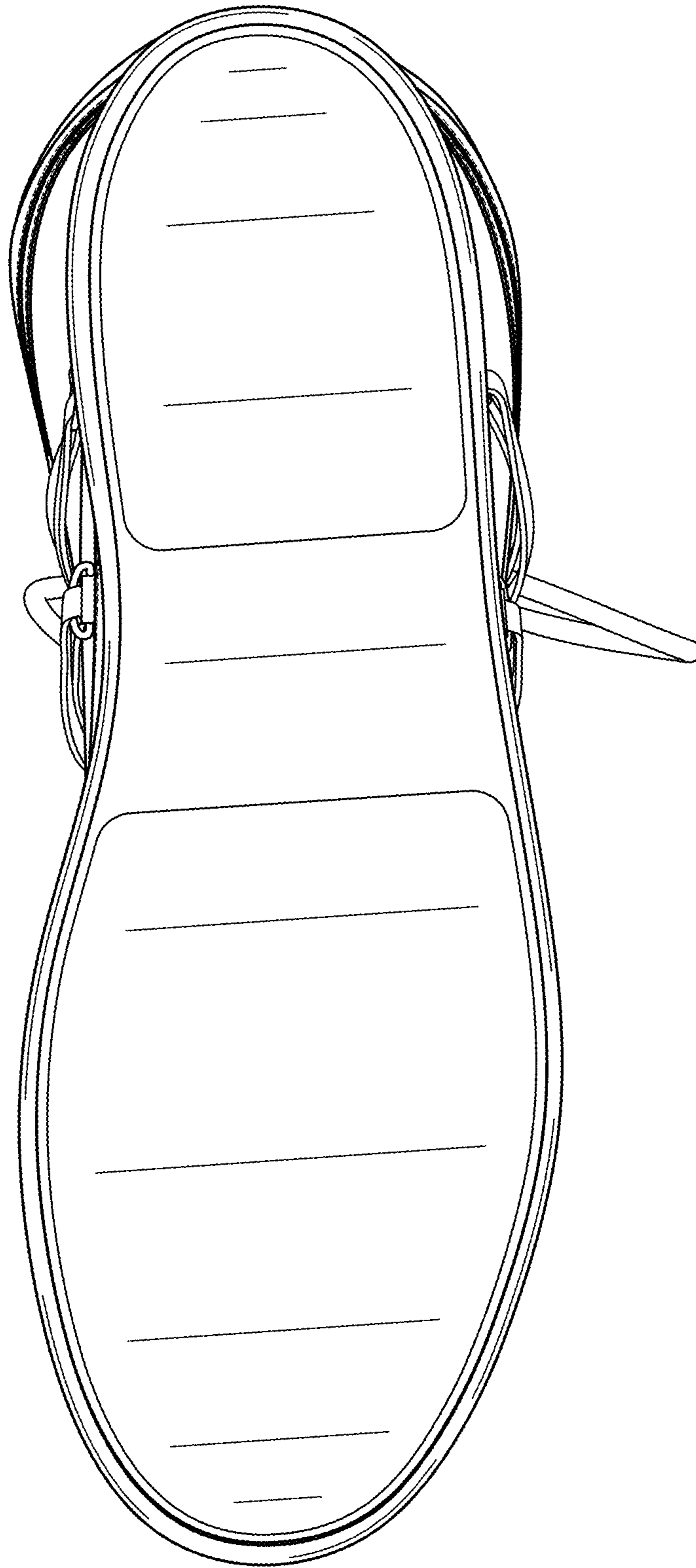

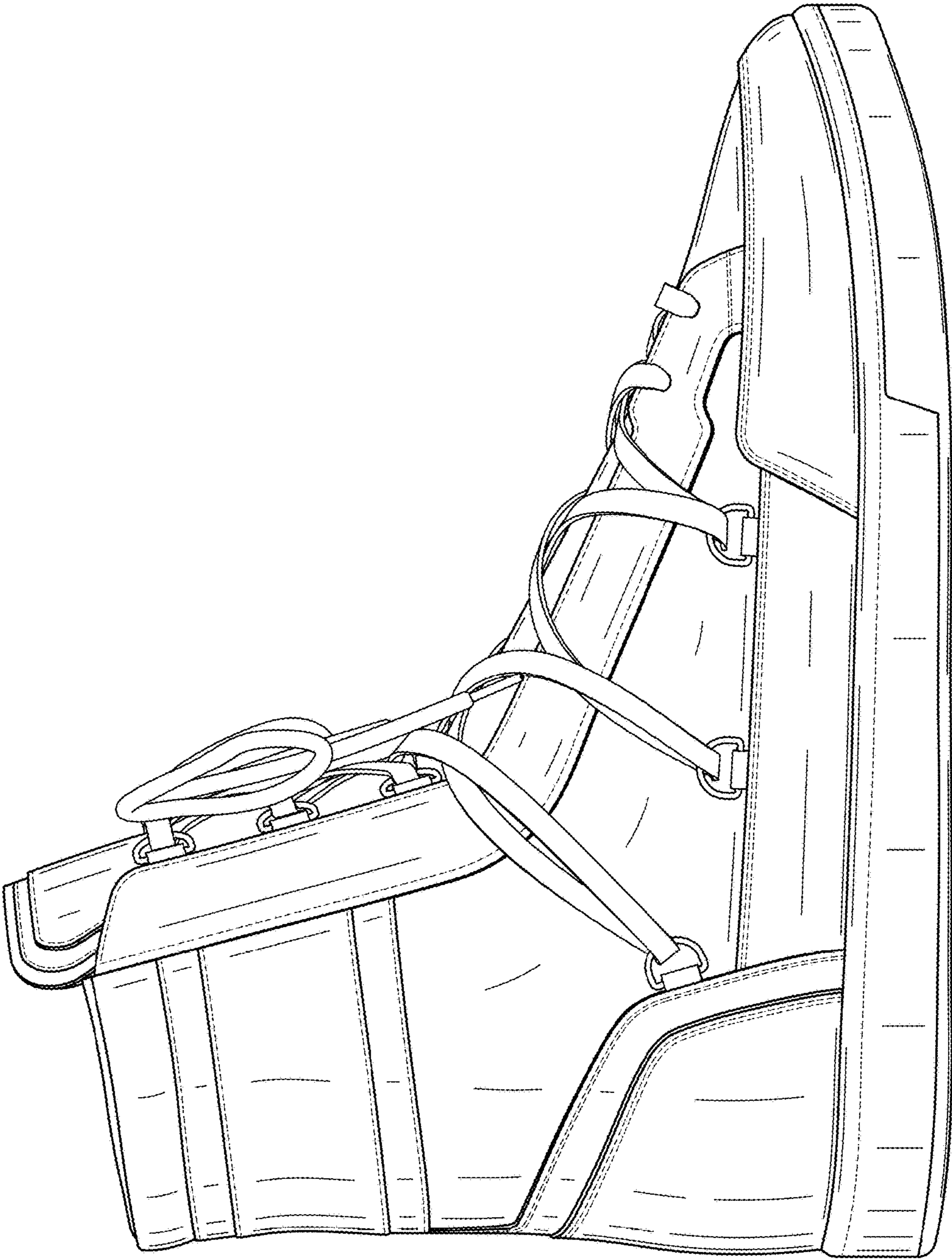

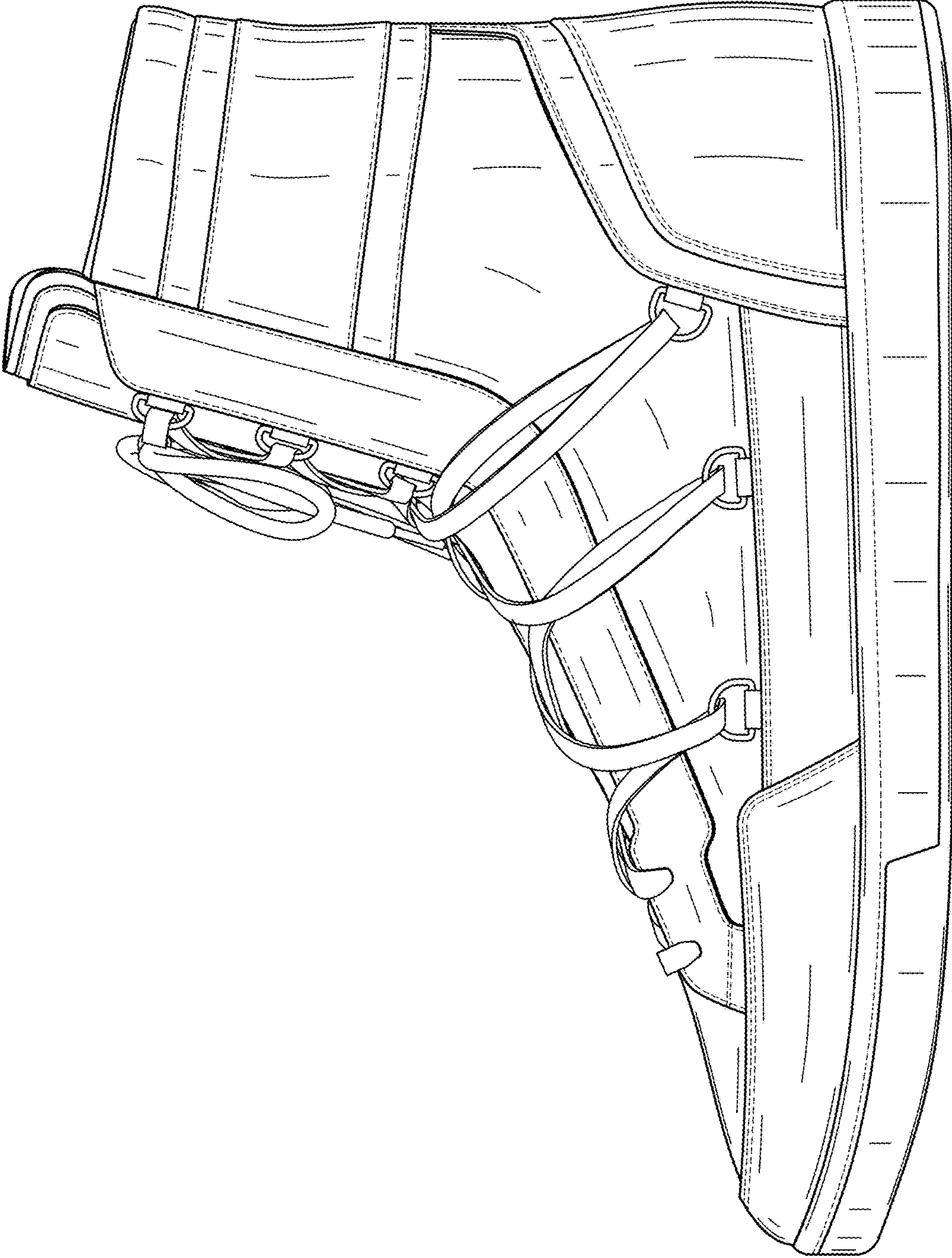

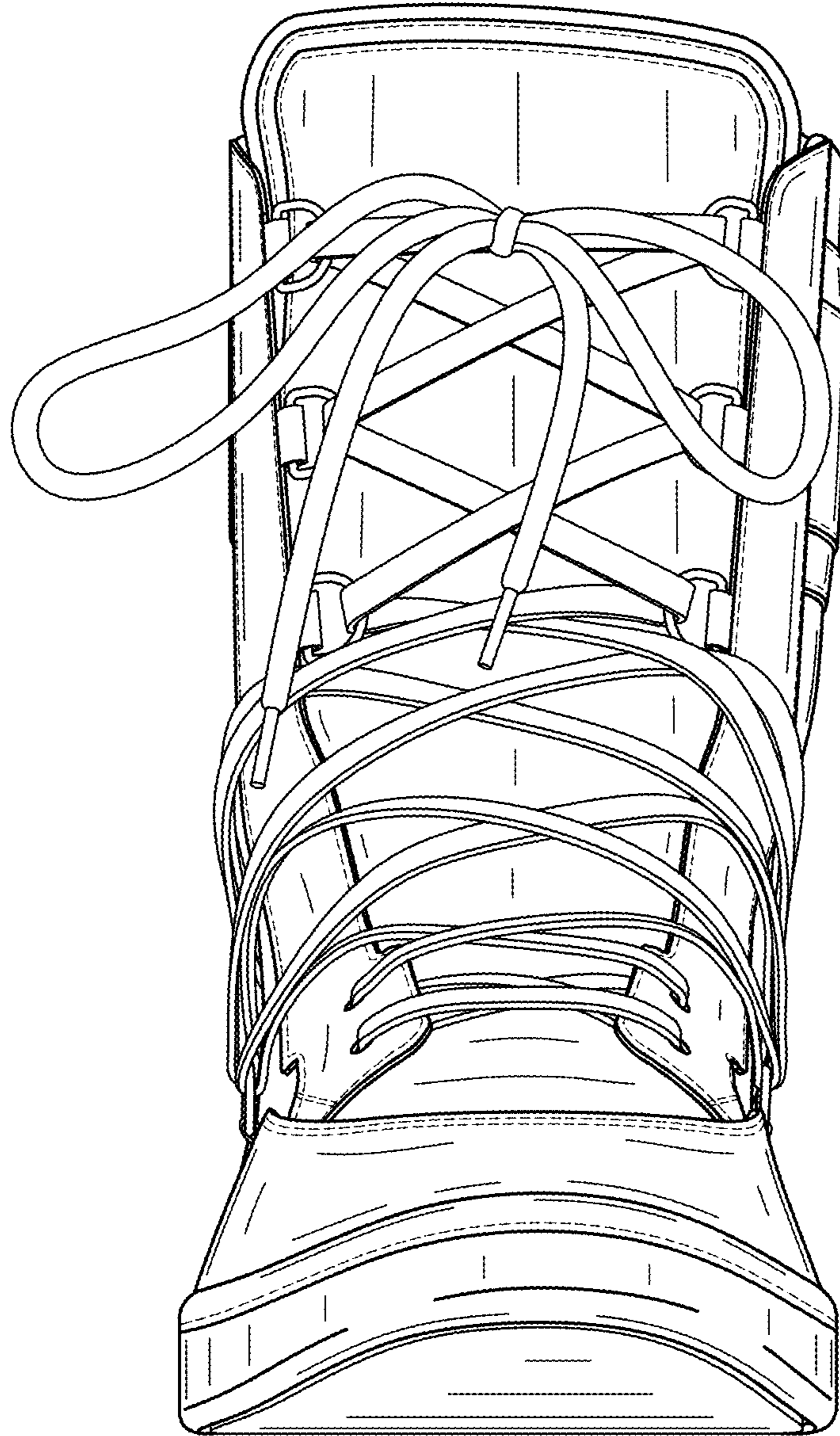

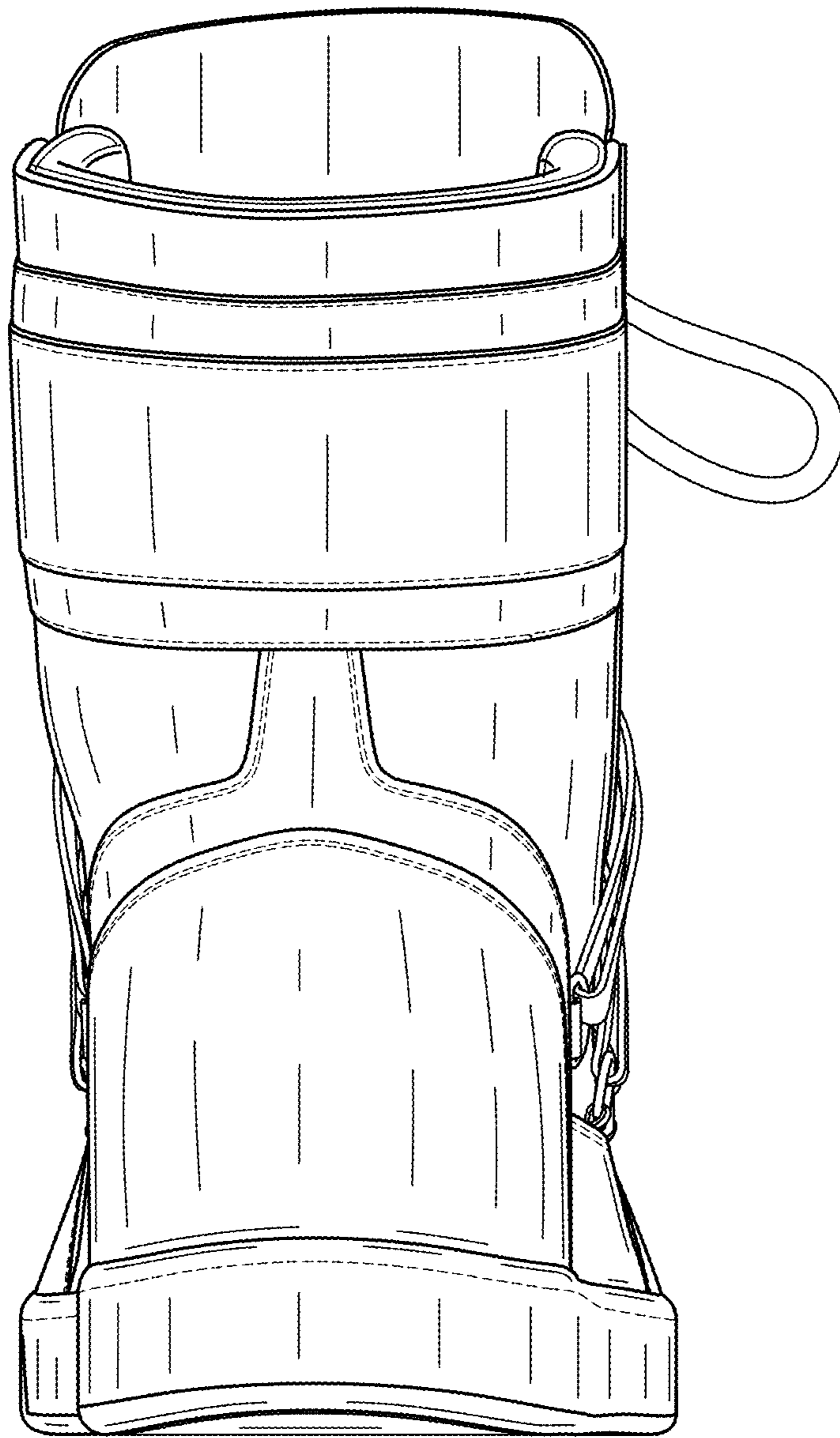
