DESCRIPTION

FIG. 7 is a left side view thereof;

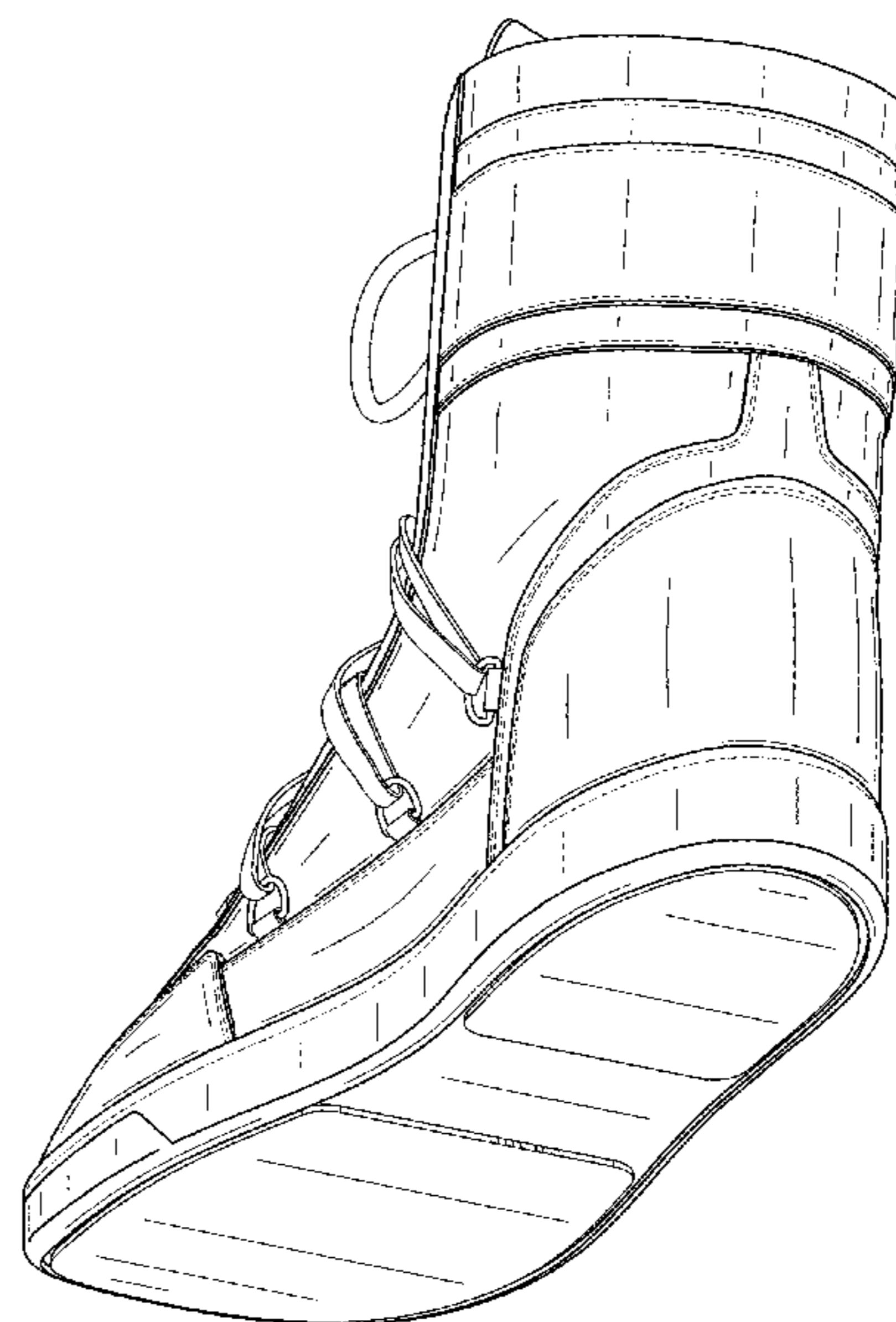
FIG. 8 is a right side view thereof;

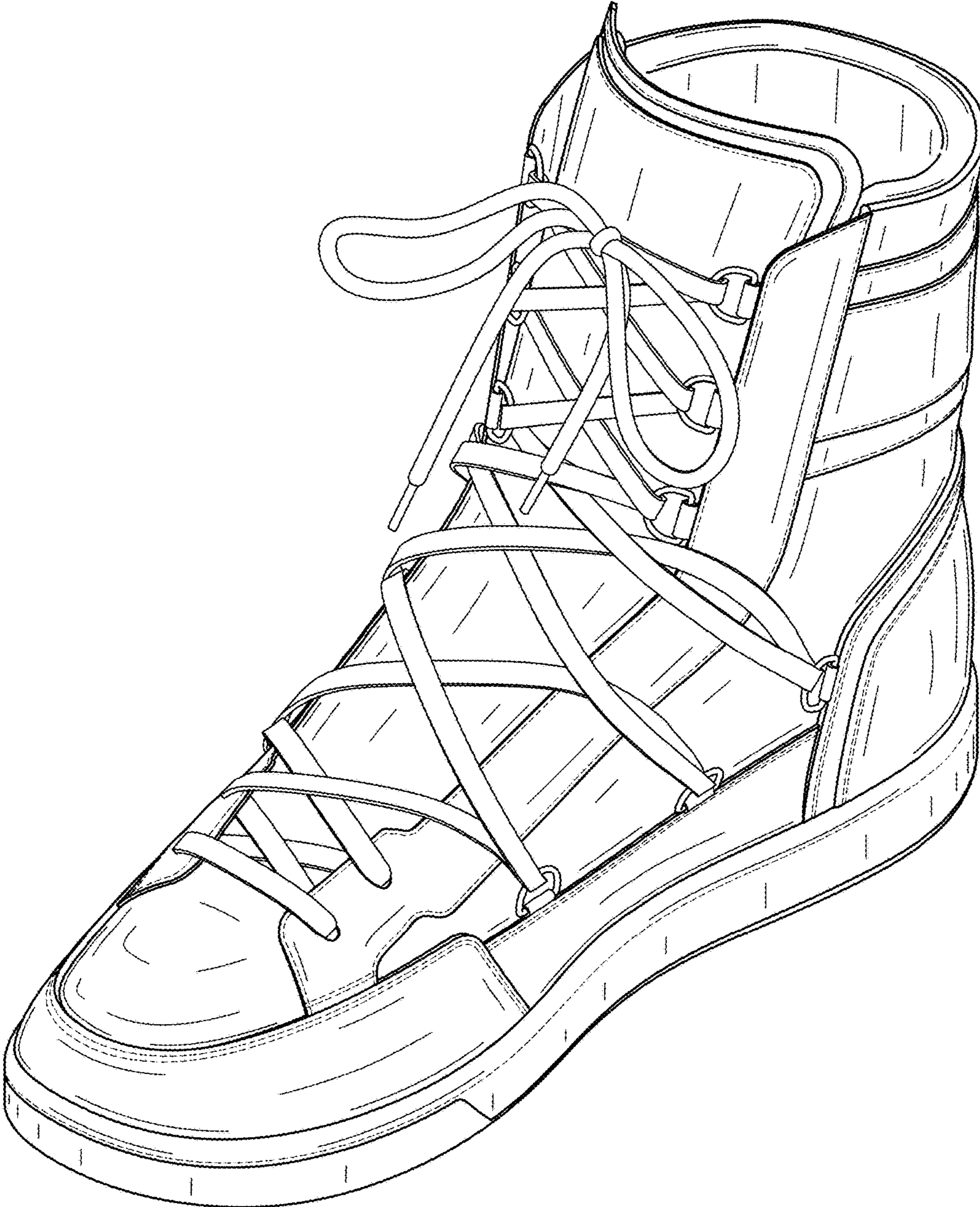

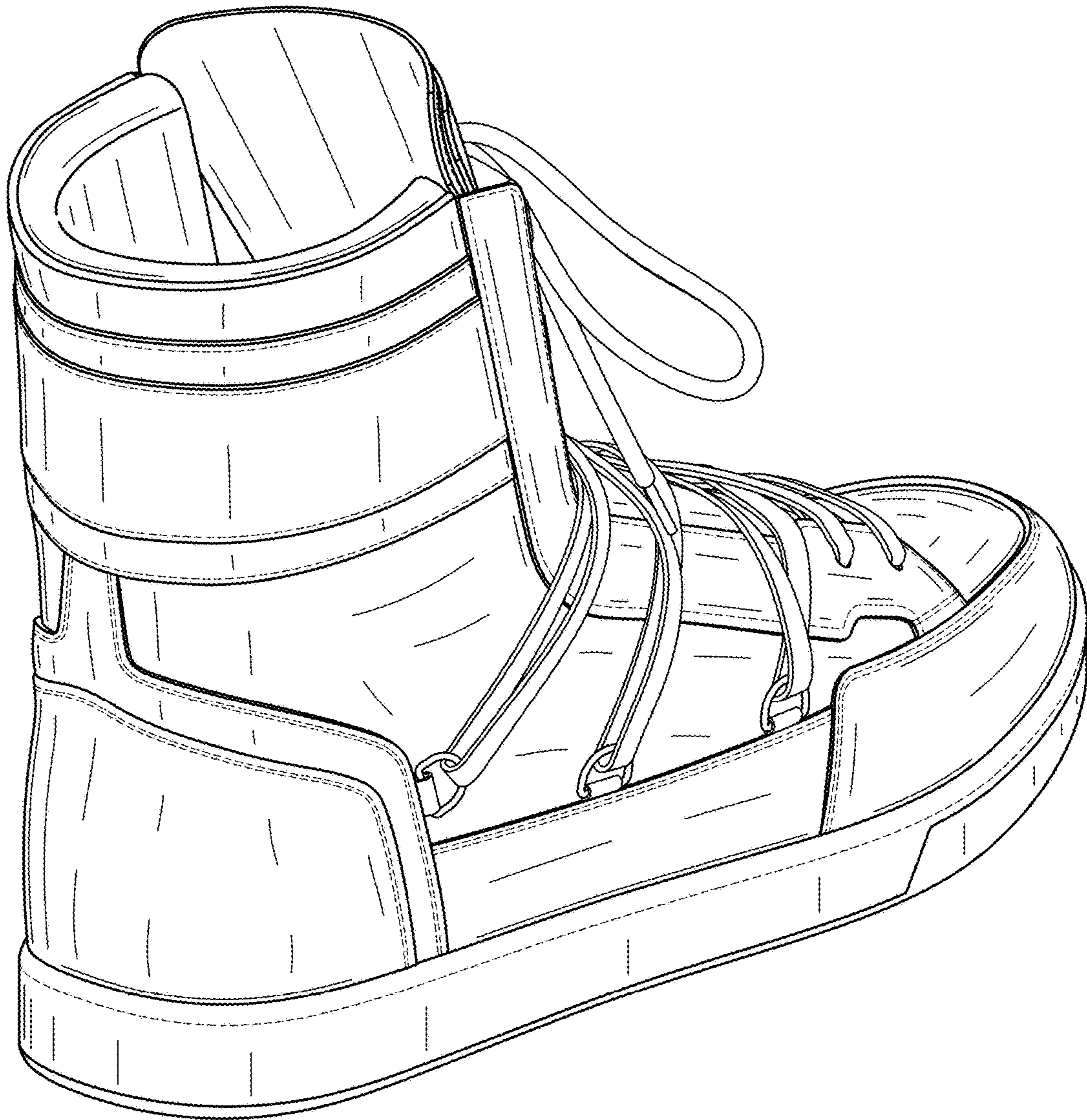

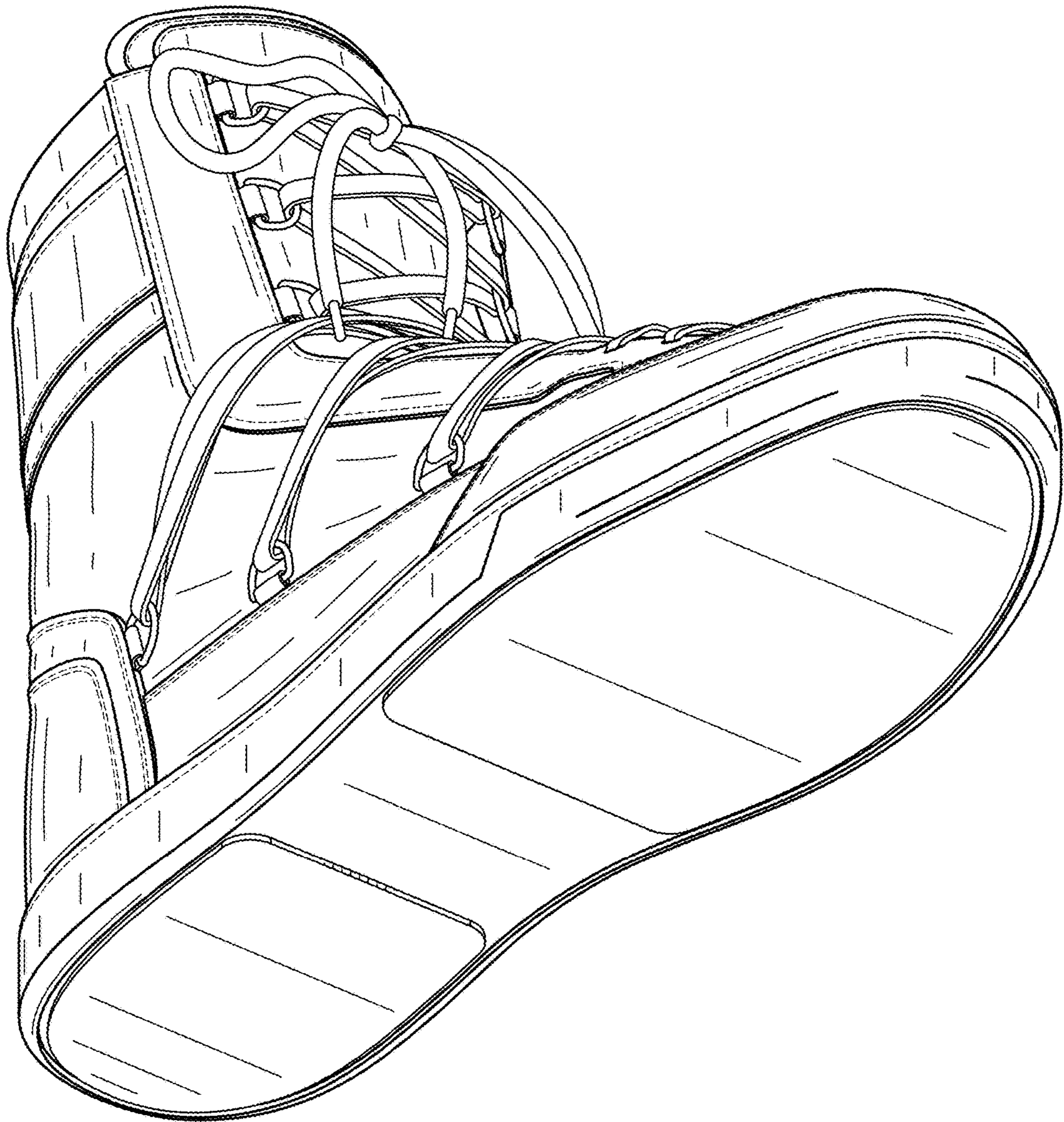

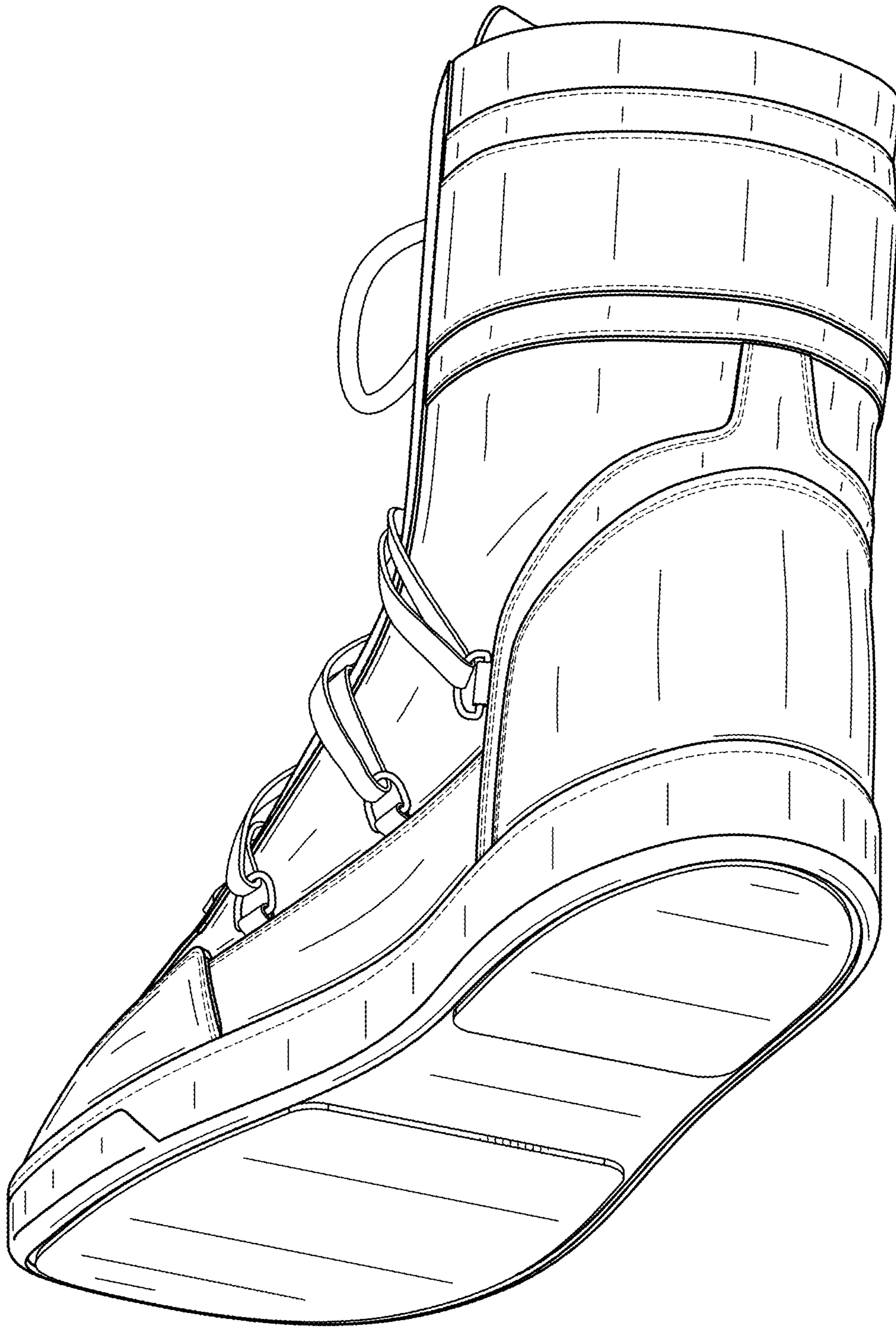

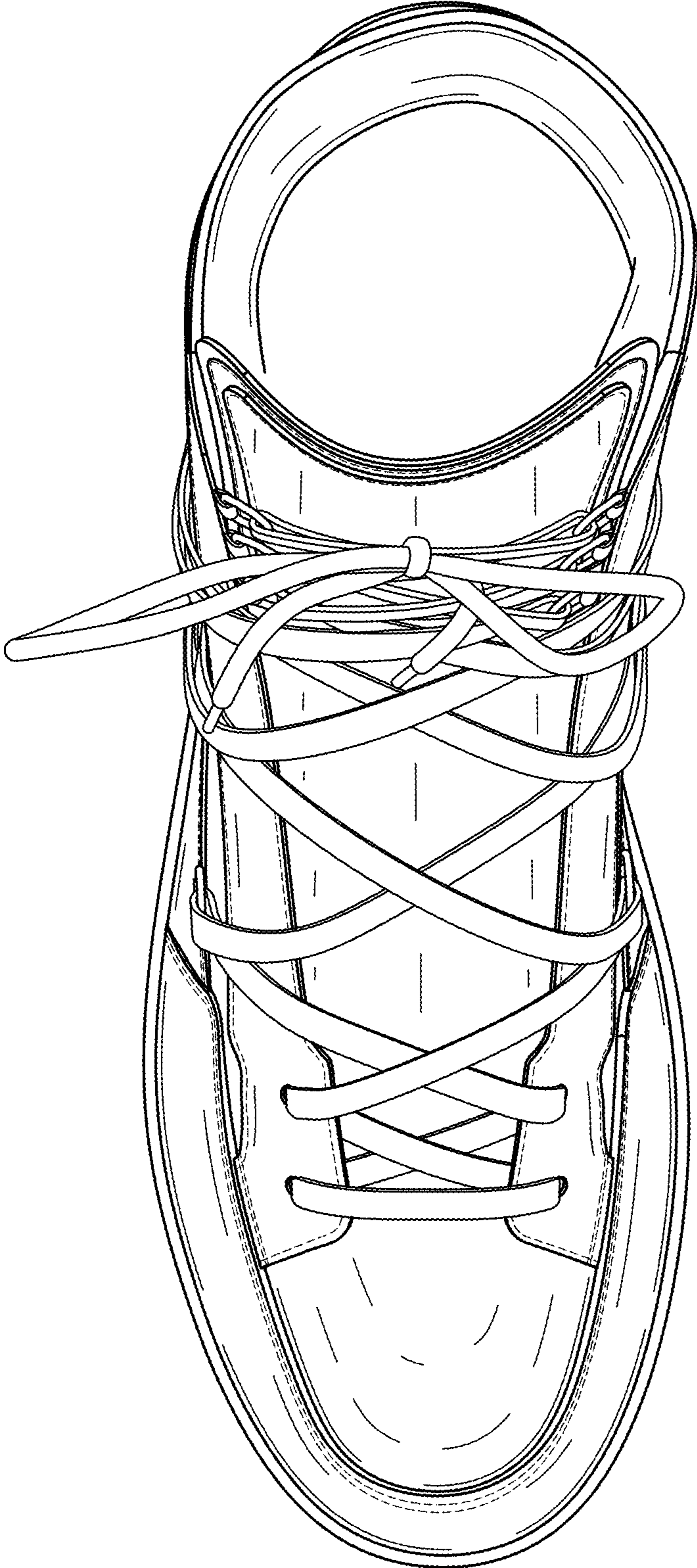

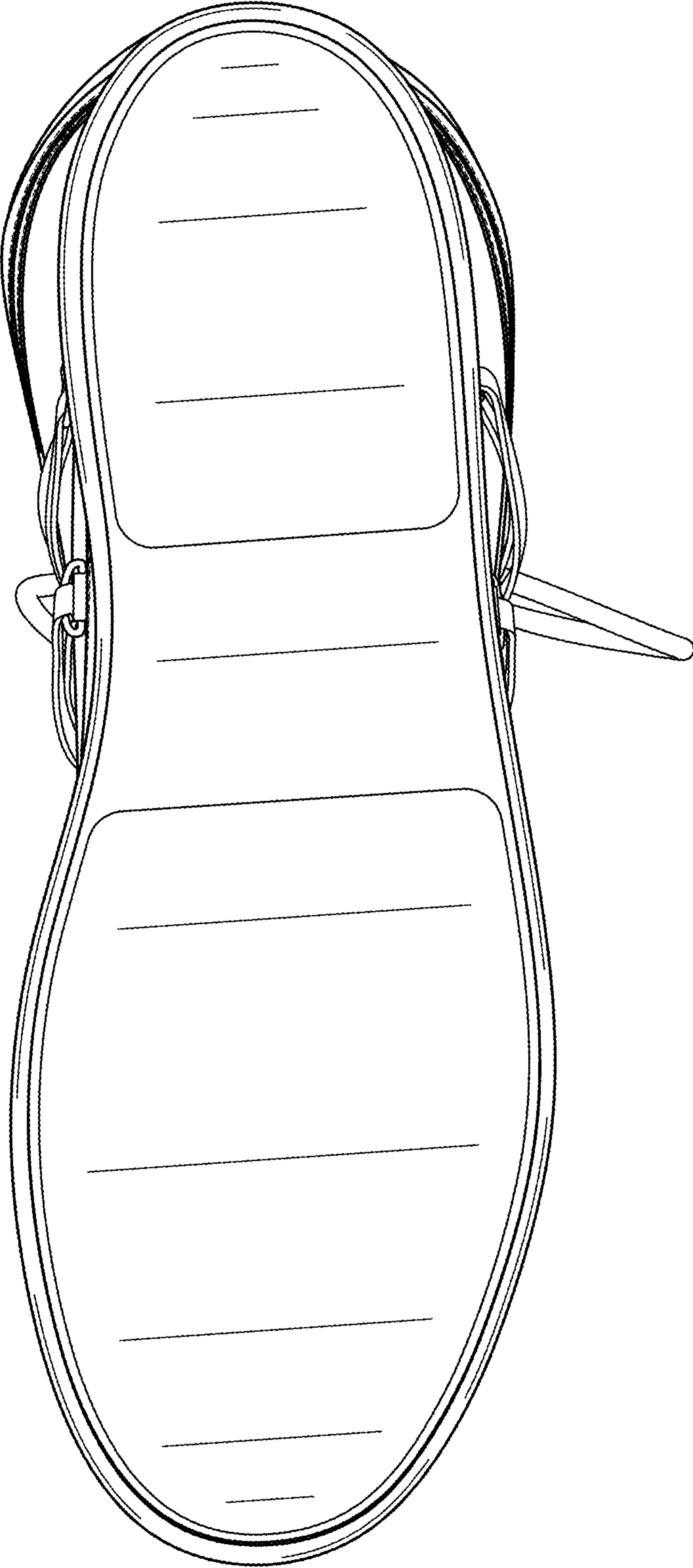

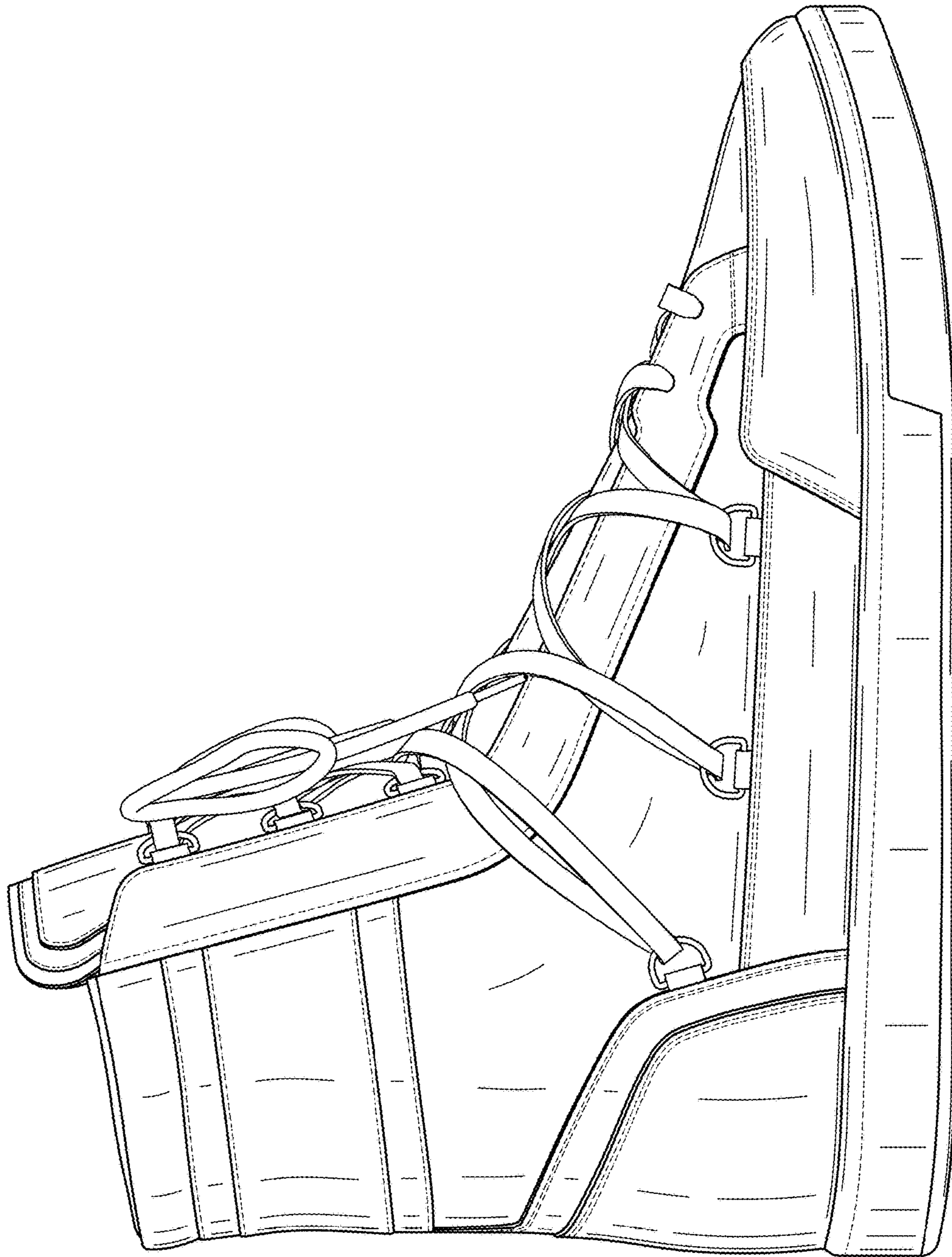

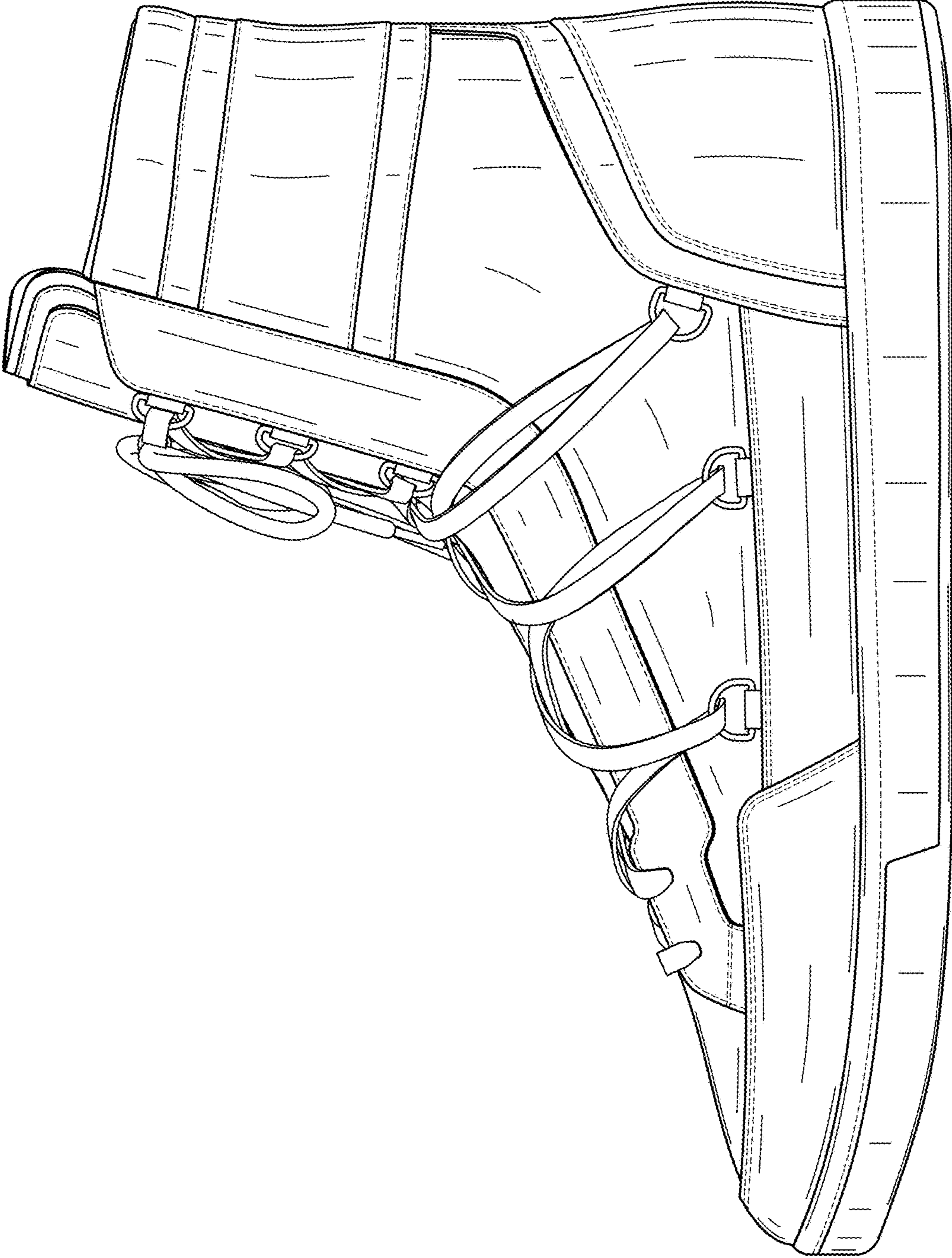

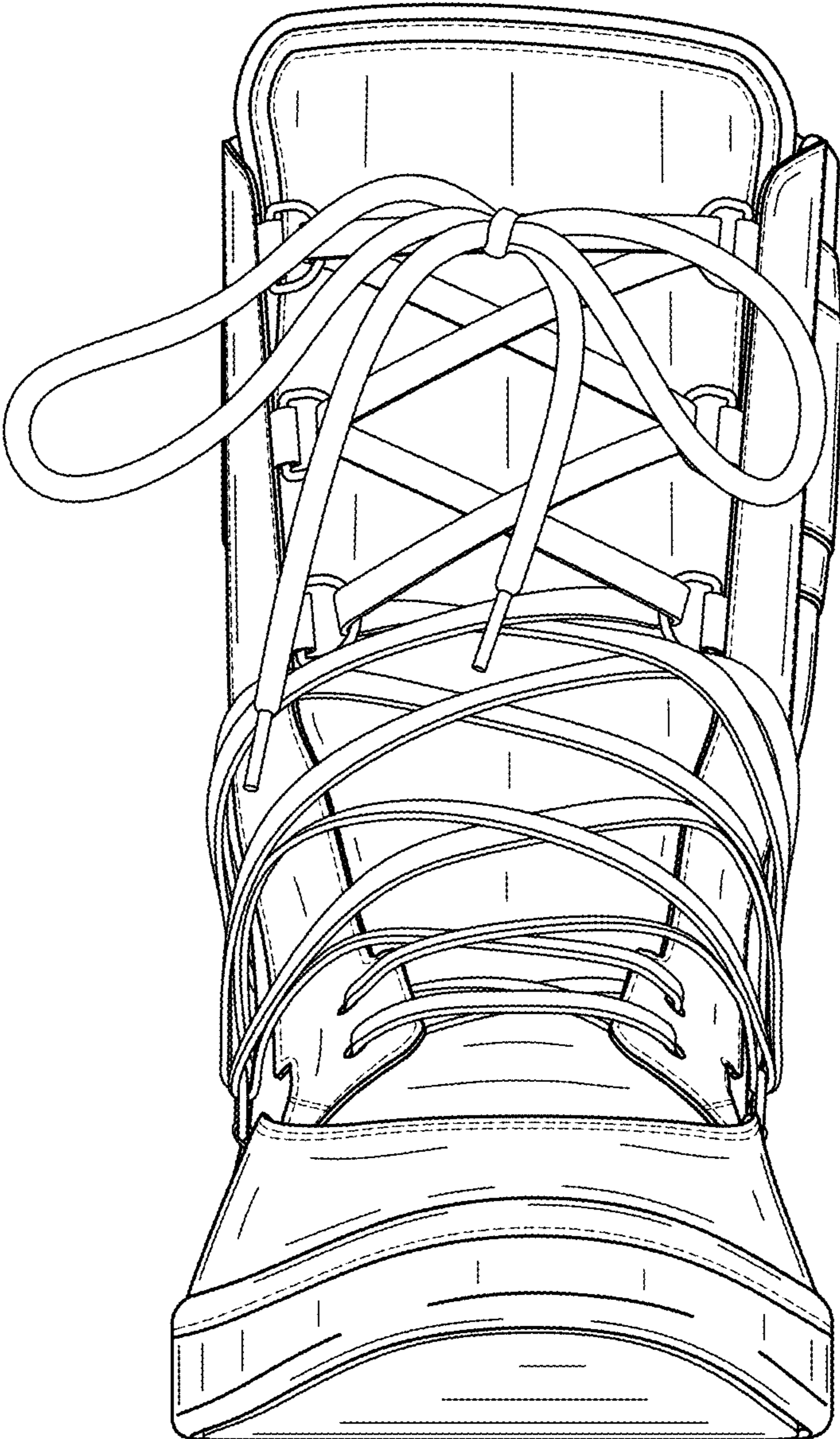

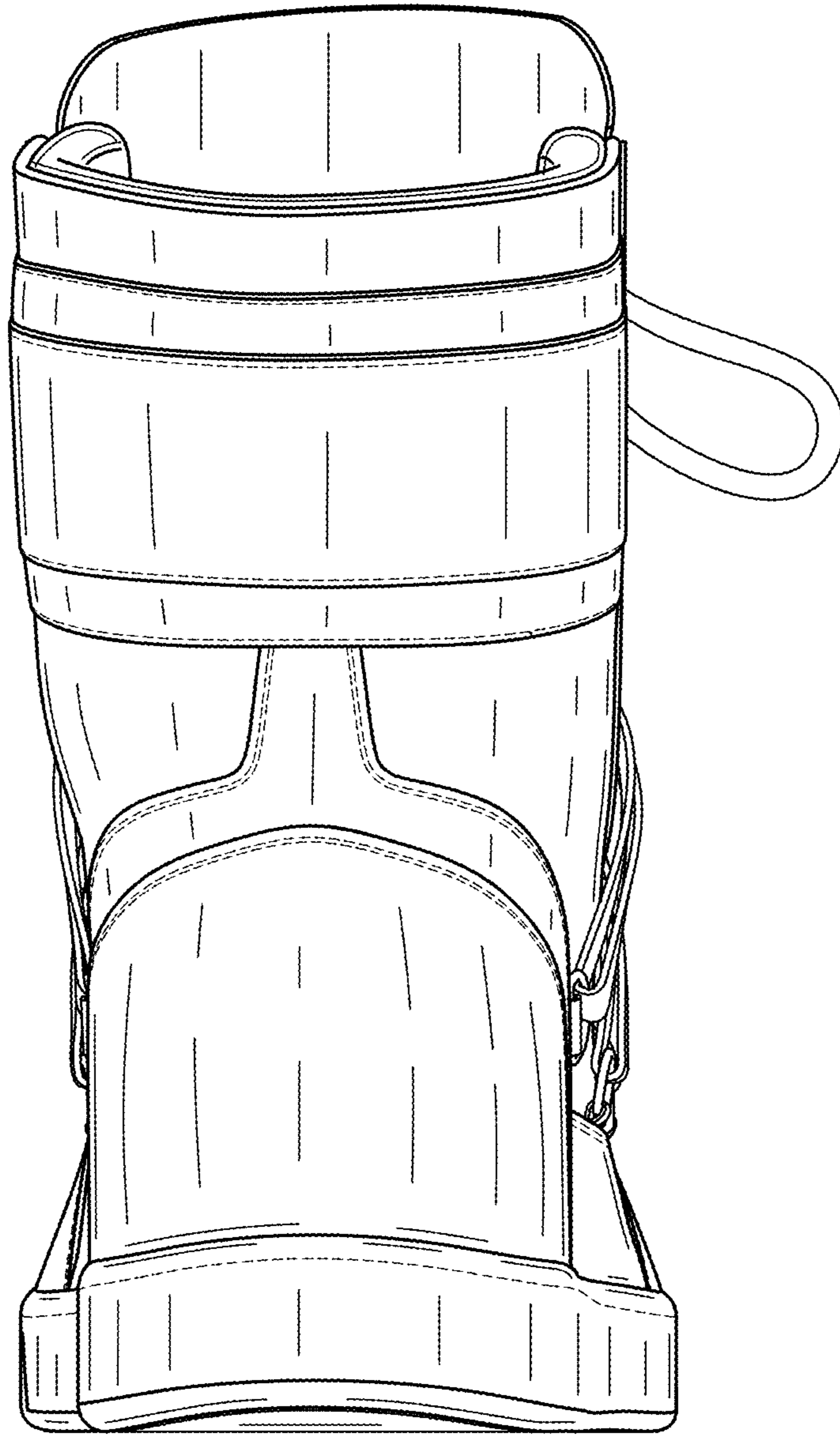
