(57) **CLAIM**

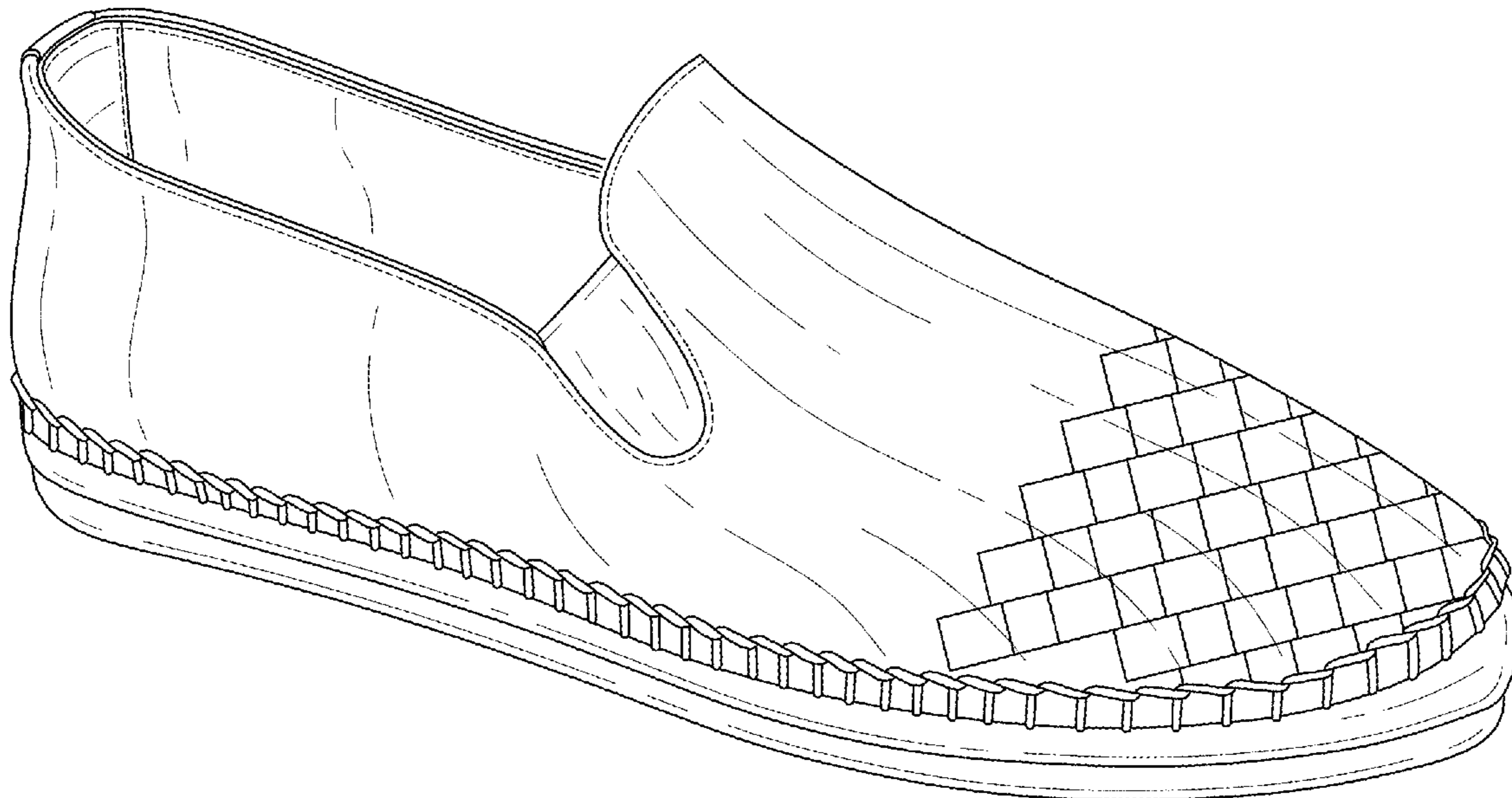
The ornamental design for a shoe, as shown and described.

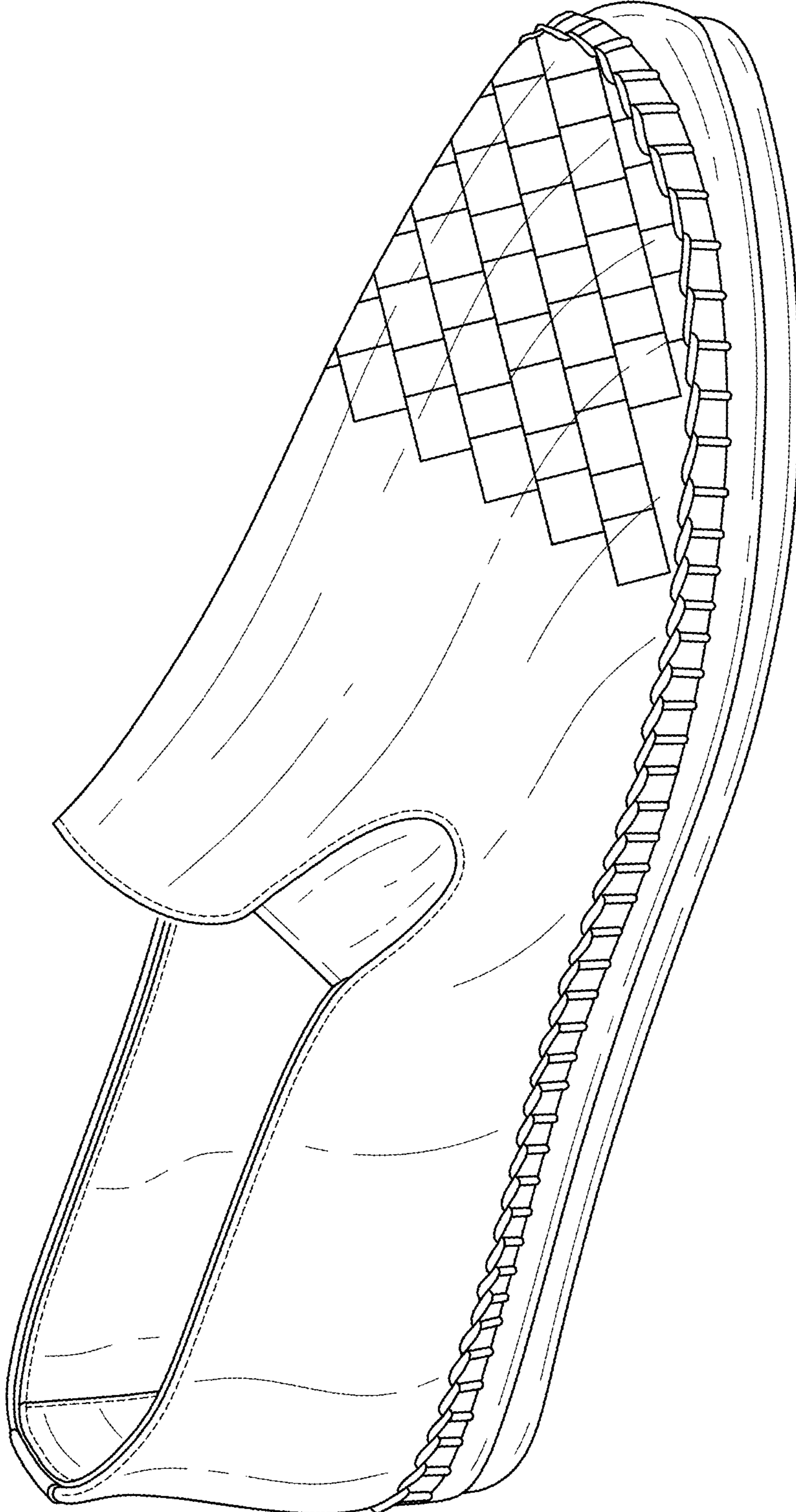
**DESCRIPTION**

**1.1** is a perspective view of a shoe showing my new design;  
**1.2** is a front elevation view thereof;  
**1.3** is a rear elevation view thereof;  
**1.4** is a left side elevation view thereof;  
**1.5** is a right side elevation view thereof;  
**1.6** is a top plan view thereof; and  
**1.7** is a bottom plan view thereof.

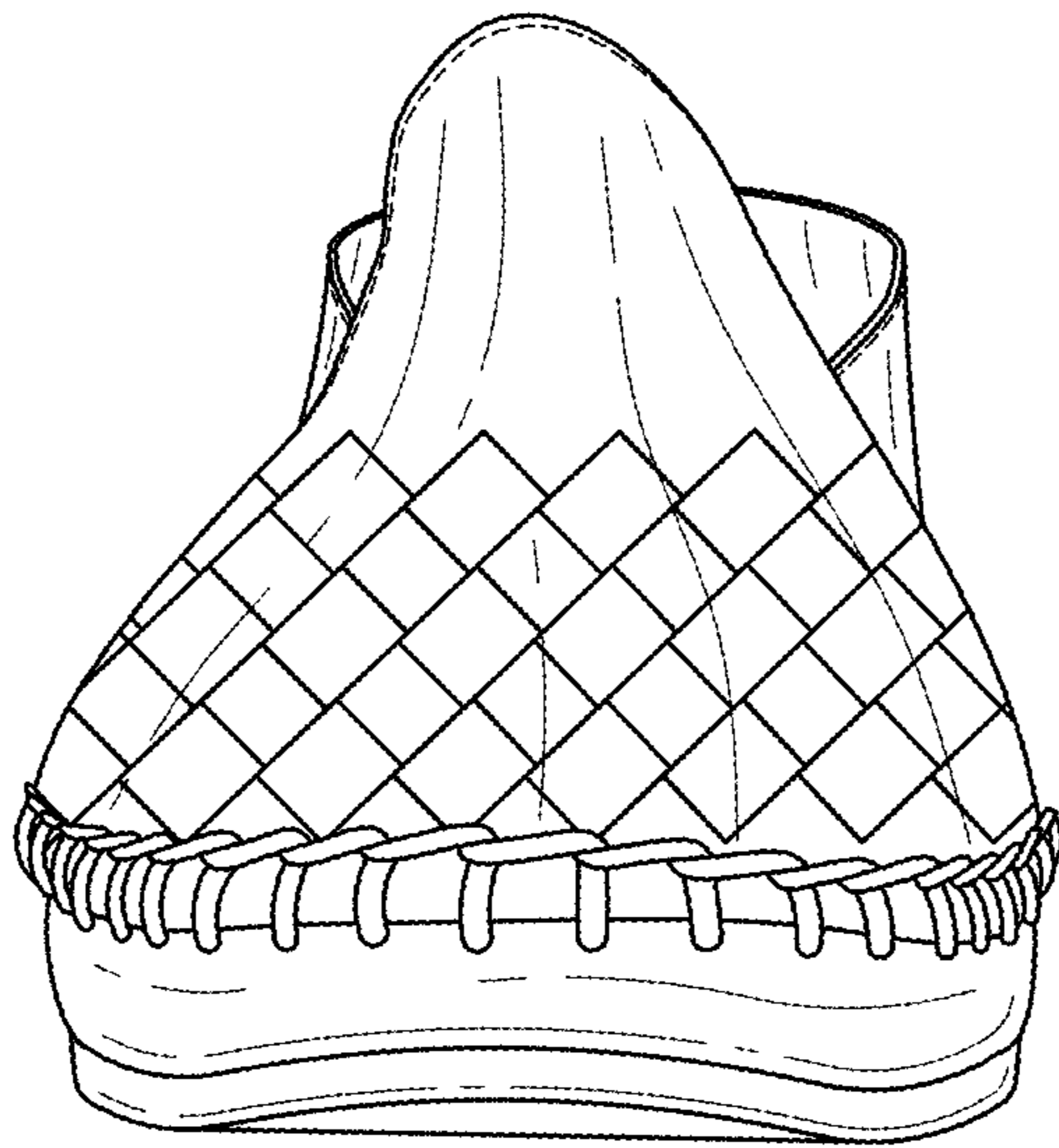

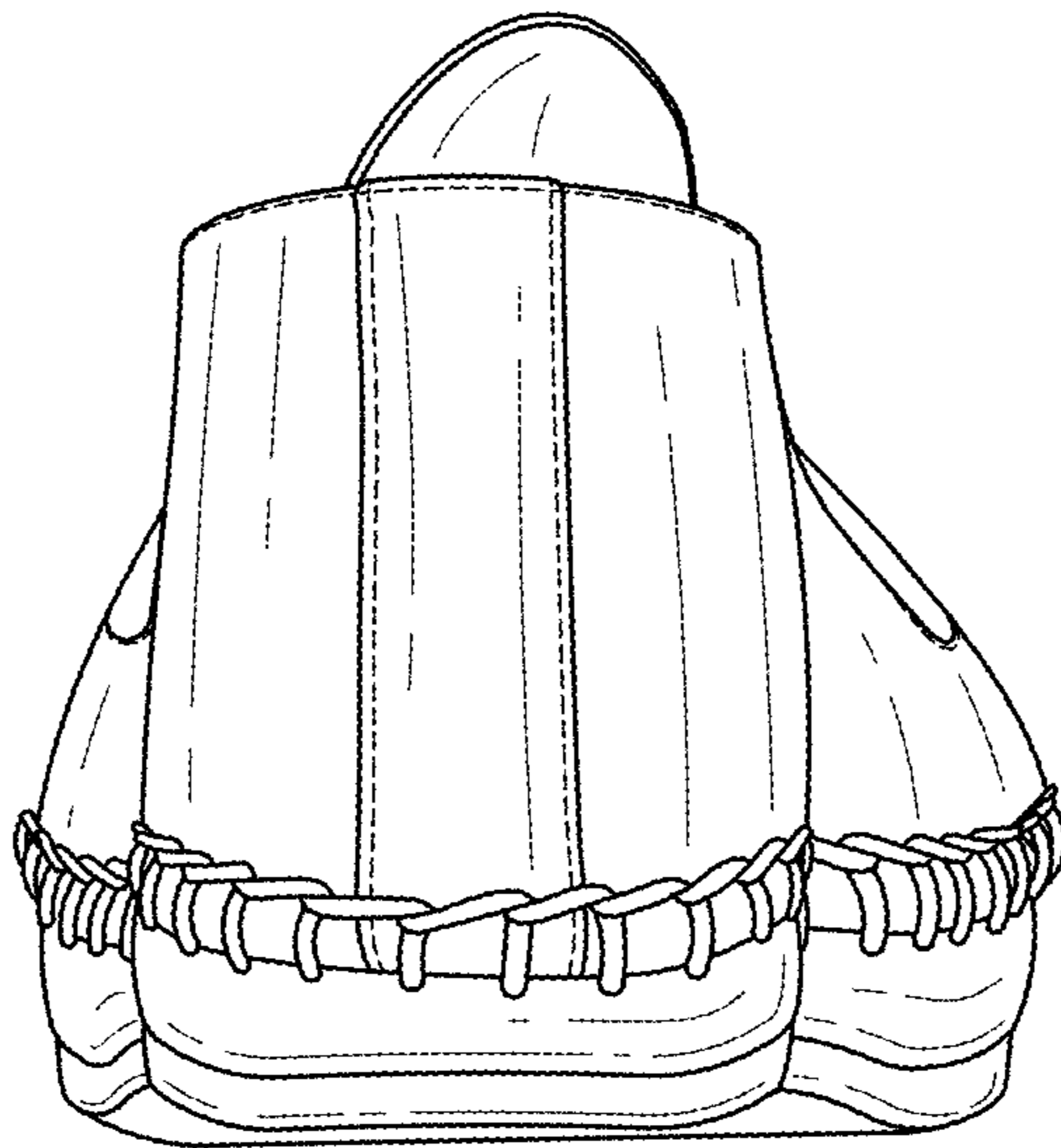

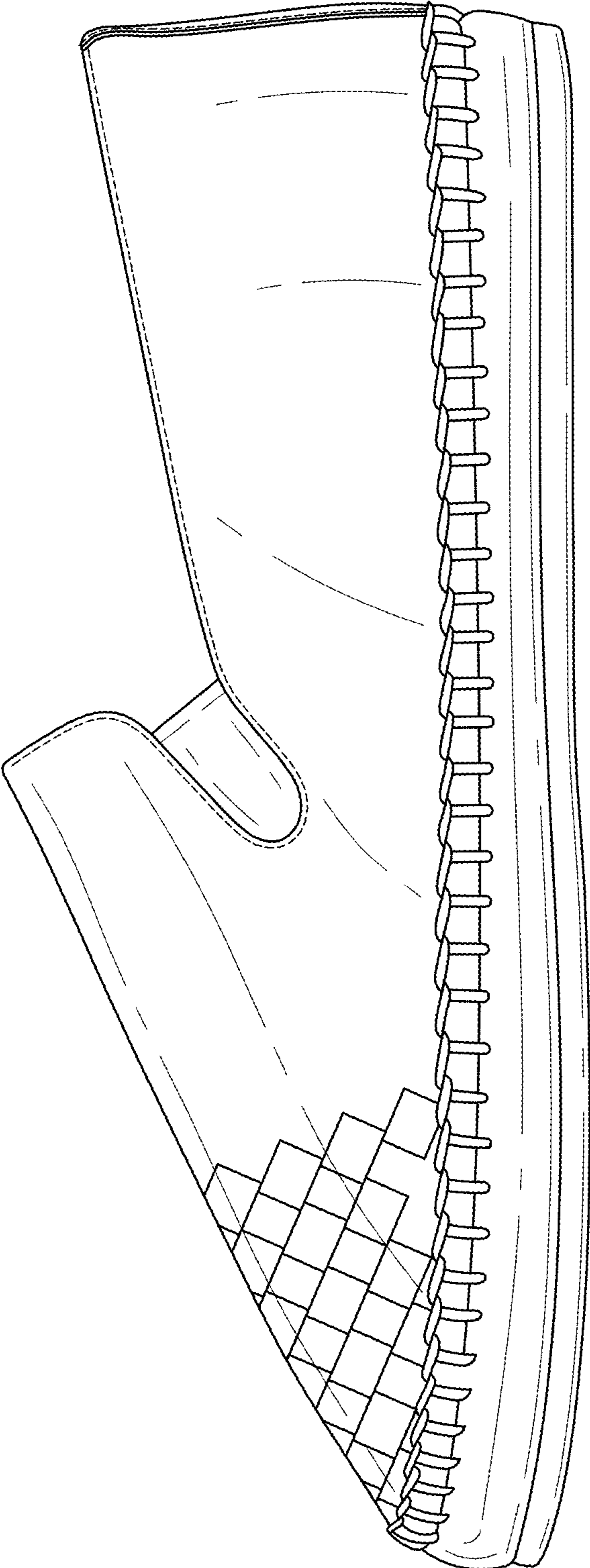

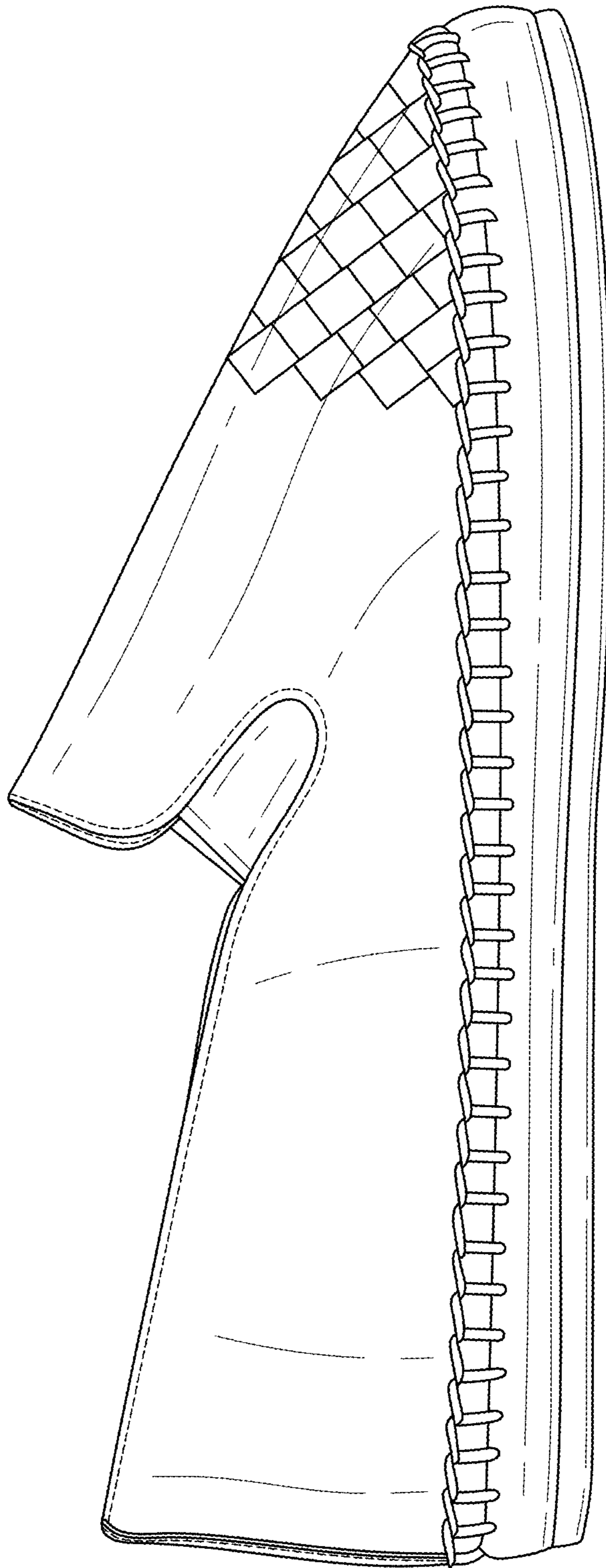

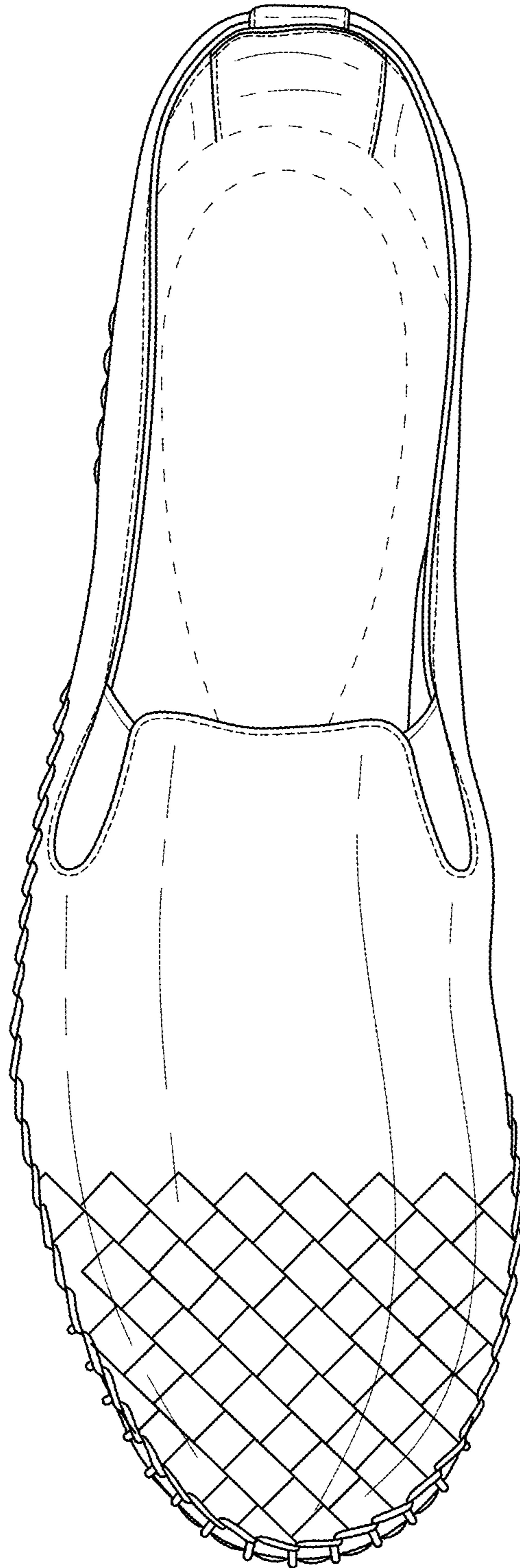




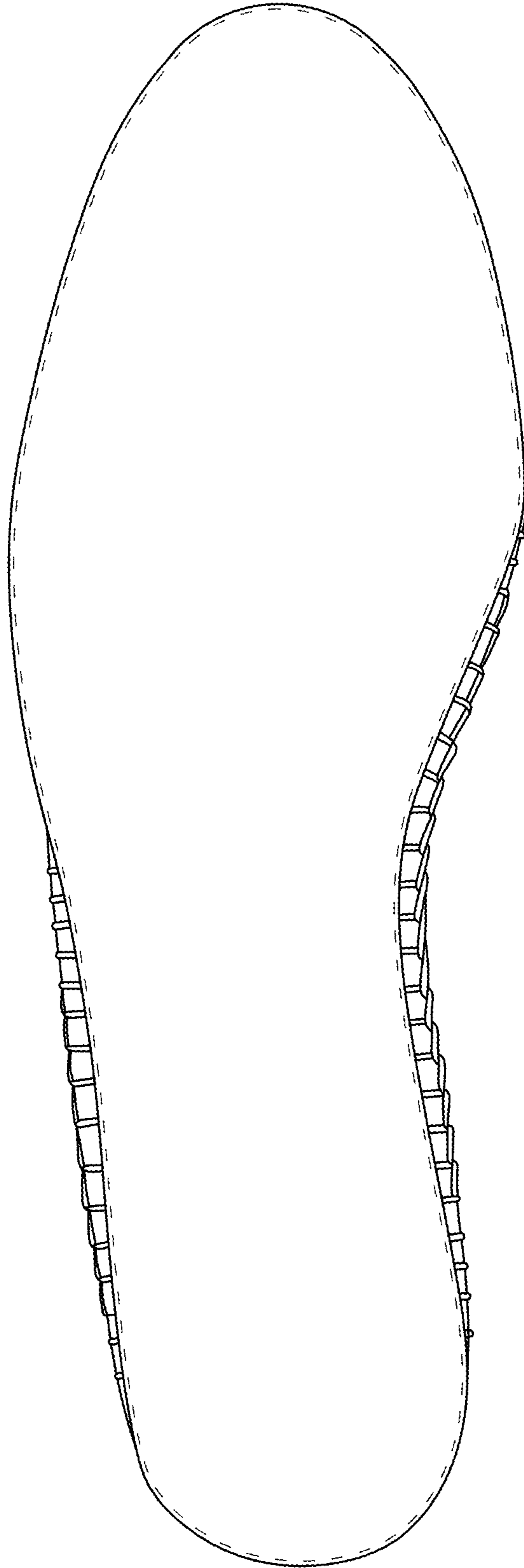
