FIG. 10 is an enlarged view of the claimed region of FIG. 4, shown in isolation from the remainder of the shoe for clarity;

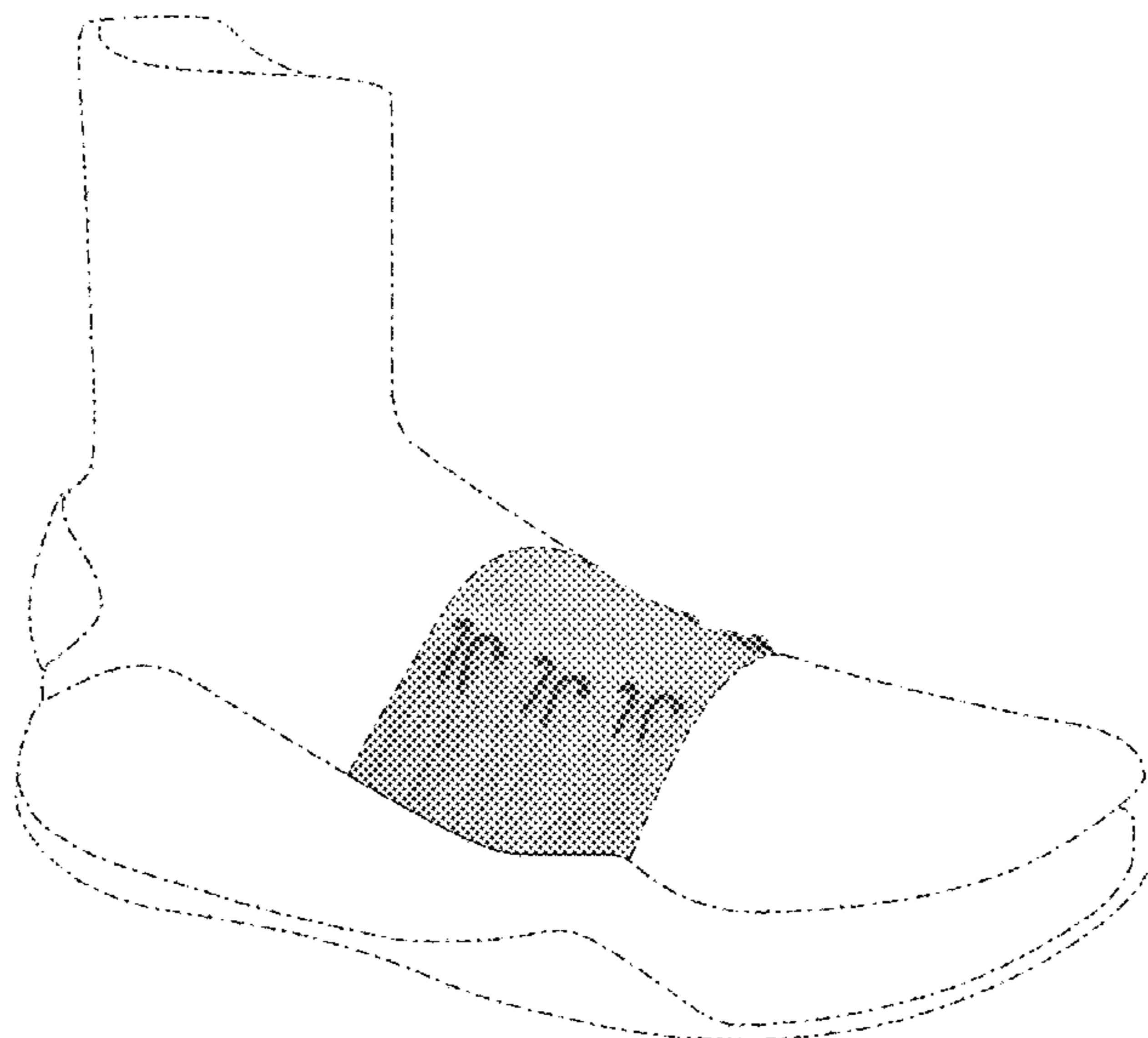
FIG. 11 is an enlarged view of the claimed region of FIG. 5, shown in isolation from the remainder of the shoe for clarity;

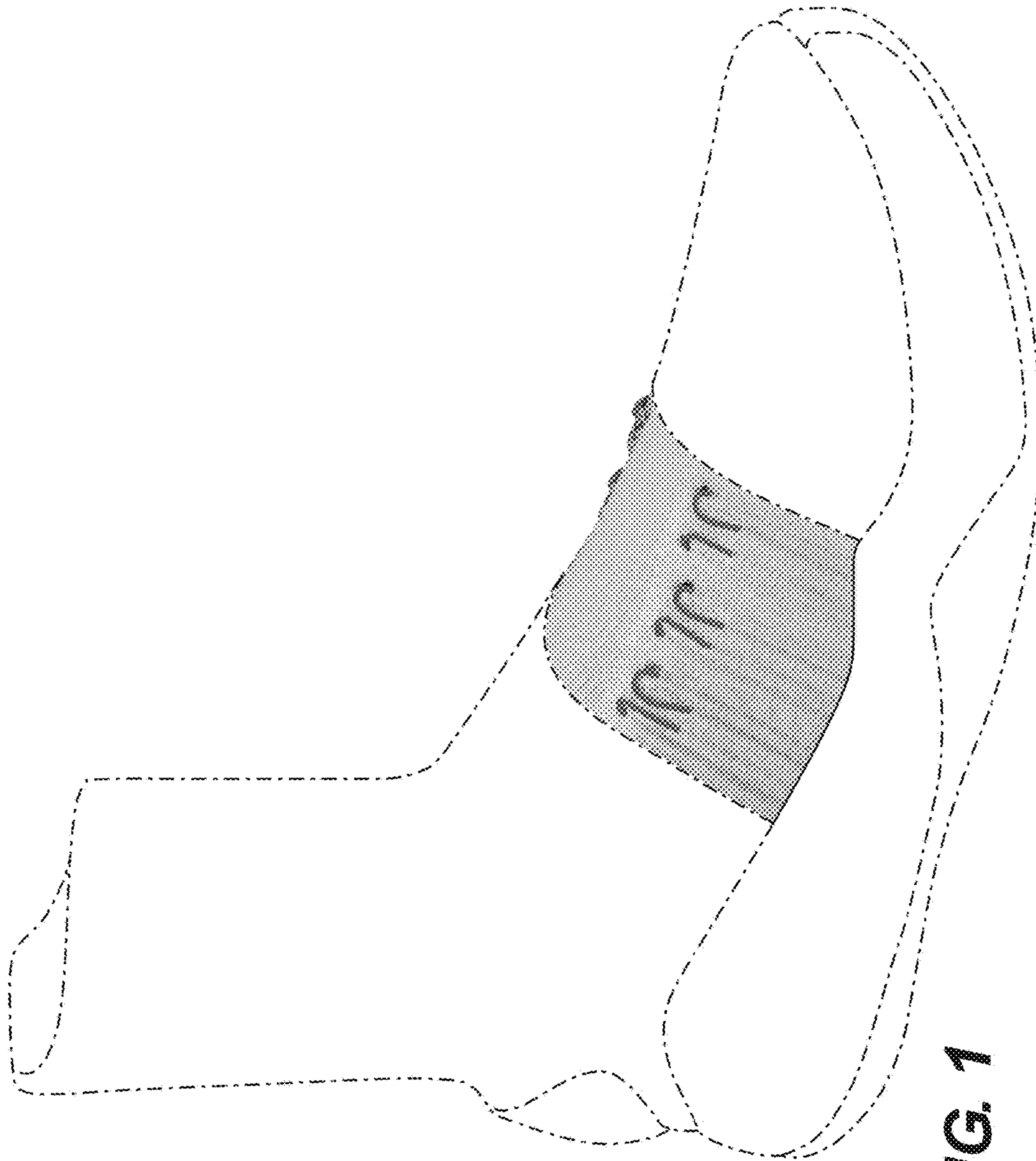

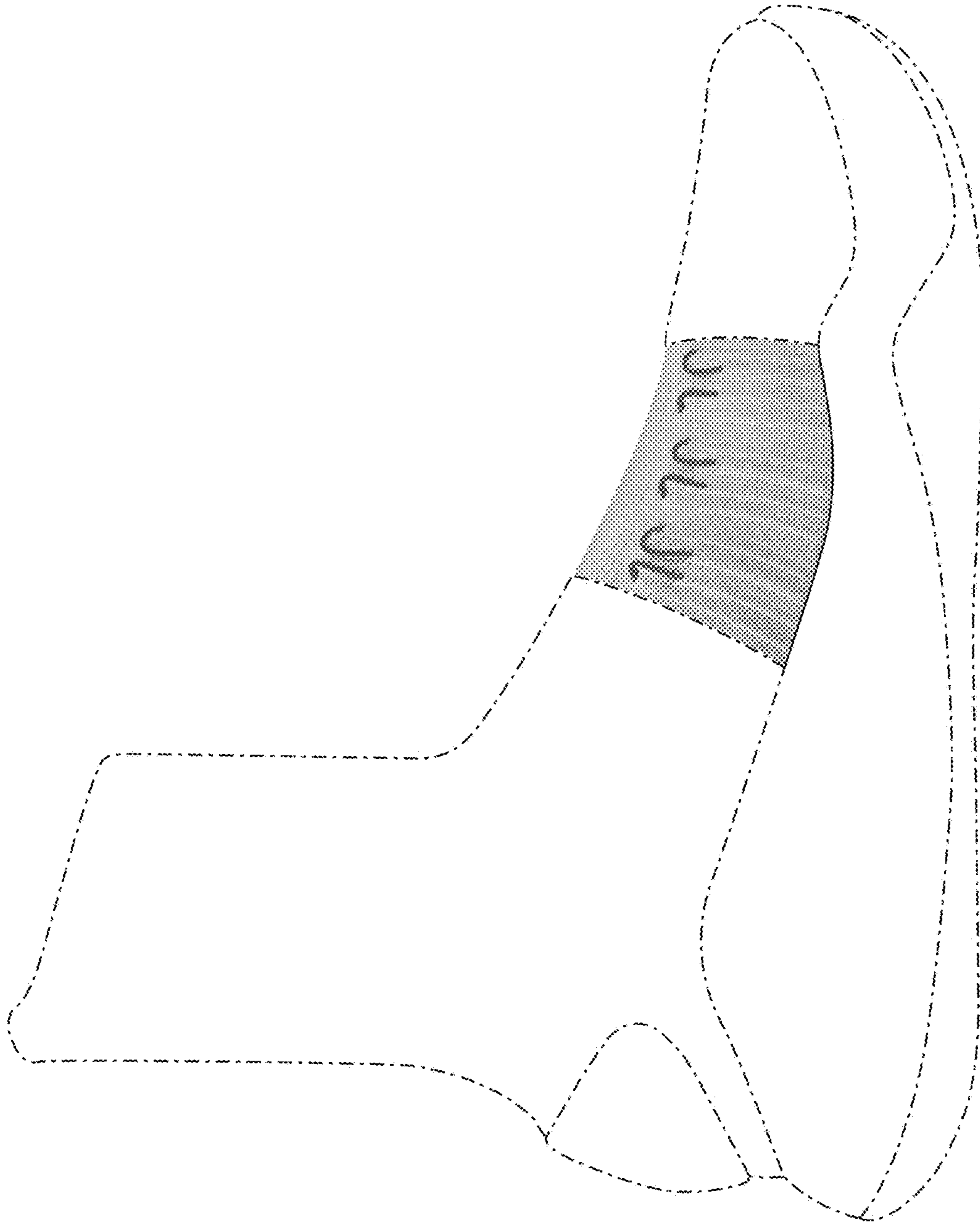

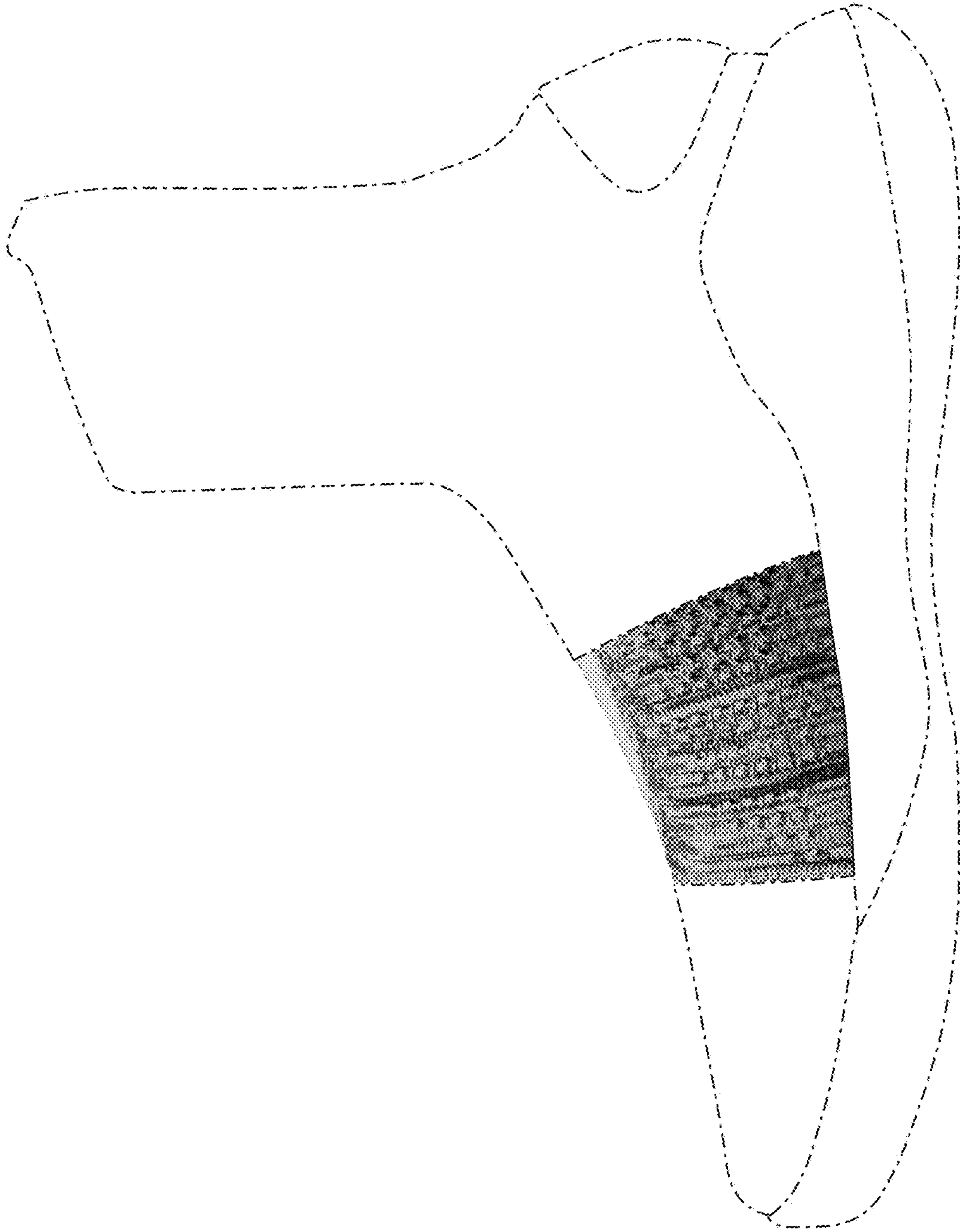

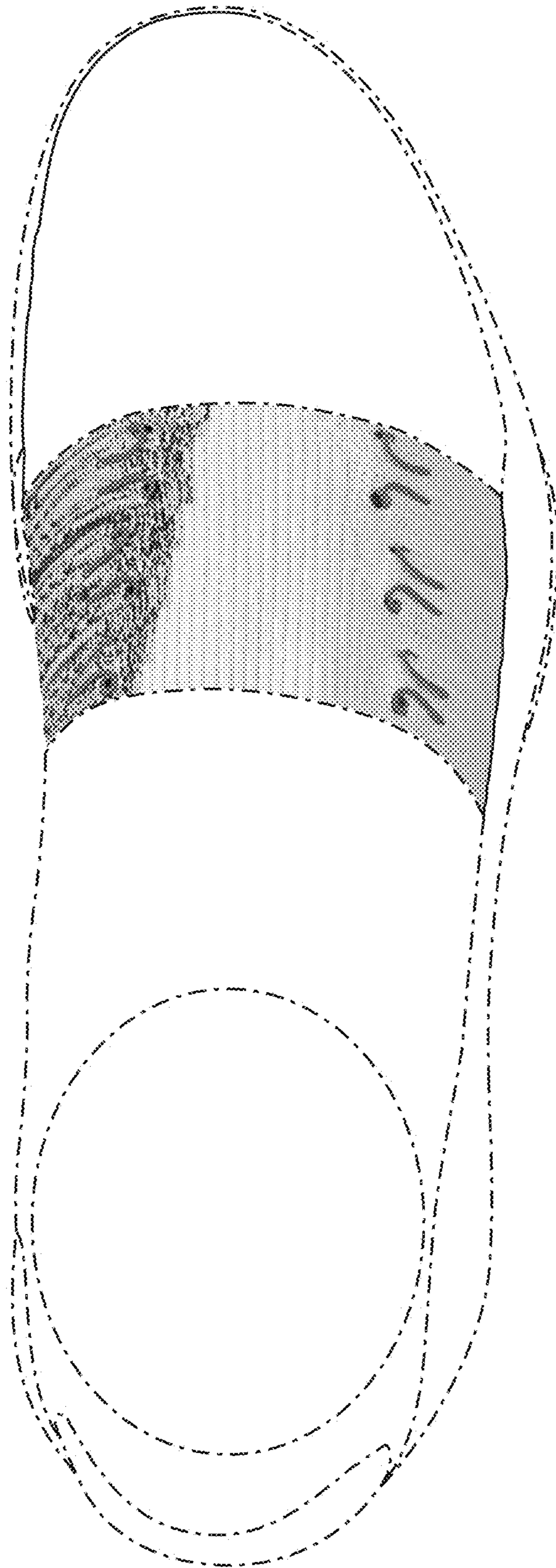

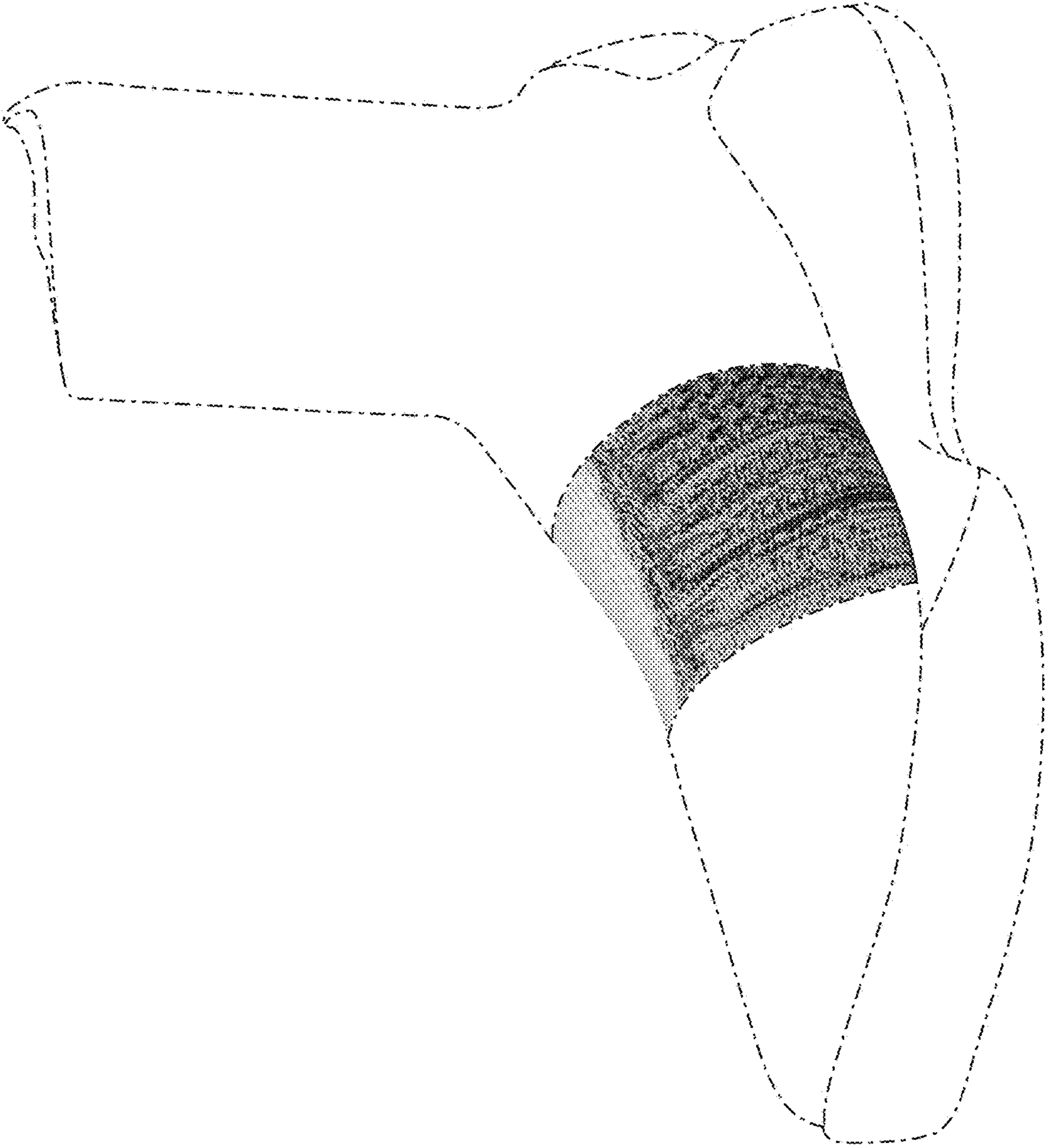

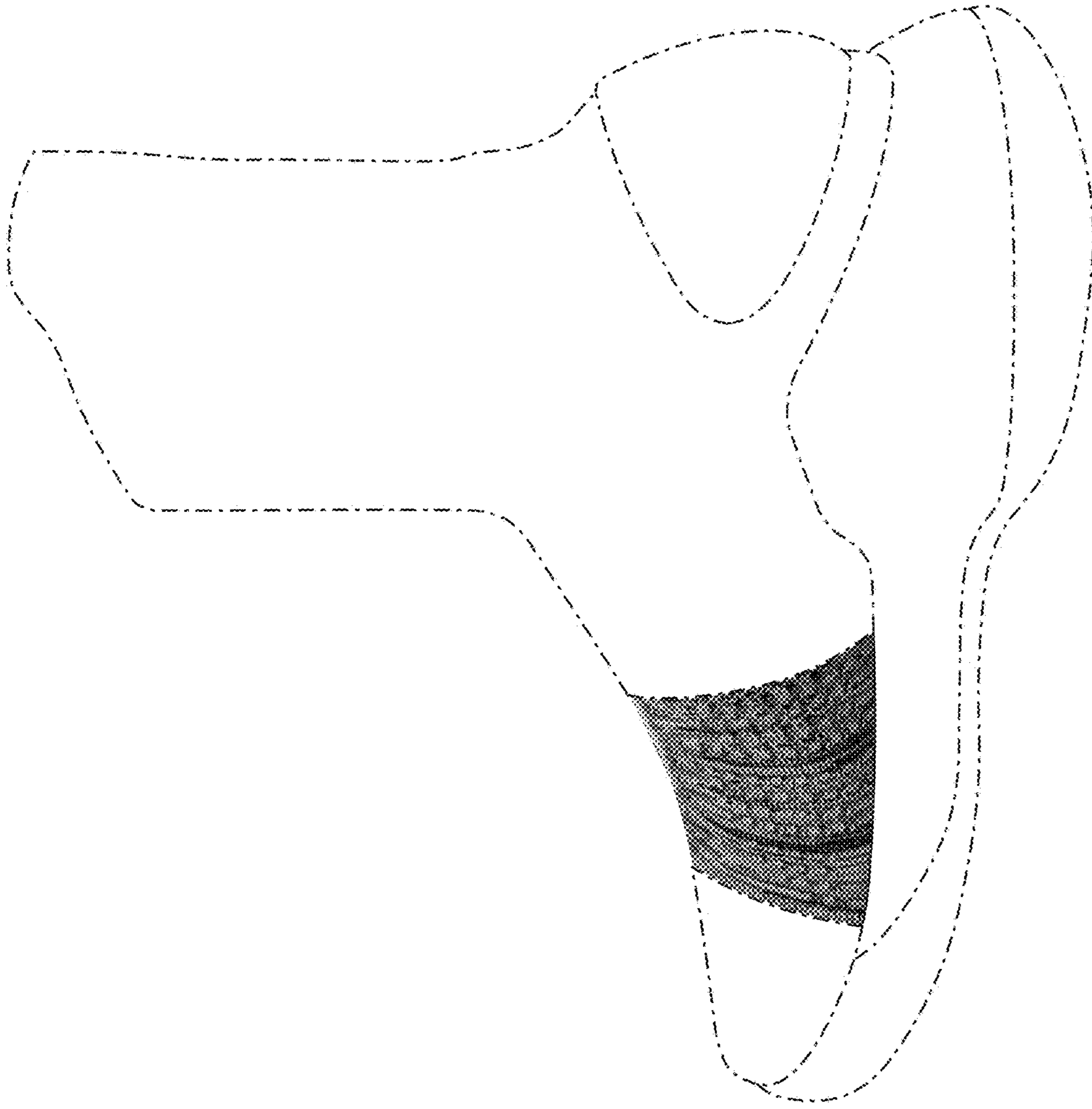

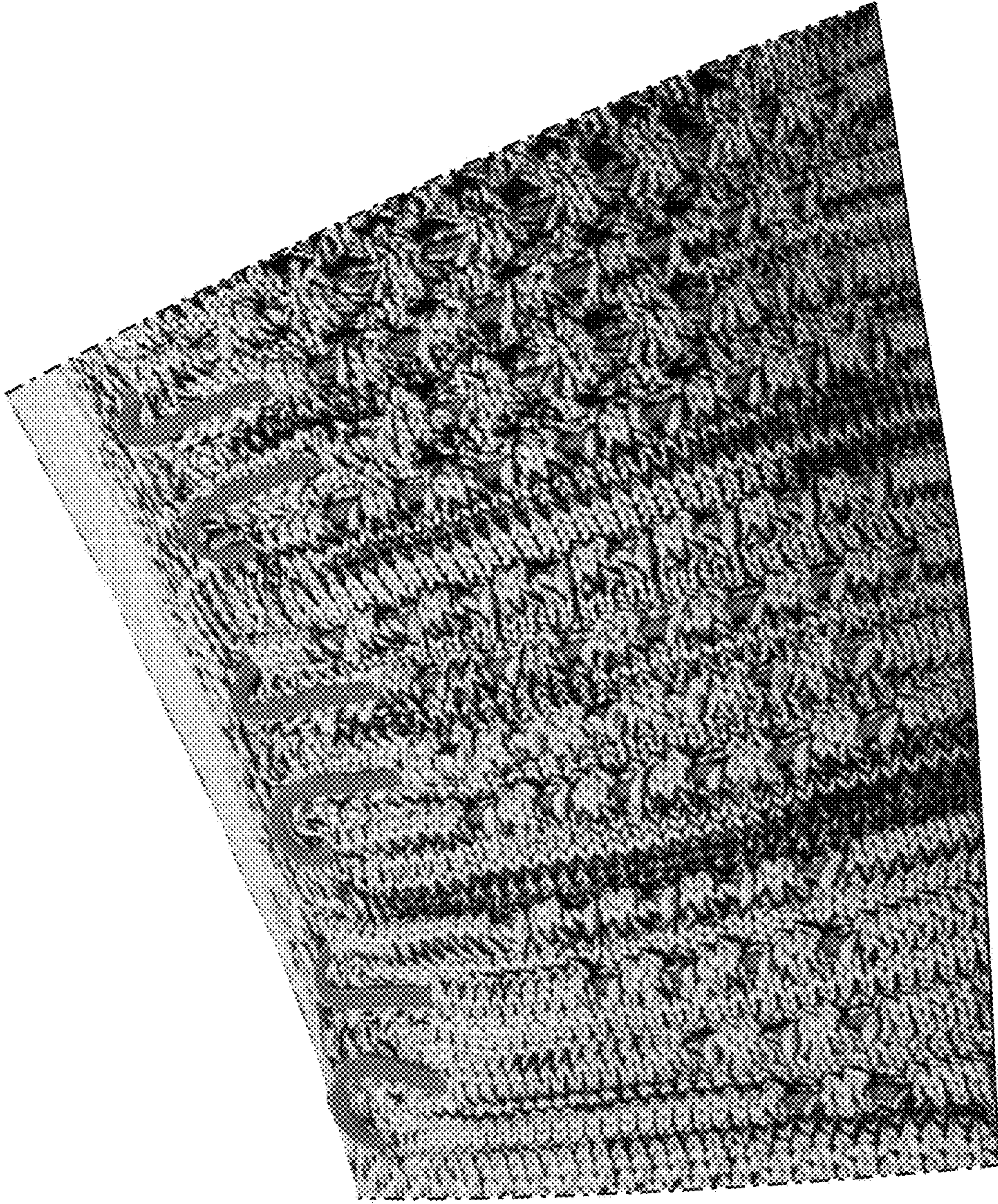




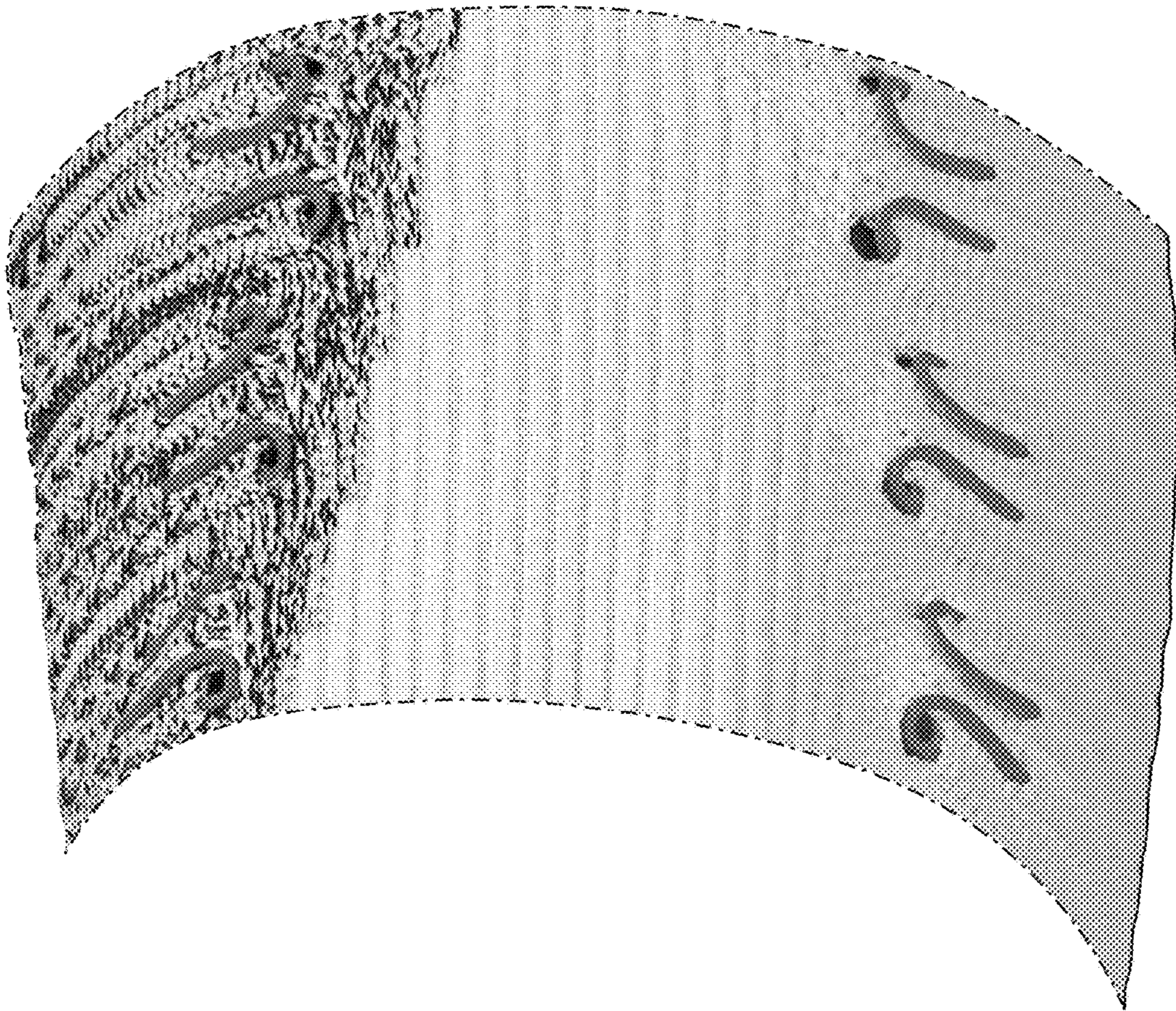

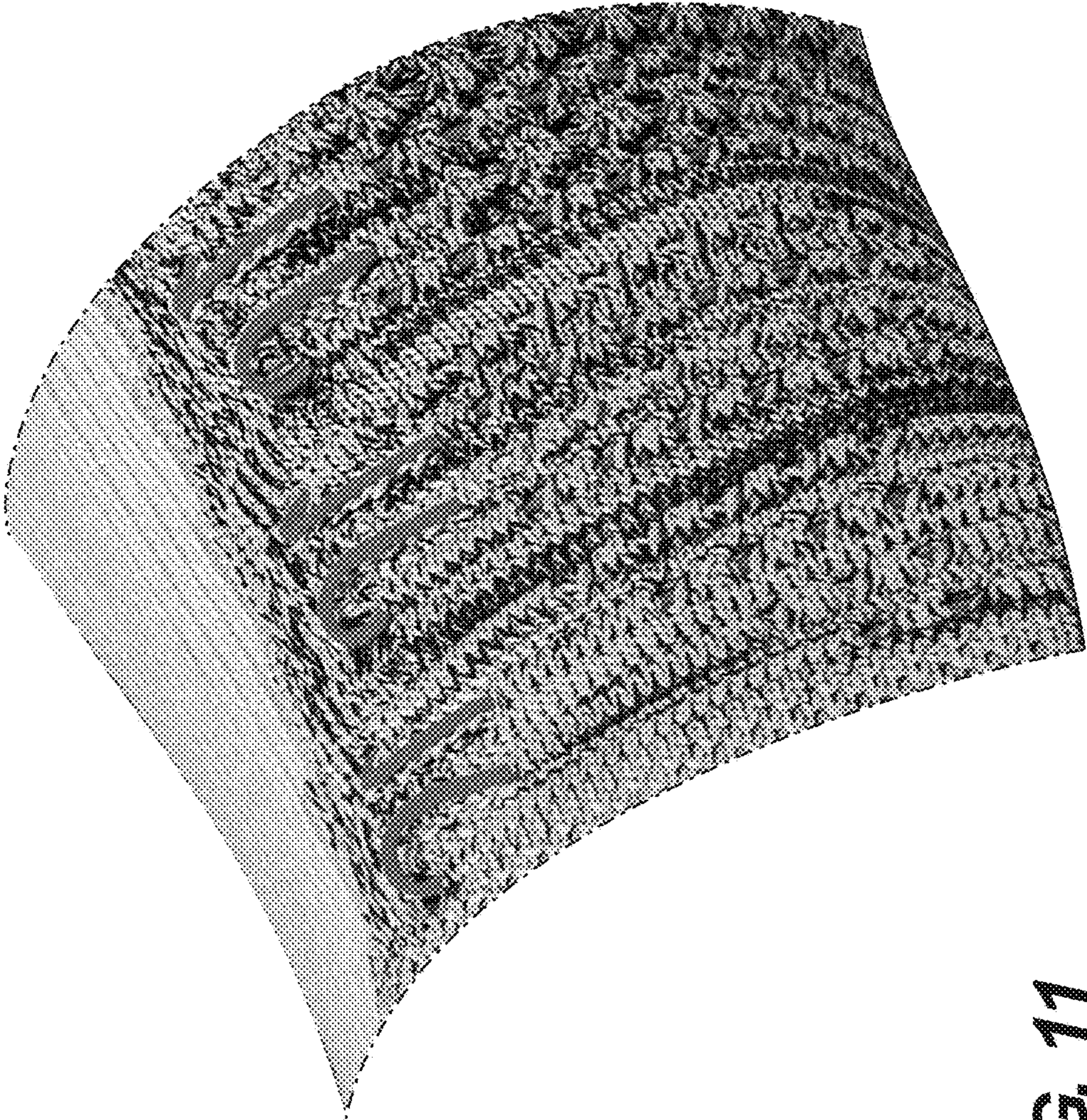

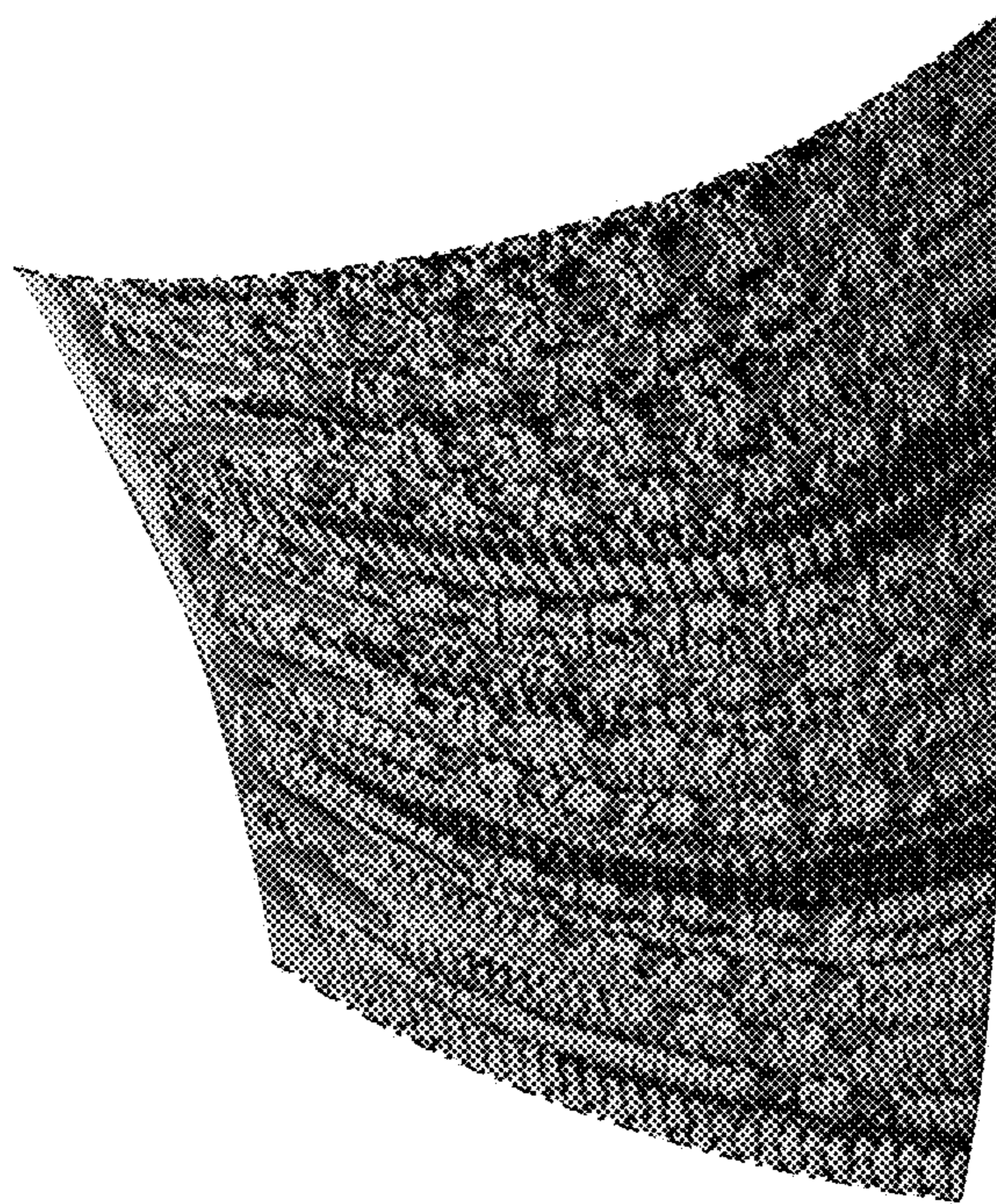
