DESCRIPTION

FIG. 1 is a front view of a bag, showing my new design; FIG. 2 is a perspective view thereof; FIG. 3 is a back view thereof; FIG. 4 is a bottom view thereof; FIG. 5 is a top view thereof; FIG. 6 is a right side thereof. FIG. 7 is a top perspective view thereof, shown in an open configuration; and, FIG. 8 is a second front view thereof, shown with a removable strap. The broken lines depict unclaimed portions of the bag.

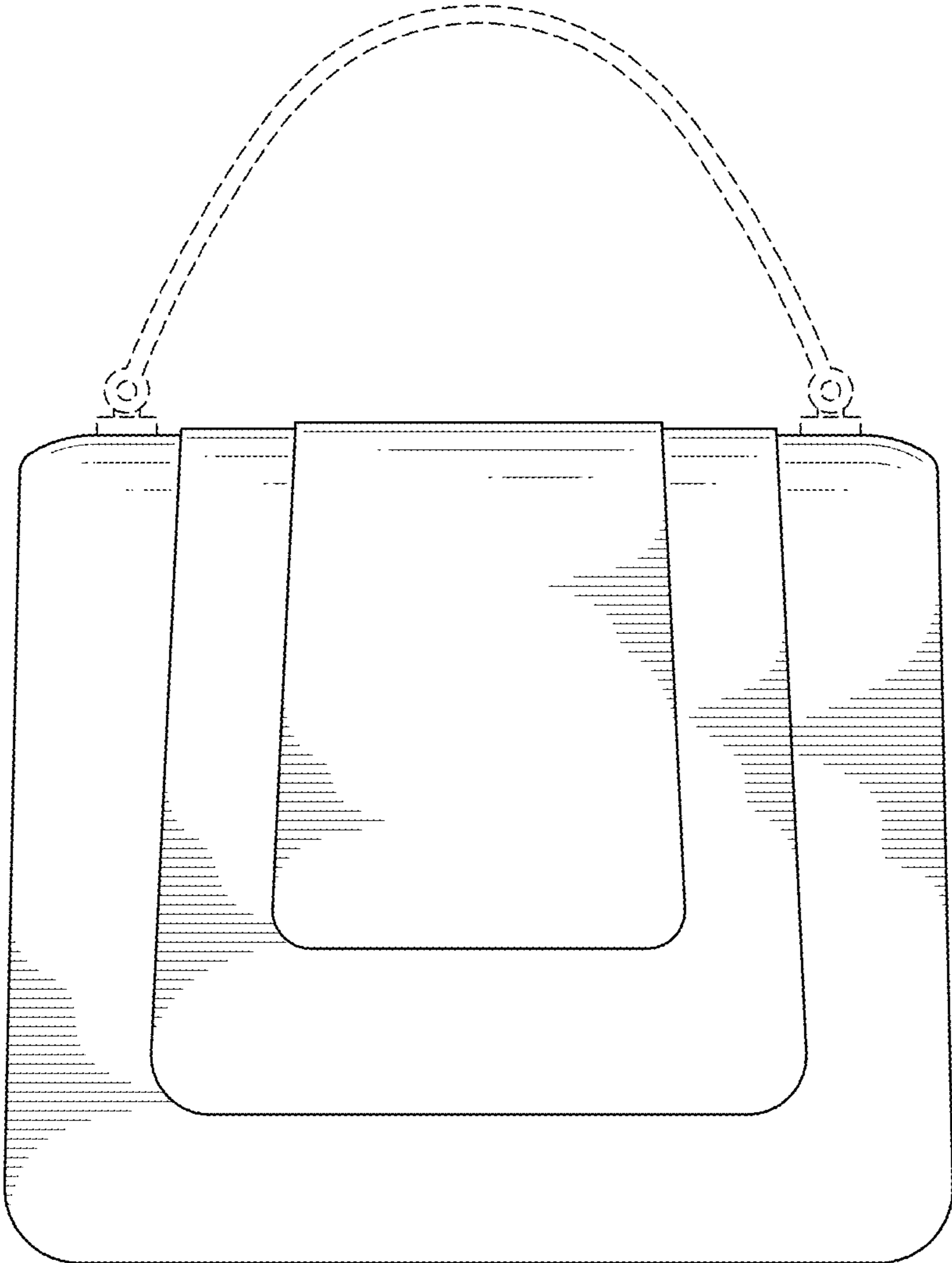

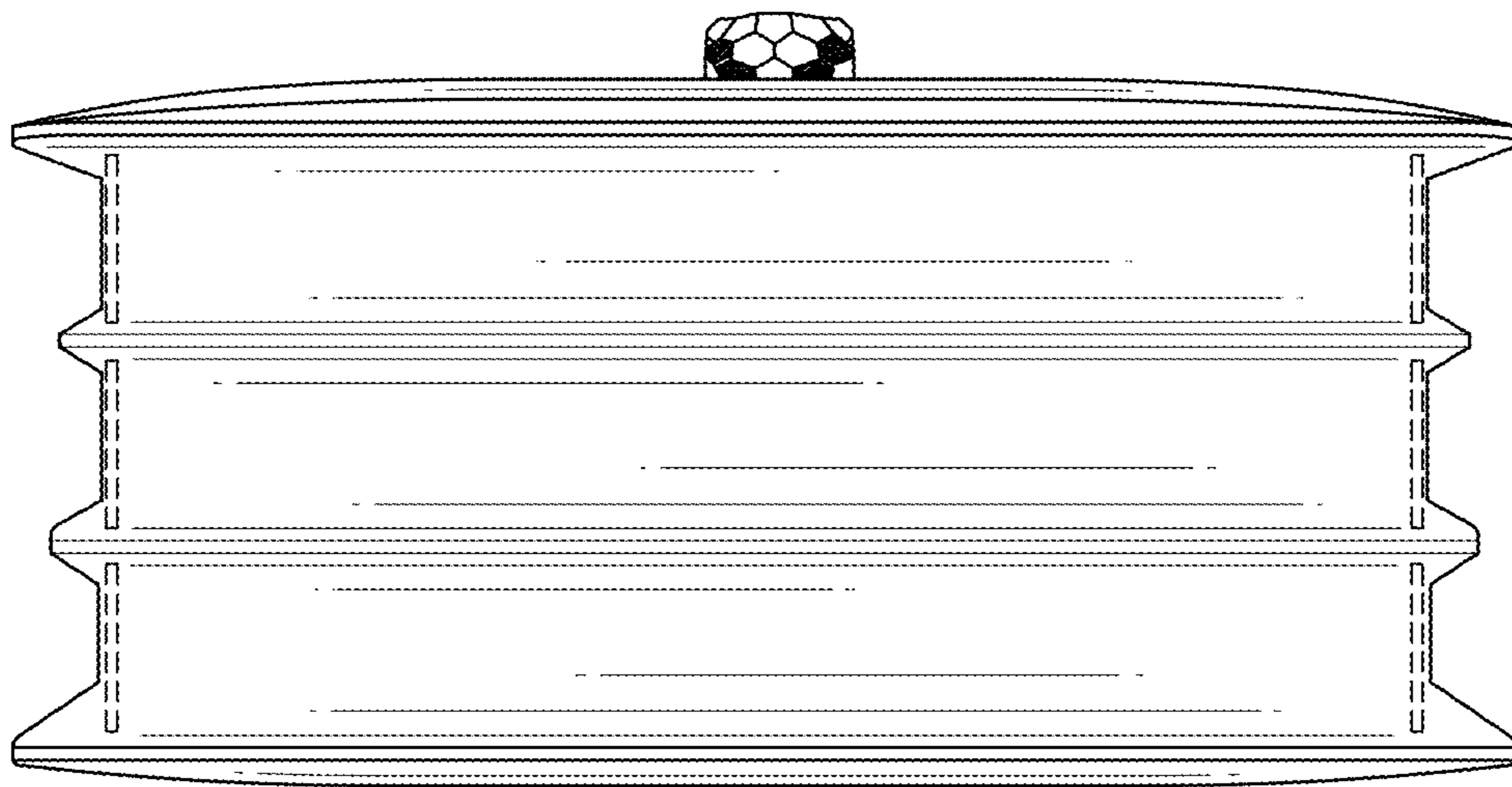

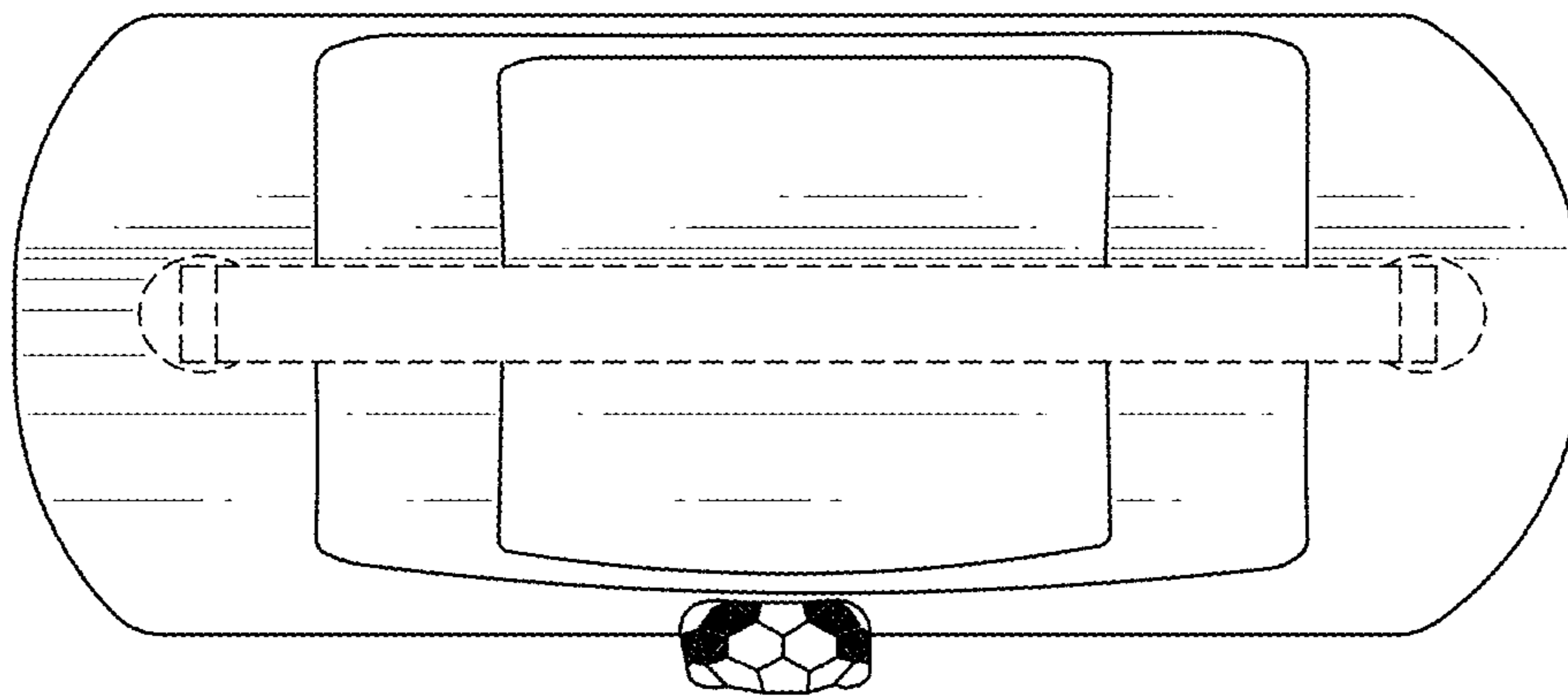

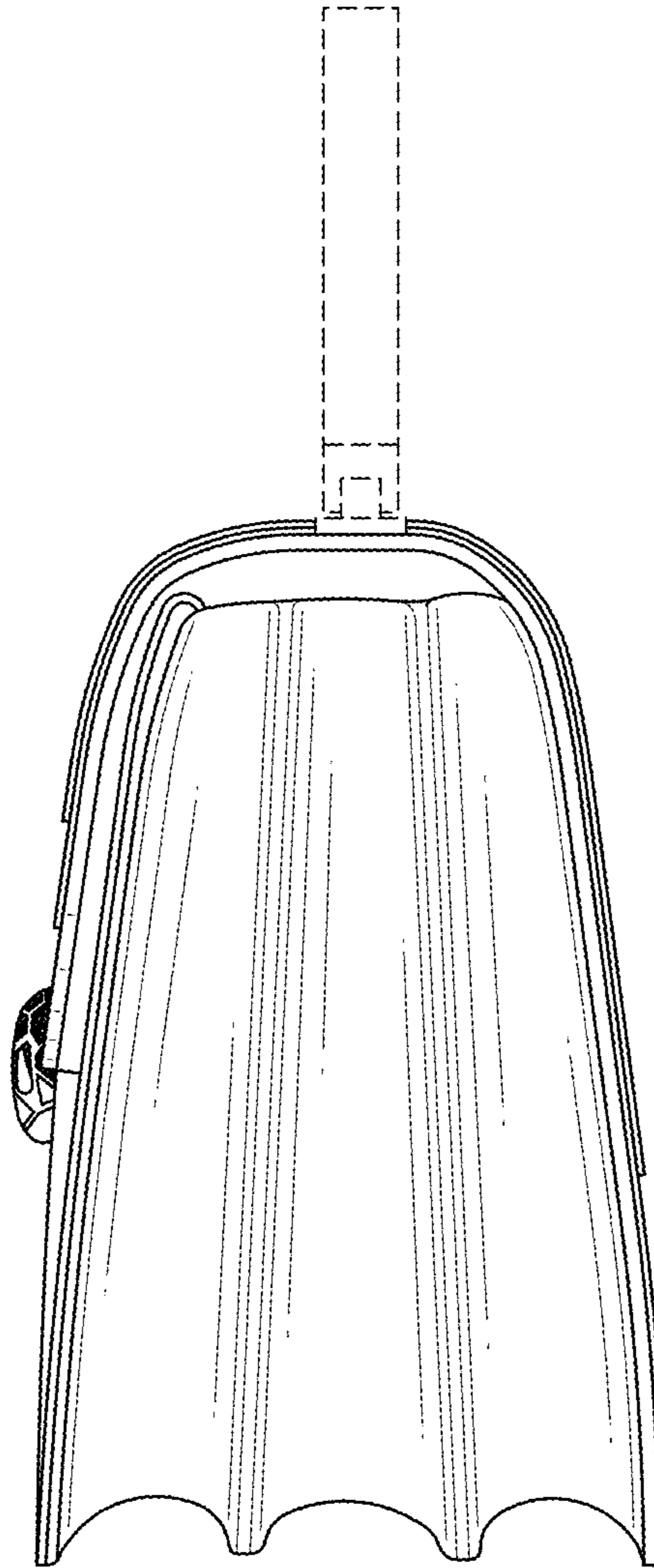

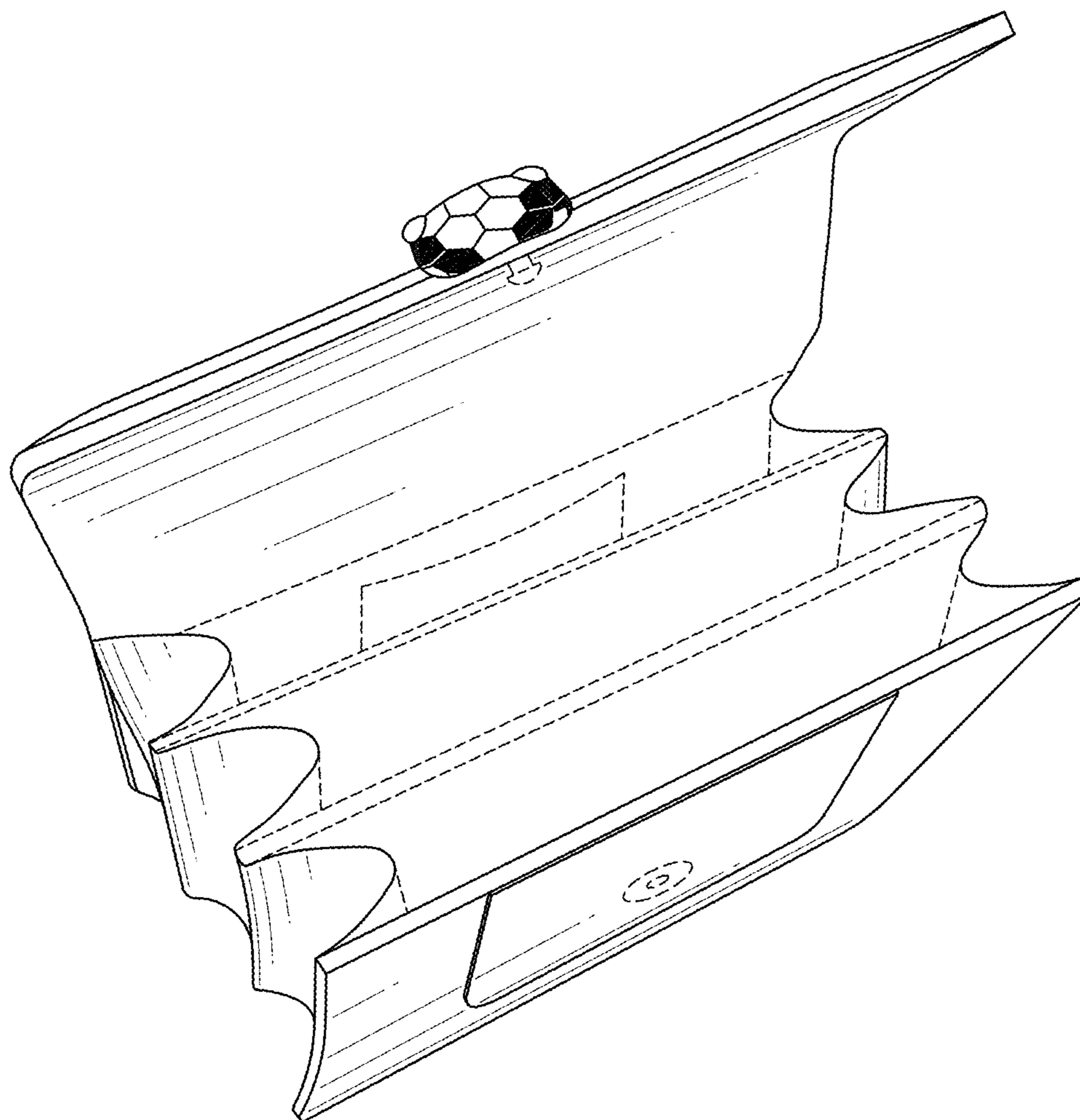
