FIG. 6 is a top perspective view of a basket, showing the second embodiment of the new design;

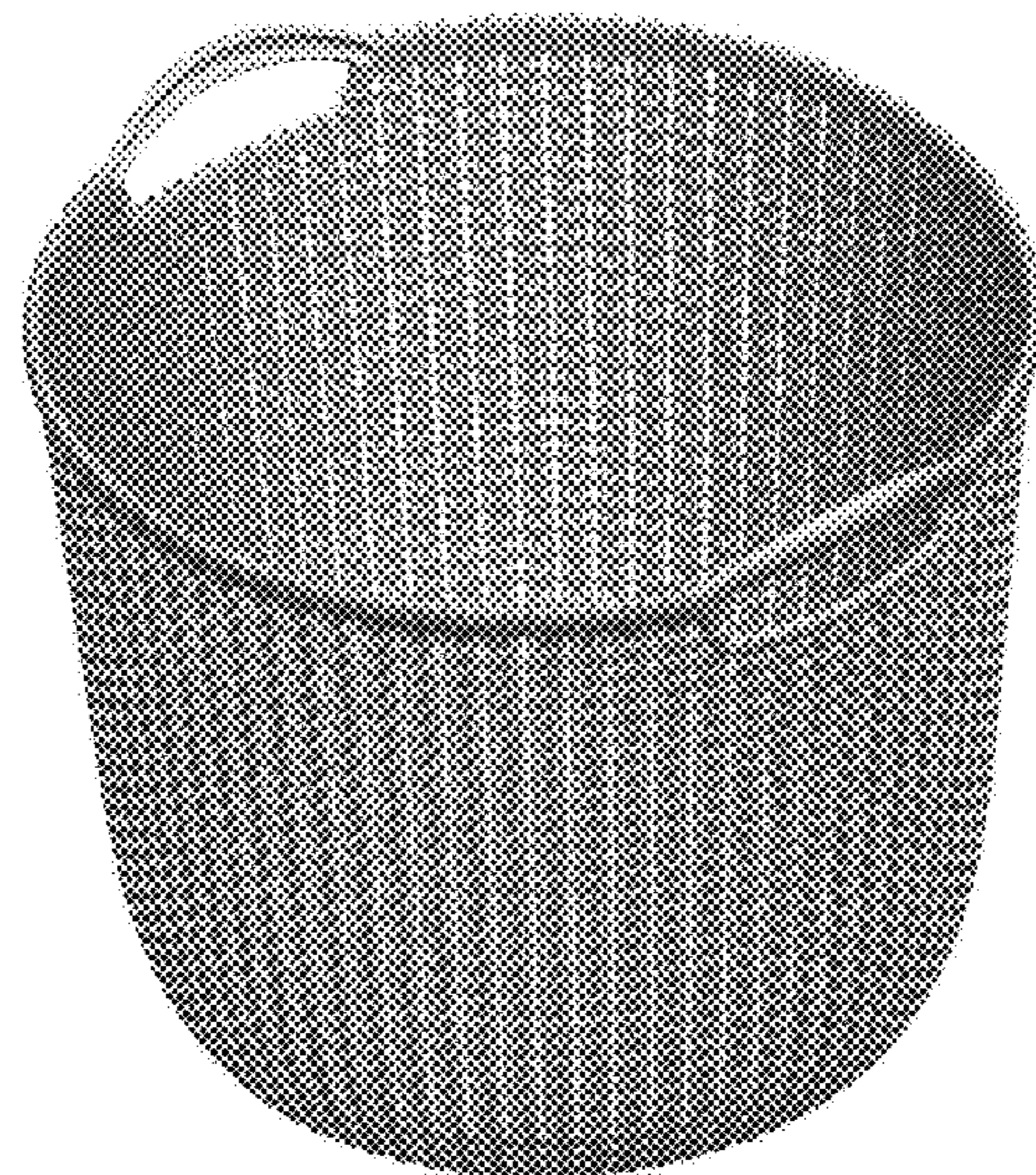
FIG. 7 is a front view of the basket shown in FIG. 6; rear view being identical;

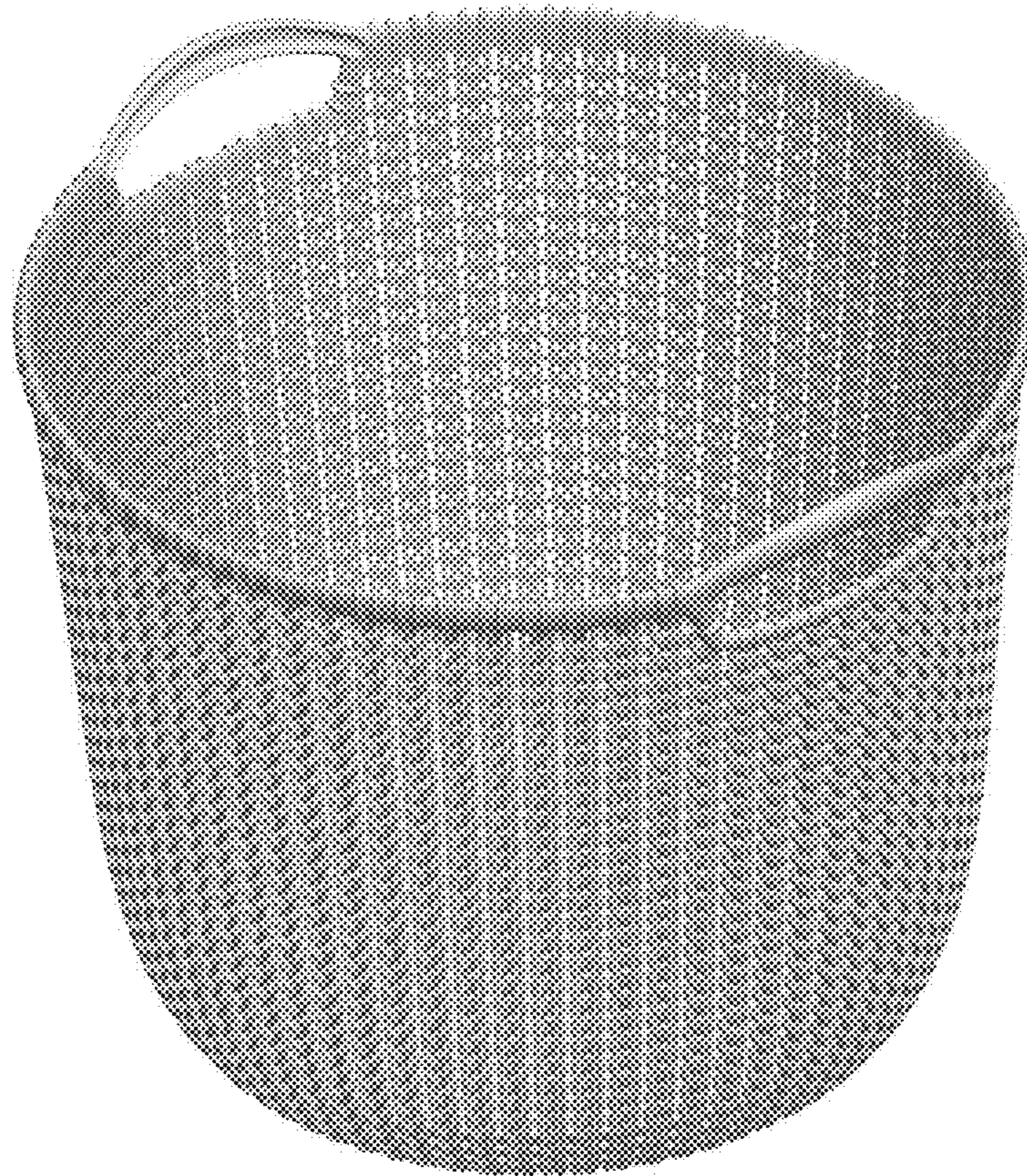

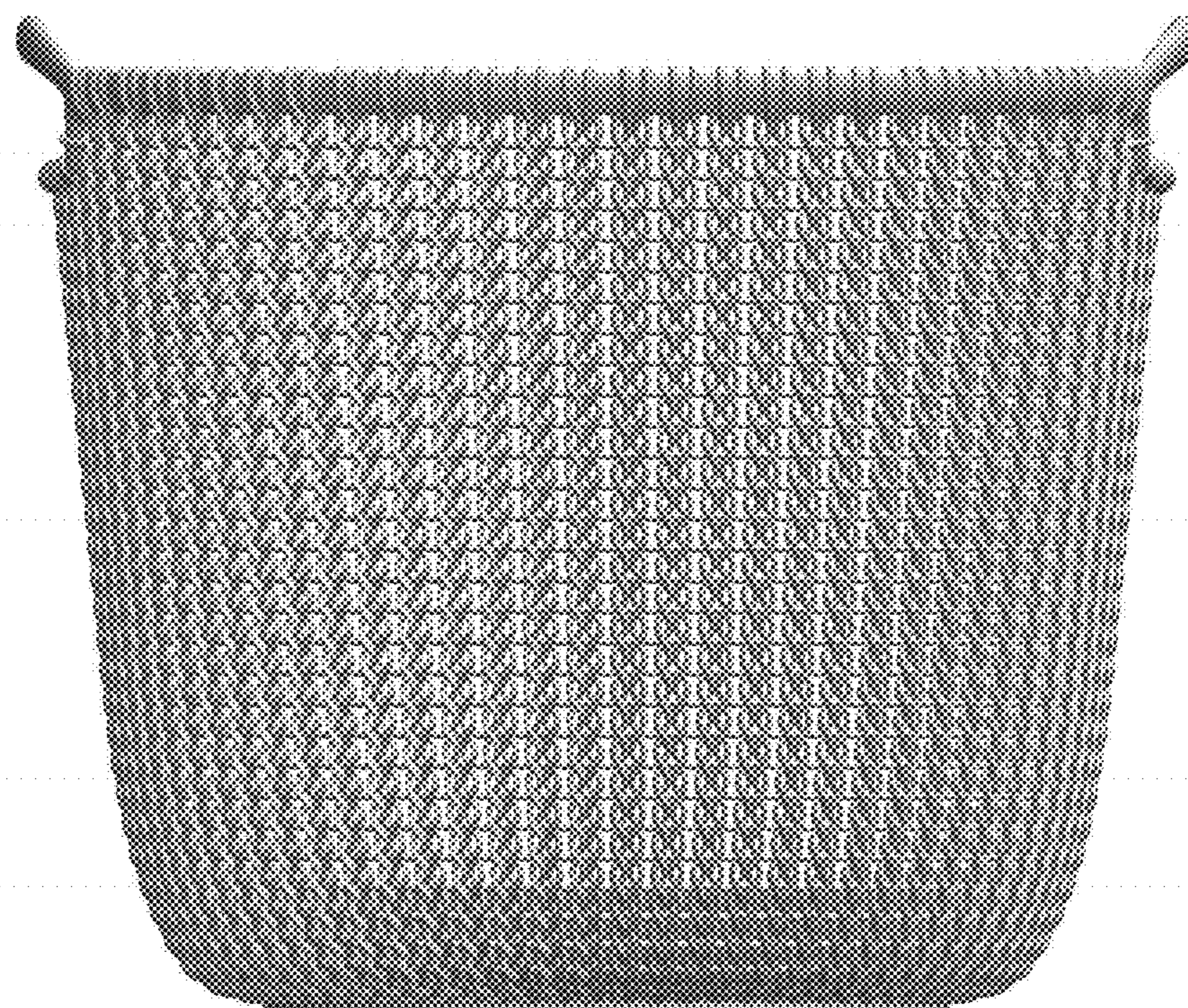

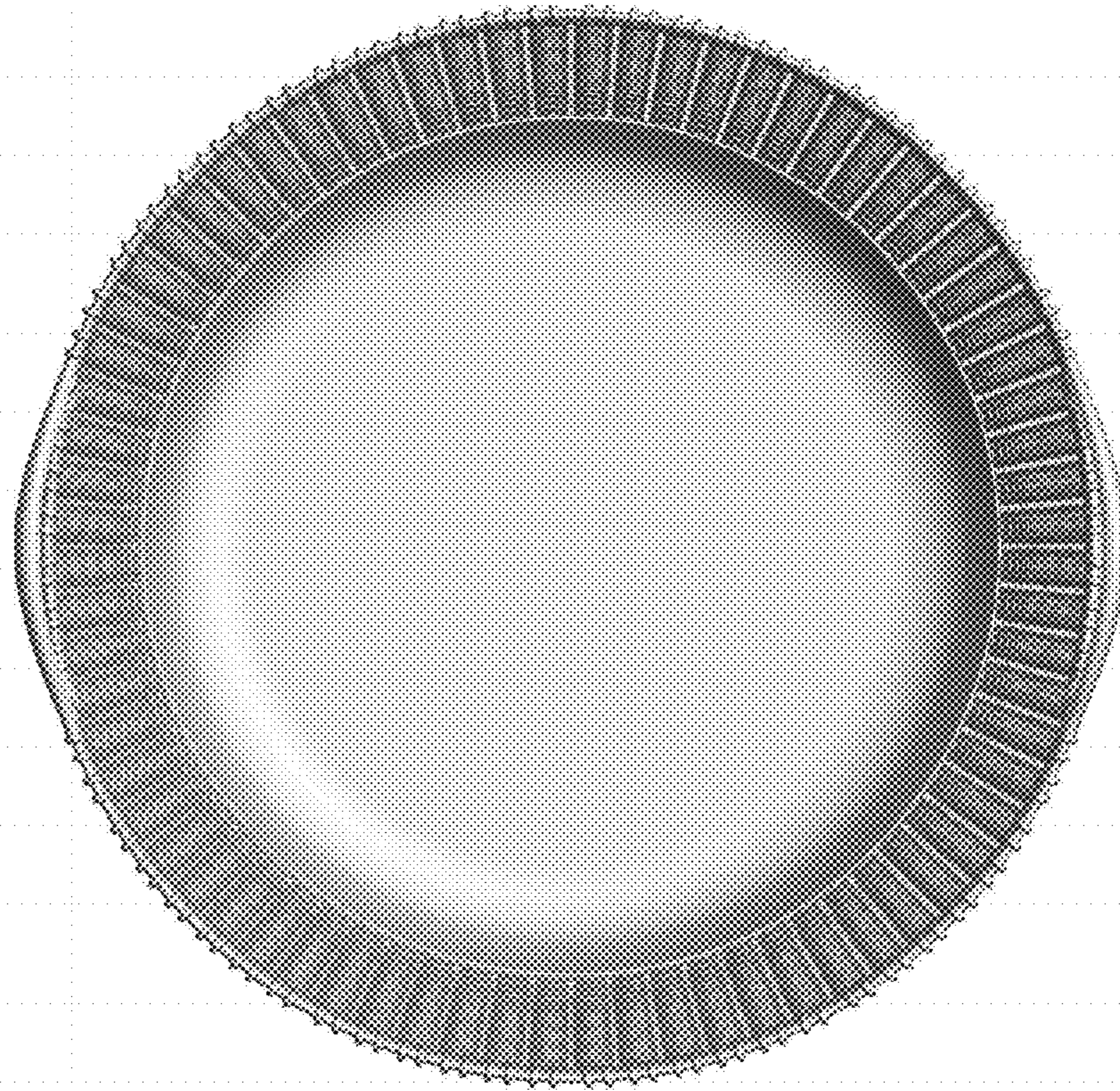

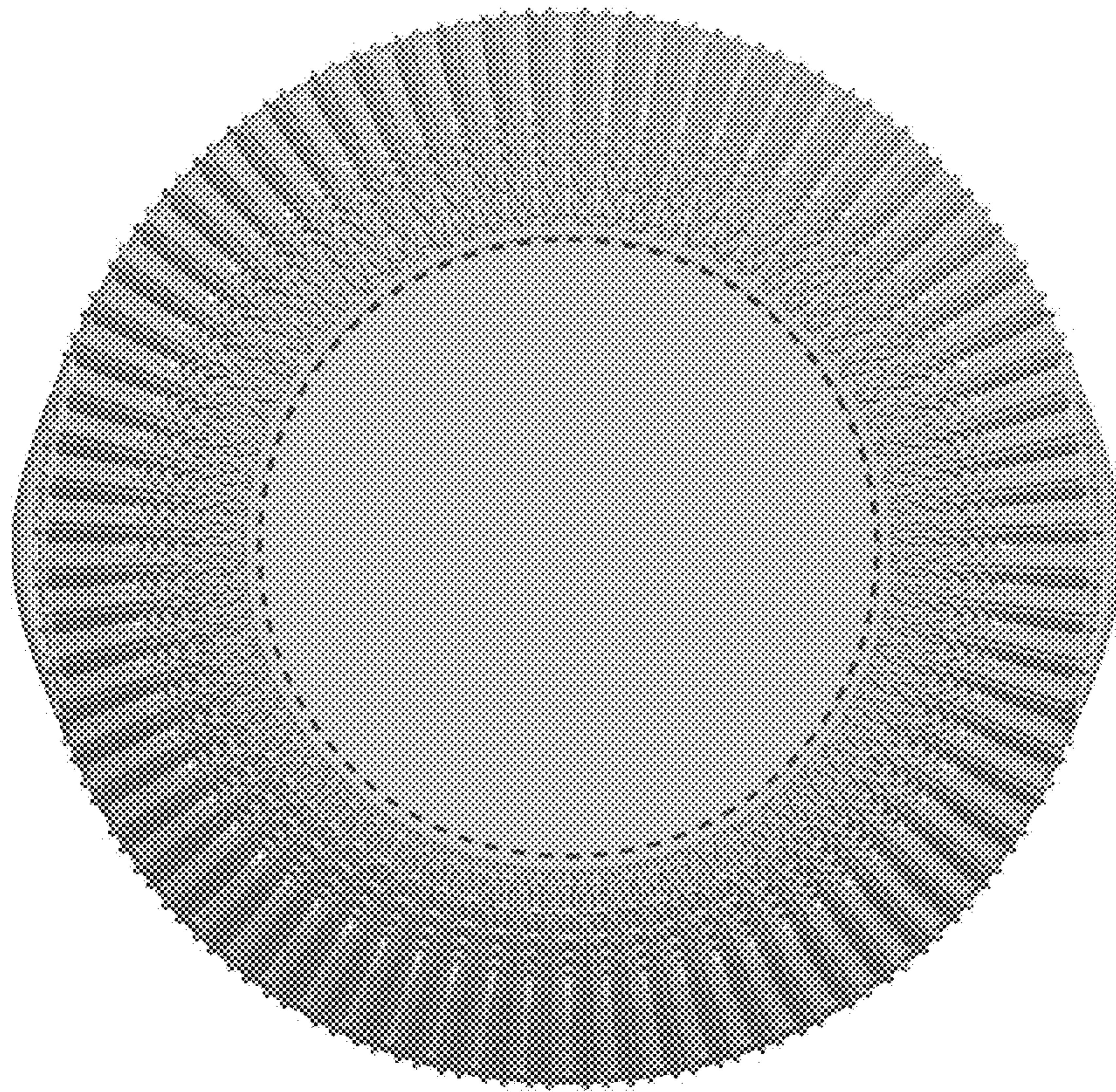

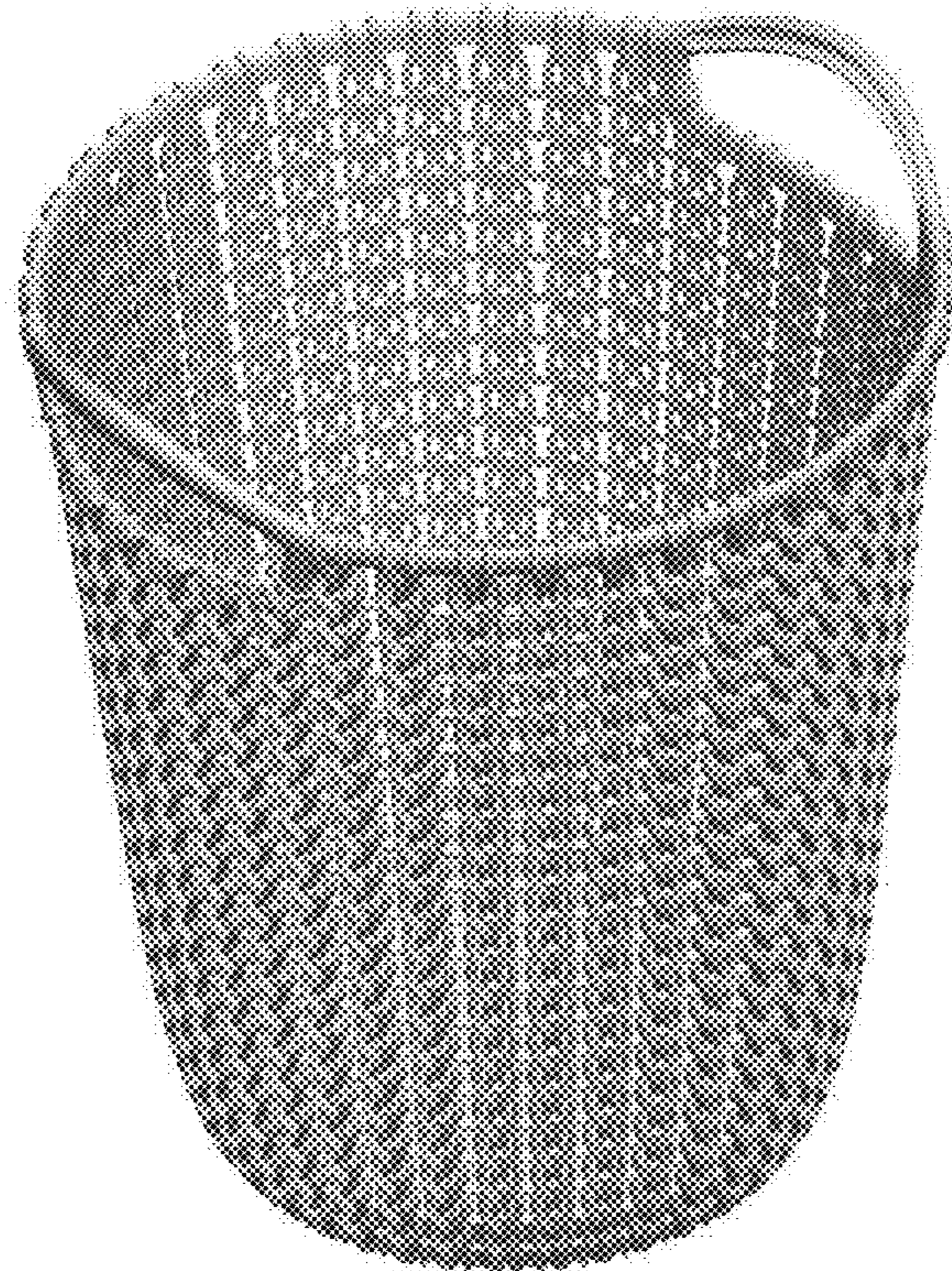

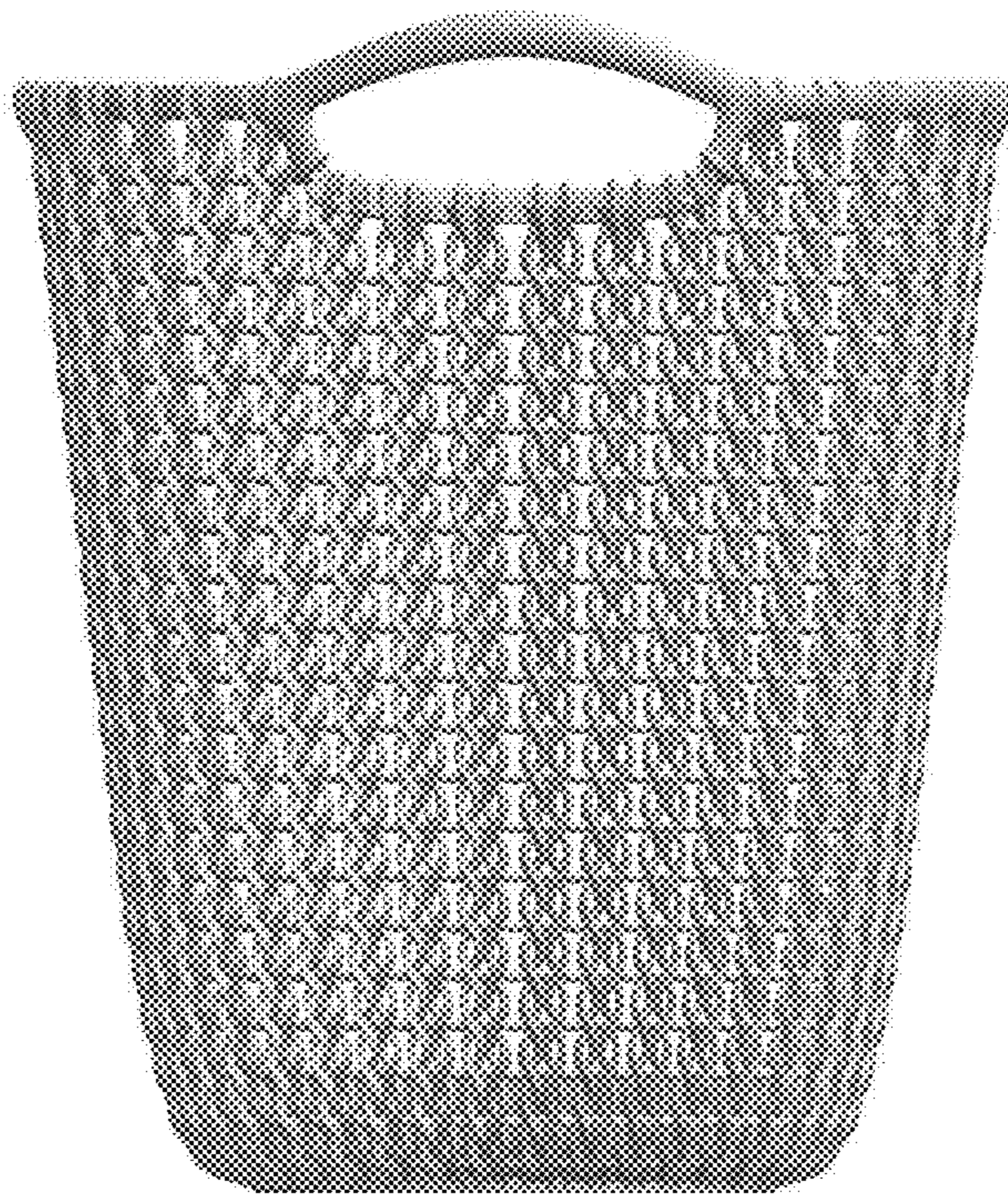

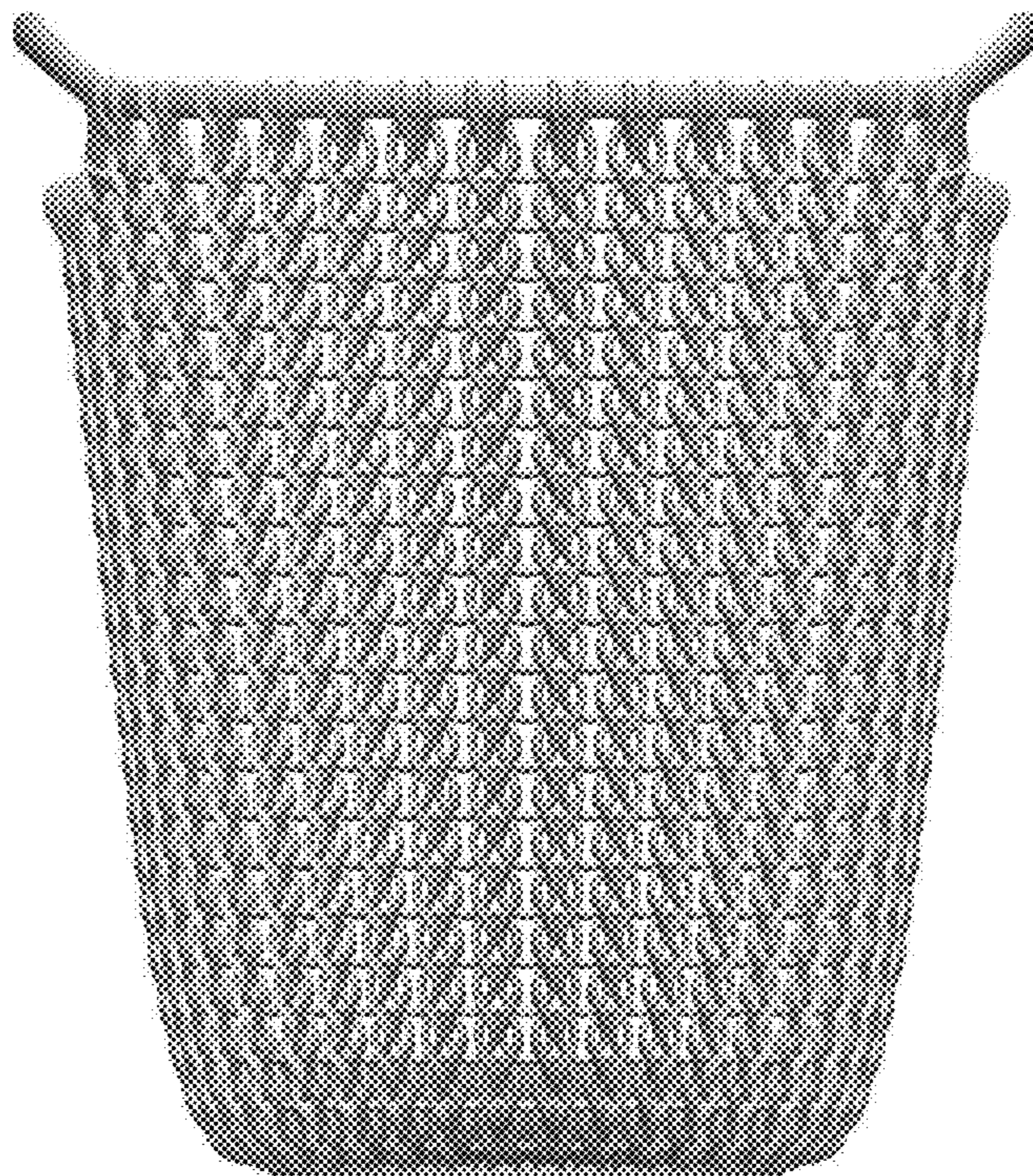

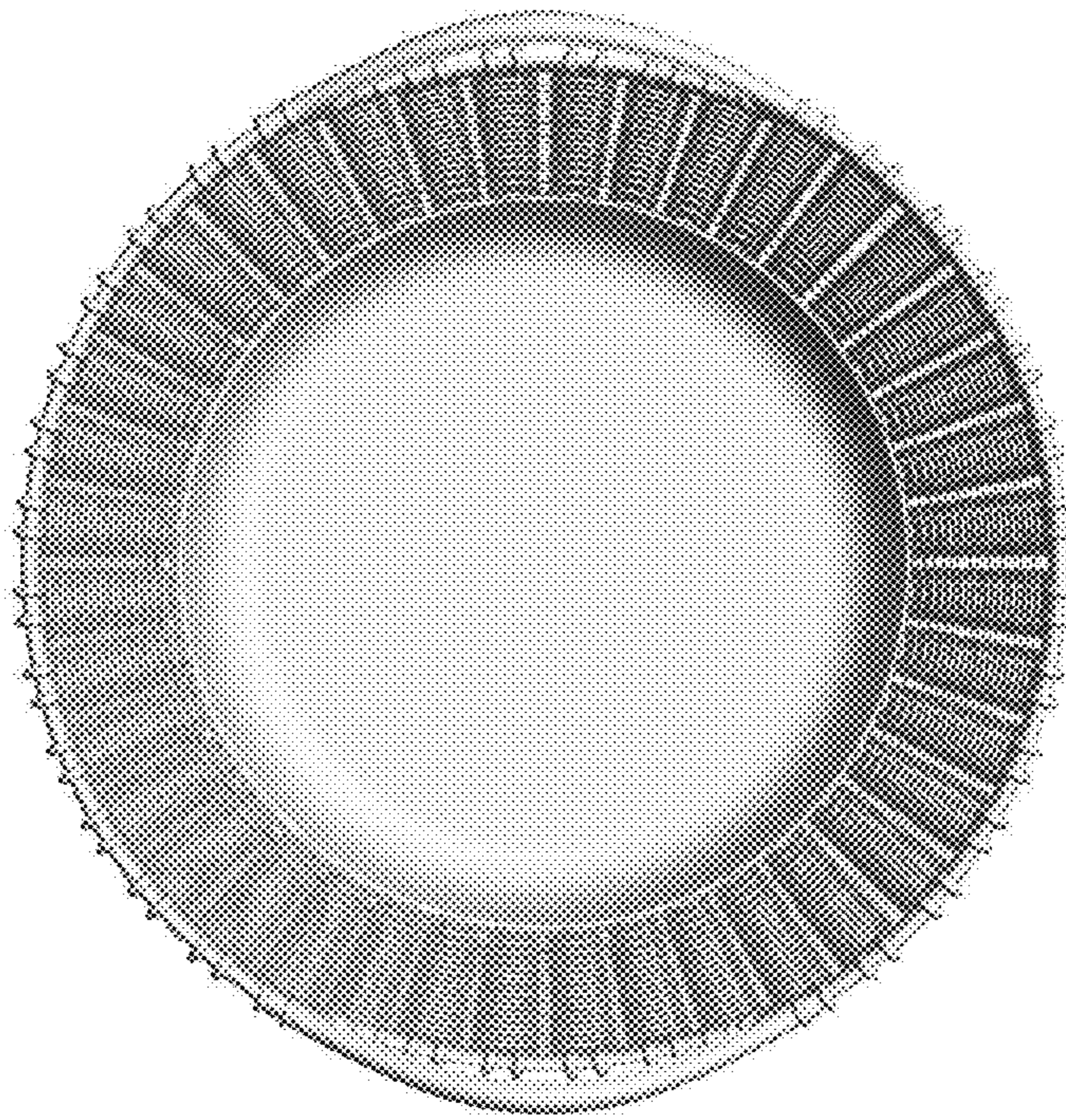

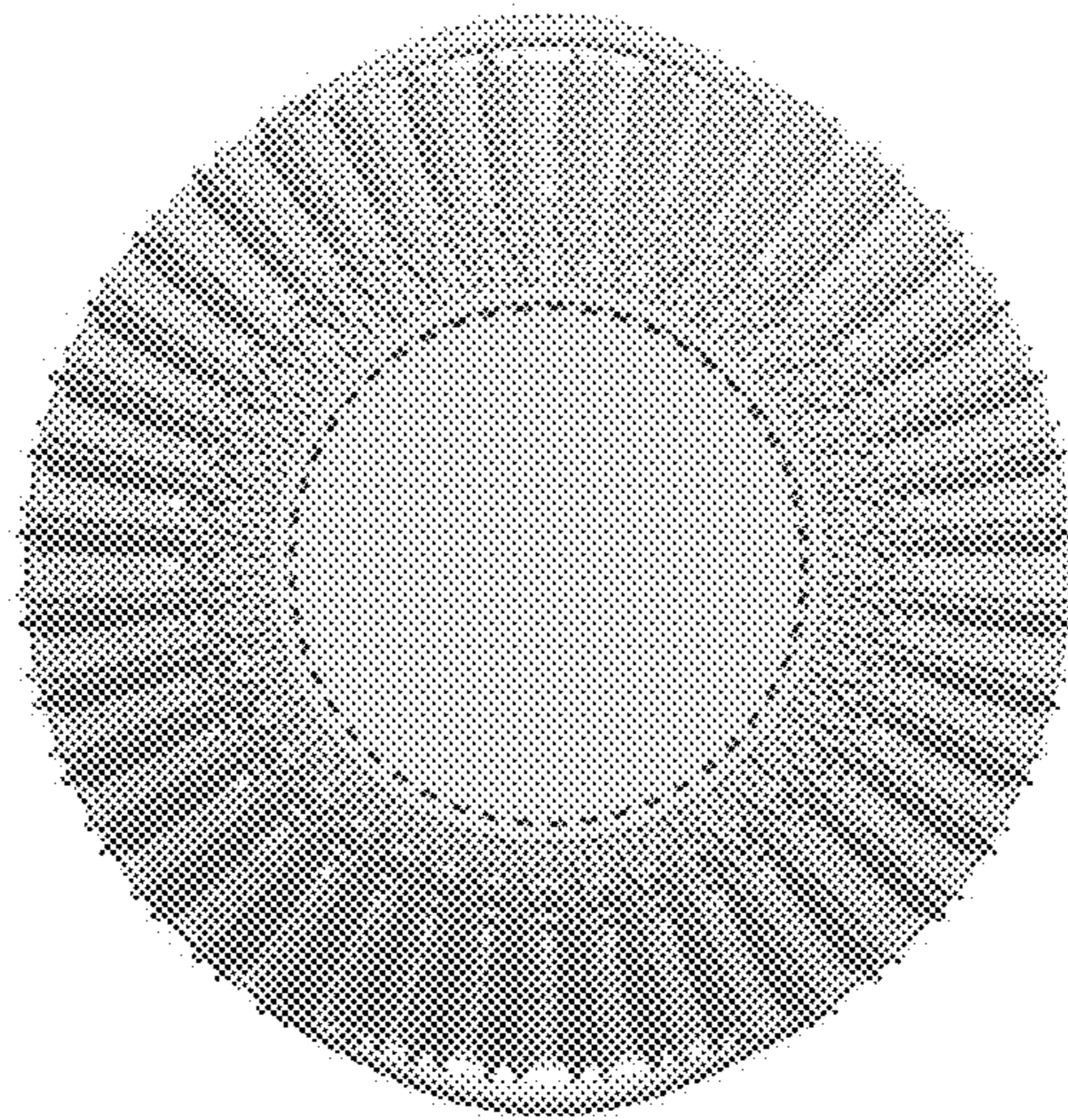
