DESCRIPTION

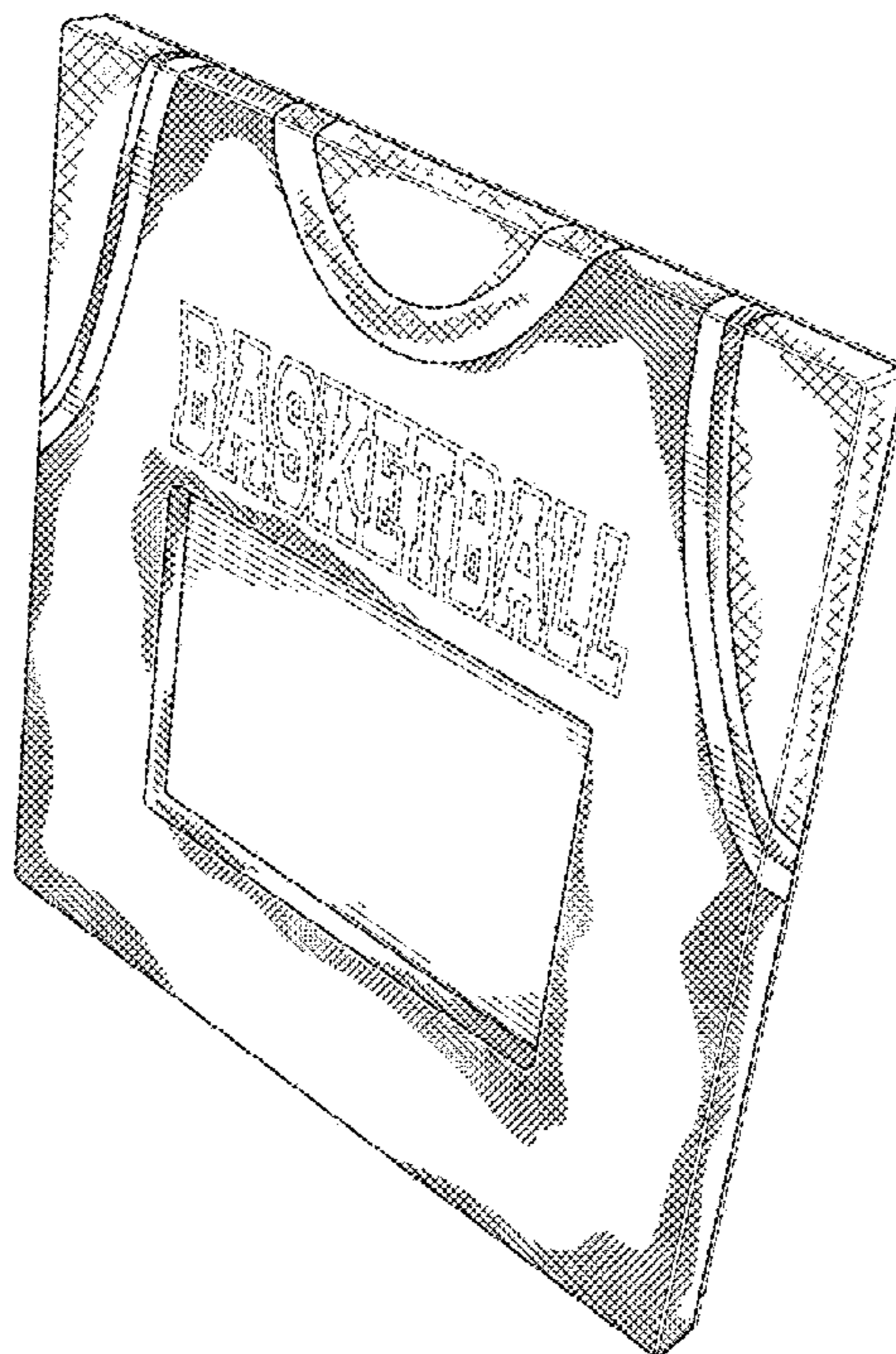
FIG. 1 is a front perspective view of my ornamental design for a basketball jersey frame.

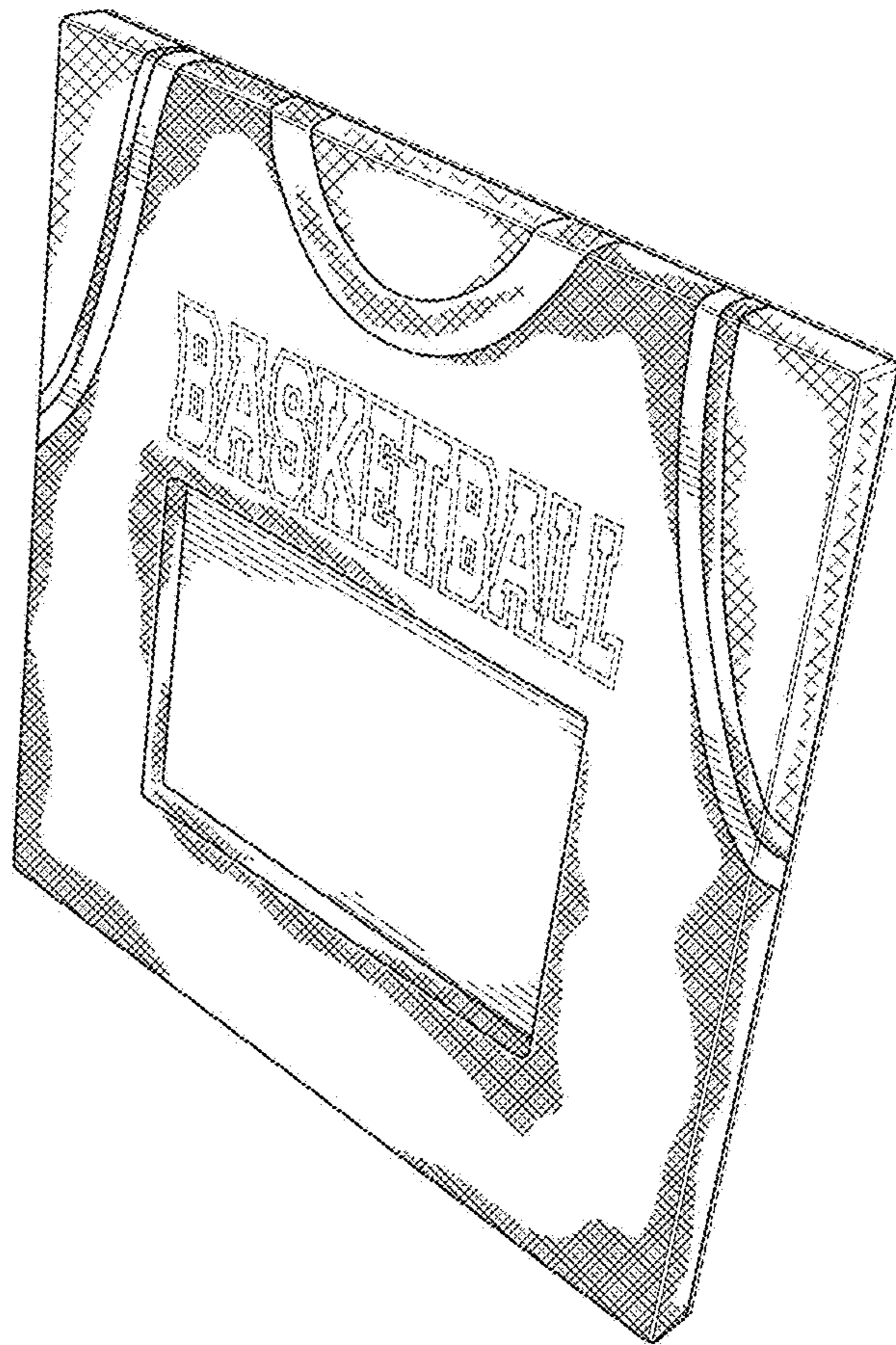

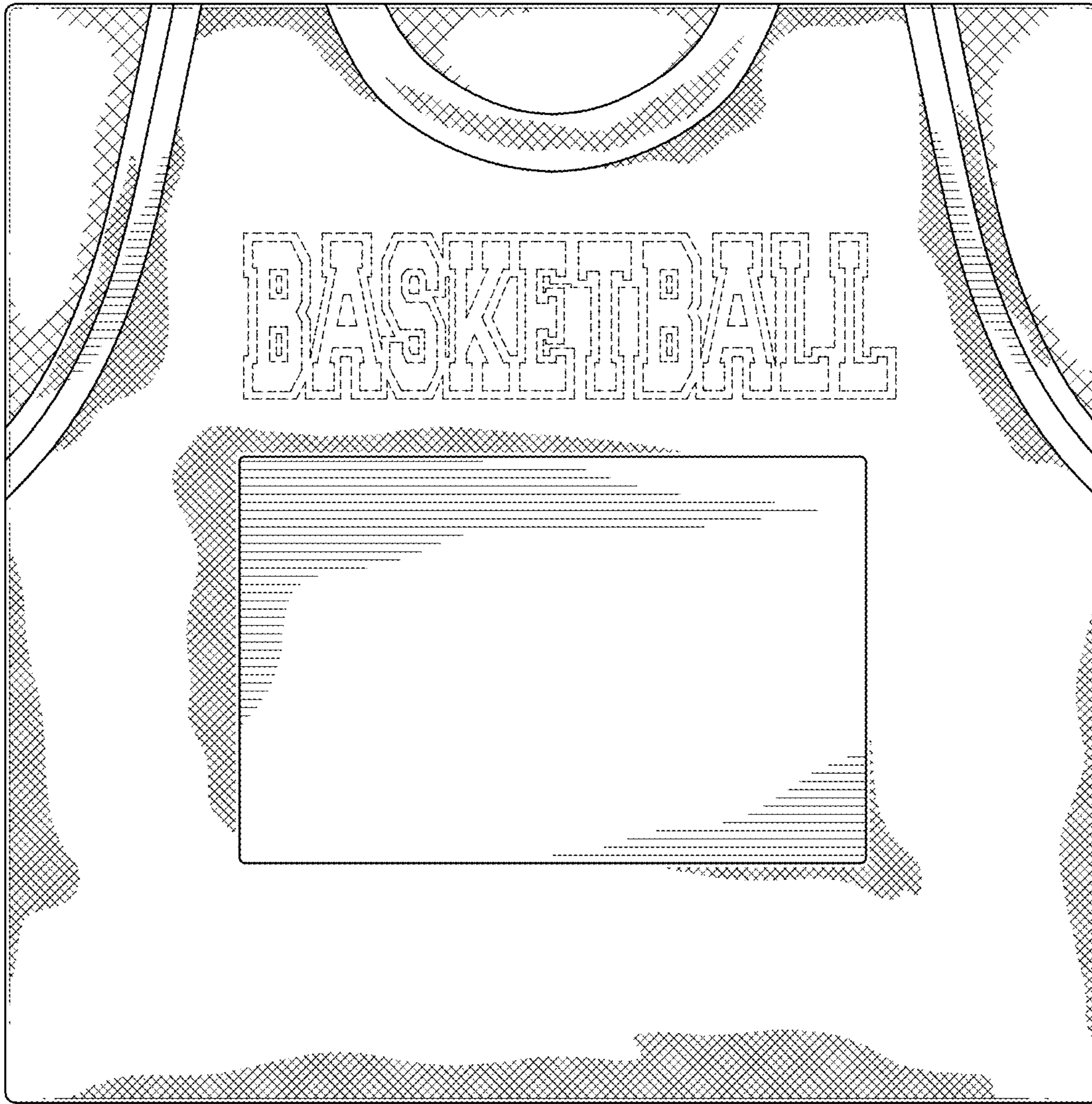

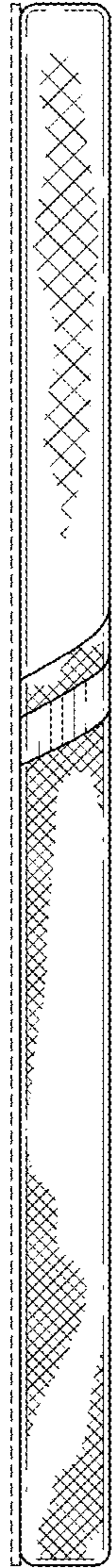

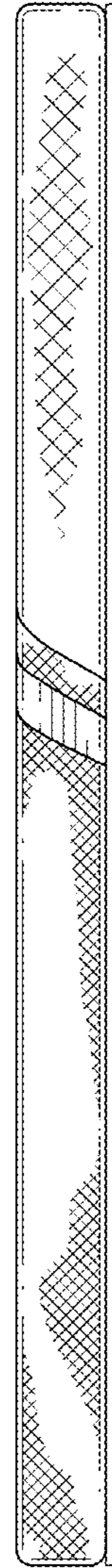

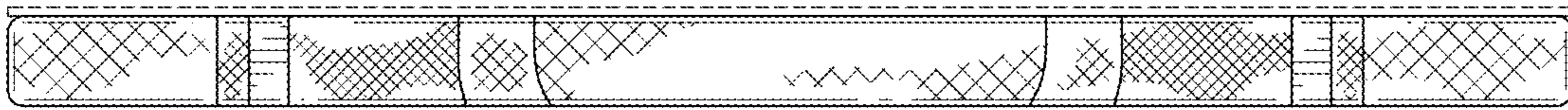

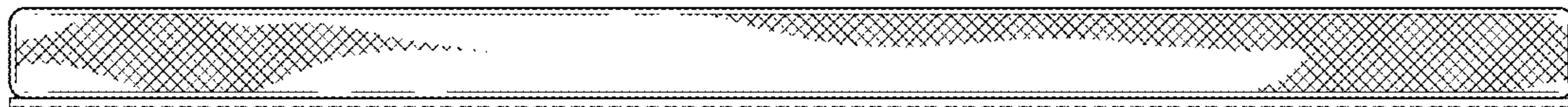
