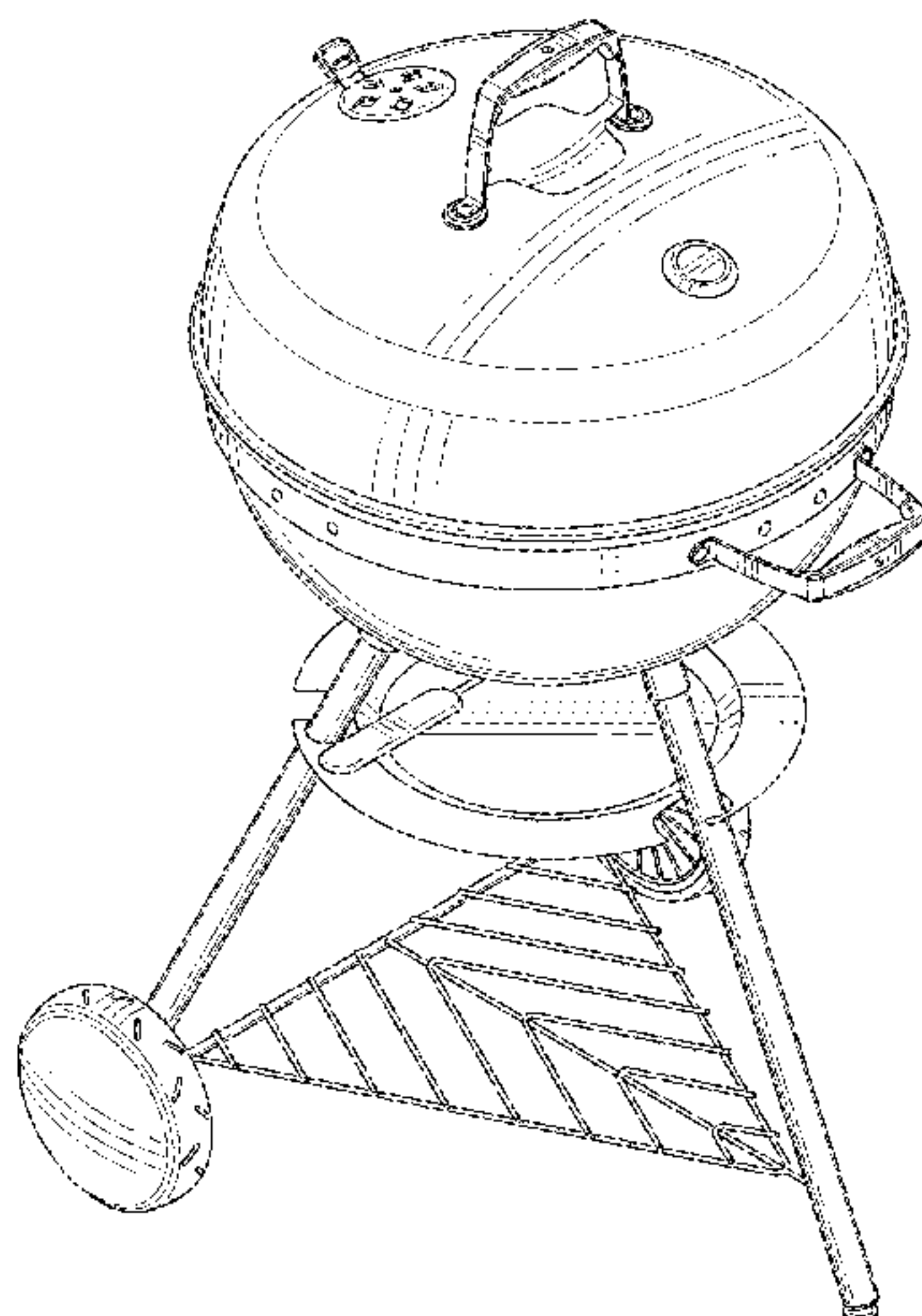
(57) CLAIM

The ornamental design for a barbecue grill, as shown and described.

DESCRIPTION

1.1 is a front elevation view of a barbecue grill showing my new design;
1.2 is a rear elevation view thereof;
1.3 is a top plan view thereof;
1.4 is a bottom plan view thereof;
1.5 is a top, front, and left side perspective view thereof;
1.6 is a right side elevation view thereof;
1.7 is a left side elevation view thereof; and

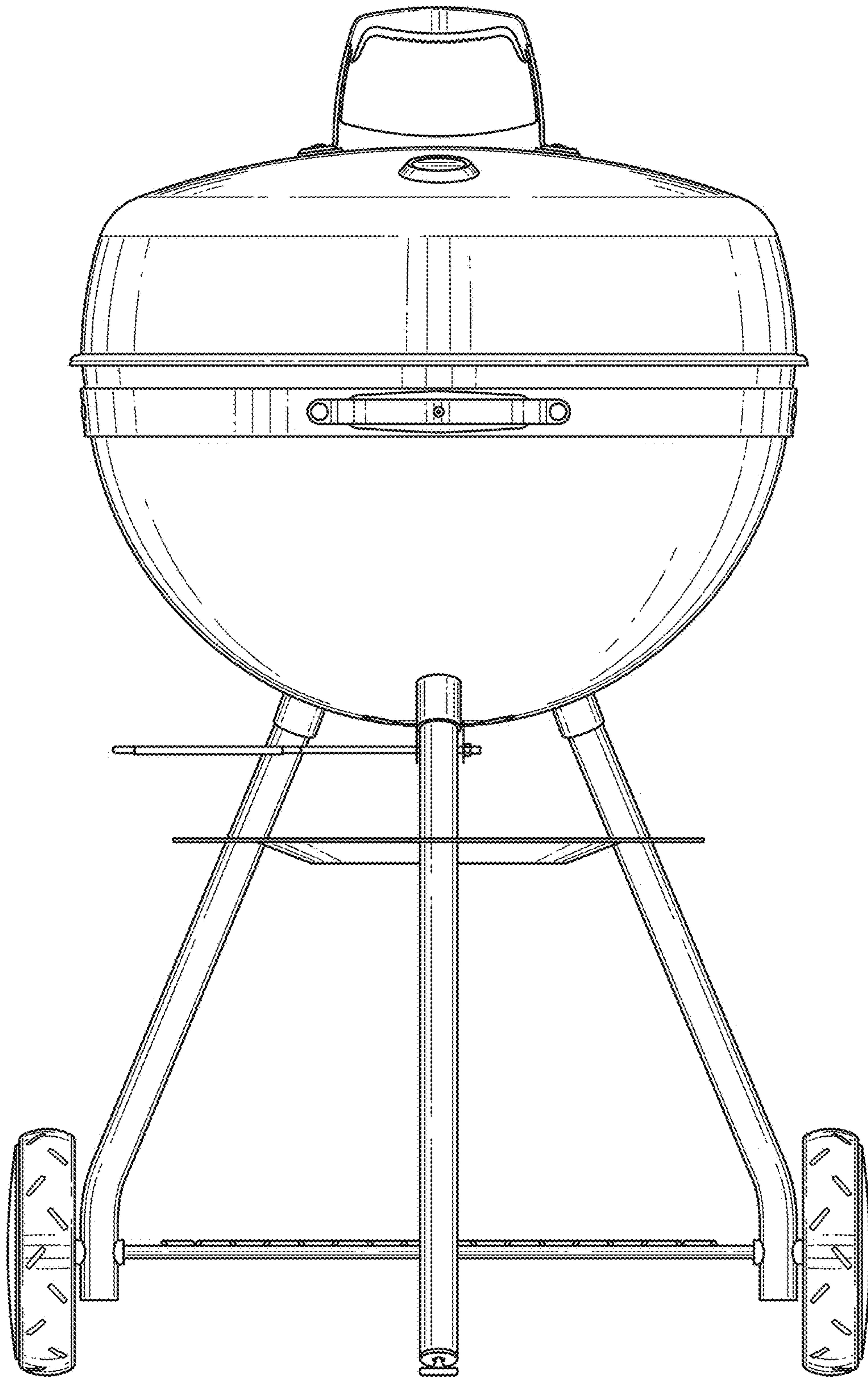

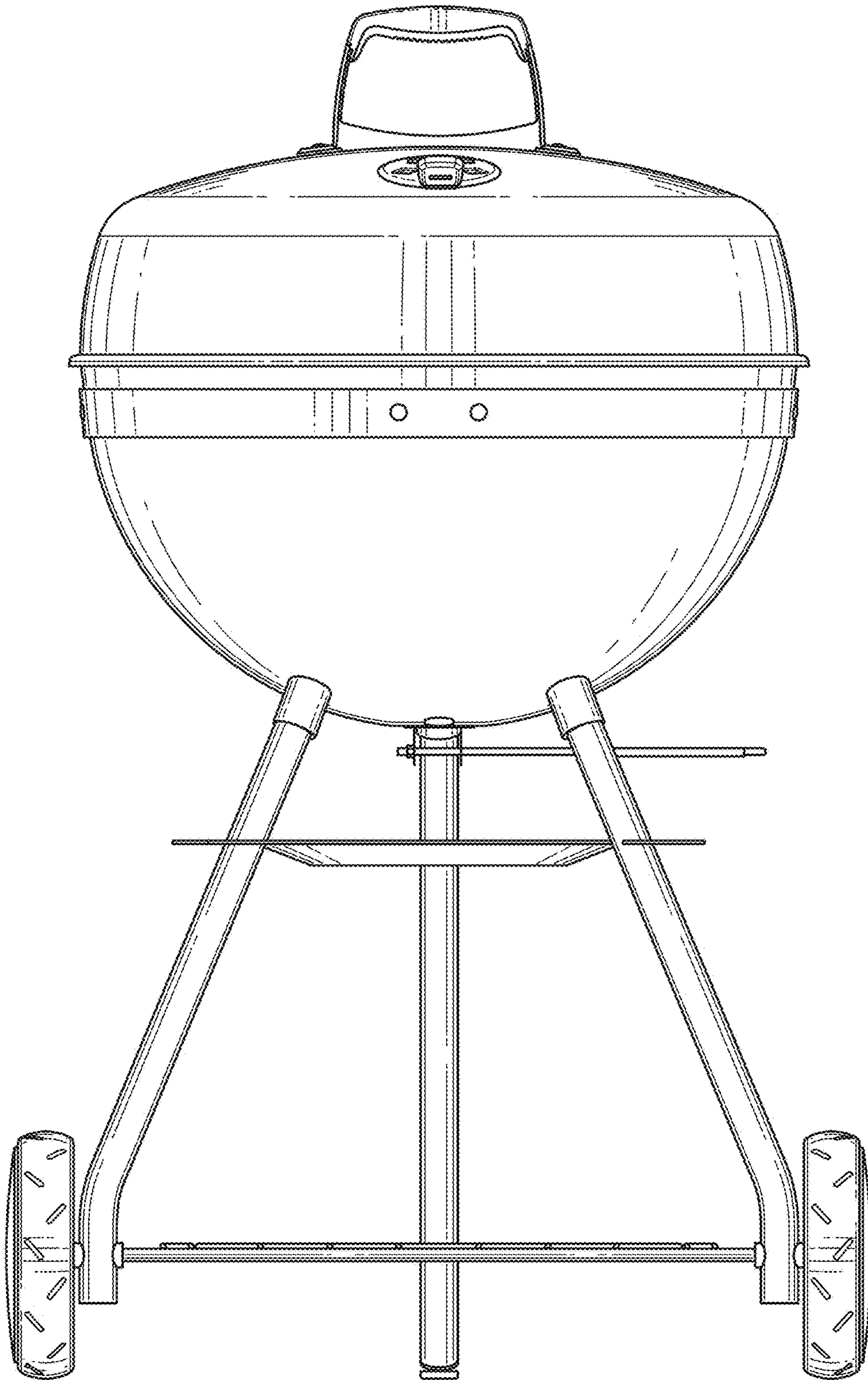

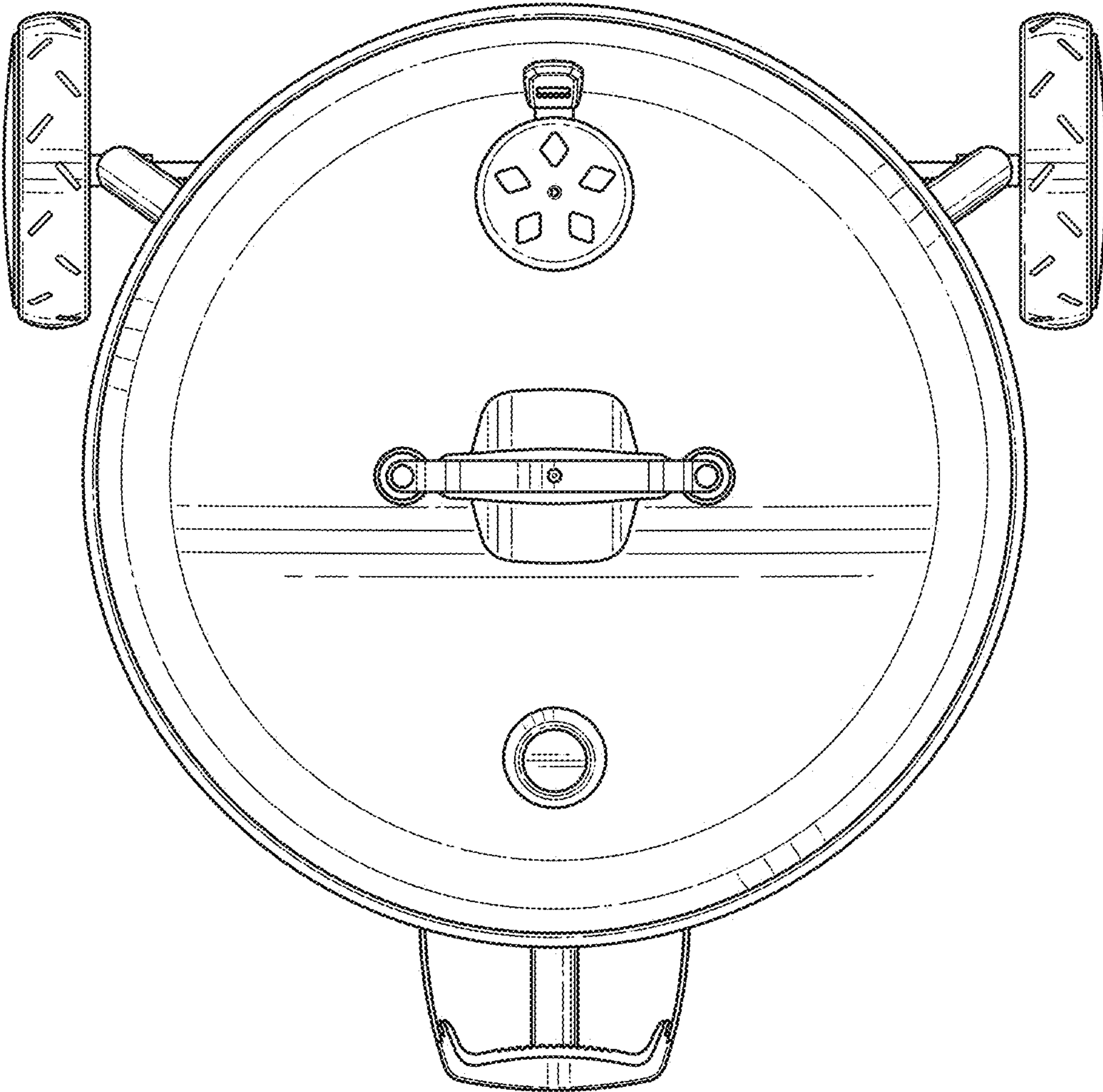

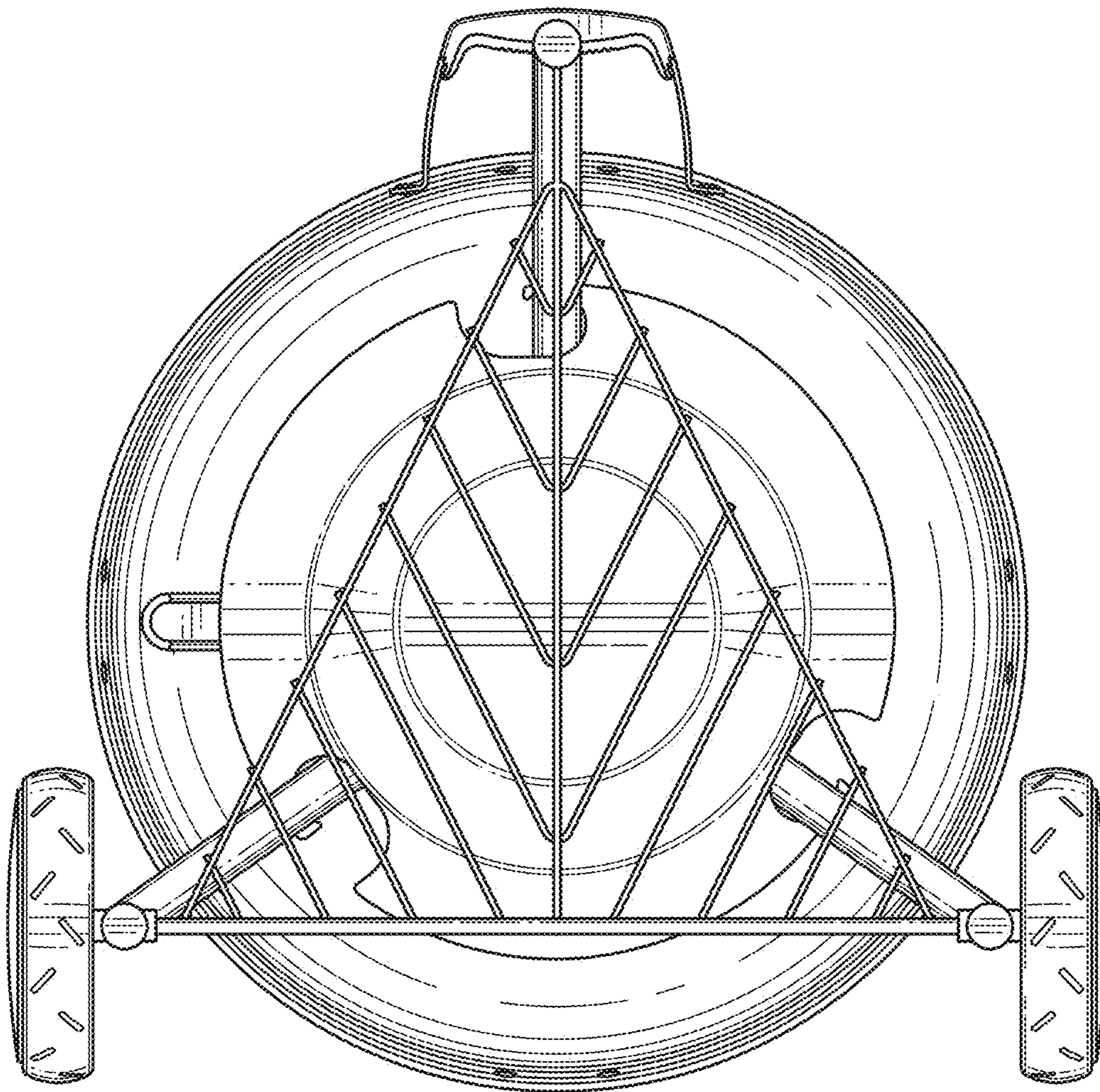




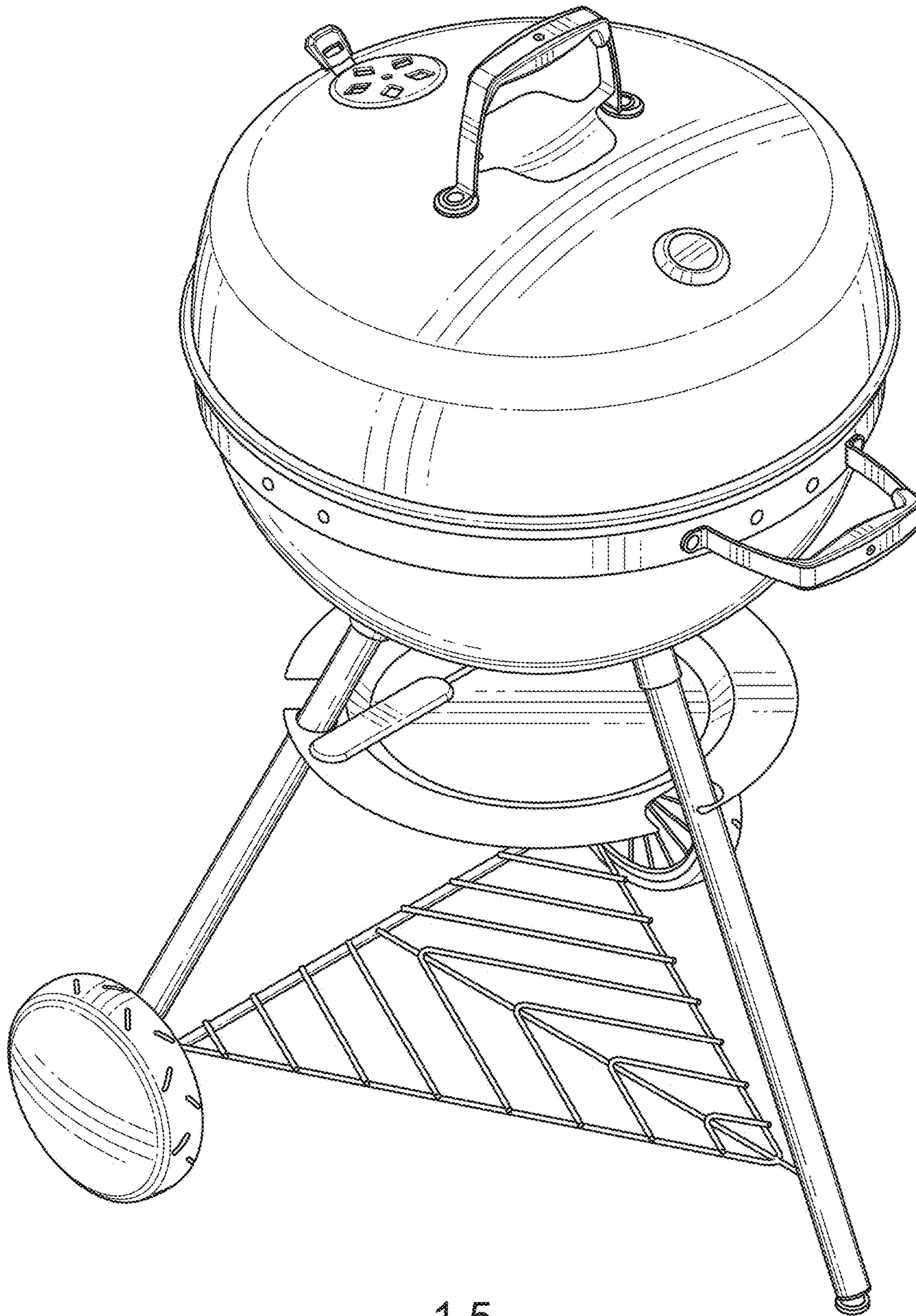

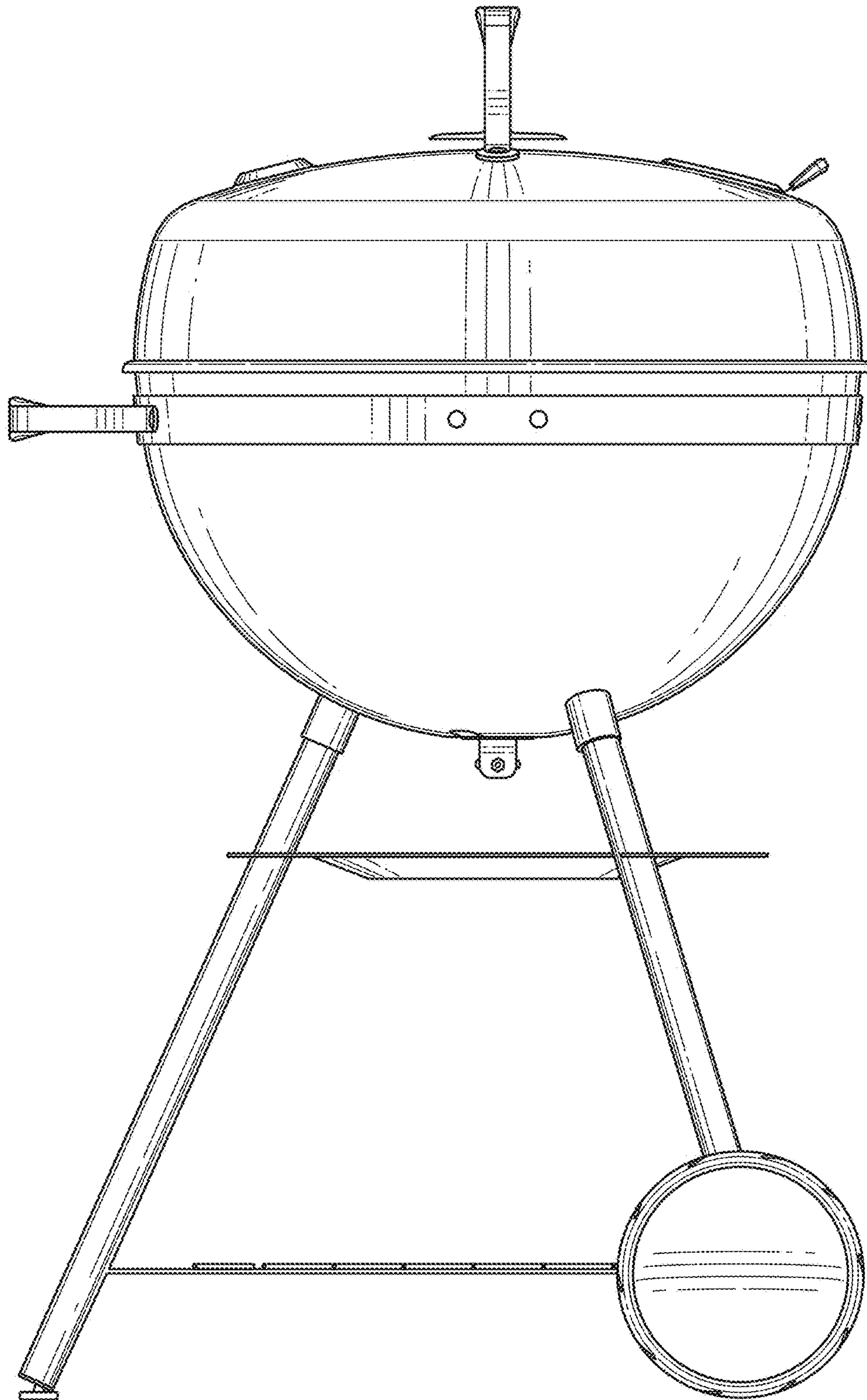

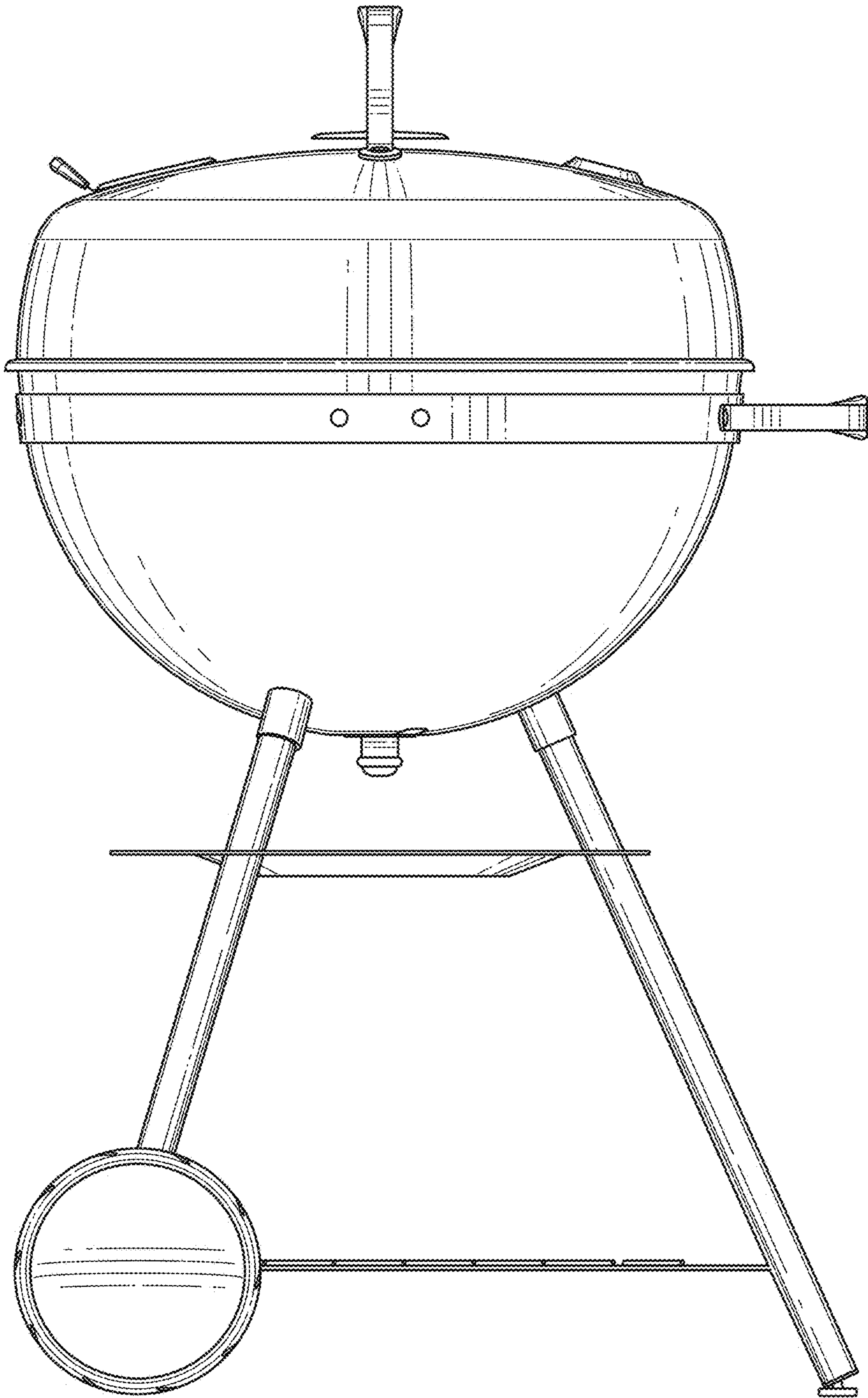

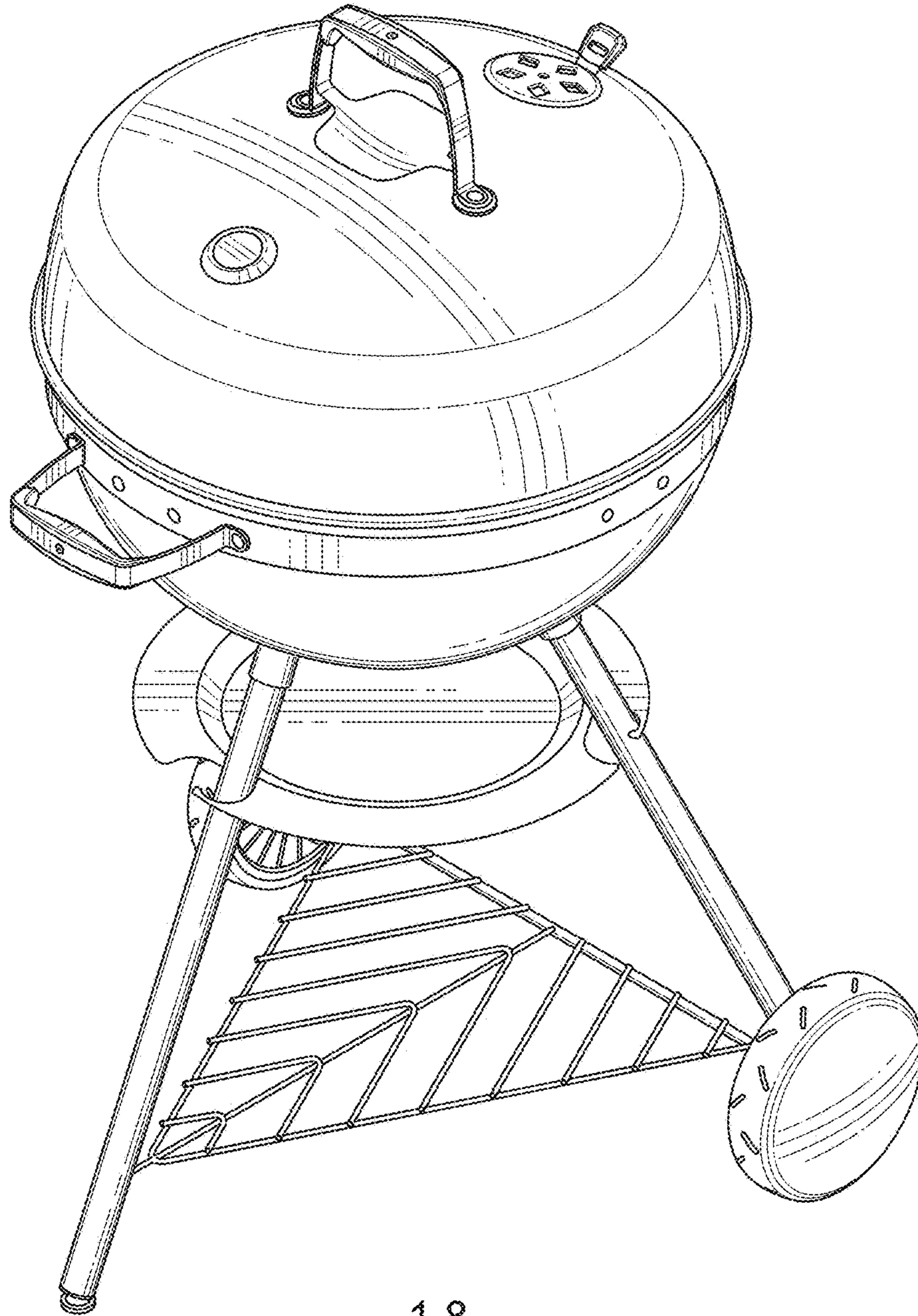
