The ornamental design for a hand tool, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a hand tool showing my new design in an open position;
FIG. 2 is a rear elevational view thereof;
FIG. 3 is a right side elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a top plan view thereof, the bottom plan view being identical;
FIG. 6 is a front elevational view of the hand tool in a closed position; and,
FIG. 7 is a perspective view of the hand tool in an open position.

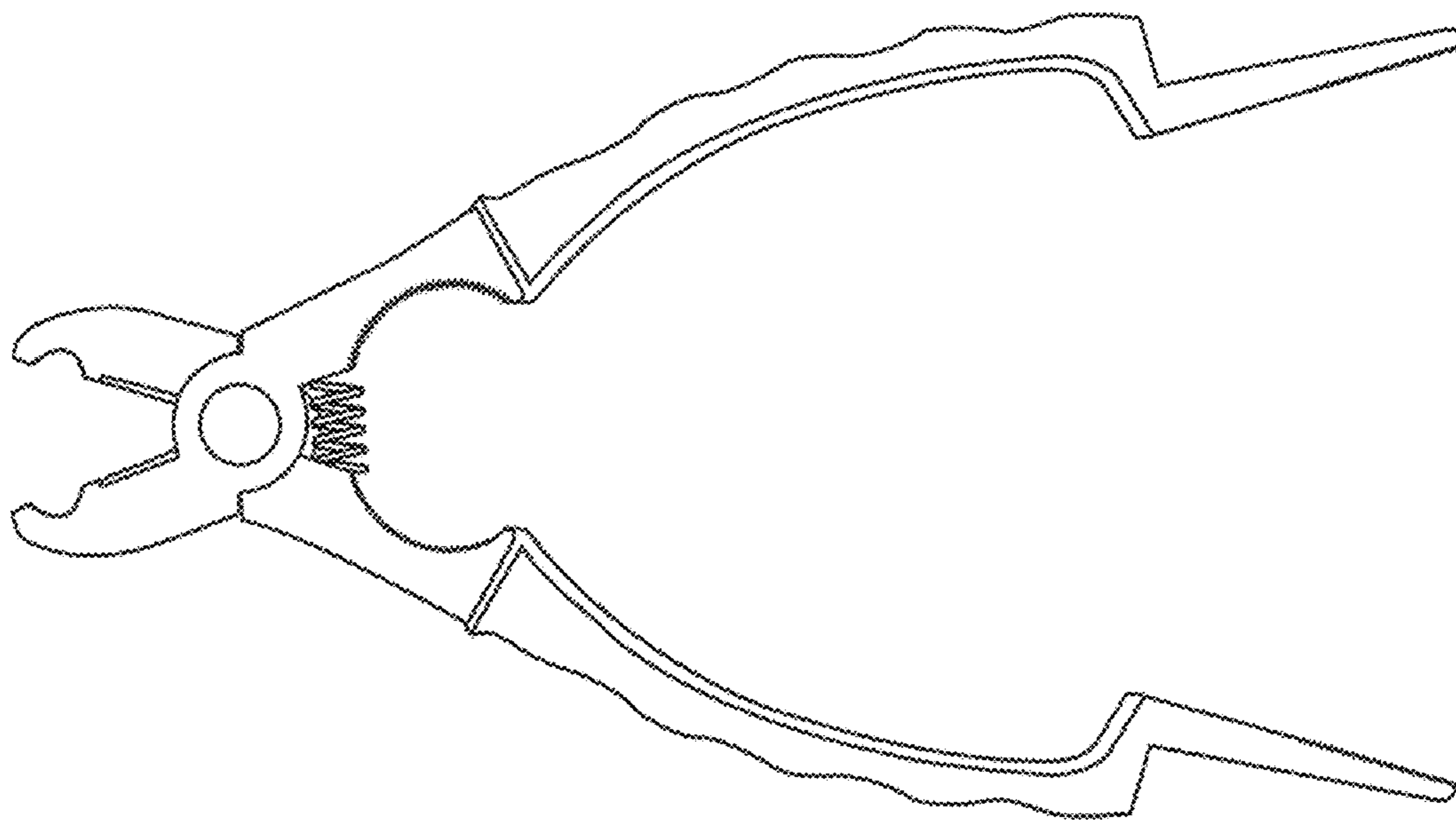

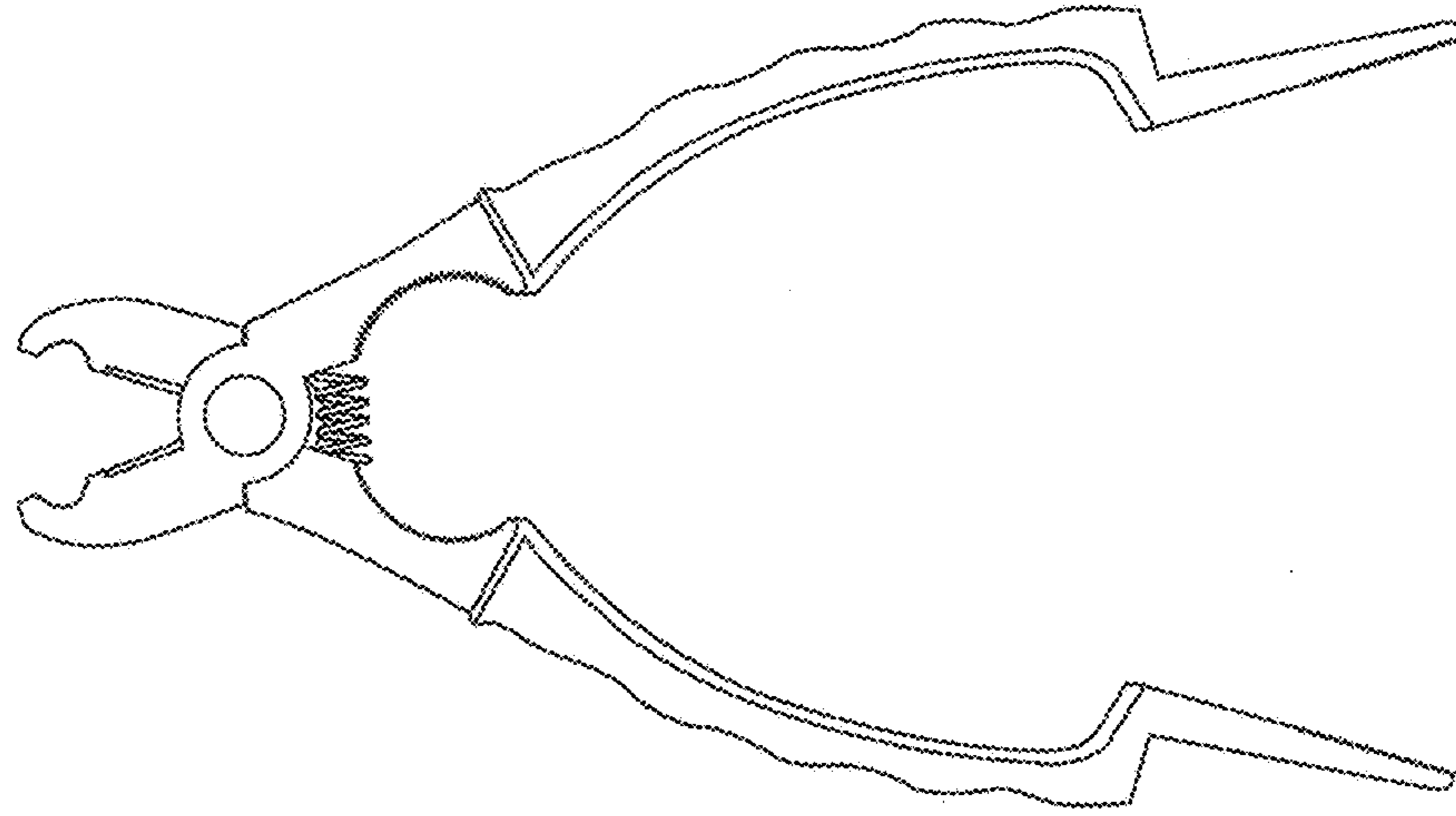

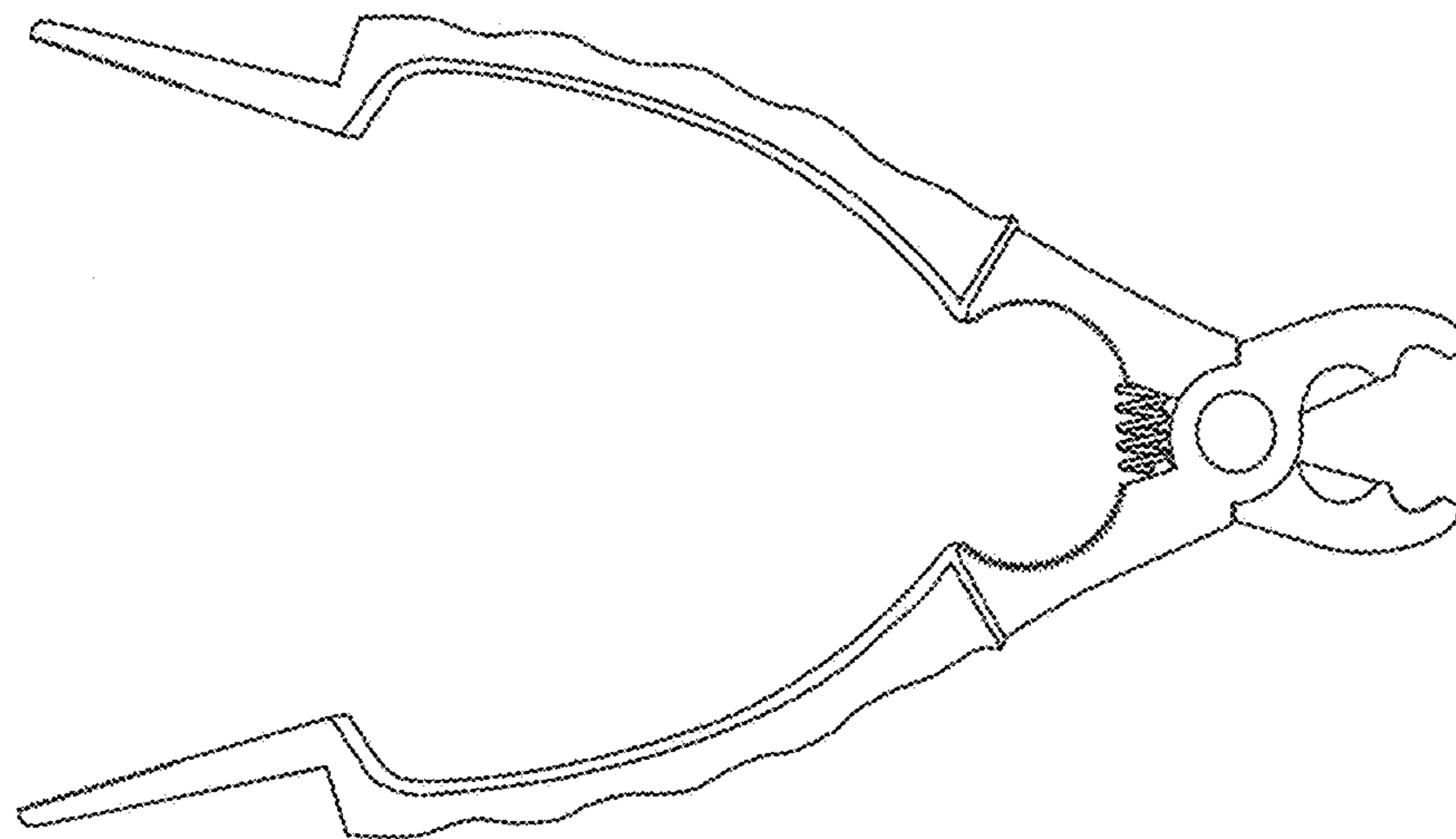

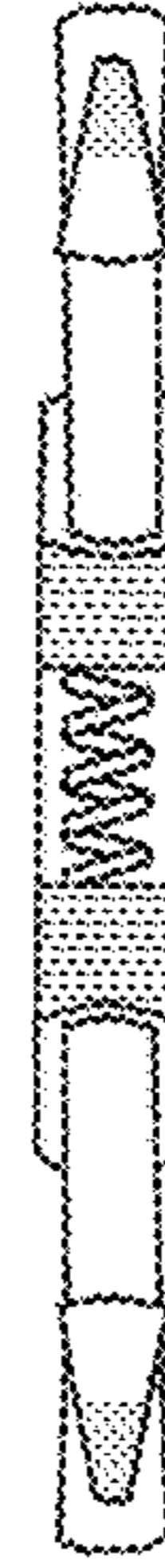

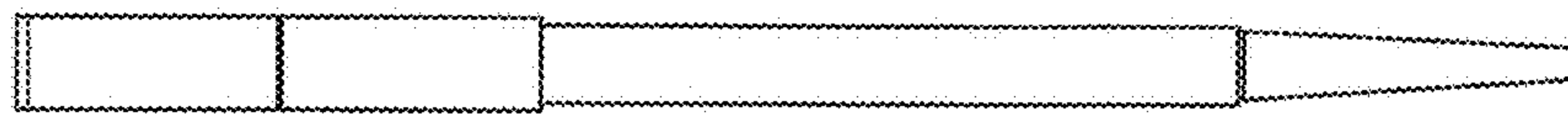

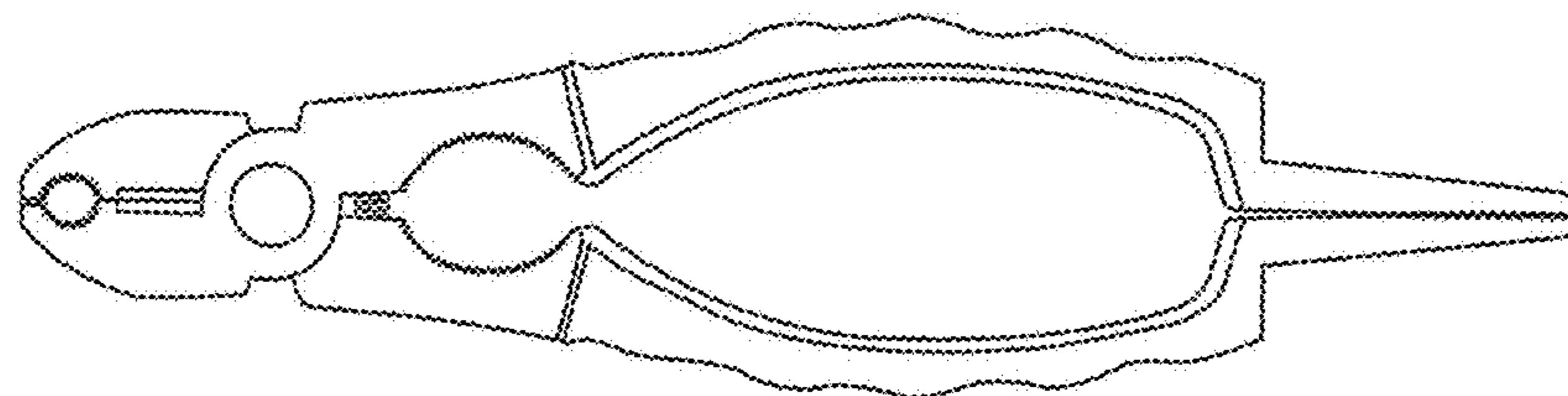
