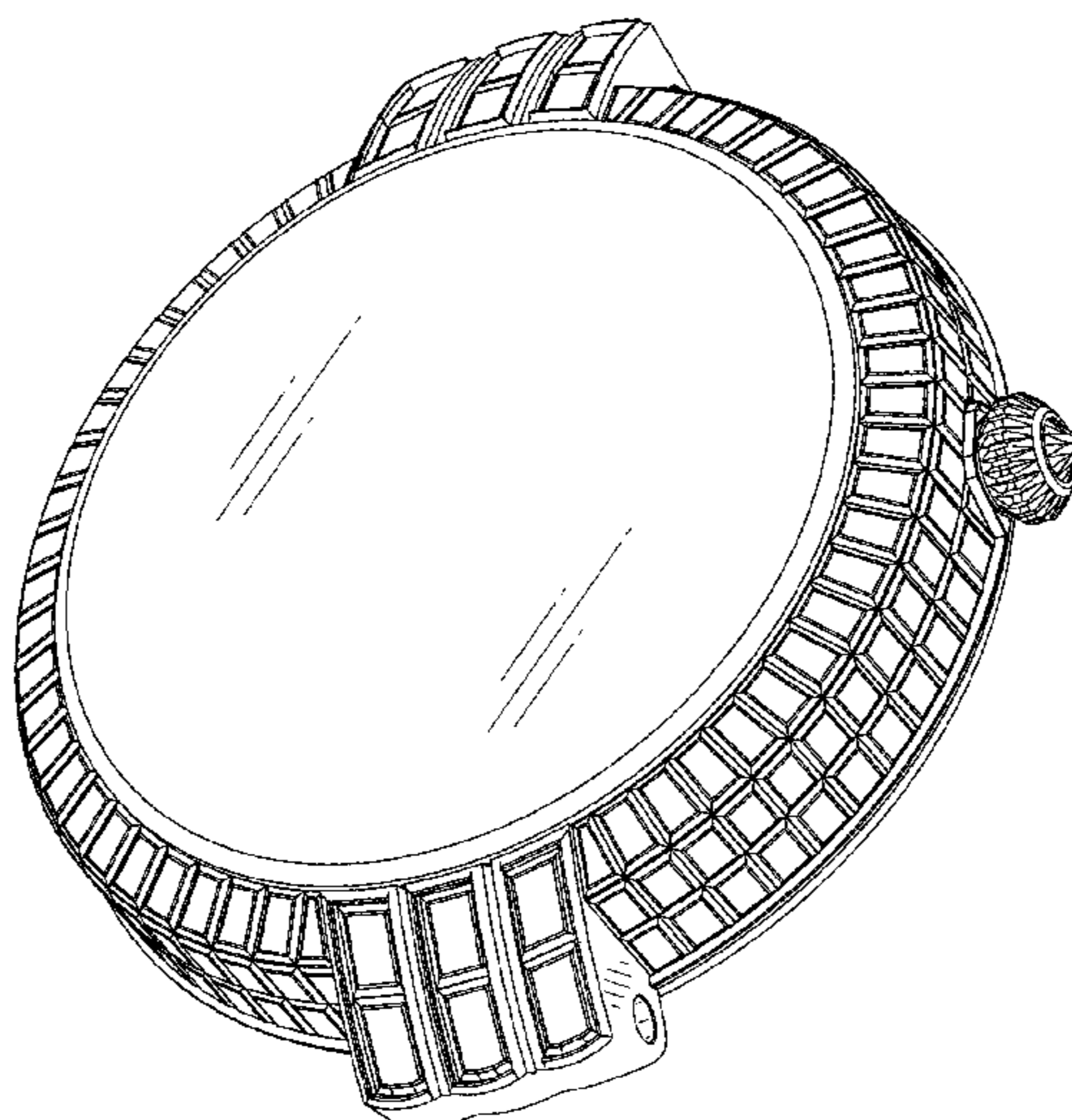
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front right perspective view of a watchcase showing my new design;
FIG. 2 is a rear left perspective view thereof;

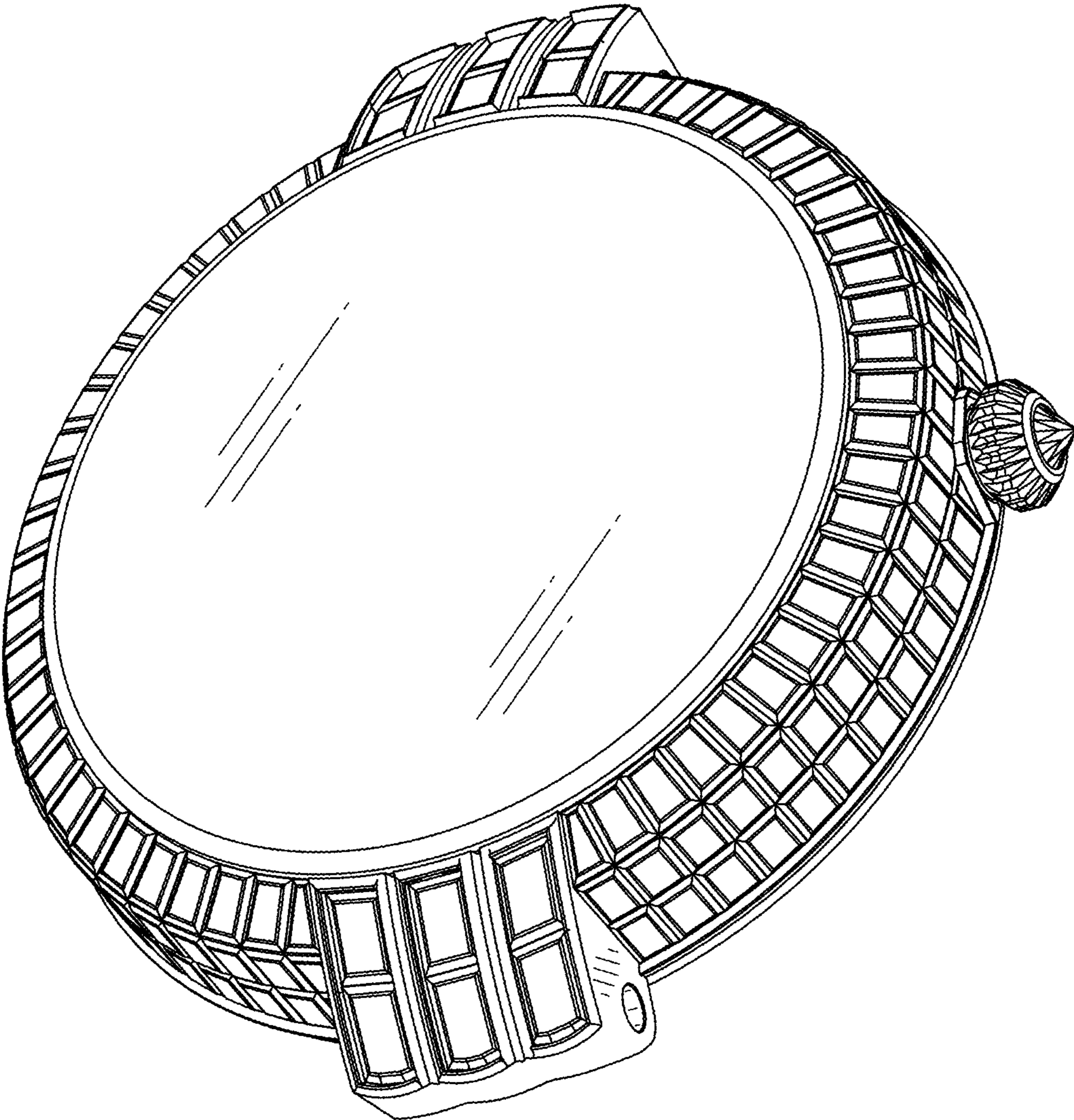

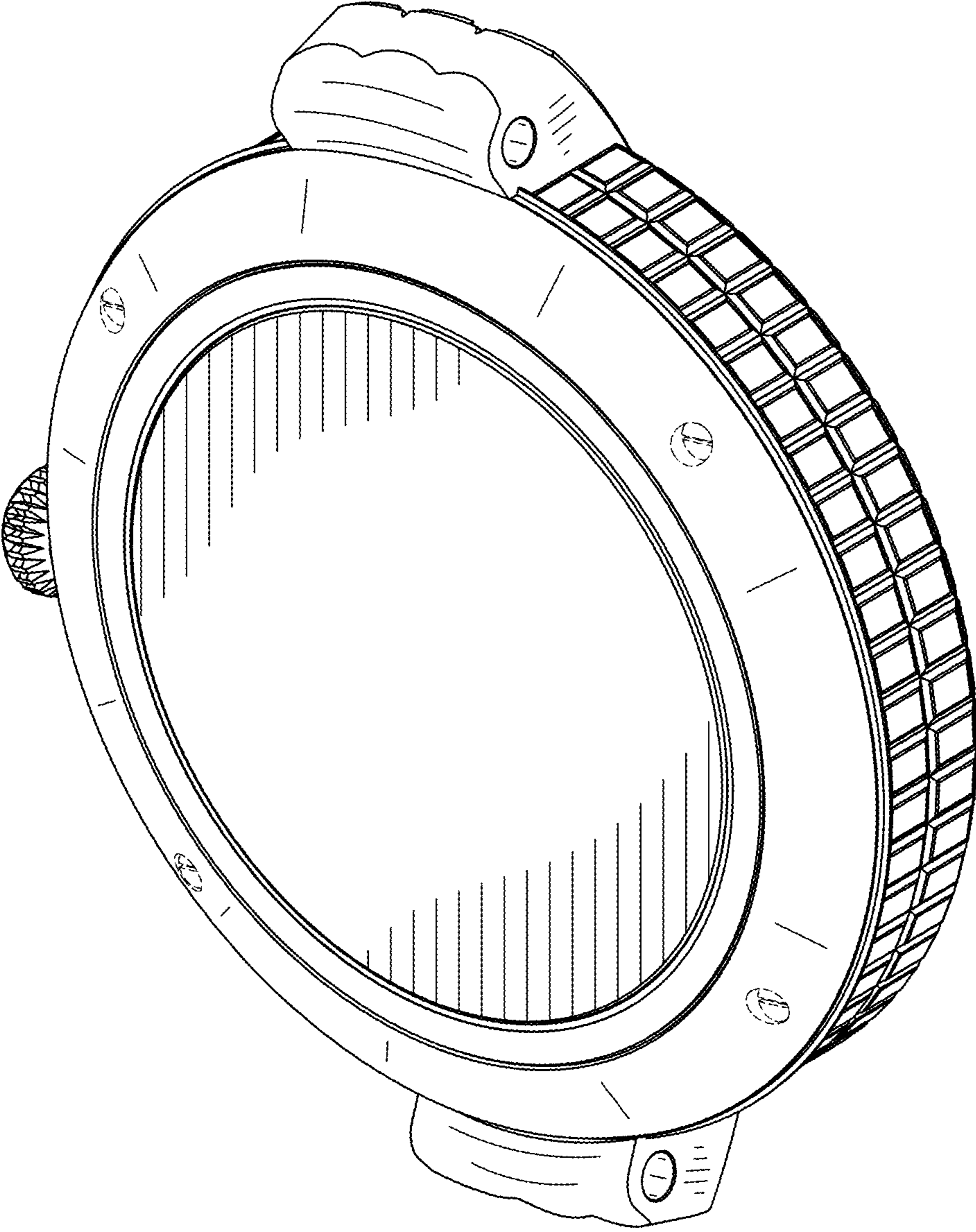

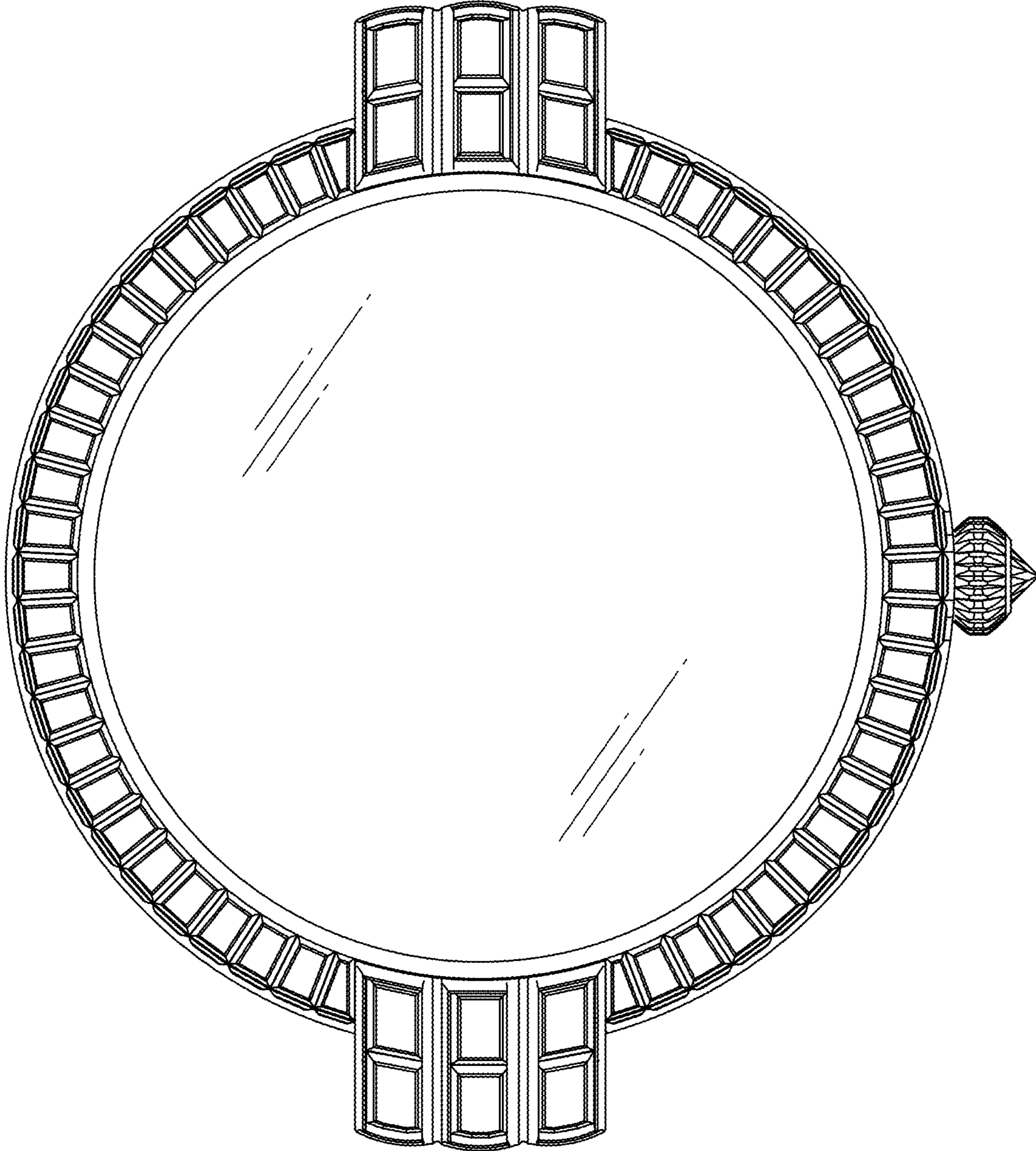

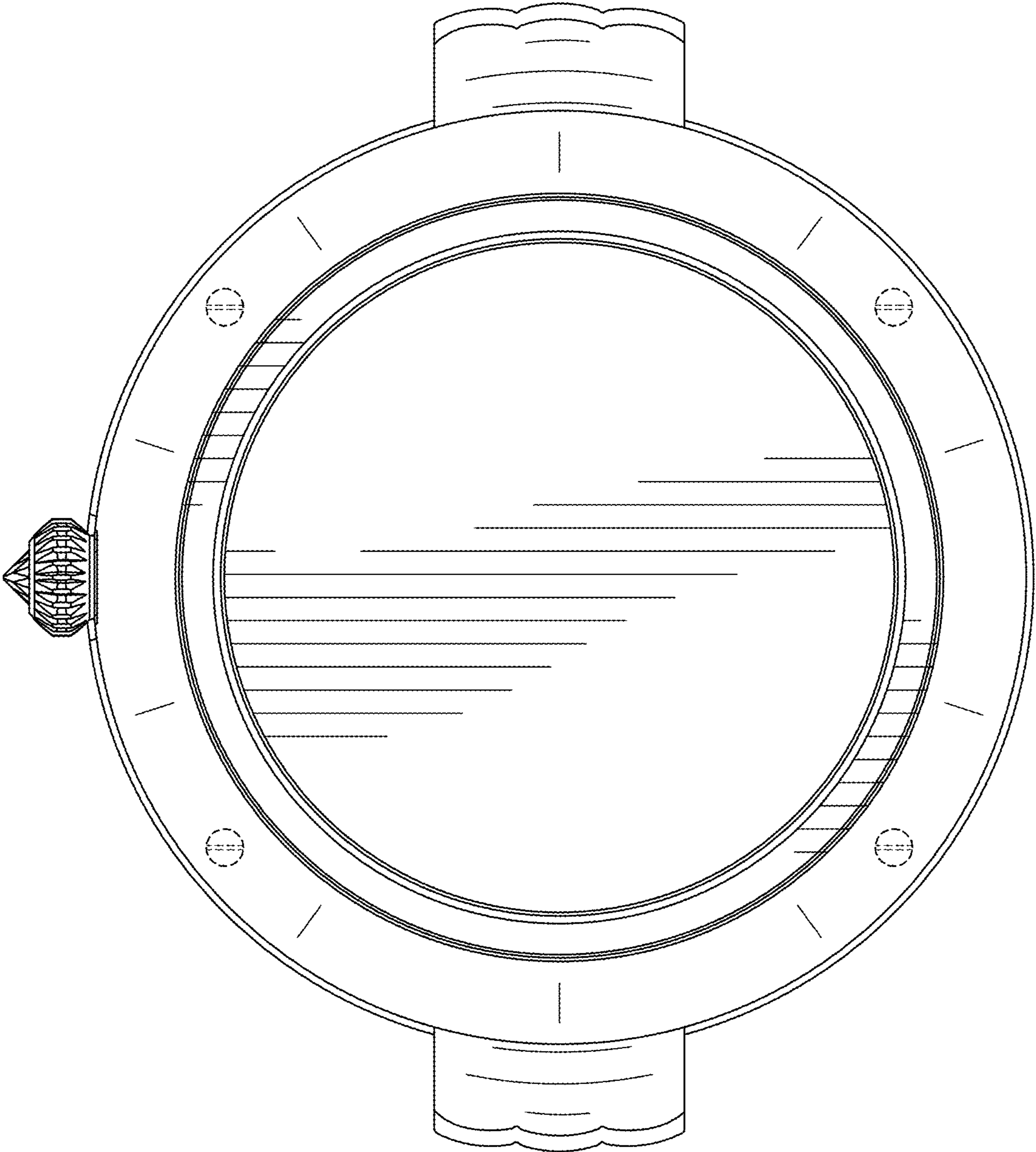

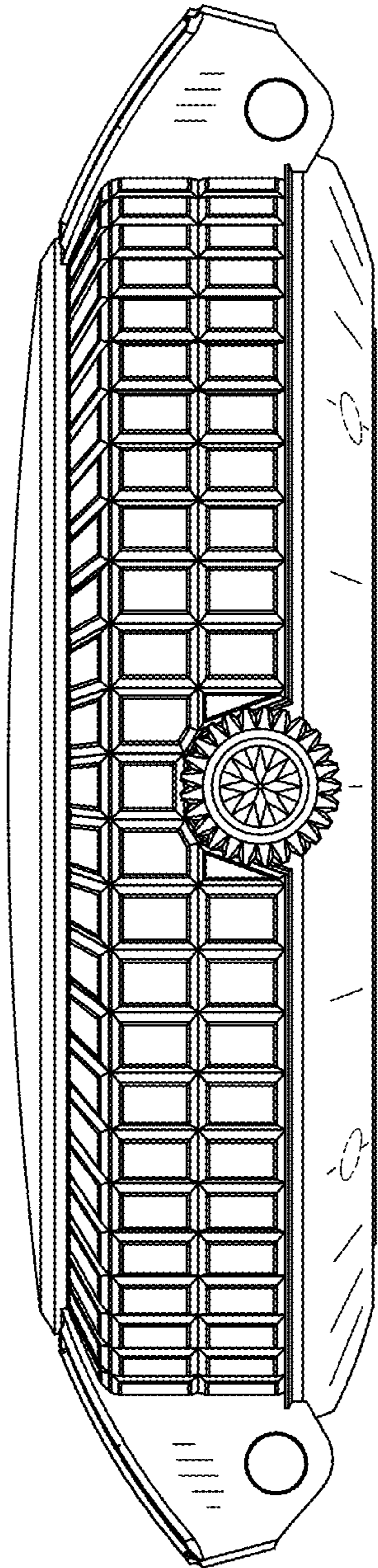

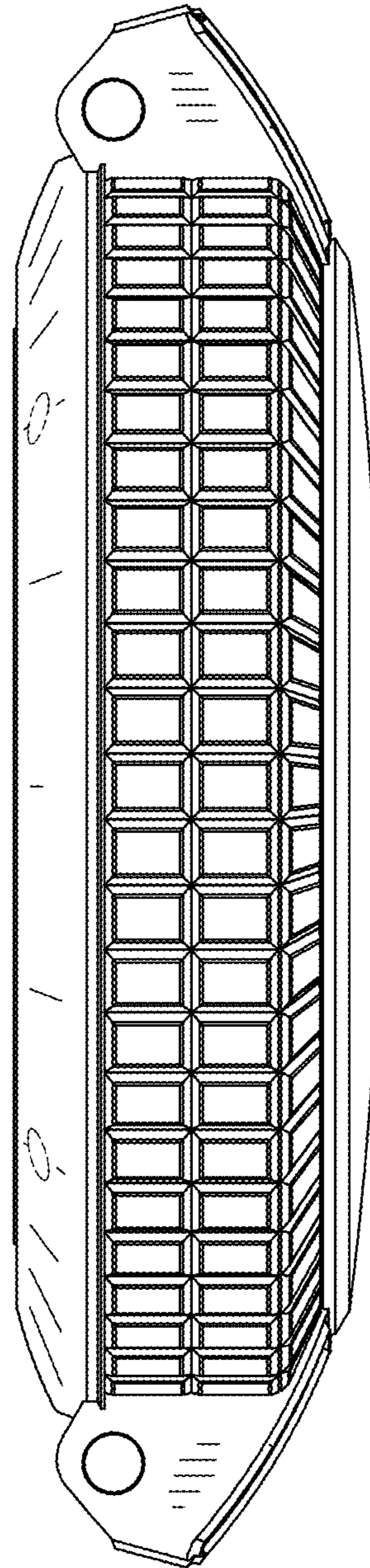

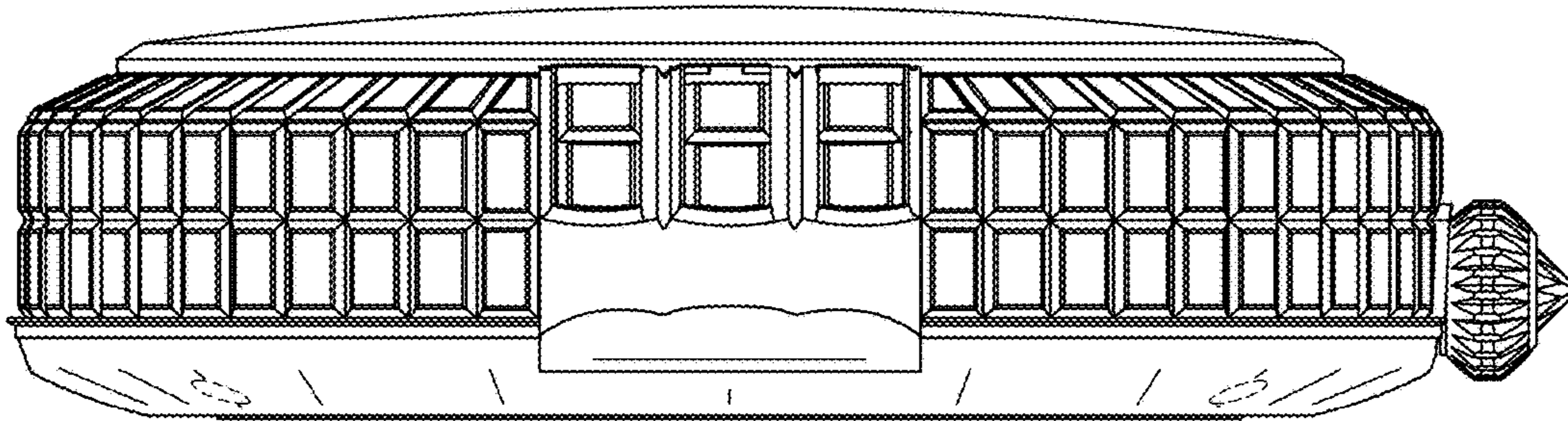

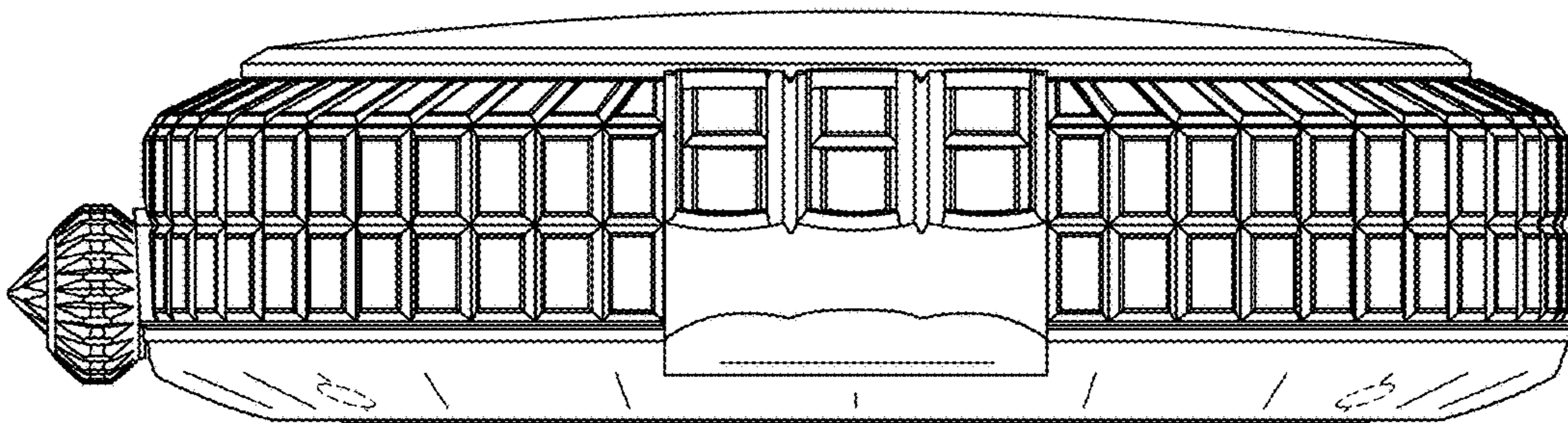
