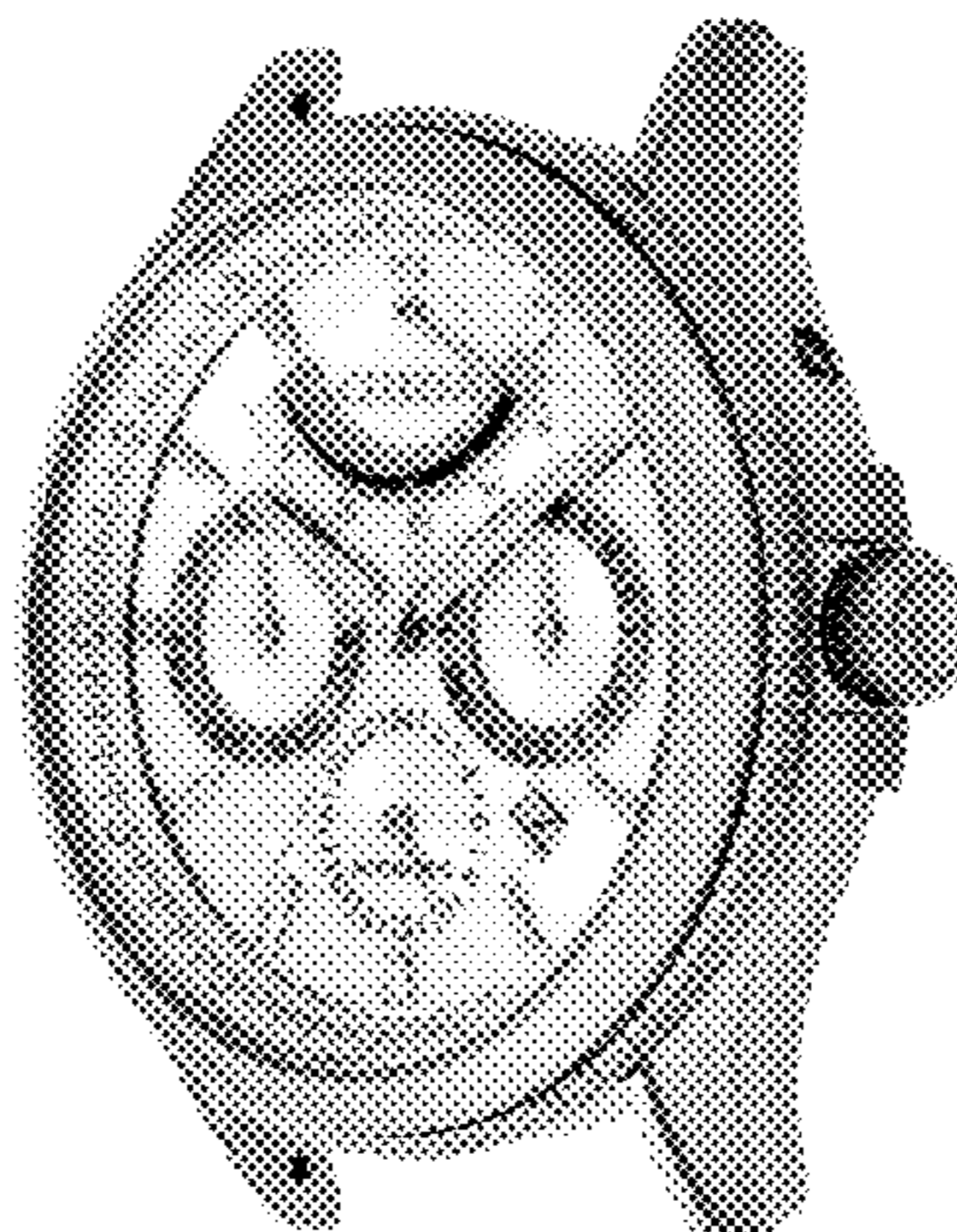
(57) **CLAIM**

The ornamental design for a wrist watch, as shown and described.

**DESCRIPTION**

FIG. 1 is an enlarged front perspective view of a wrist watch showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a left side elevational view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a rear elevational view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof. The broken lines showing portions of the wrist watch are included for the purpose of illustrating portions of the article and form no part of the claimed design.

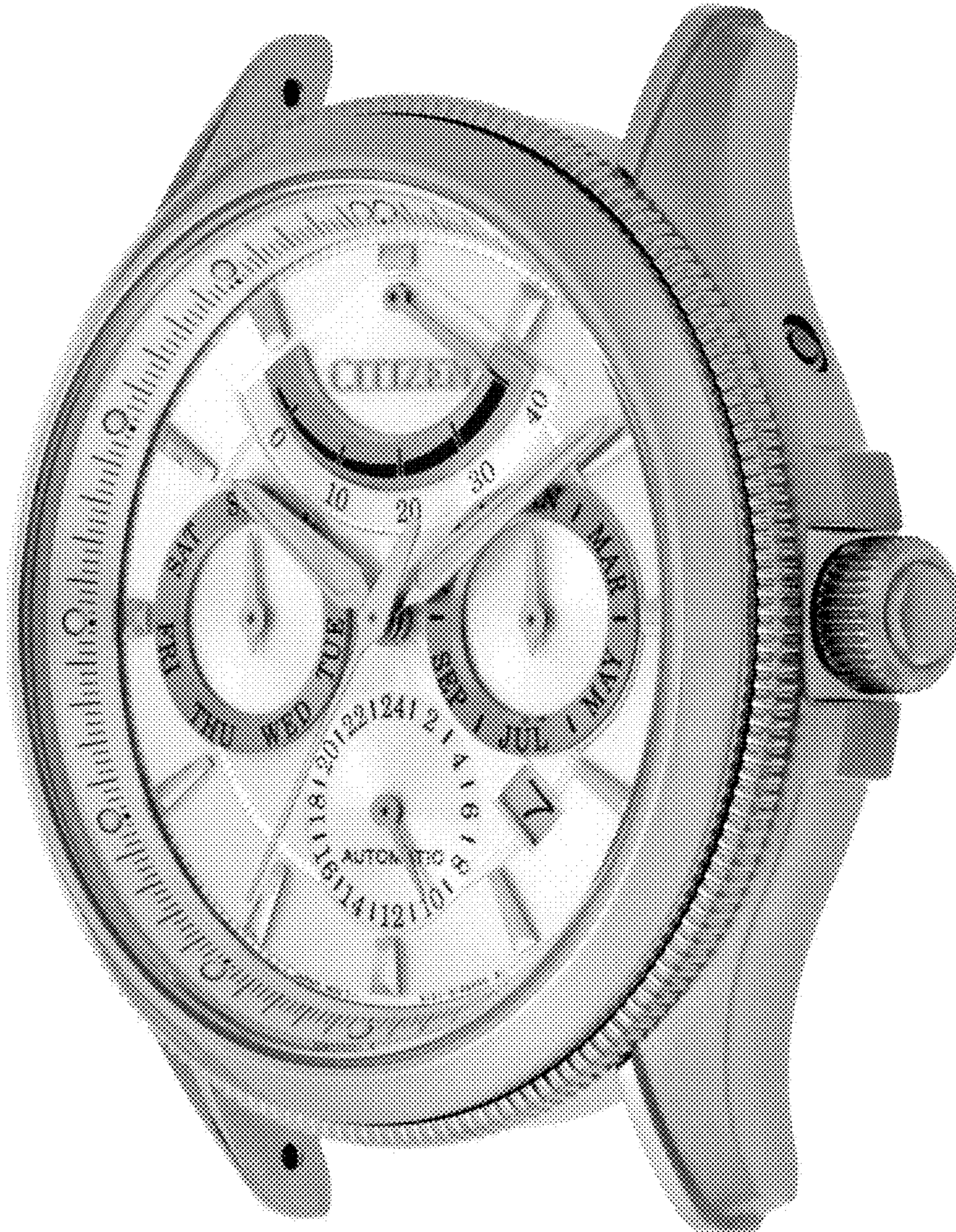

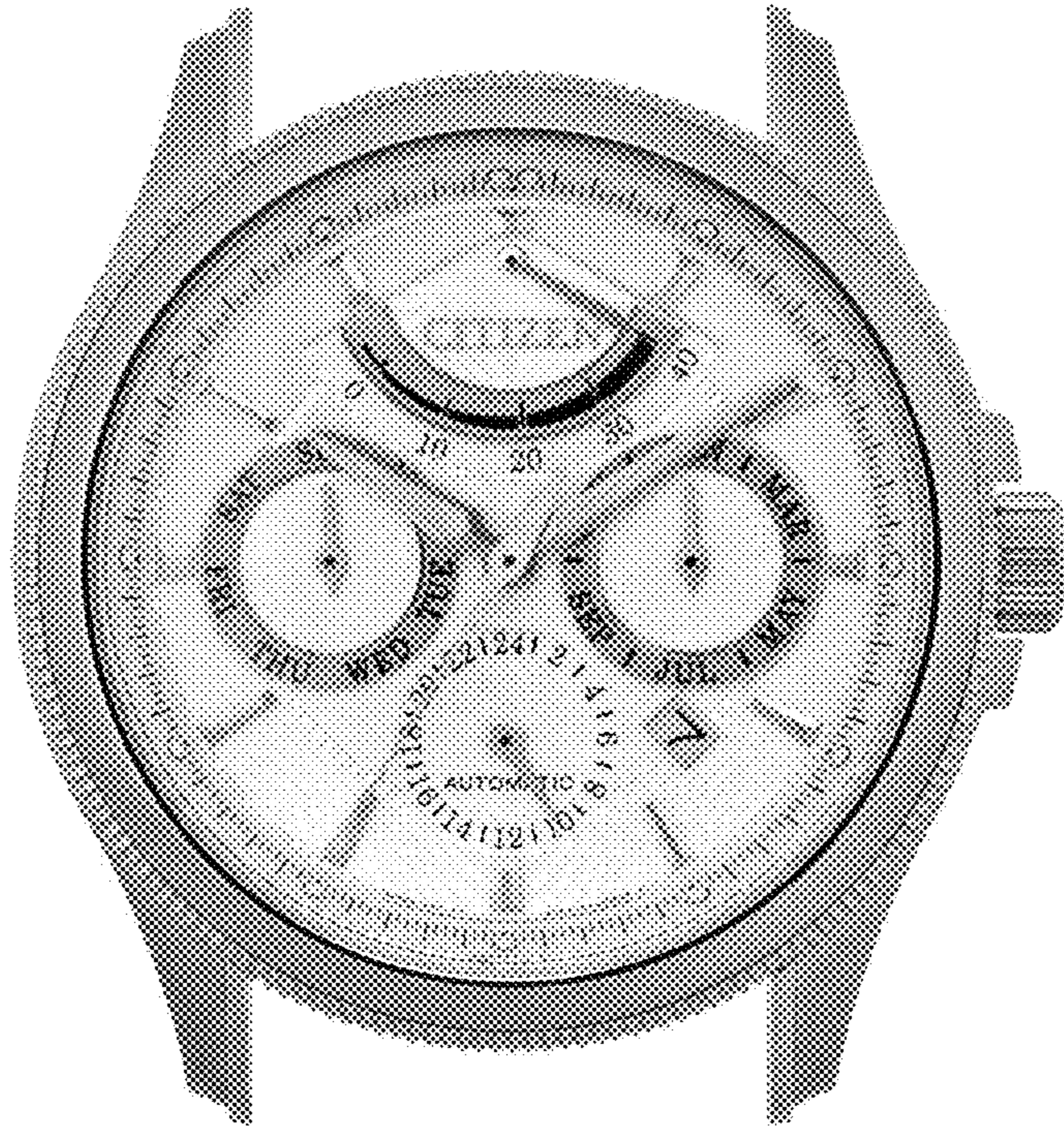

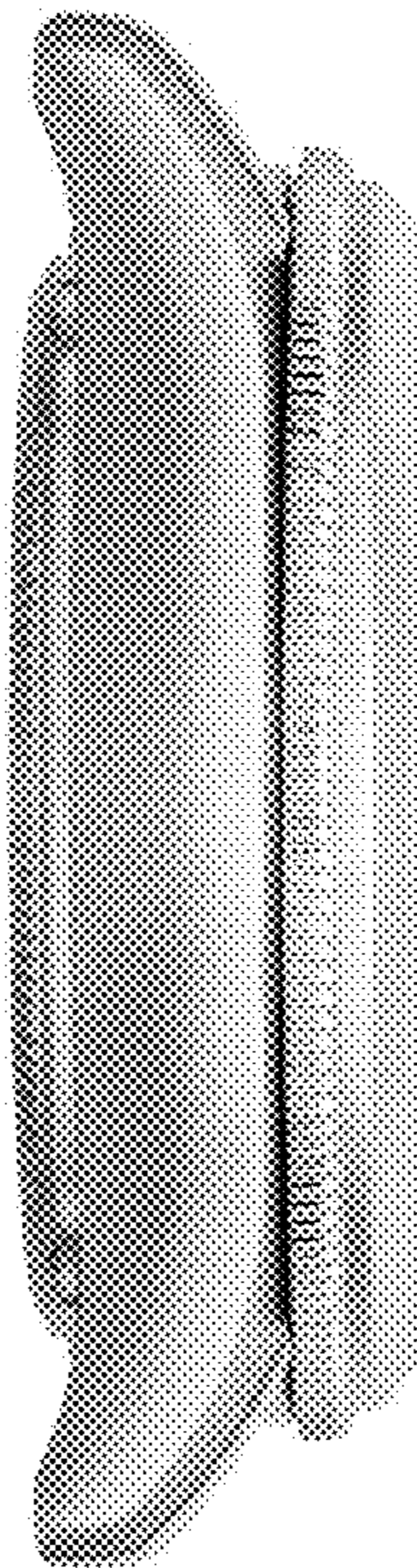

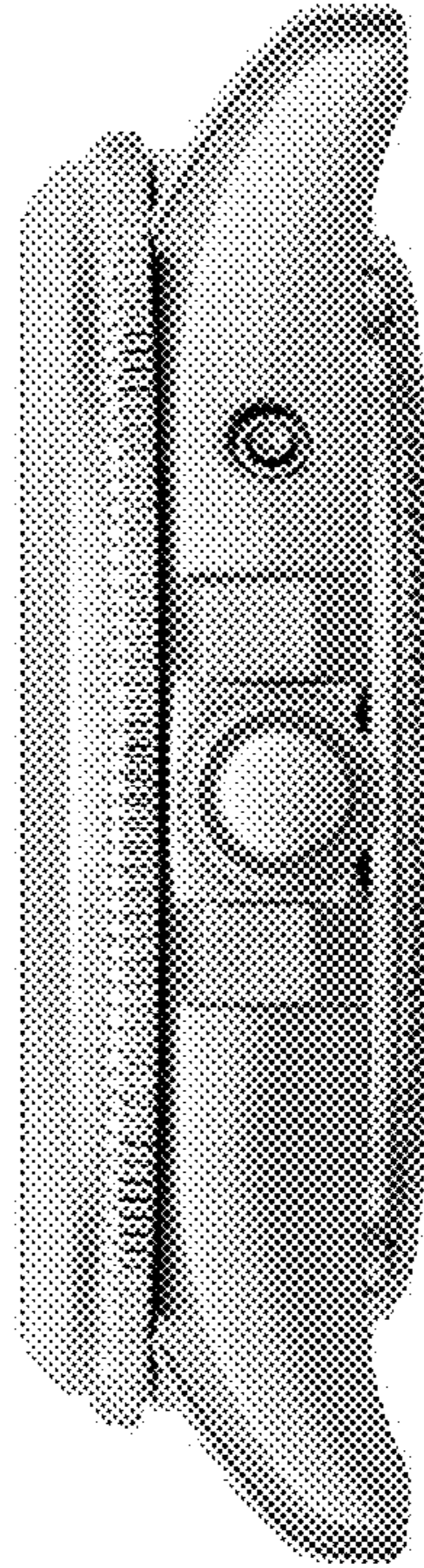

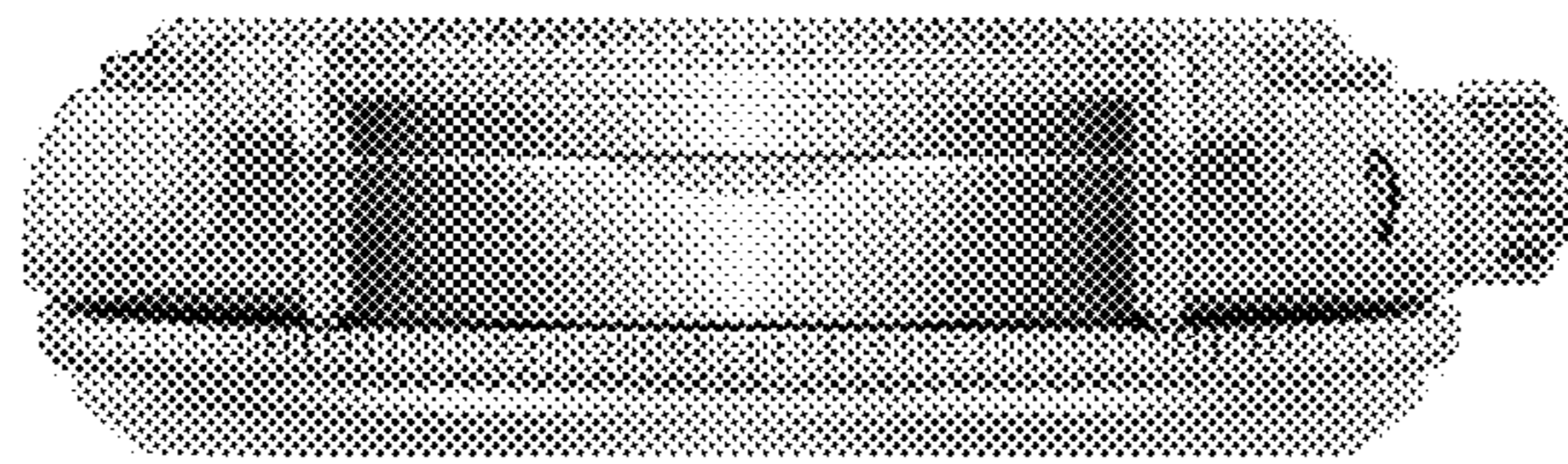
