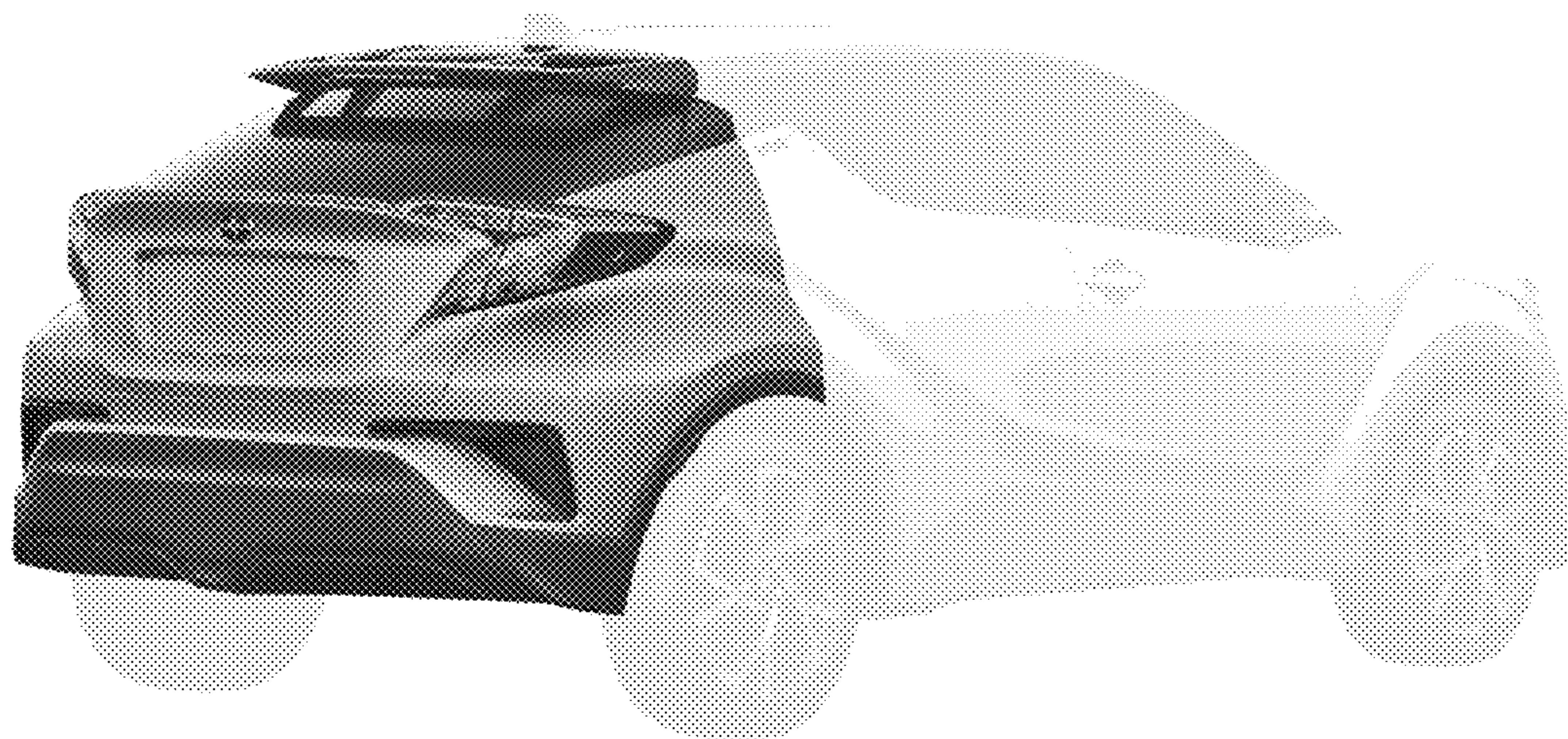

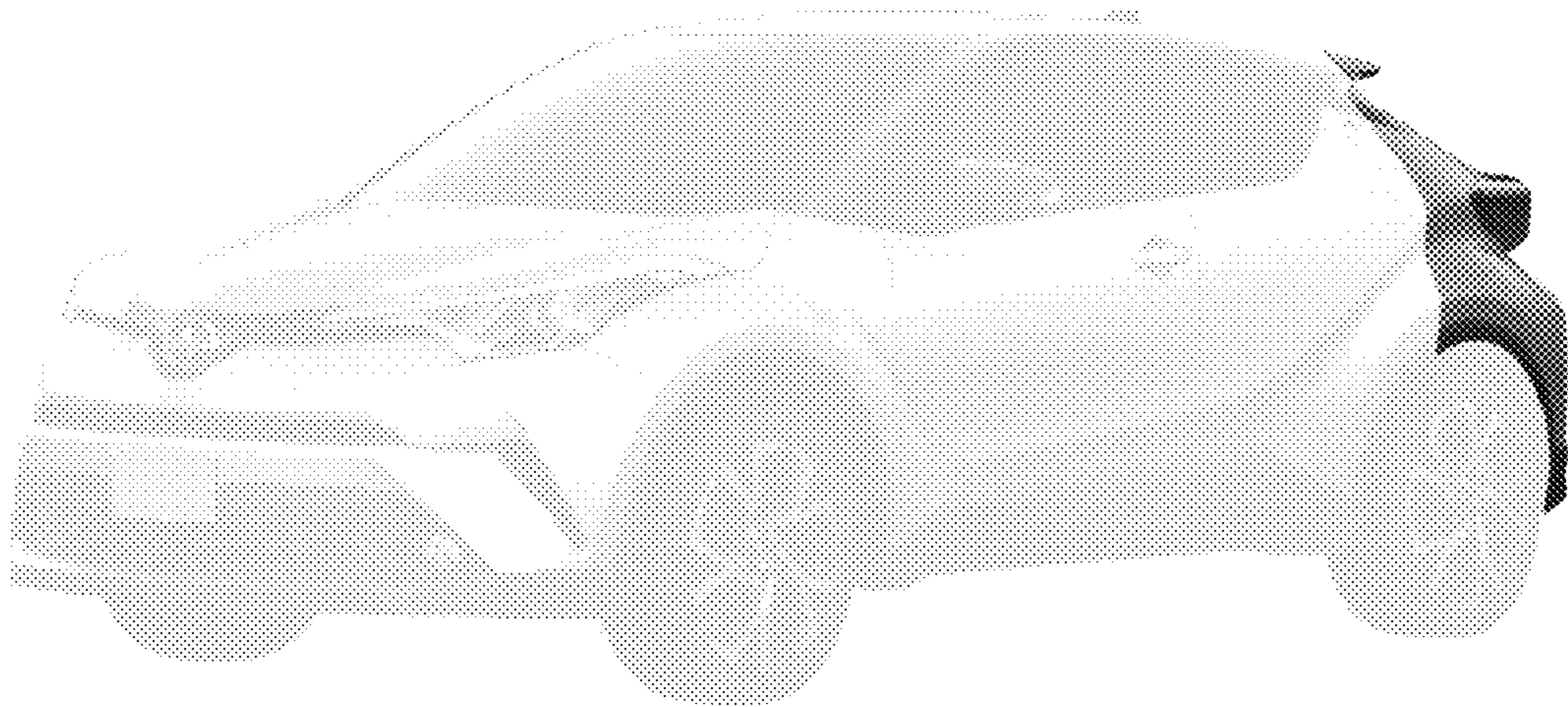
**DESCRIPTION**

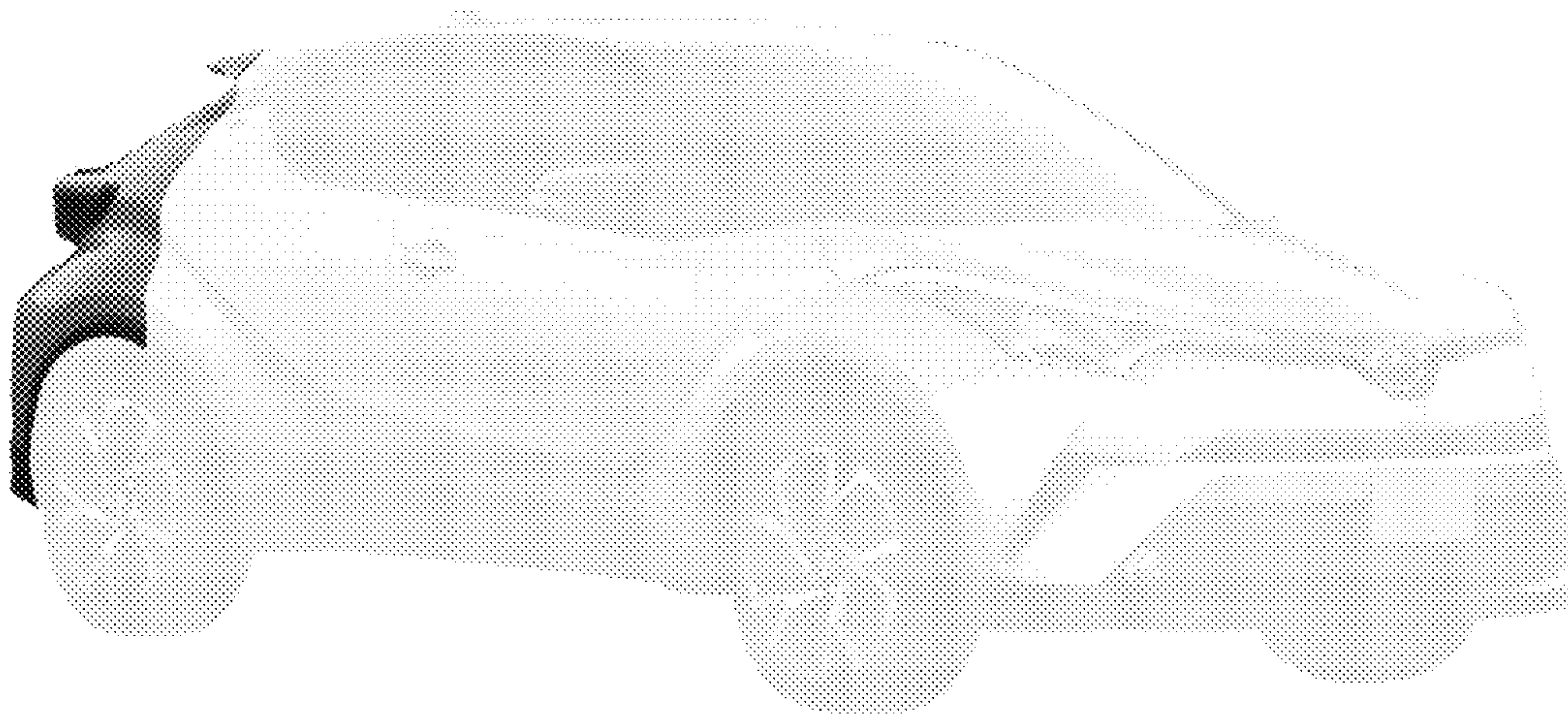
The claimed design is indicated by the relatively dark portions in the figures. The relatively light portions form no part of the claimed design.

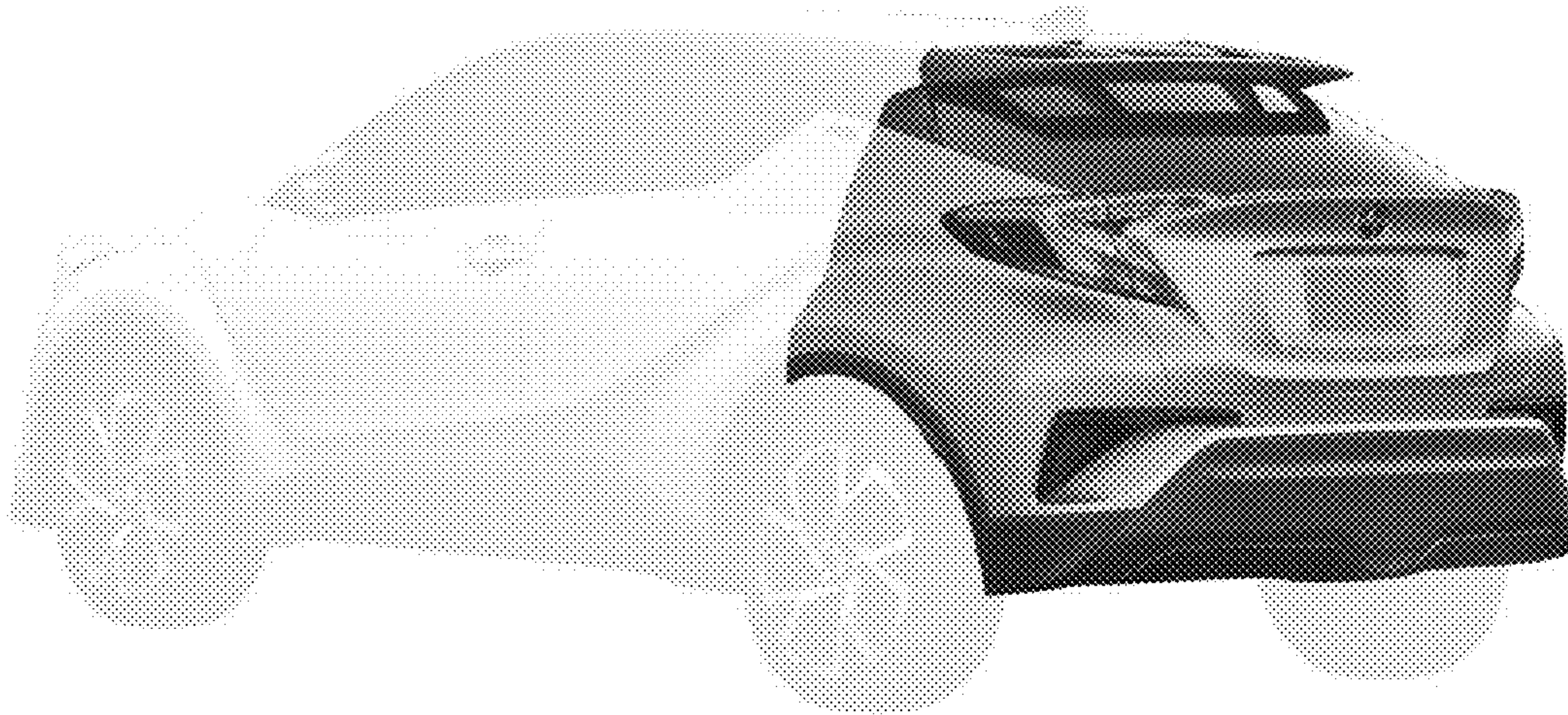

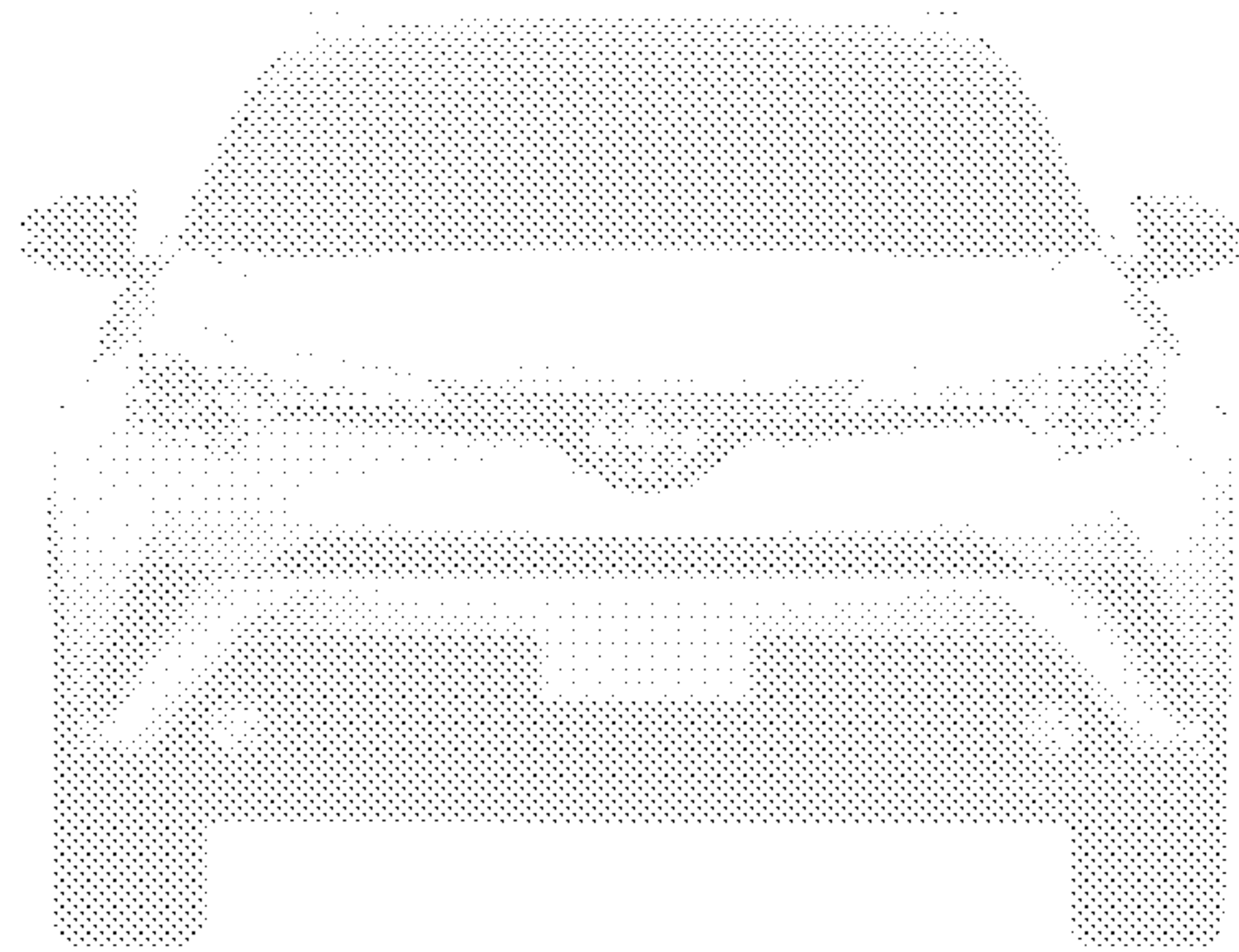




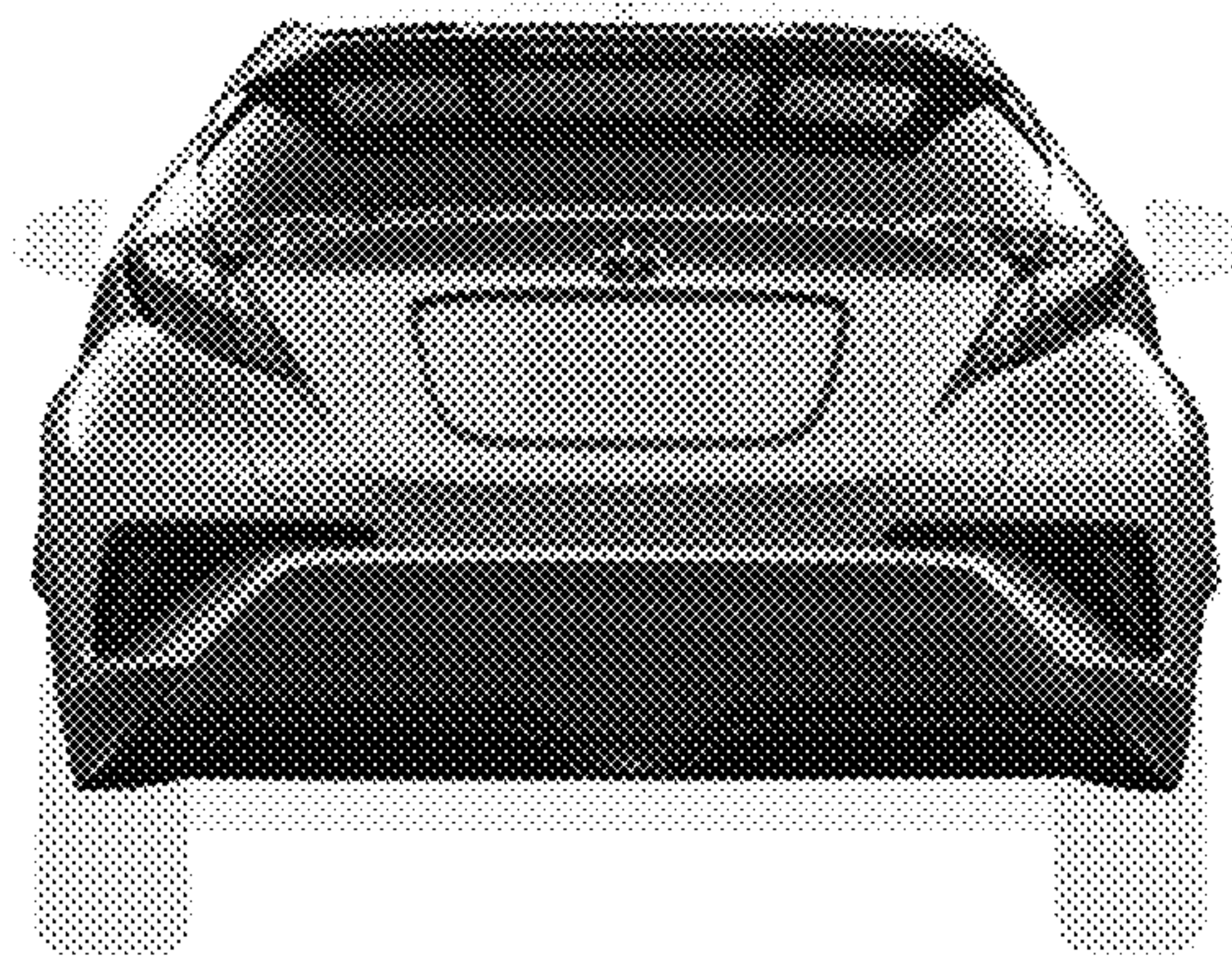

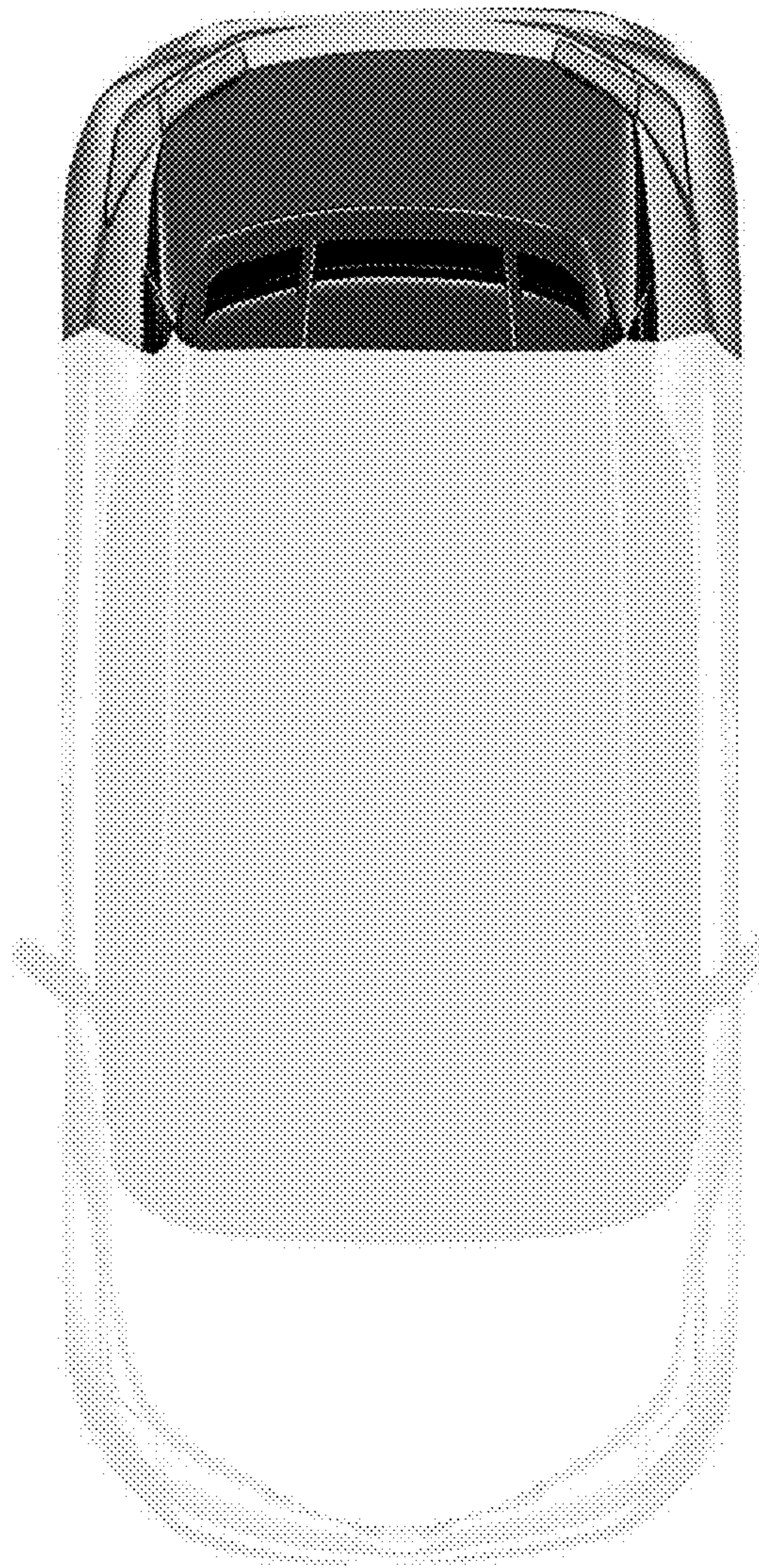

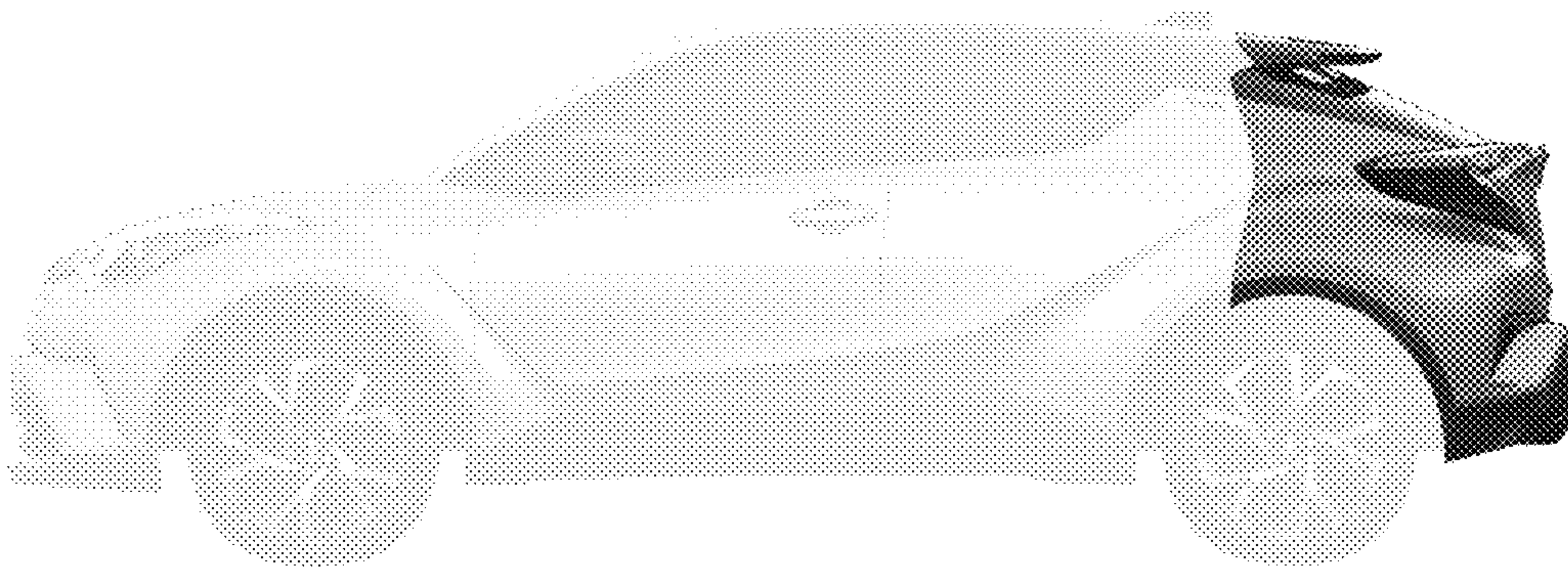

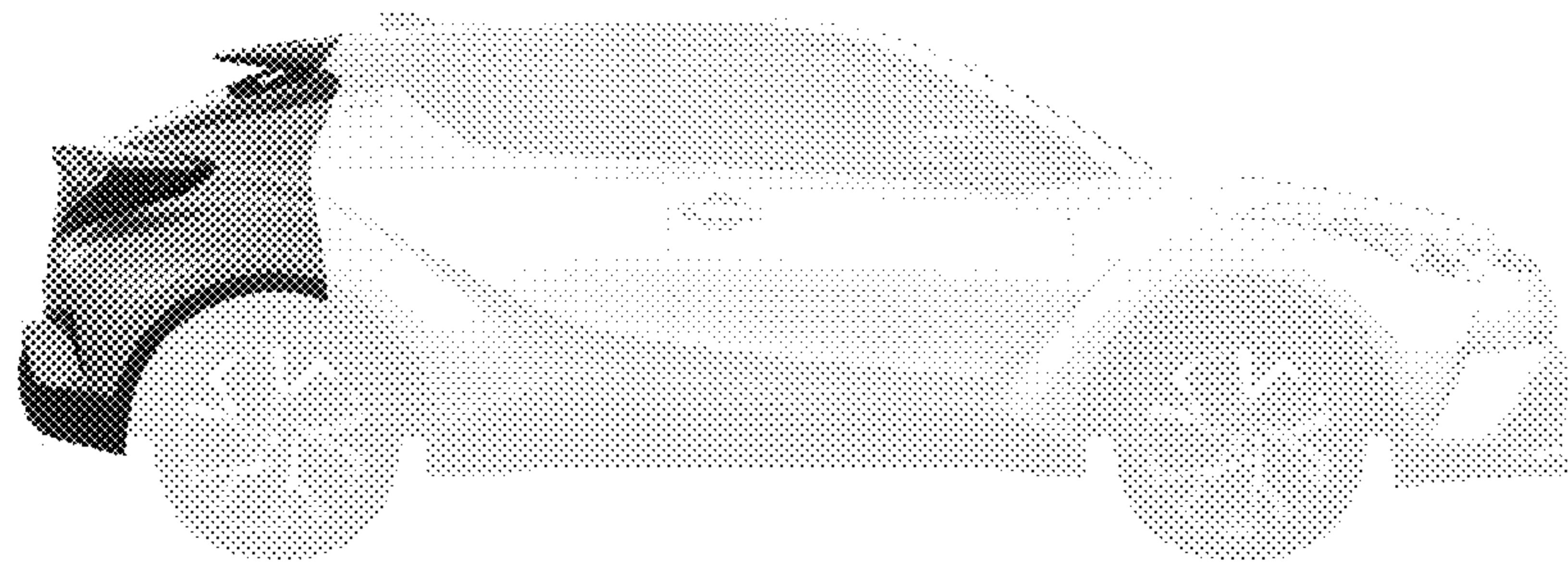

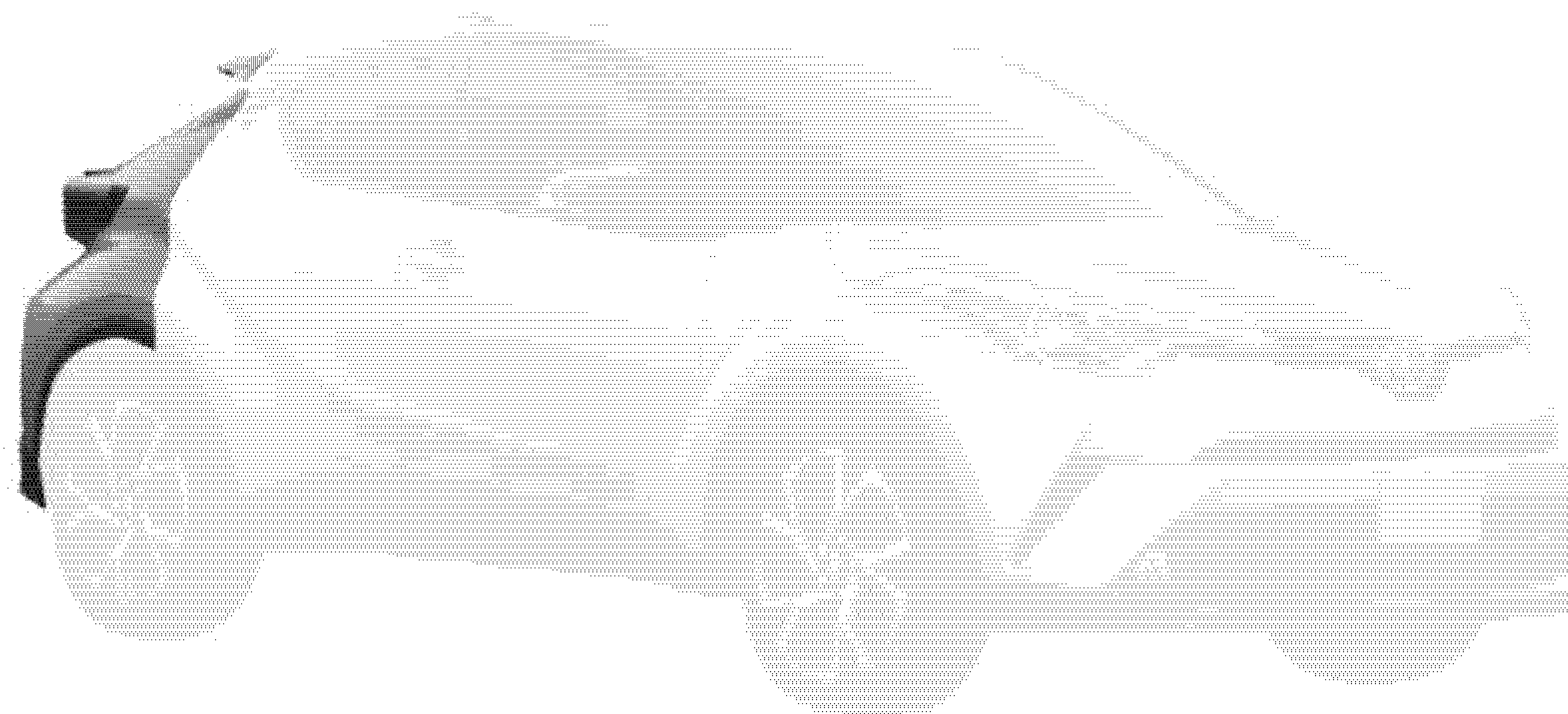

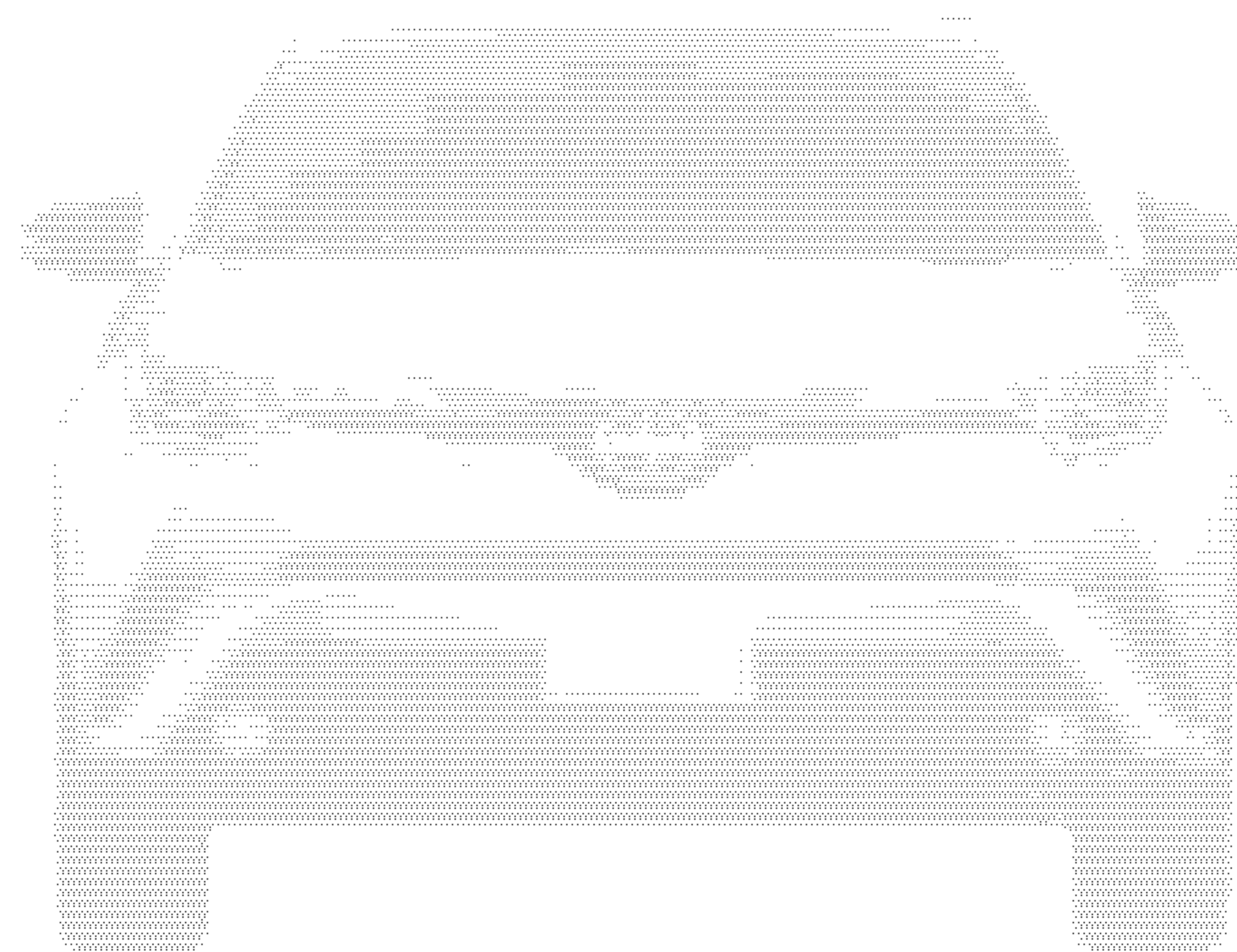

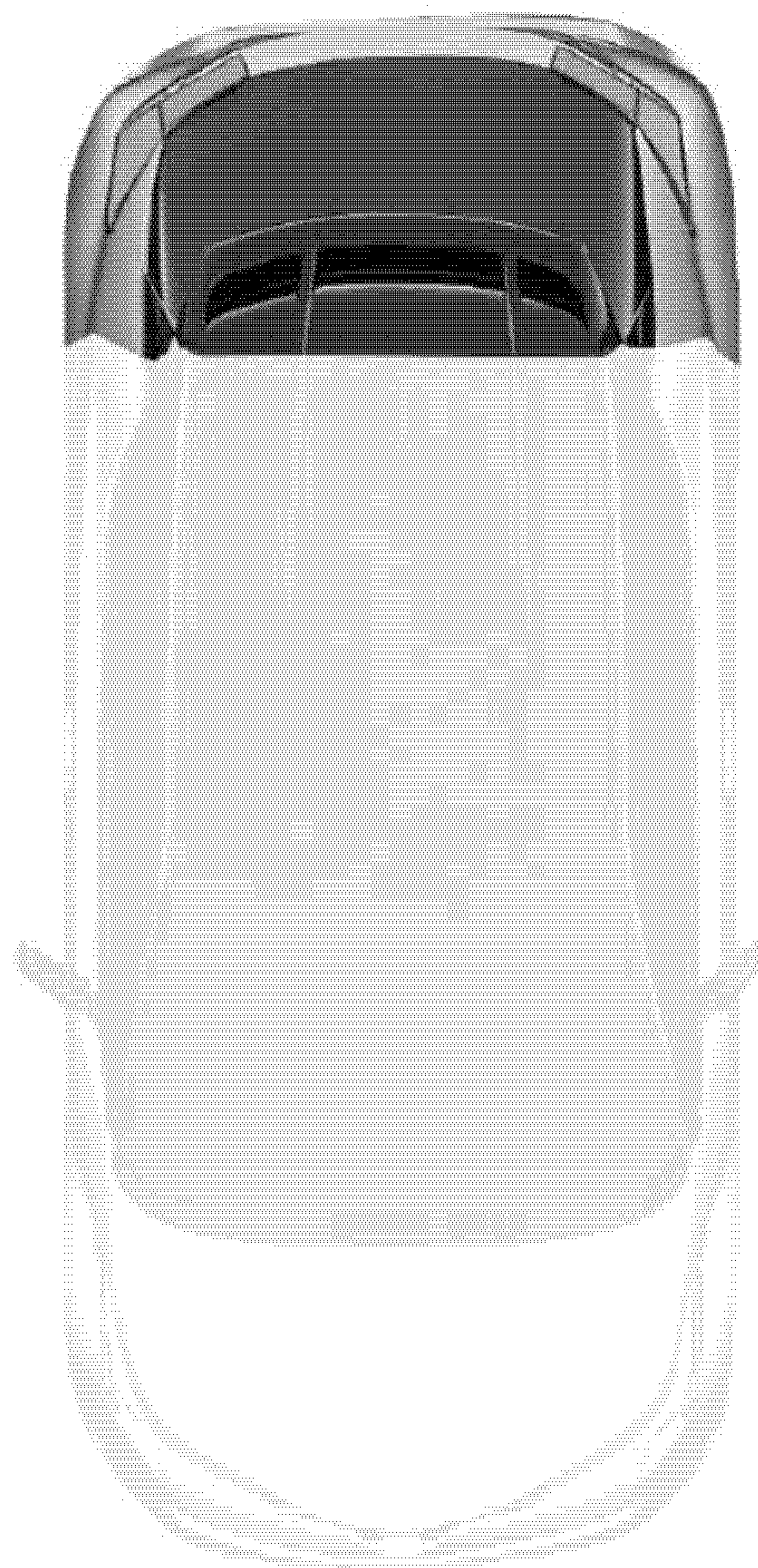

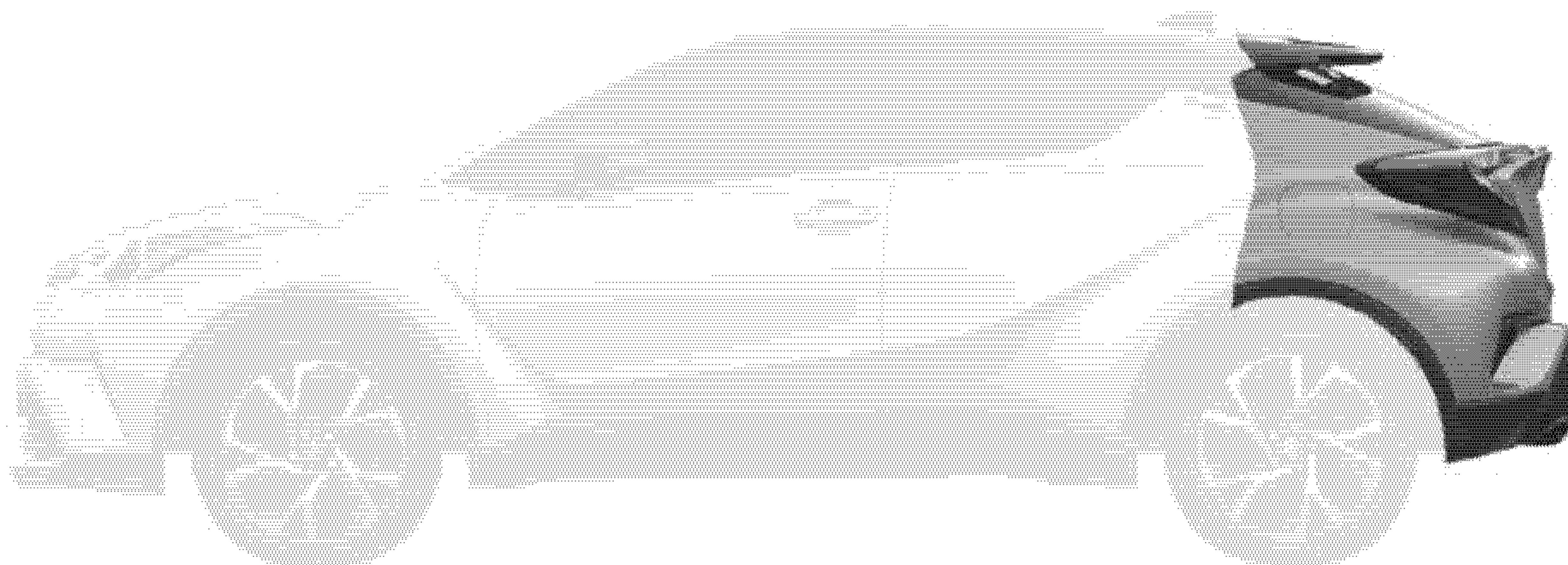

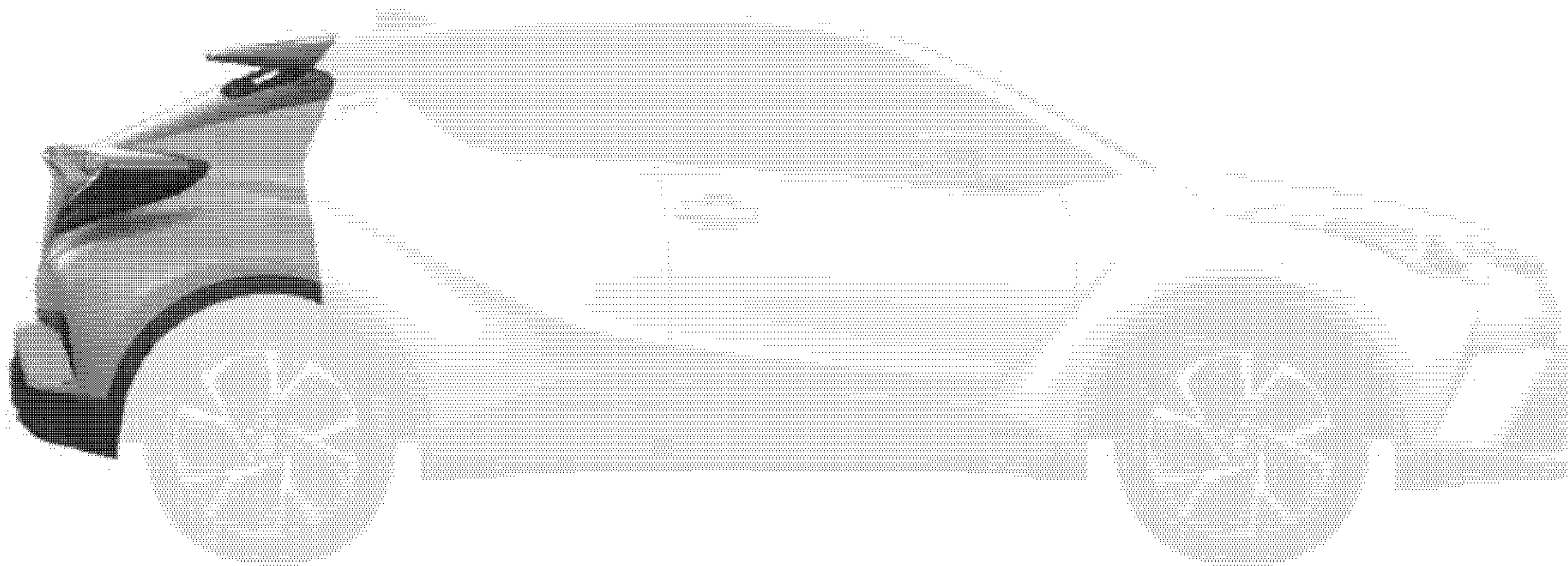

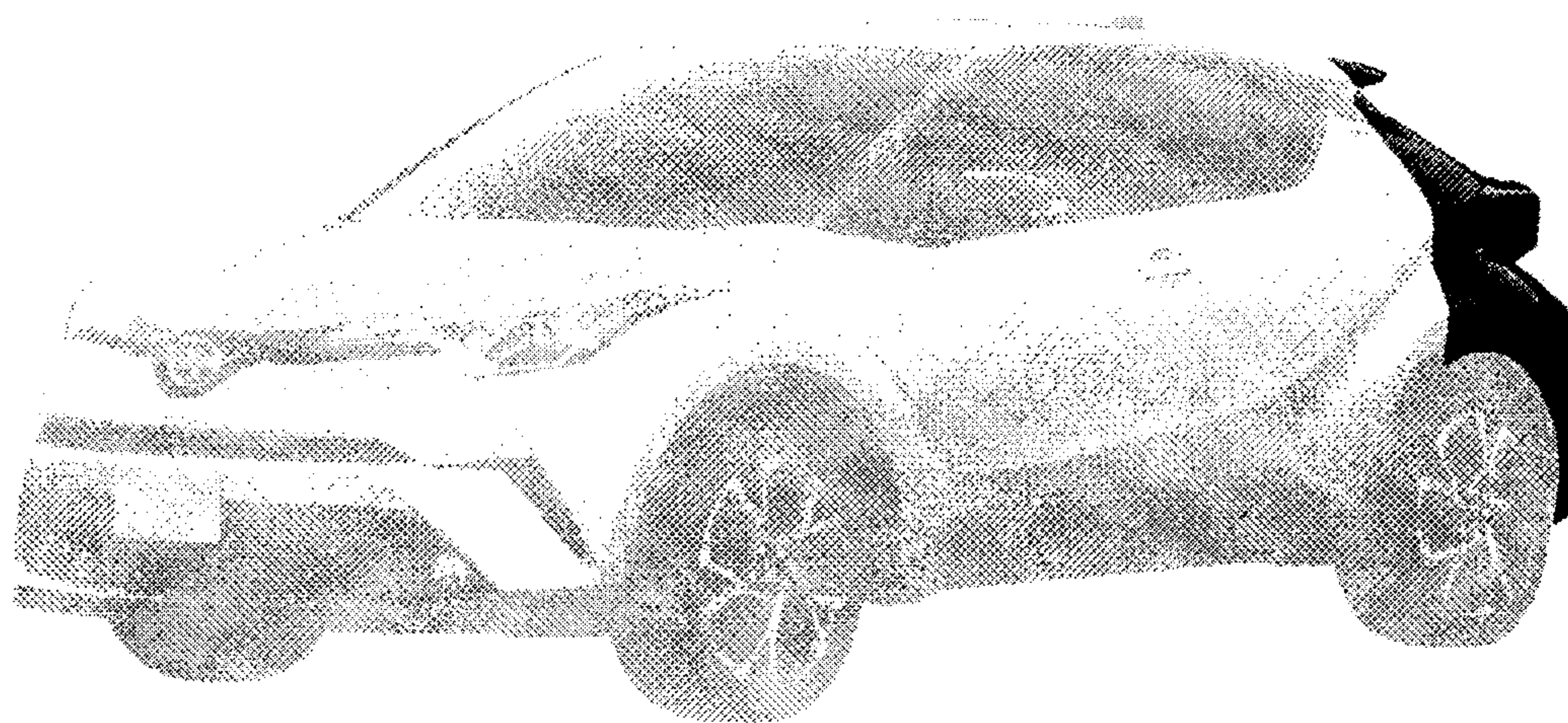

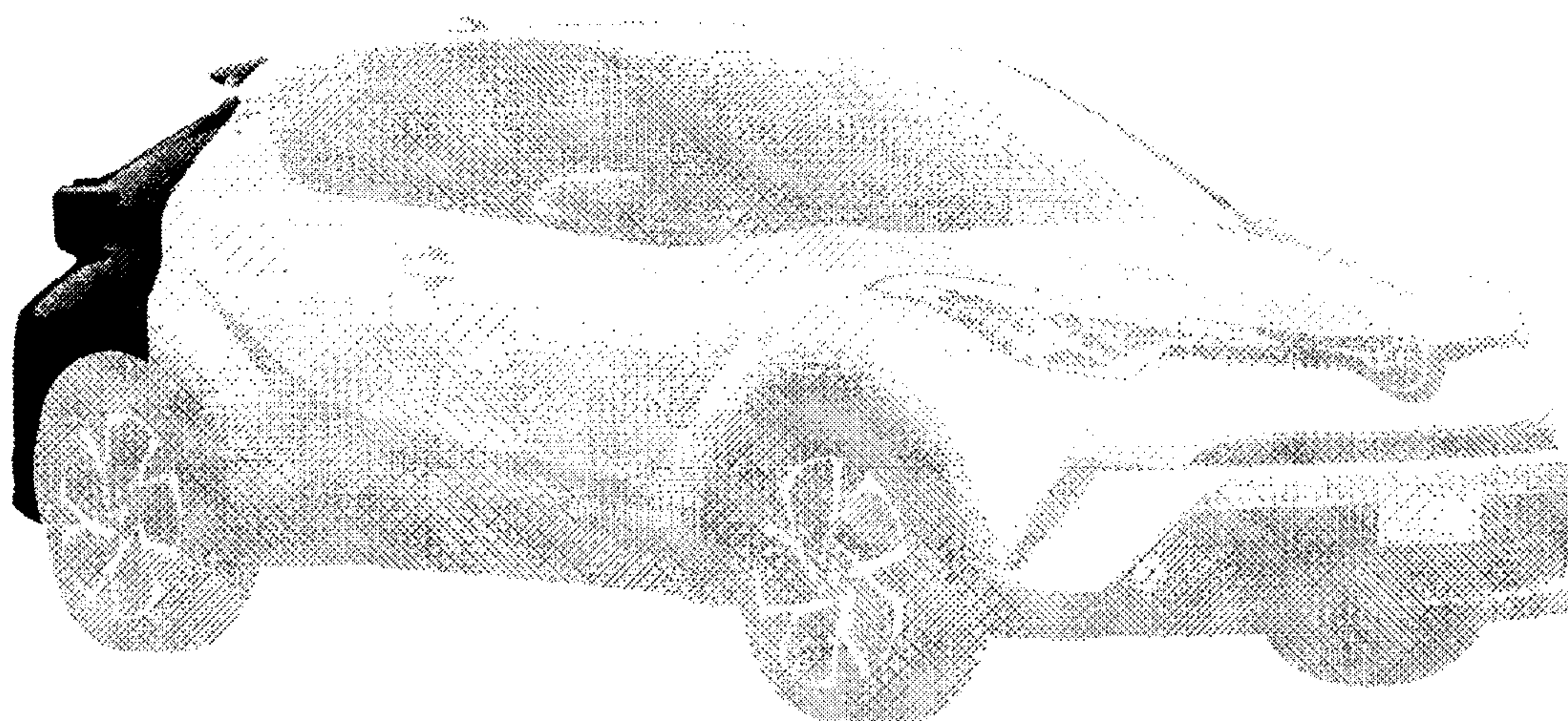

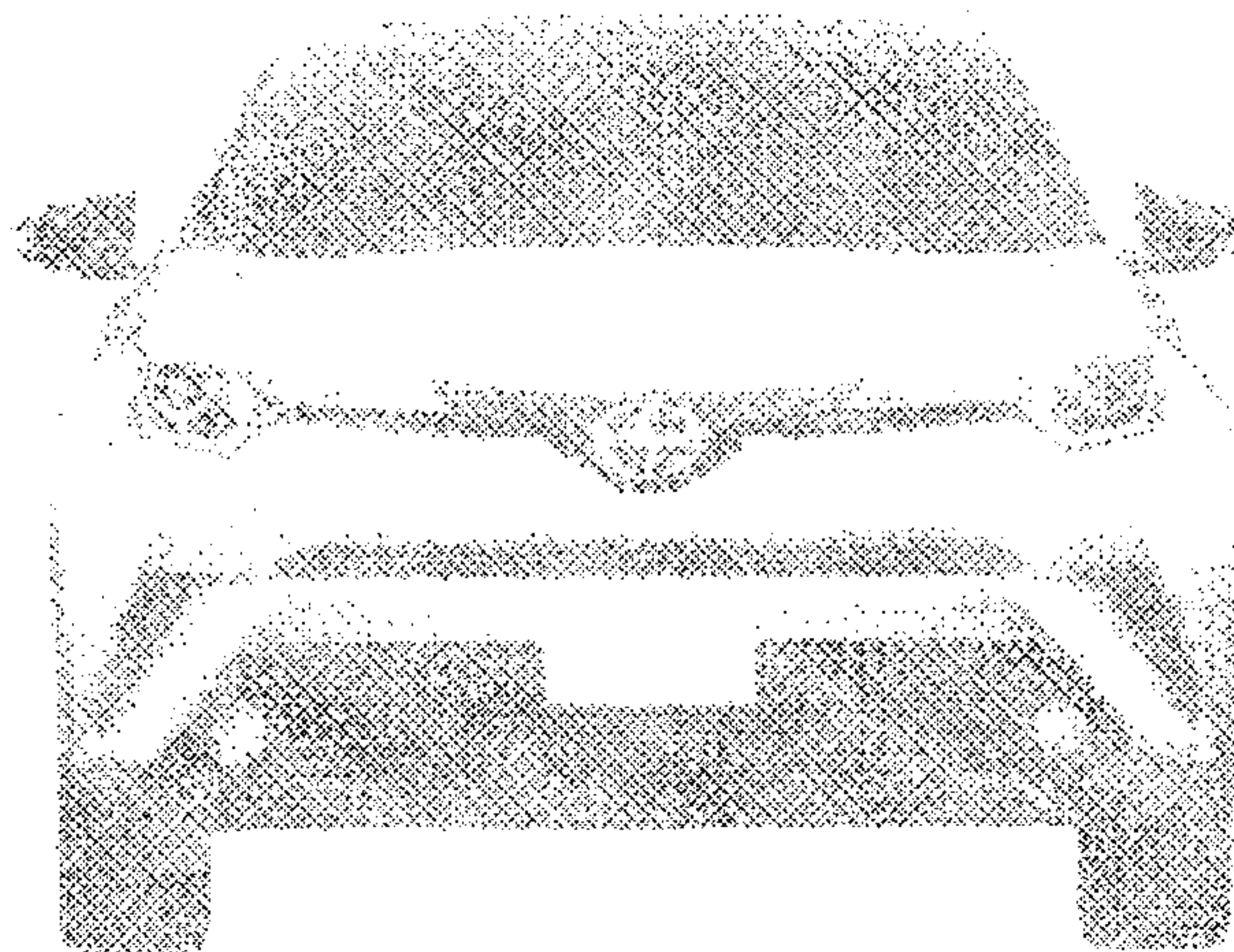




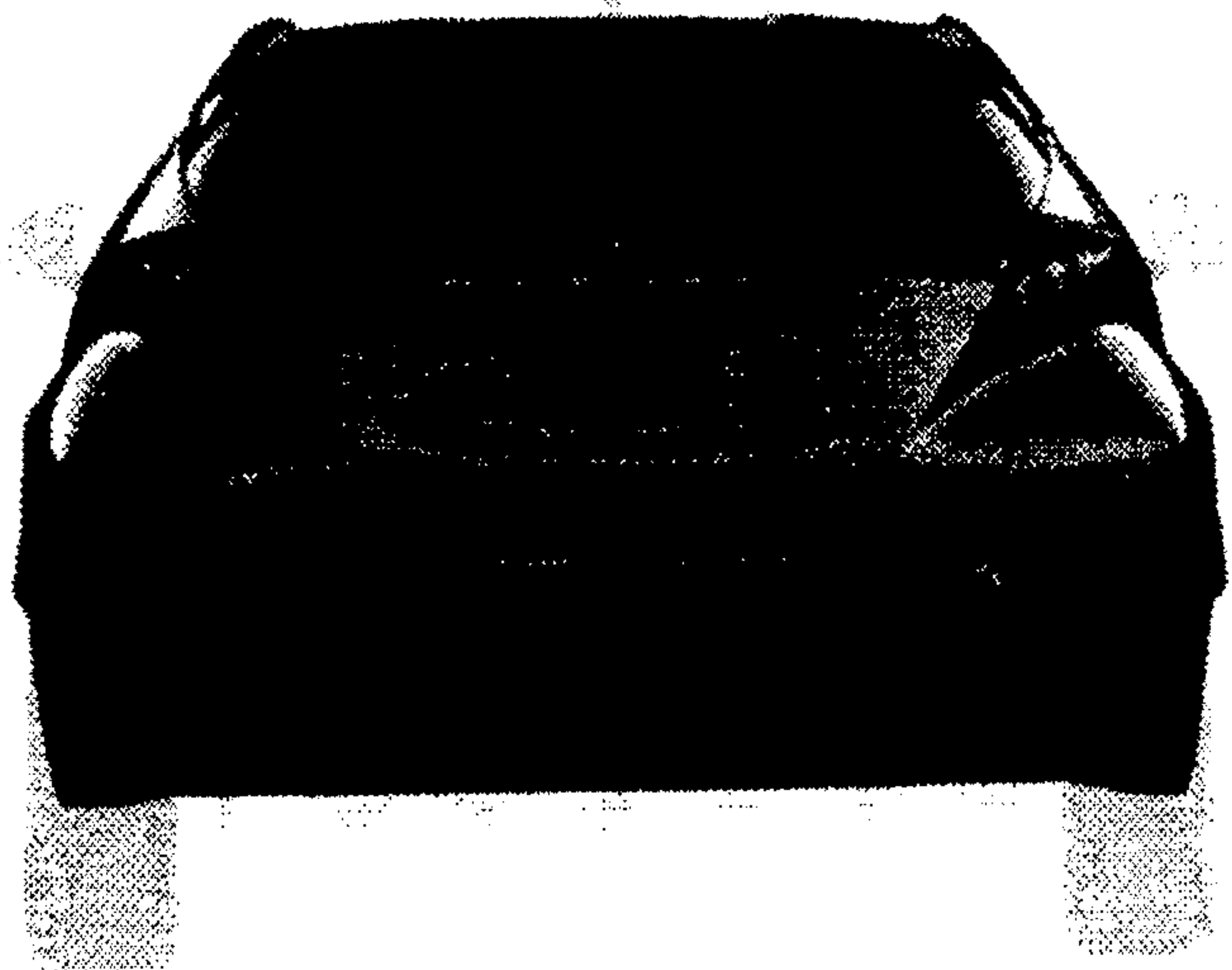

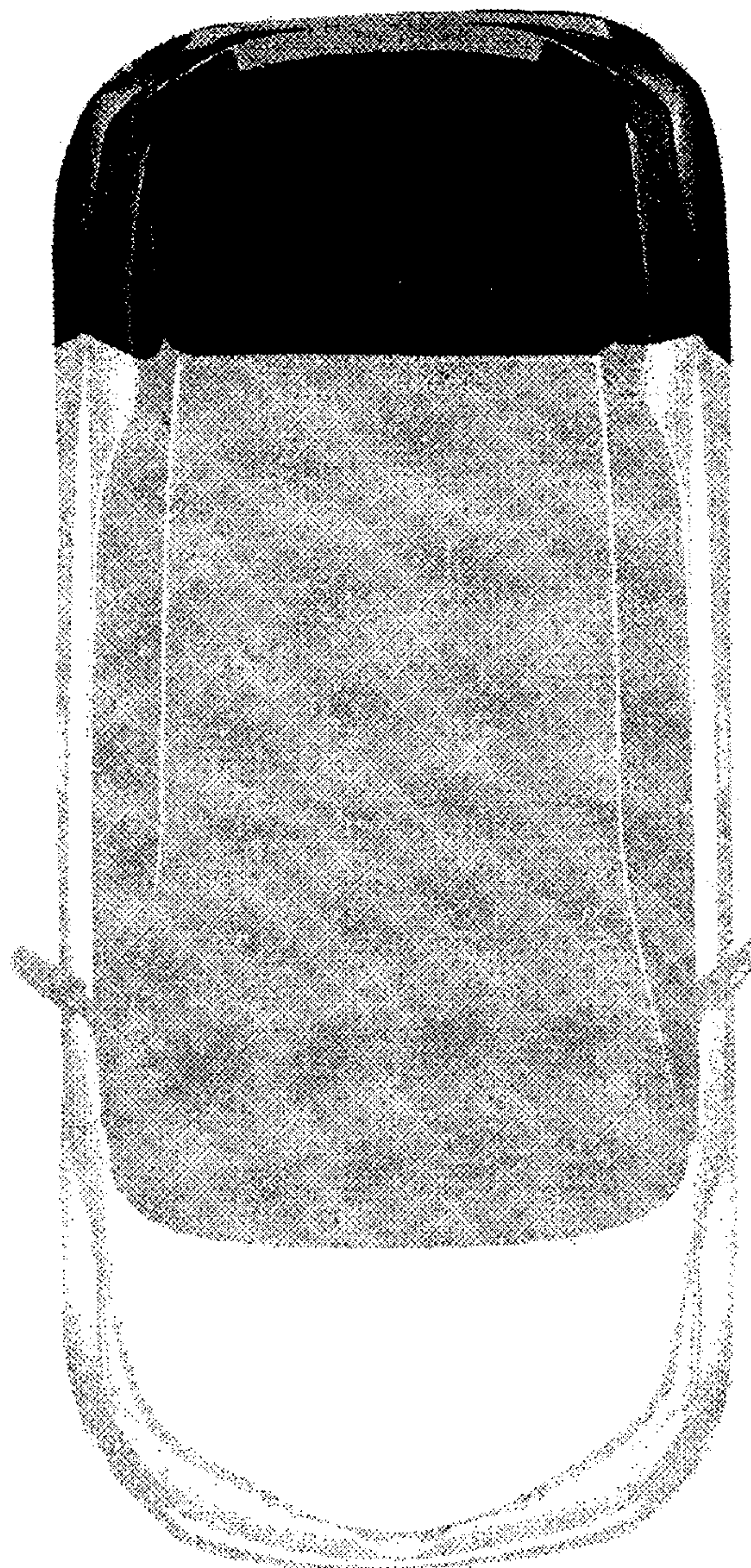

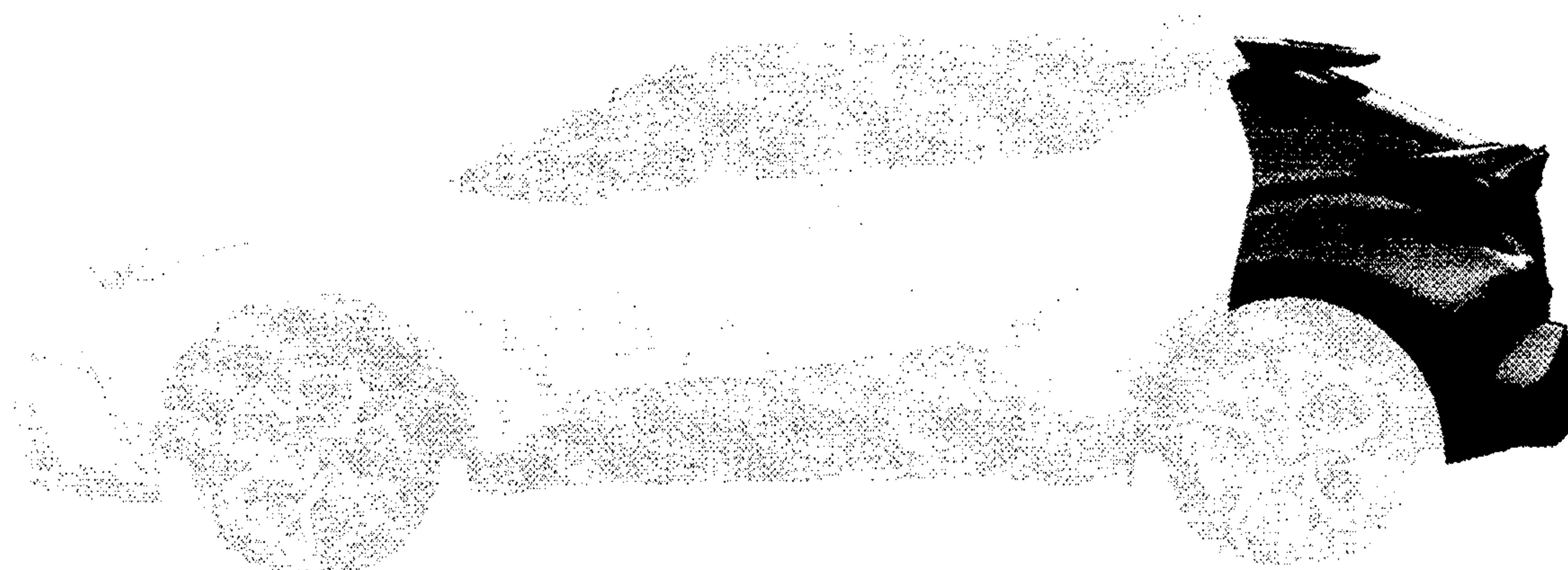

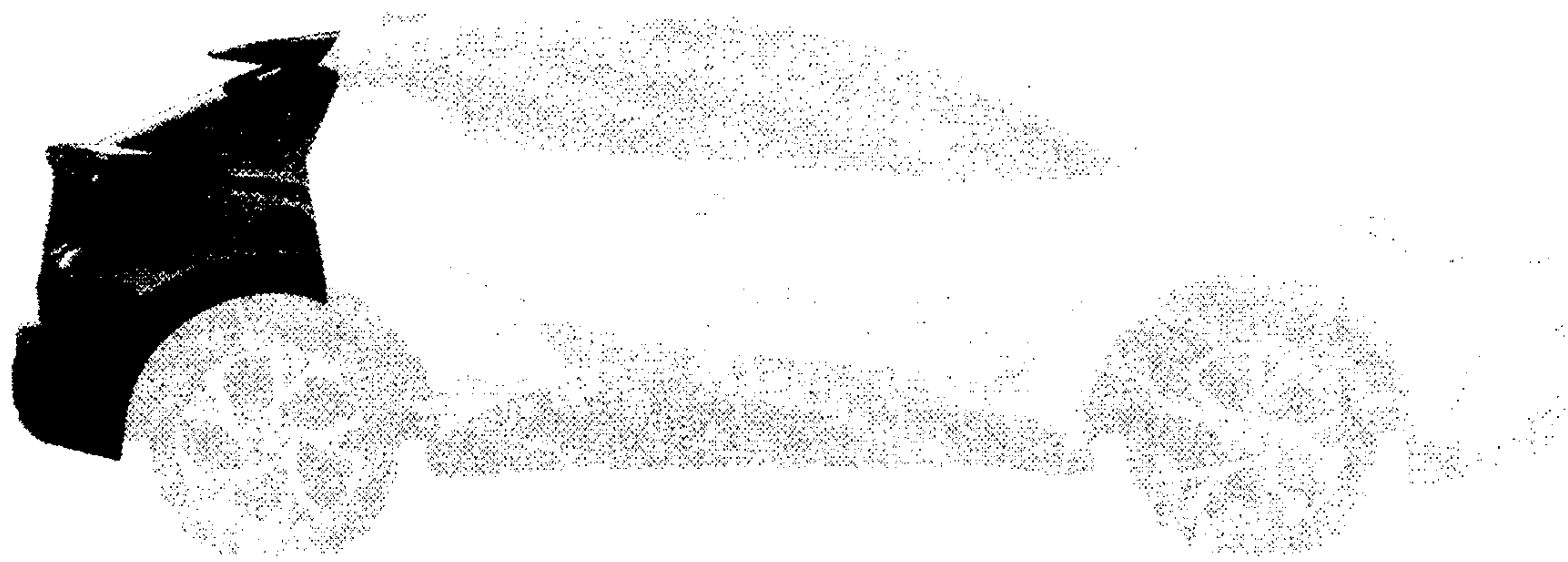
