DESCRIPTION

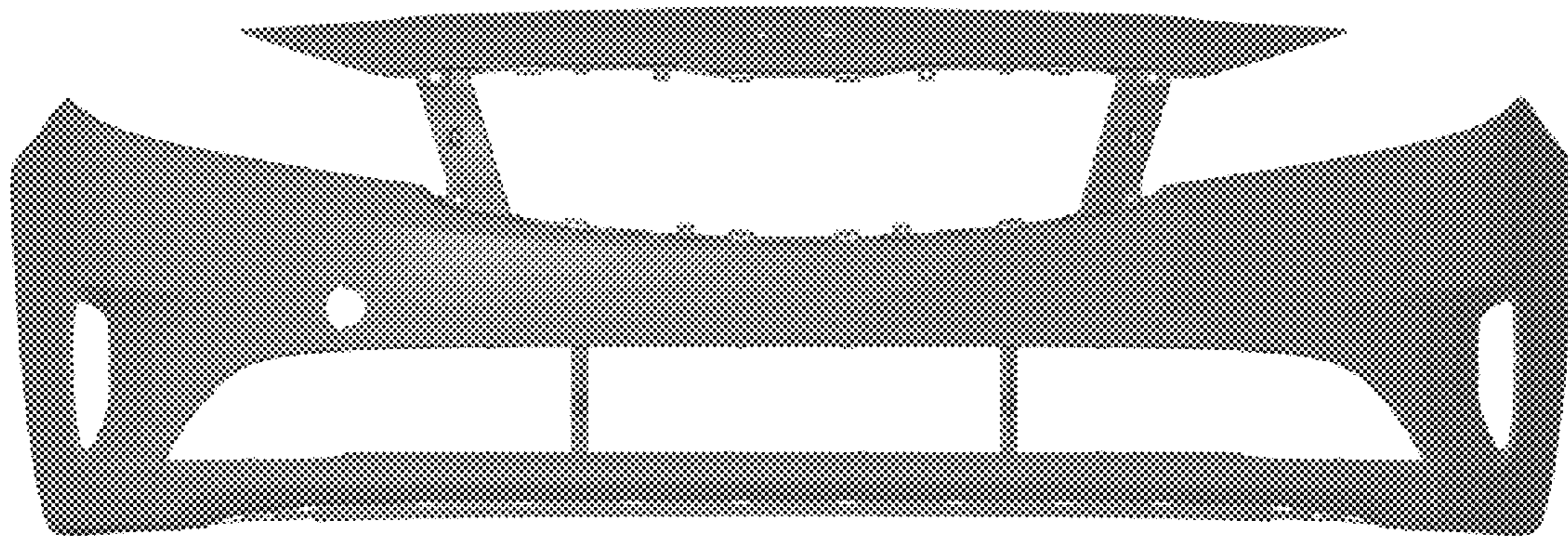

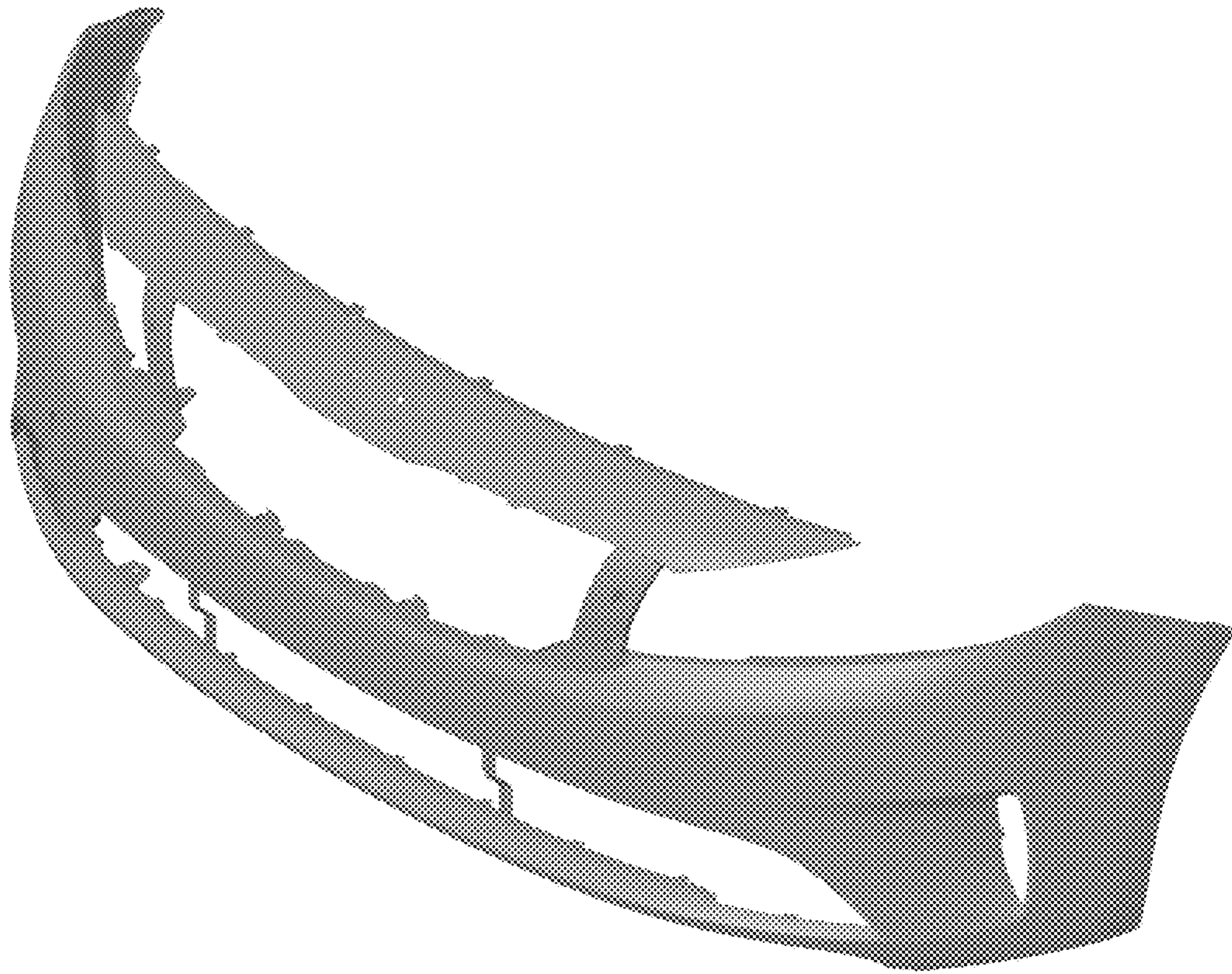

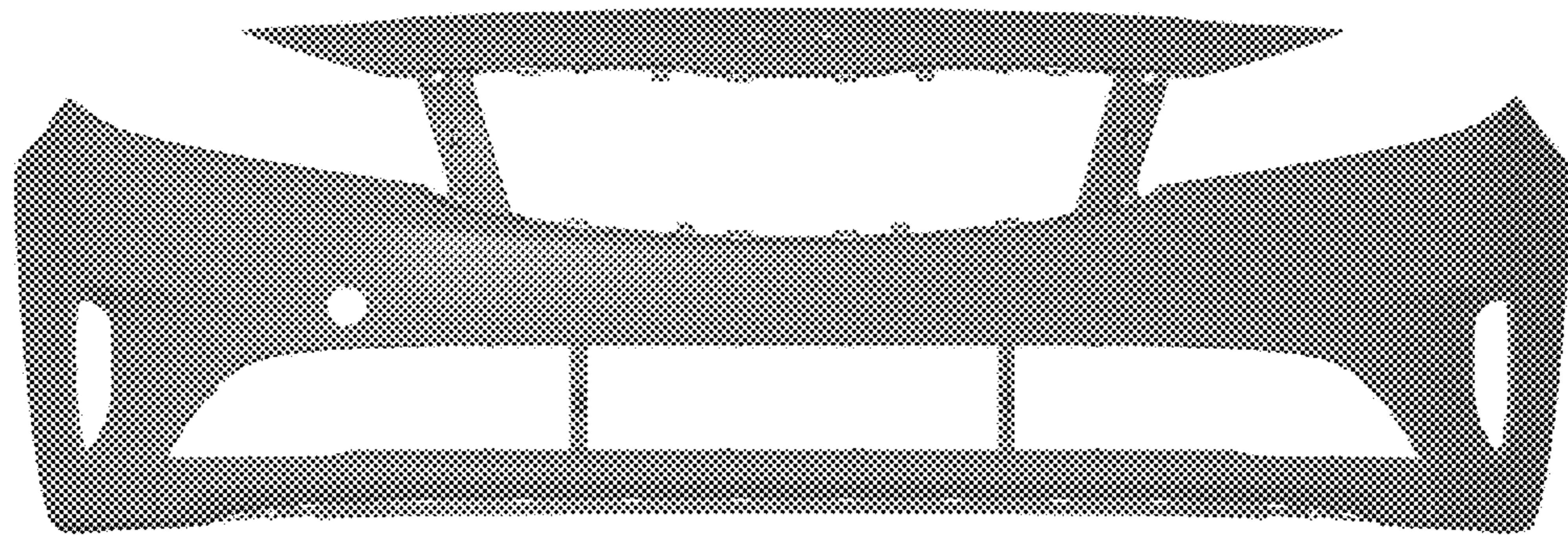

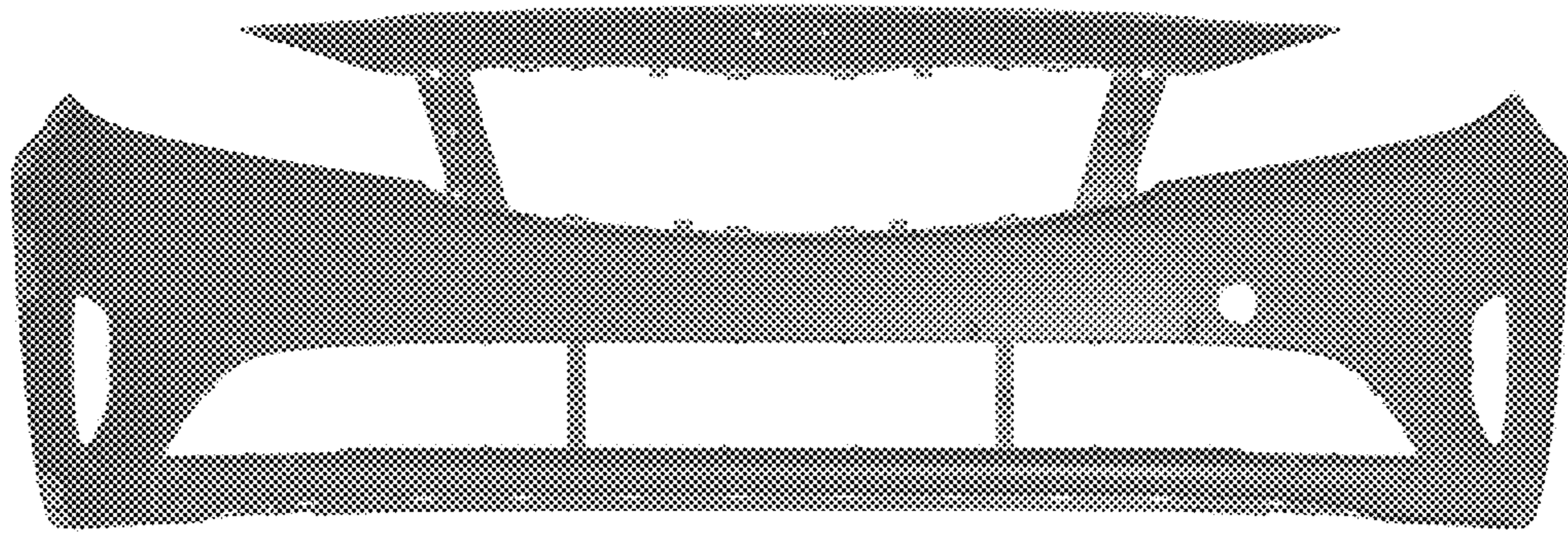

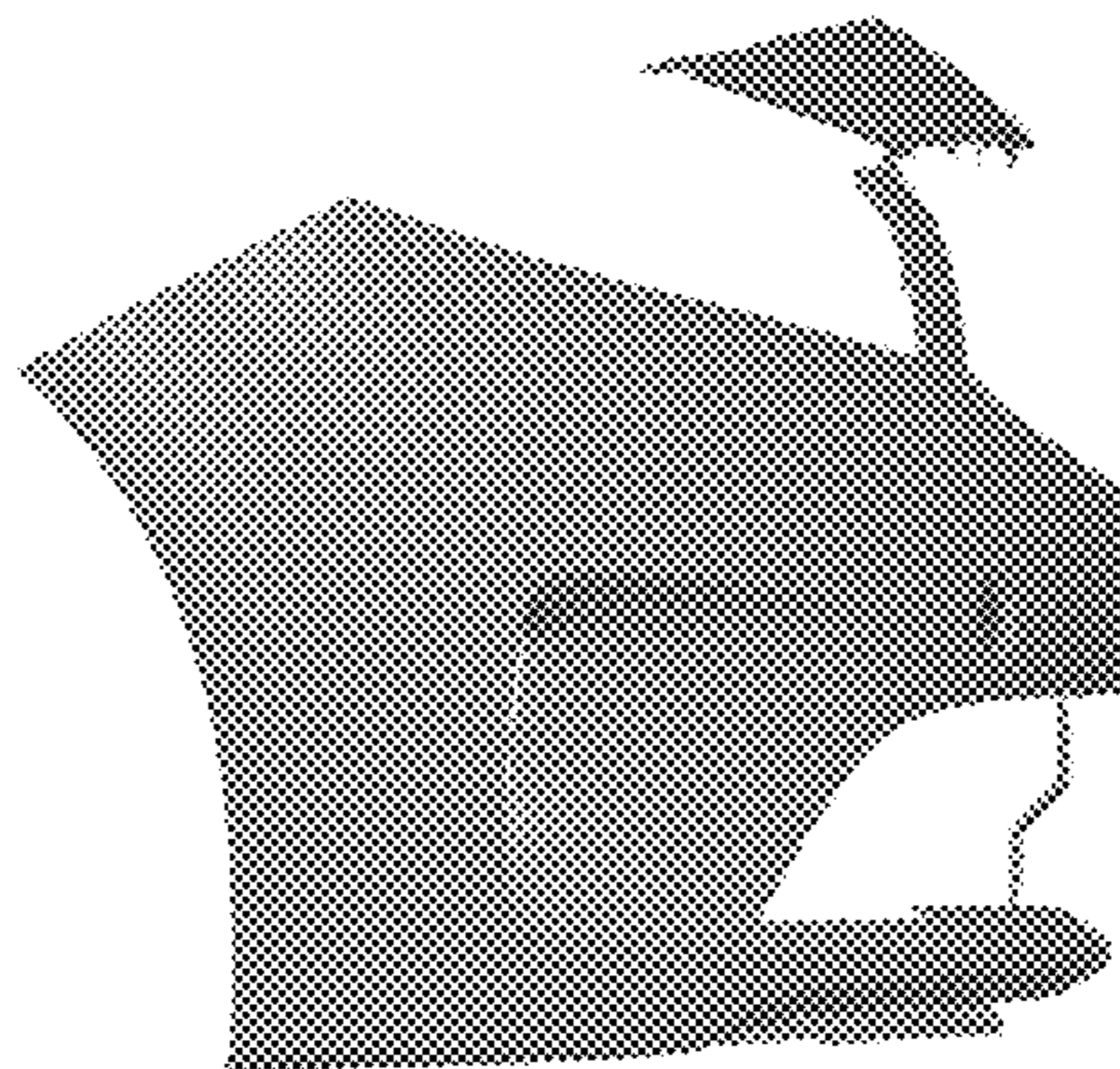

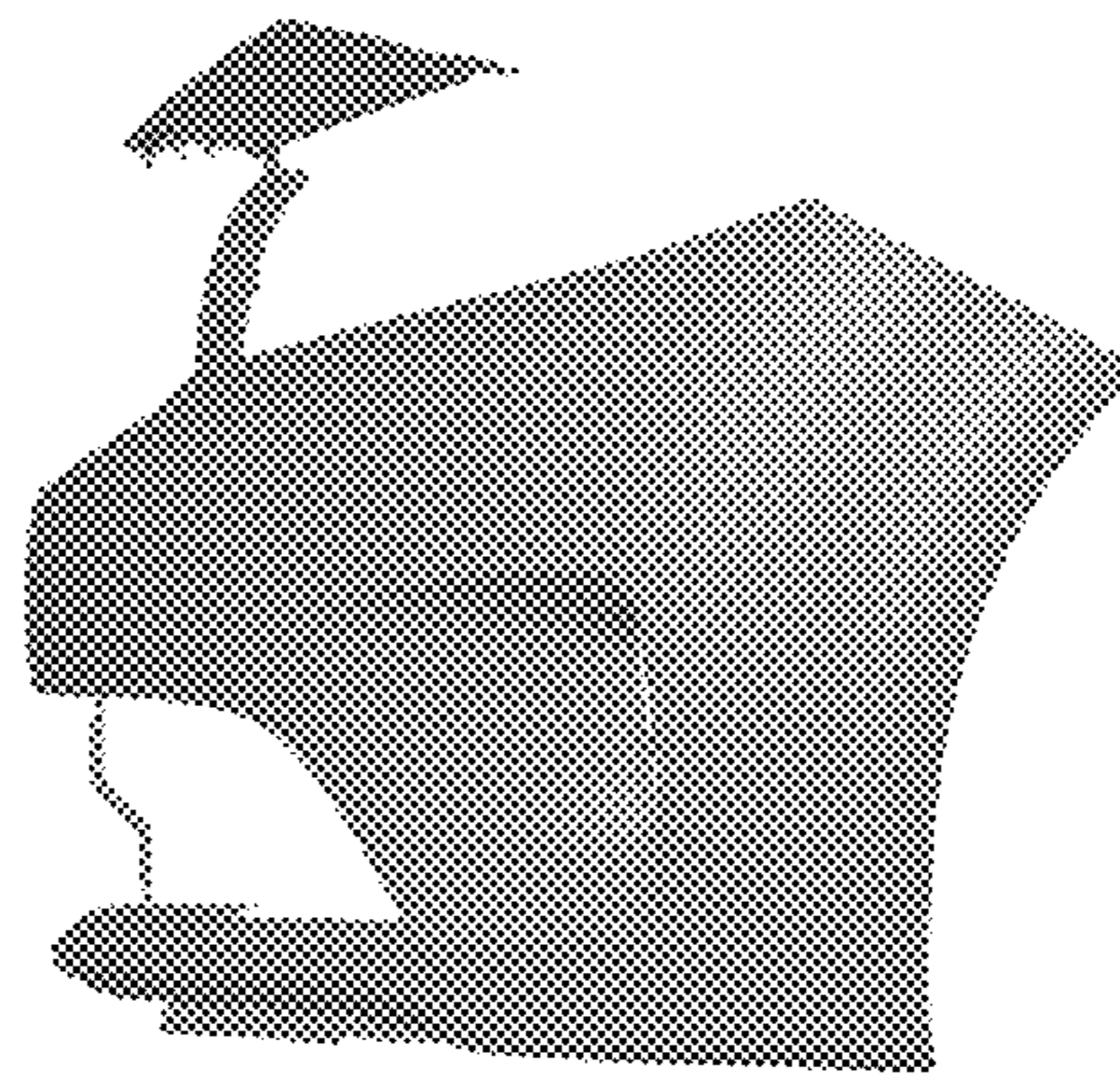

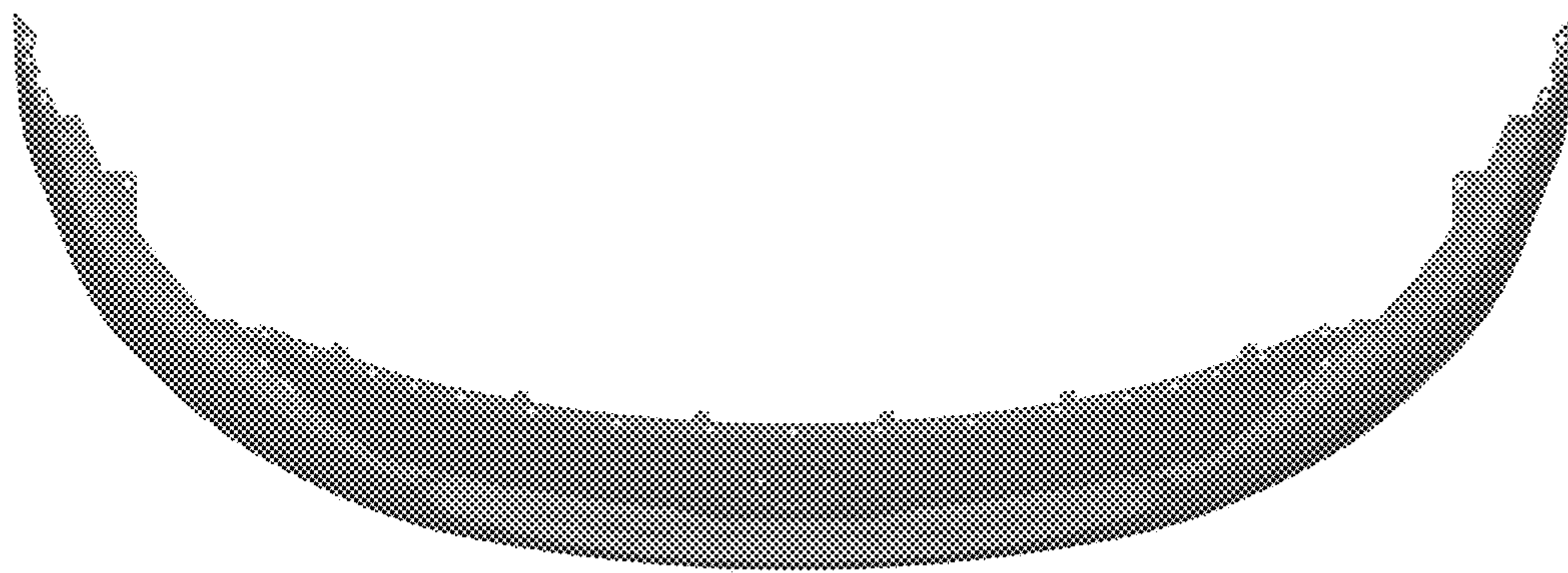

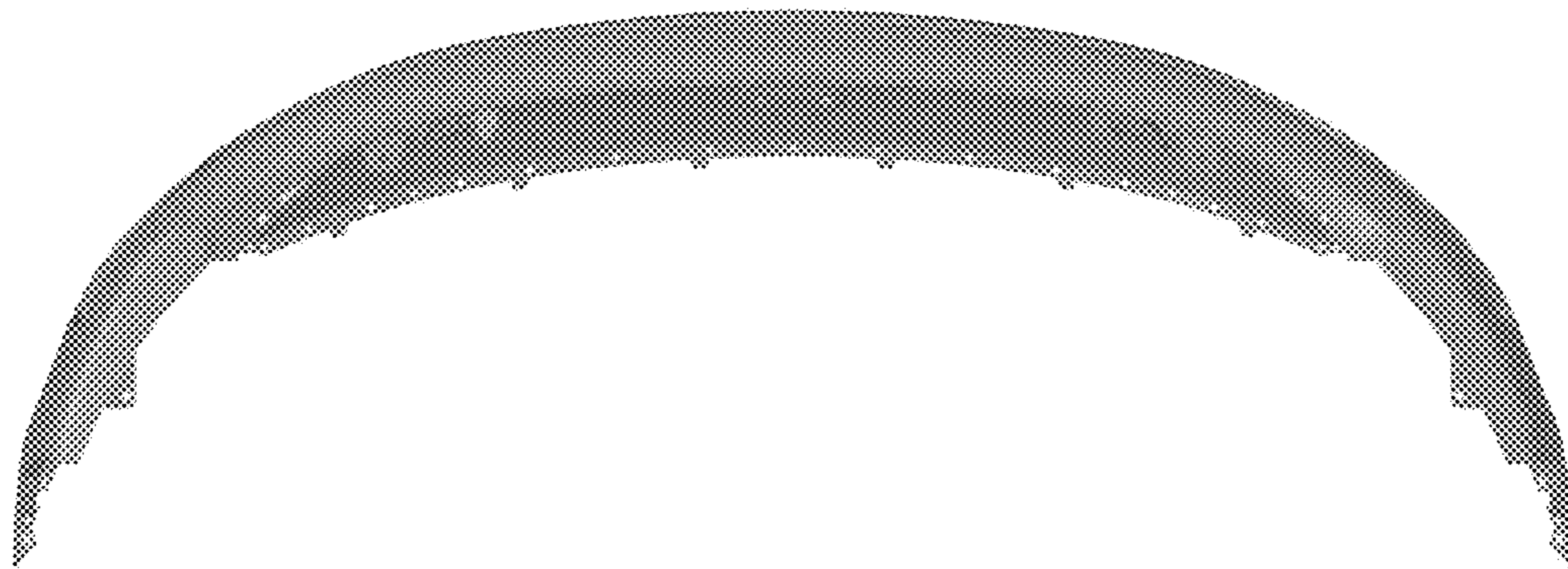
