FIG. 4 is a partial enlarged view of a third image thereof; and,

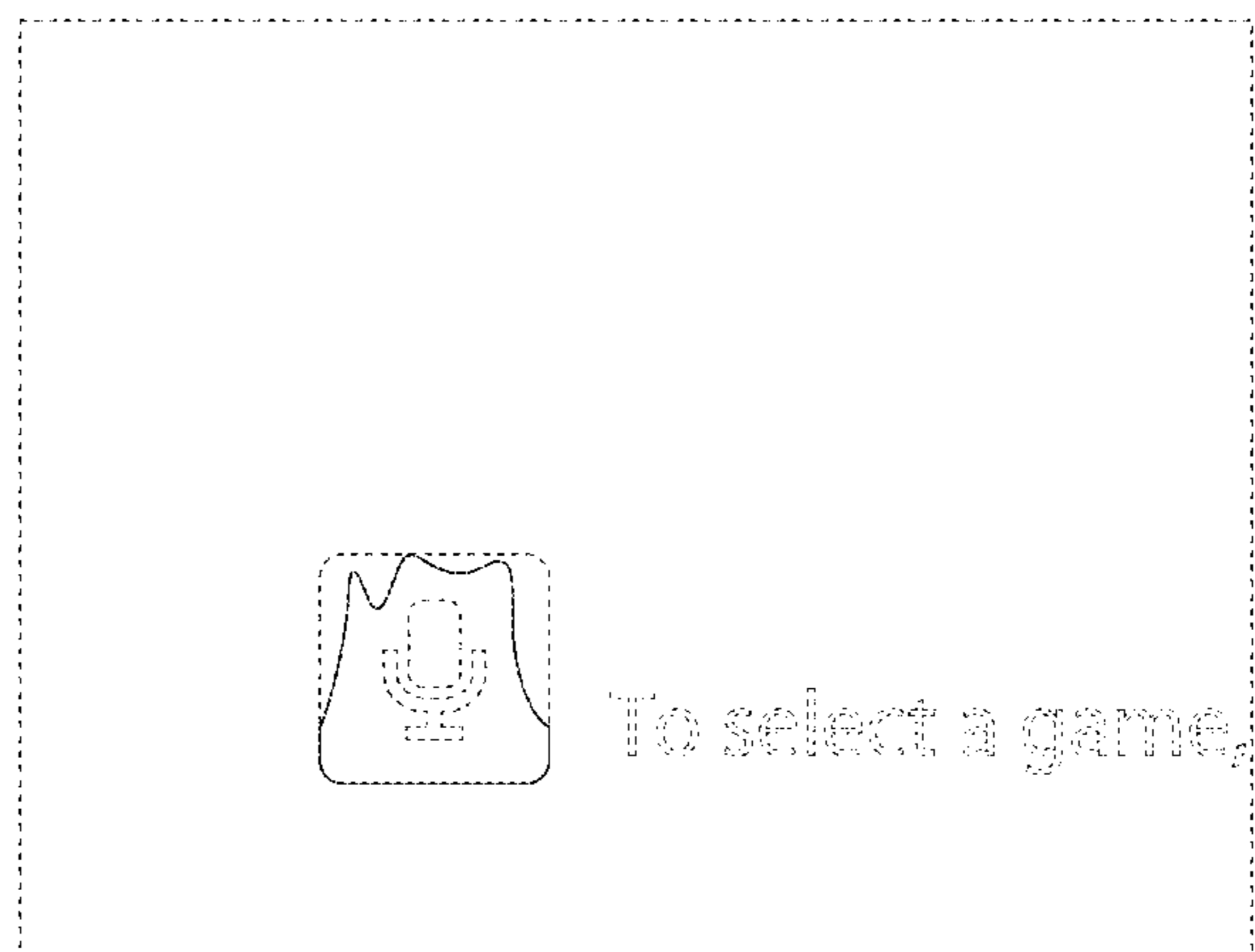
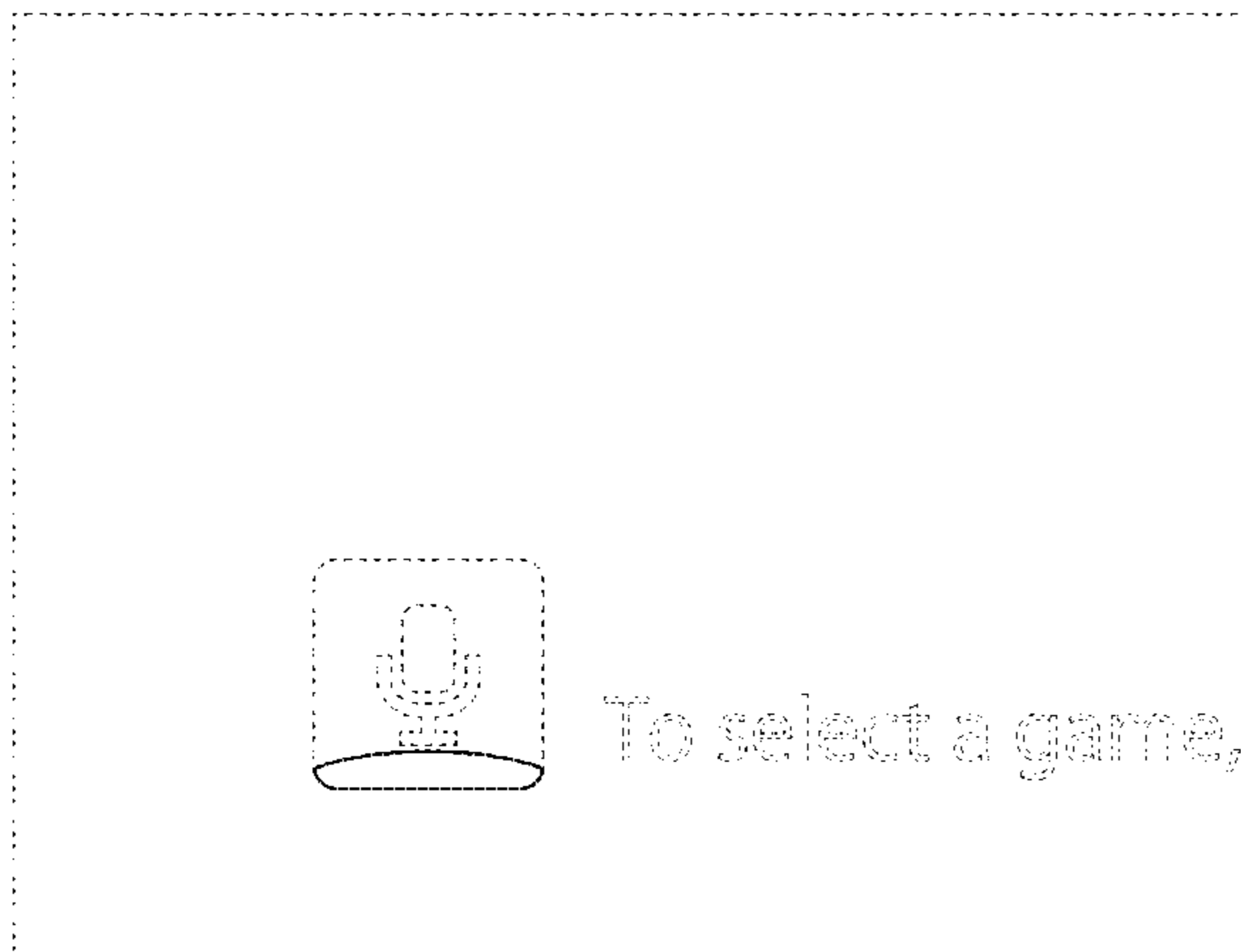
FIG. 5 is a partial enlarged view of a fourth image thereof.

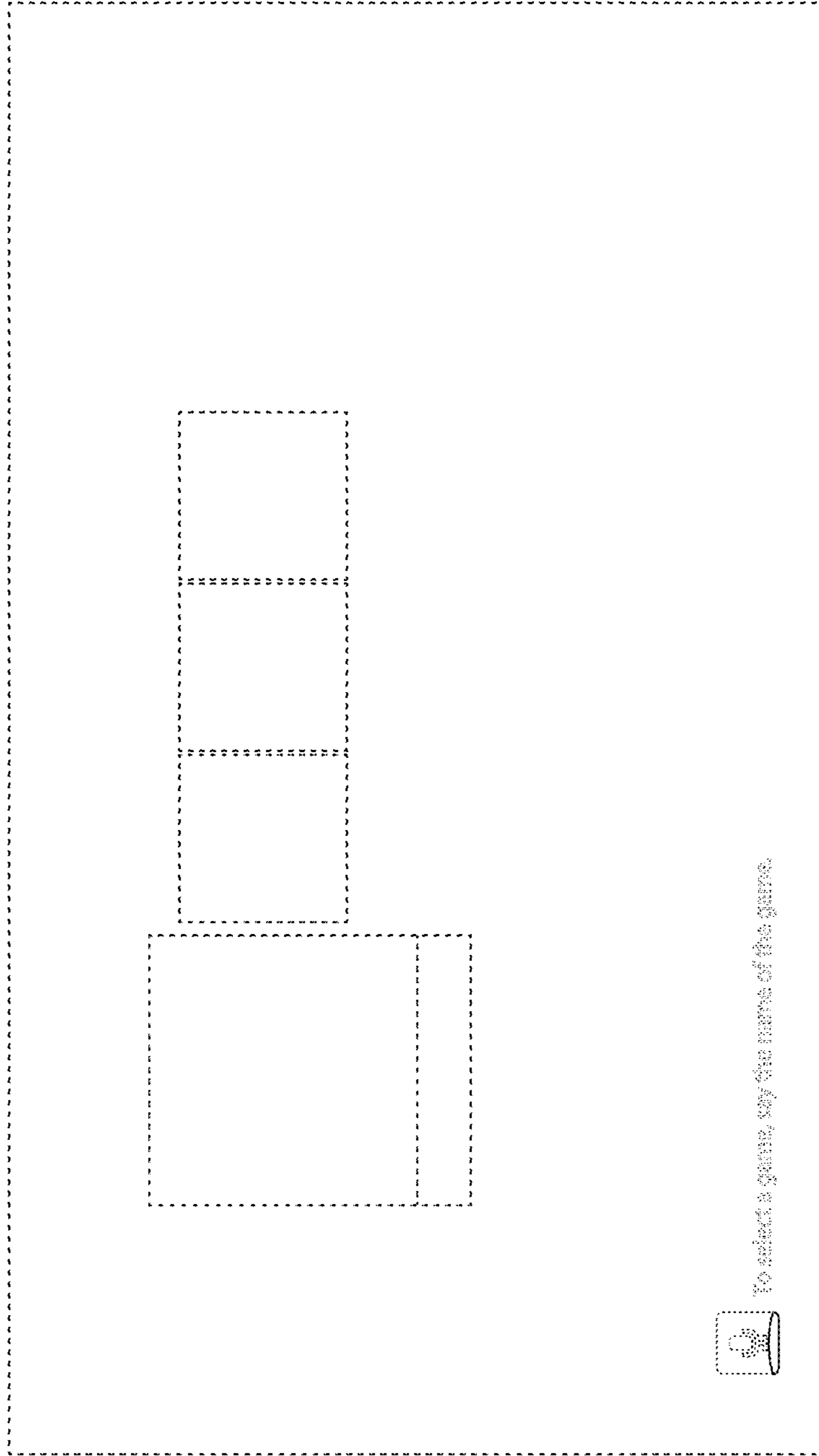

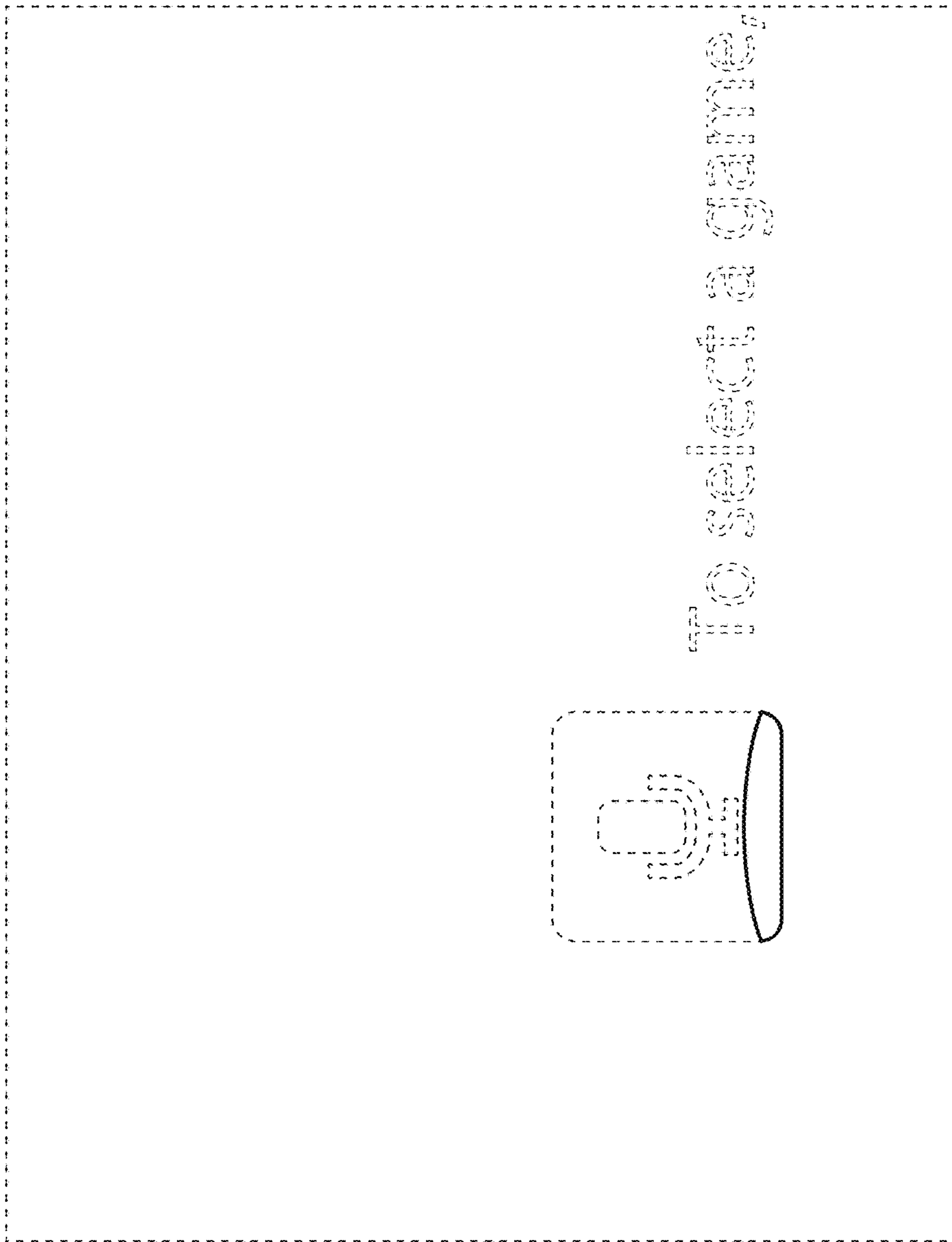

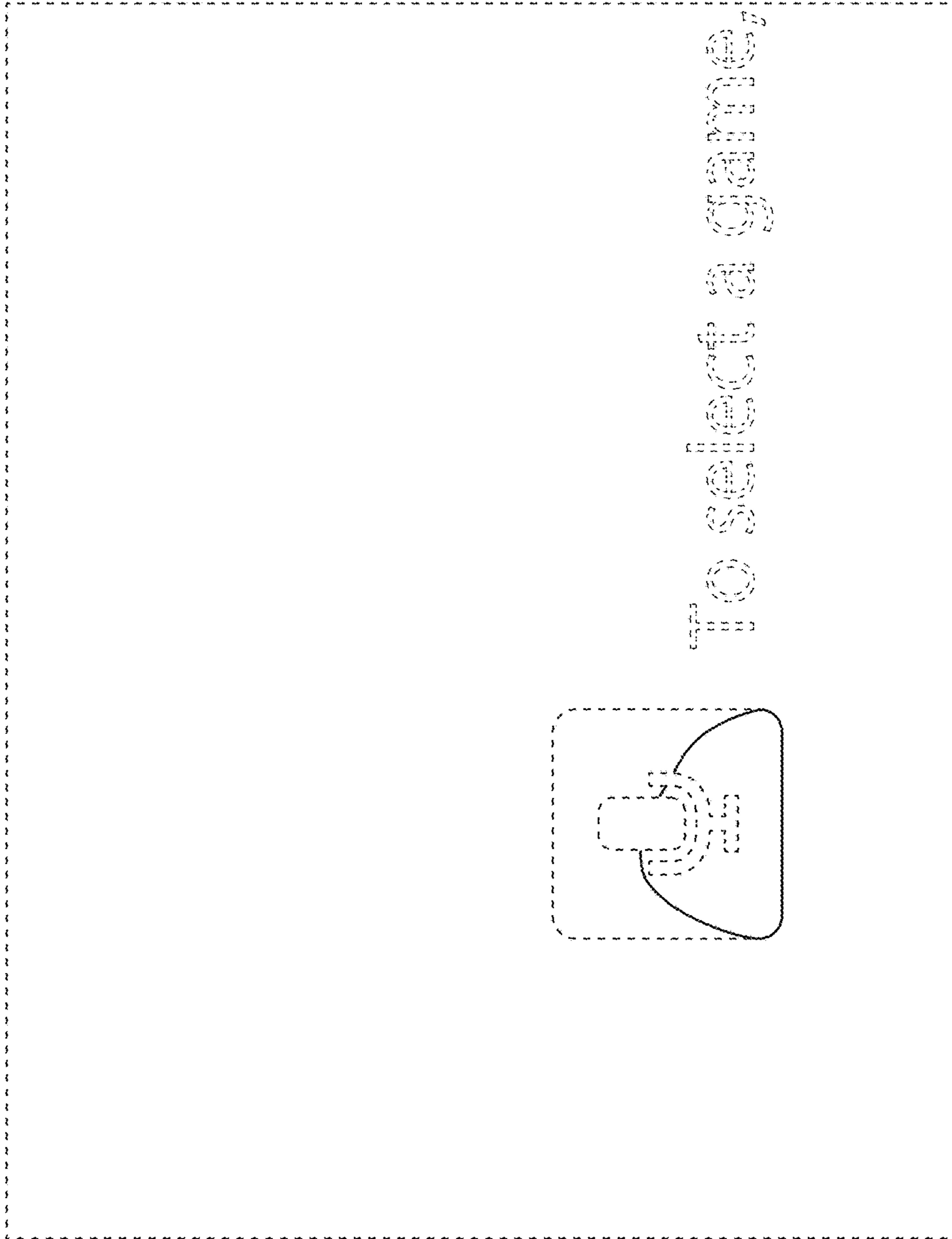

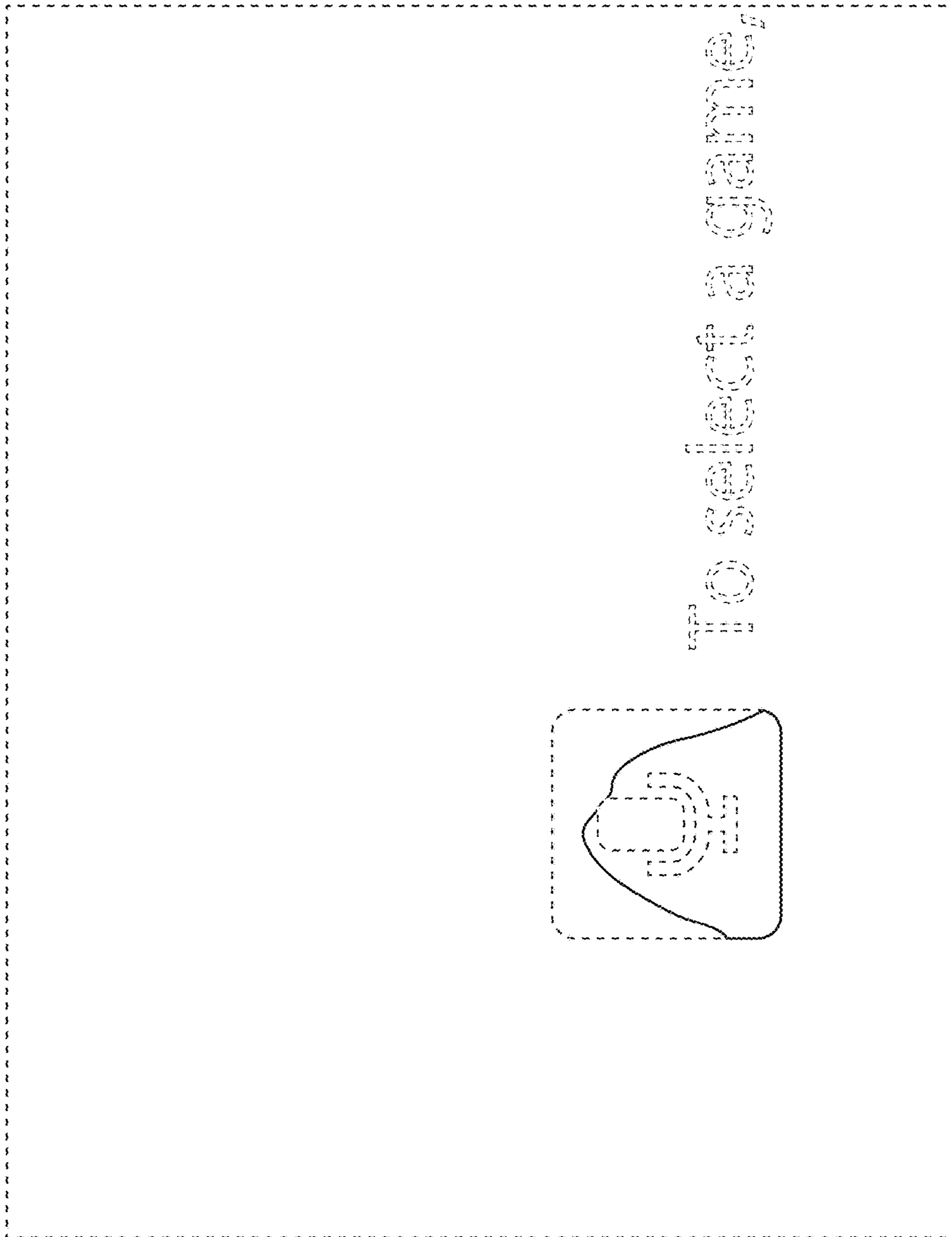

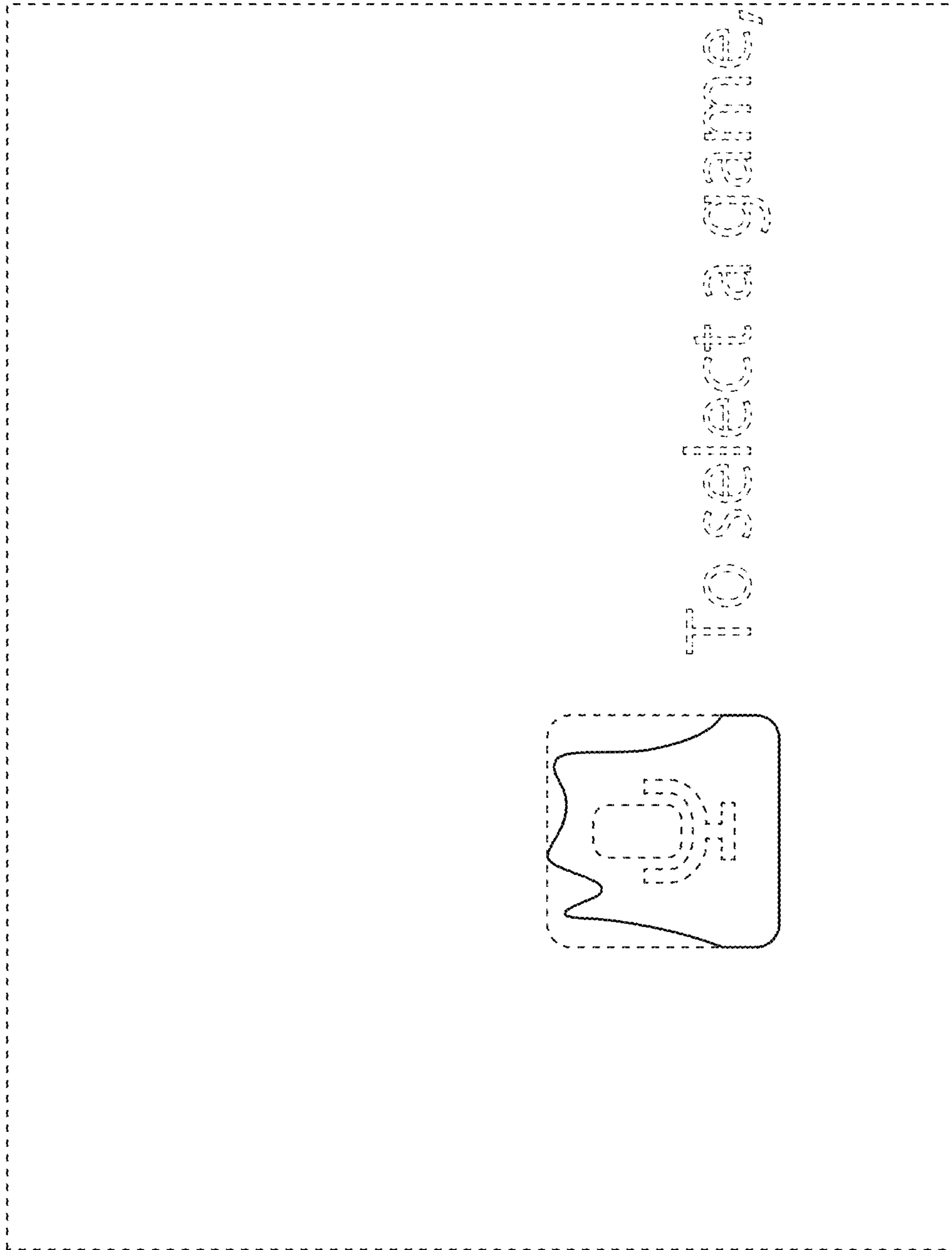
