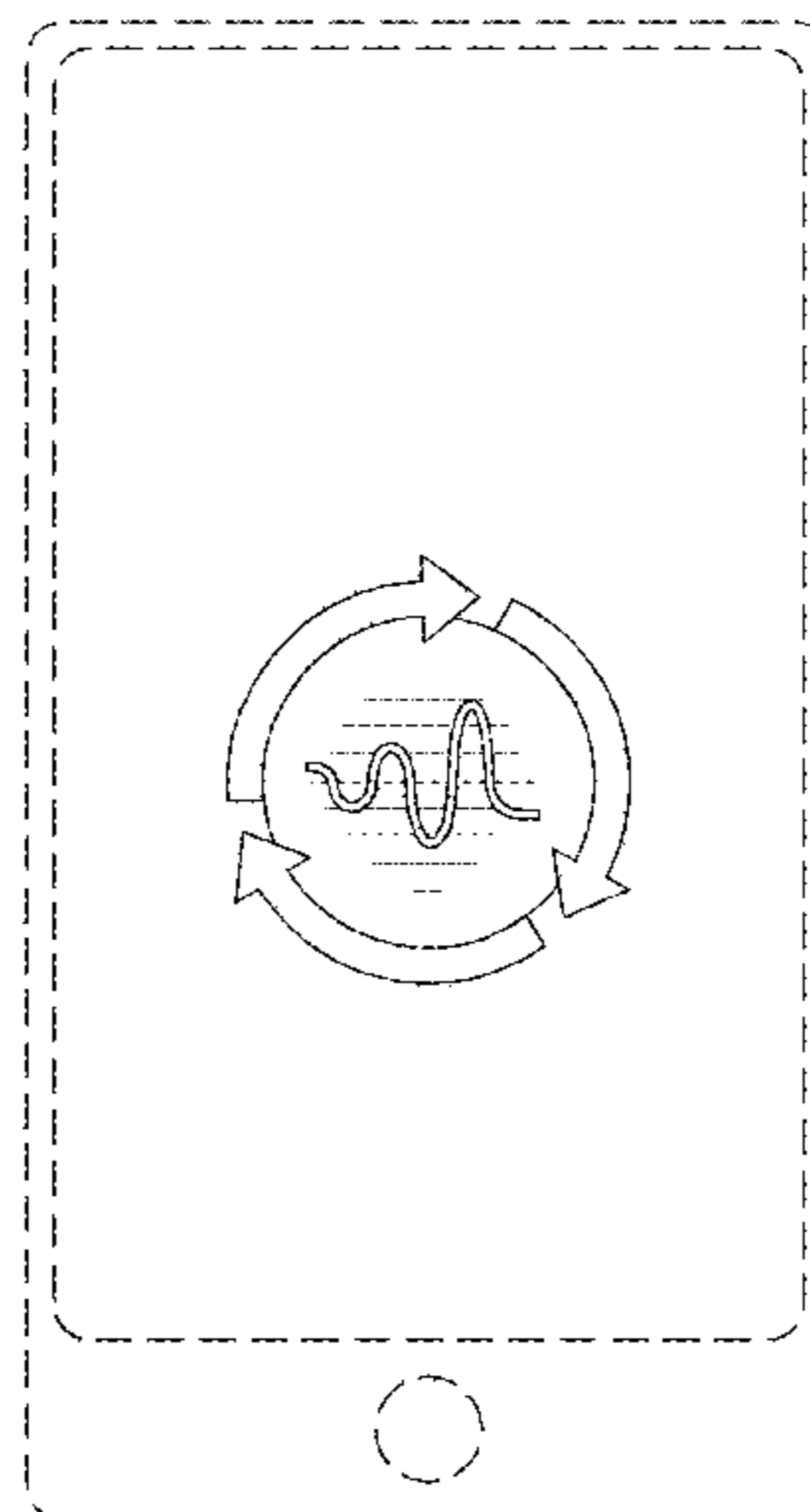
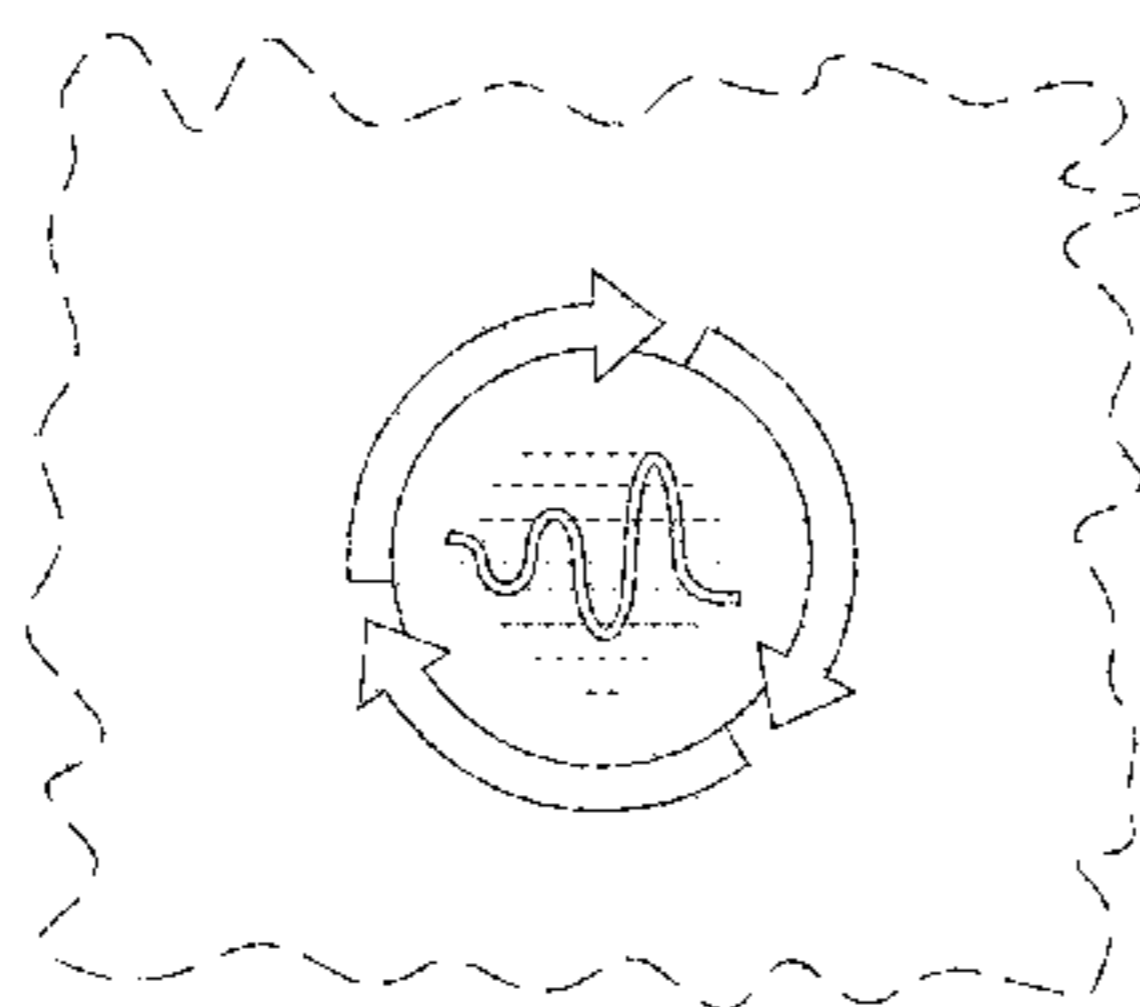
(57) **CLAIM**

The ornamental design for a continuous glucose monitor display screen with icon, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a portion of the display screen with continuous glucose monitor icon; and, FIG. 2 is a front view of the continuous glucose monitor icon of FIG. 1, shown on a handheld computing device. The broken line in FIG. 1 illustrates a portion of the display screen. The broken lines in FIG. 2 illustrate a handheld computing device and display screen. None of the broken lines form part of the claimed design.

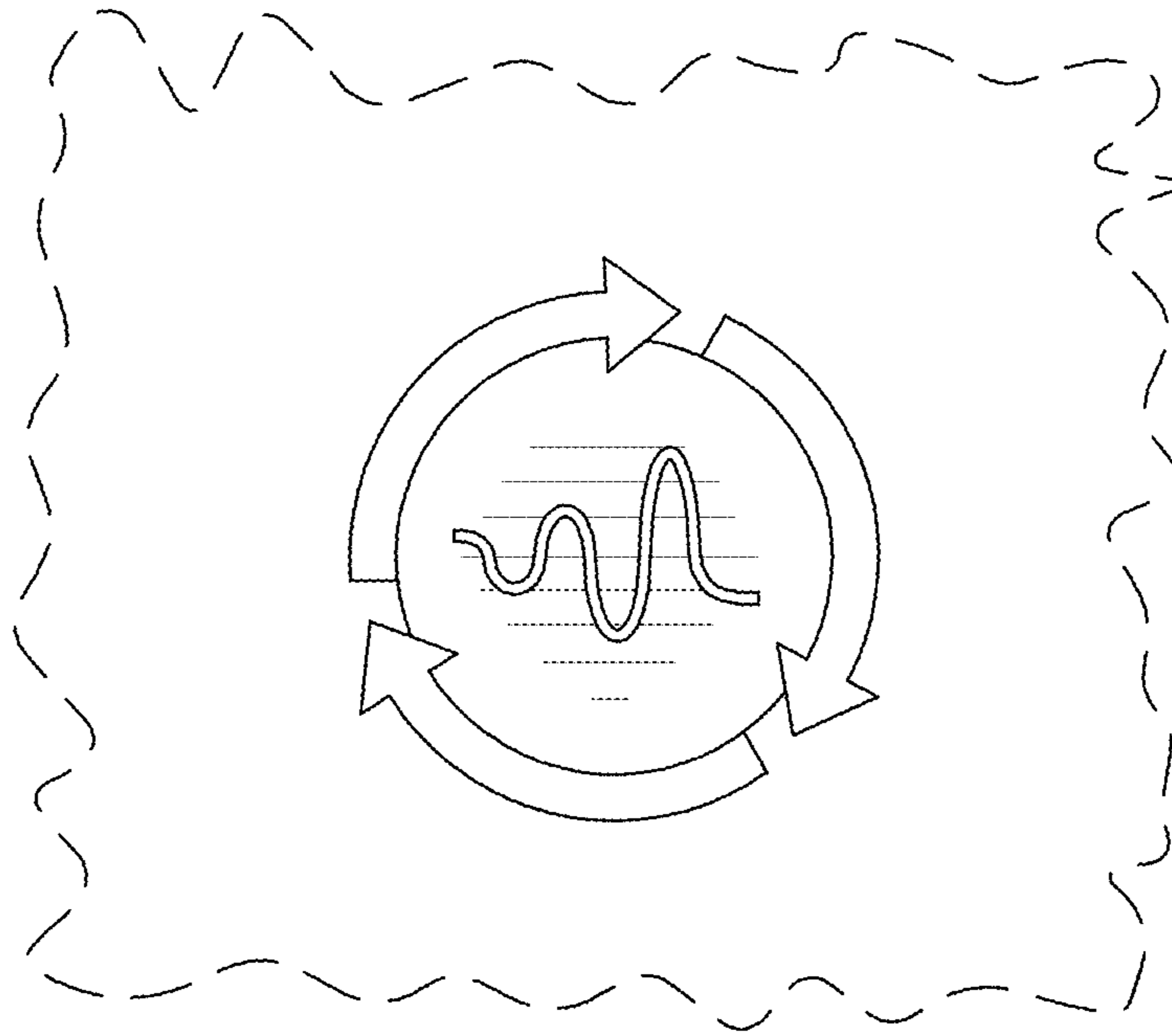

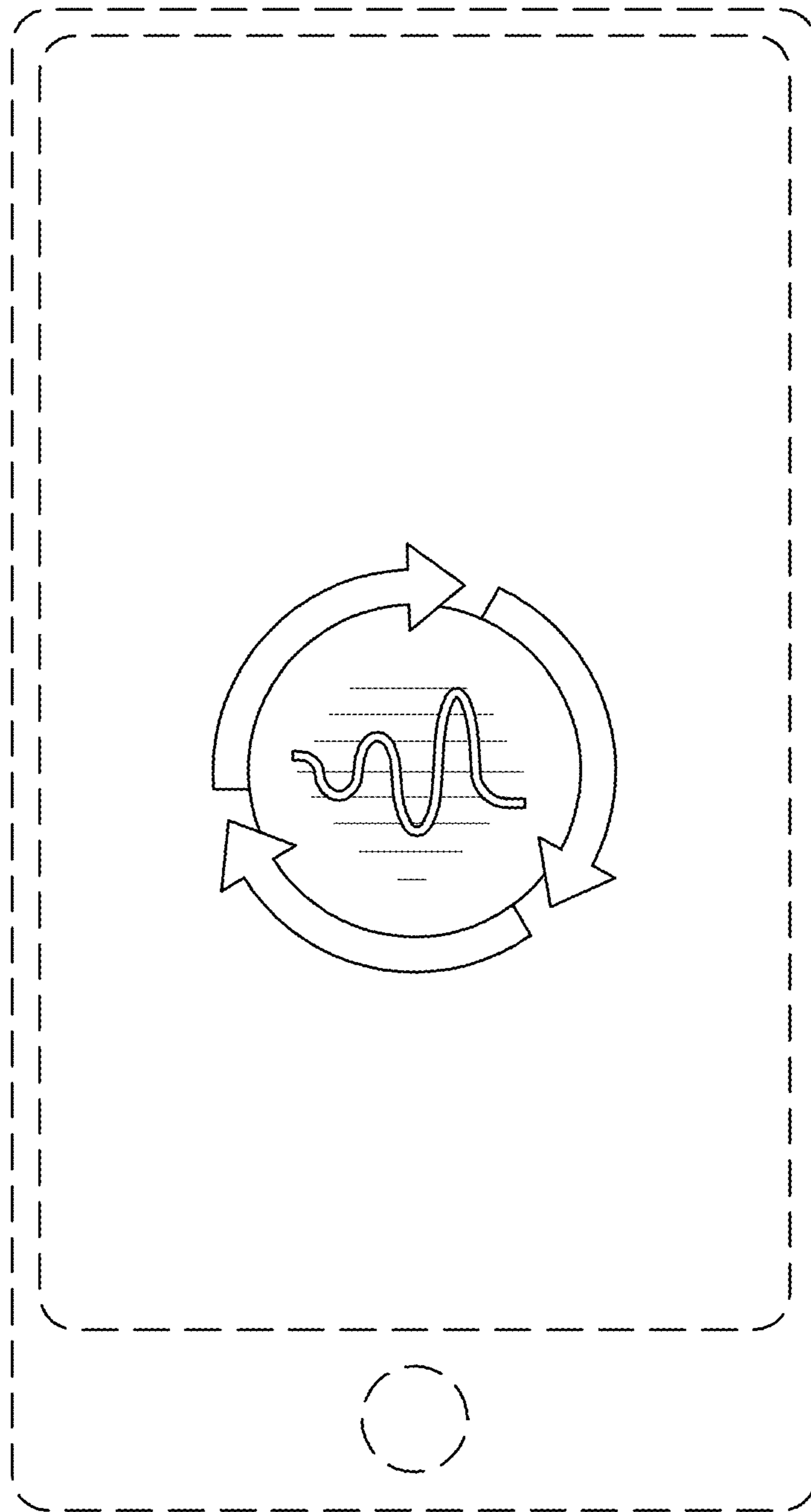
