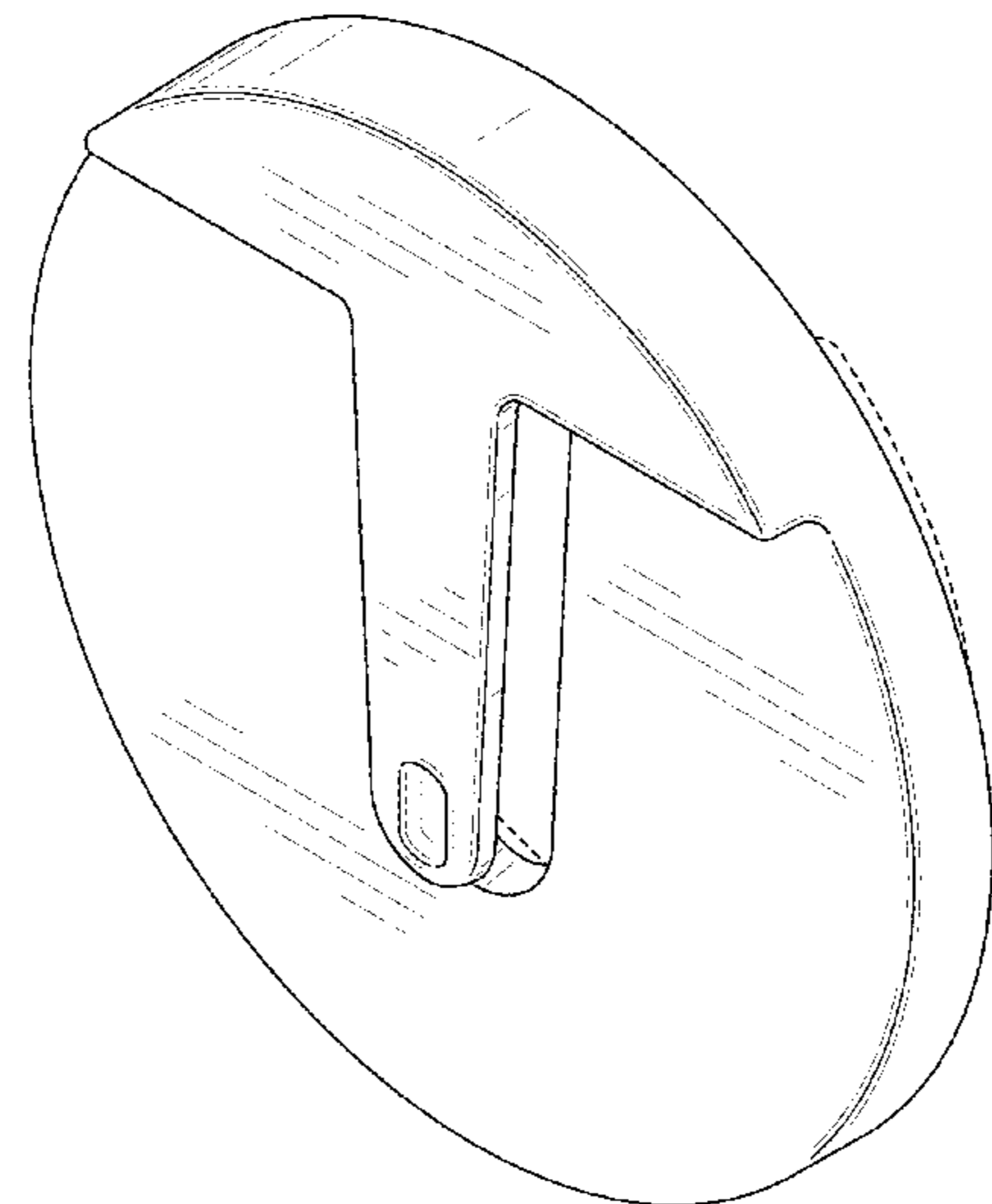
The ornamental design for a note holder, as shown and described.

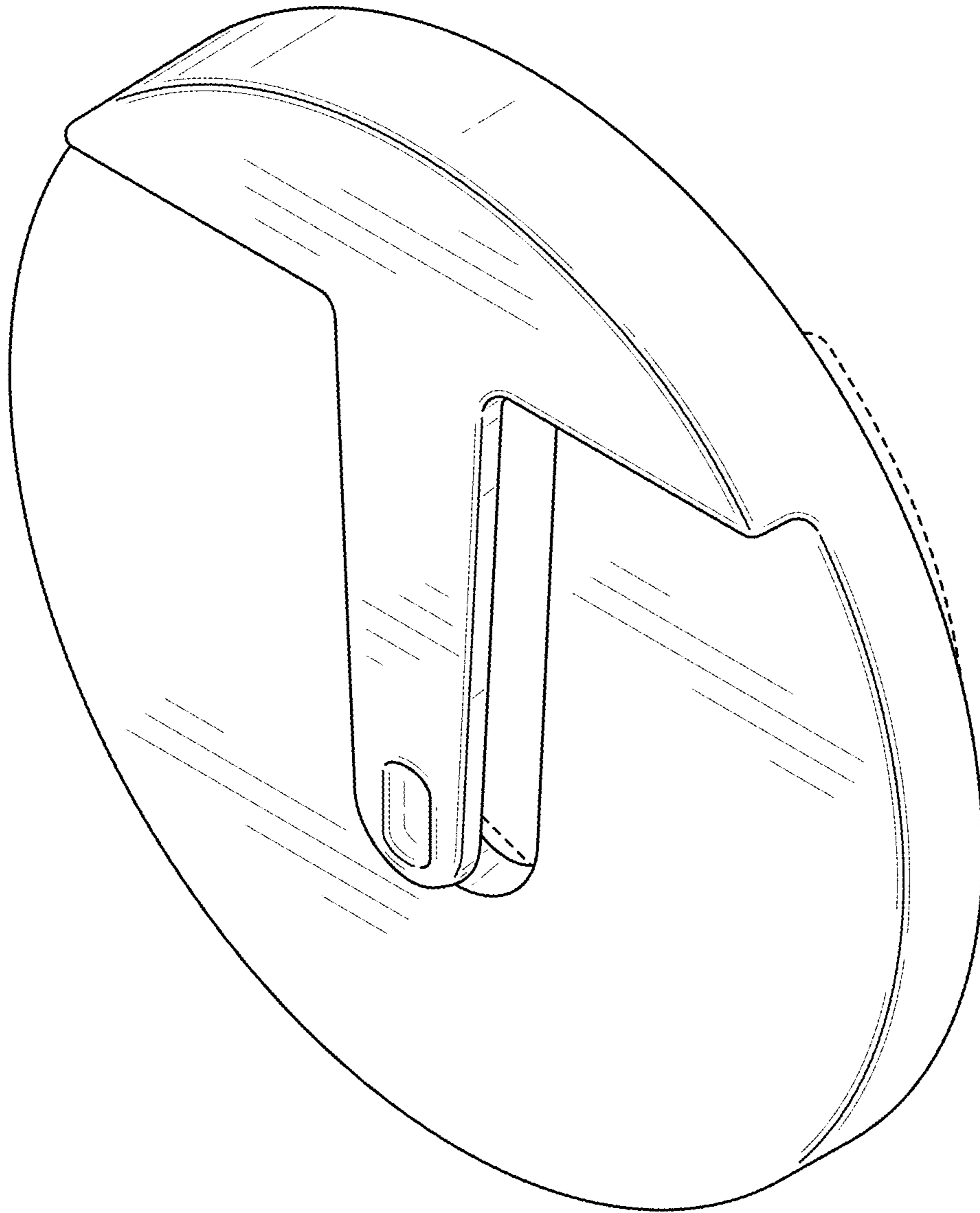

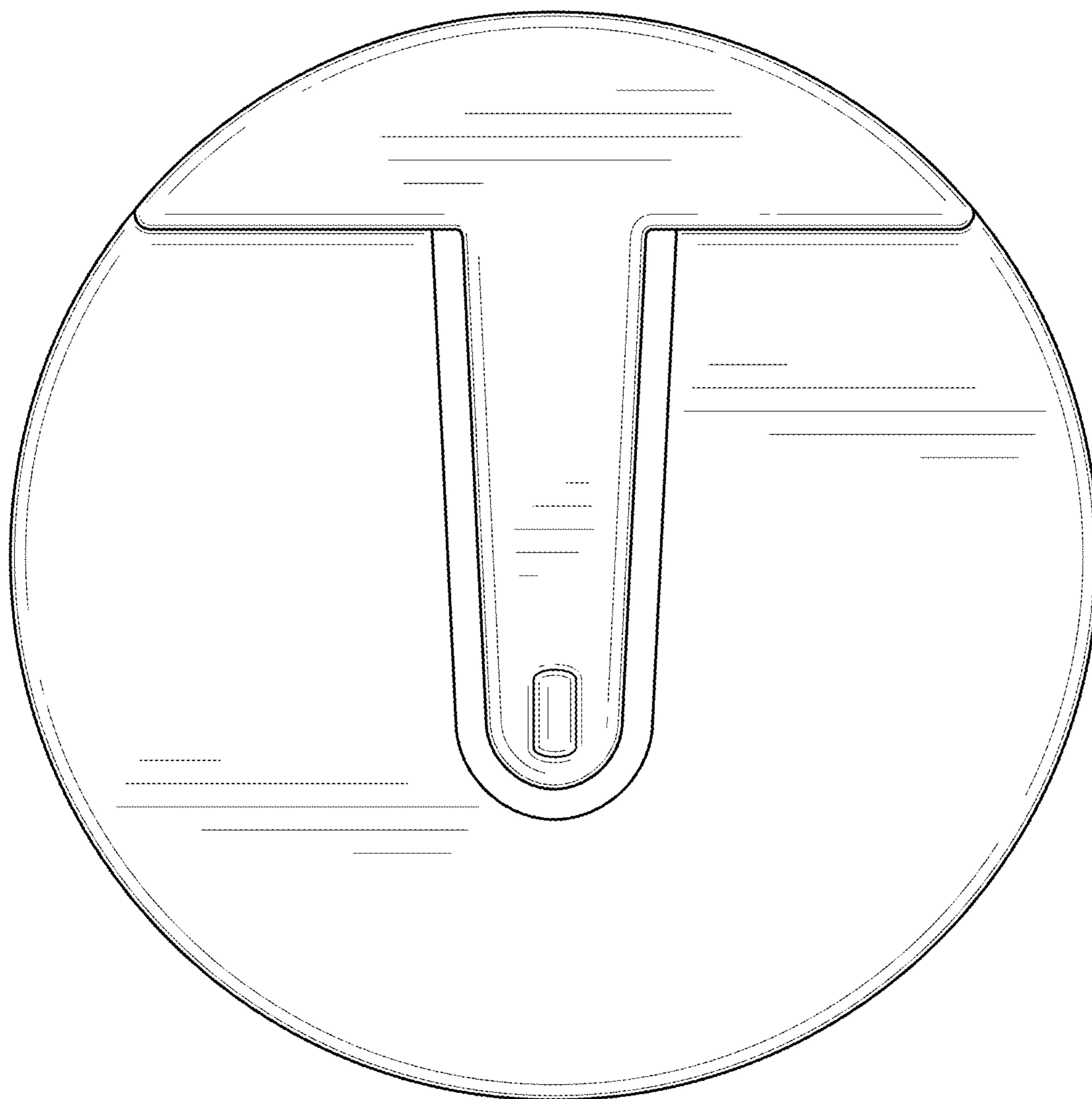

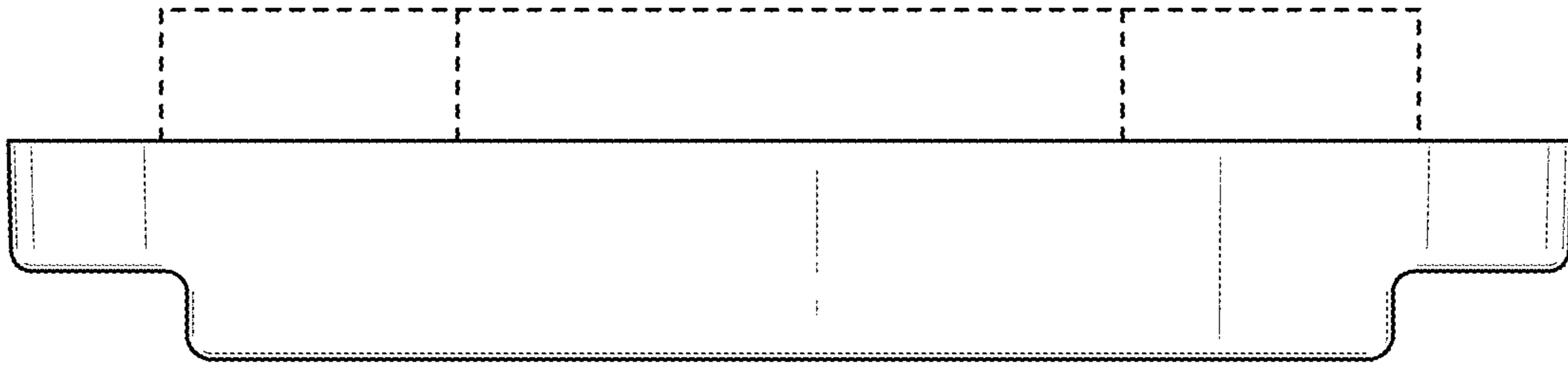

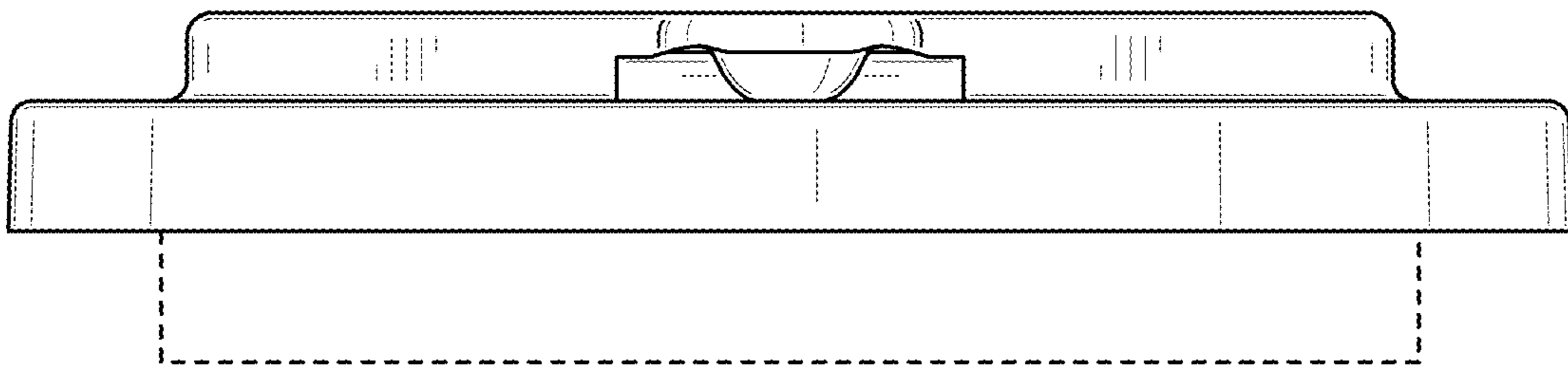

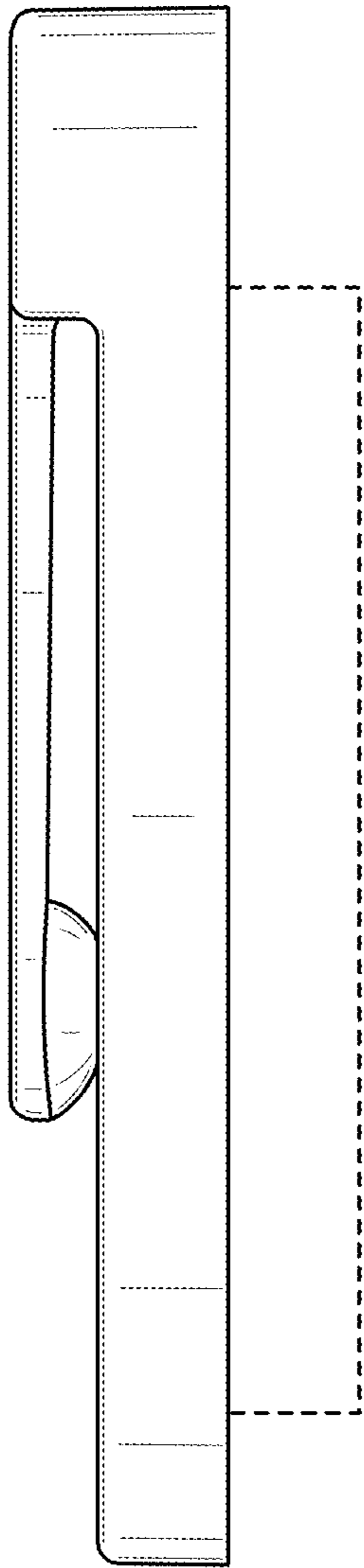

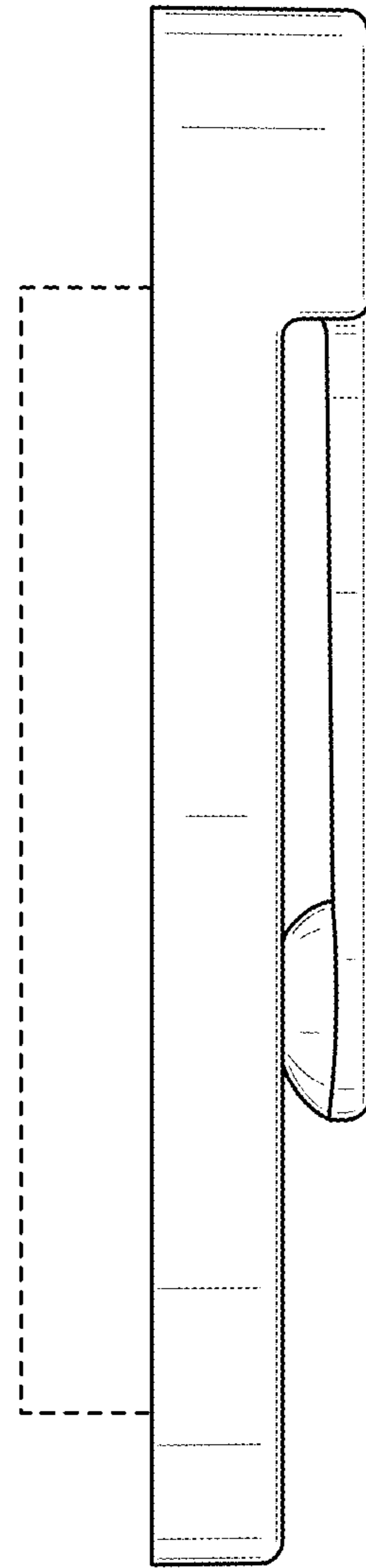
