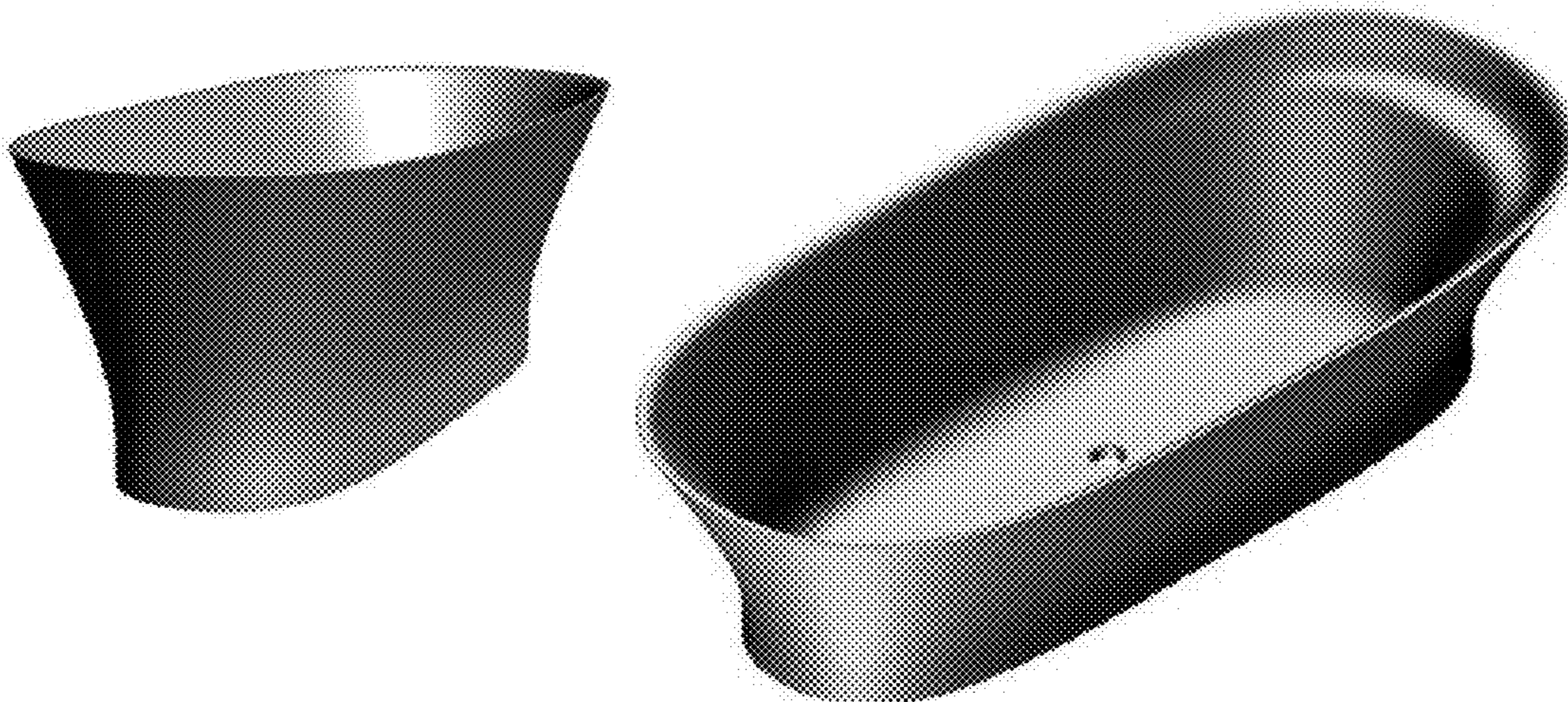

The ornamental design for a bath tub, as shown and described.

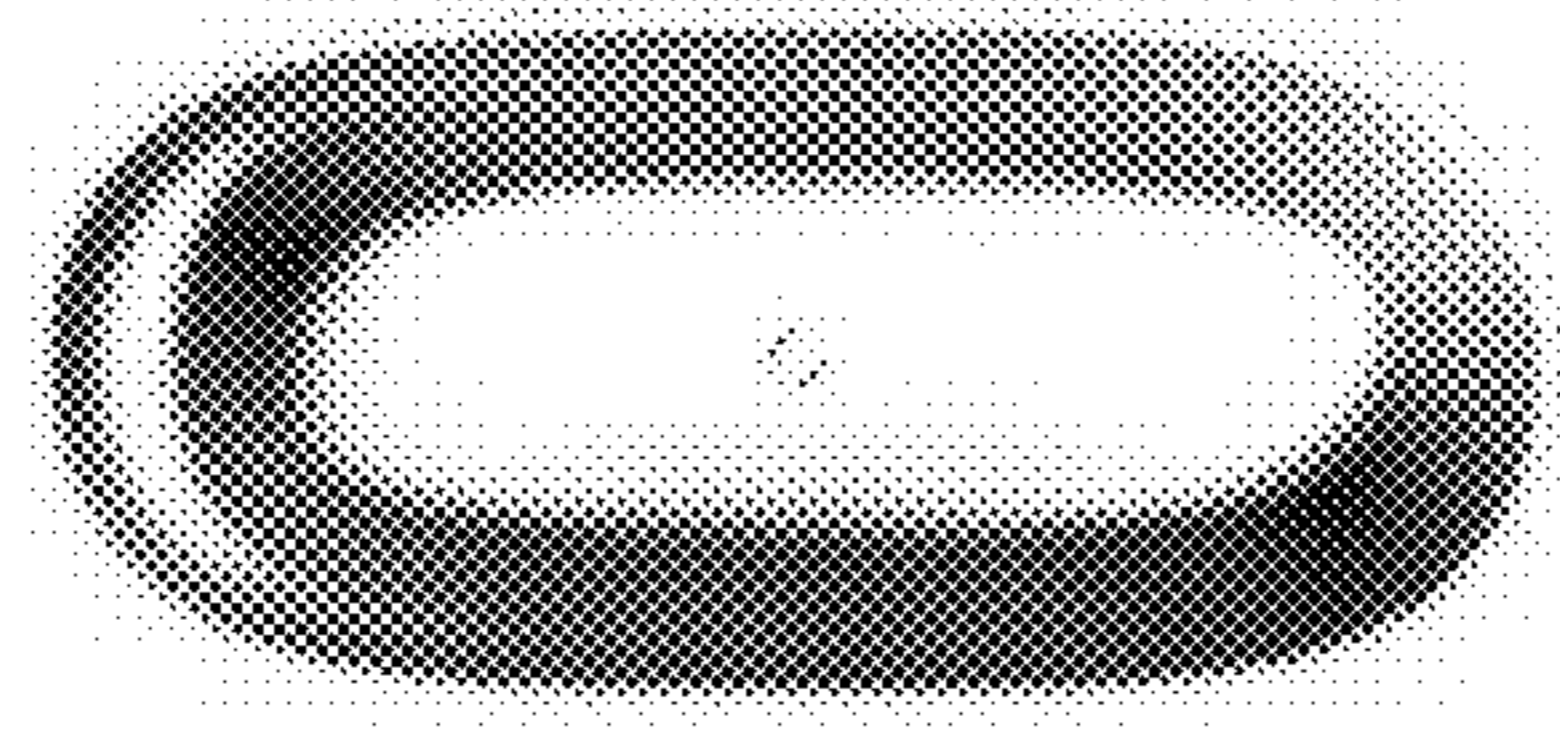
DESCRIPTION

- 3.5 is an alternate perspective view.

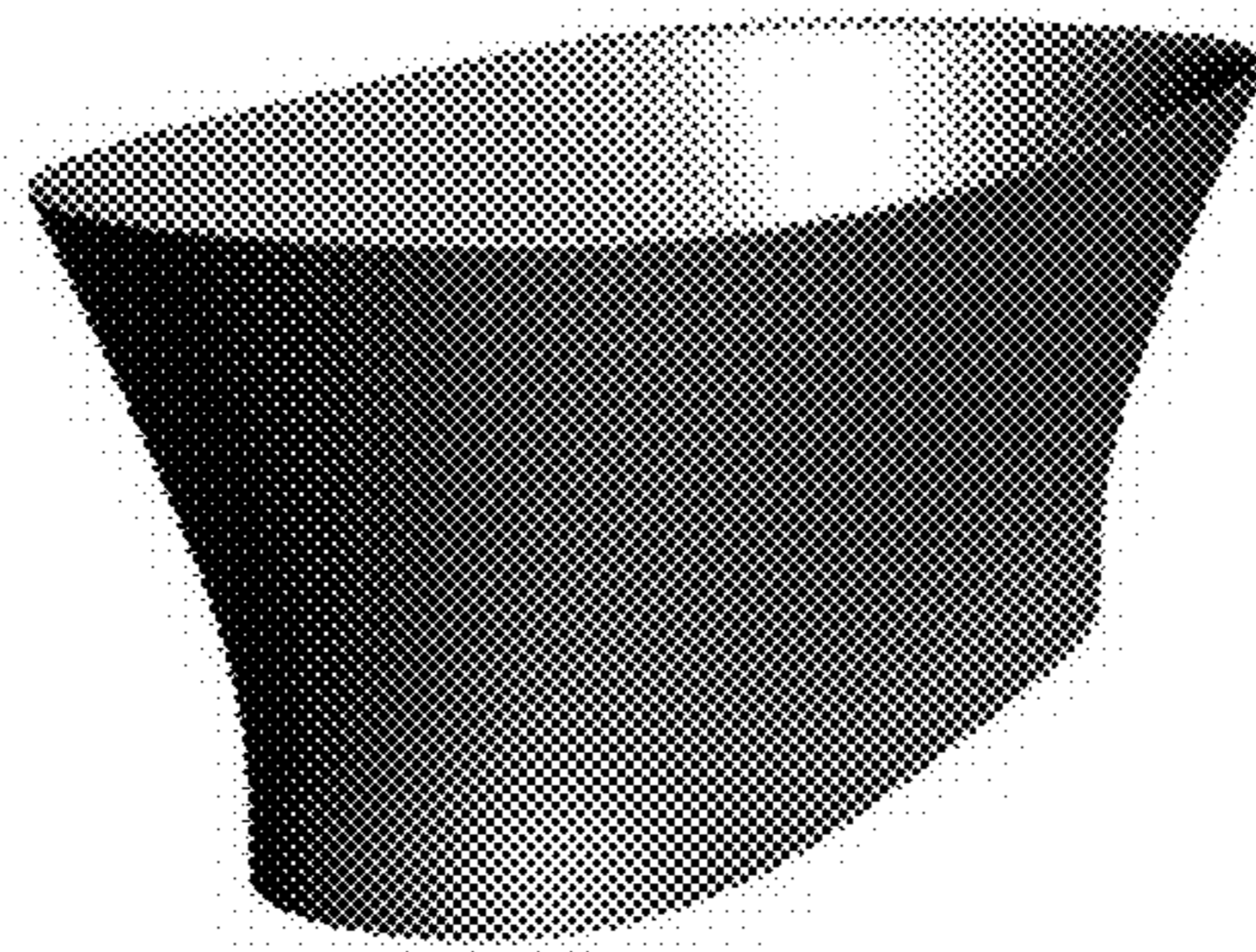

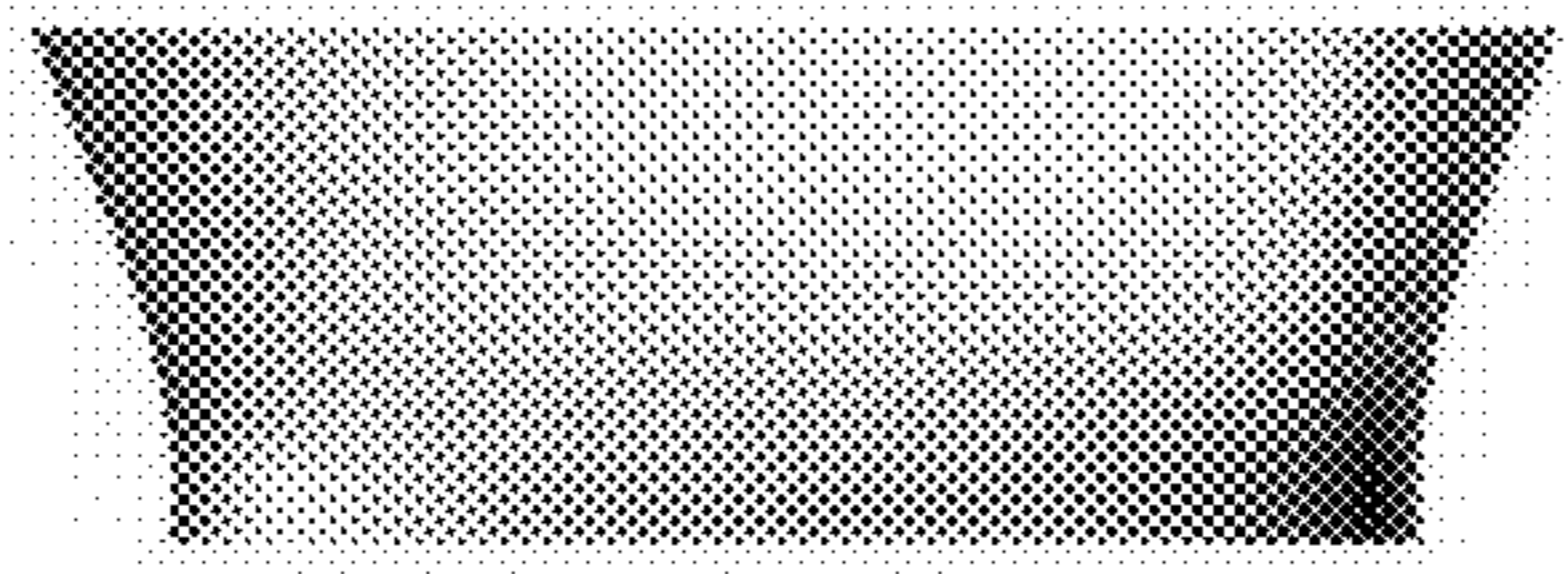

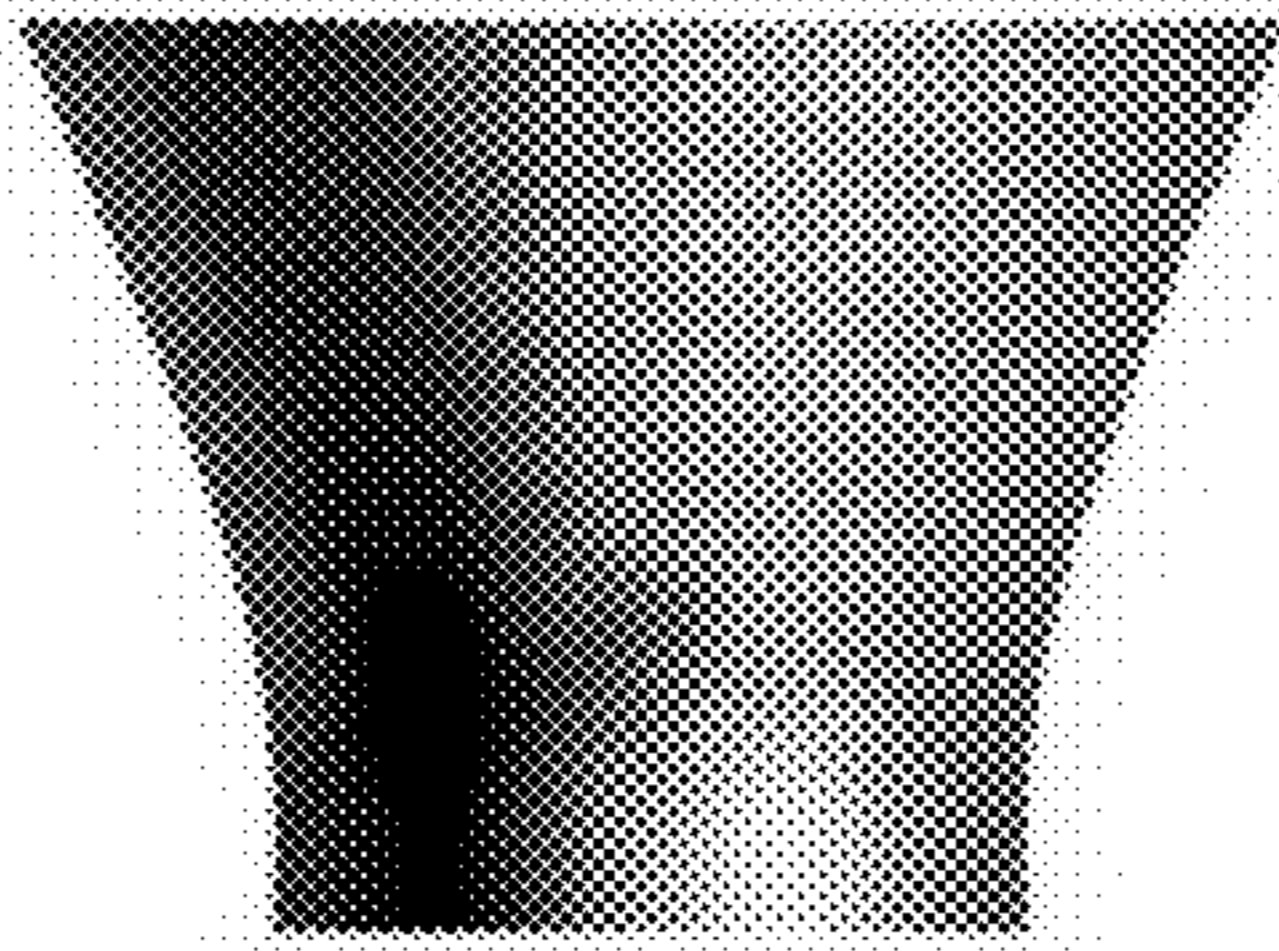
