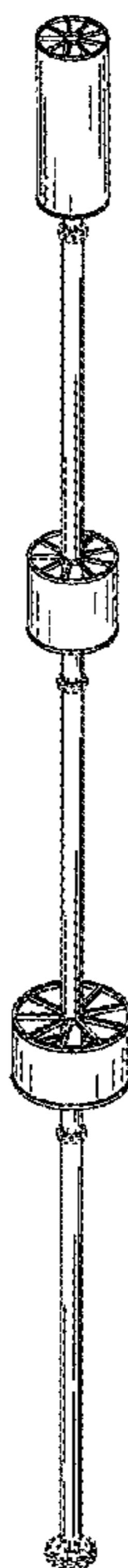

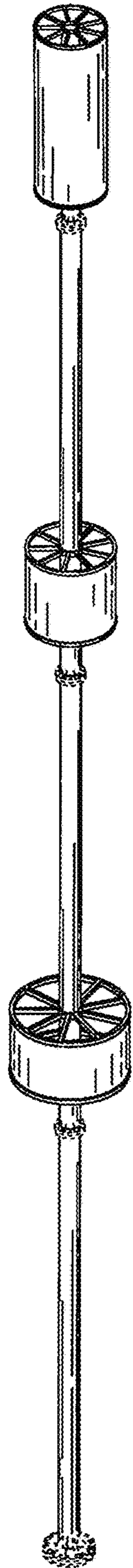
The ornamental design for a post, as shown and described.

**DESCRIPTION**

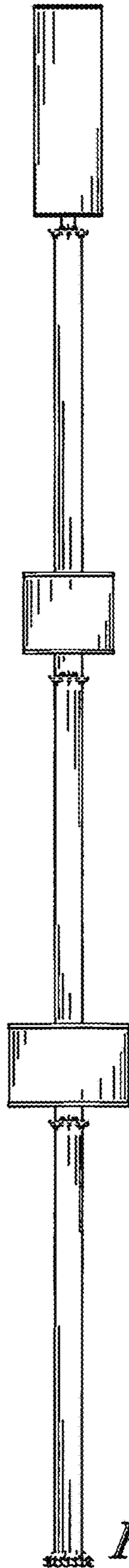
FIG. 1 is a perspective view of a post in accordance with the present invention;

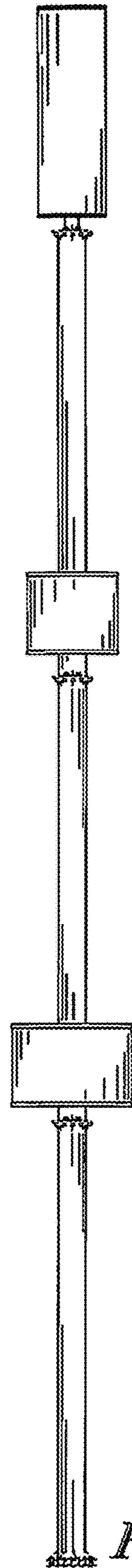




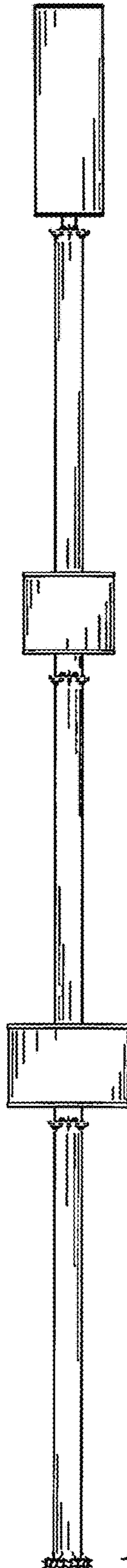

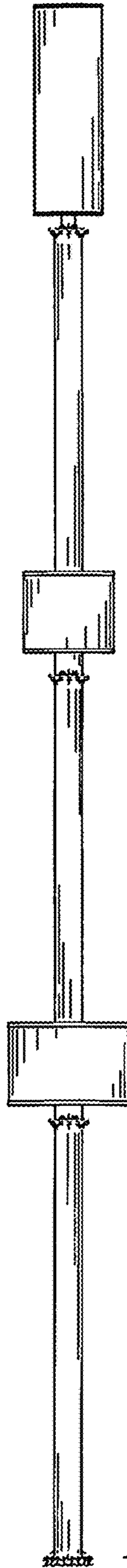

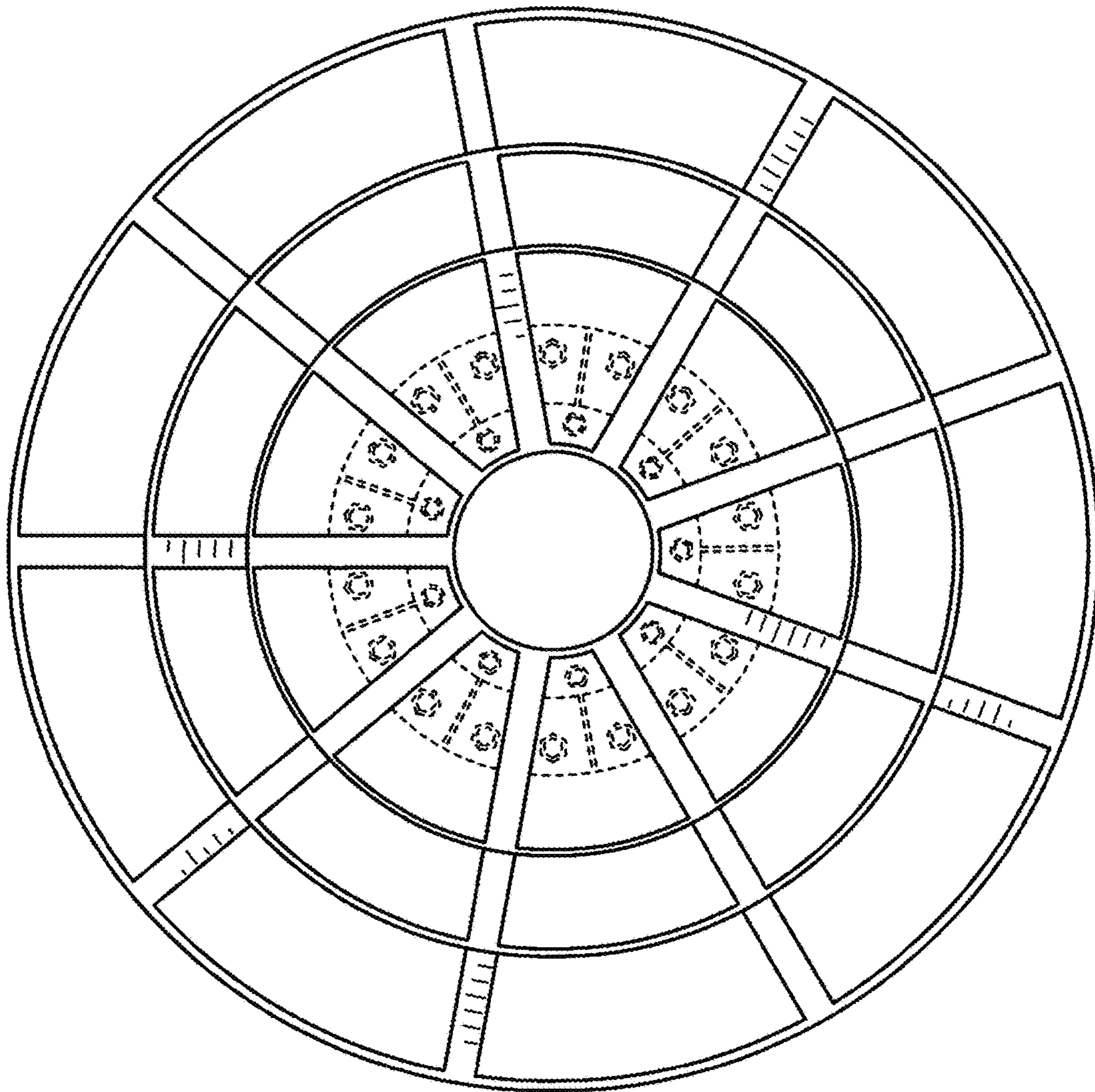

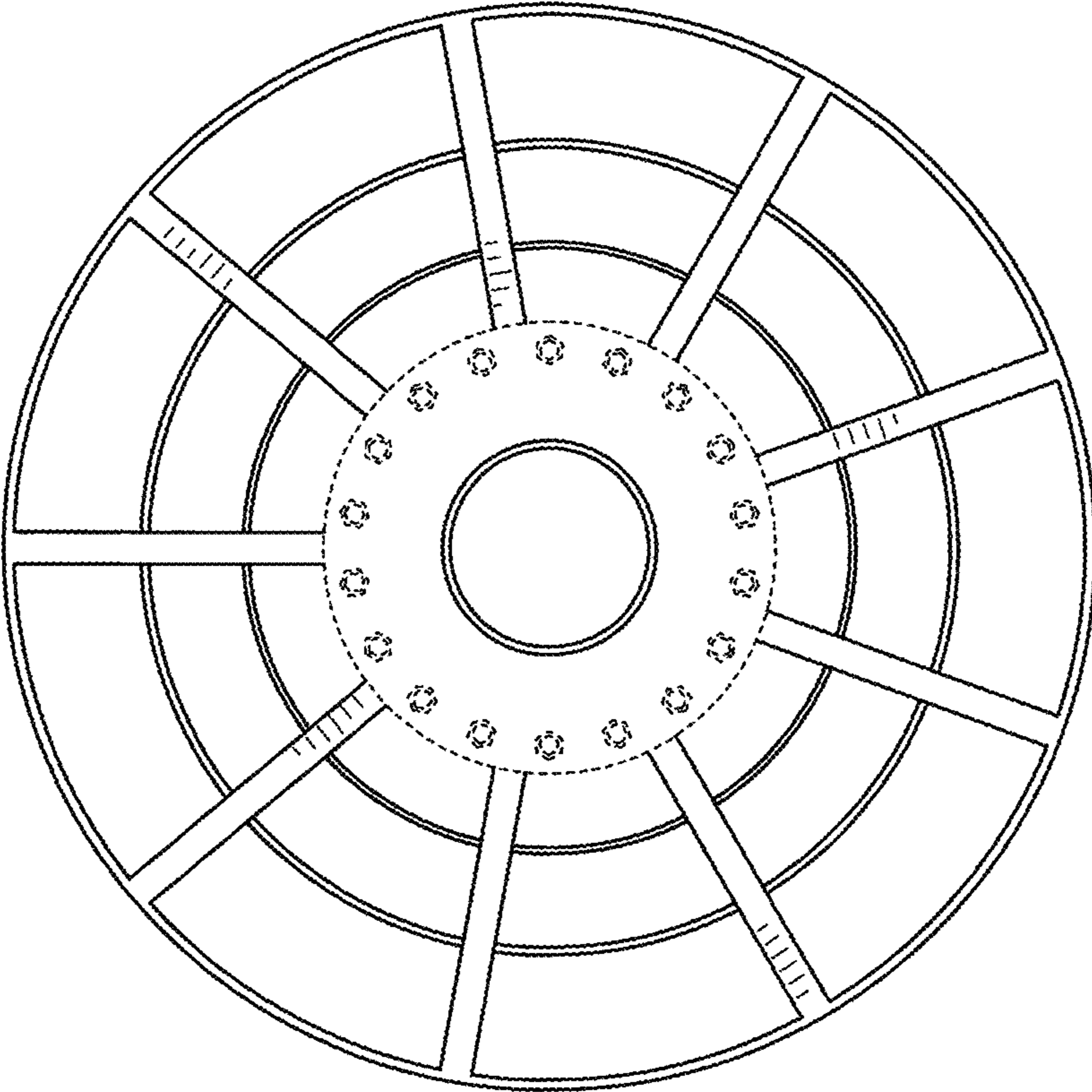
