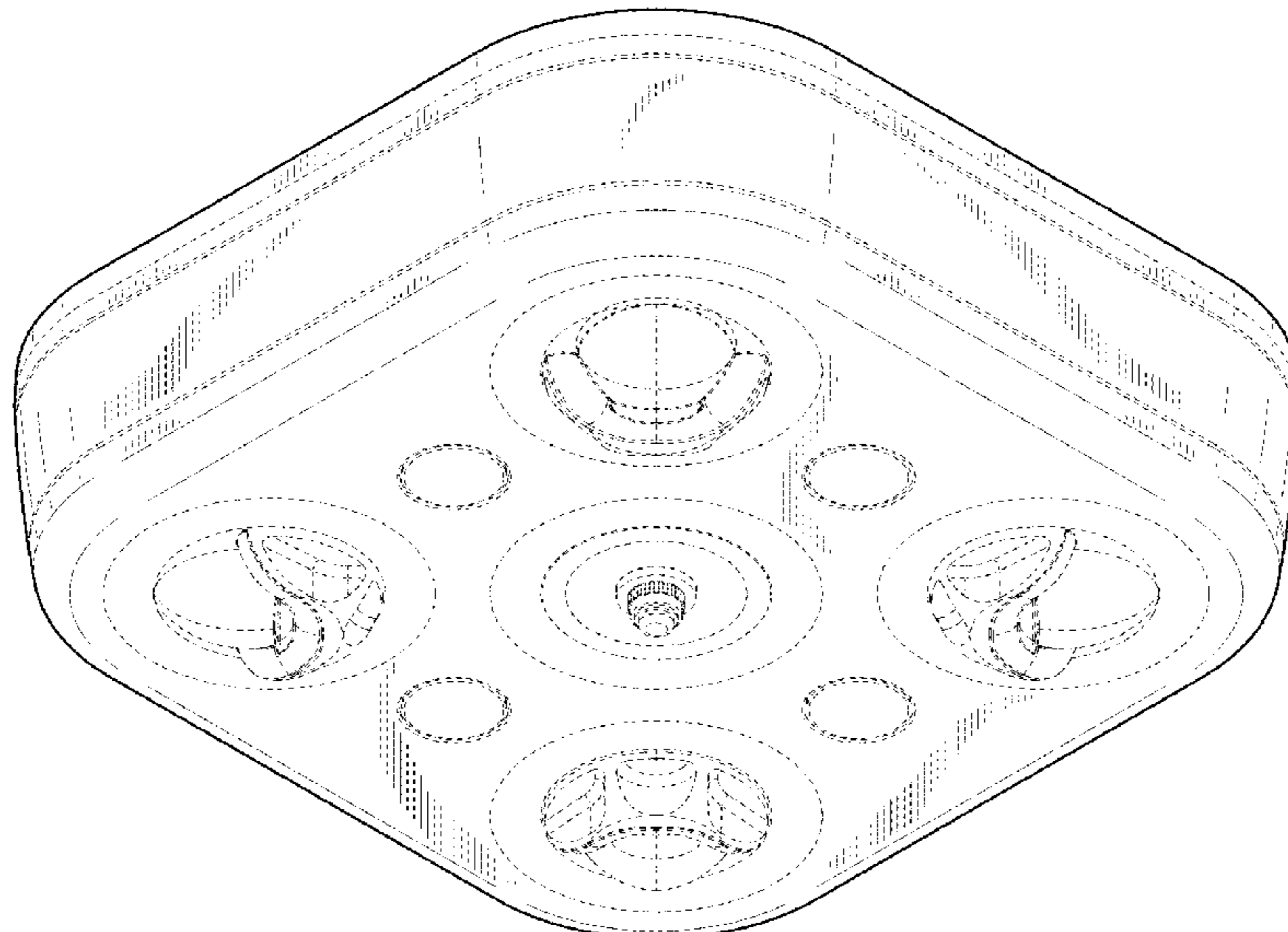
The ornamental design for a low profile outdoor light fixture,

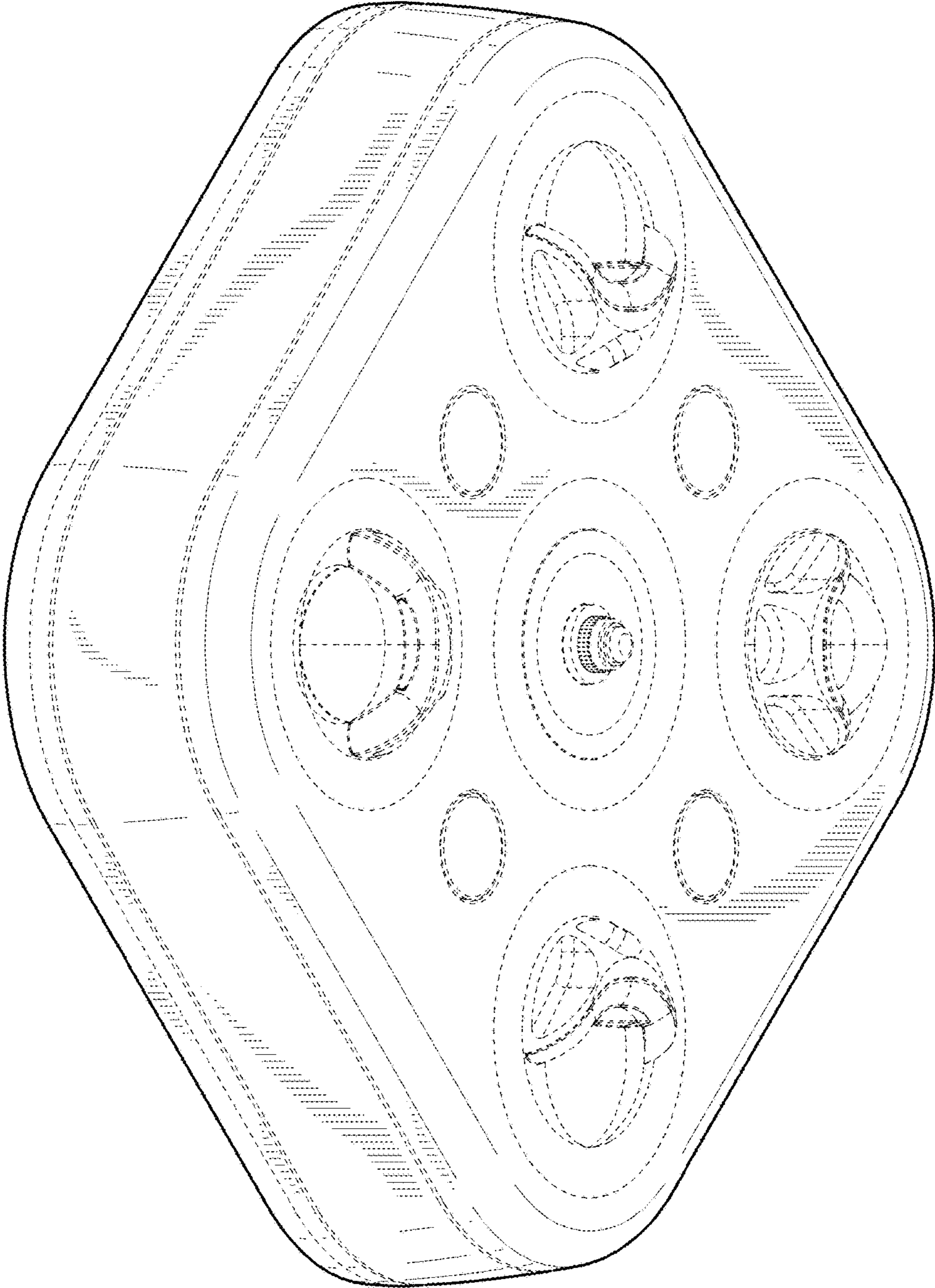

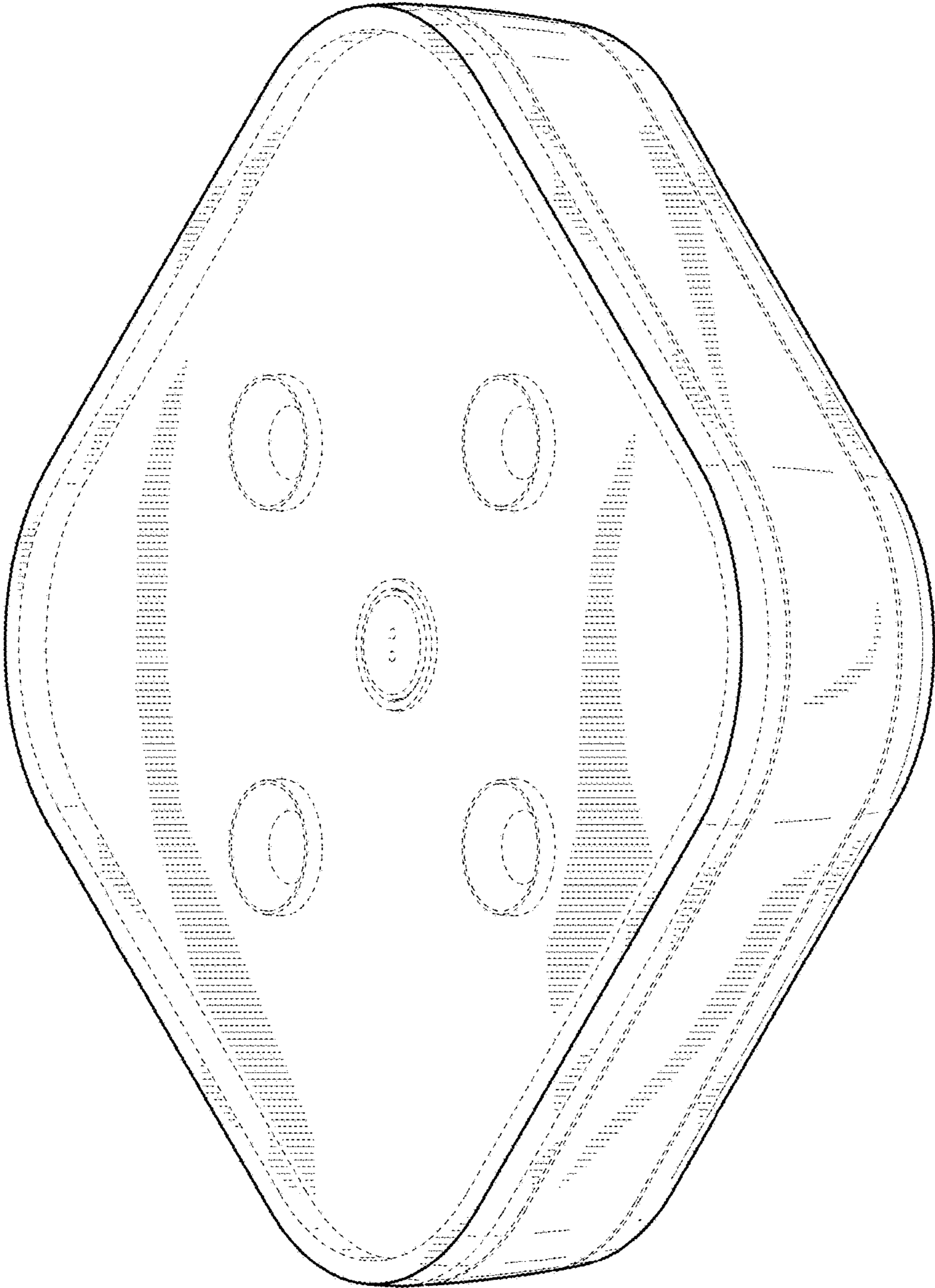

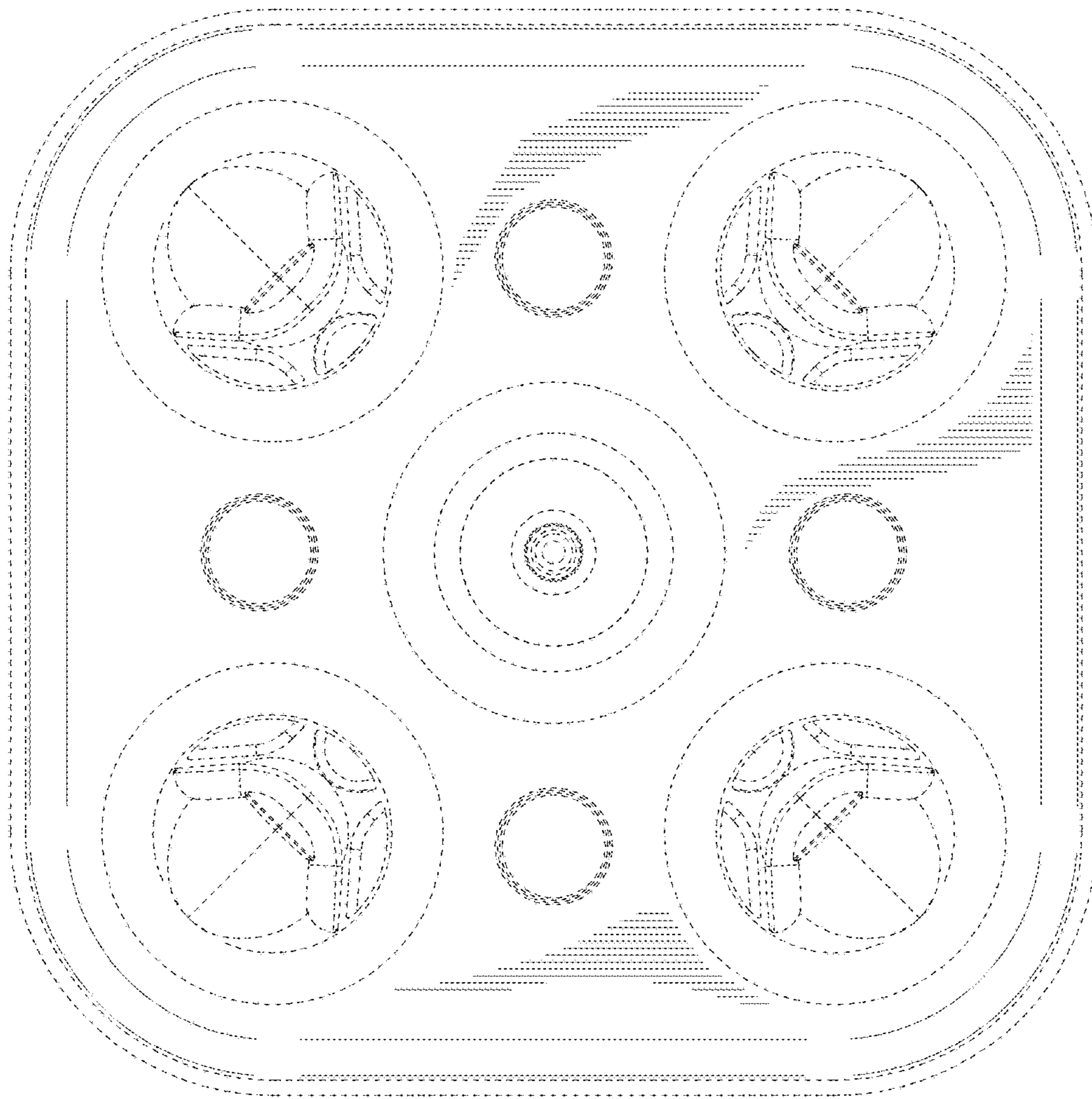

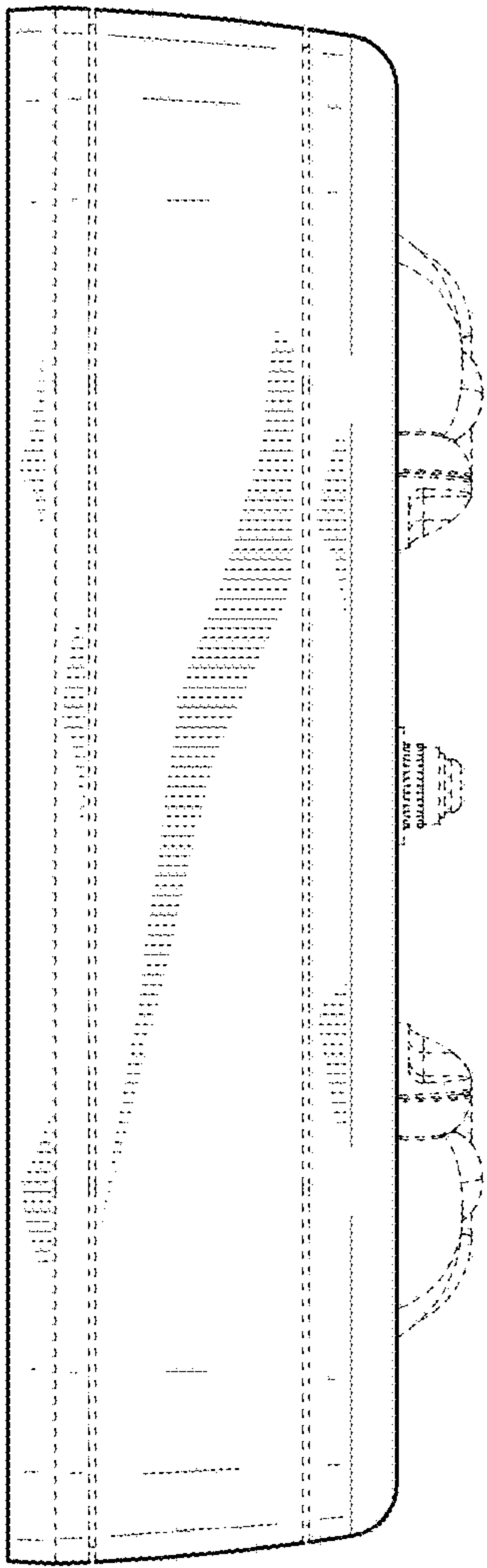

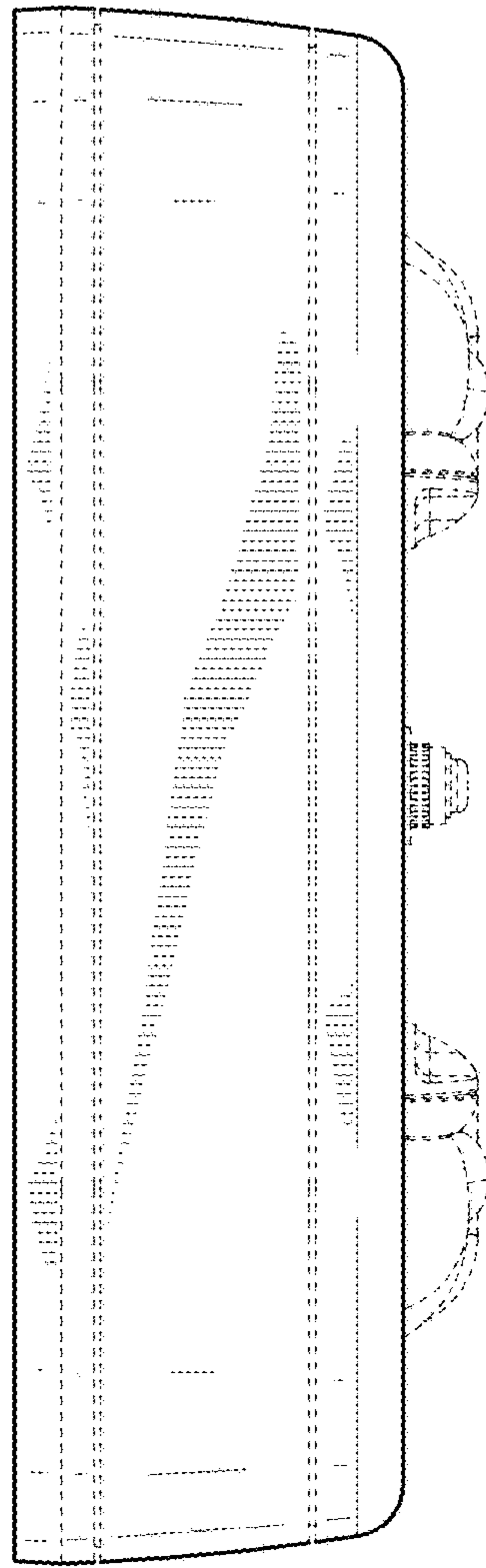

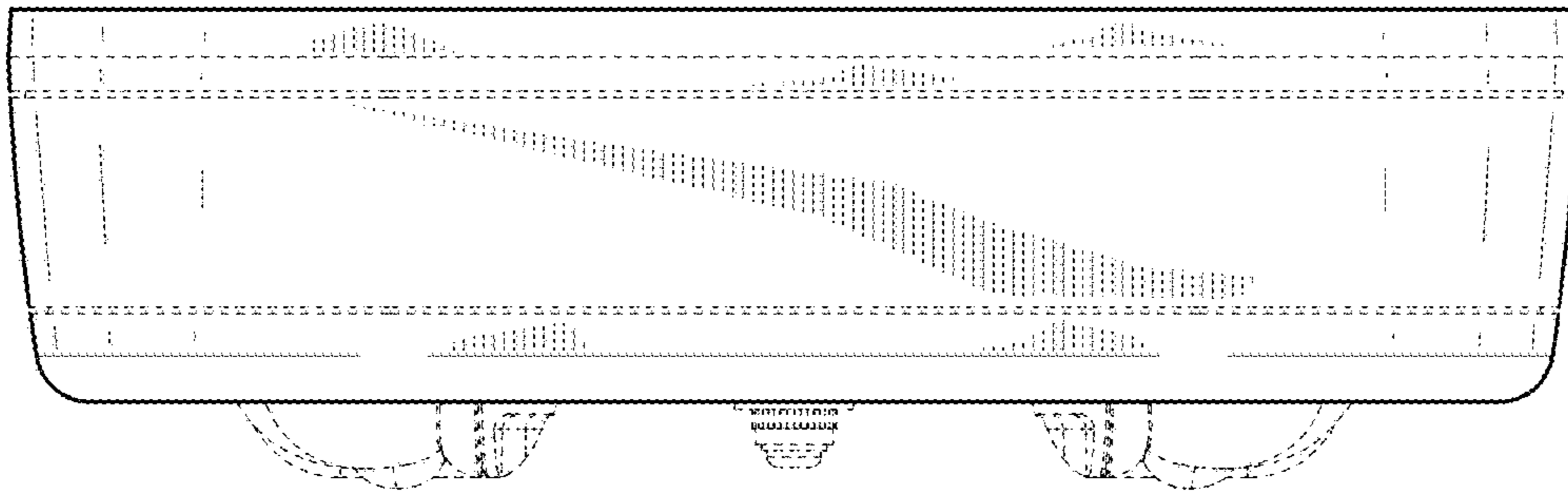

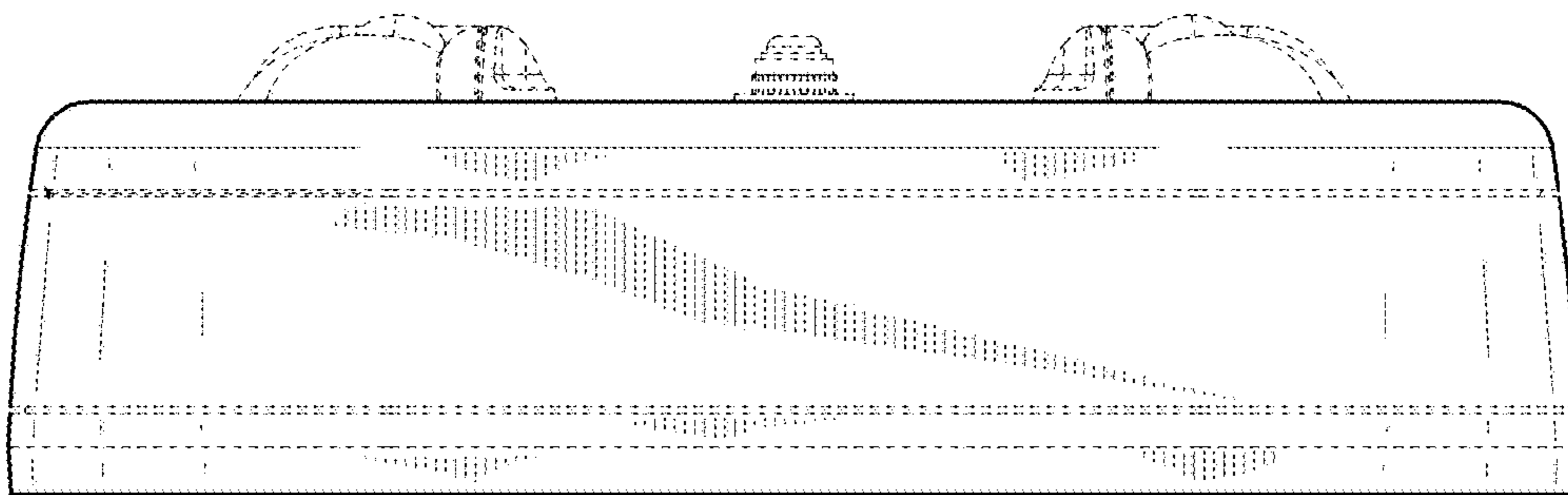
