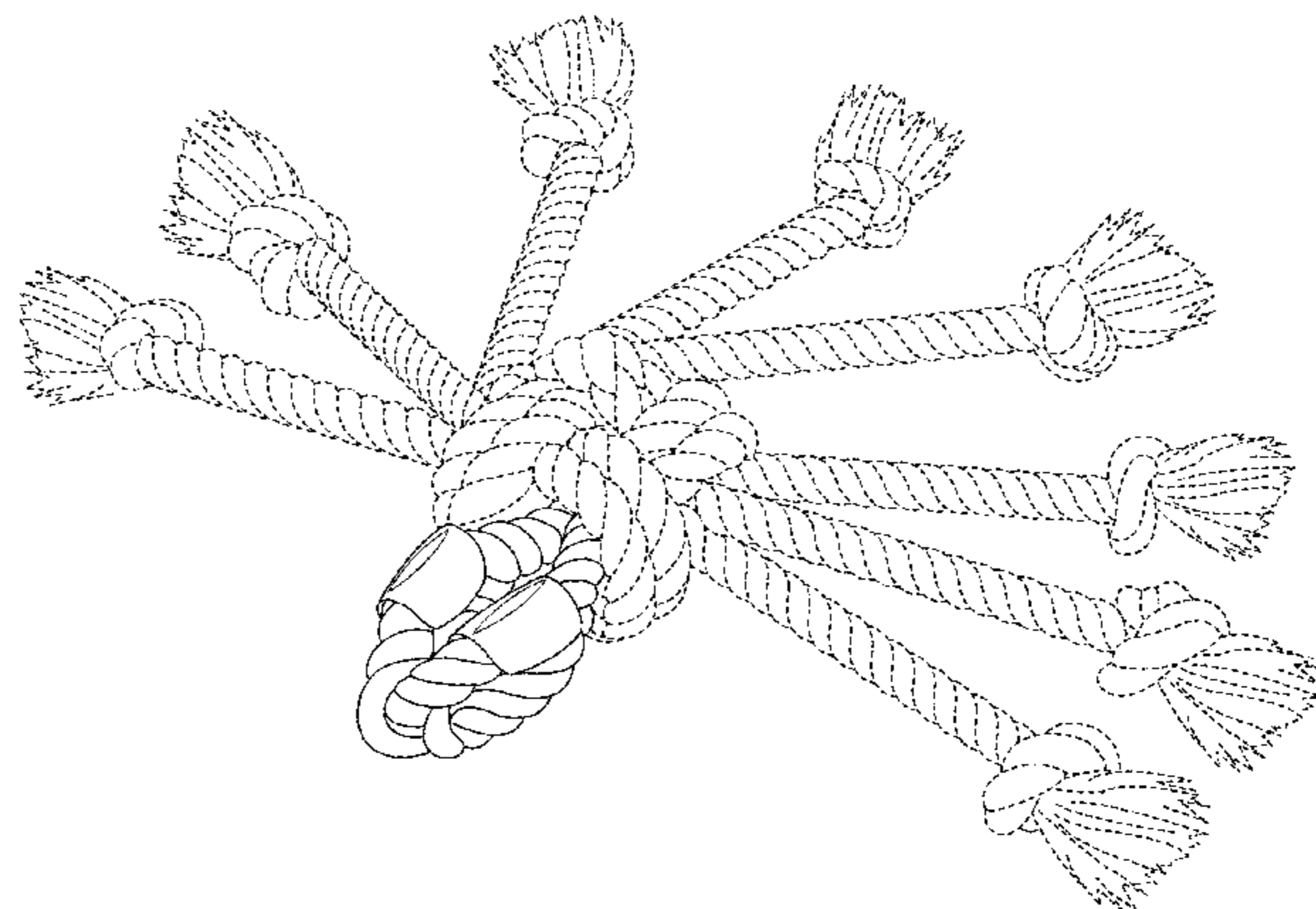
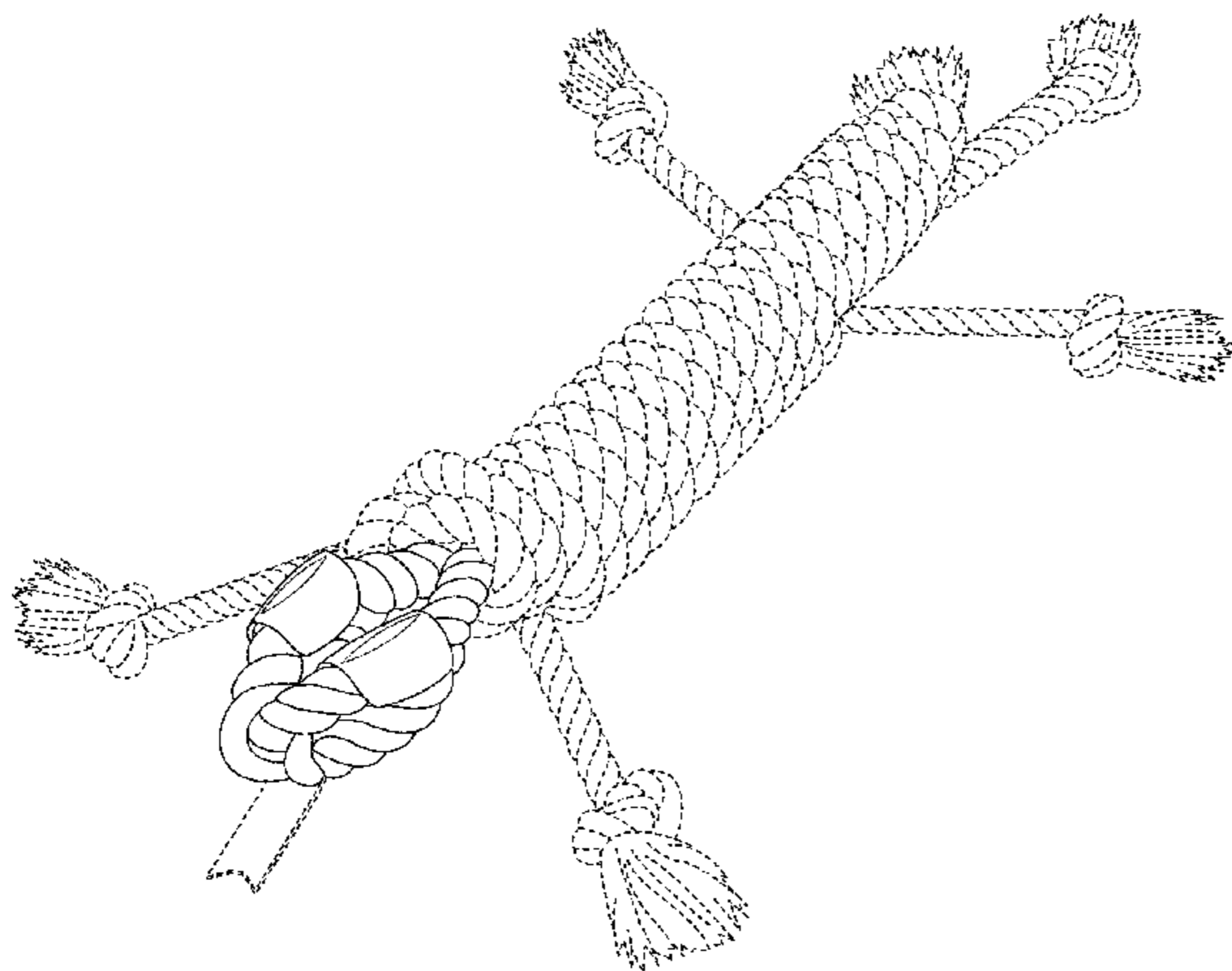
The ornamental design for an animal head rope pet toy, as shown and described.

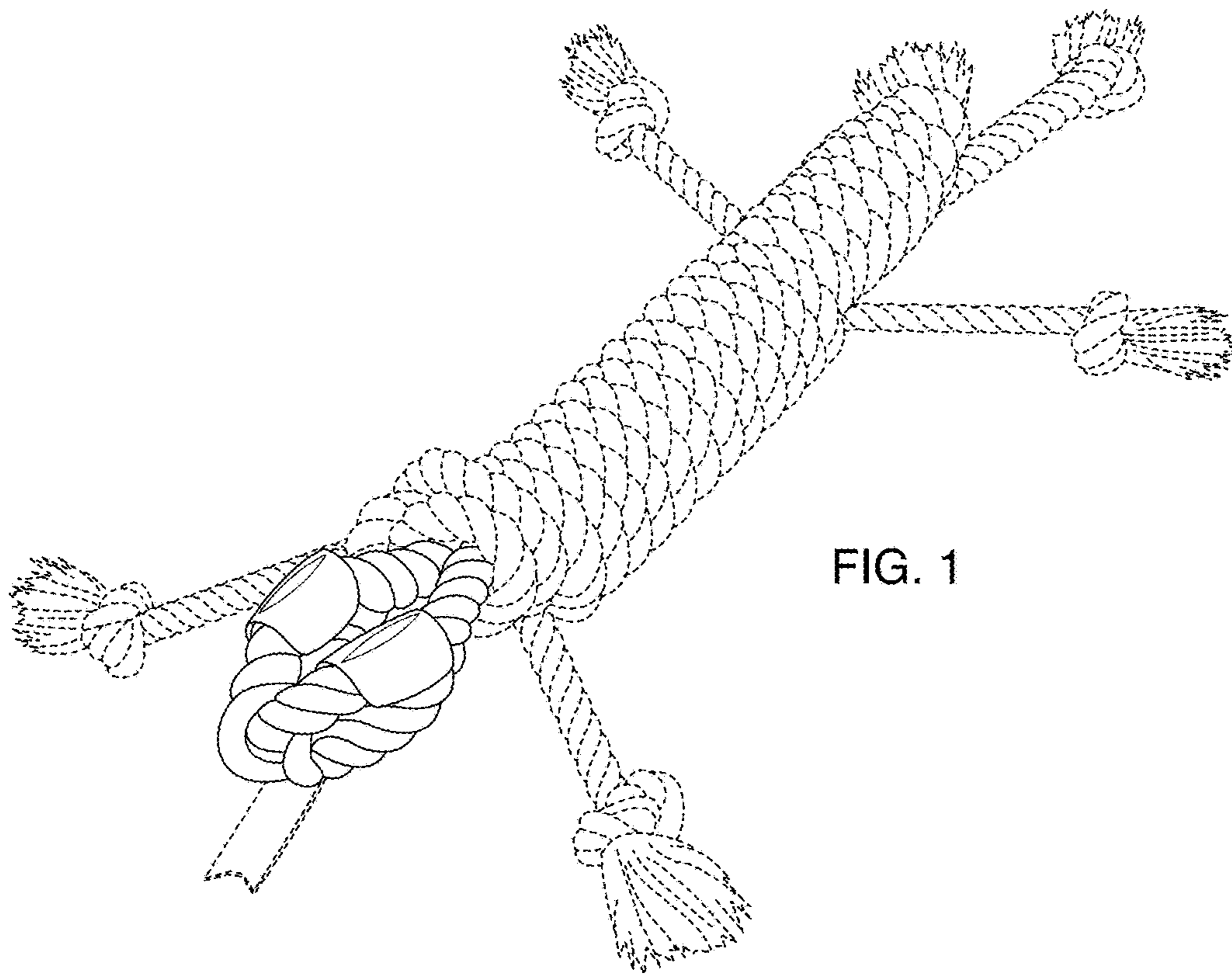

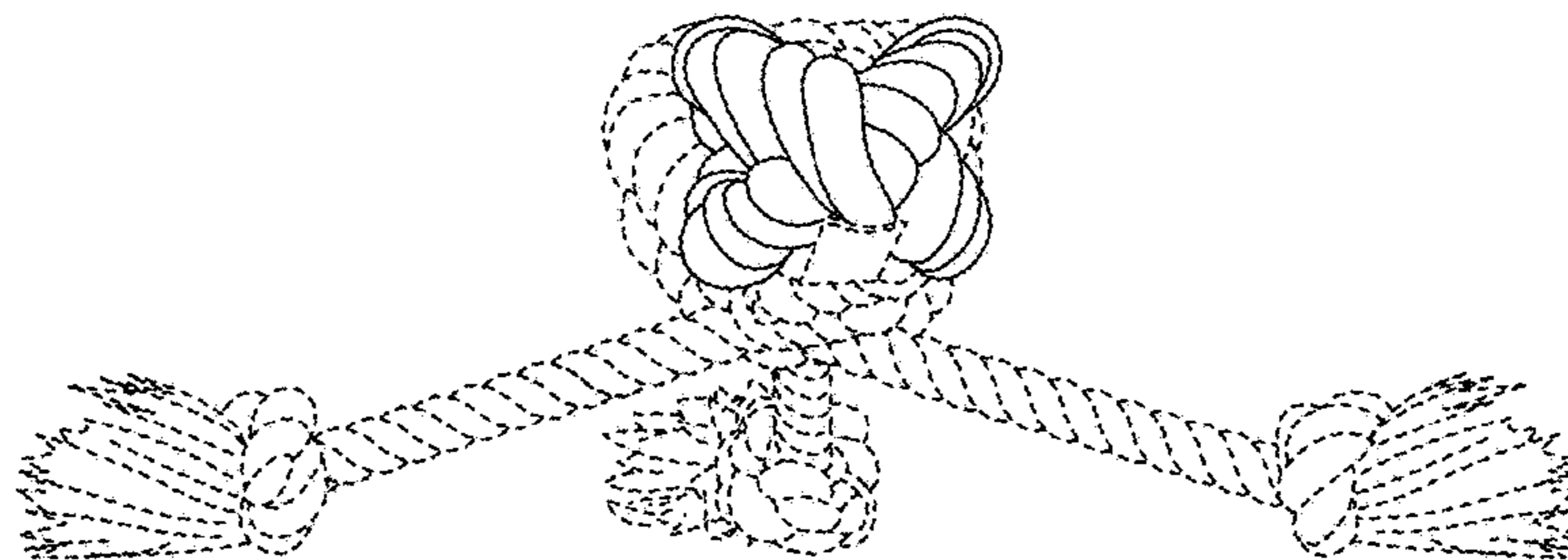
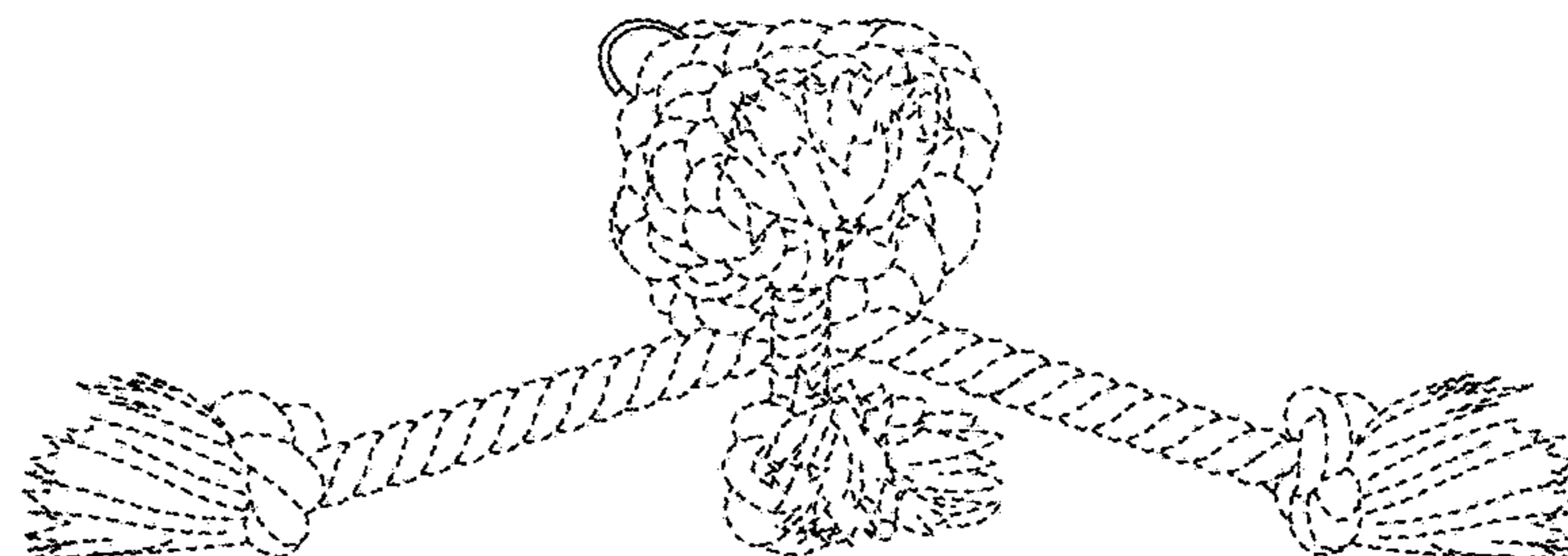

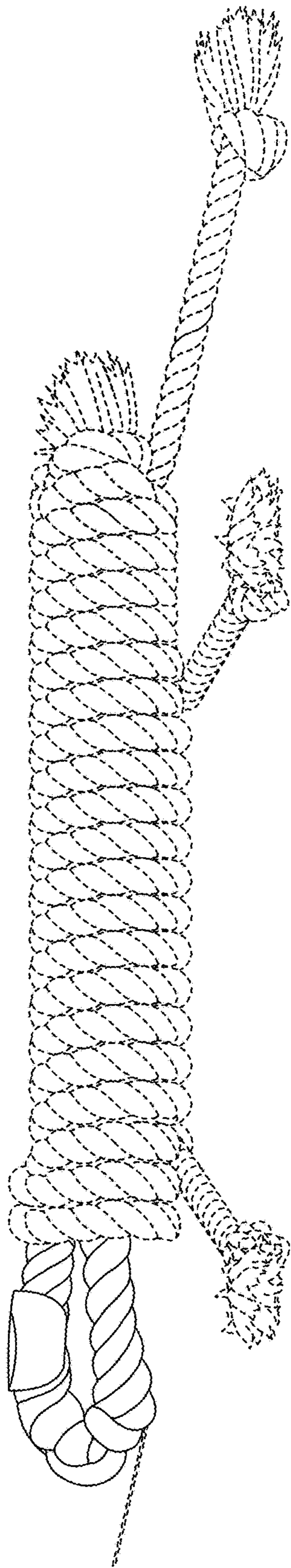

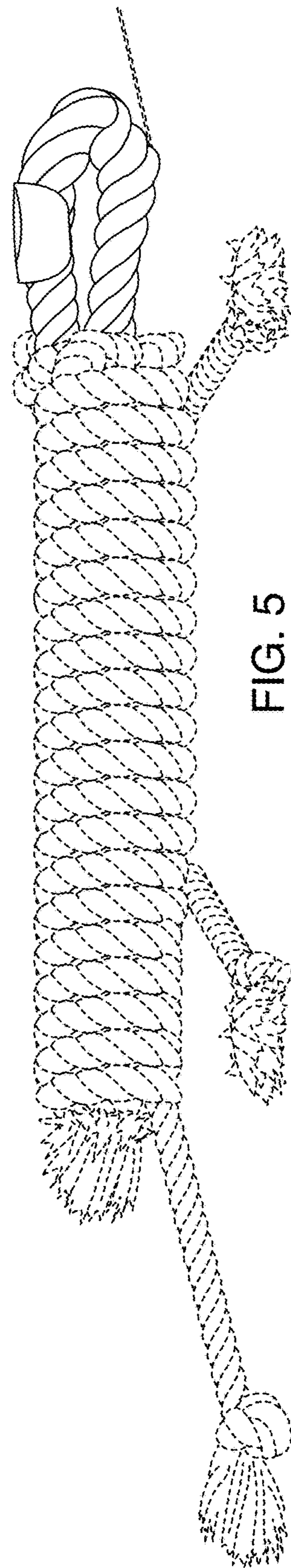

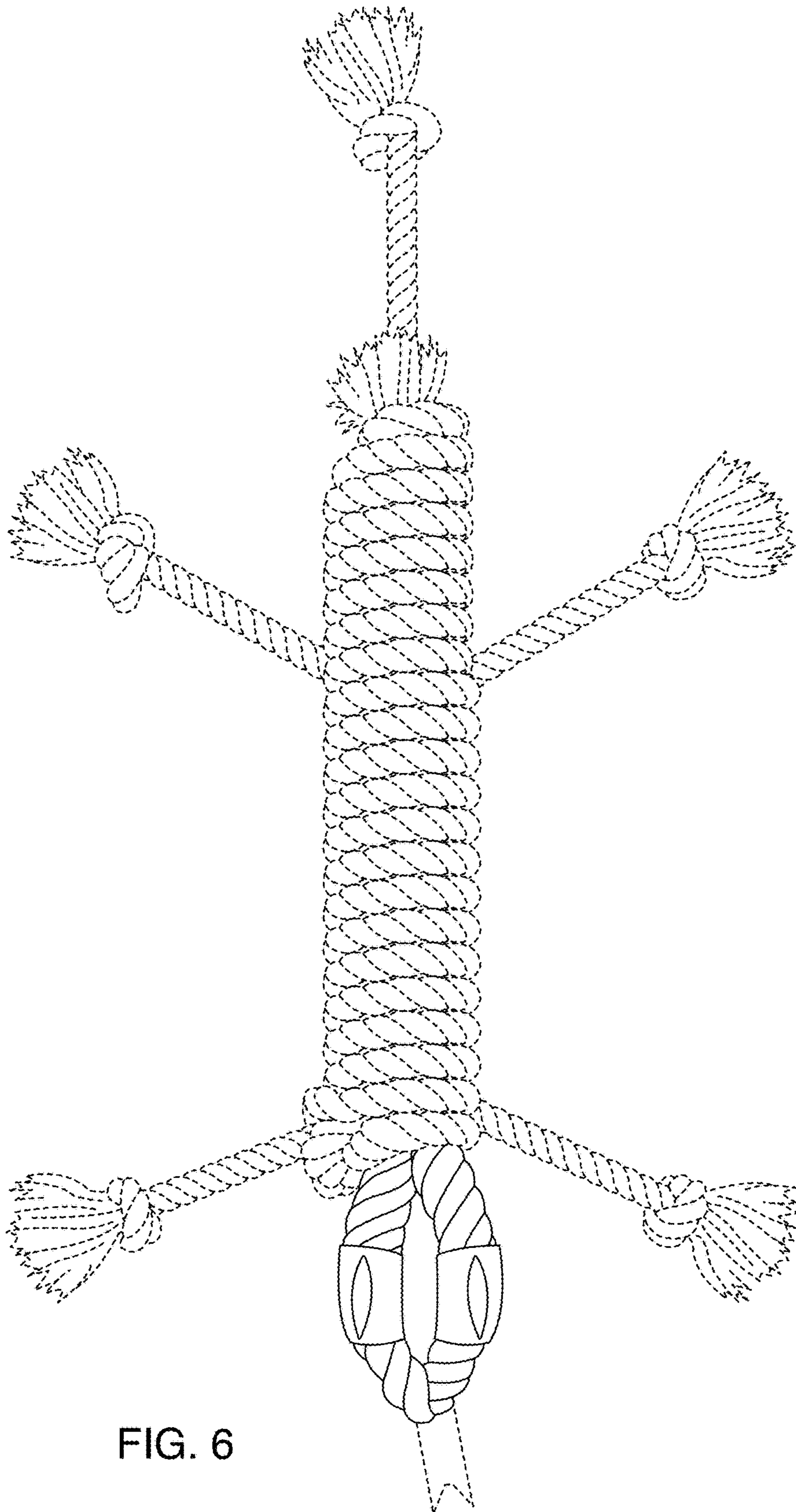

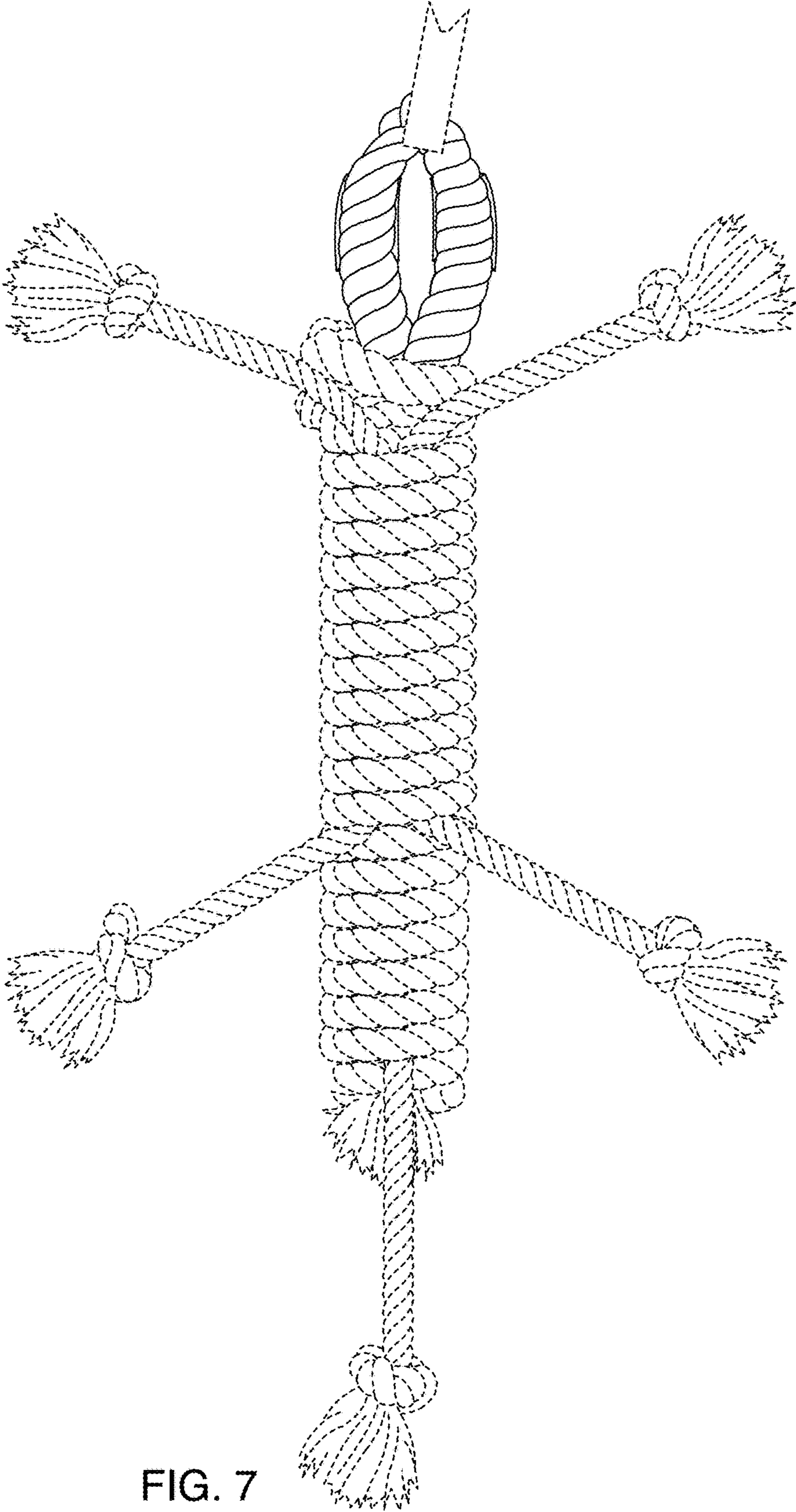

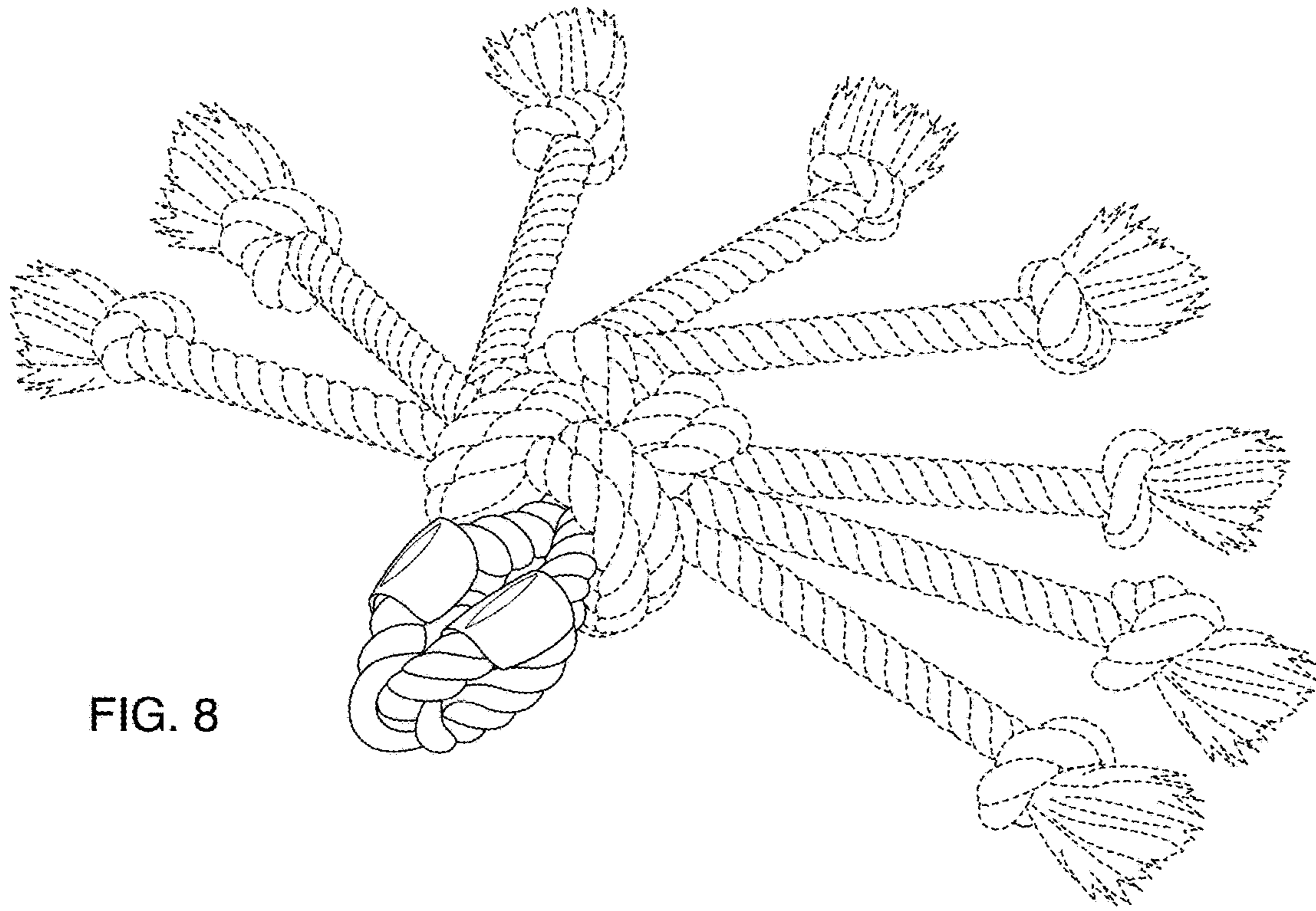

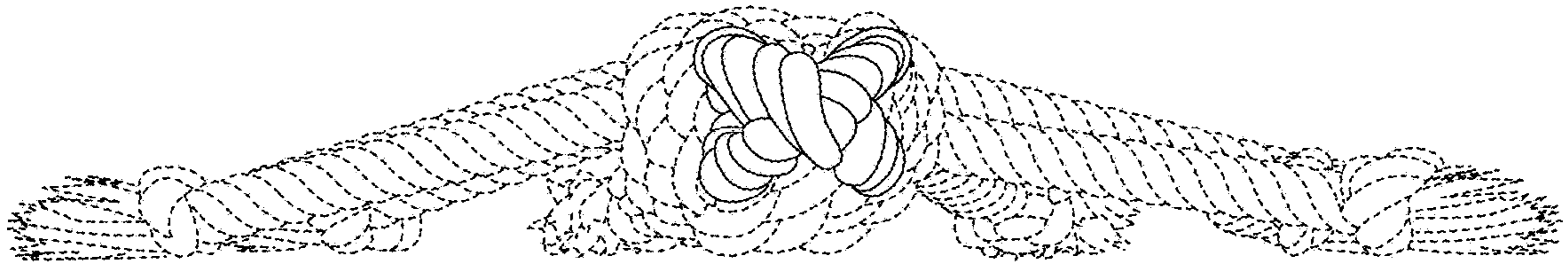

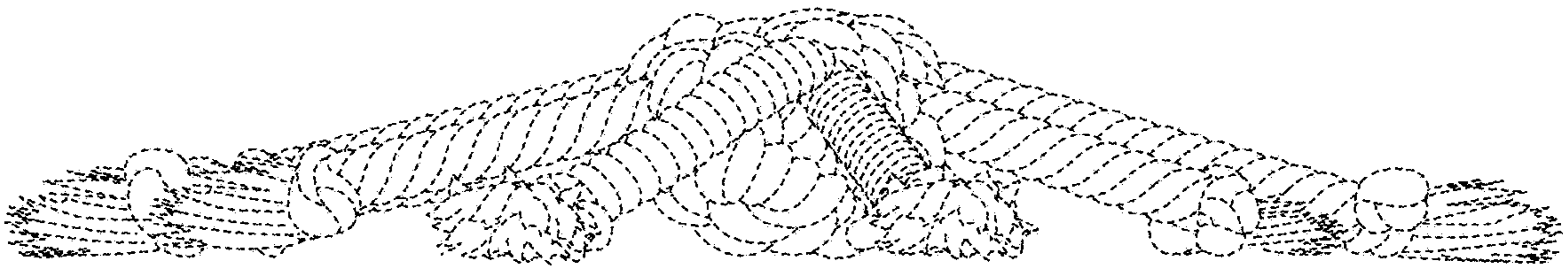

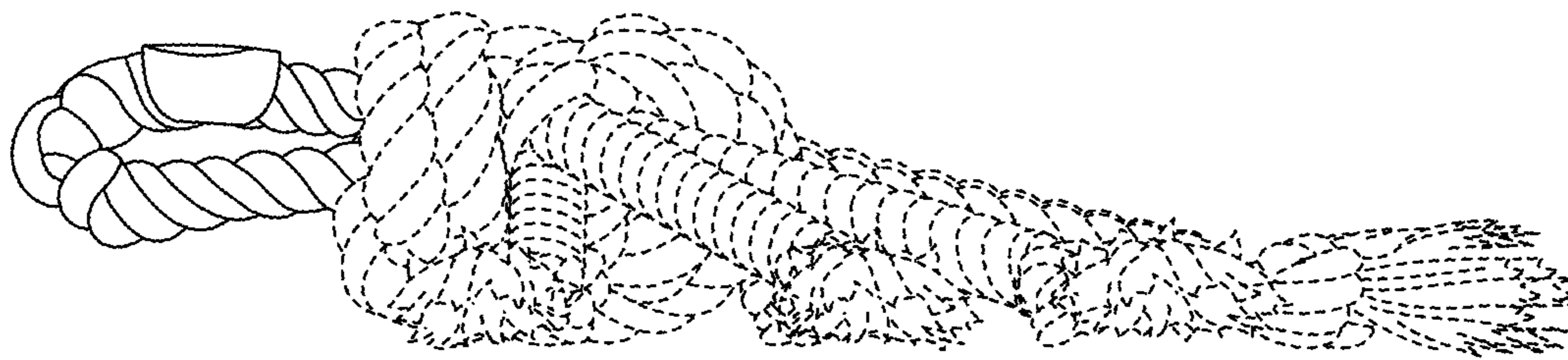

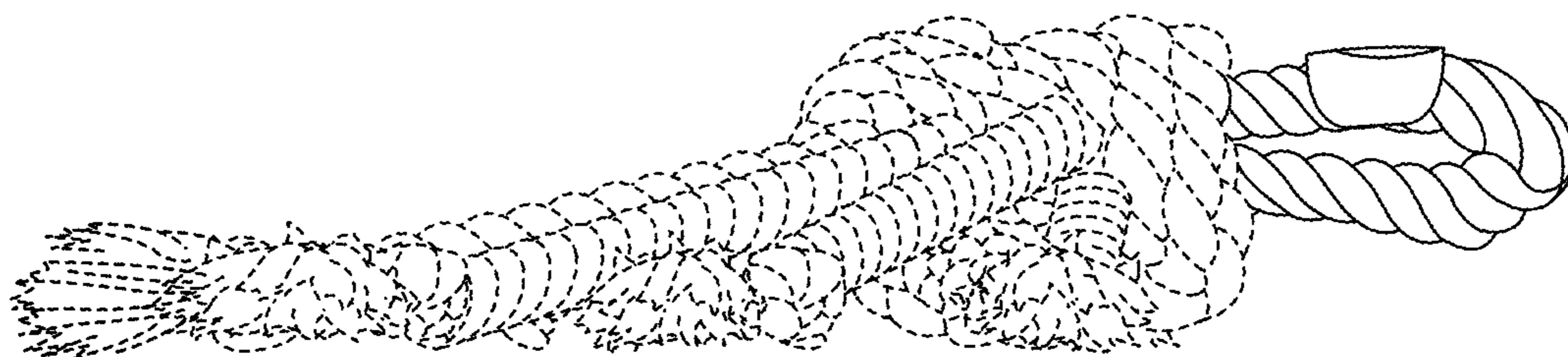

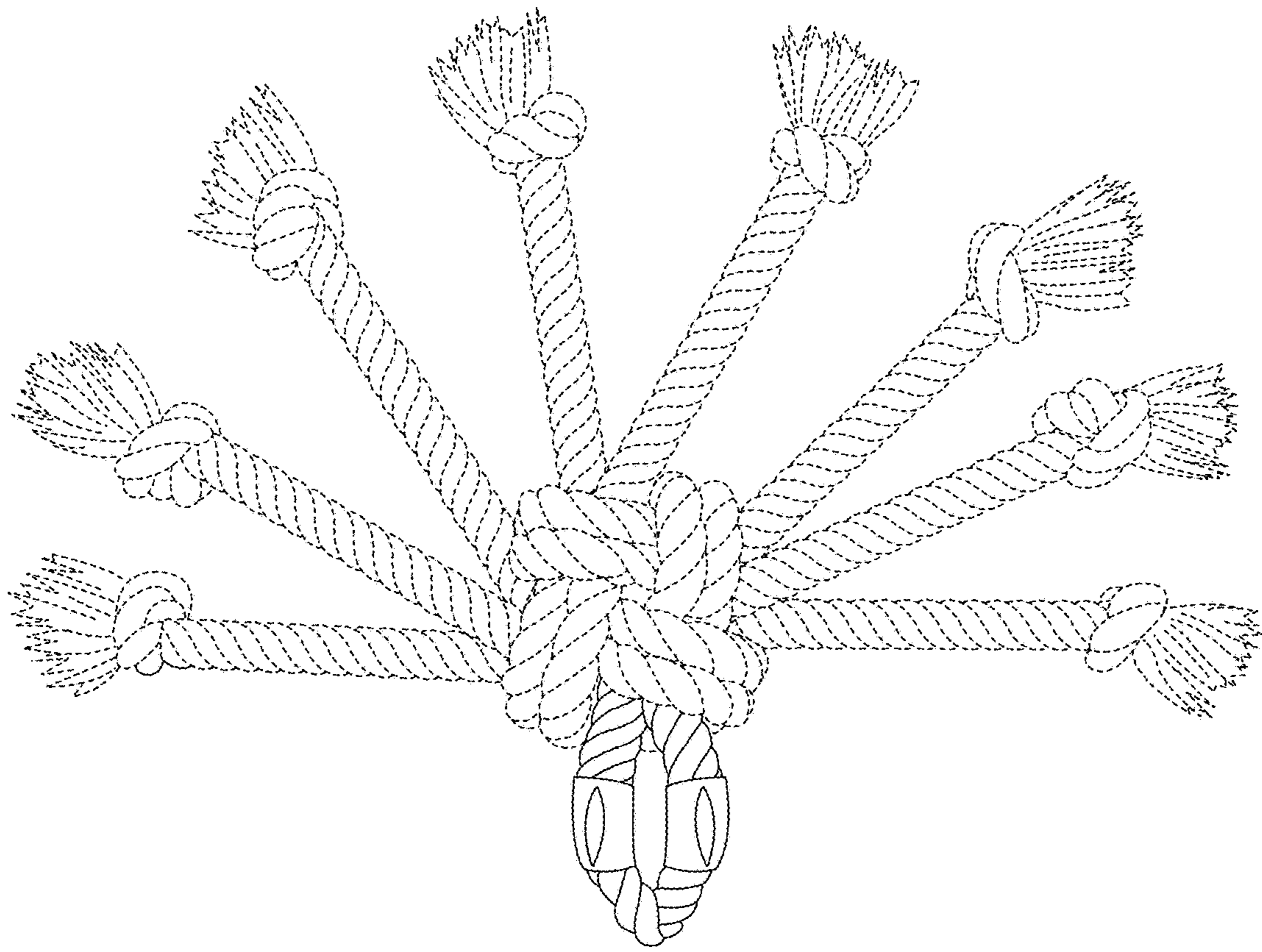

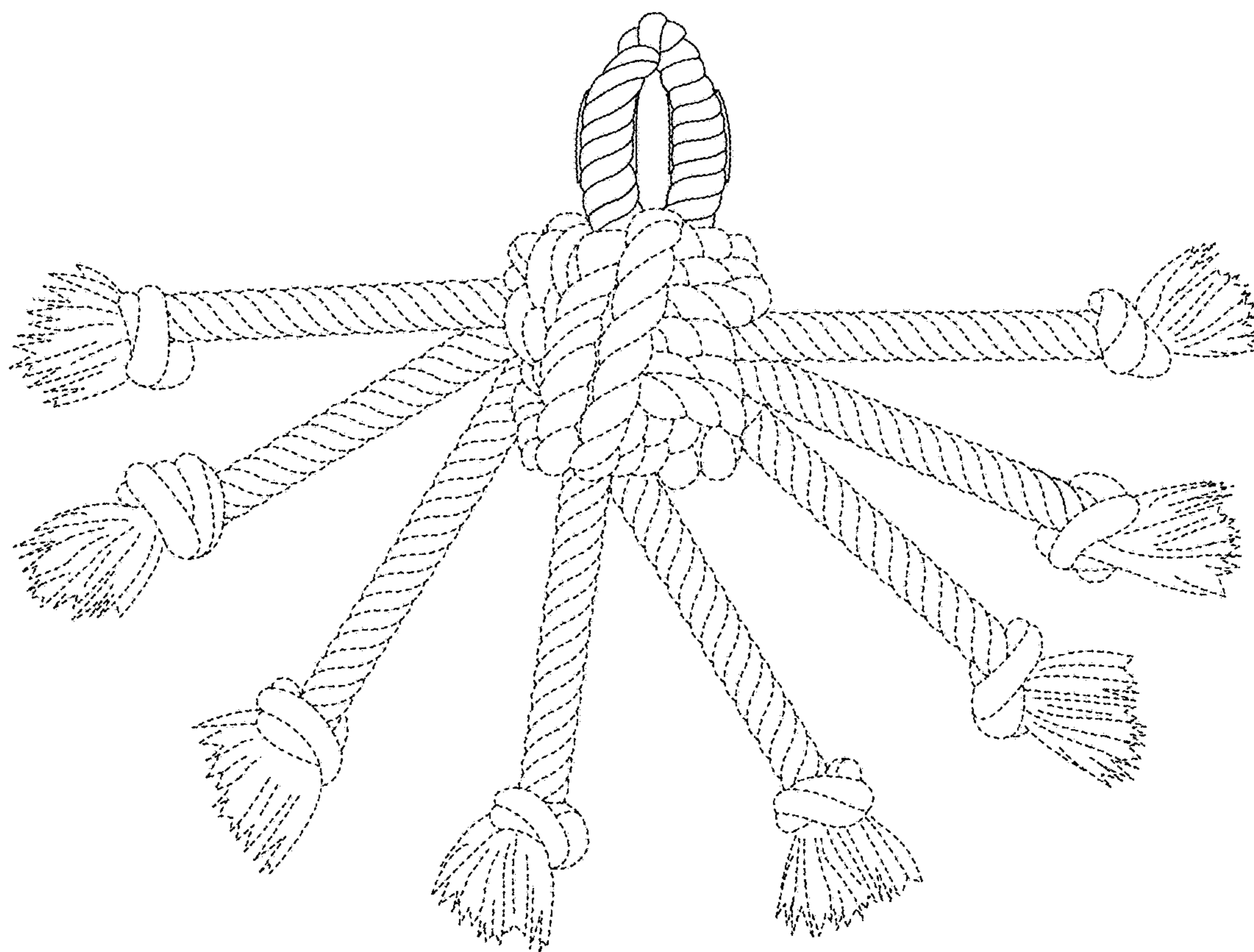
