I claim the ornamental design for a garment with medical tube opening flap, as shown and described.

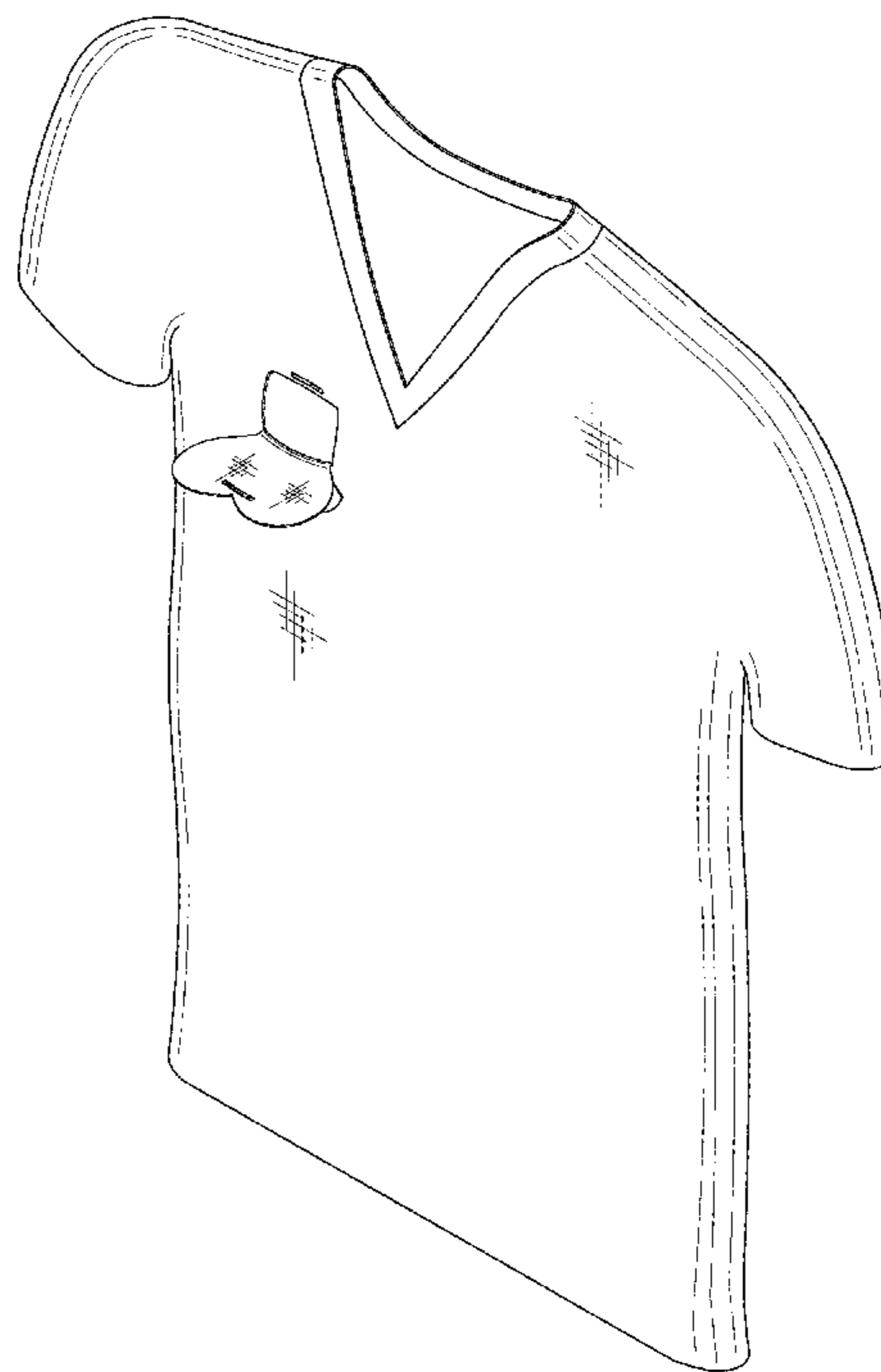
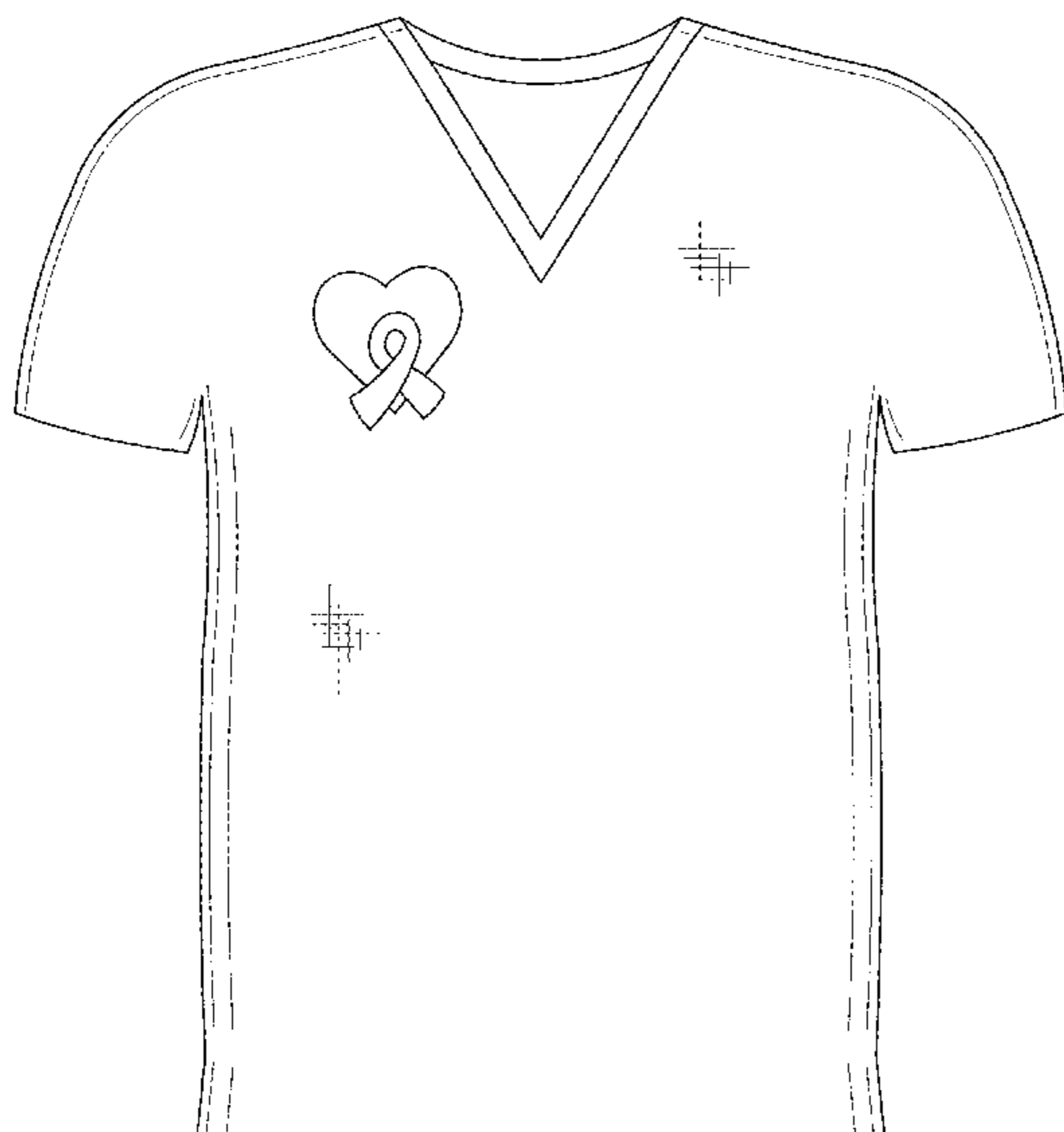
**DESCRIPTION**

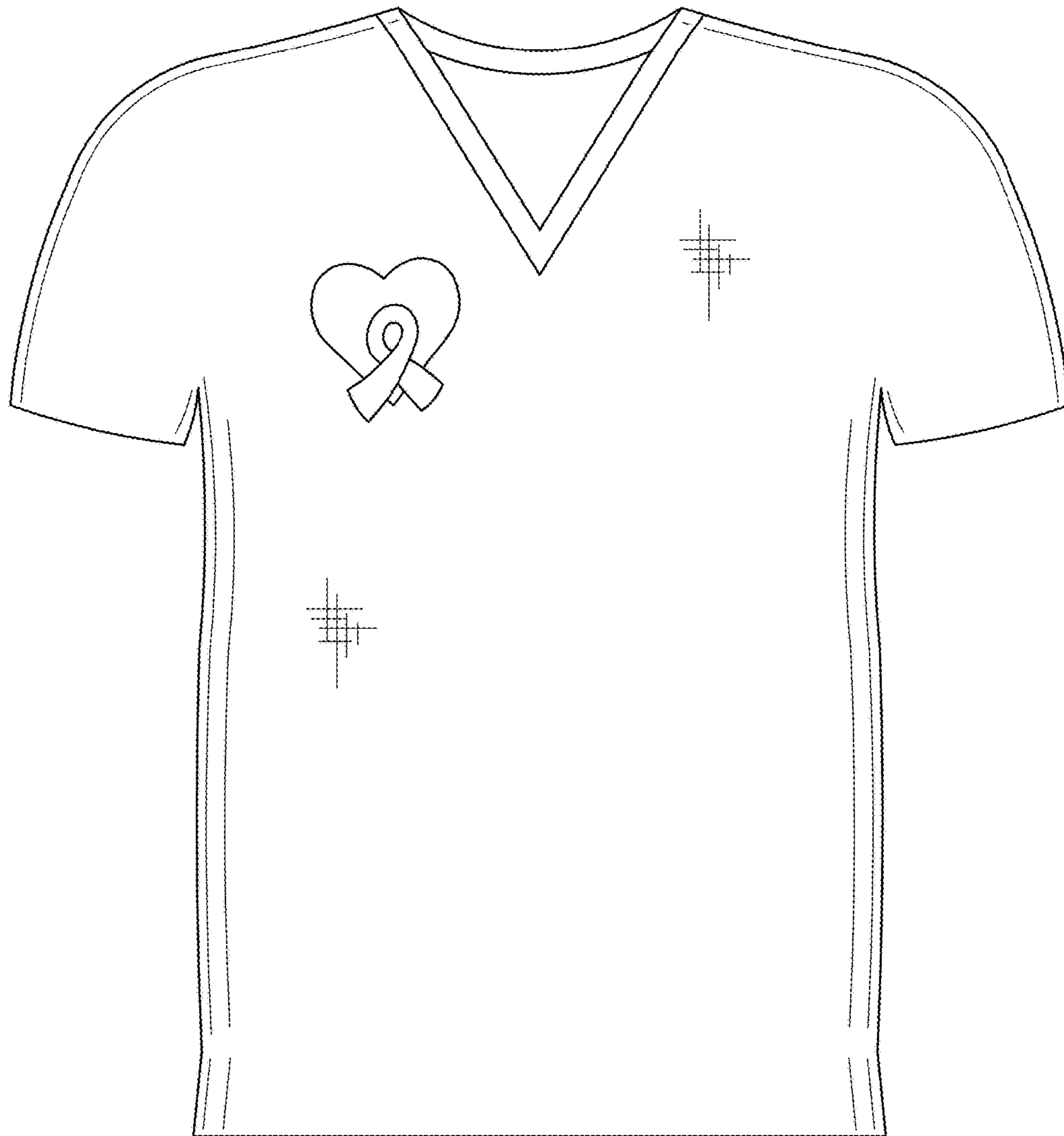

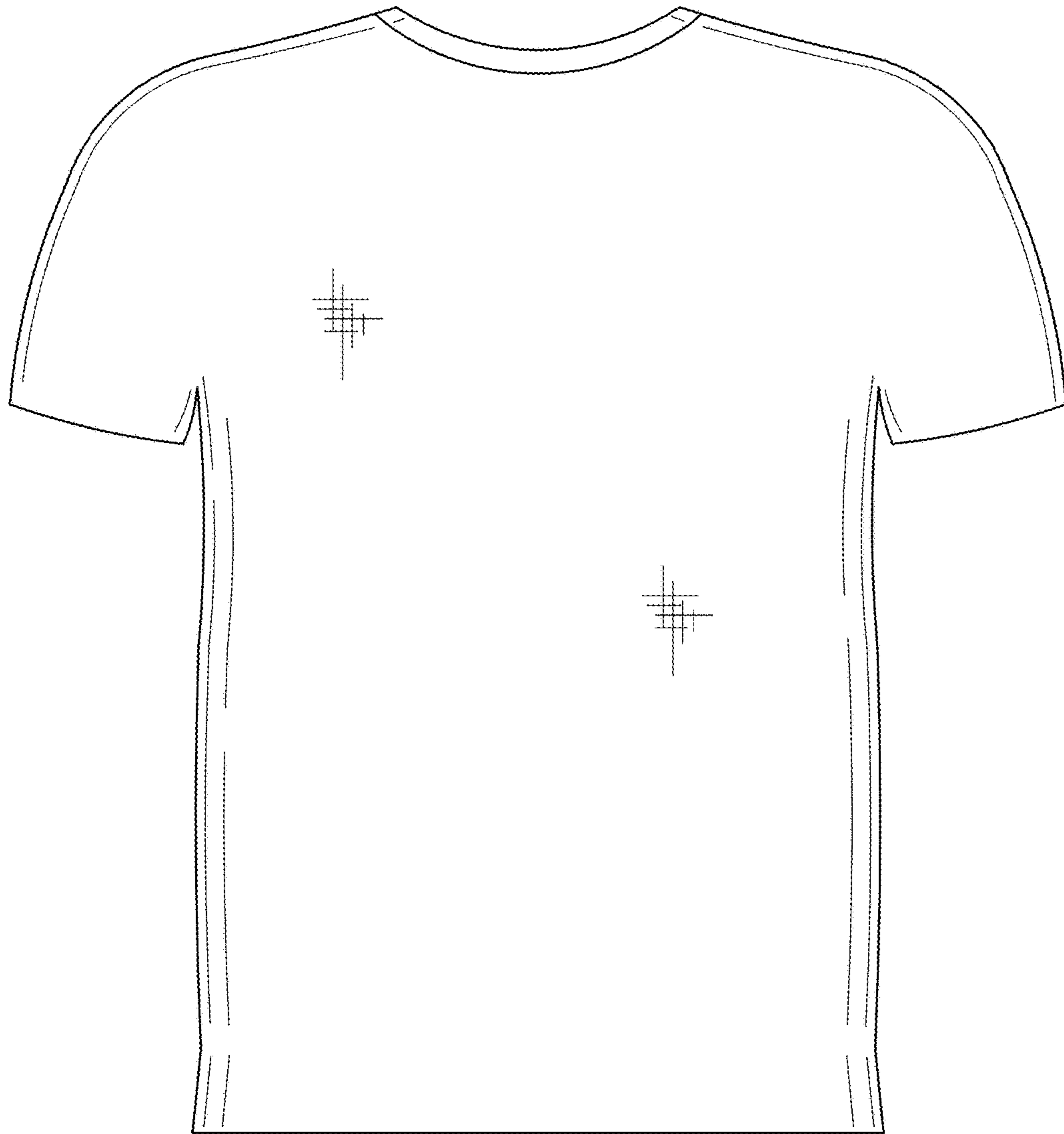
