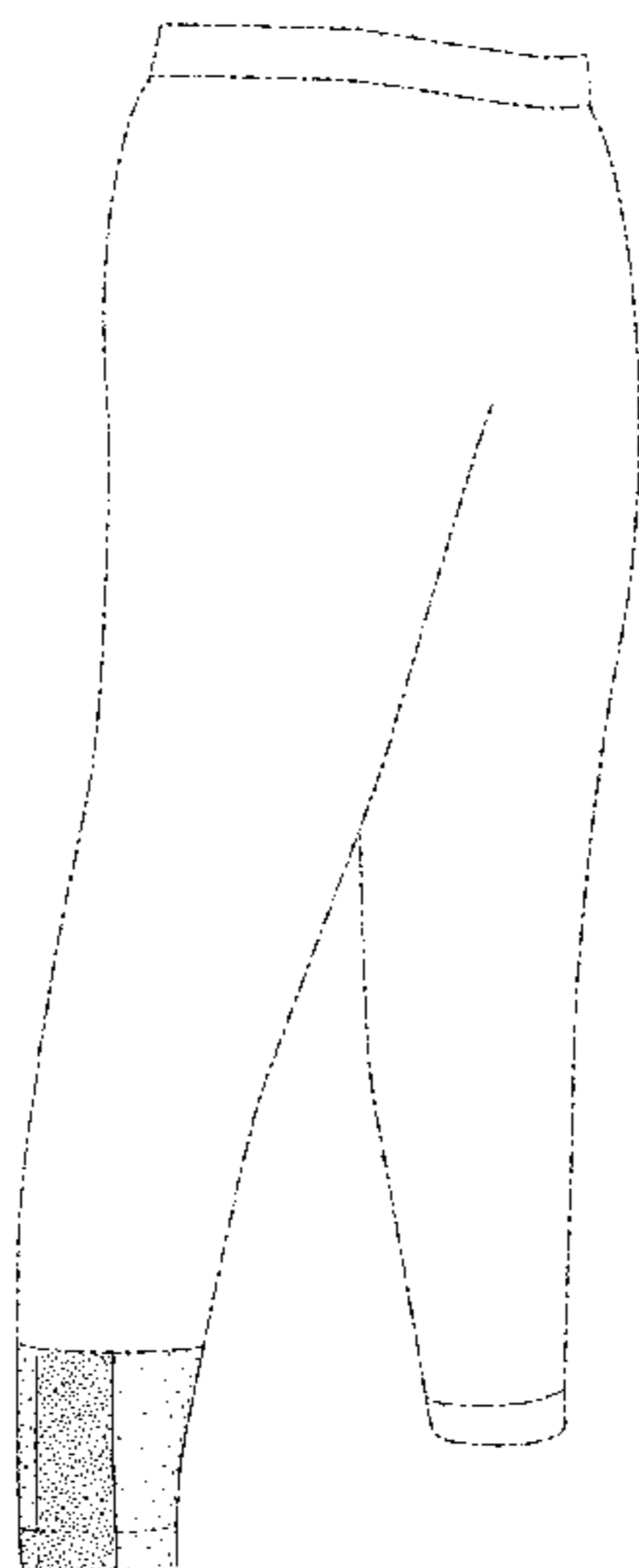
(57) **CLAIM**

The ornamental design for pants, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of pants showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a side view thereof; and,
FIG. 5 is a cross-sectional view at 5-5 in FIG. 2 thereof.
The broken lines immediately adjacent to the shaded area represent unclaimed boundaries of the design. The even-length broken lines within the shaded area represents disclaimed seam and stitch lines and forms no part of the claimed design. The uneven-length broken lines showing the remainder of the pants represent unclaimed subject matter and form no part of the claimed design. The contrast in shading represents a contrast in appearance and does not represent any particular color, material, texture or finish.

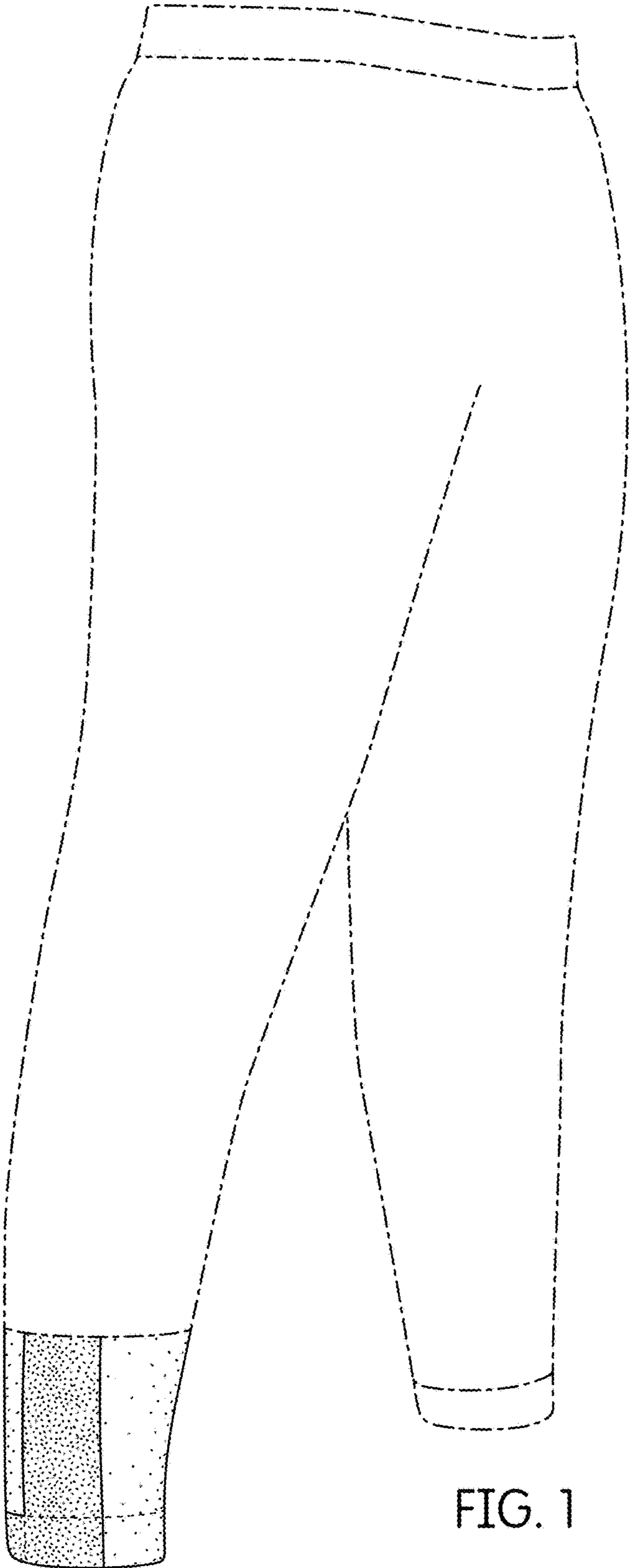

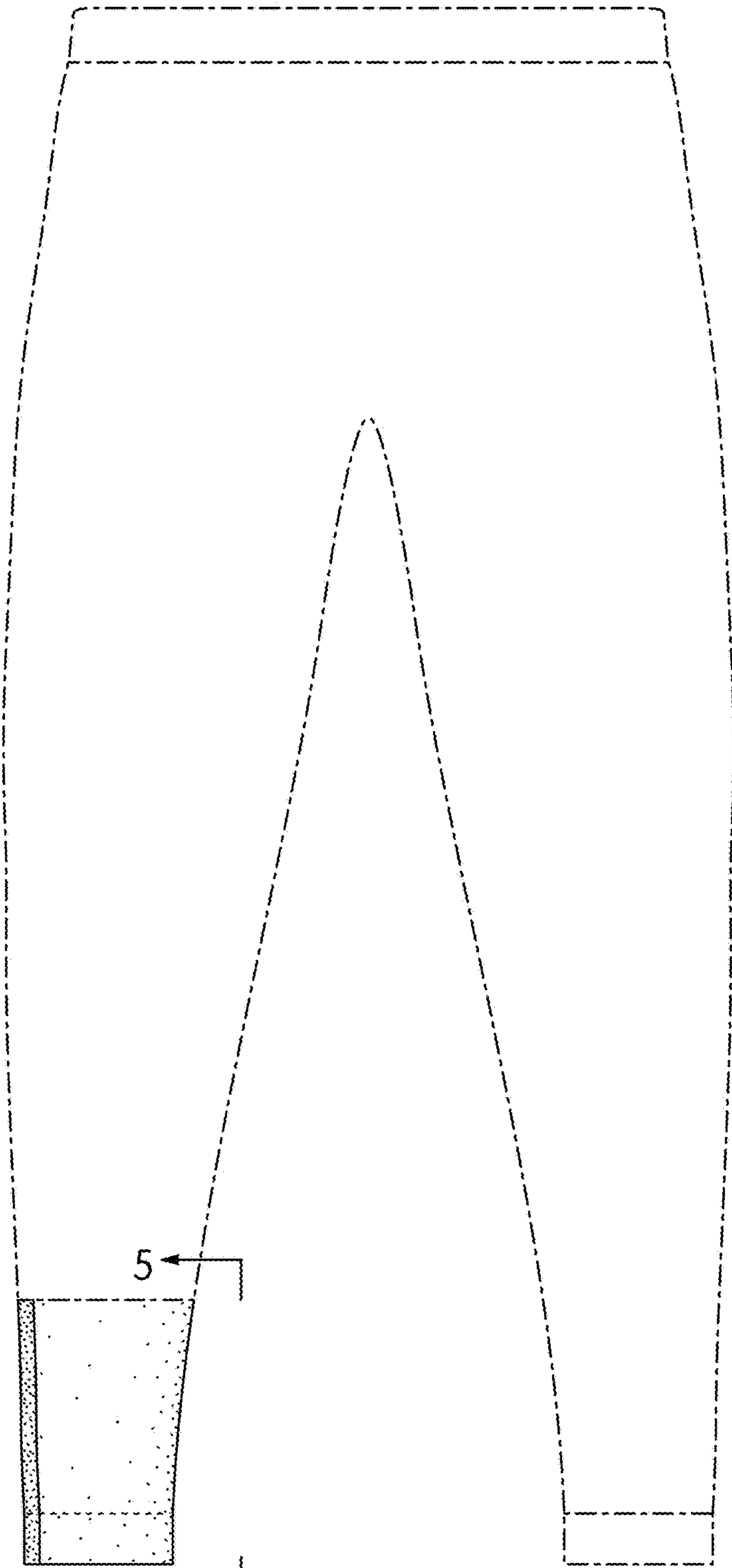

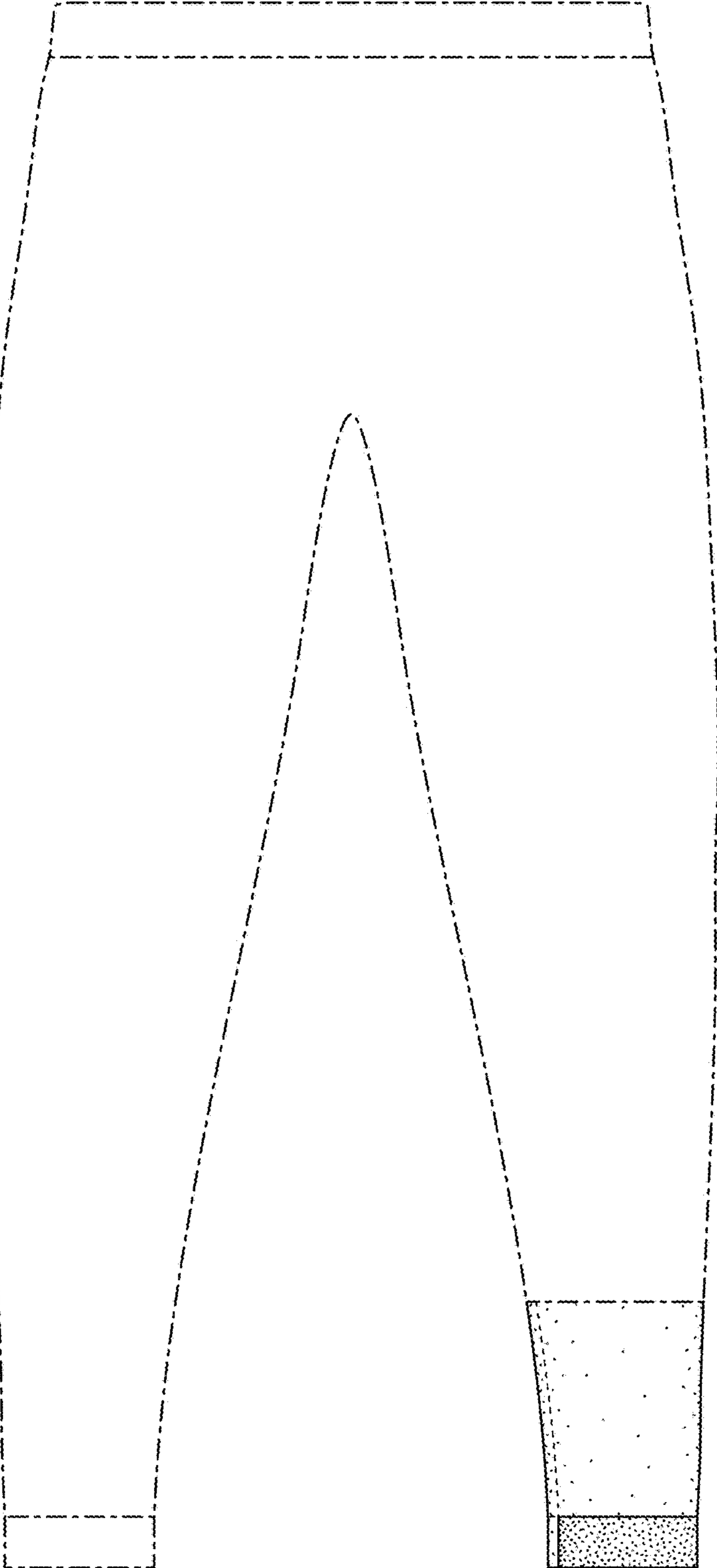

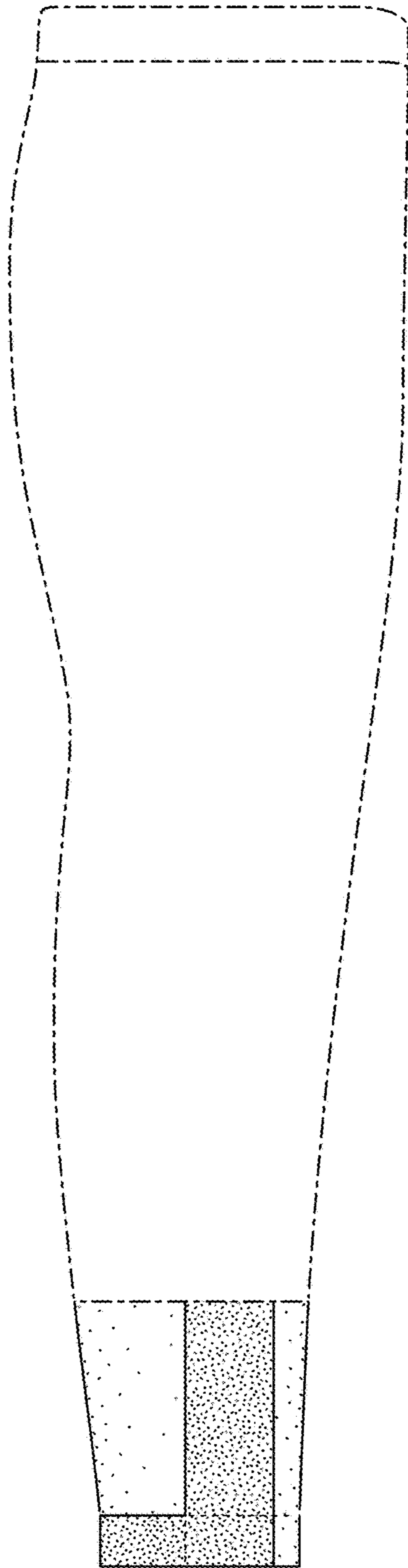

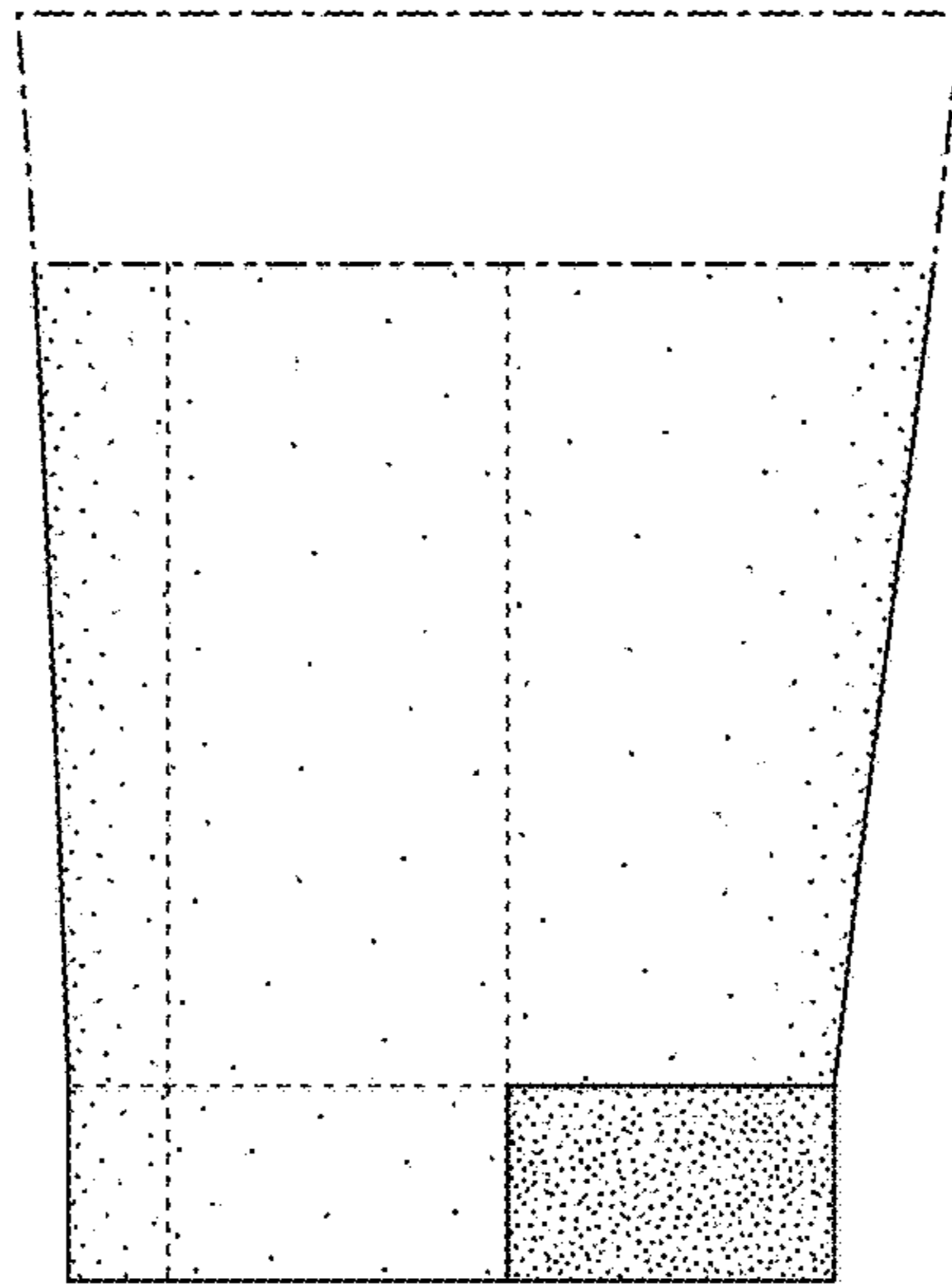
