DESCRIPTION

FIG. 1 is a side view of the shoe showing my new design; FIG. 2 is a top plan view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a front elevation view thereof; and, FIG. 5 is a front perspective view thereof. 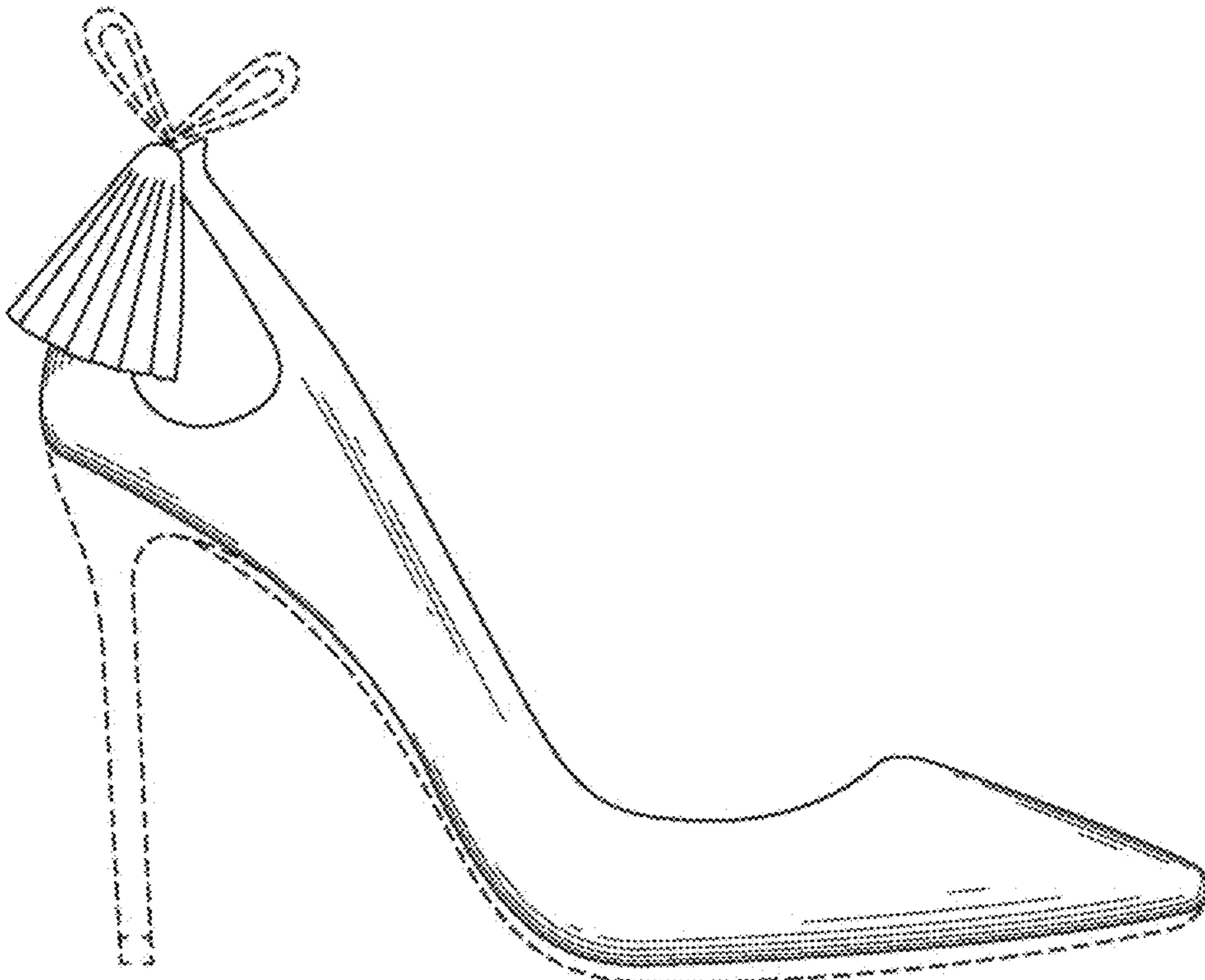

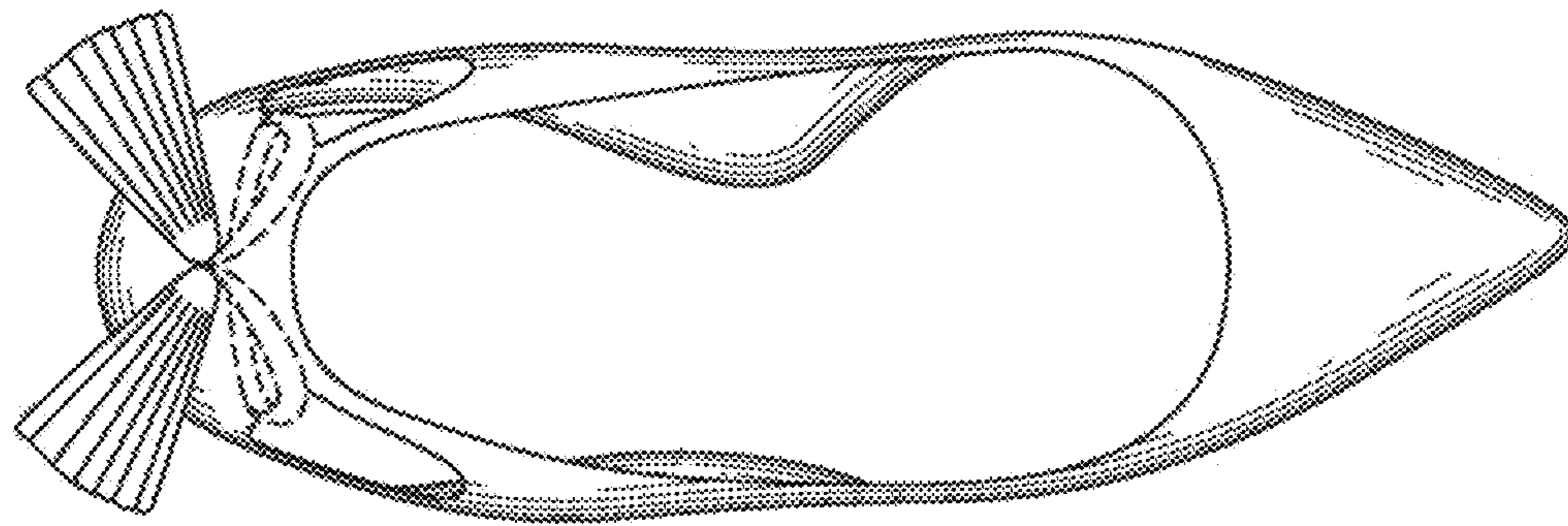

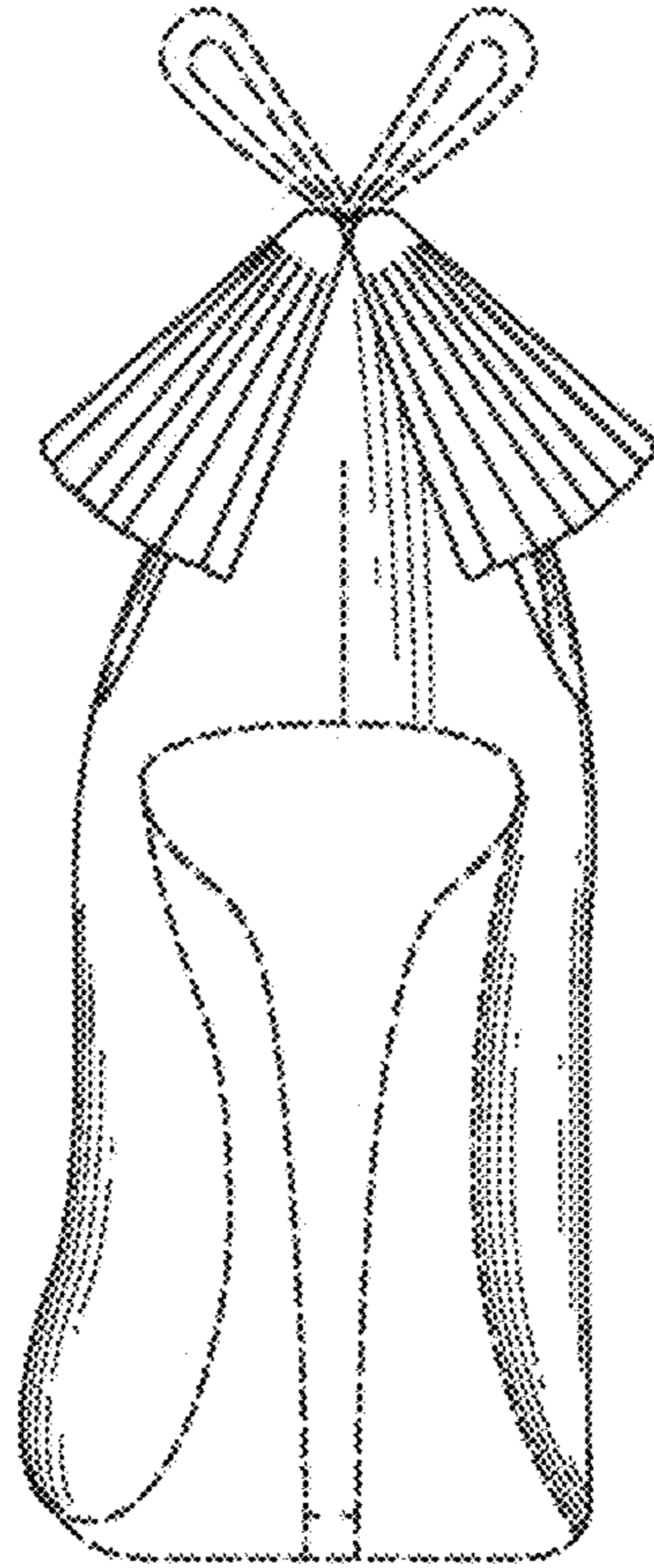

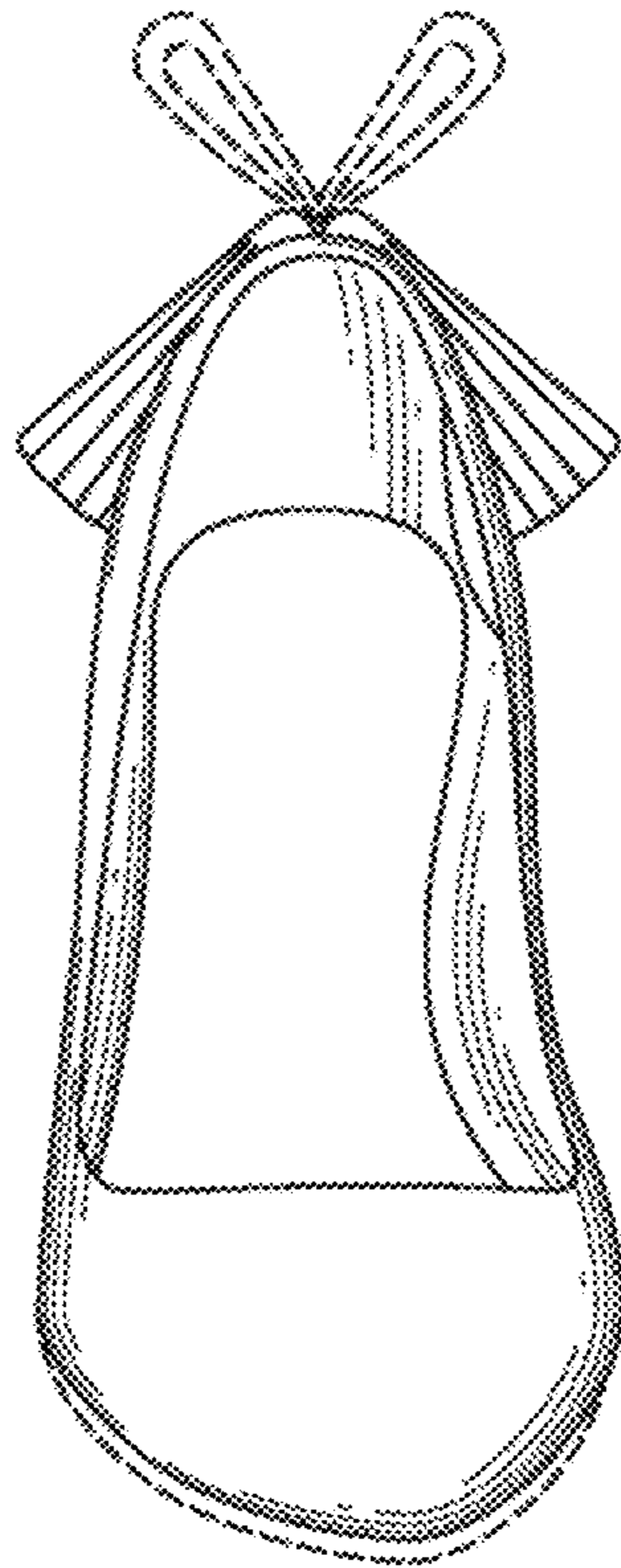

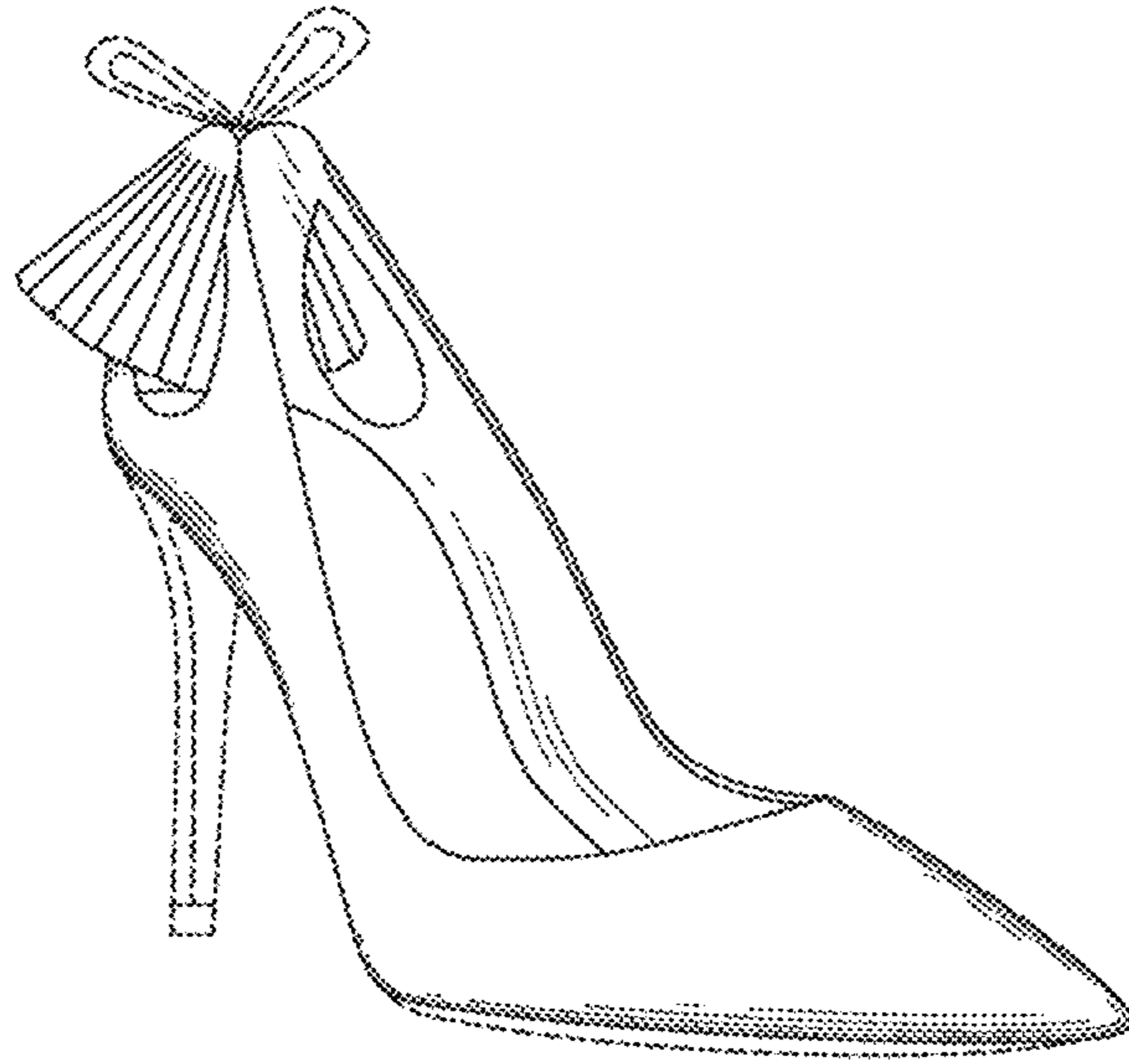
