(57) **CLAIM**

We claim the ornamental design for a golf shoe, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a golf shoe as viewed from the front and one side thereof, according to an embodiment of the design.

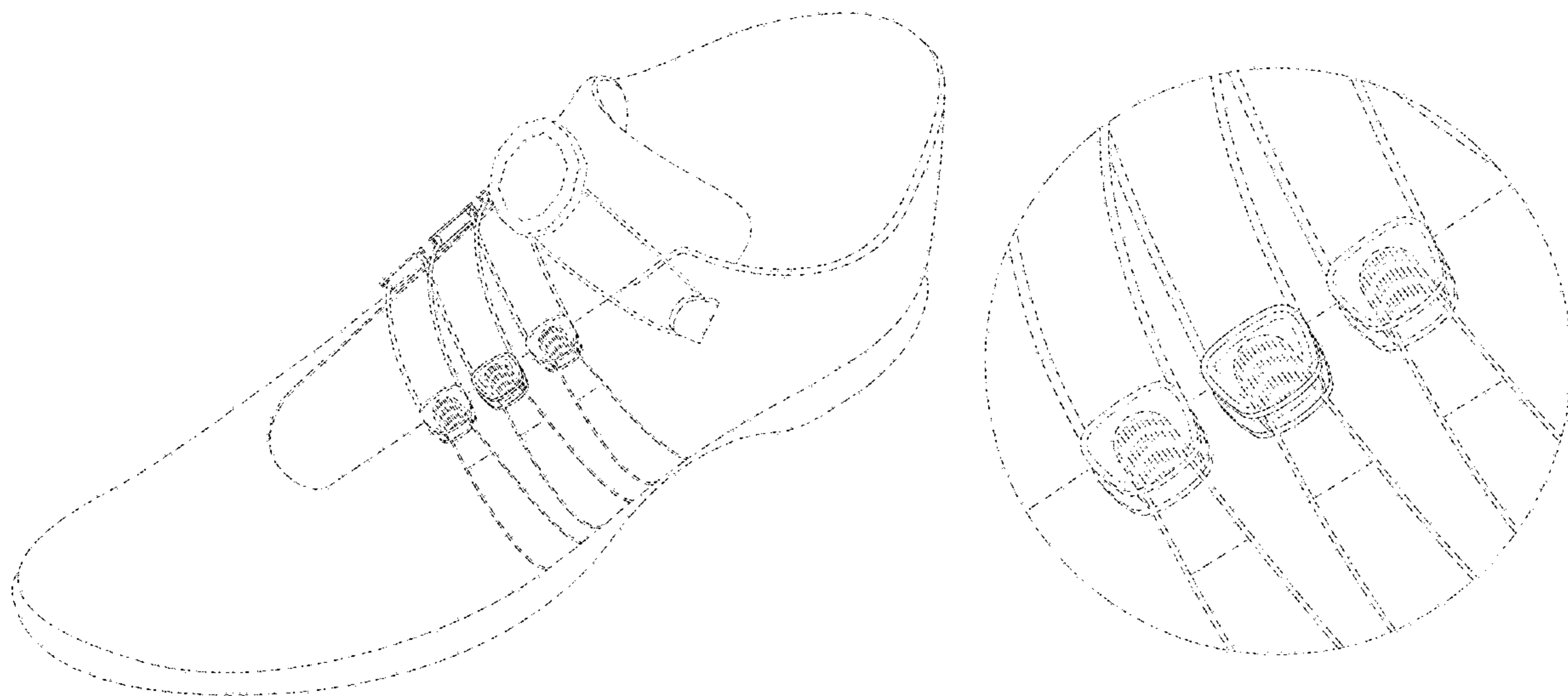
FIG. 2 is a front elevation view of the golf shoe of FIG. 1. FIG. 3 is a rear elevation view of the golf shoe of FIG. 1. FIG. 4 is a side elevation view of the golf shoe of FIG. 1. FIG. 5 is a side elevation view of the golf shoe of FIG. 1, from the side opposite FIG. 4.

FIG. 6 is a top plan view of the golf shoe of FIG. 1.

FIG. 7 is a bottom plan view of the golf shoe of FIG. 1; and, FIG. 8 is an enlargement of a central area of FIG. 1, showing lacing fasteners.

The dashed lines in the drawings are for purposes of illustrating environmental structure that form no part of the claimed design. Broken lines located within the lacing fasteners represent ridges that are part of the environment and not claimed.

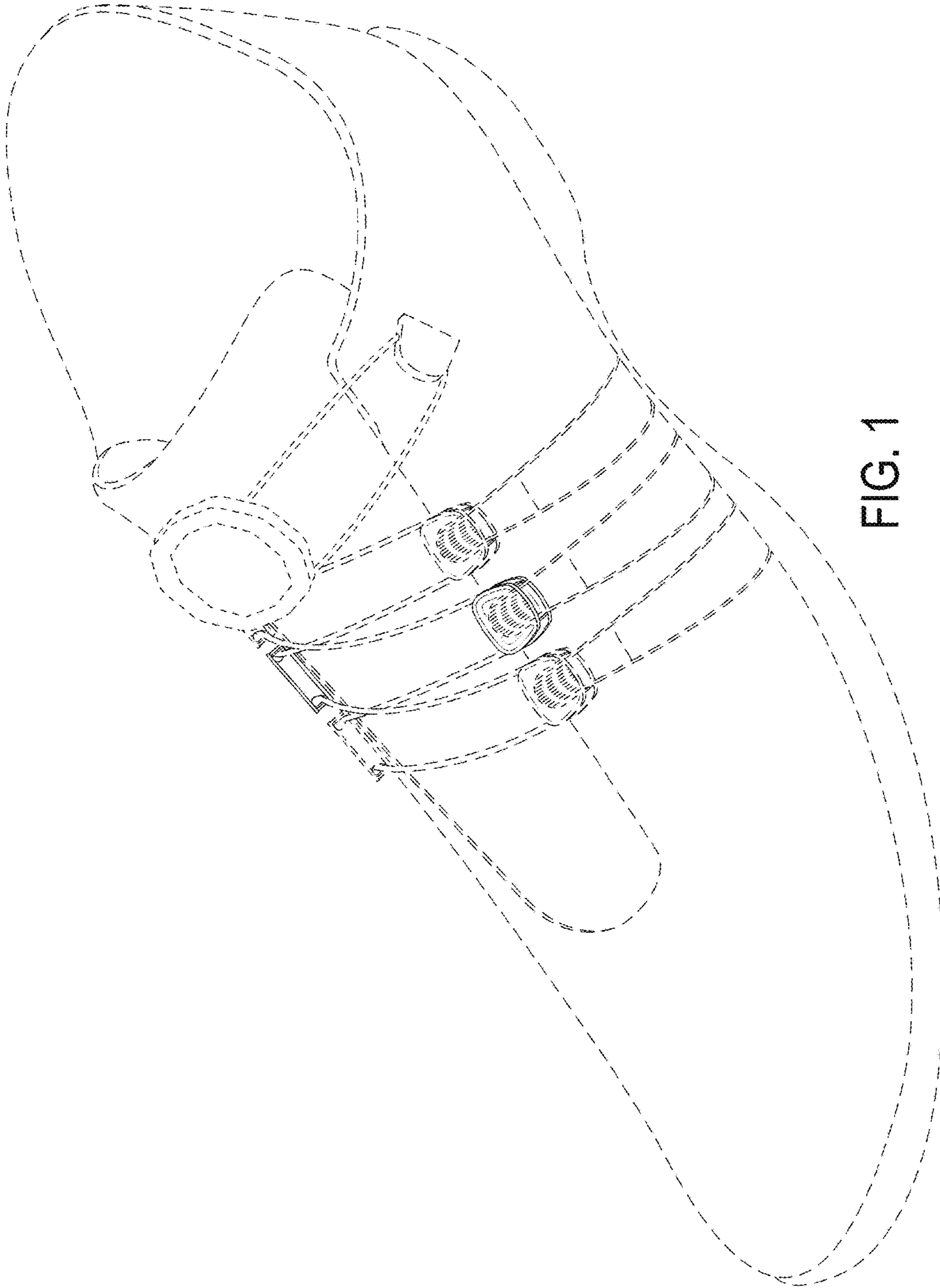

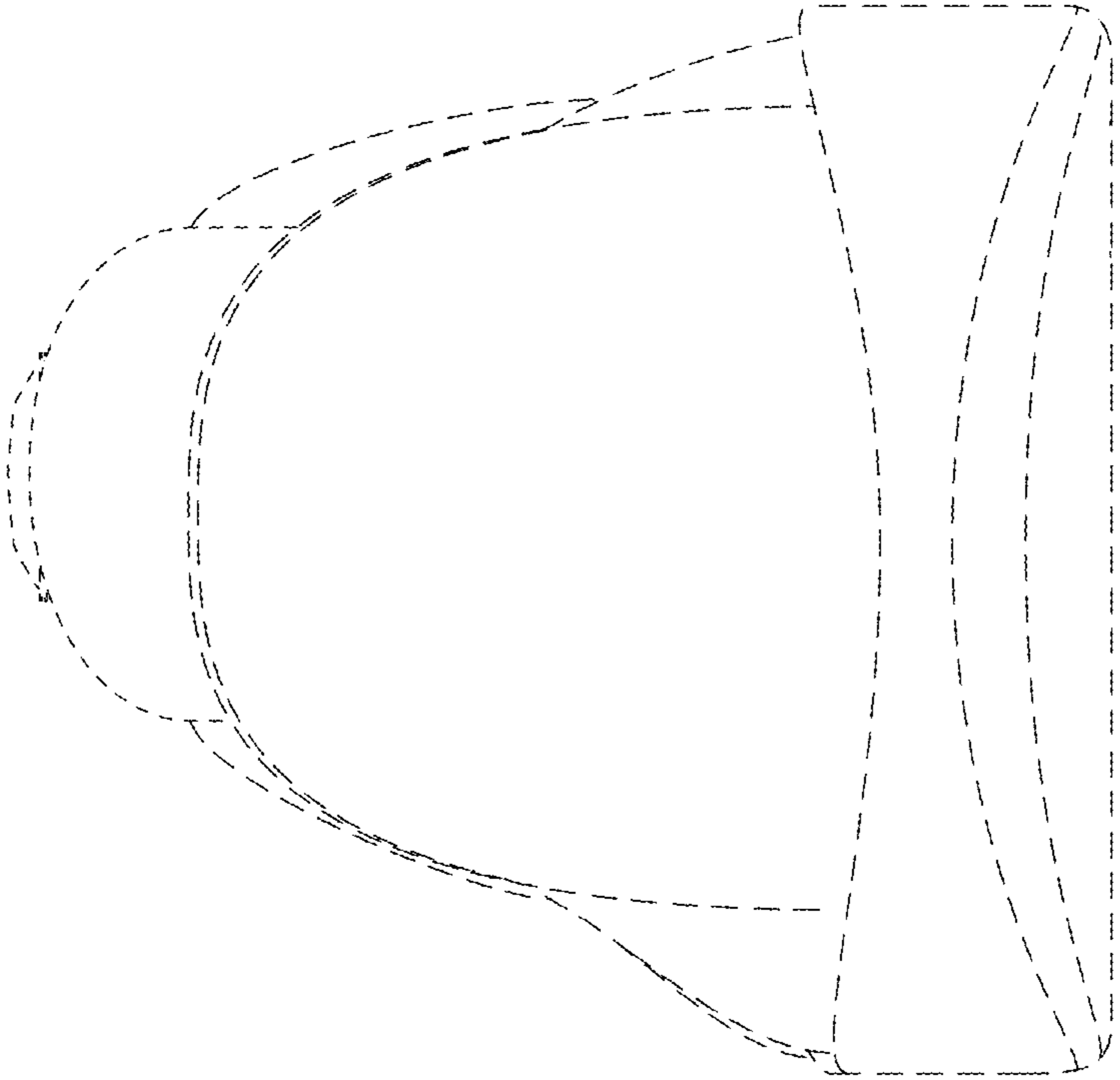

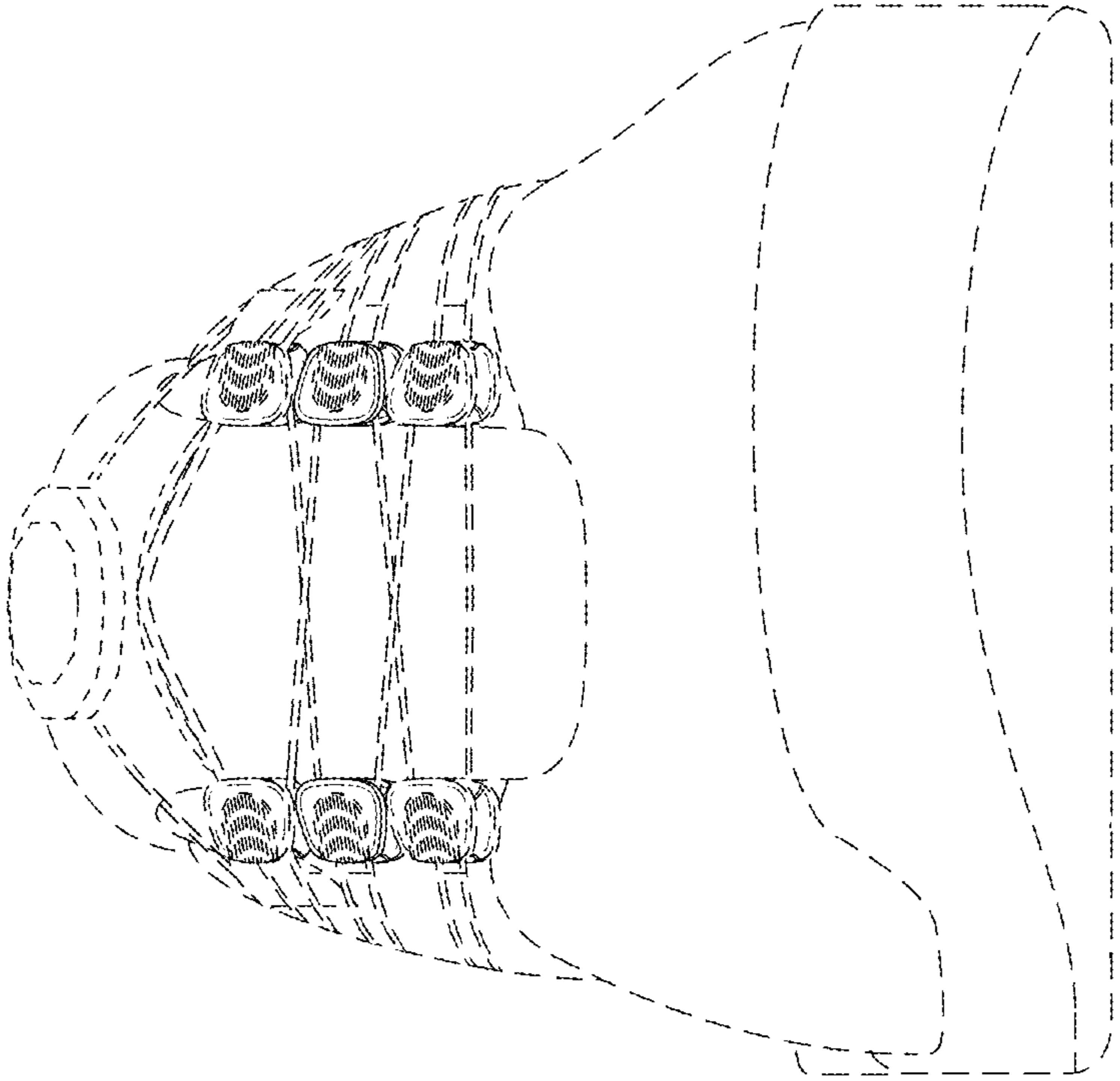

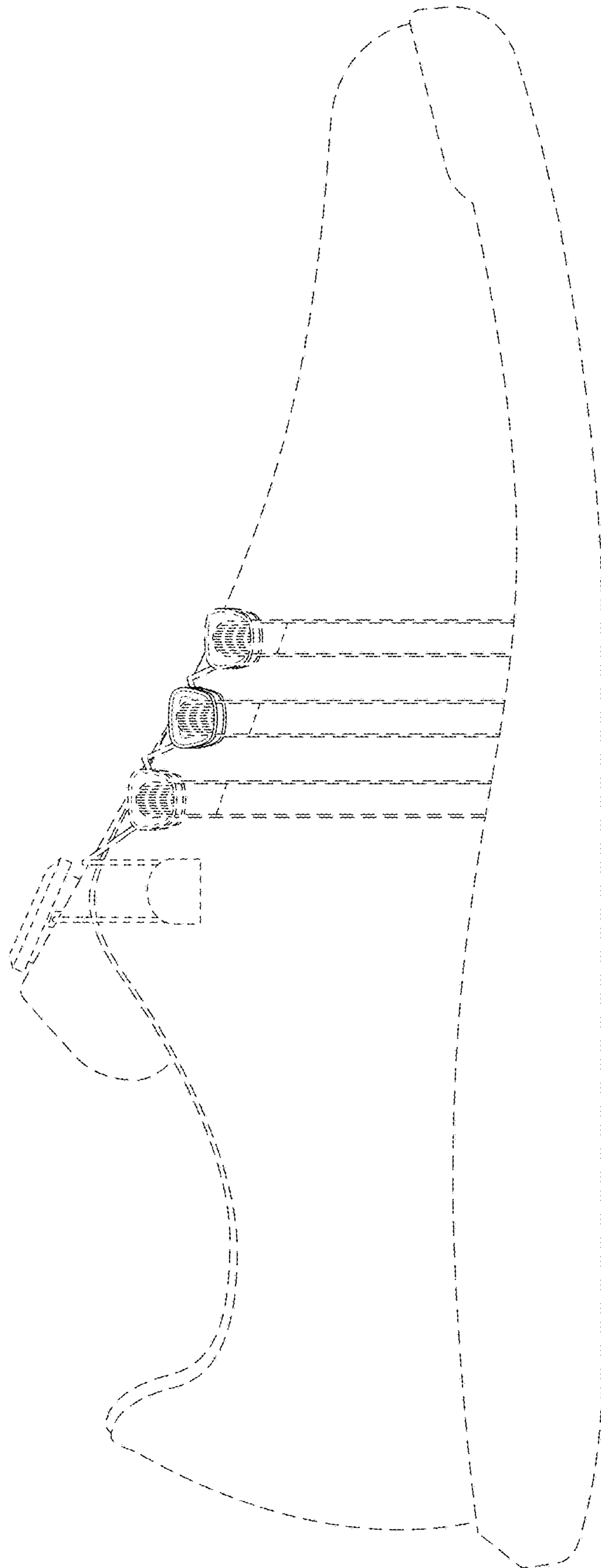

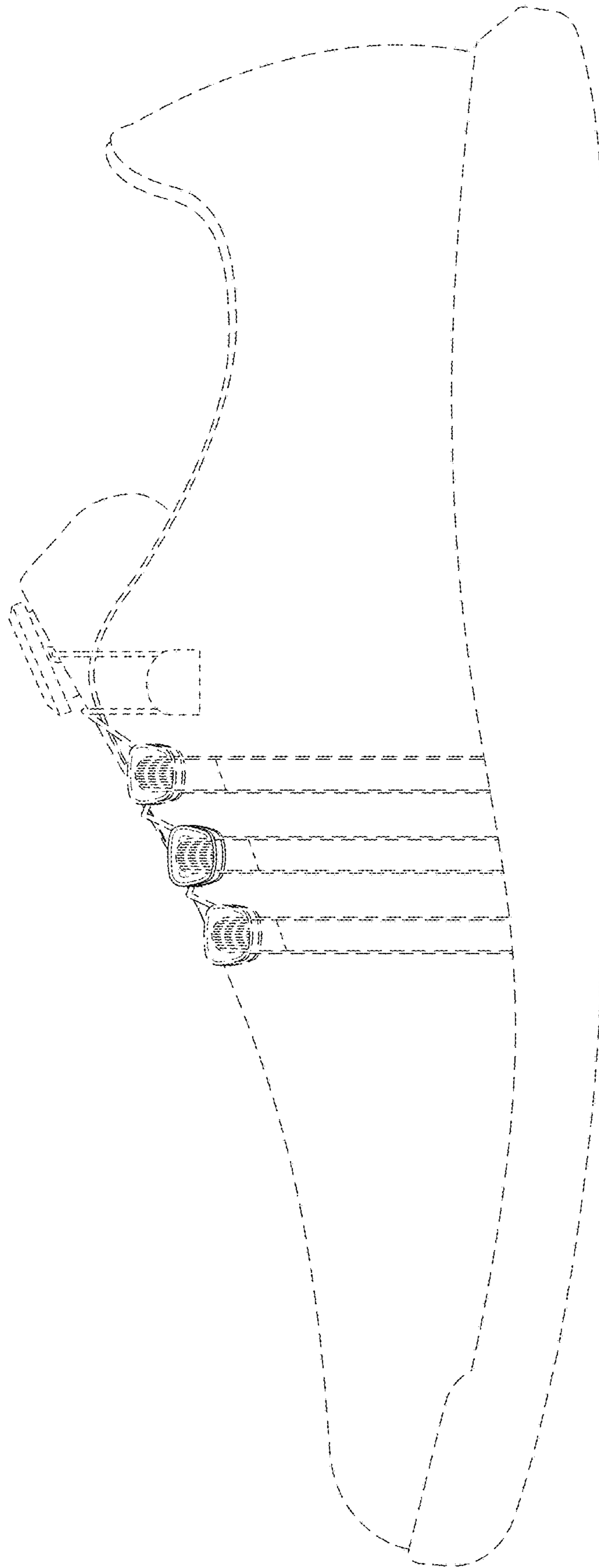

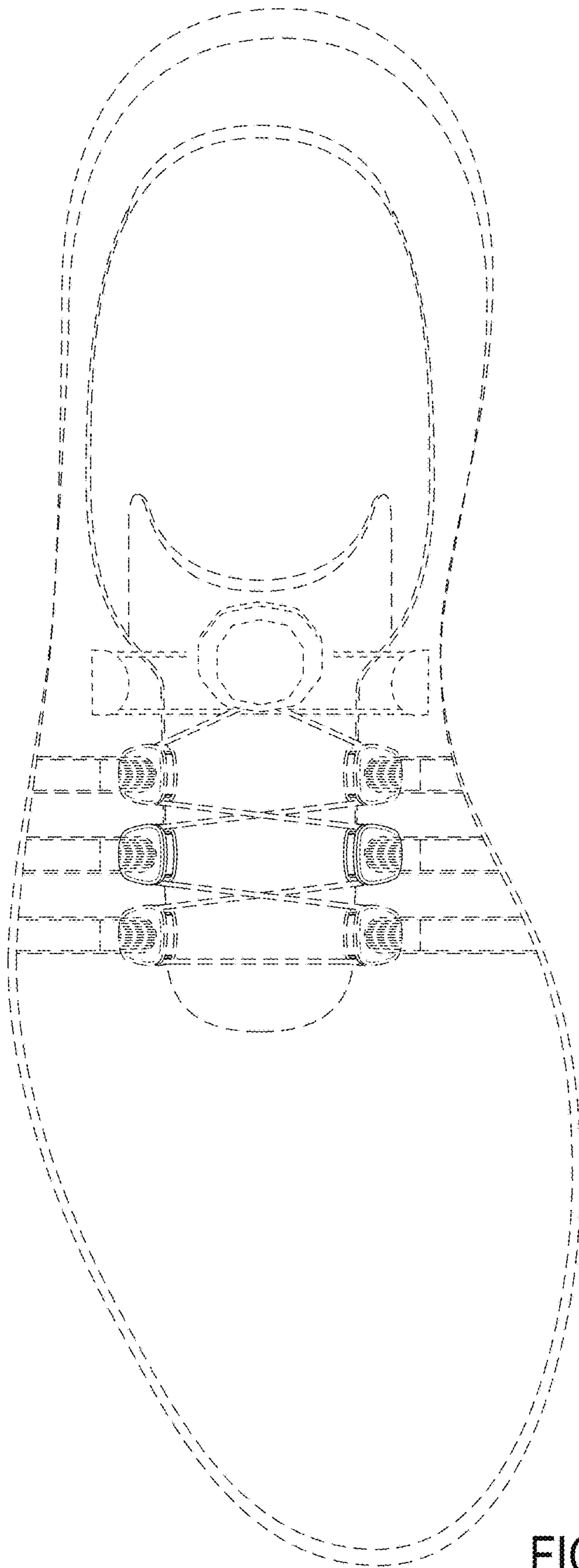

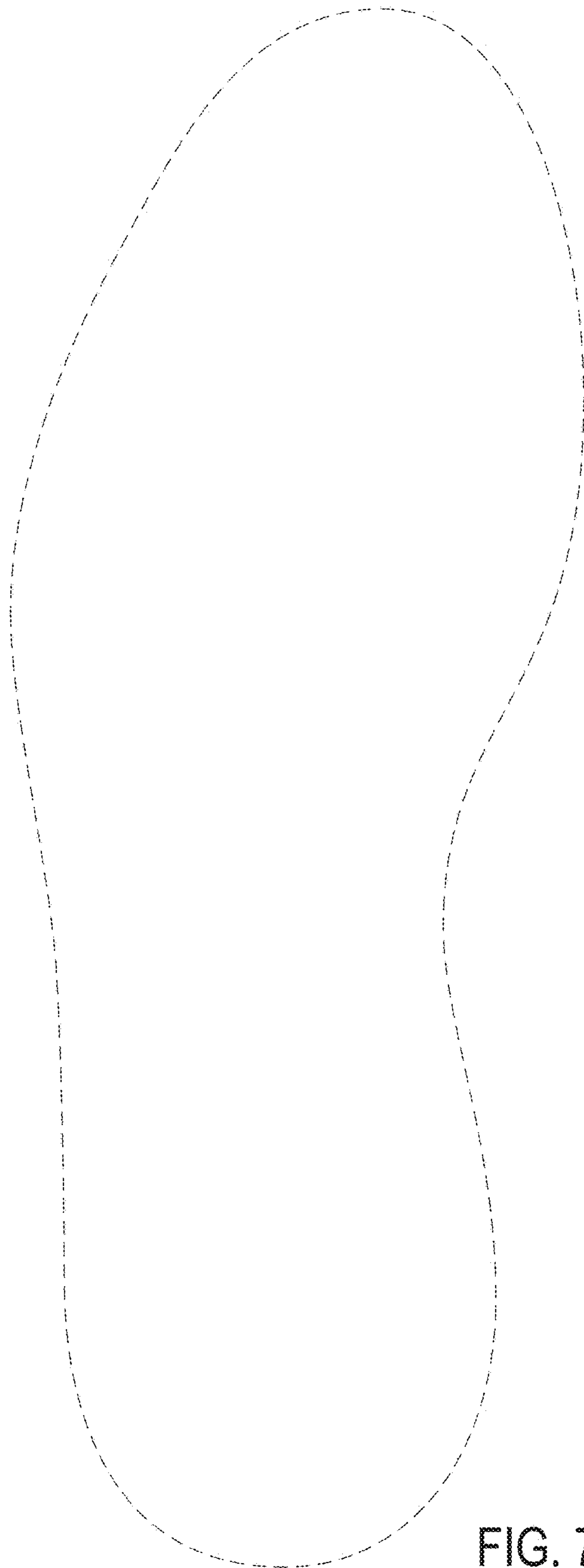

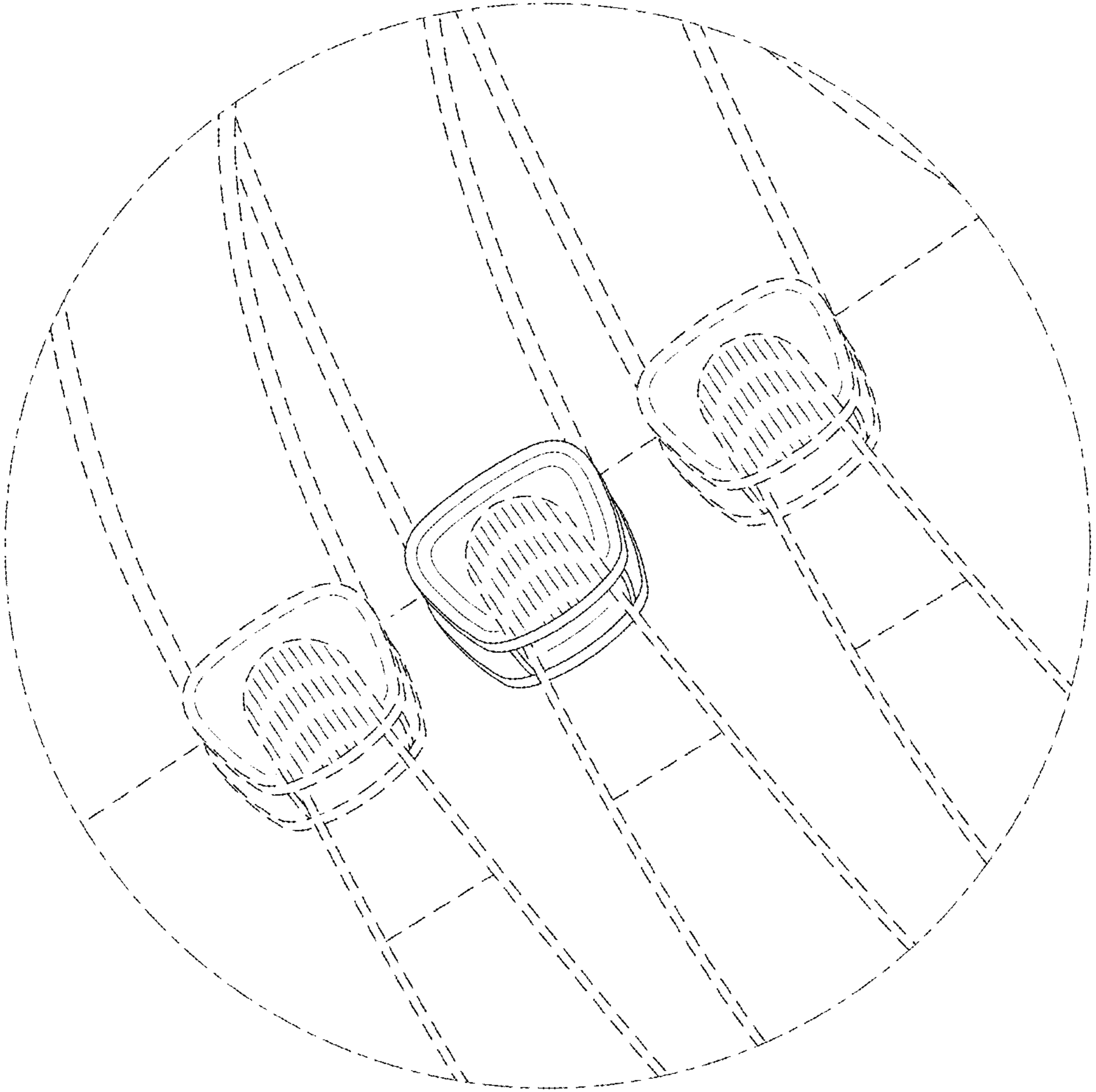
