FIG. 6 is a bottom plan view thereof;

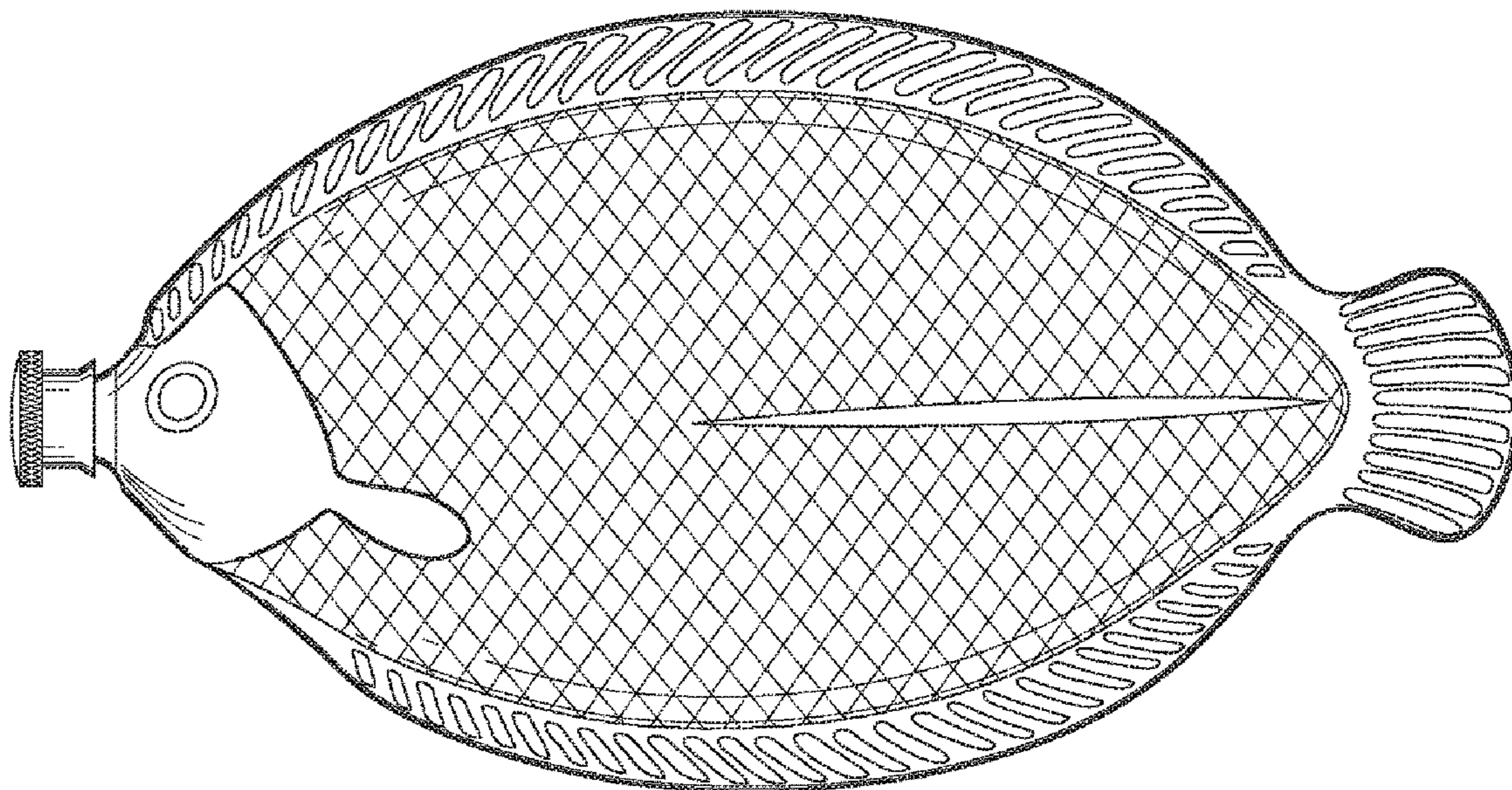
FIG. 7 is a front perspective thereof; and,

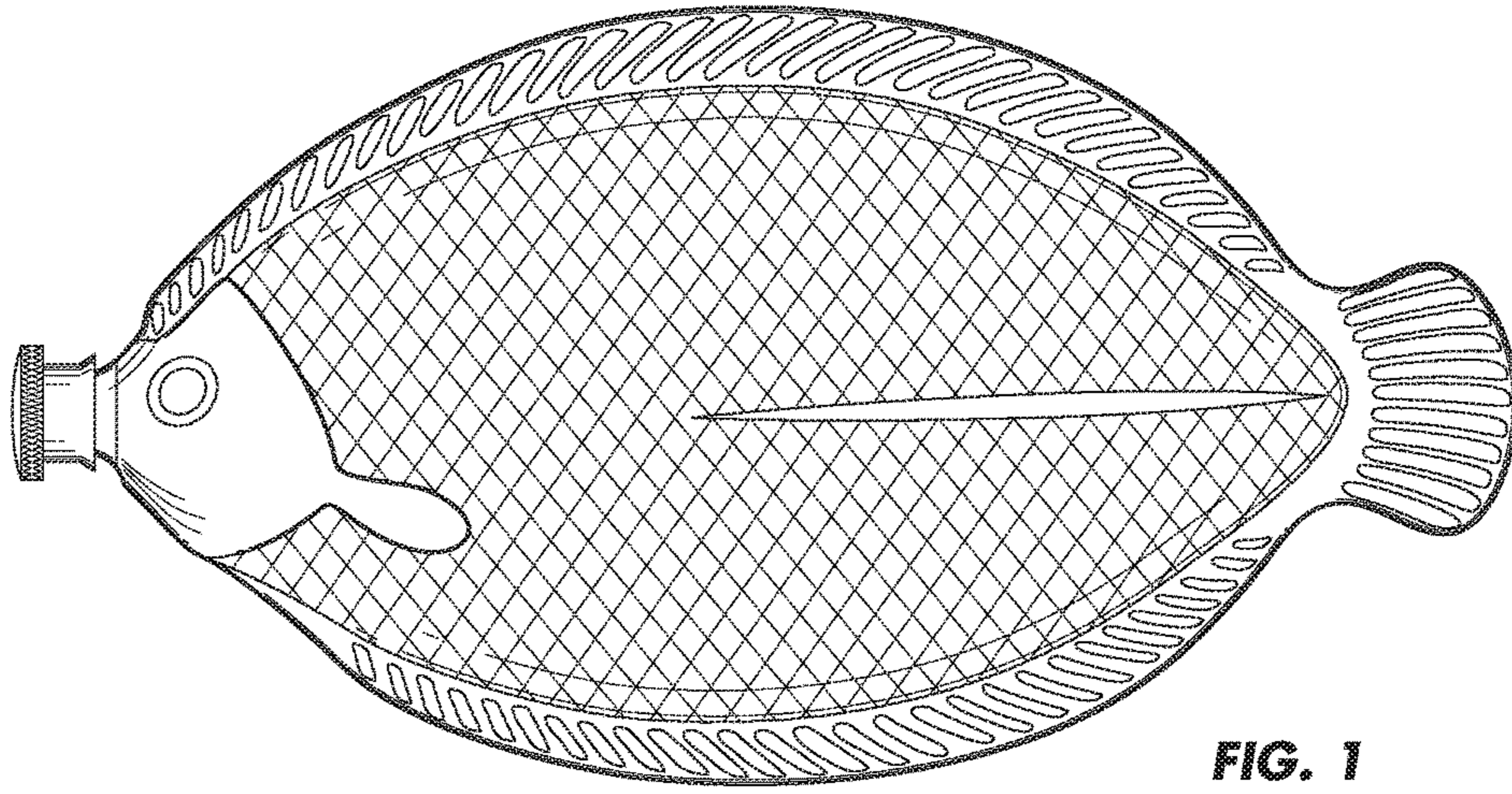

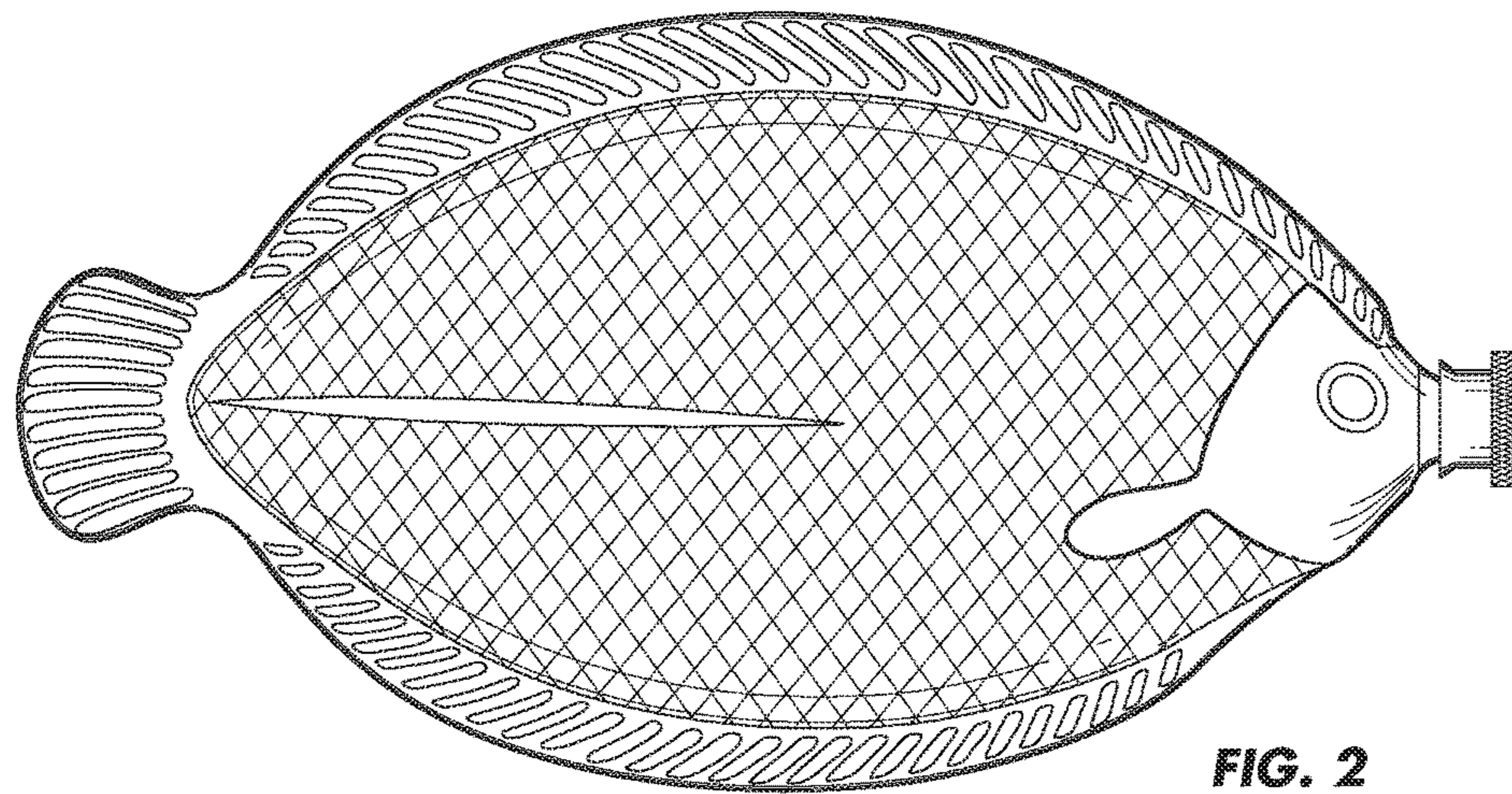

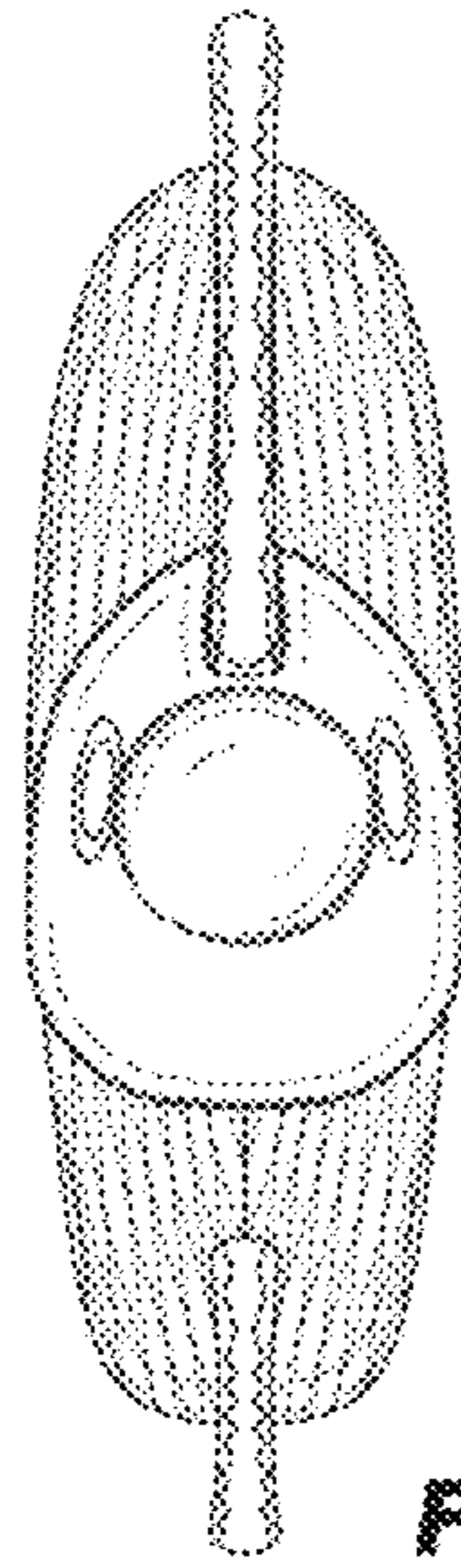

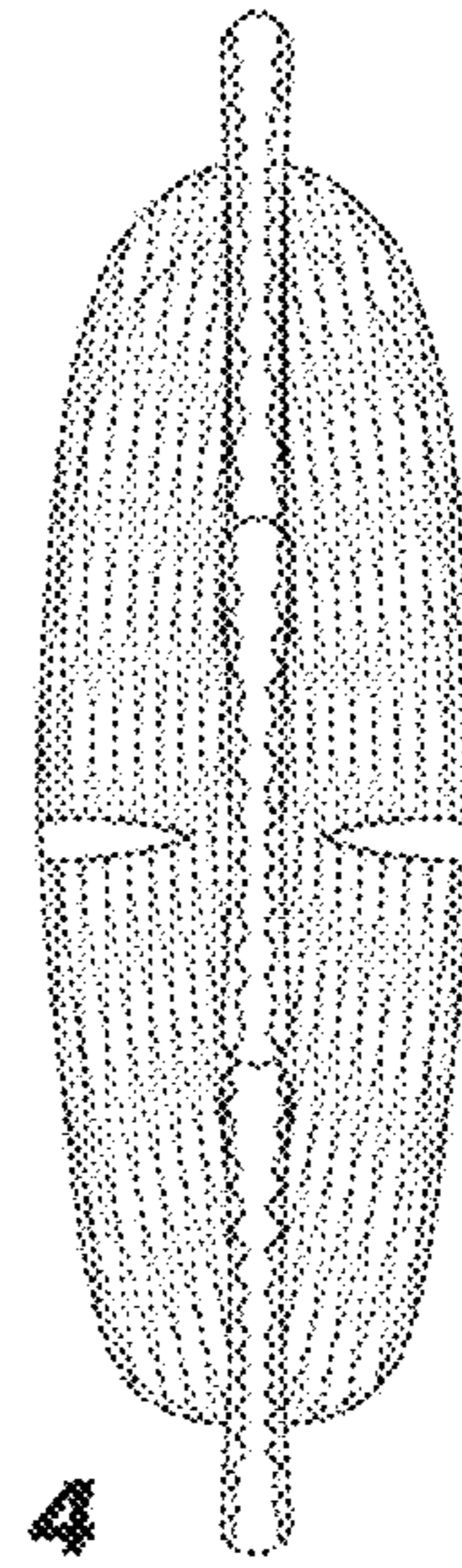

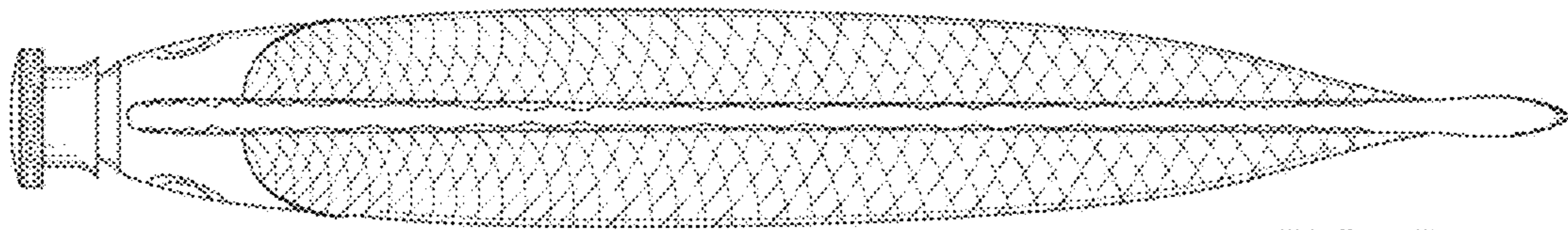

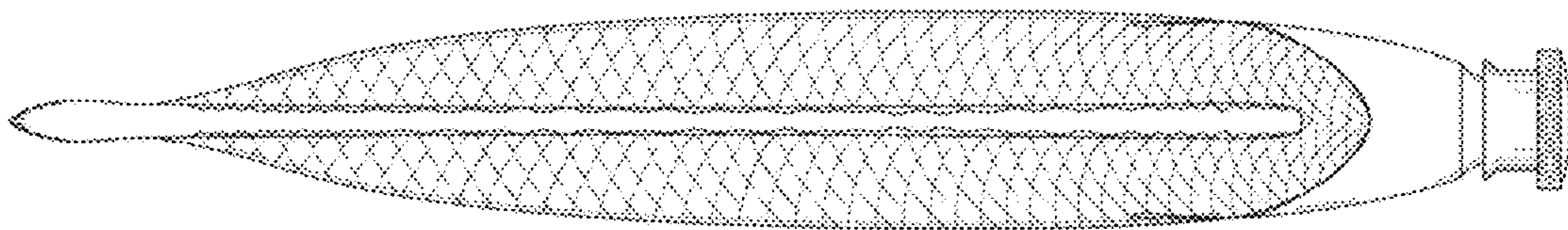

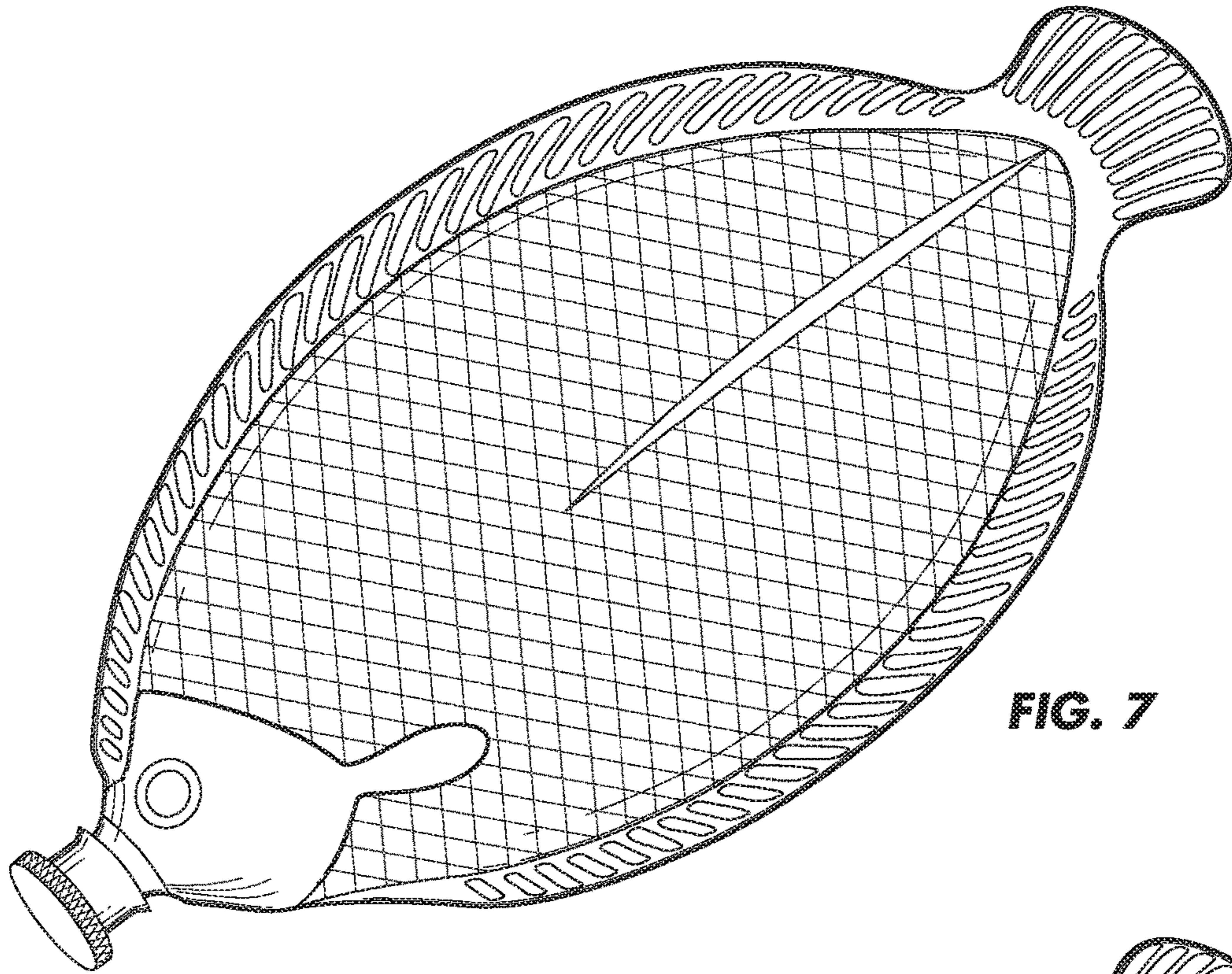

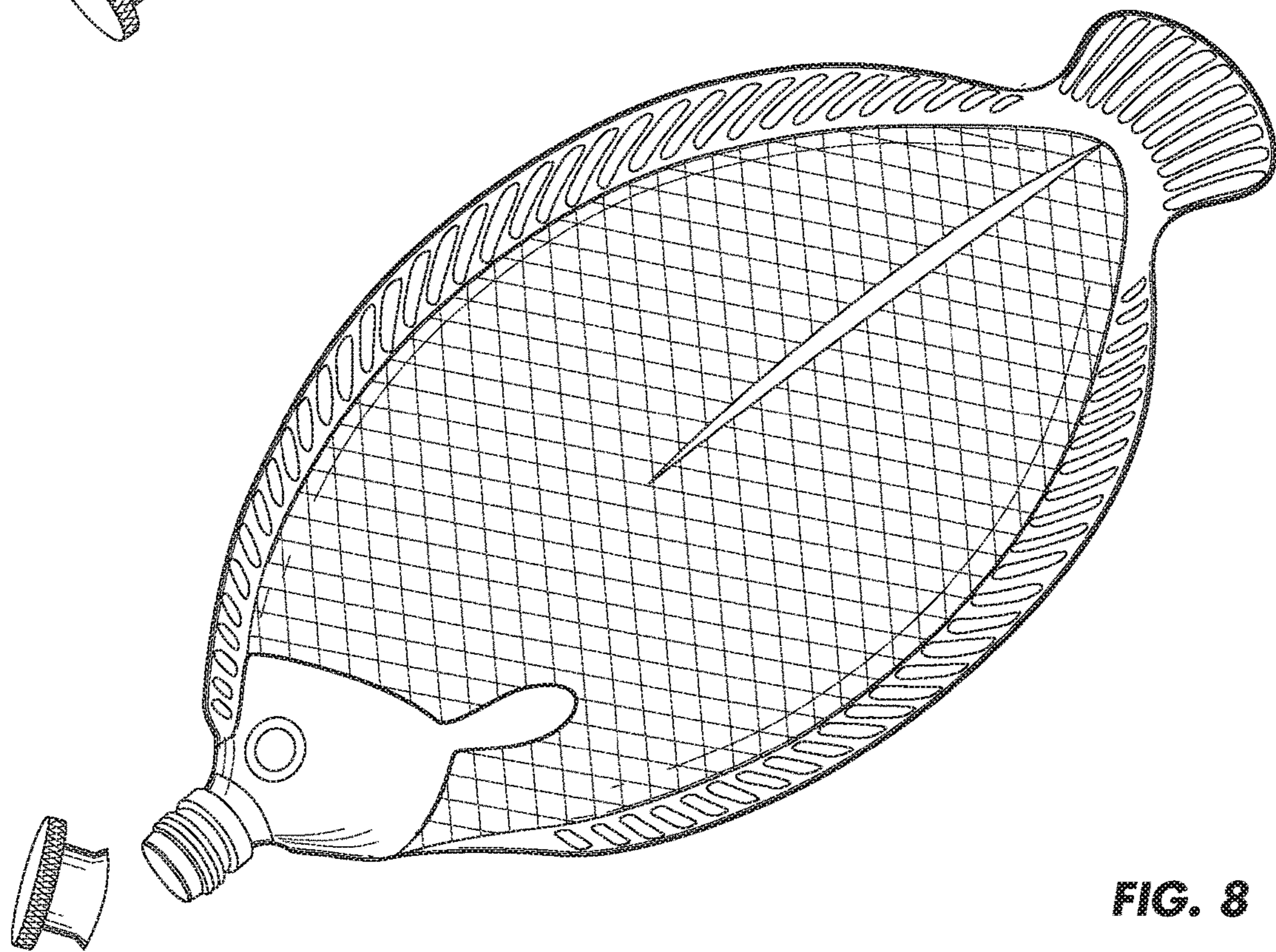
