**DESCRIPTION**

FIG. 1 is a front perspective view of the kitchen furniture according to a first embodiment of the present invention;

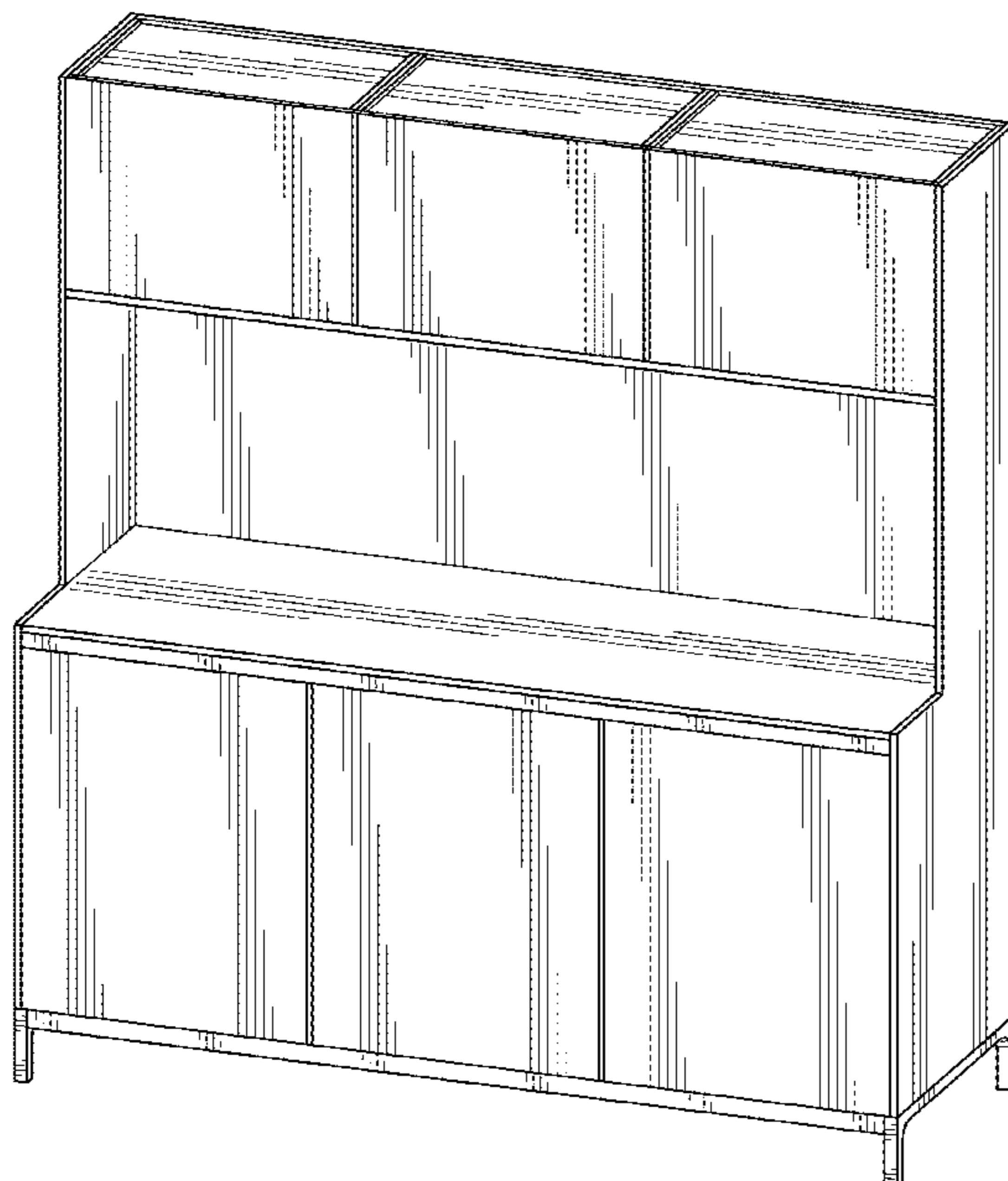

FIG. 19 is a front perspective view of the kitchen furniture according to a fourth embodiment of the present invention;

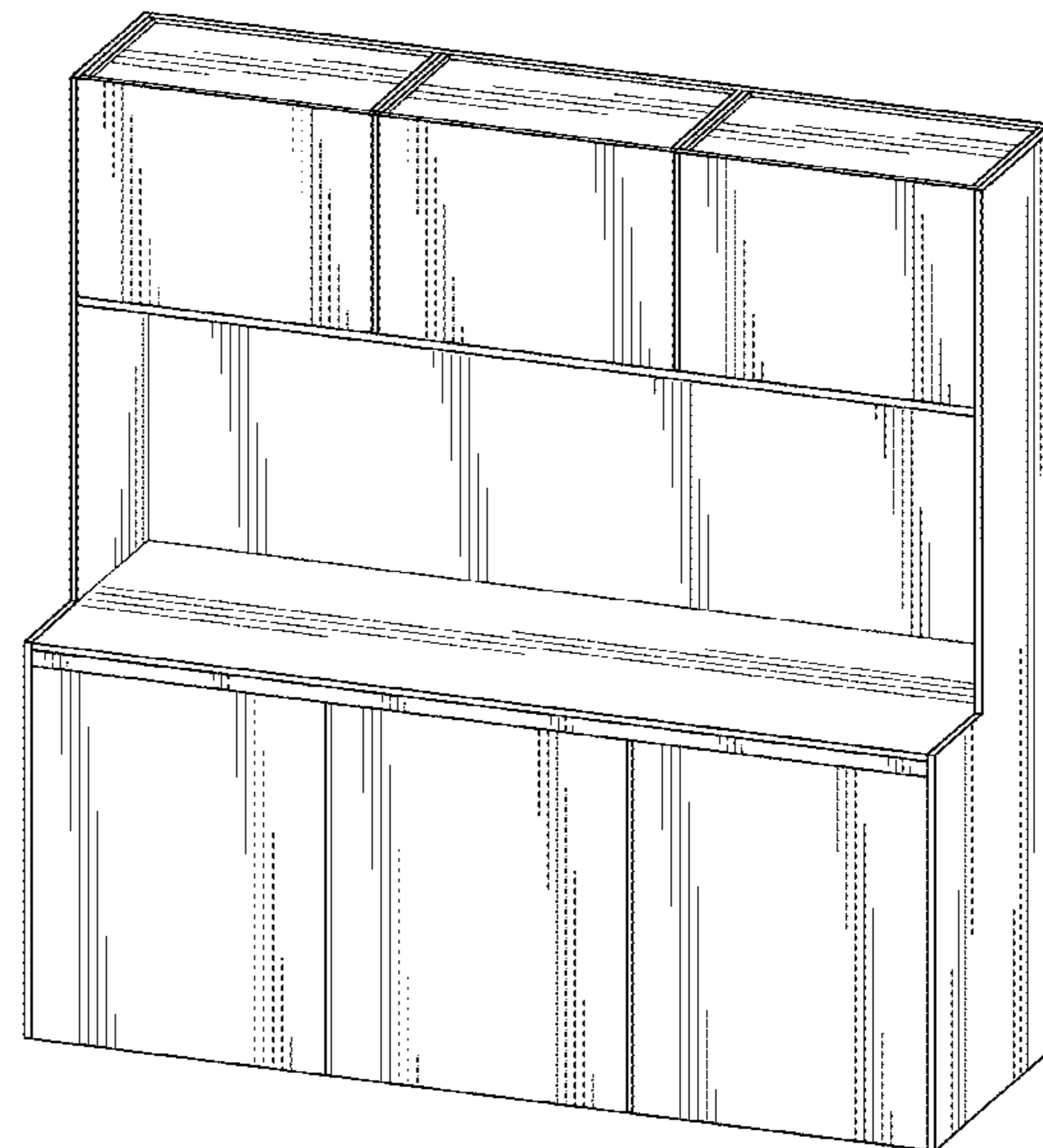
FIG. 20 is a front view of the kitchen furniture of FIG. 19; FIG. 21 is a left side view of the kitchen furniture of FIG. 19;

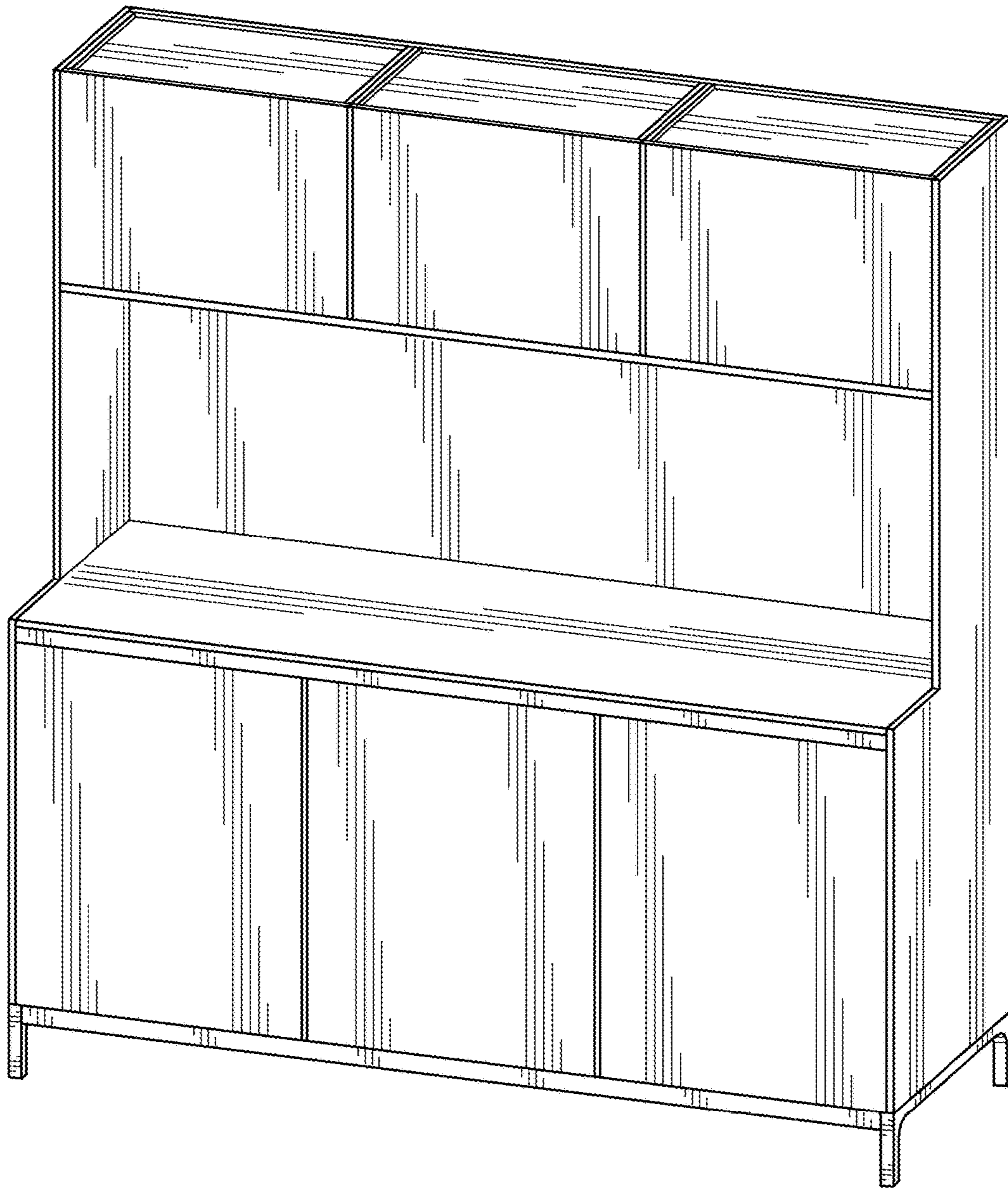

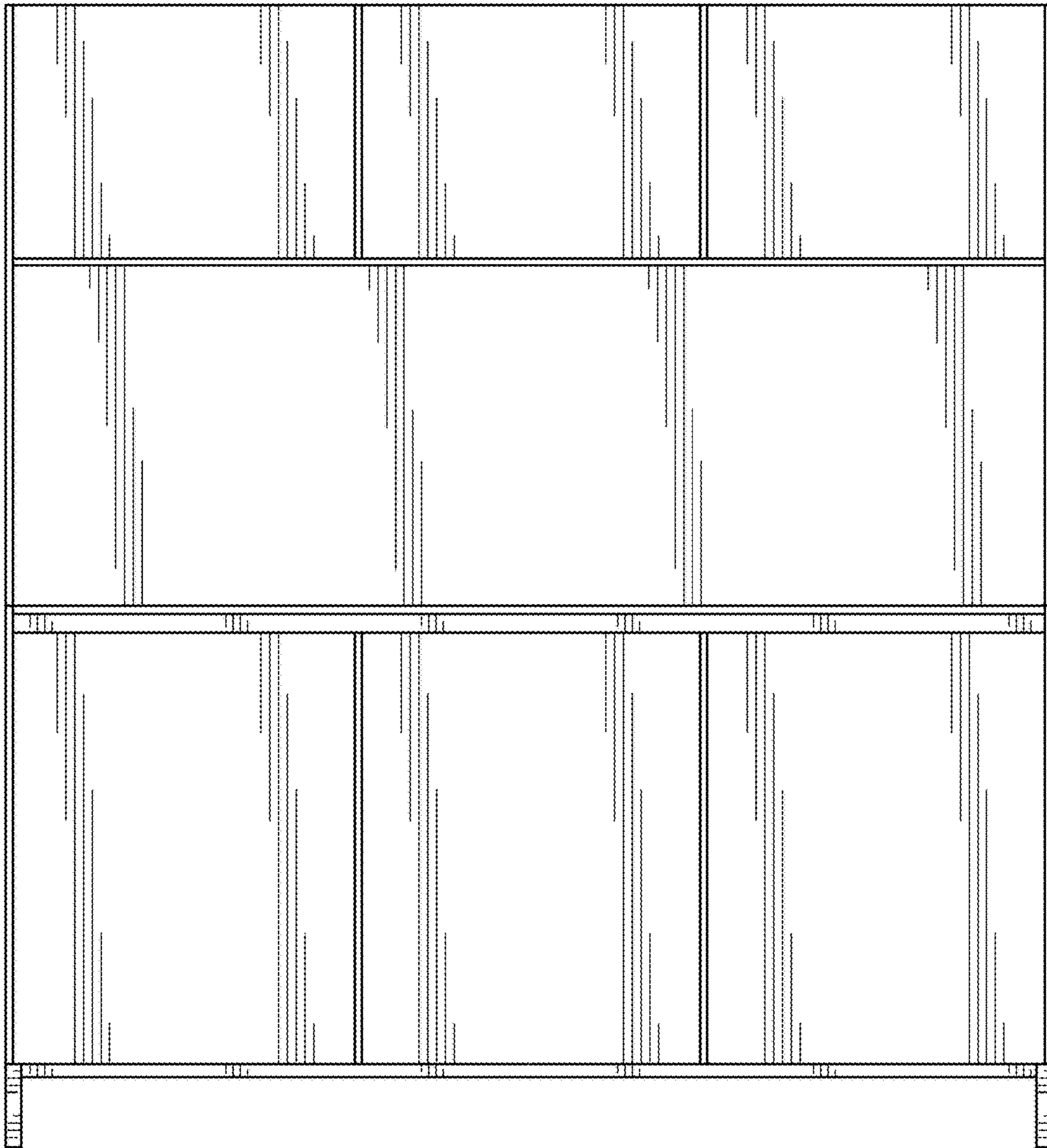

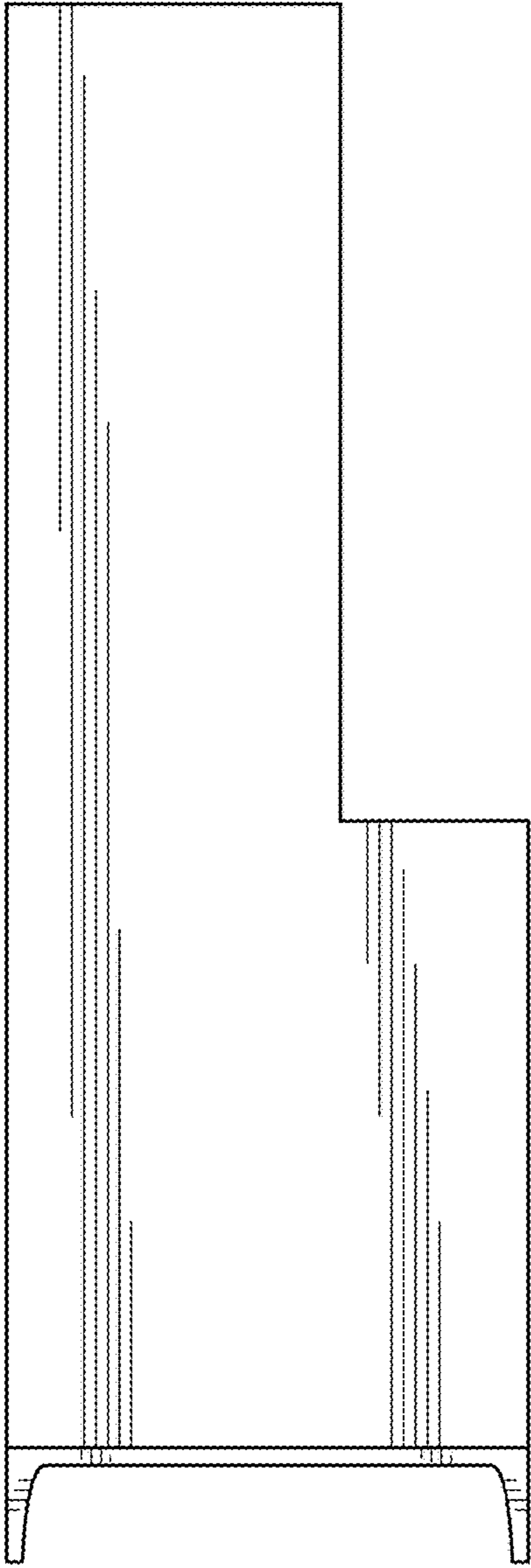

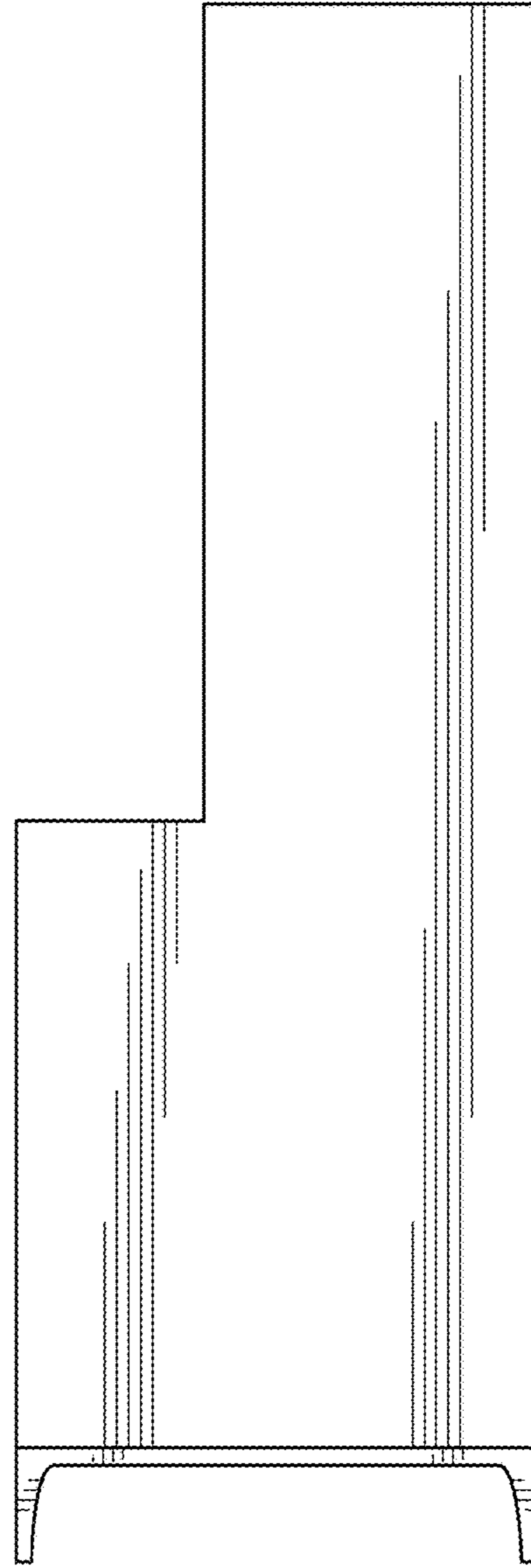

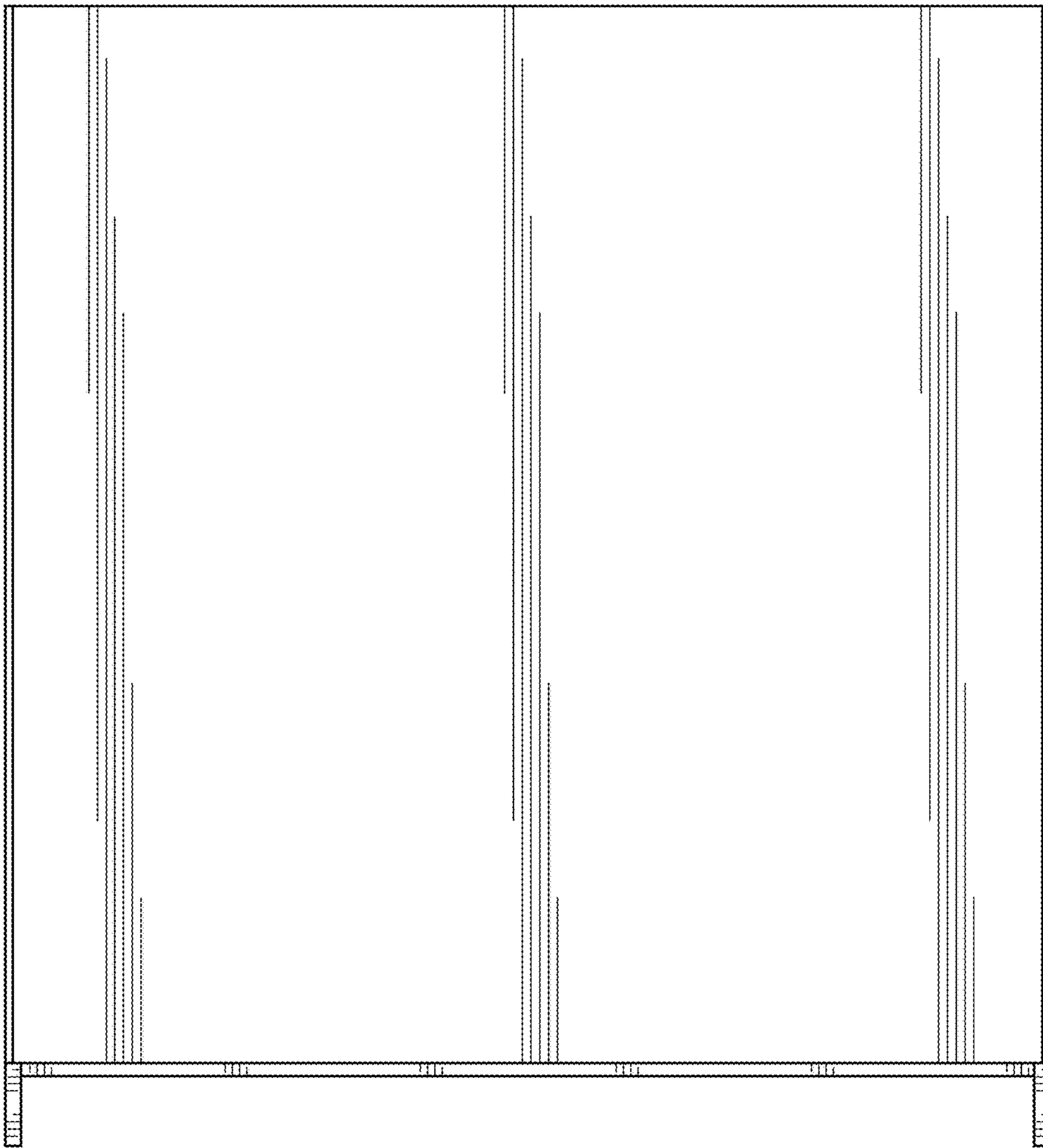

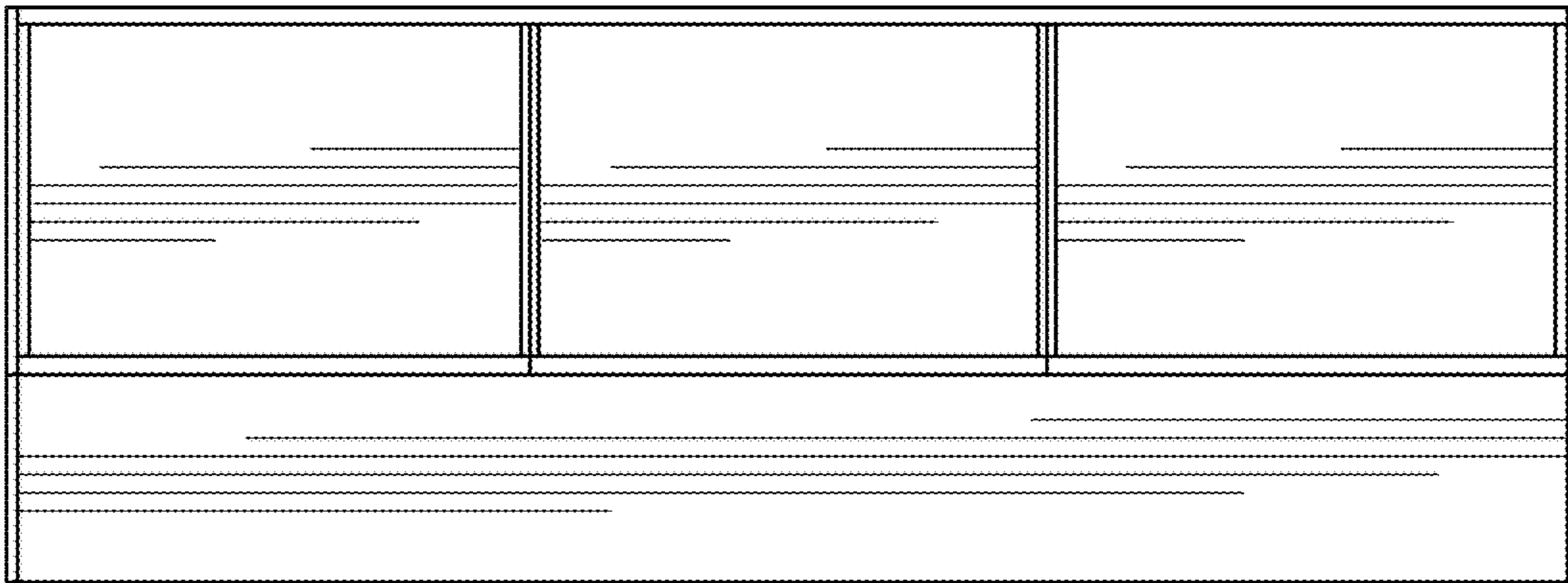

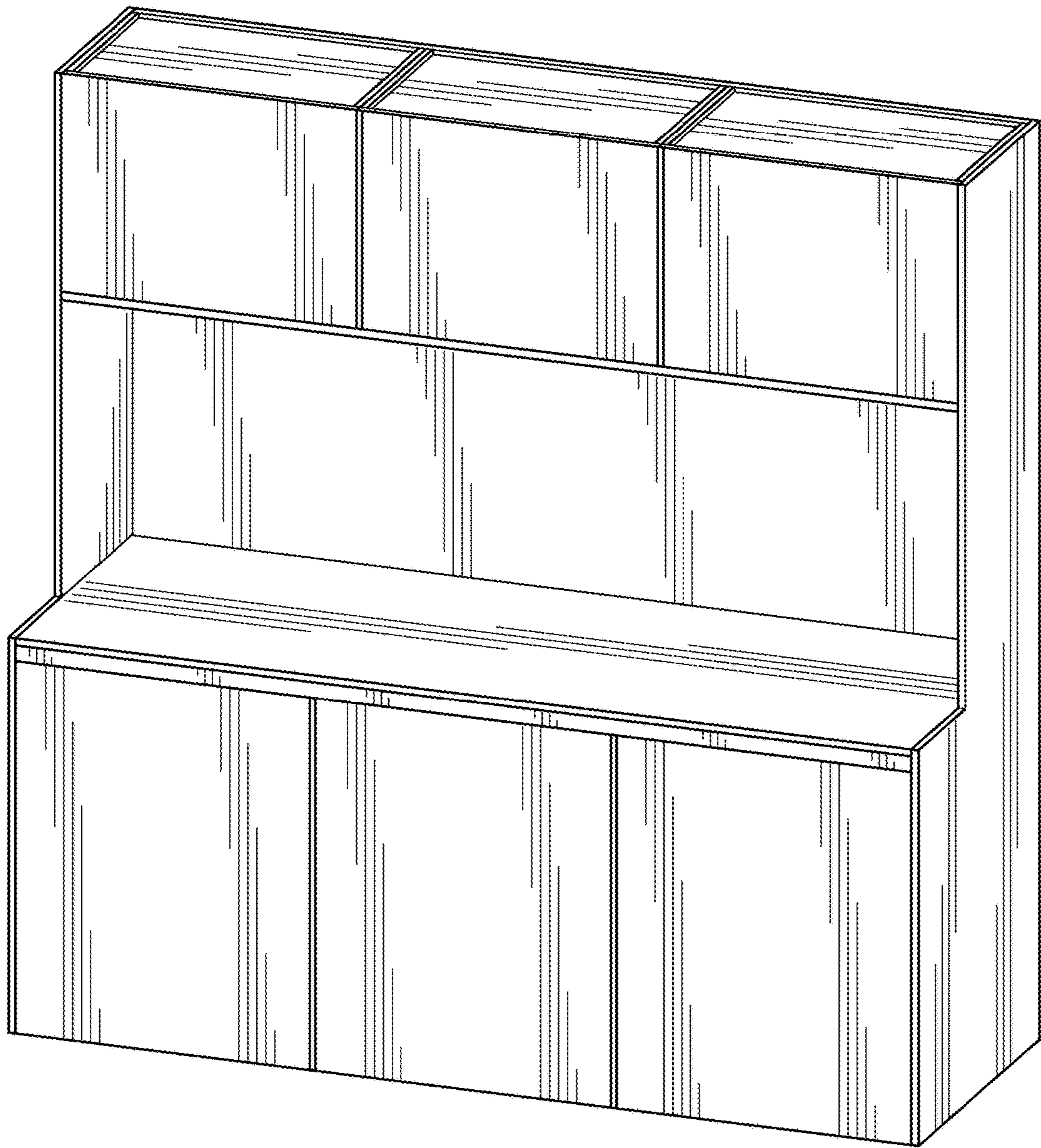

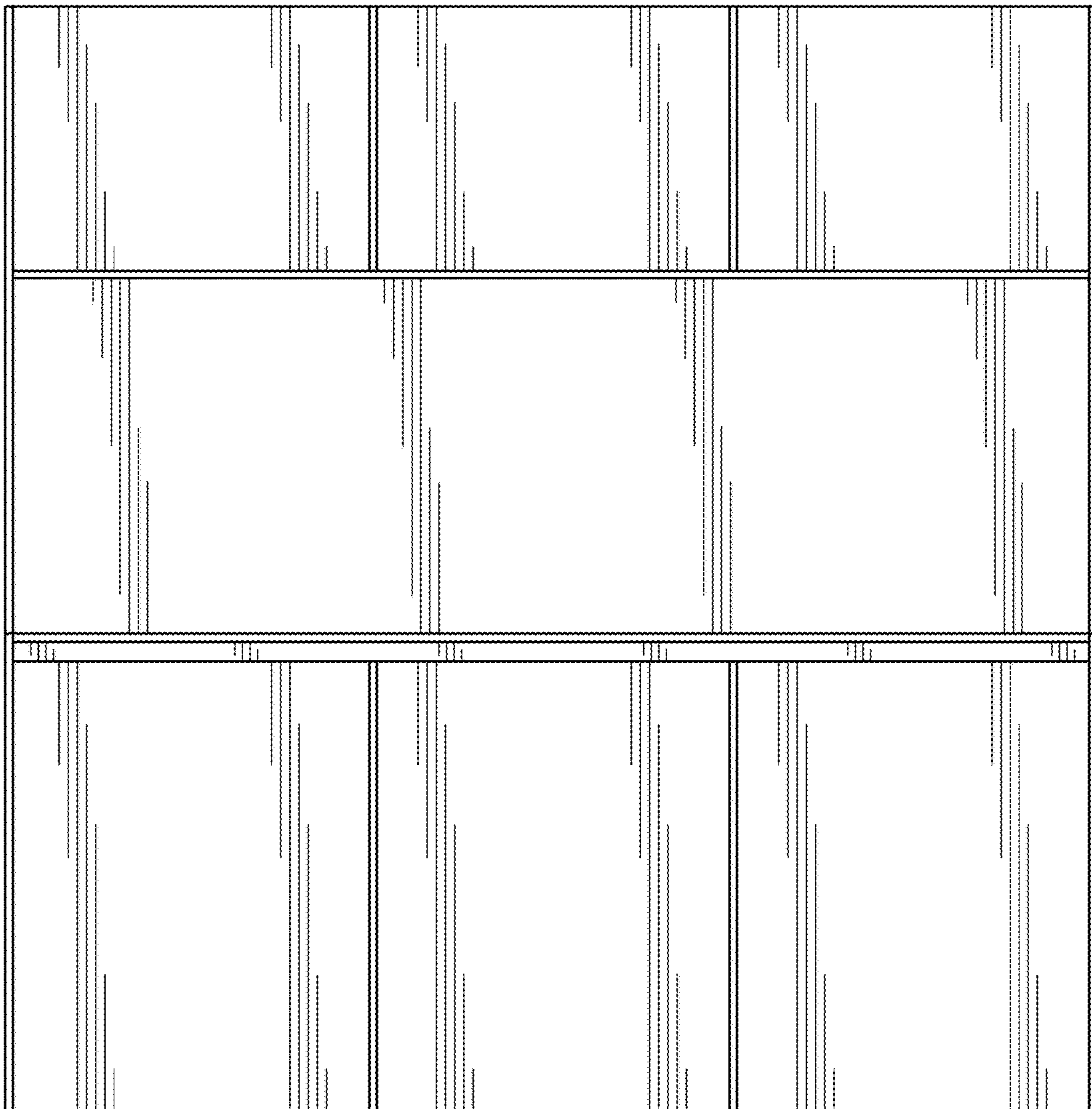

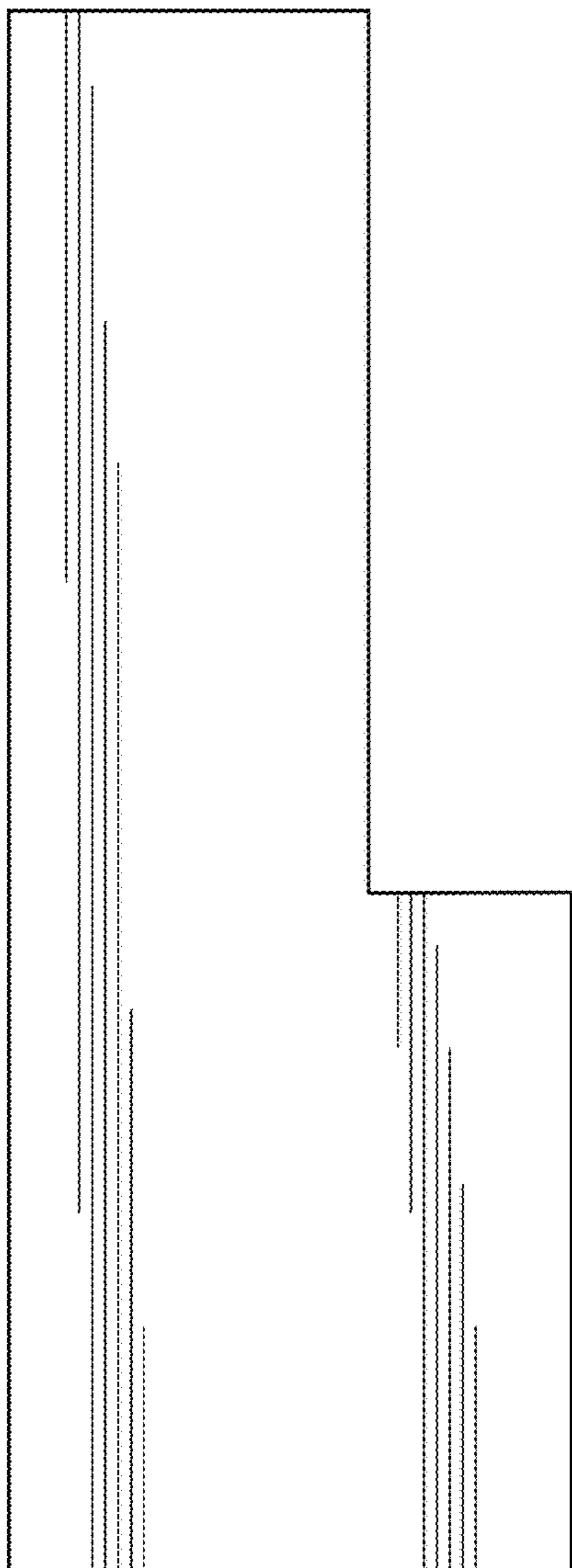

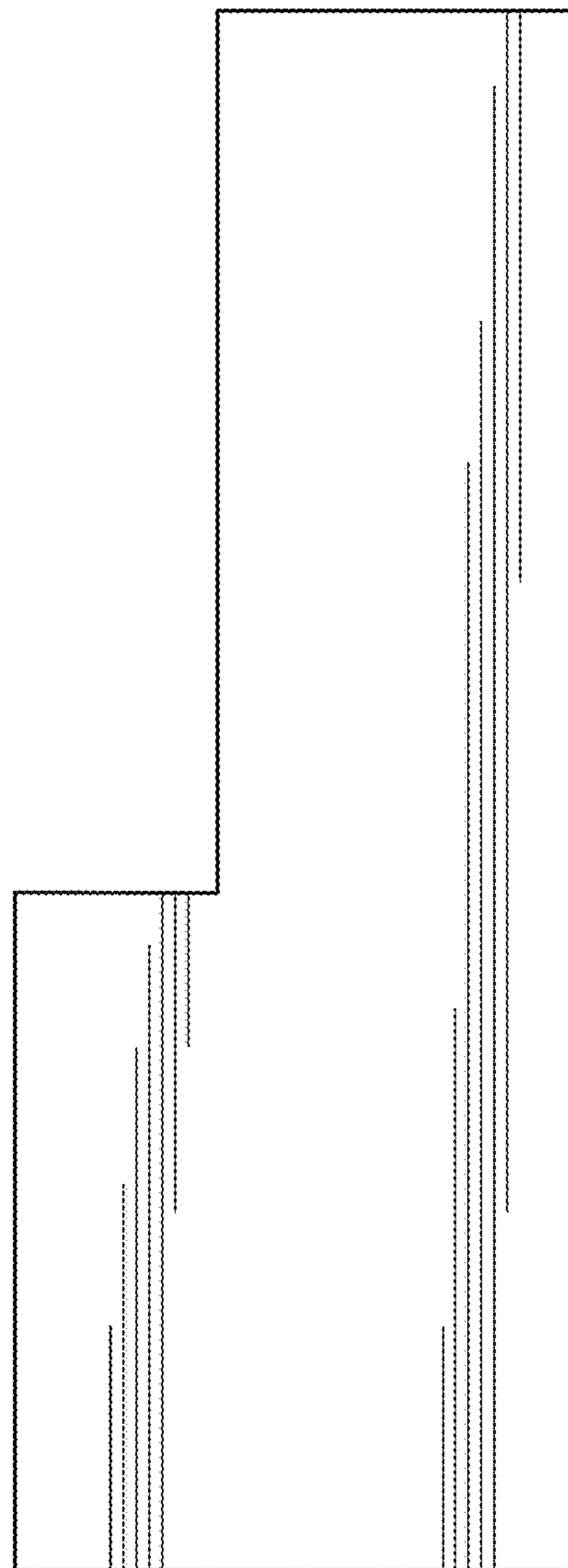

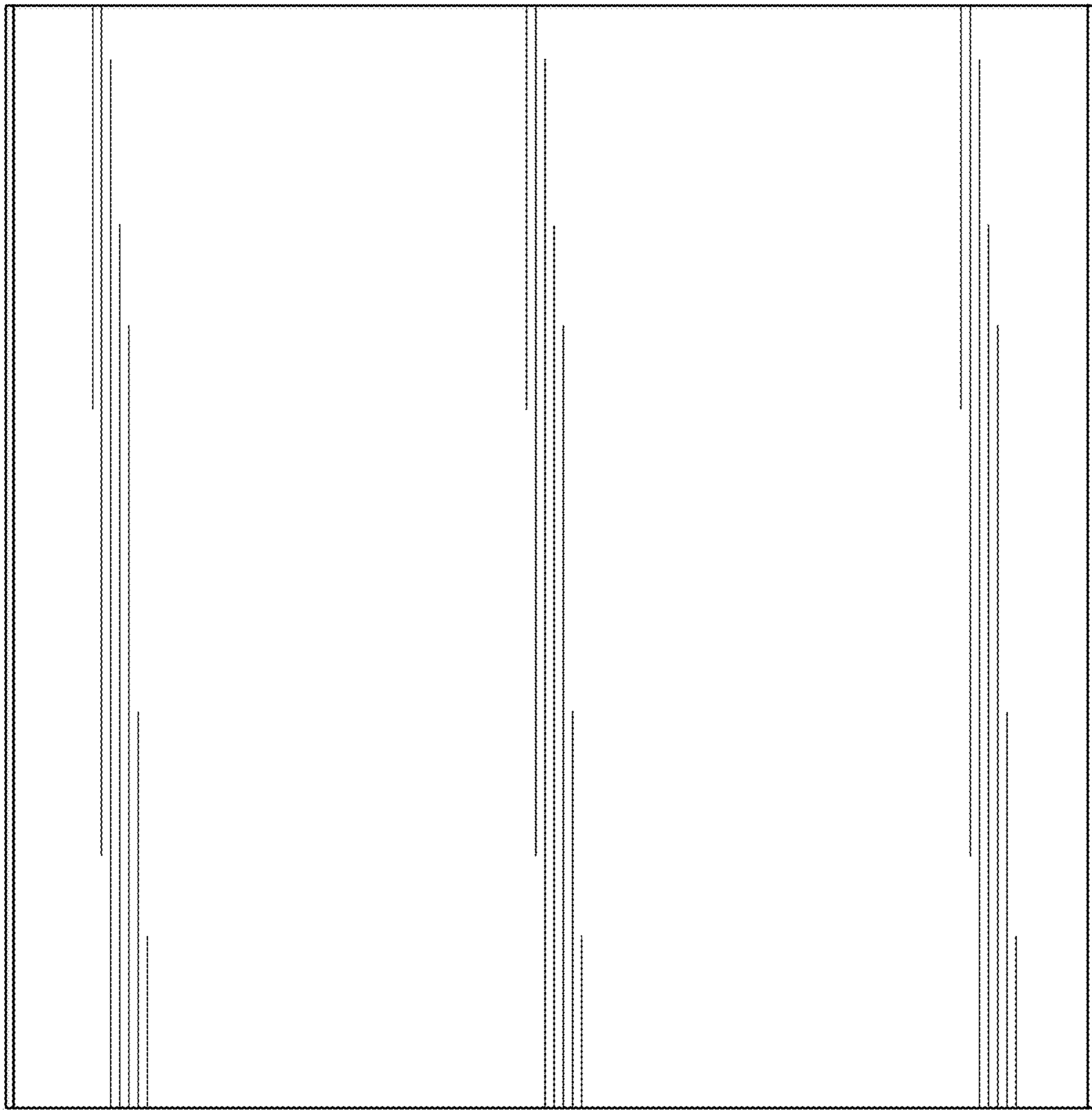

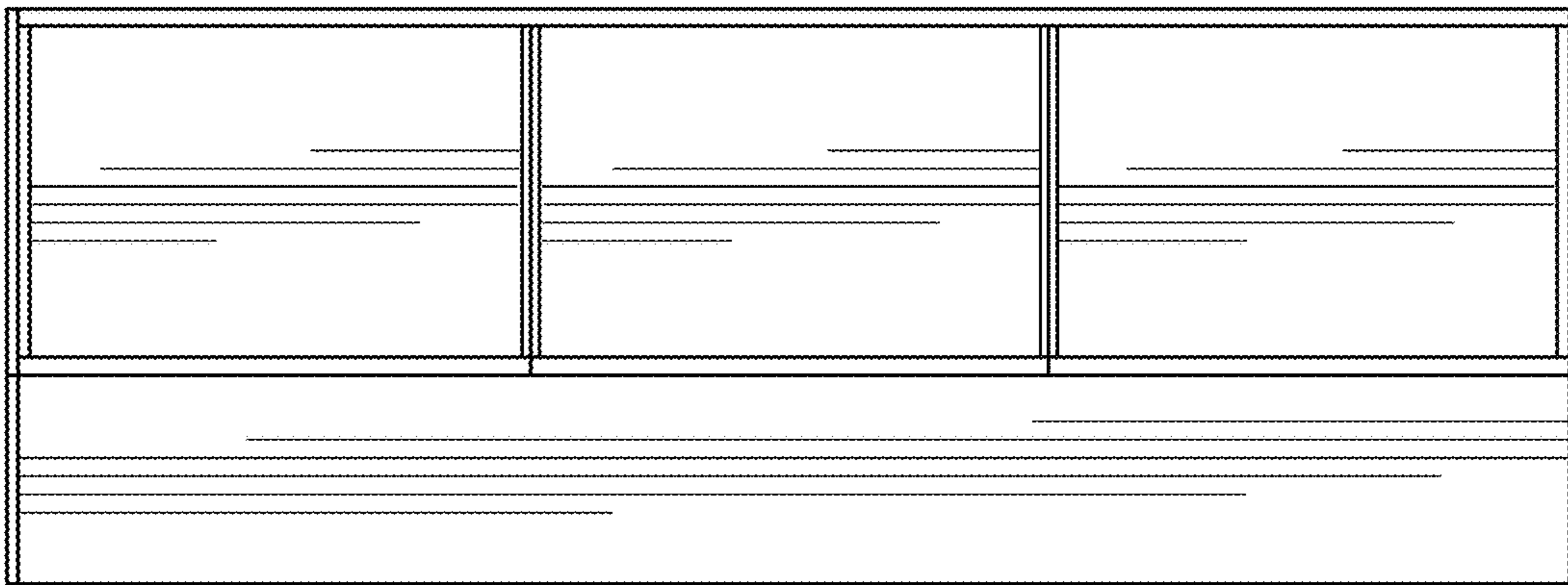

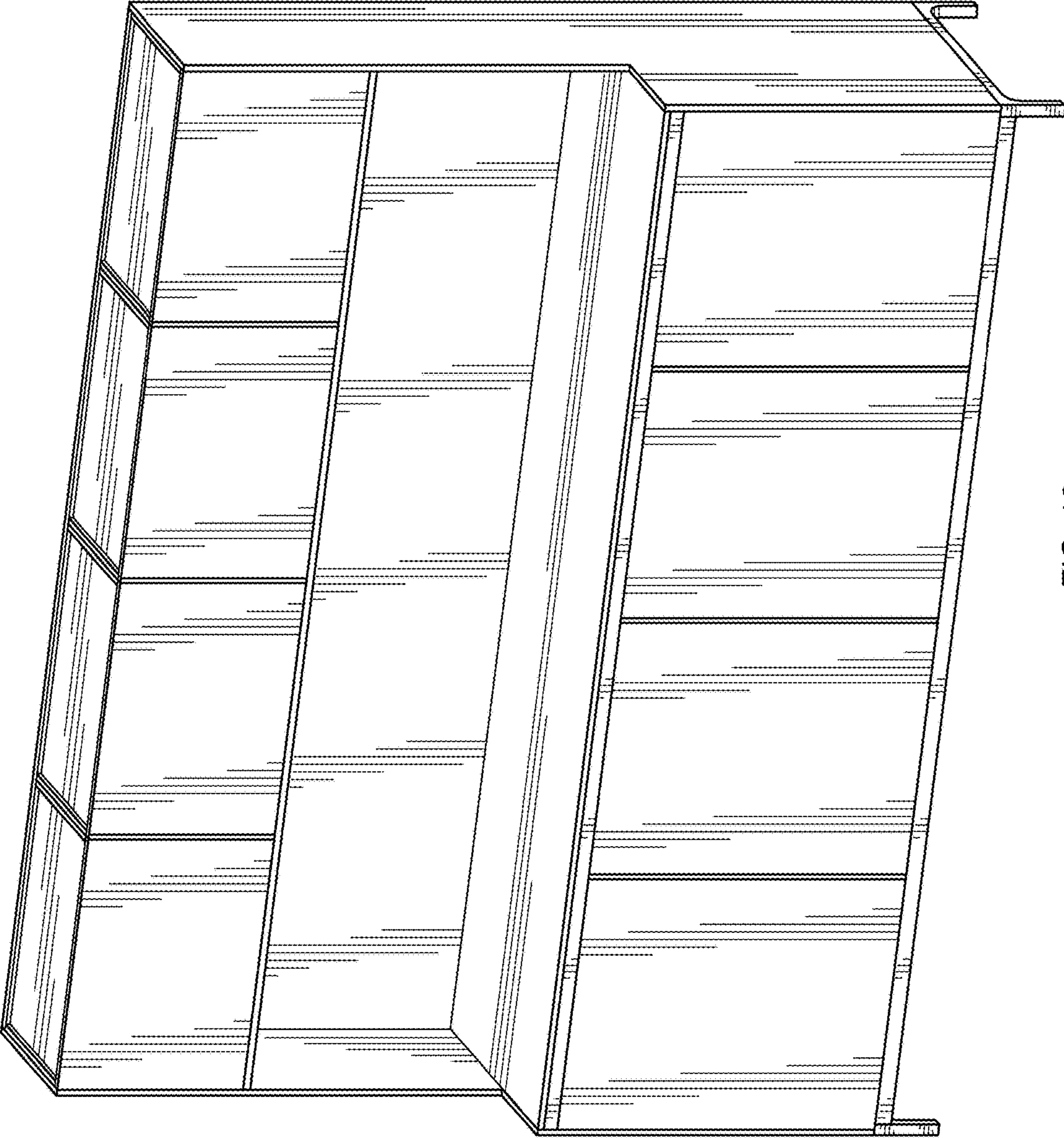

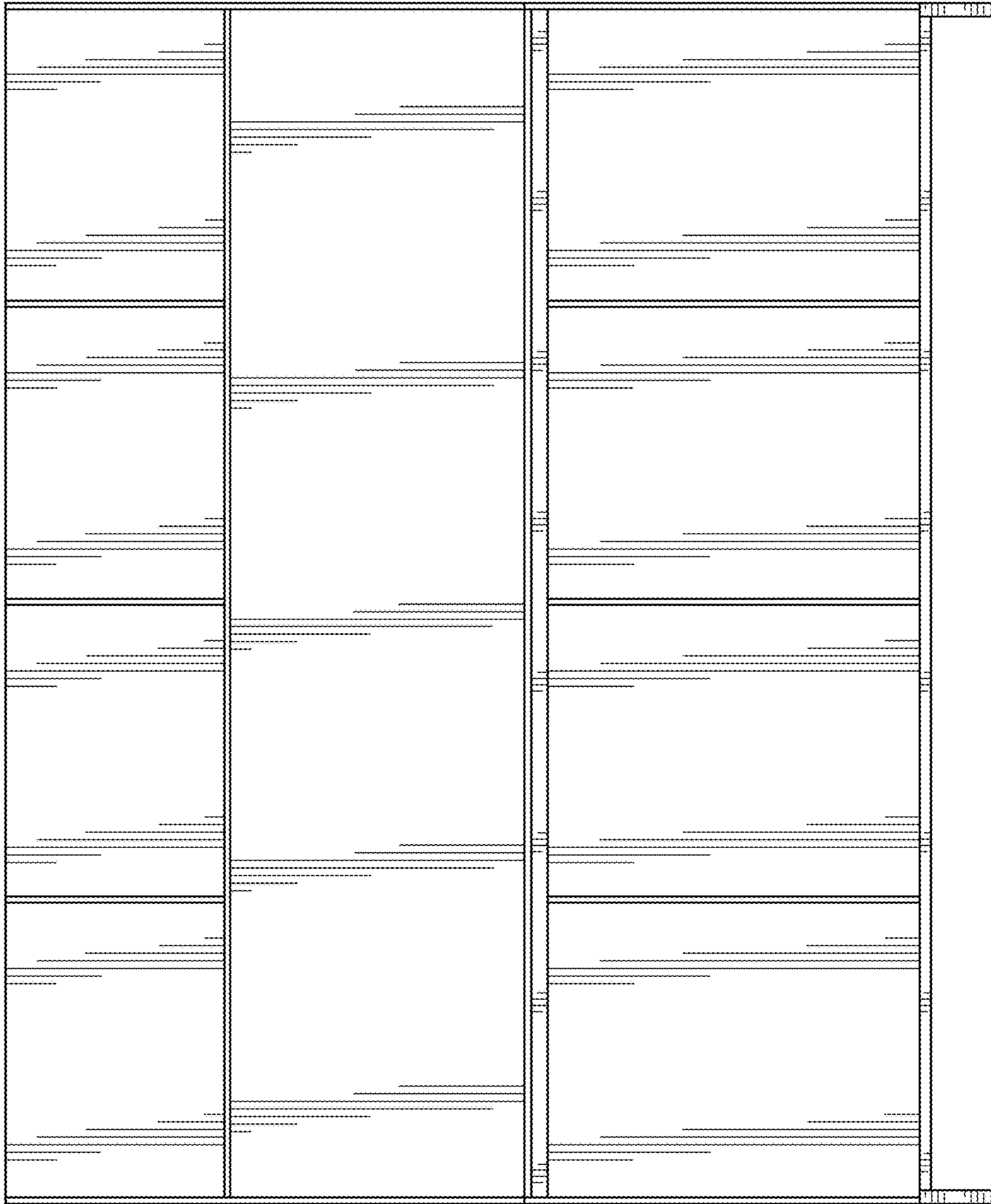

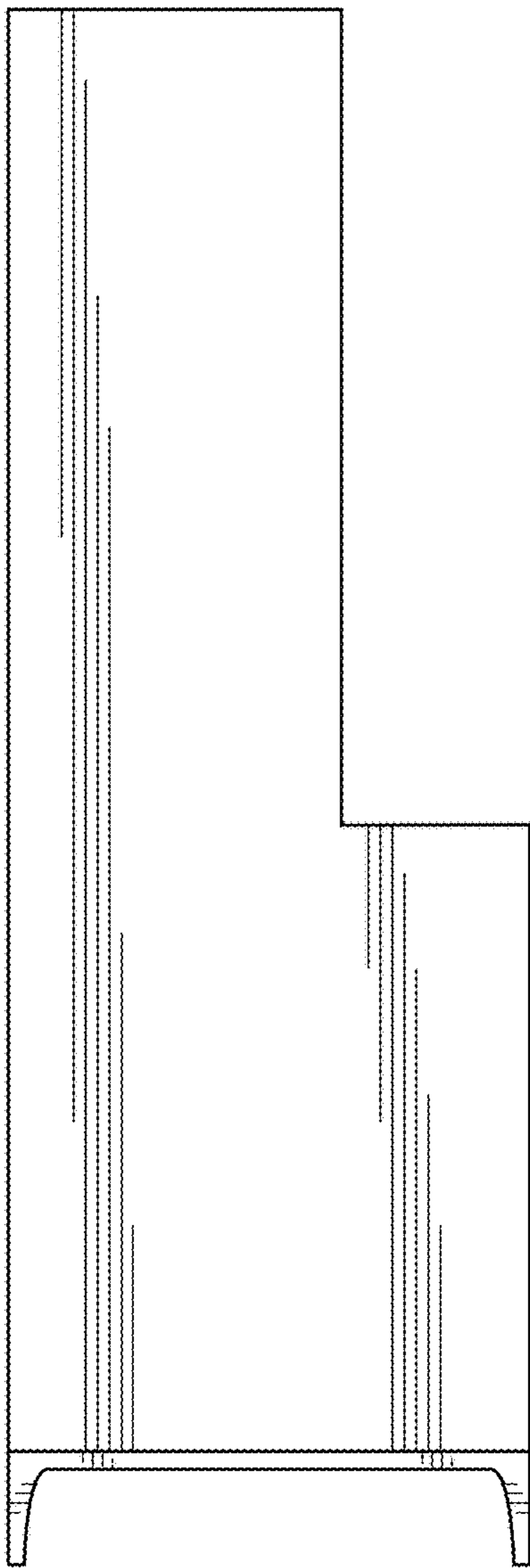

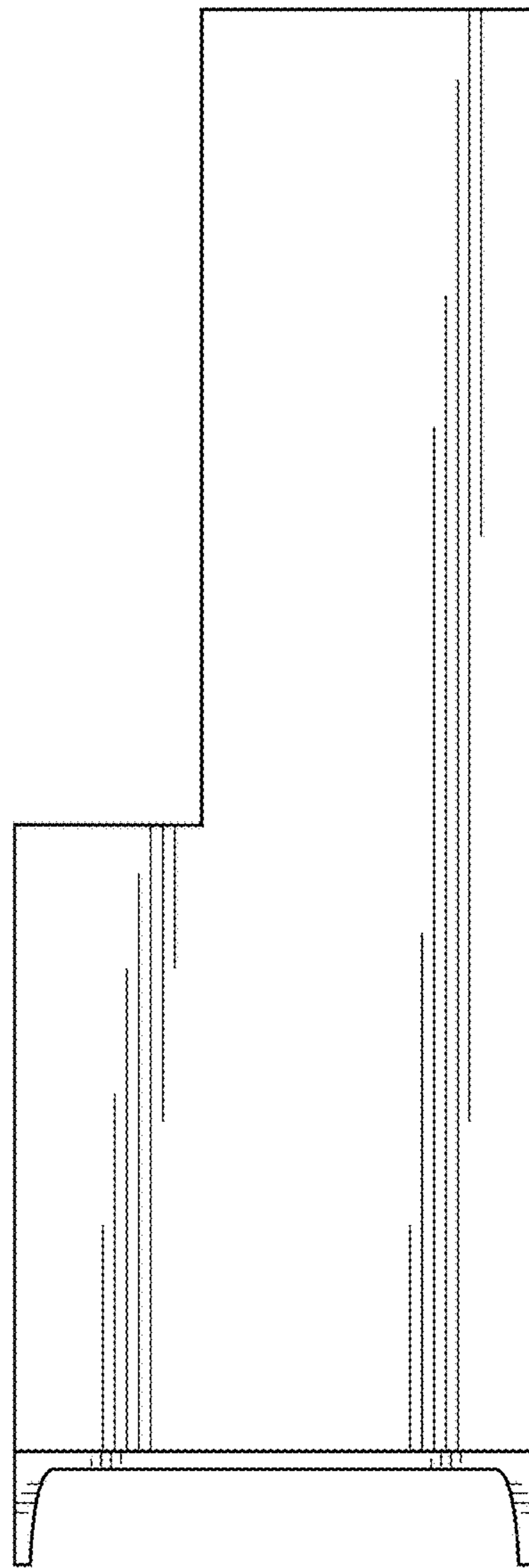

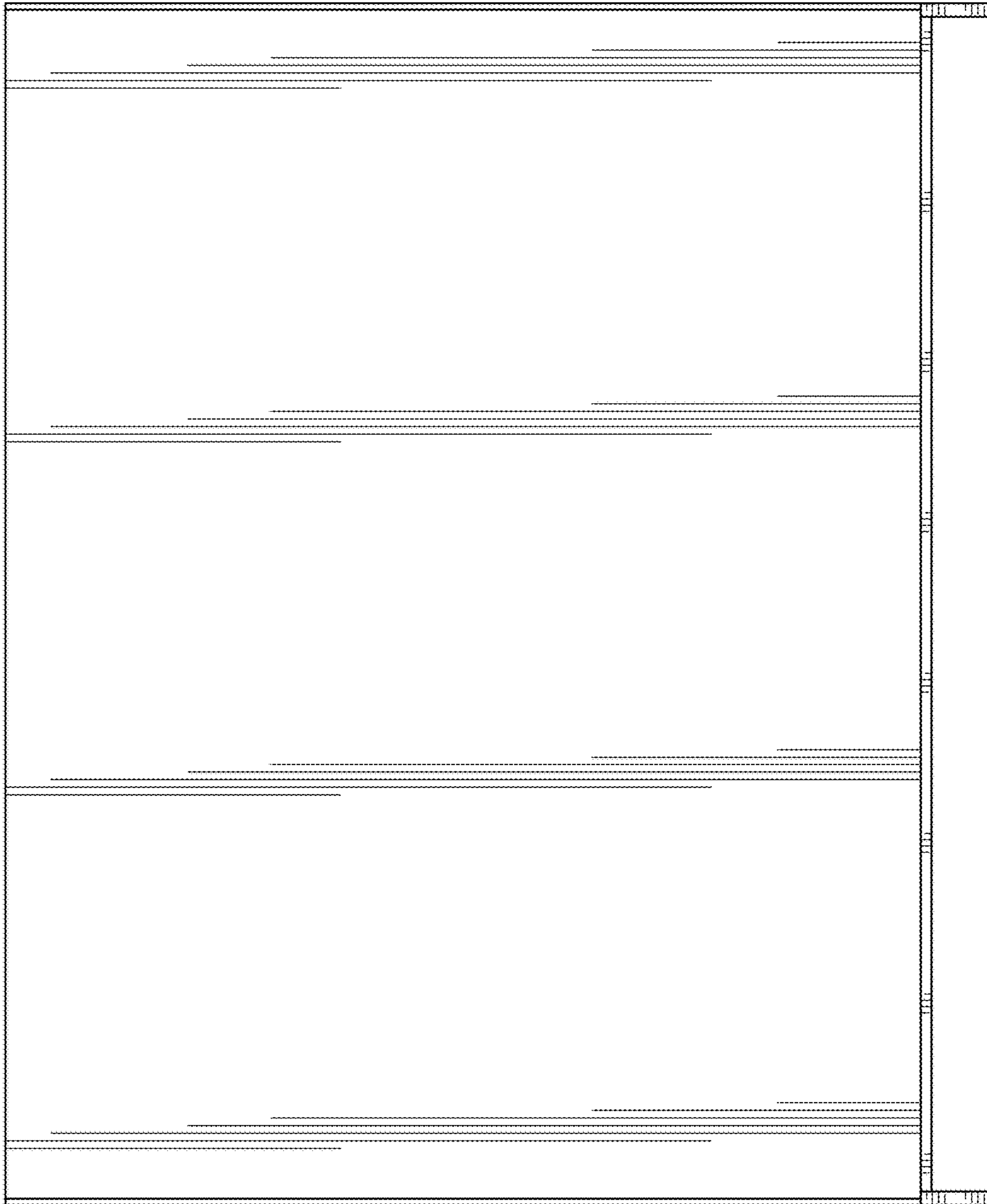

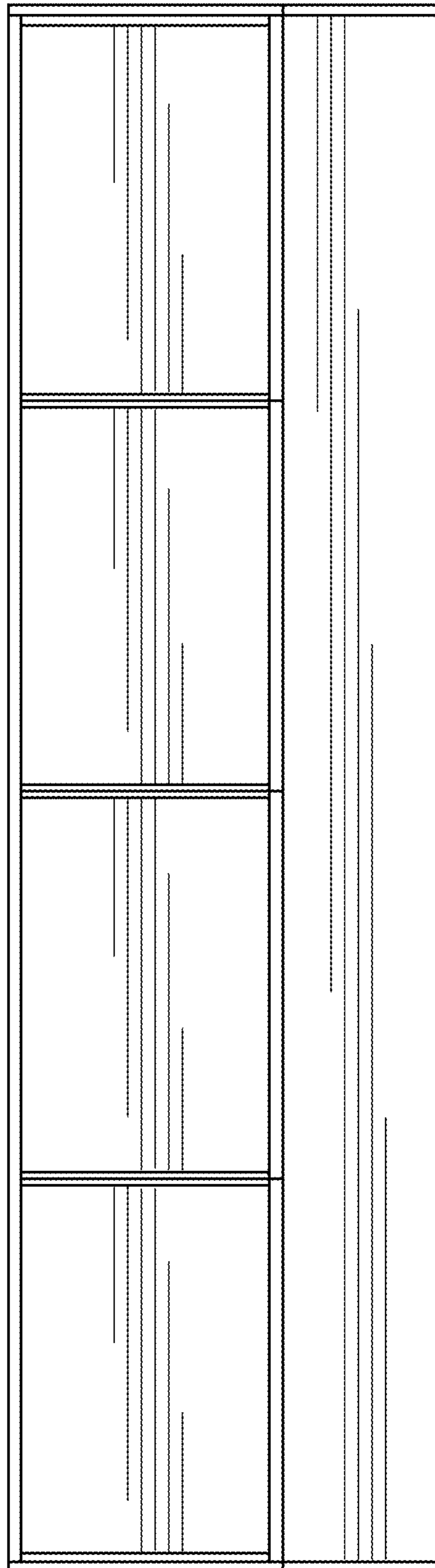

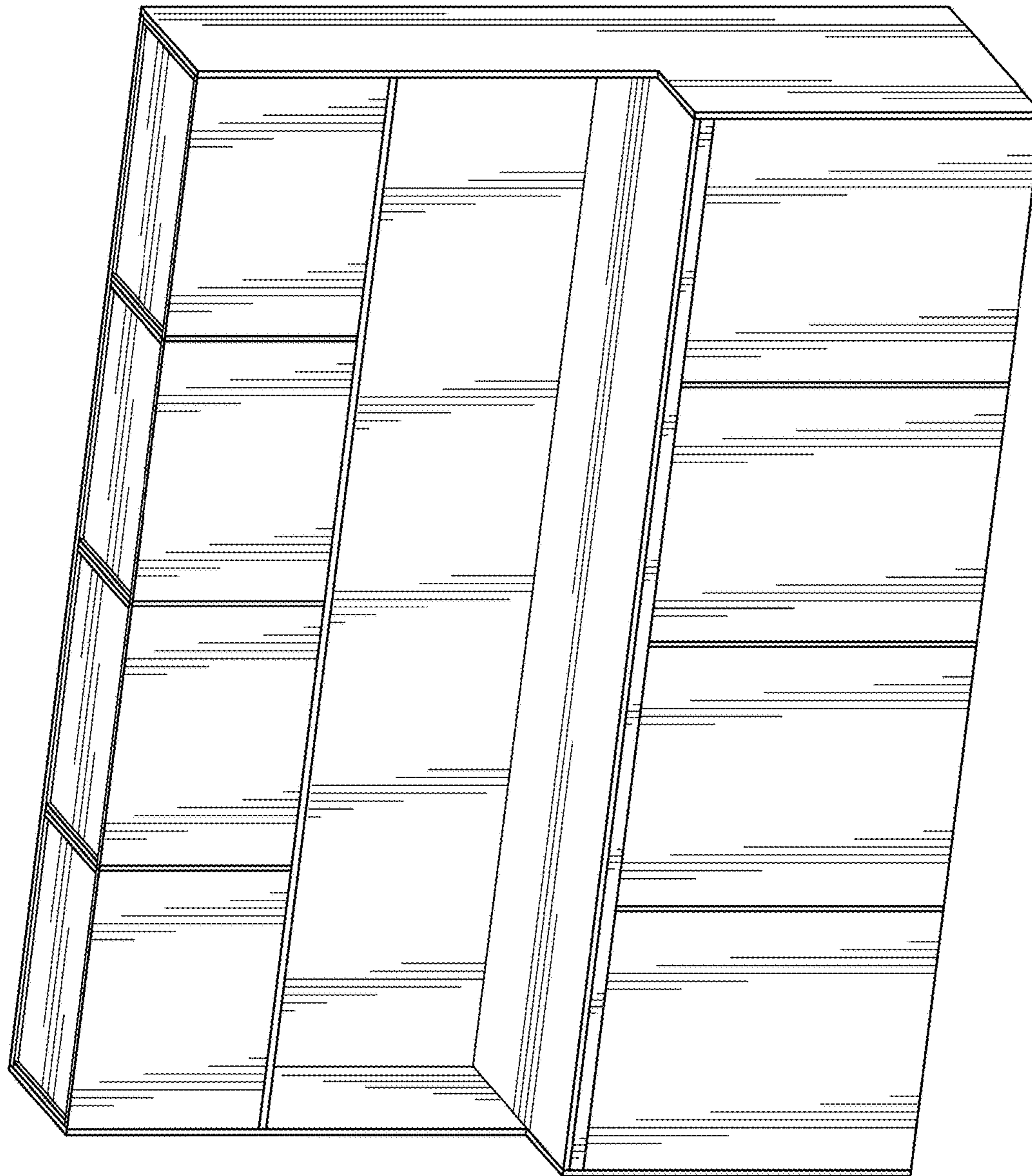

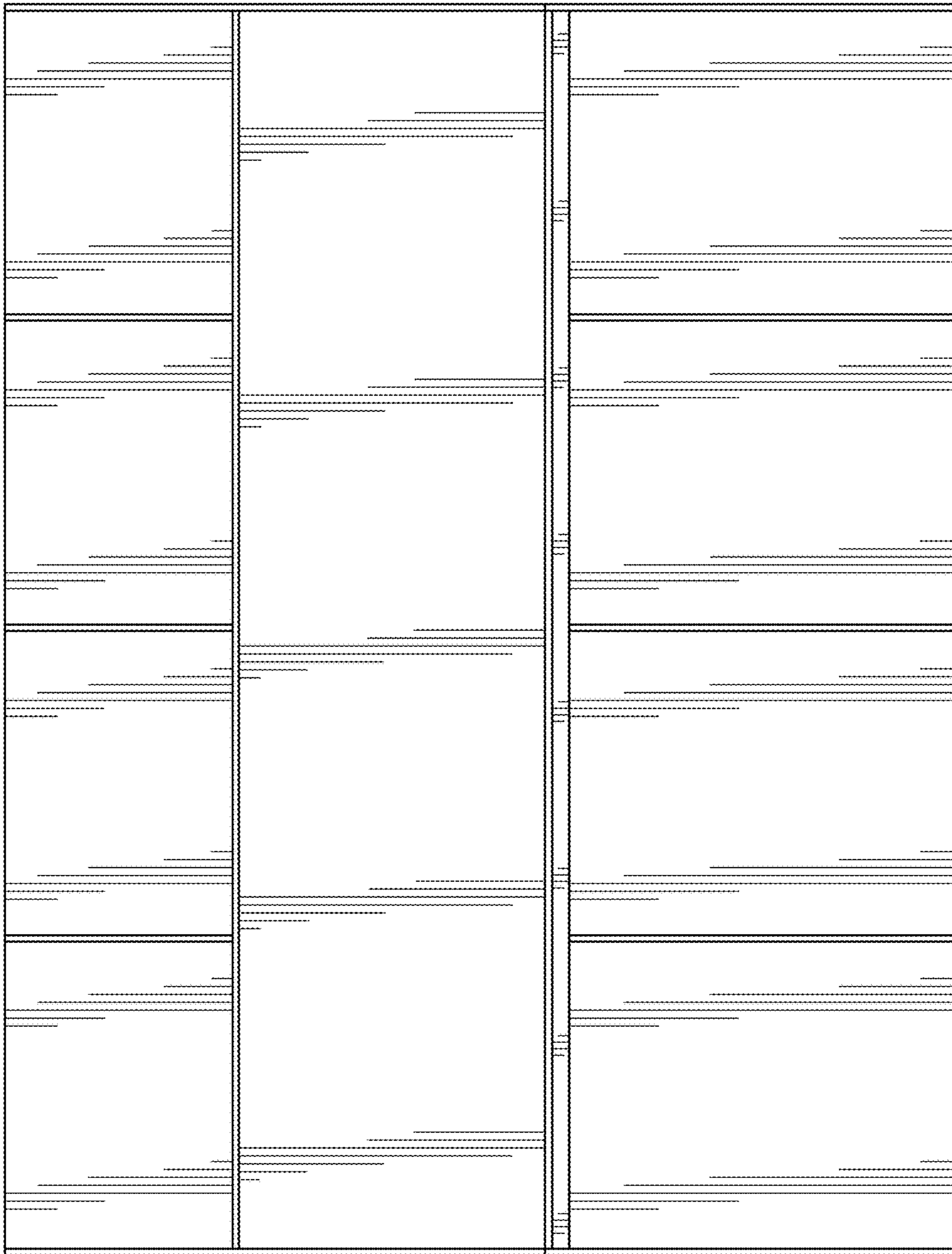

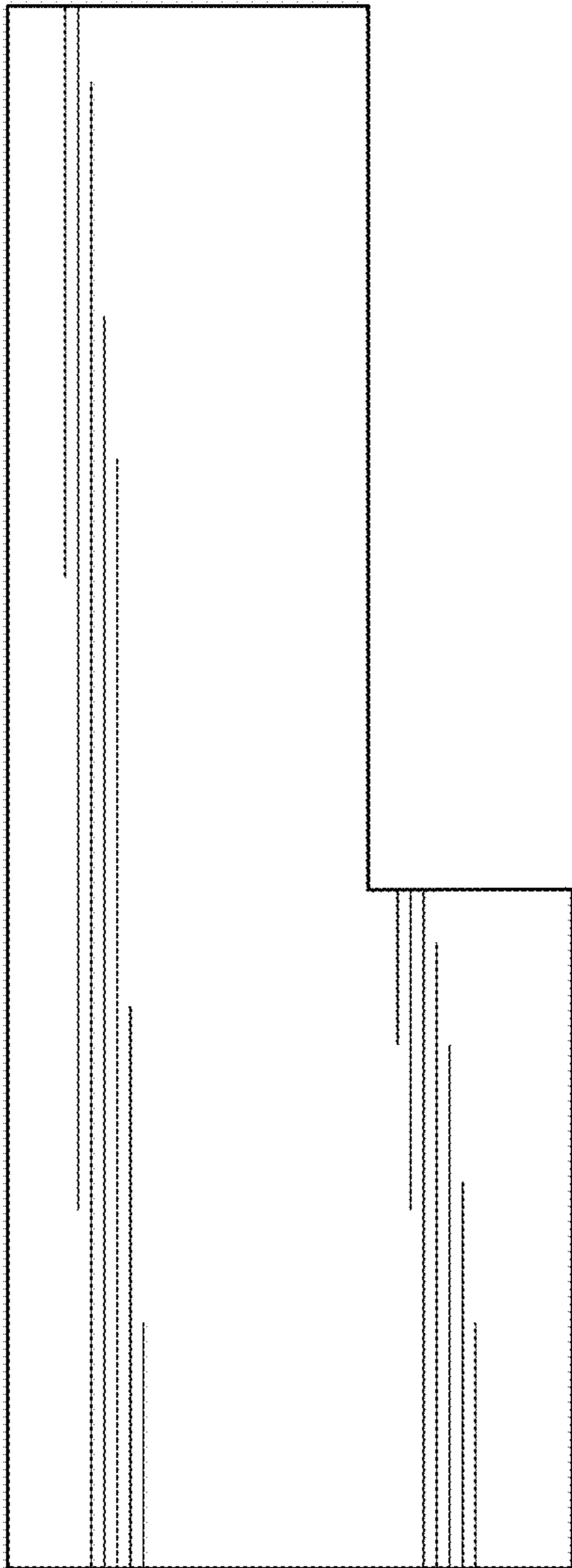

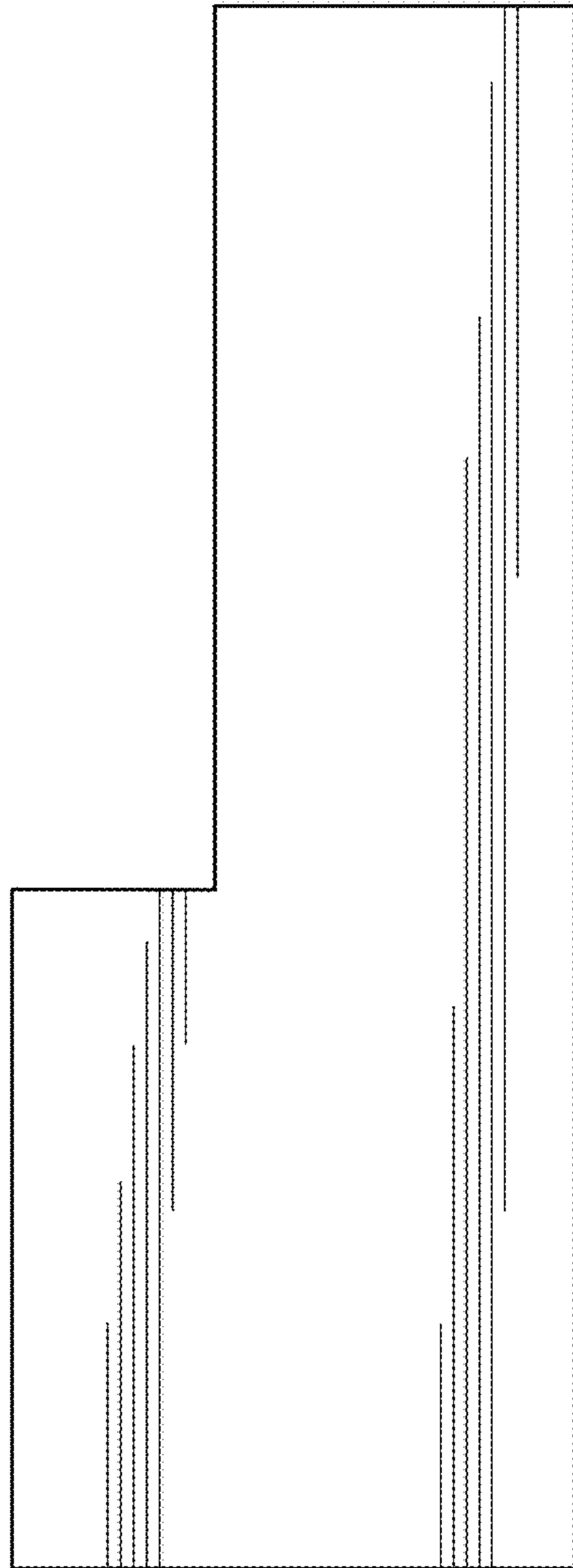

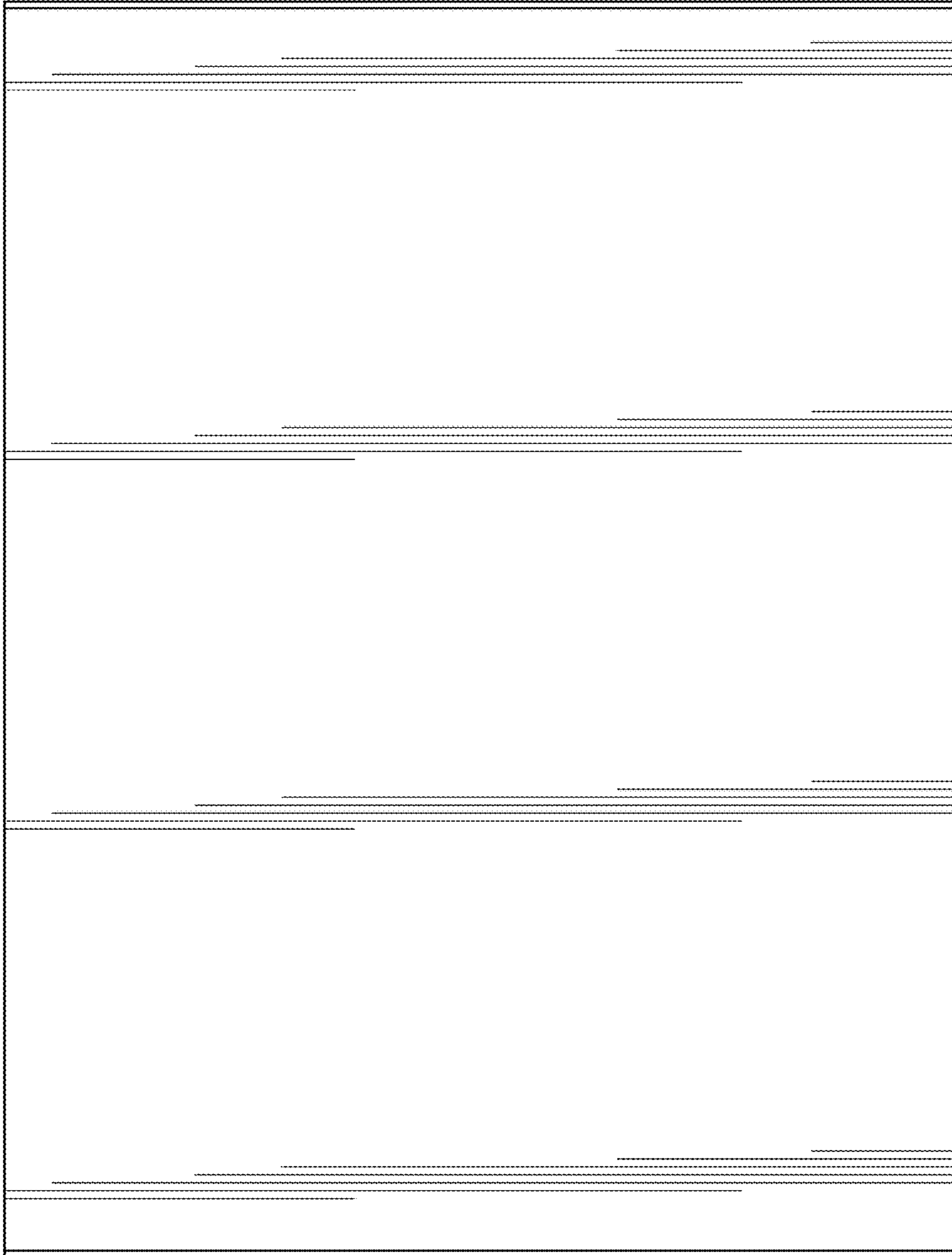

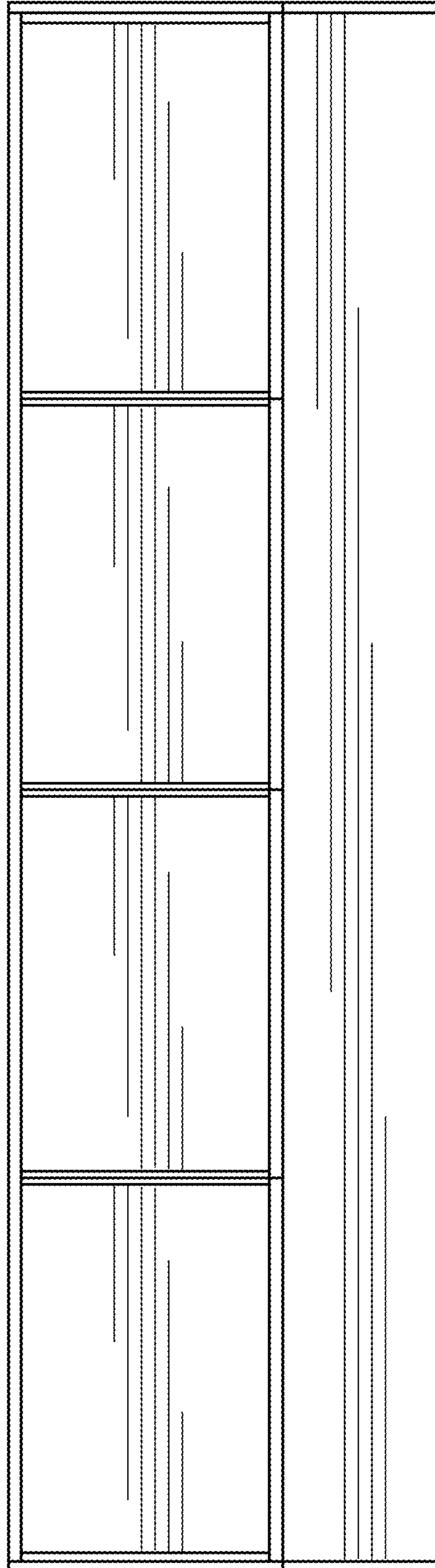
