DESCRIPTION

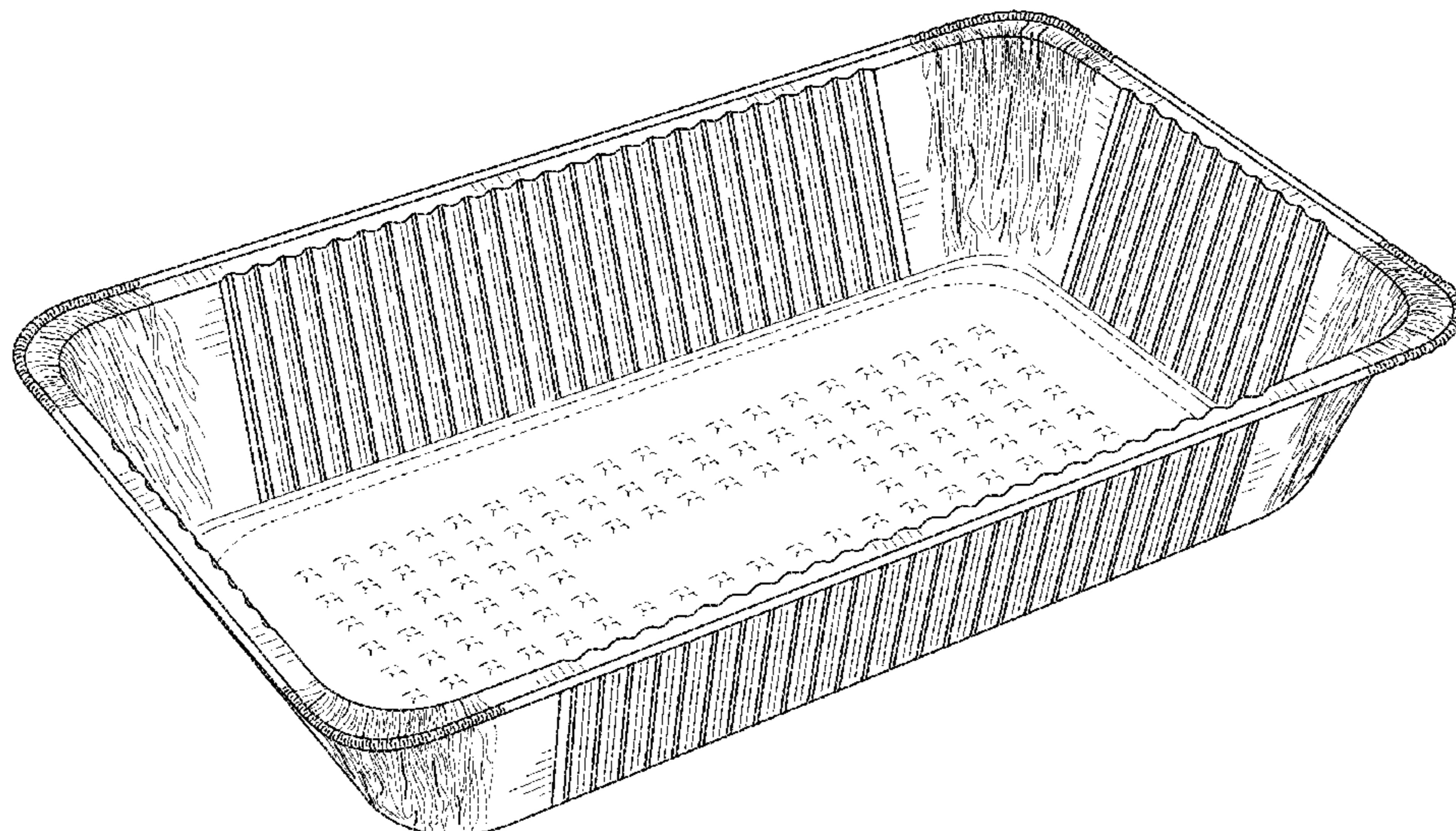
FIG. 1 is a front side perspective view showing the new design for a pan;

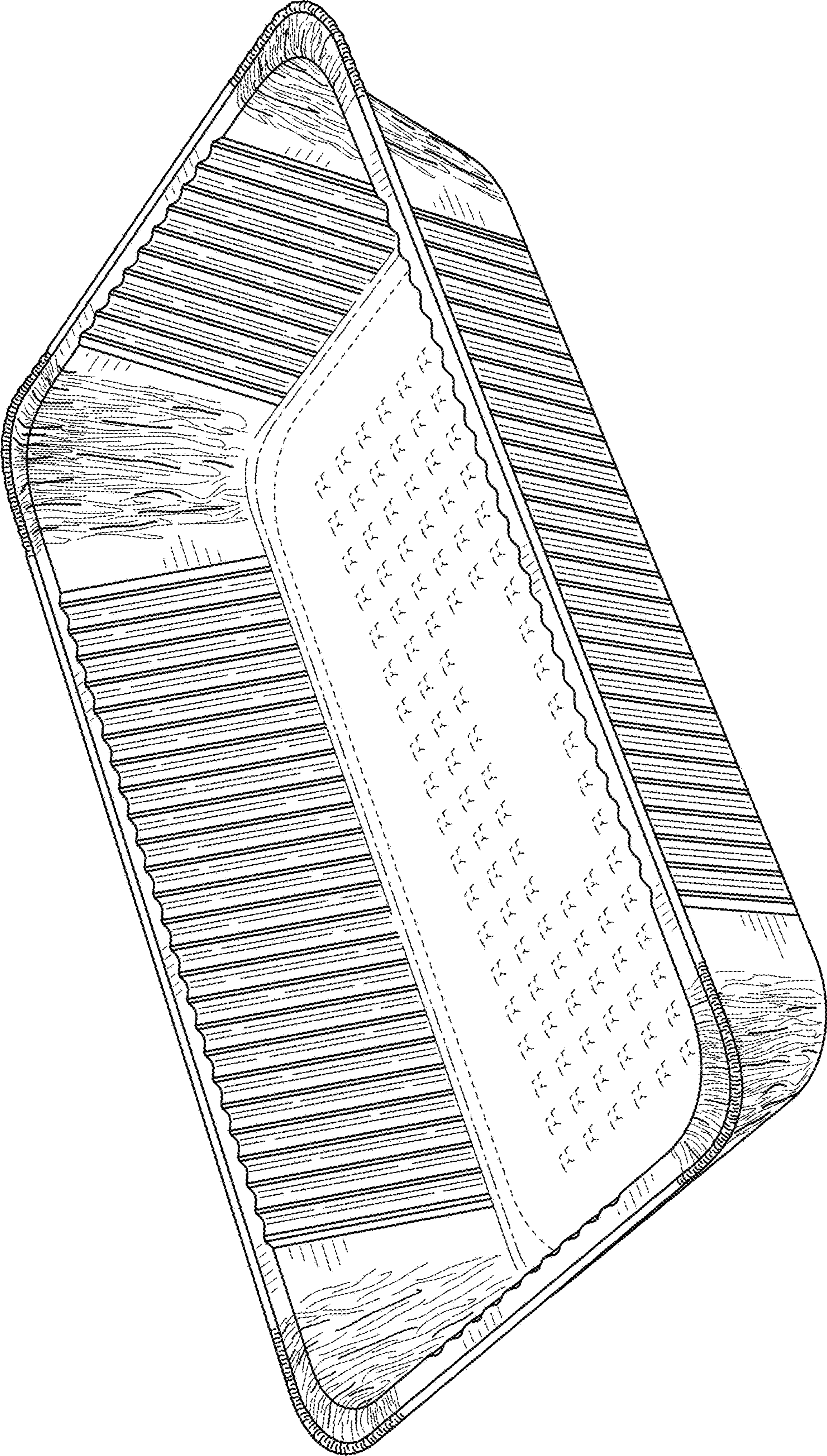

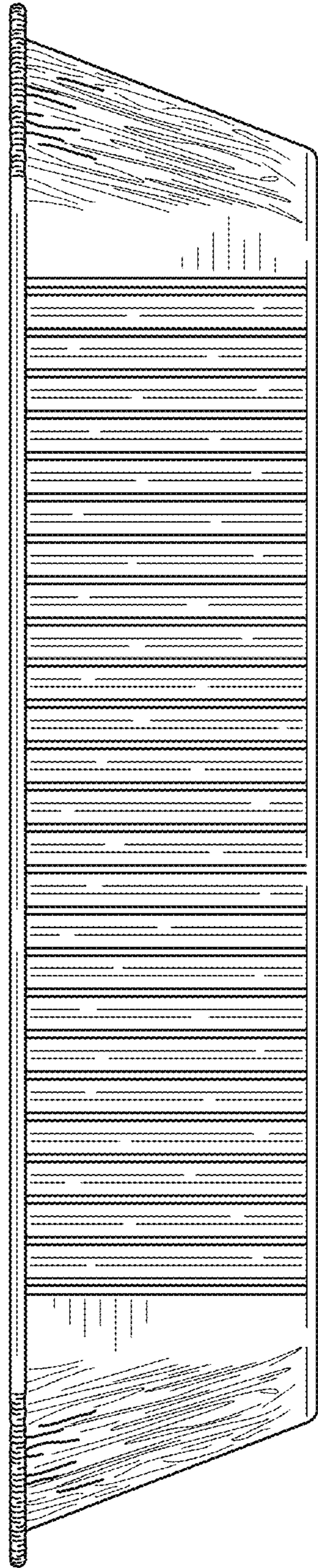

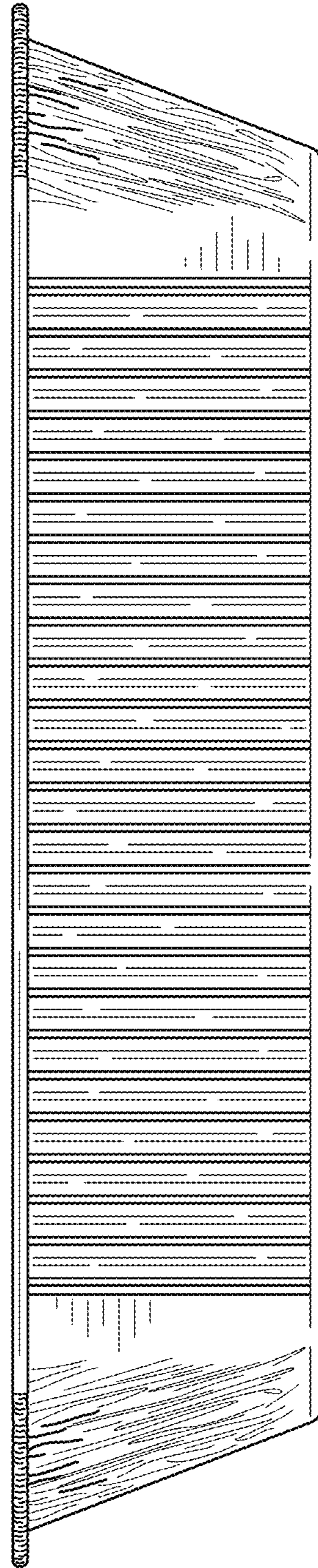

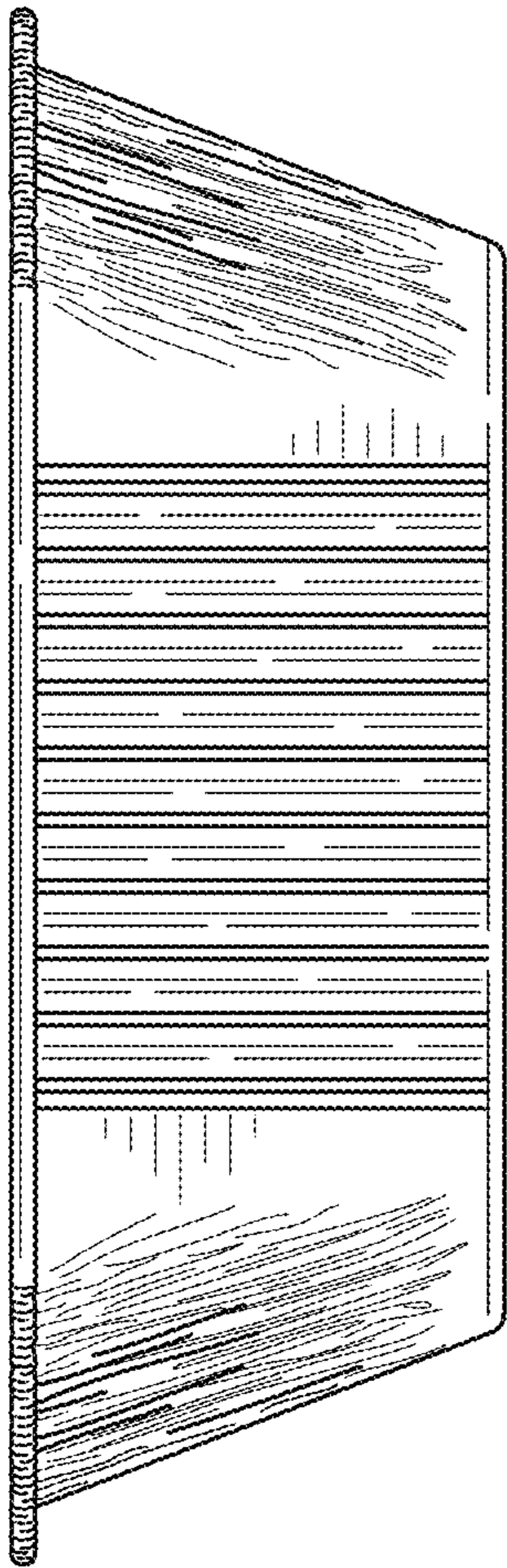

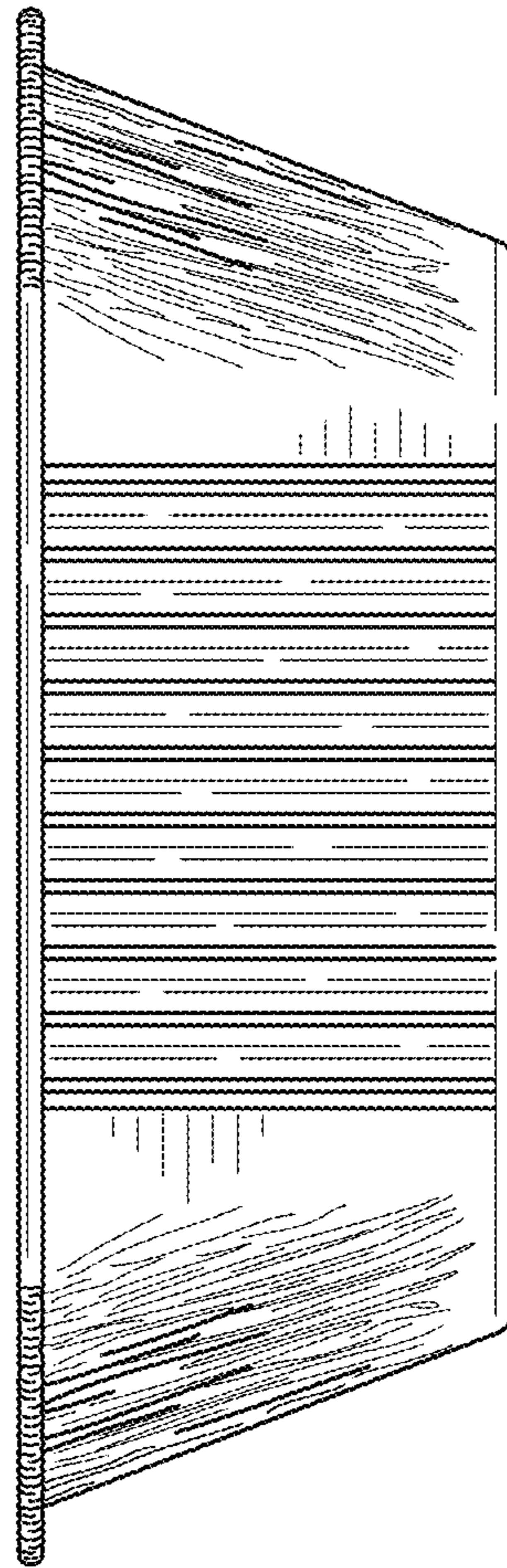

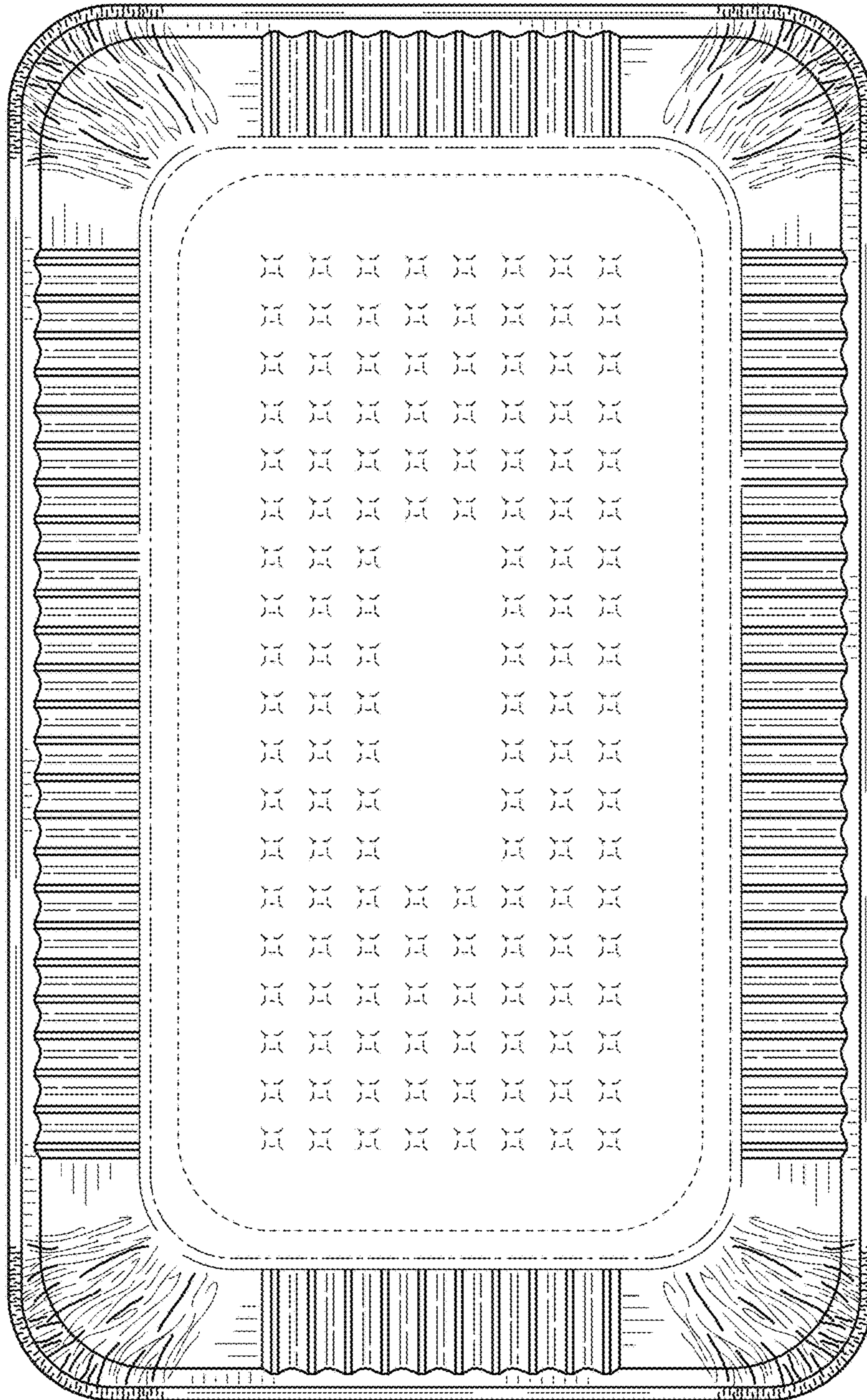

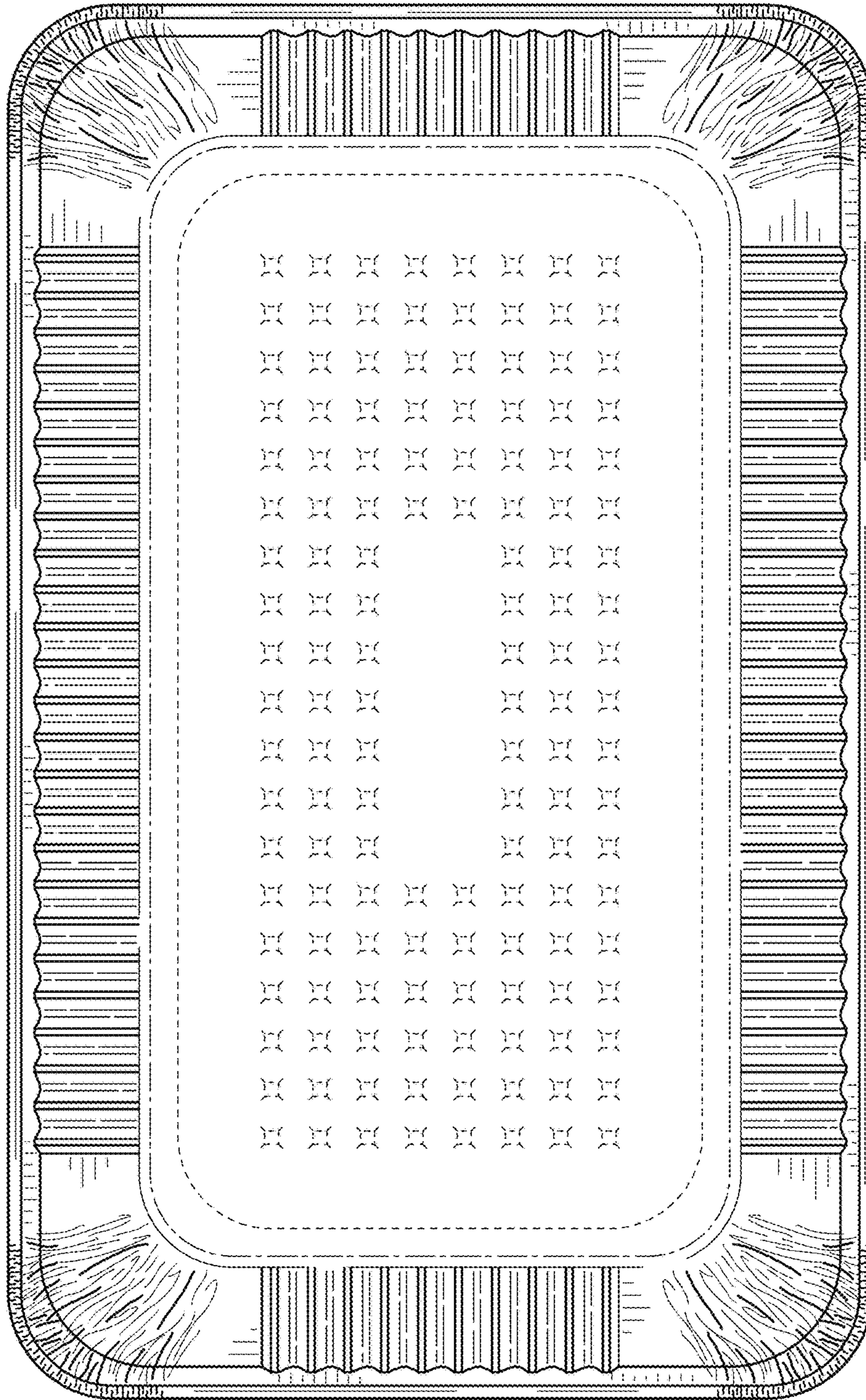

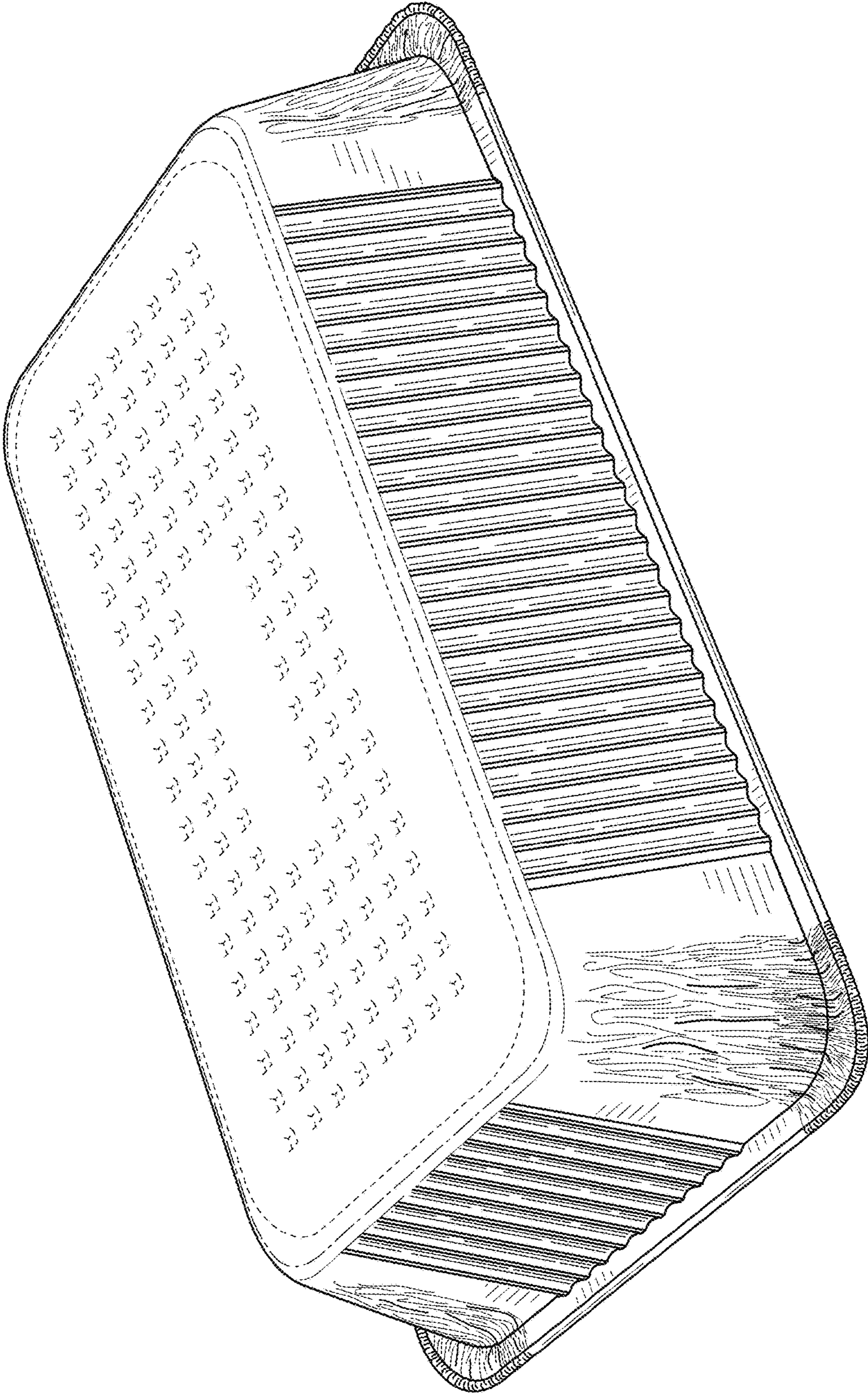
