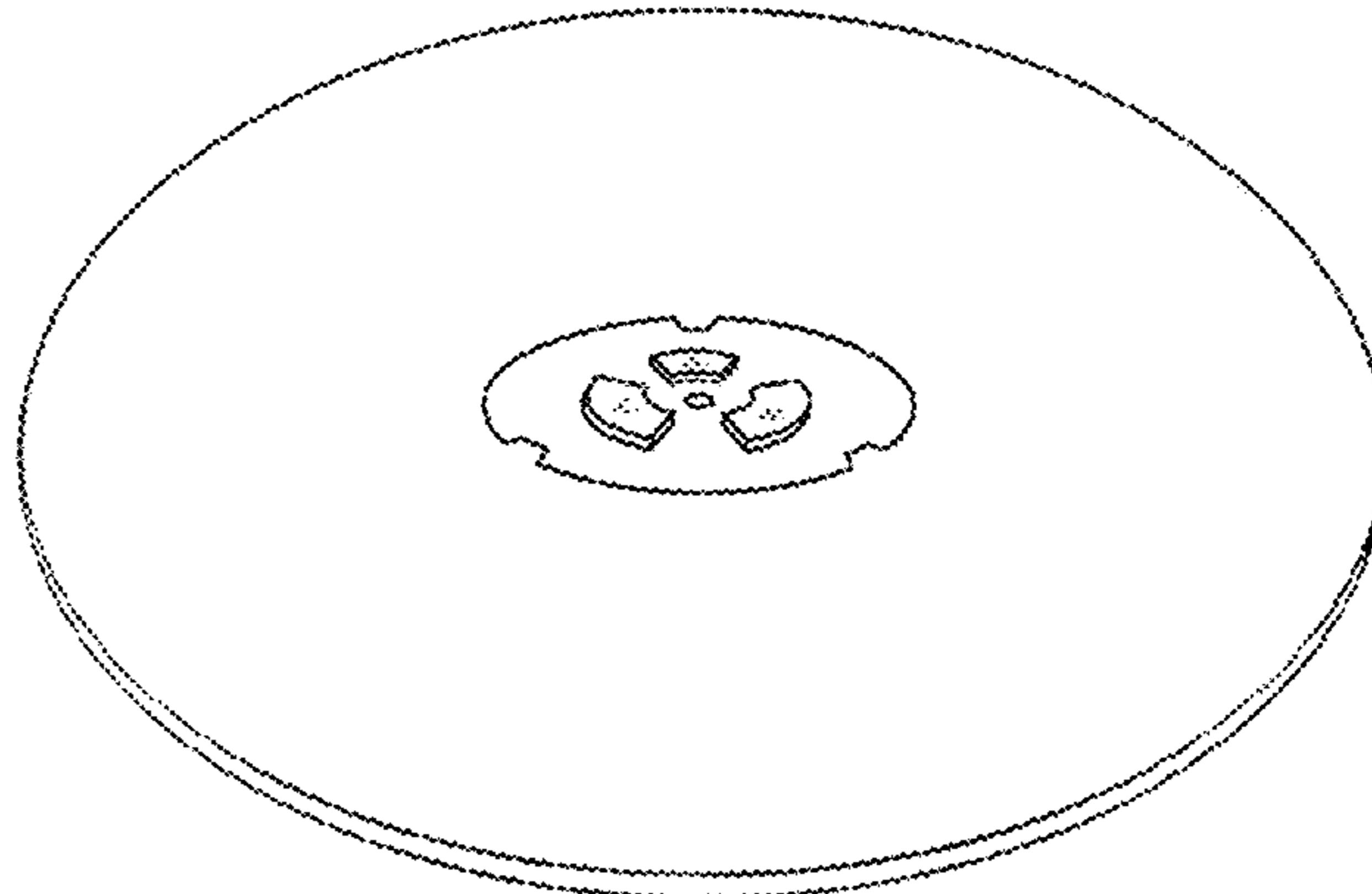
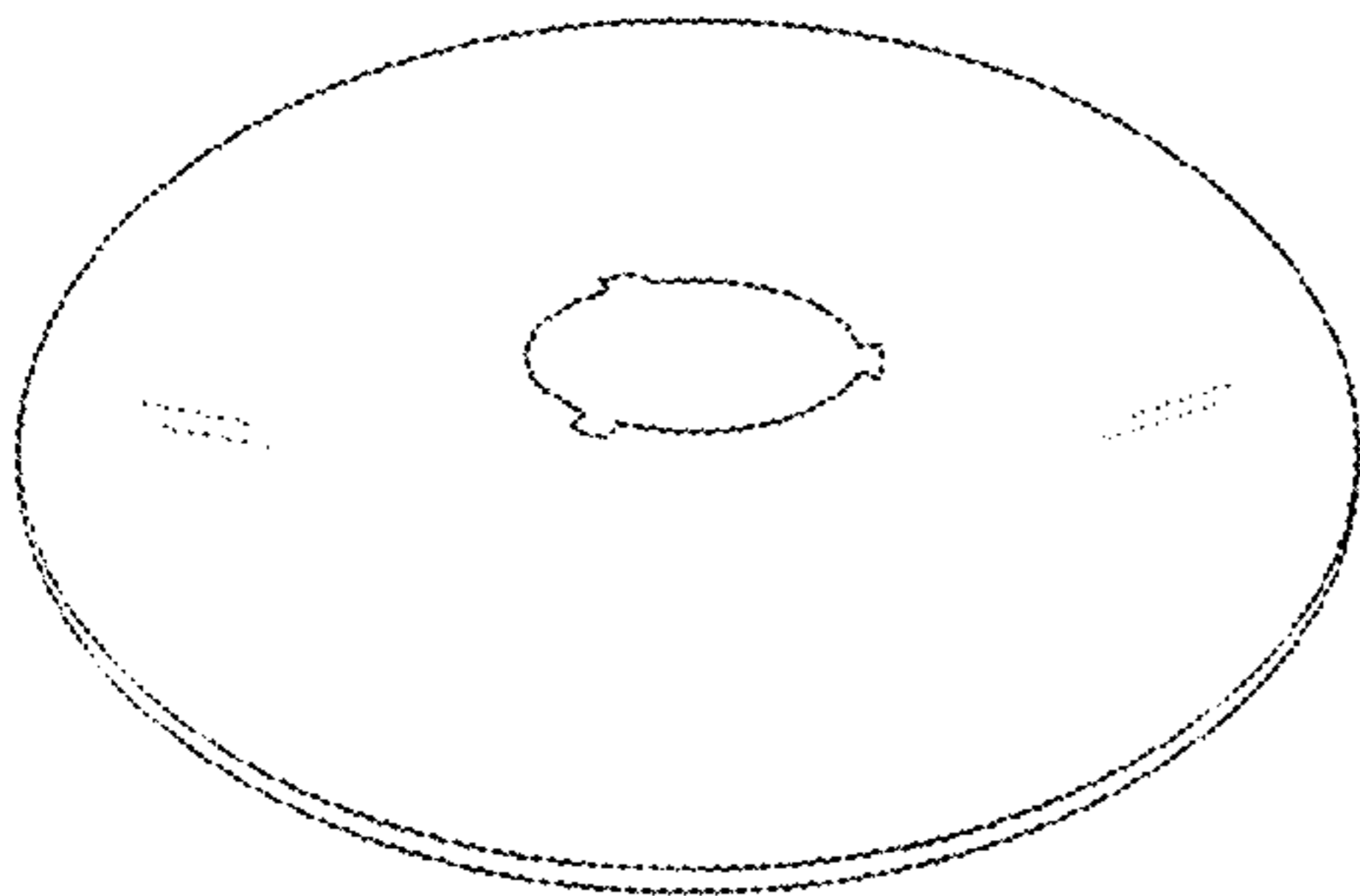
(57) **CLAIM**

The ornamental design for a microwave tray with a removable center portion, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a microwave tray with a removable center portion;
FIG. 2 is a top view thereof;
FIG. 3 is a front side view thereof;
FIG. 4 is a rear view thereof;
FIG. 5 is a left side view thereof; the right side view of the microwave tray is identical to the left side view;
FIG. 6 is a bottom view thereof; and,
FIG. 7 is a perspective view of a bottom surface of the microwave tray.
Any broken line showings of the microwave tray in the figures are for the purpose of illustrating an environment only and form no part of the claimed design.

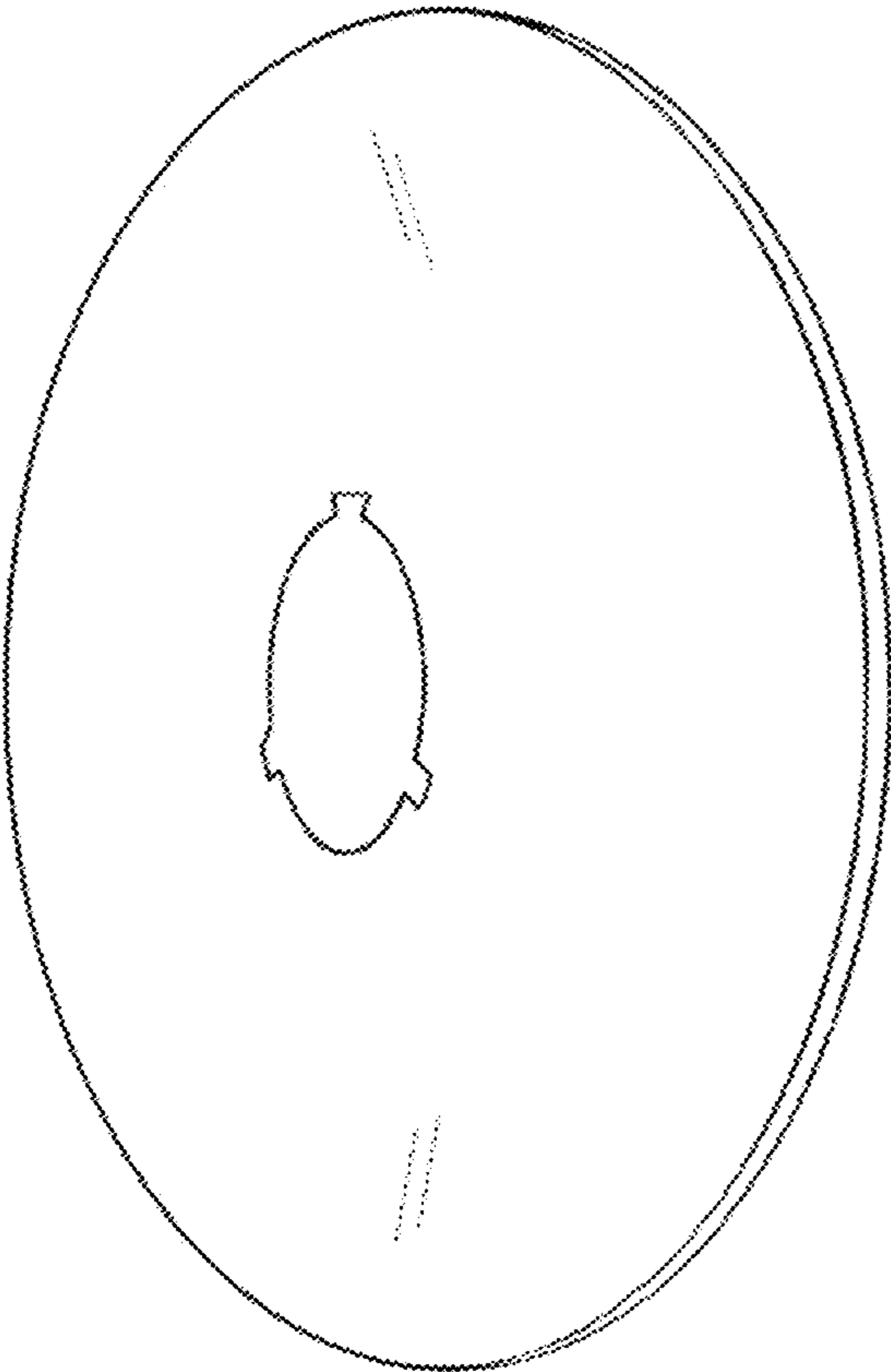

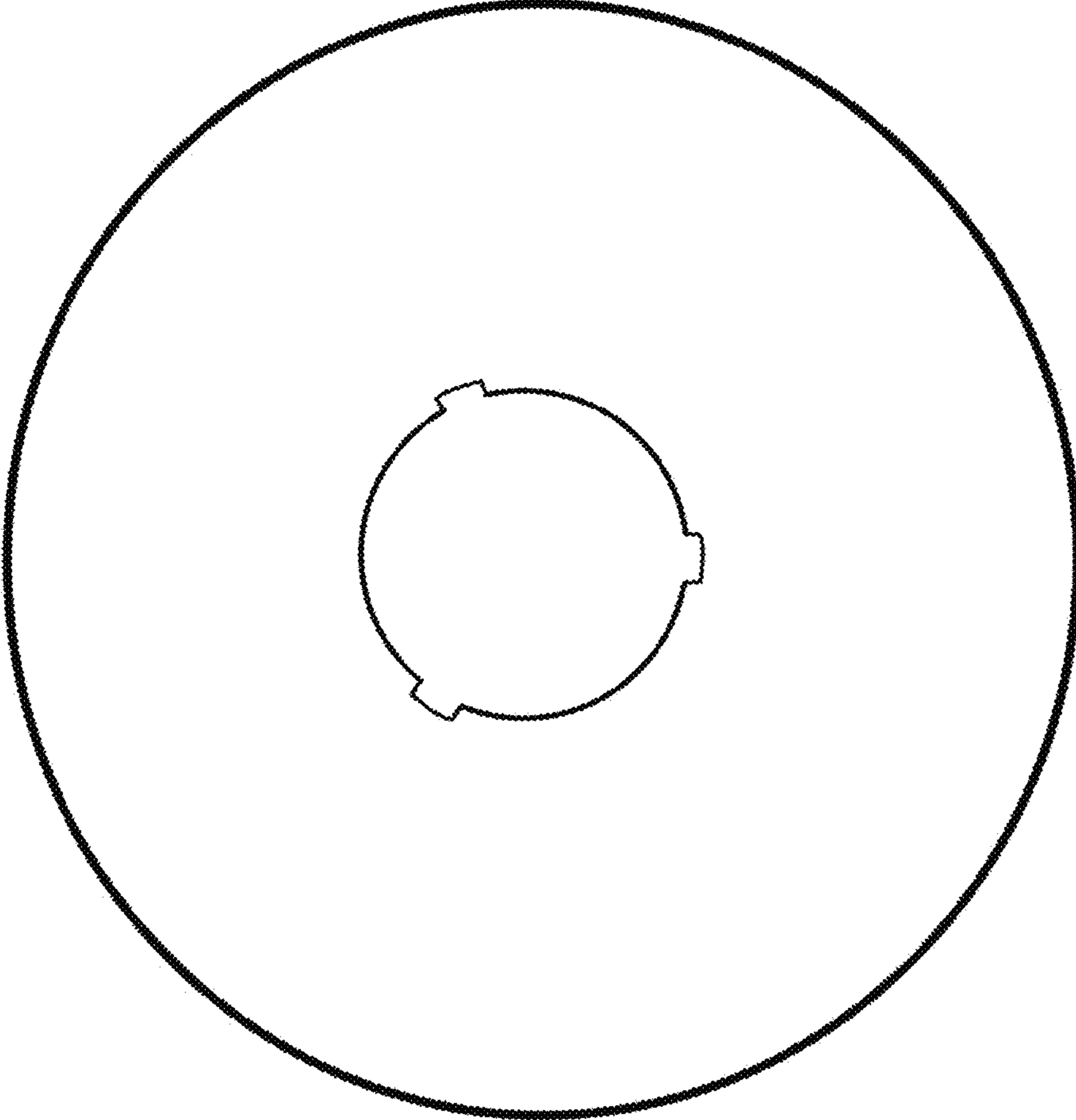

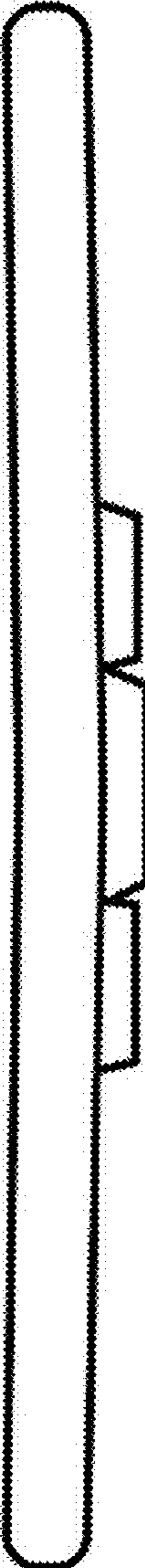

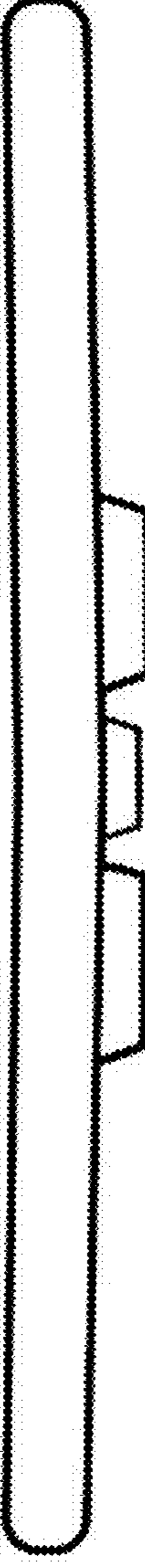

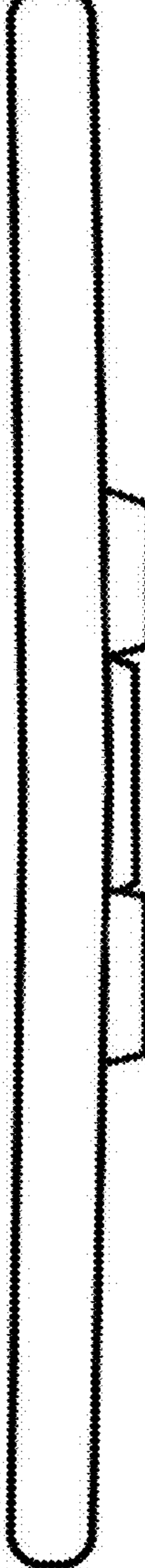

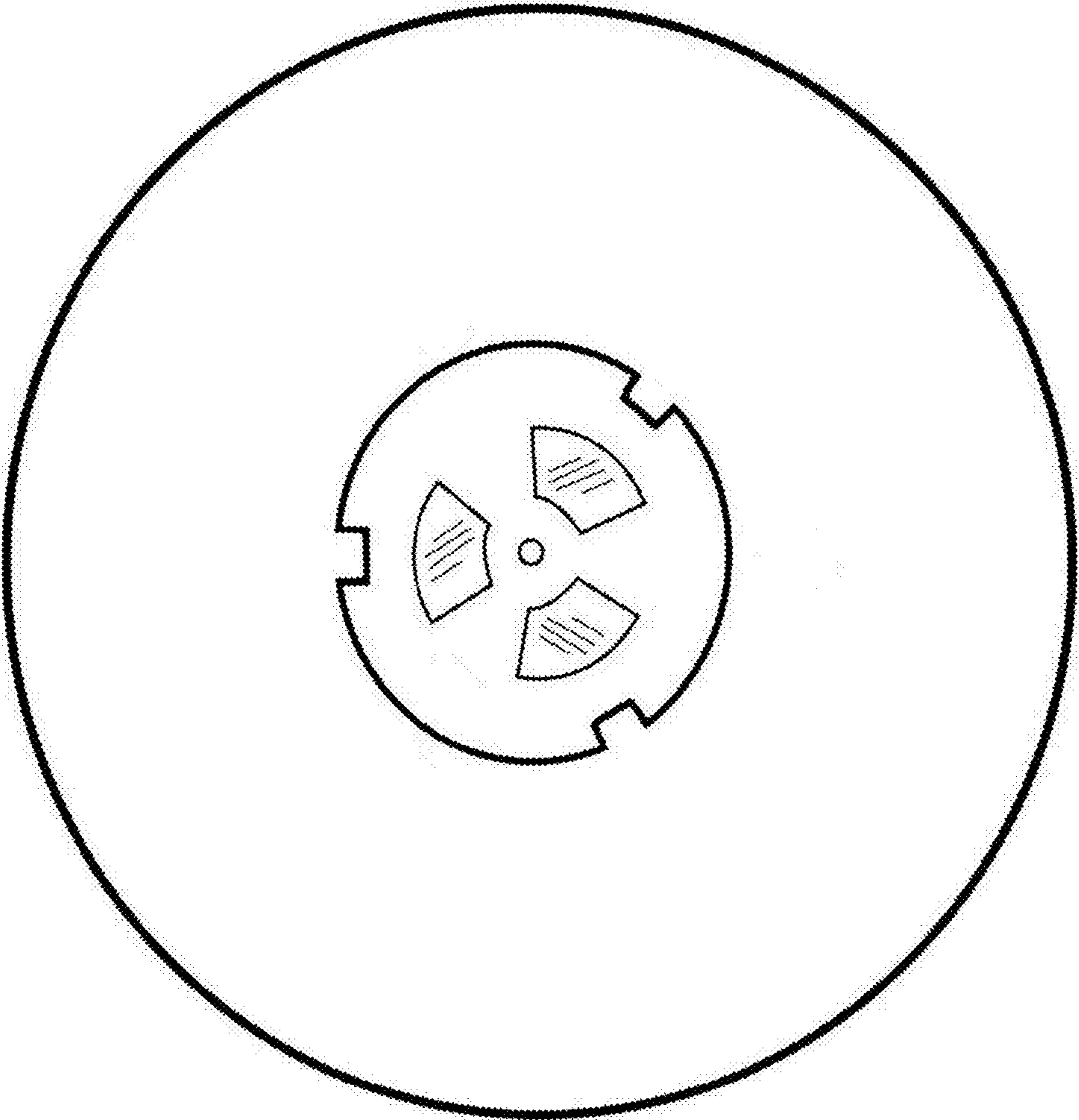

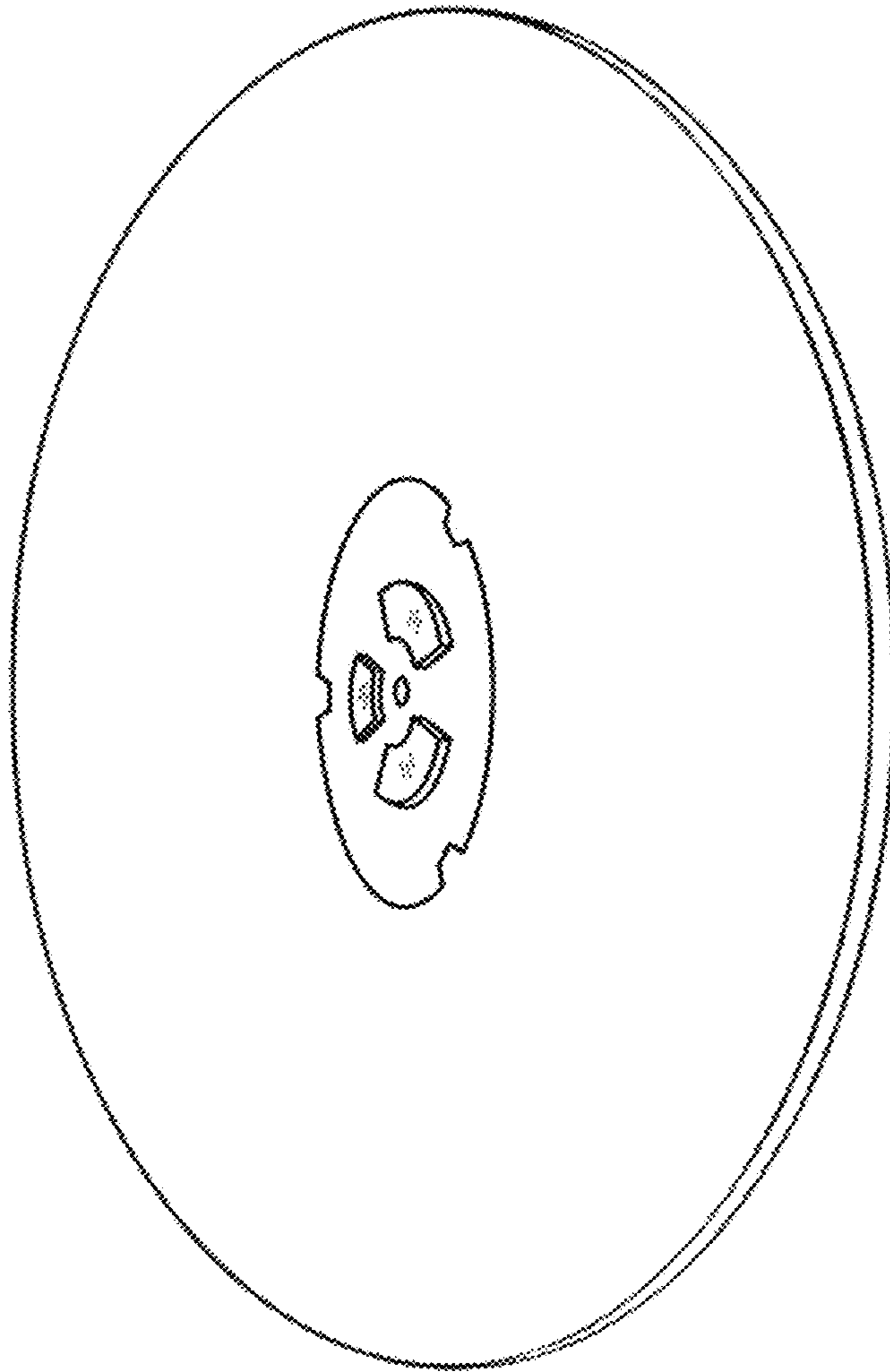
