The ornamental design for a blank for forming a lid for a container, as shown and described.

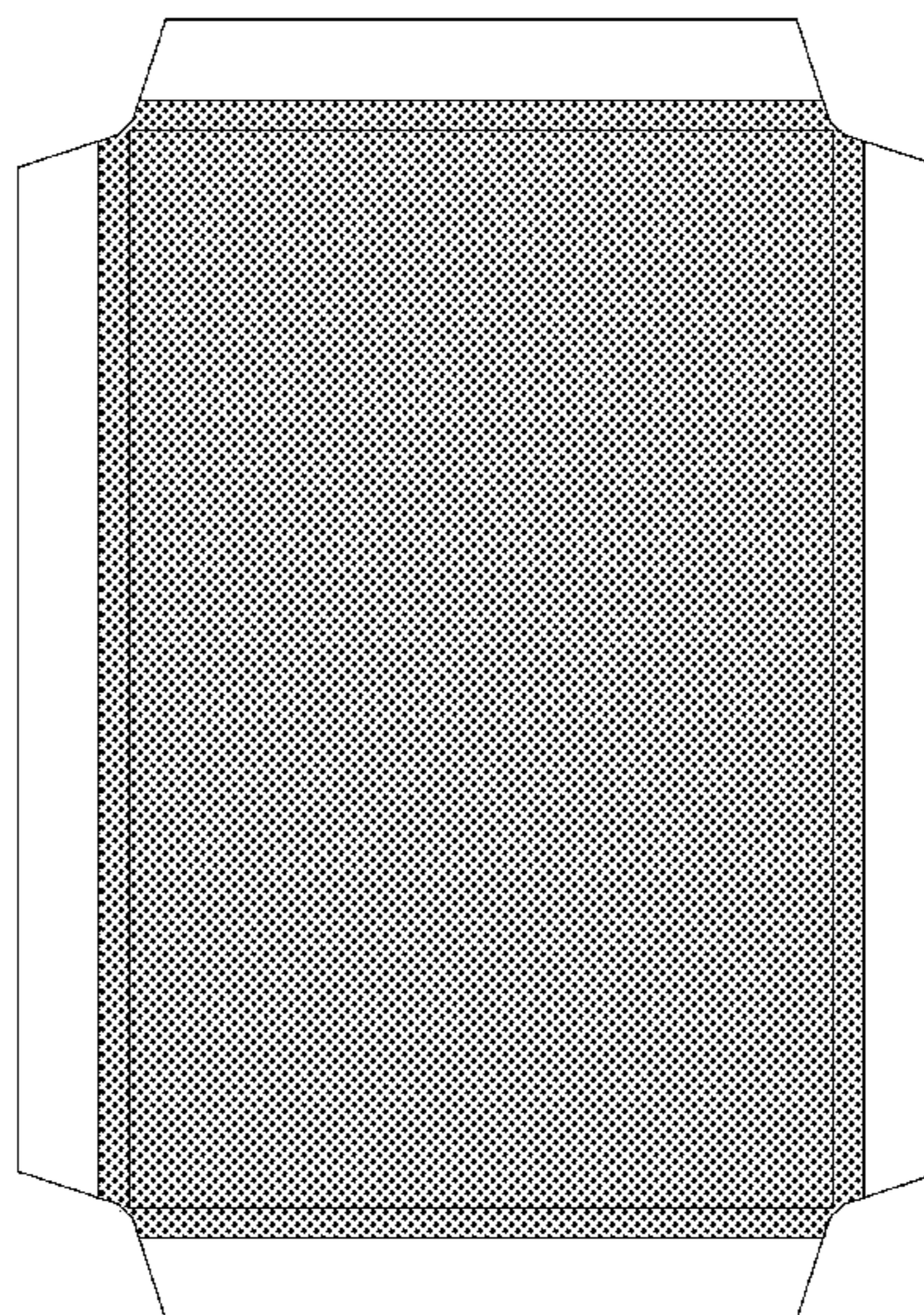
DESCRIPTION
