**1.2** is a perspective view thereof showing the fluid dispenser in an expanded position;

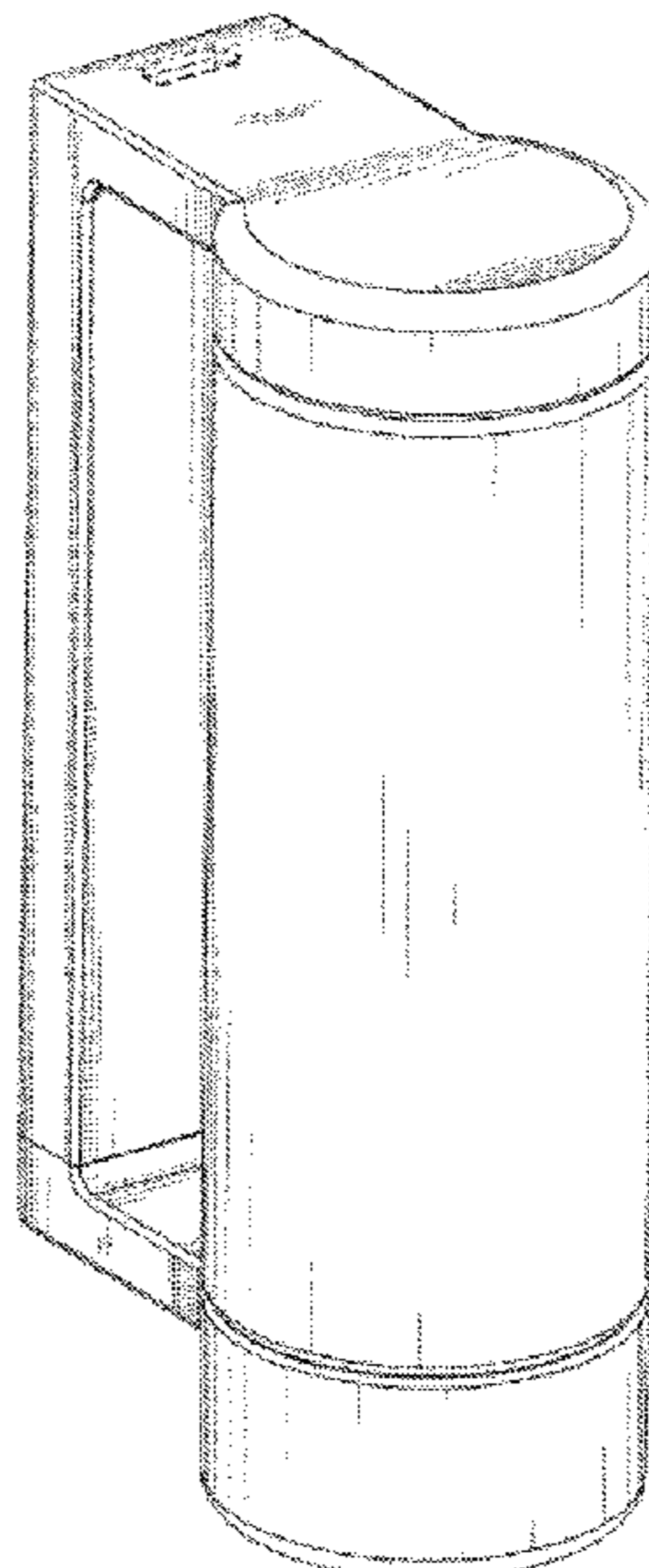
**1.3** is a top view thereof;

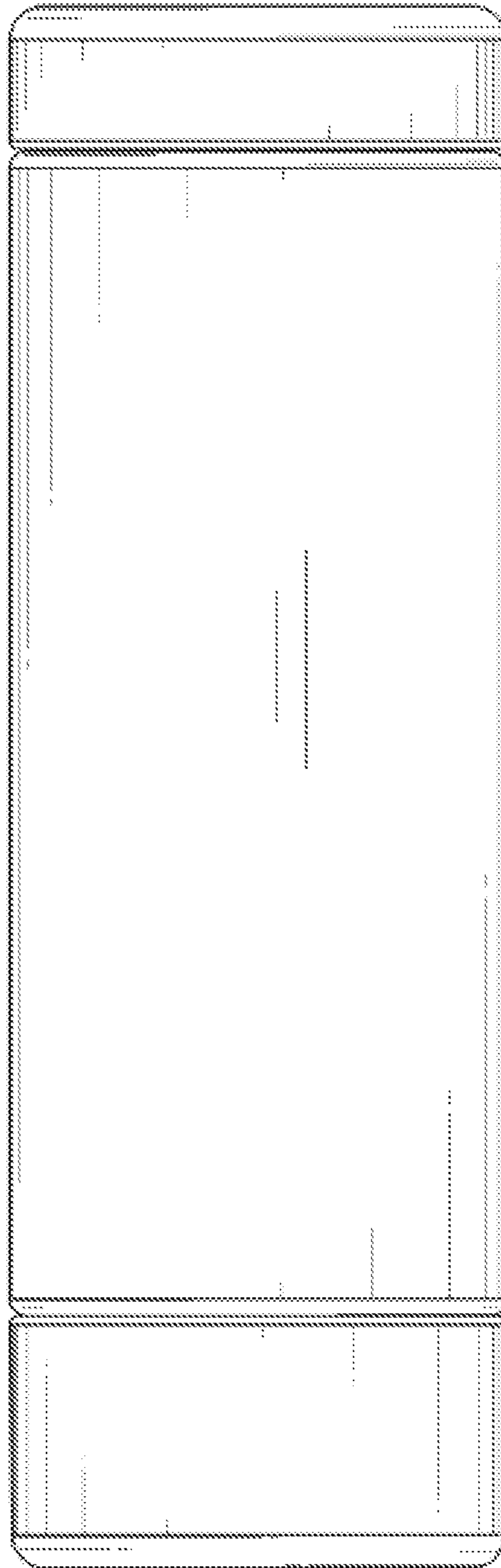
**1.4** is side elevational view thereof; and

**1.5** is a perspective view thereof showing the fluid dispenser in a compressed position.

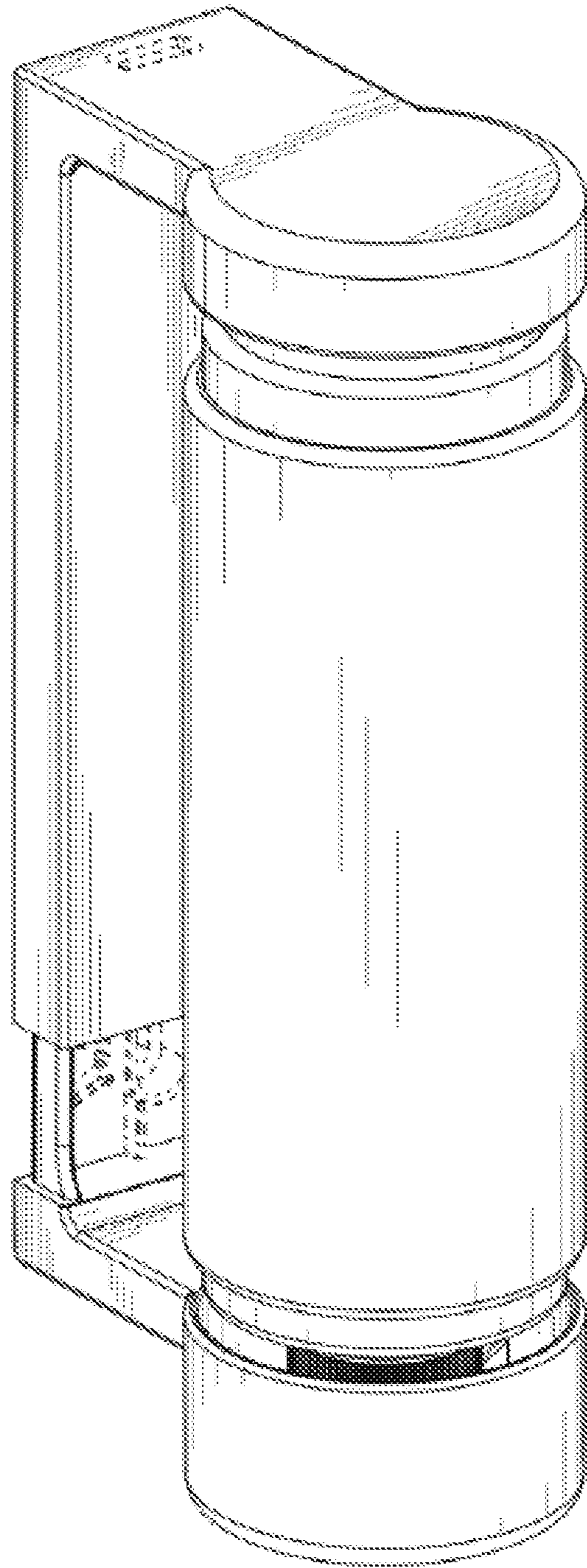
The broken lines in the reproductions and the structure shown shaded in solid black in **1.2** illustrate portions of the fluid dispenser that form no part of the claimed design.

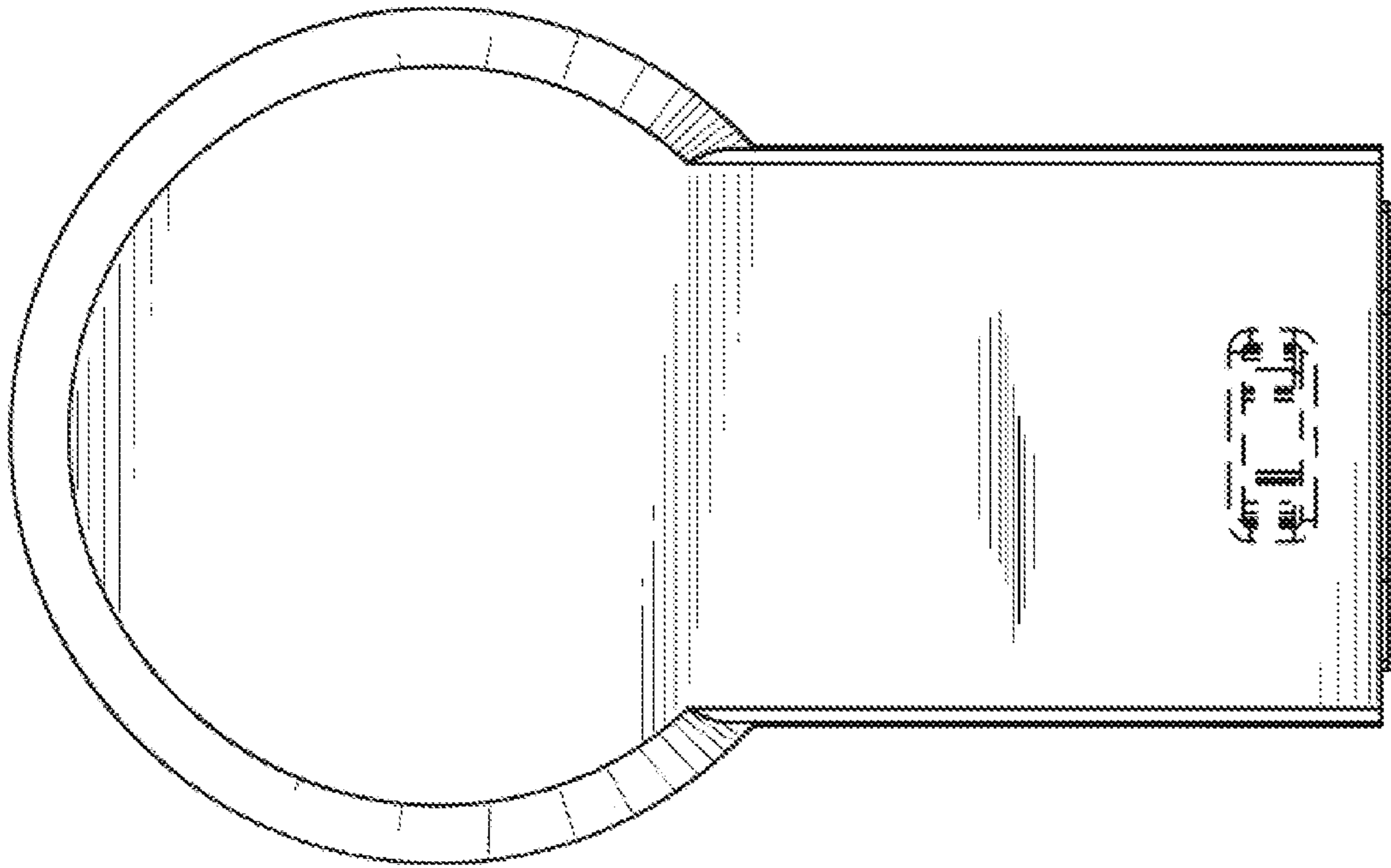

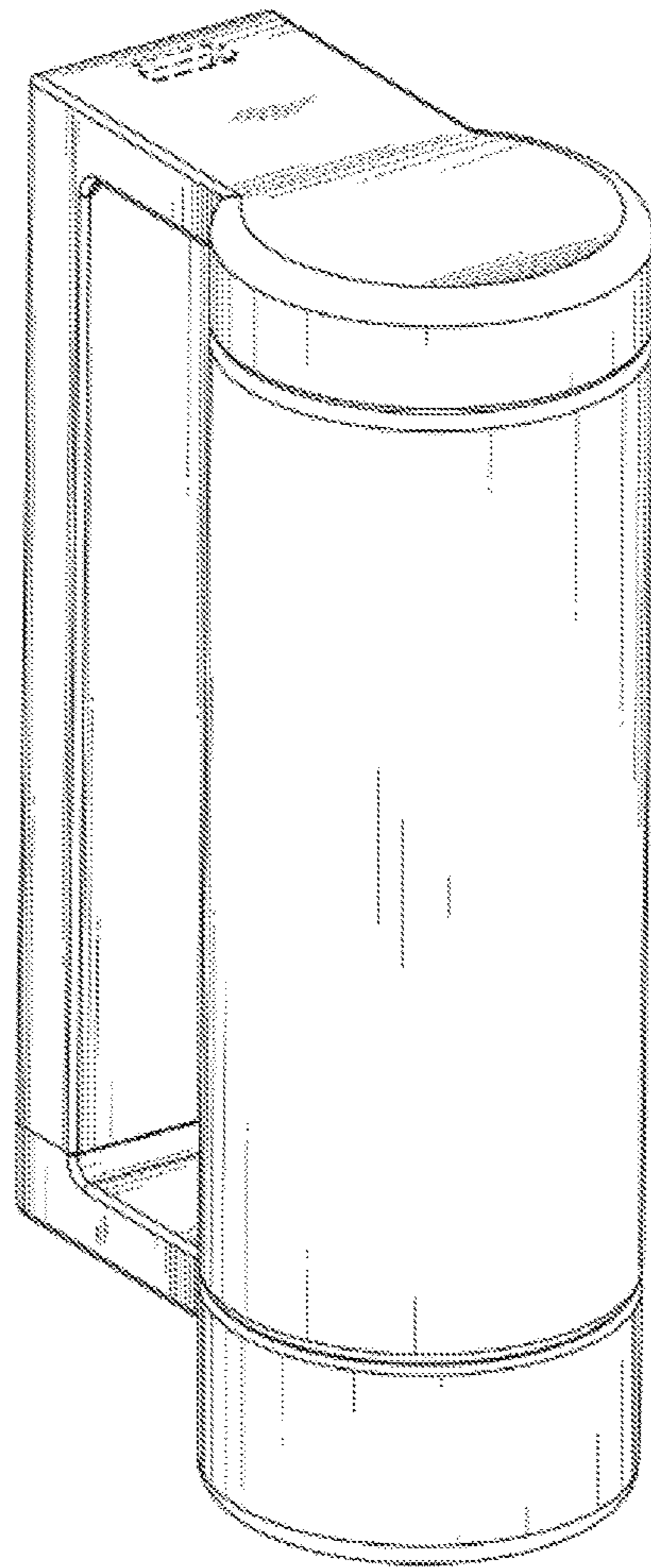
