FIG. 6 is a right side view of the pendant of FIG. 1; and, FIG. 7 is a front, right side perspective view of the pendant of FIG. 1.

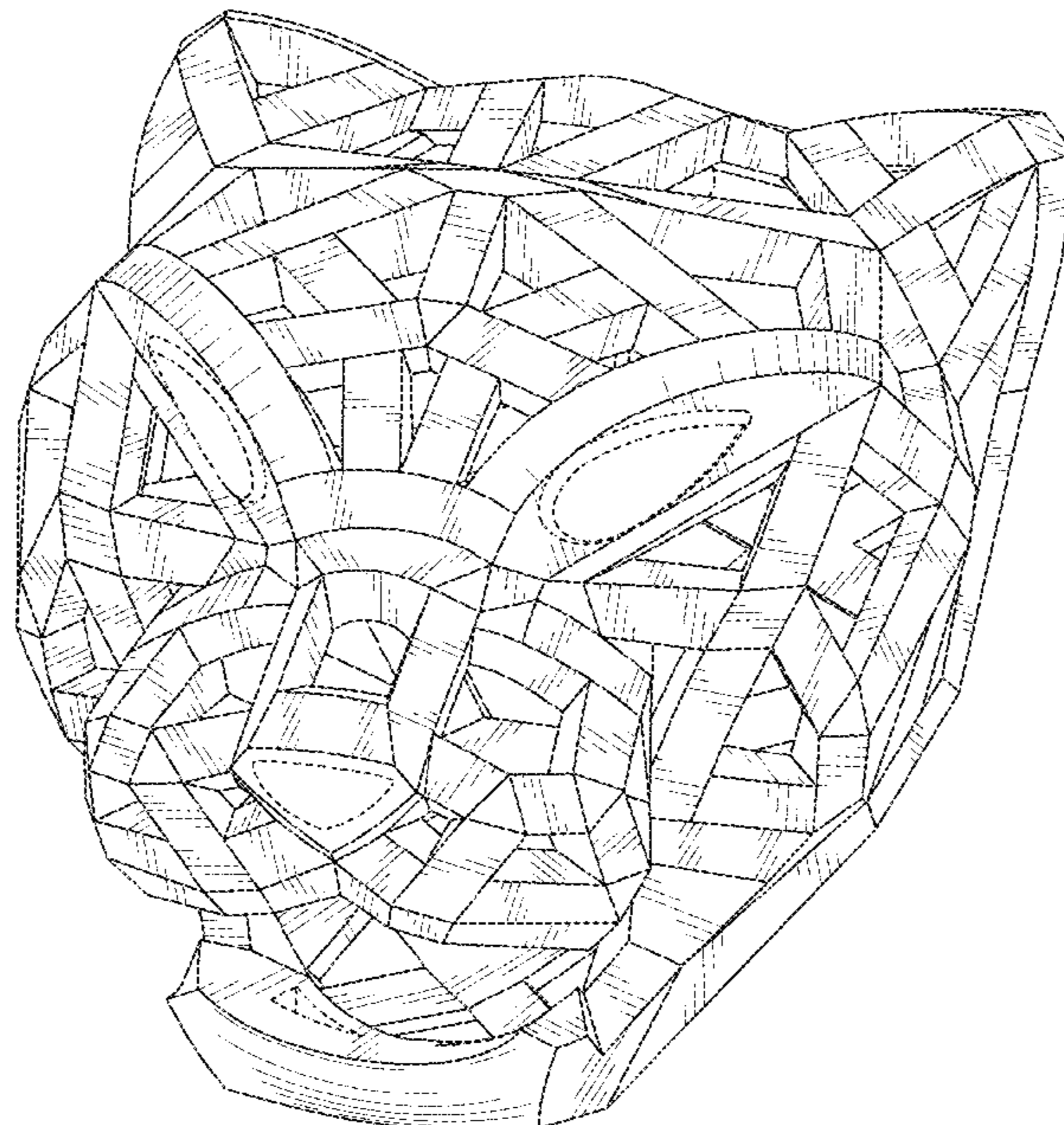

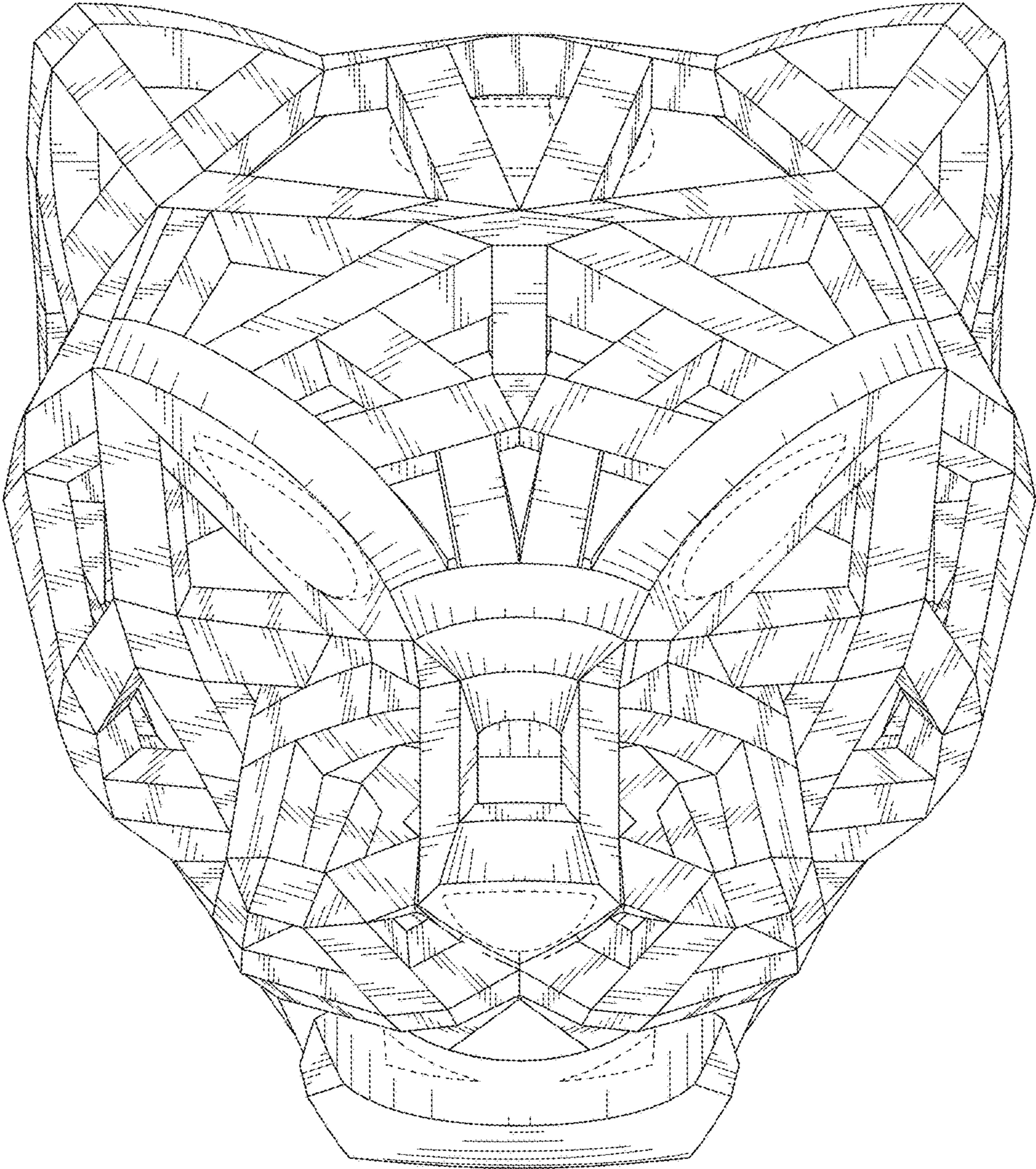

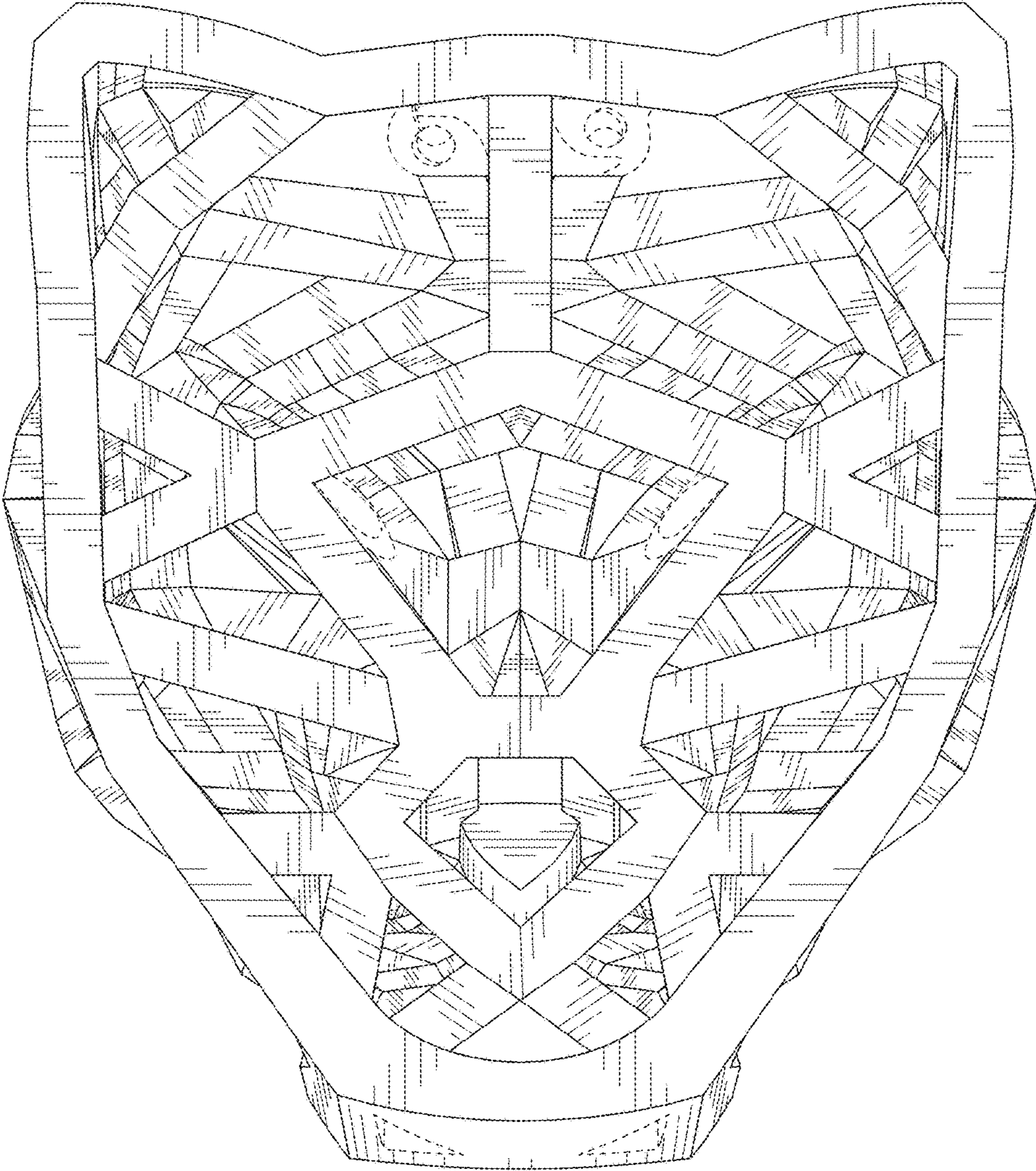

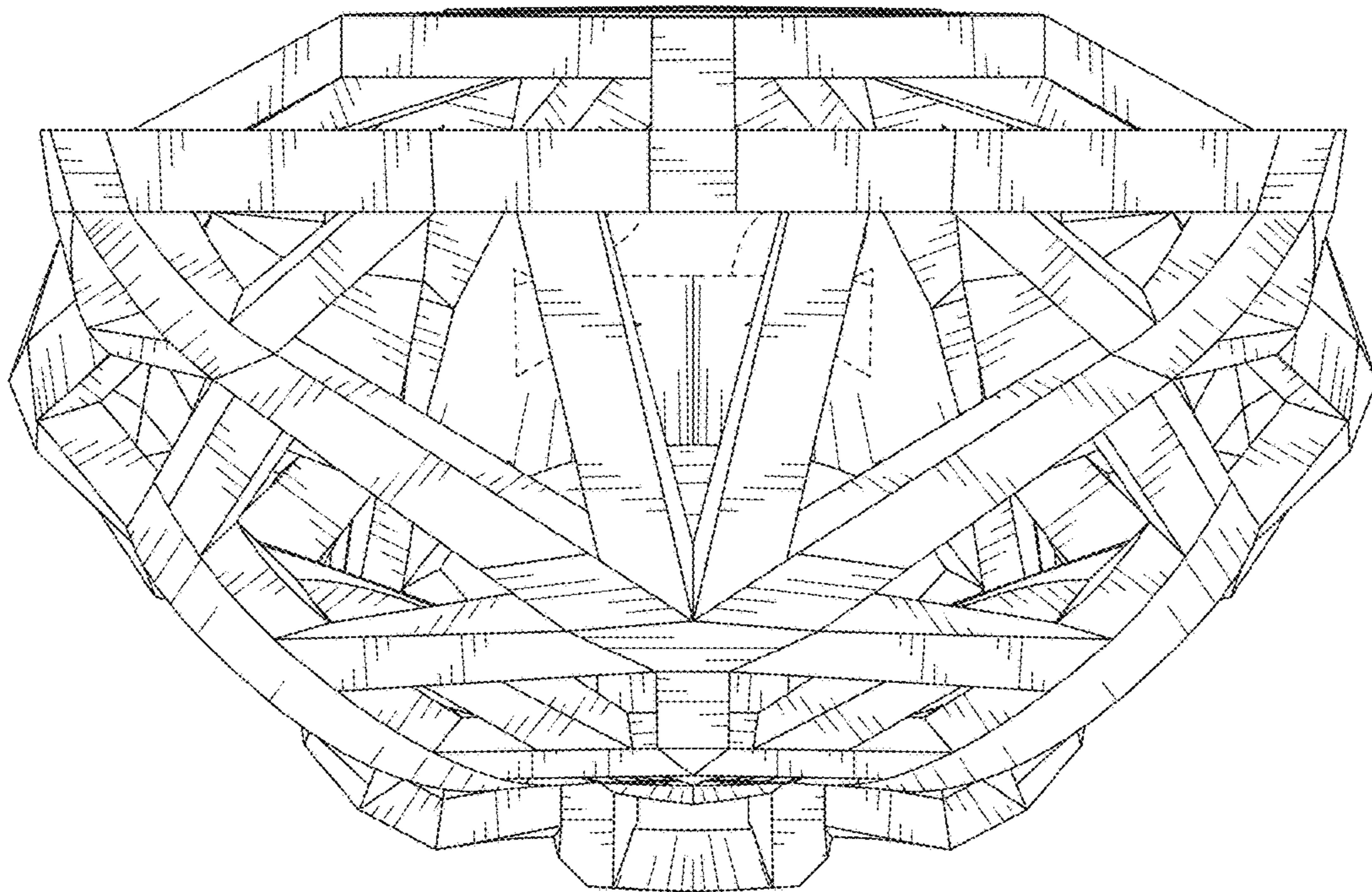

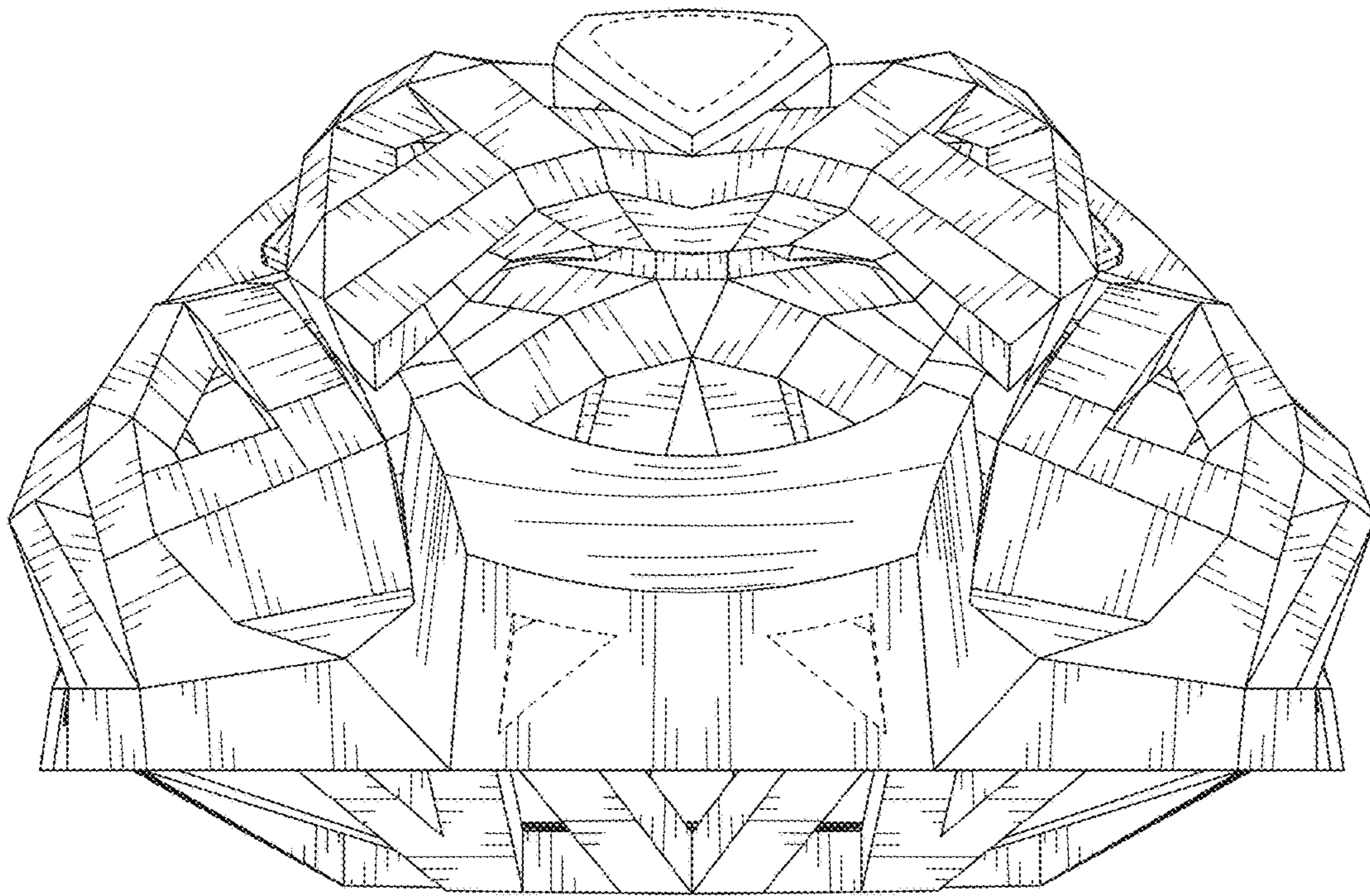

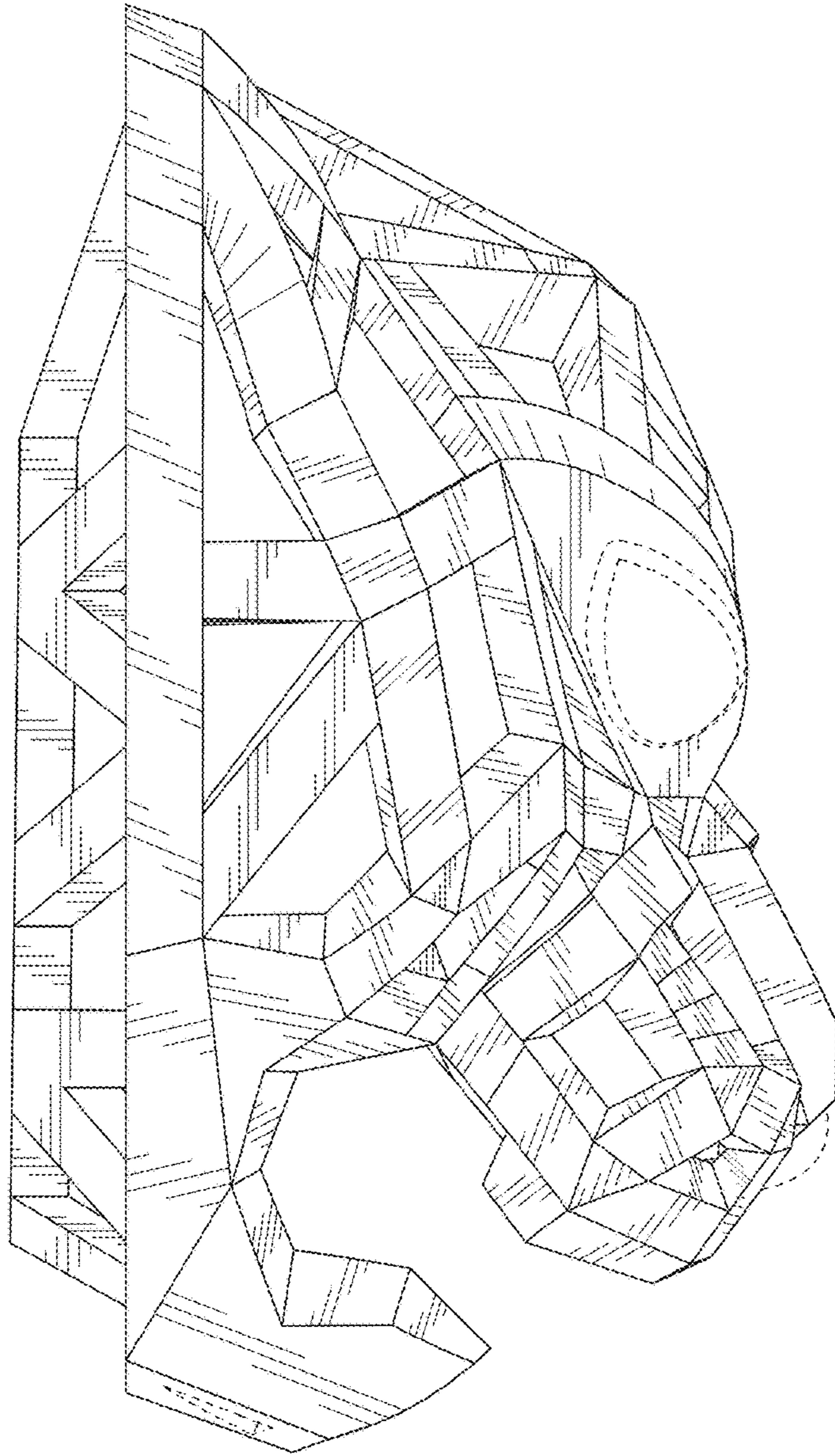

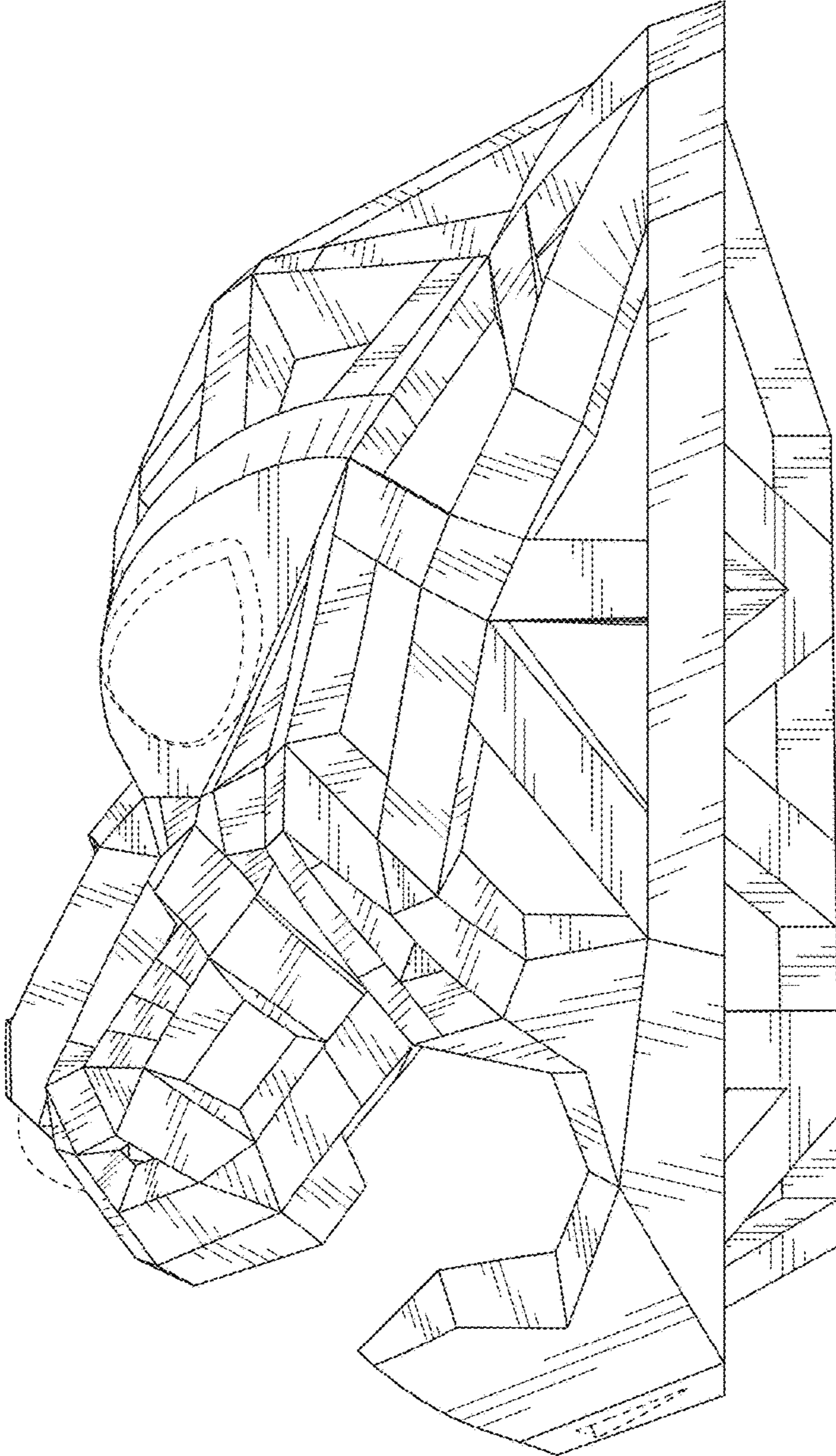

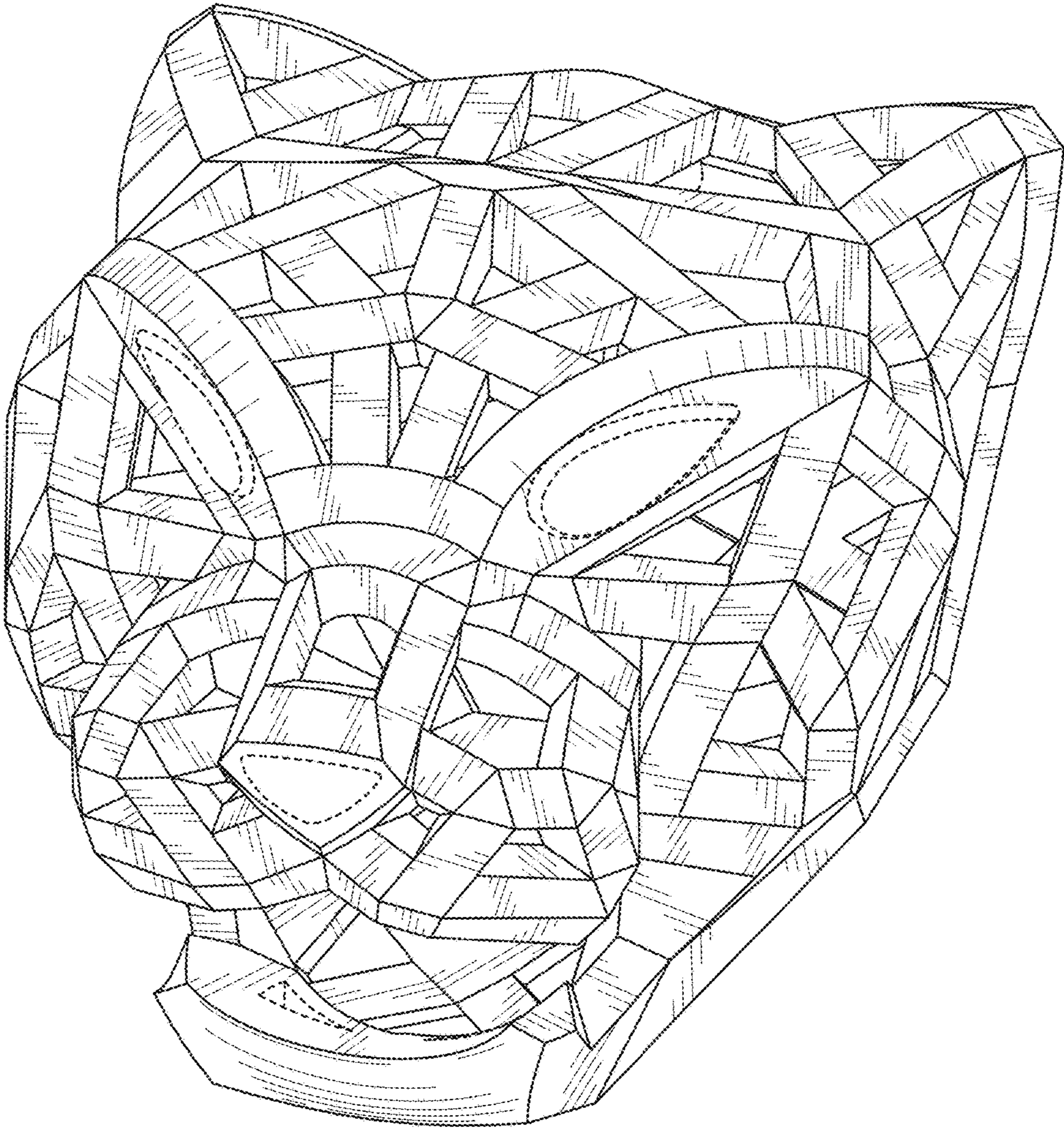
