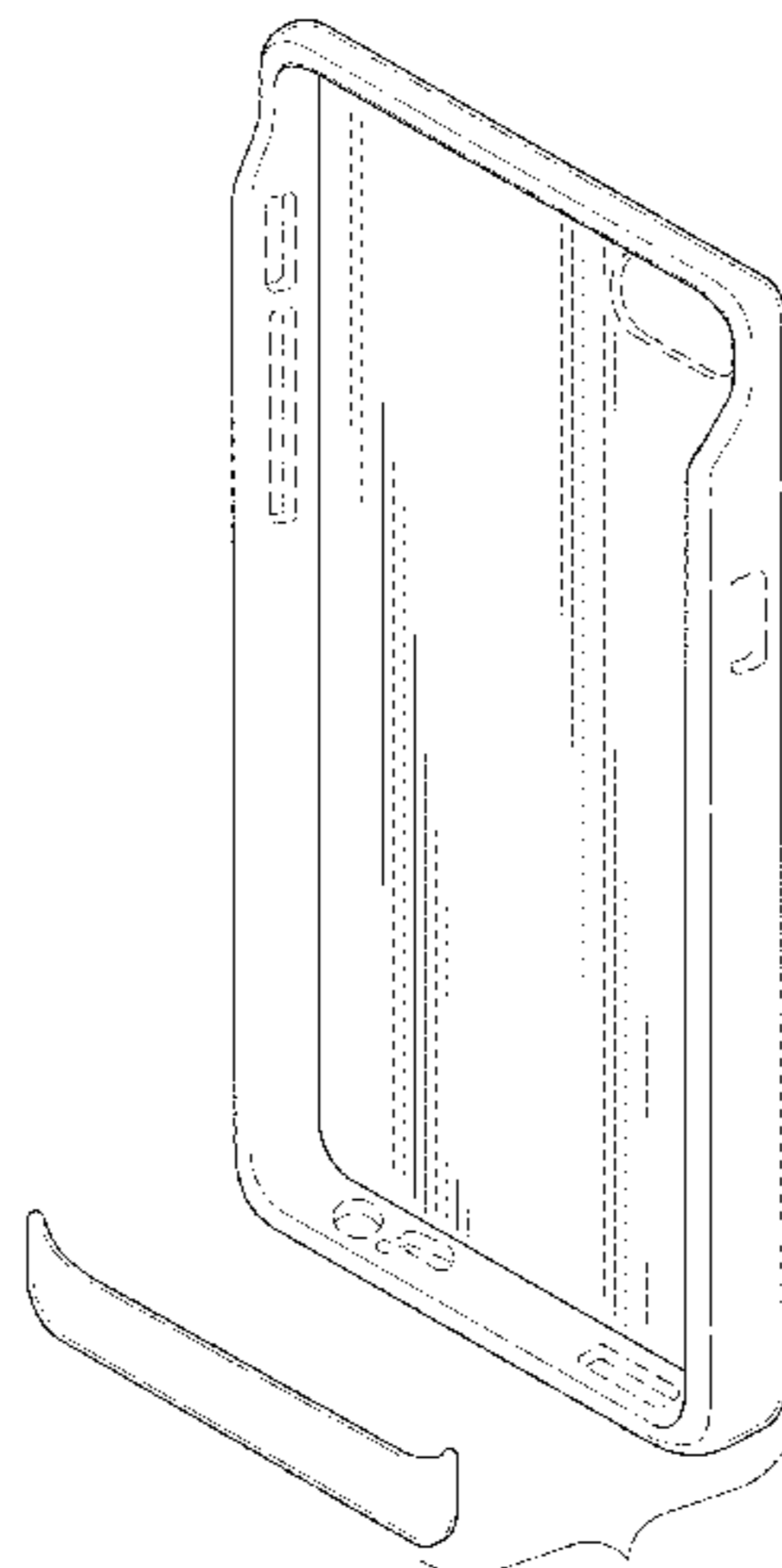
FIG. 1 is an exploded view of a case for an electronic device showing our new design;

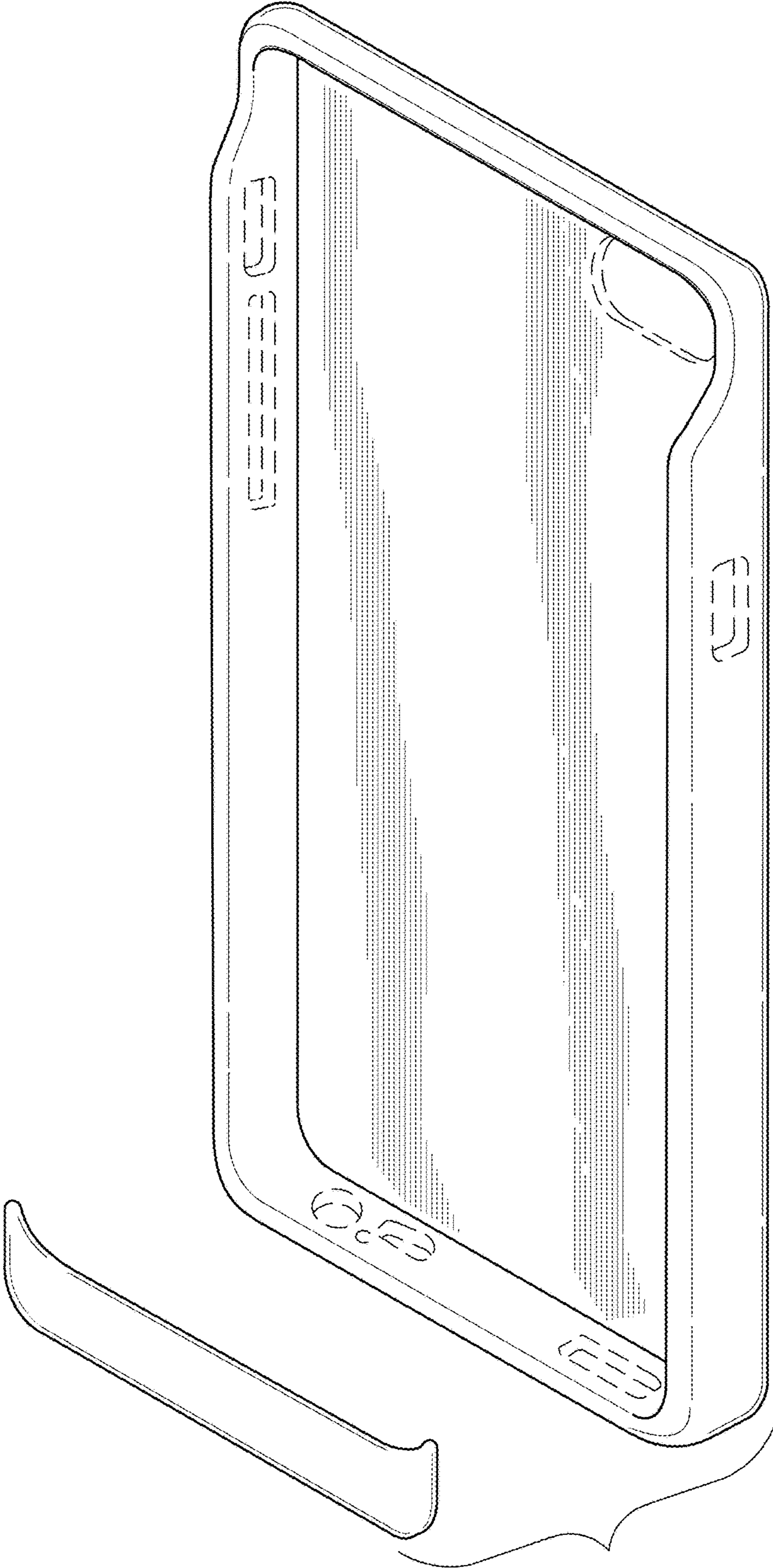

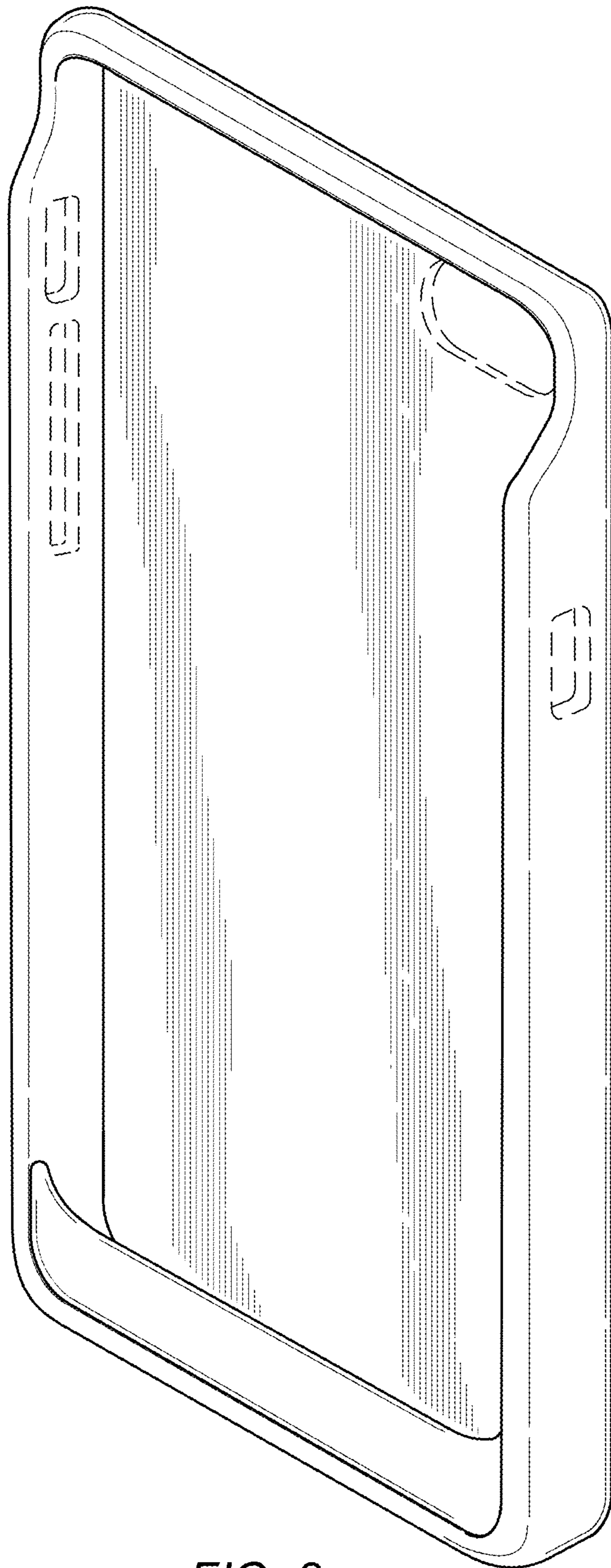

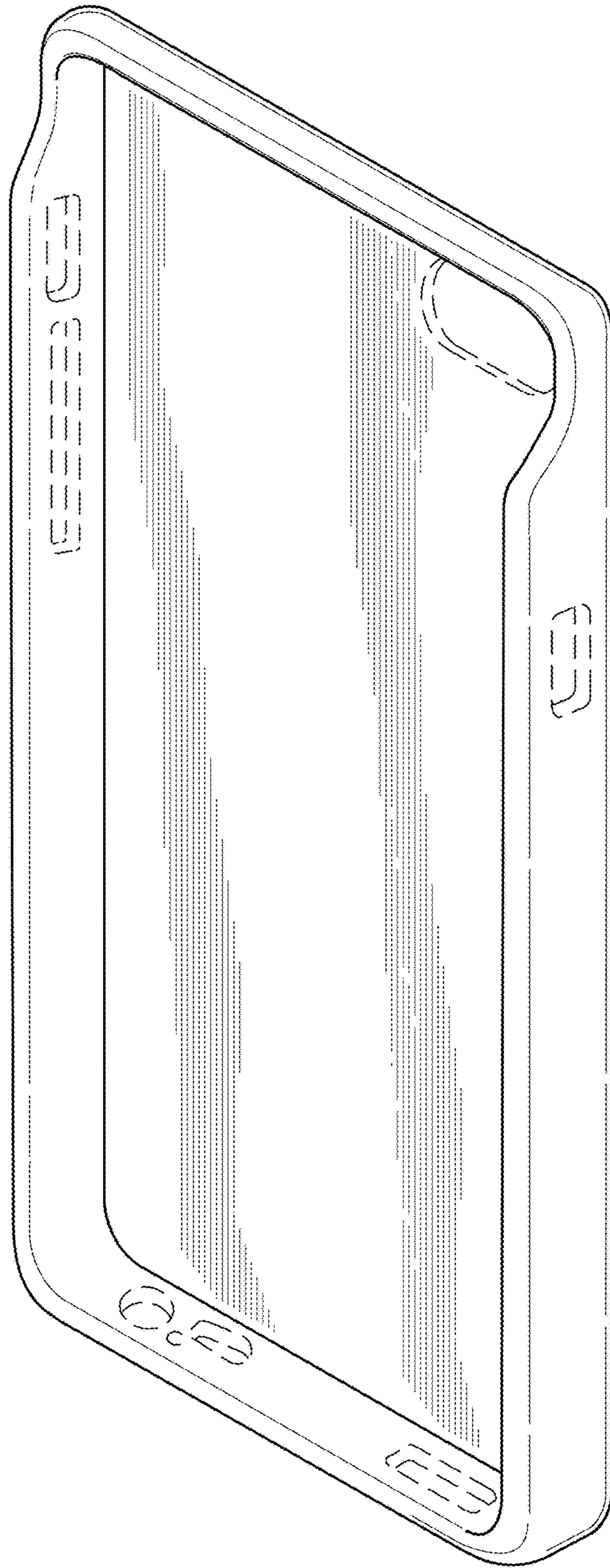

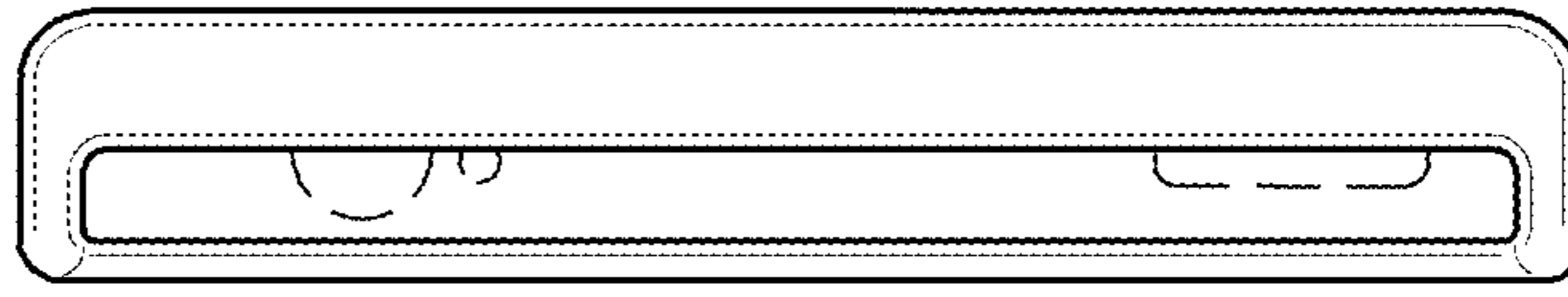

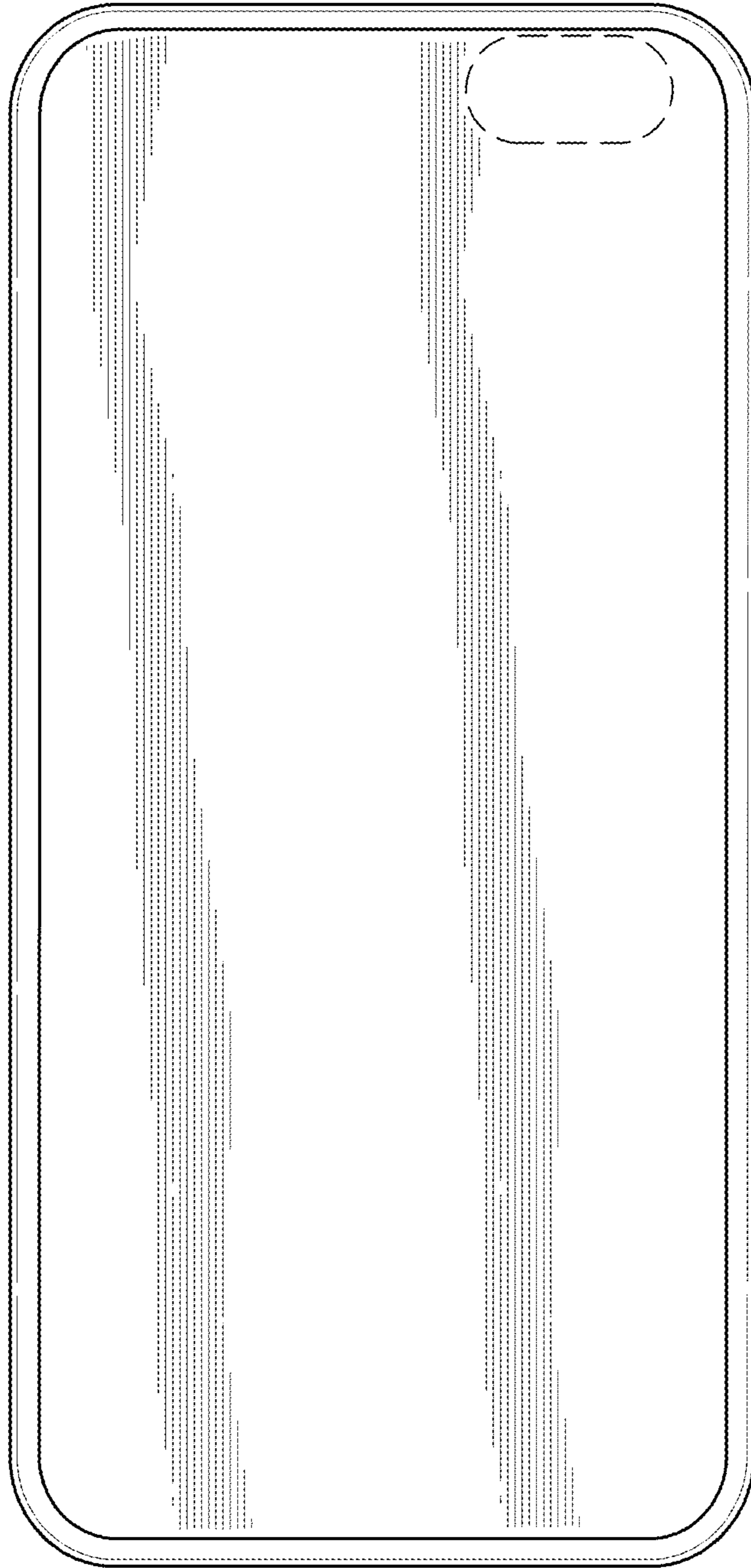

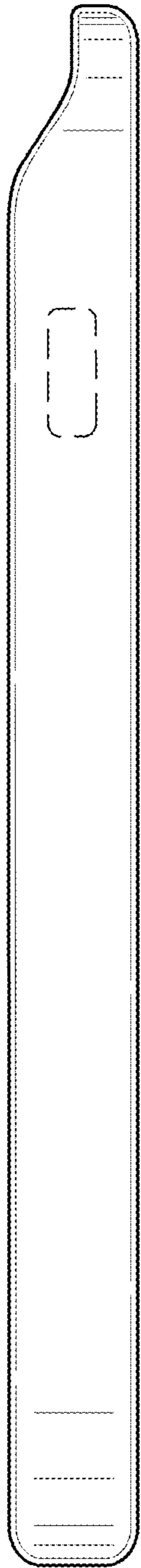

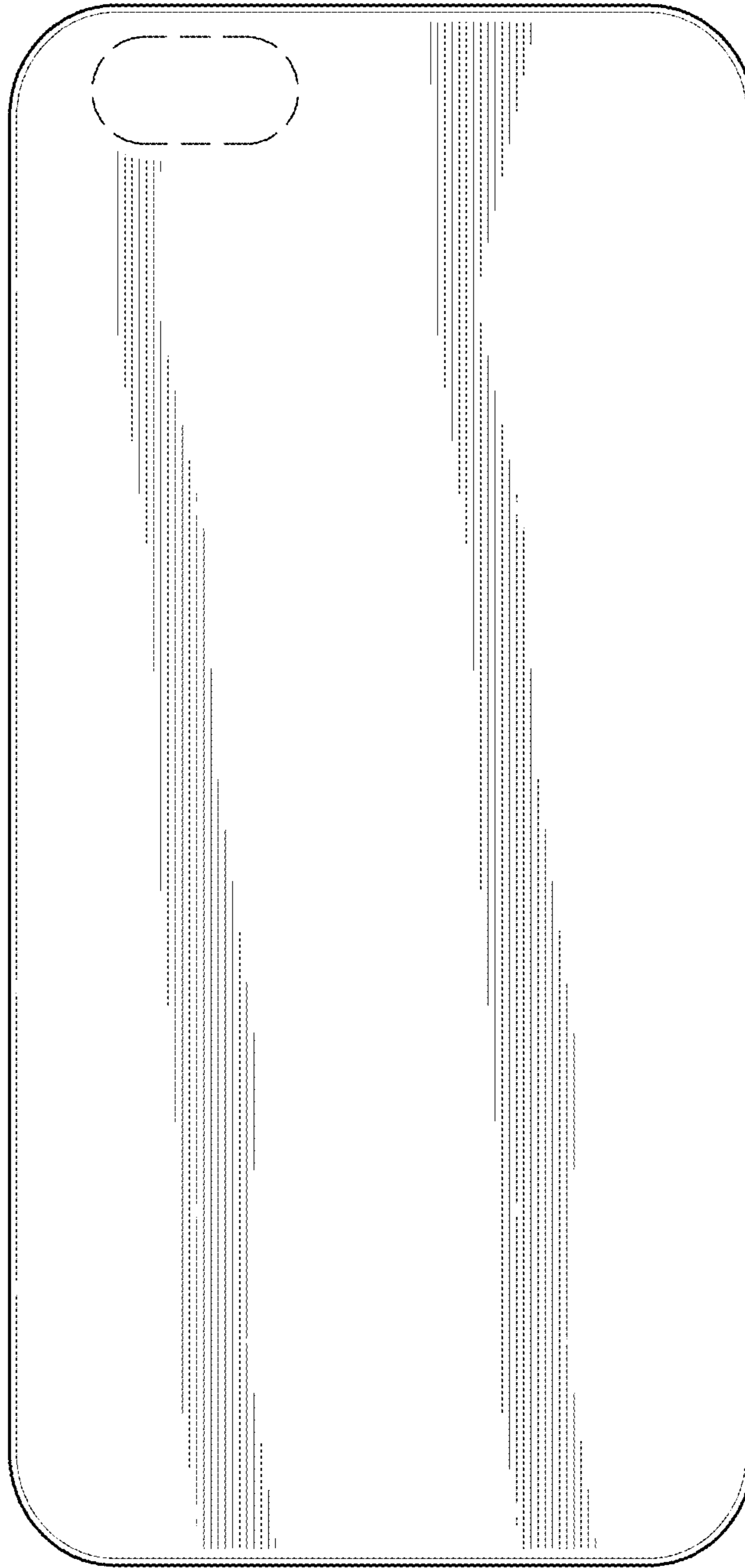

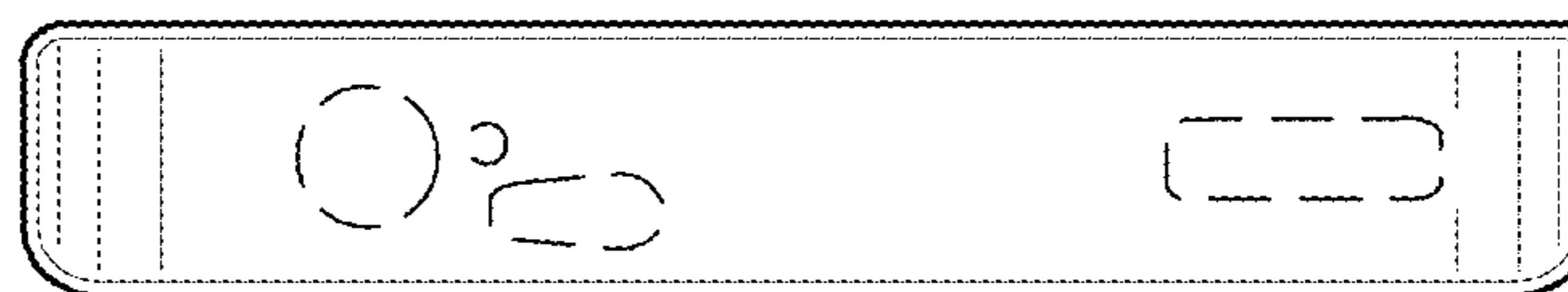

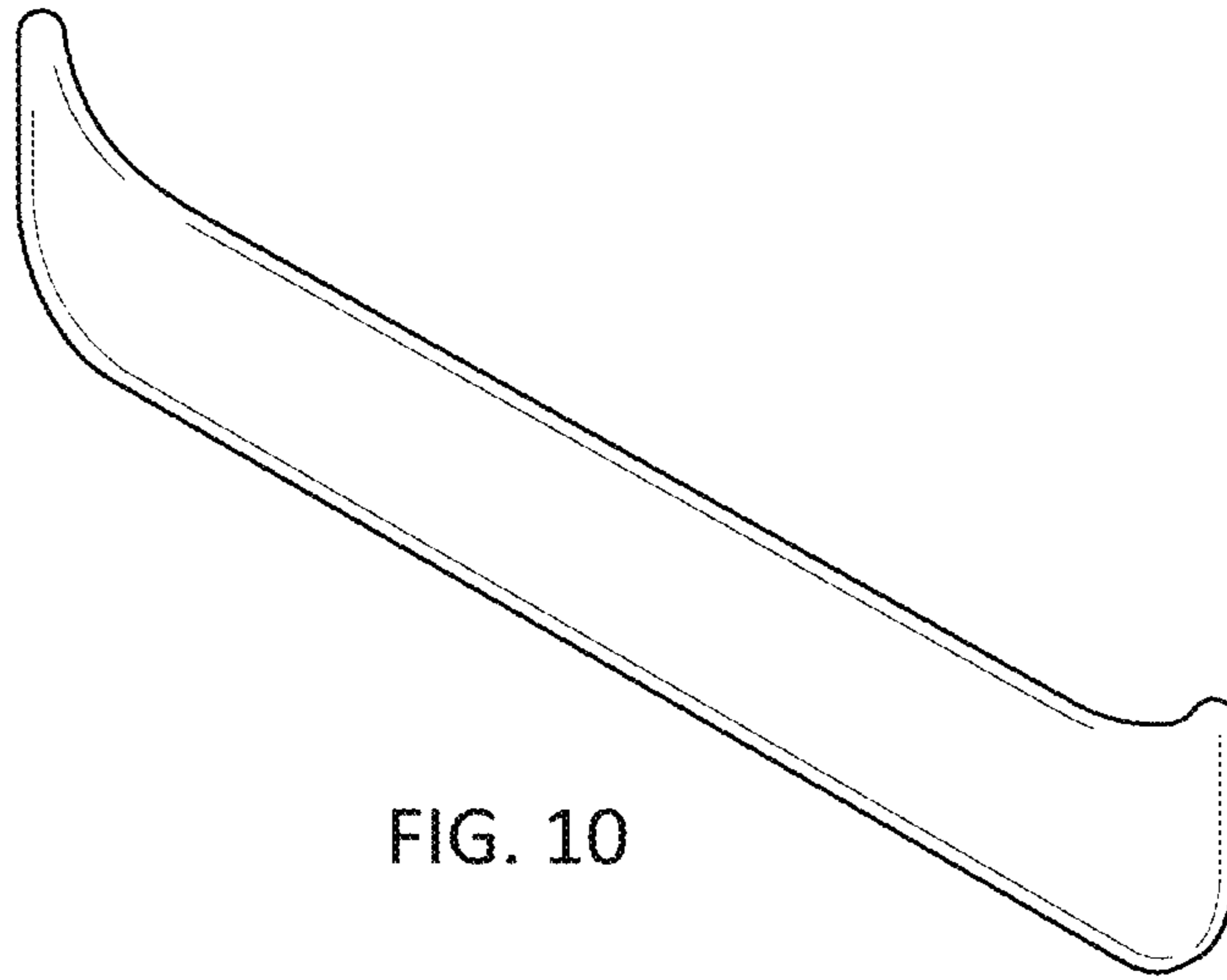

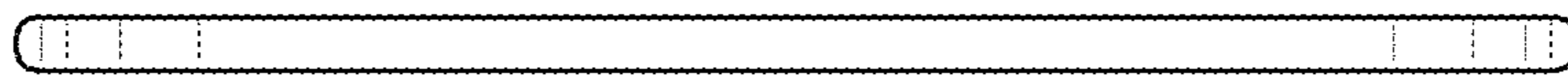

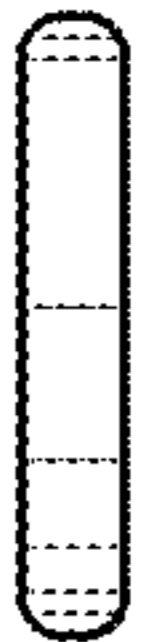

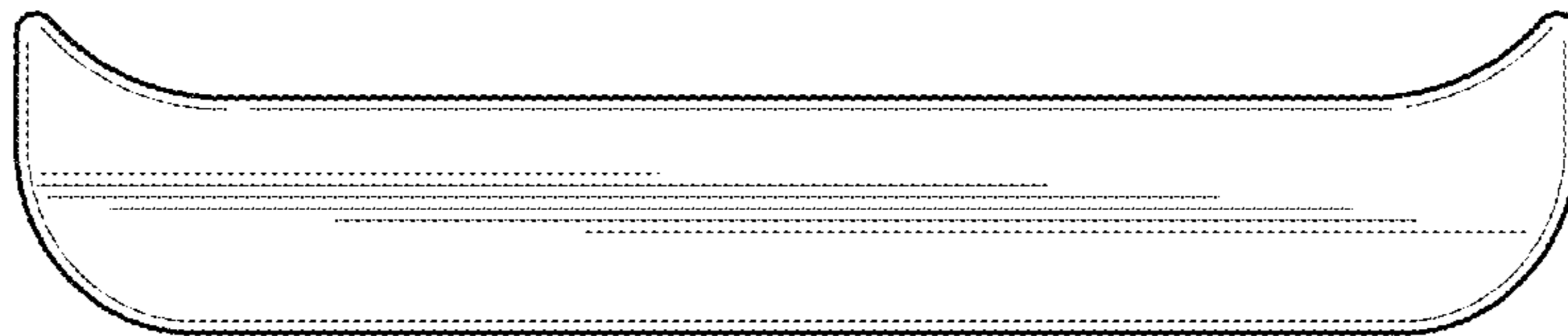

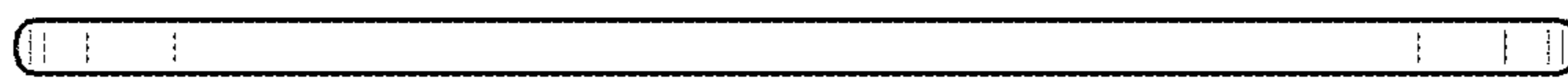

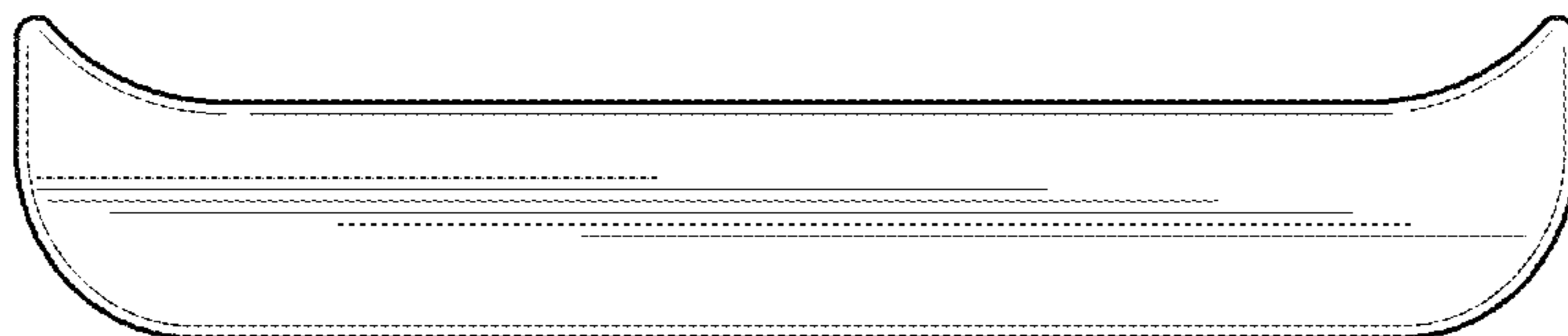
