The ornamental design for a holder for a mobile device, as shown and described.

DESCRIPTION

FIG. 1 is a front right perspective view of a holder for a mobile device according to the present invention.

FIG. 2 is a rear left perspective view of the holder for a mobile device of FIG. 1.

FIG. 3 is a left side view of the holder for a mobile device of FIG. 1.

FIG. 5 is a front side view of the holder for a mobile device of FIG. 1.

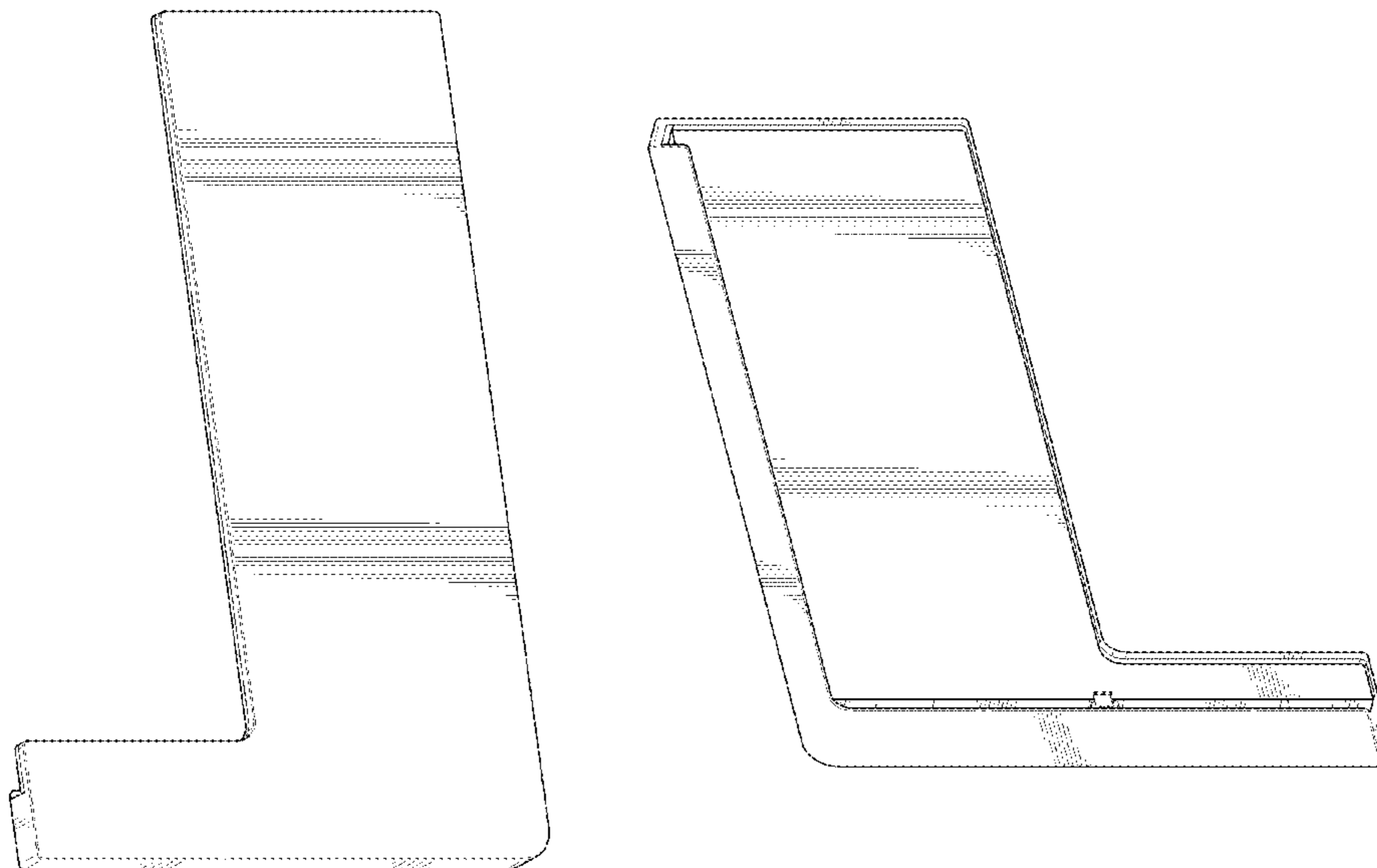
FIG. 6 is a bottom view of the holder for a mobile device of FIG. 1.

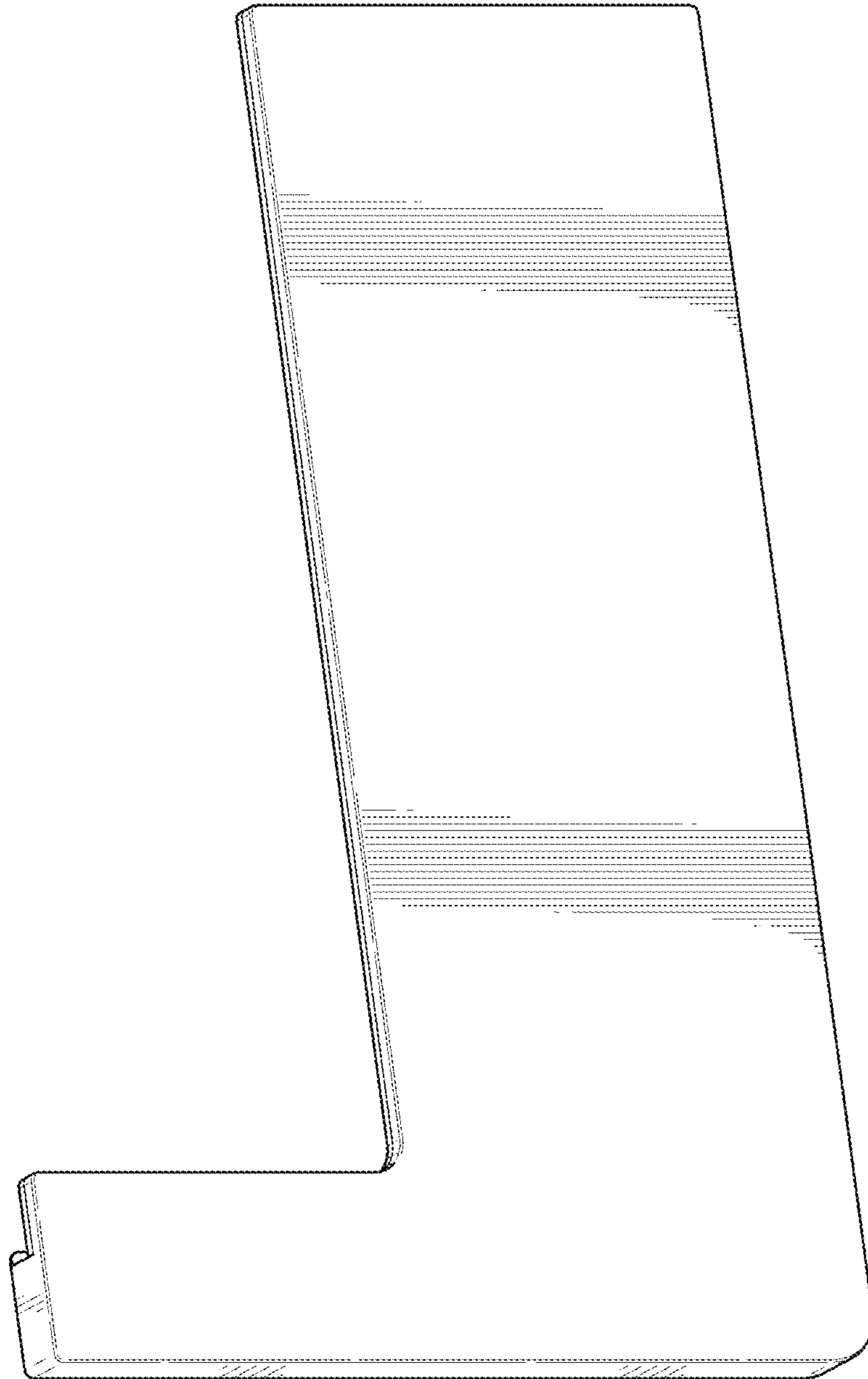

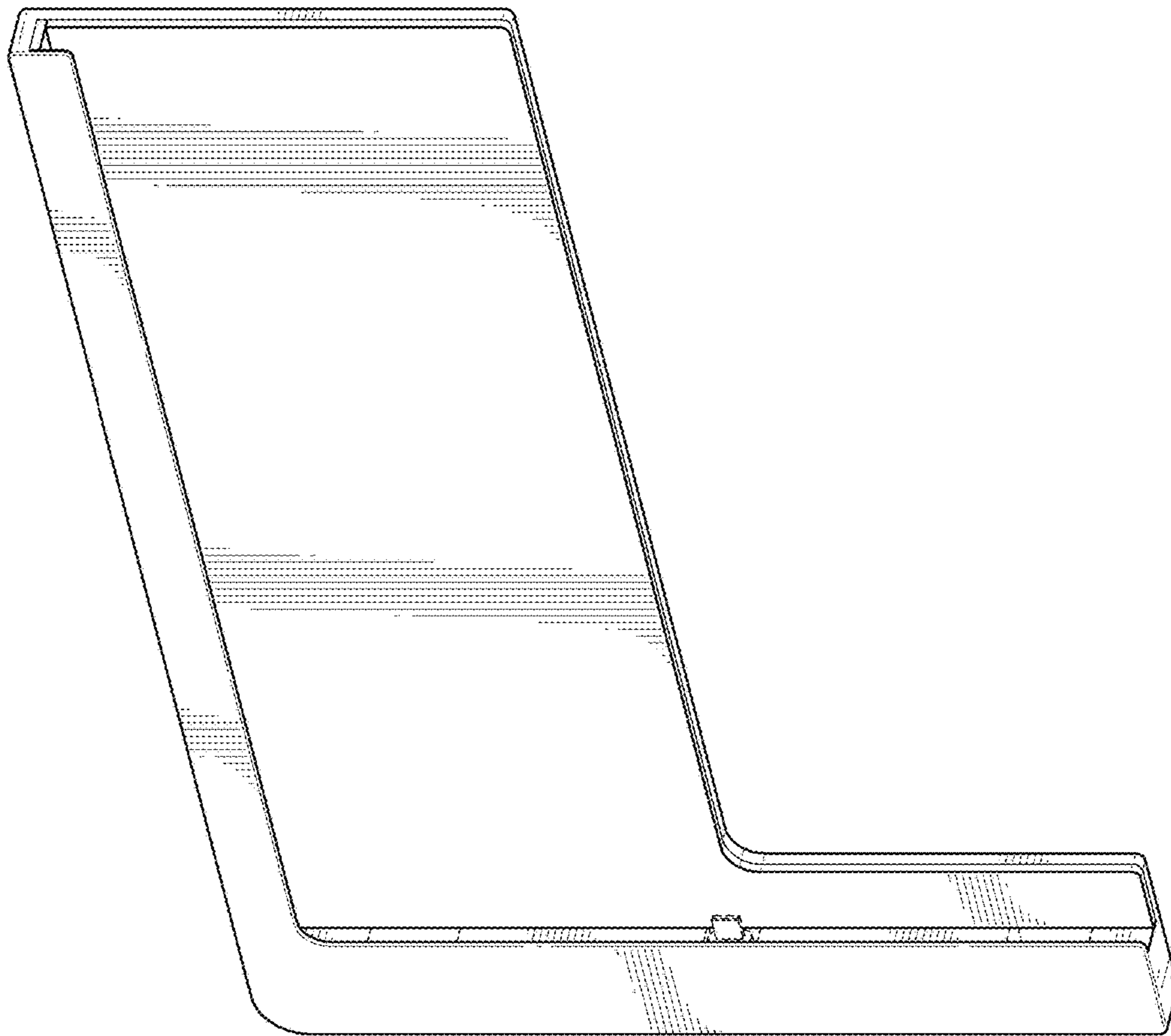

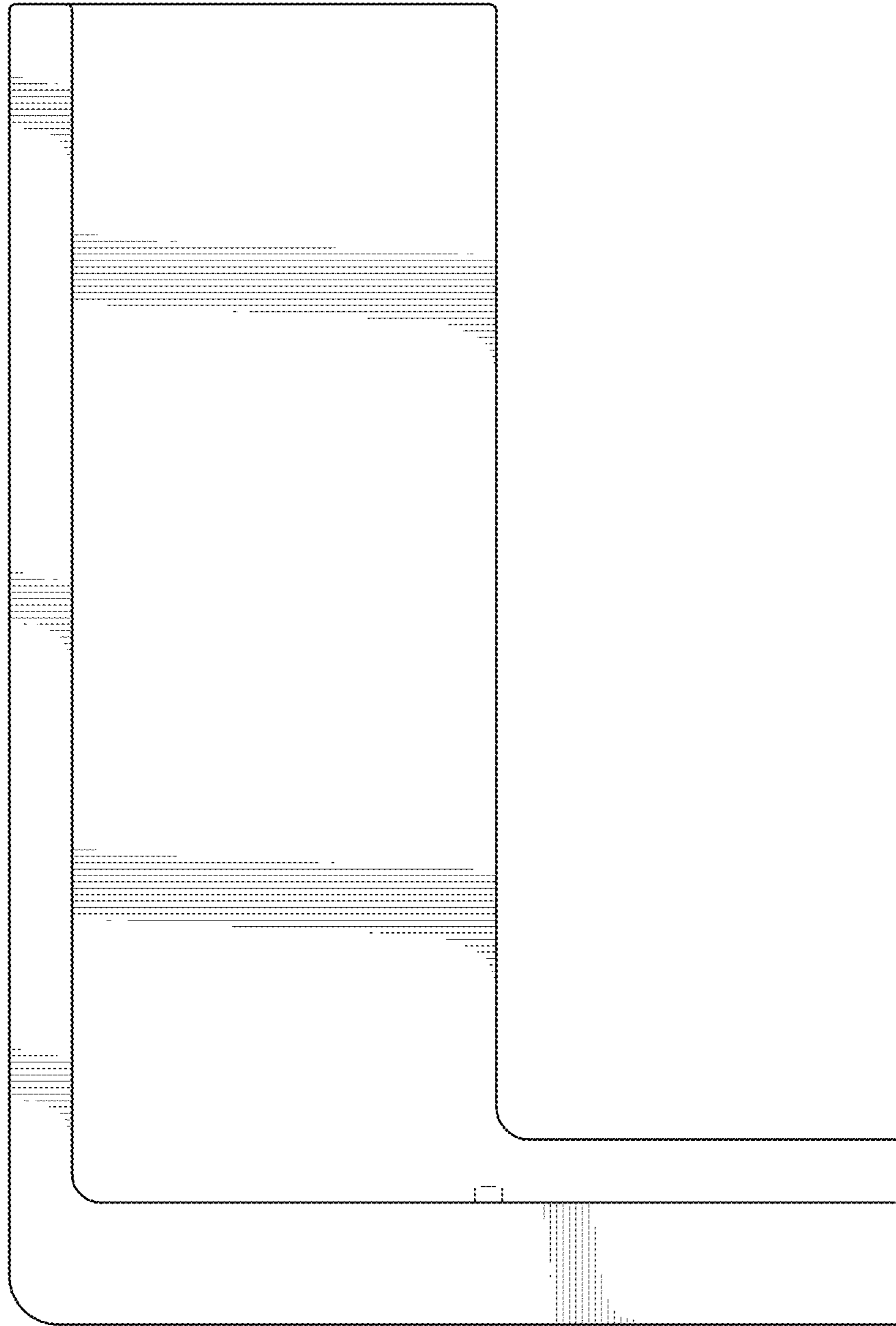

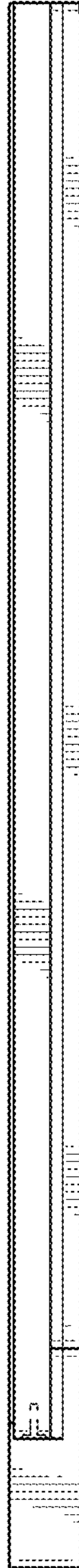

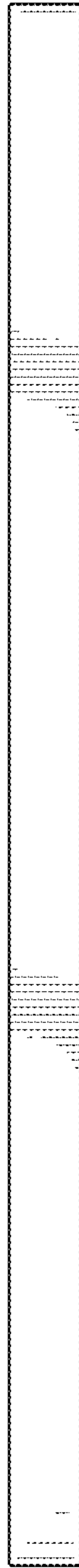
