CLAIM

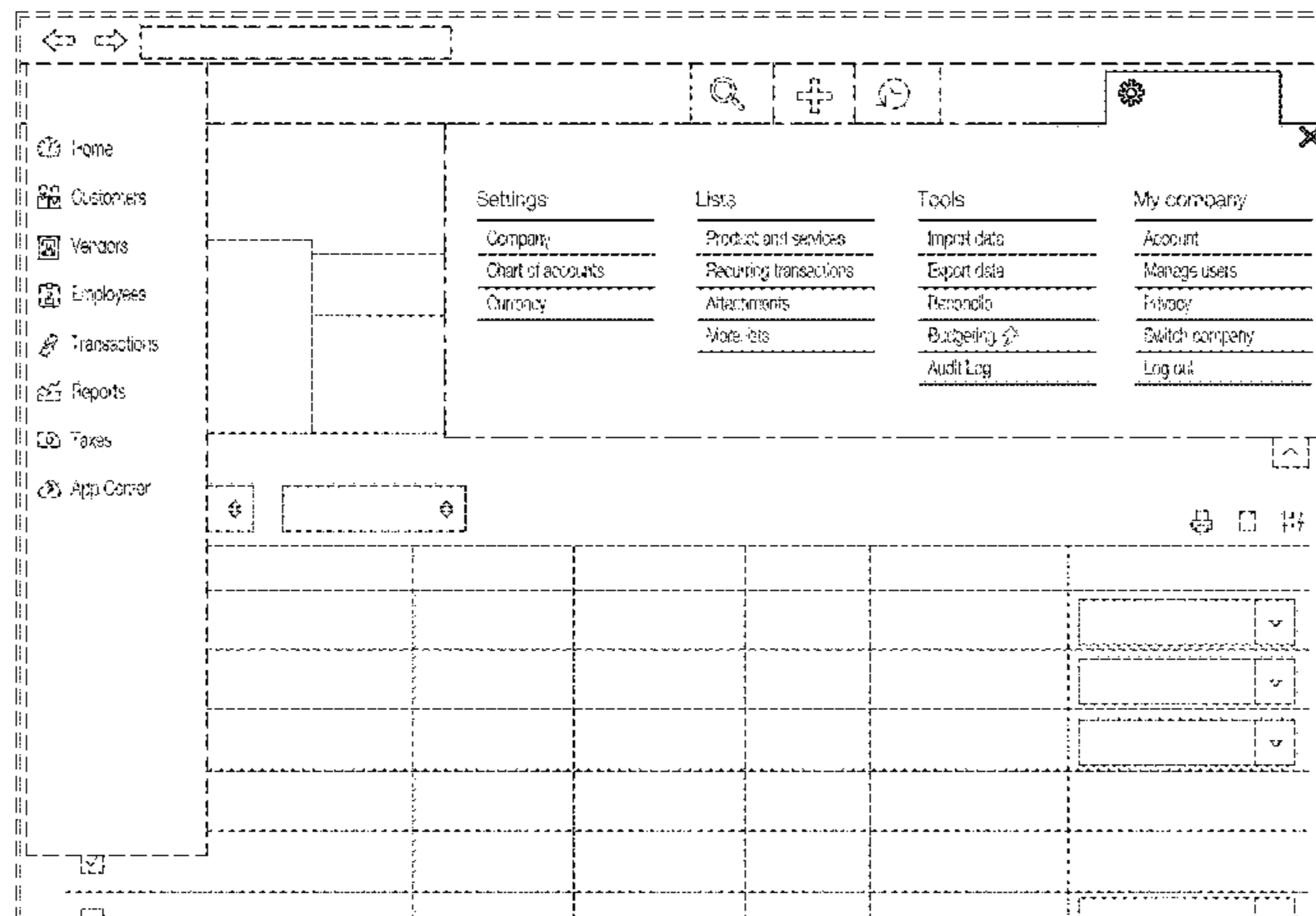
An ornamental design for a display device with a settings flyout for a graphical user interface, as shown and described.

DESCRIPTION

The sole FIGURE is a view of a display device with a settings flyout for a user interface, according to the invention.

The broken lines along the outer perimeter represent a display device, illustrating the environment of the article, and form no part of the claimed design. The dot dashed line represents a boundary of the settings flyout, and form no part of the claimed design. The remaining broken lines show portions of the graphical user interface and form no part of the claimed design.
