(57) **CLAIM**

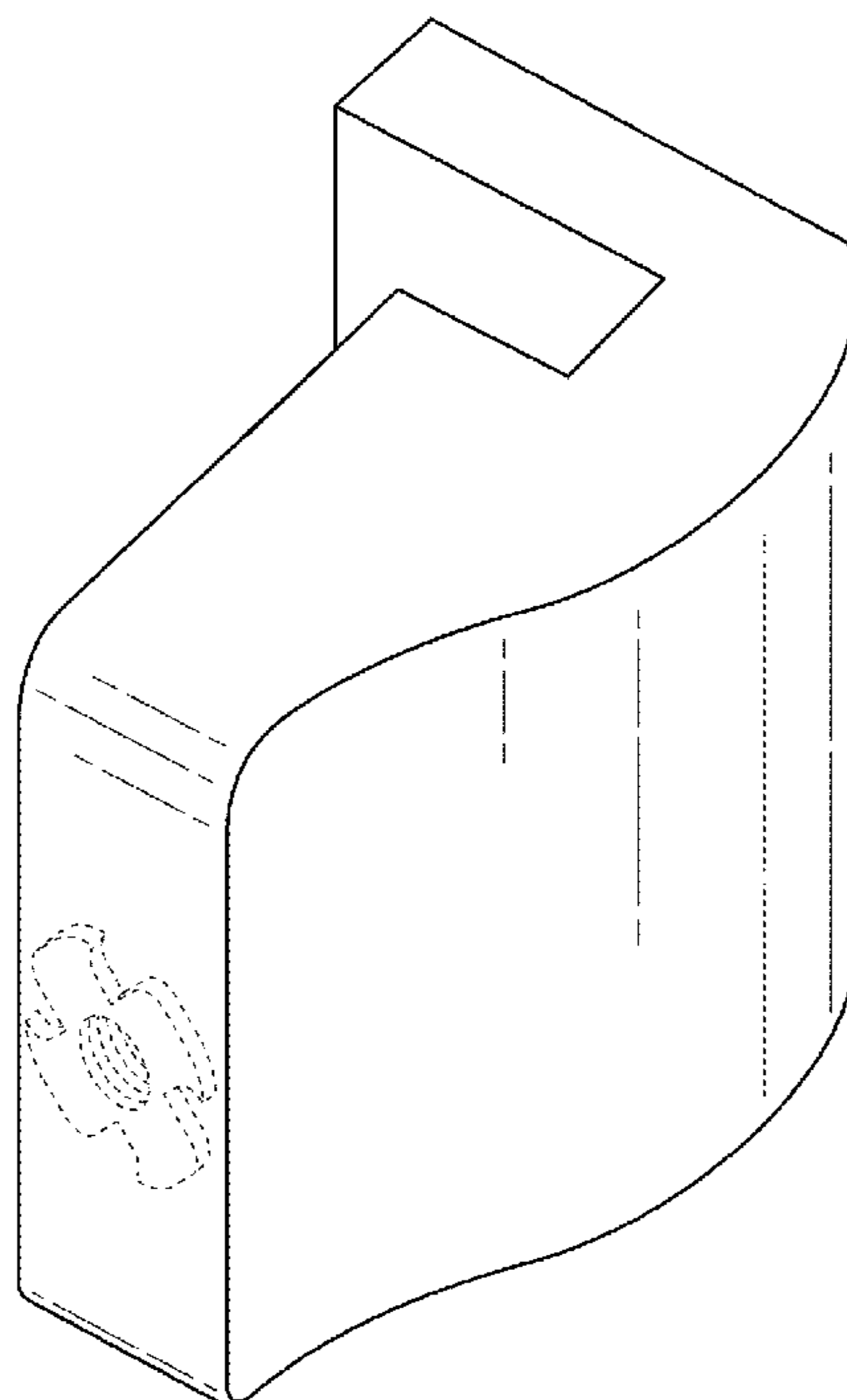
The ornamental design for a sided handle for a camera, as shown and described.

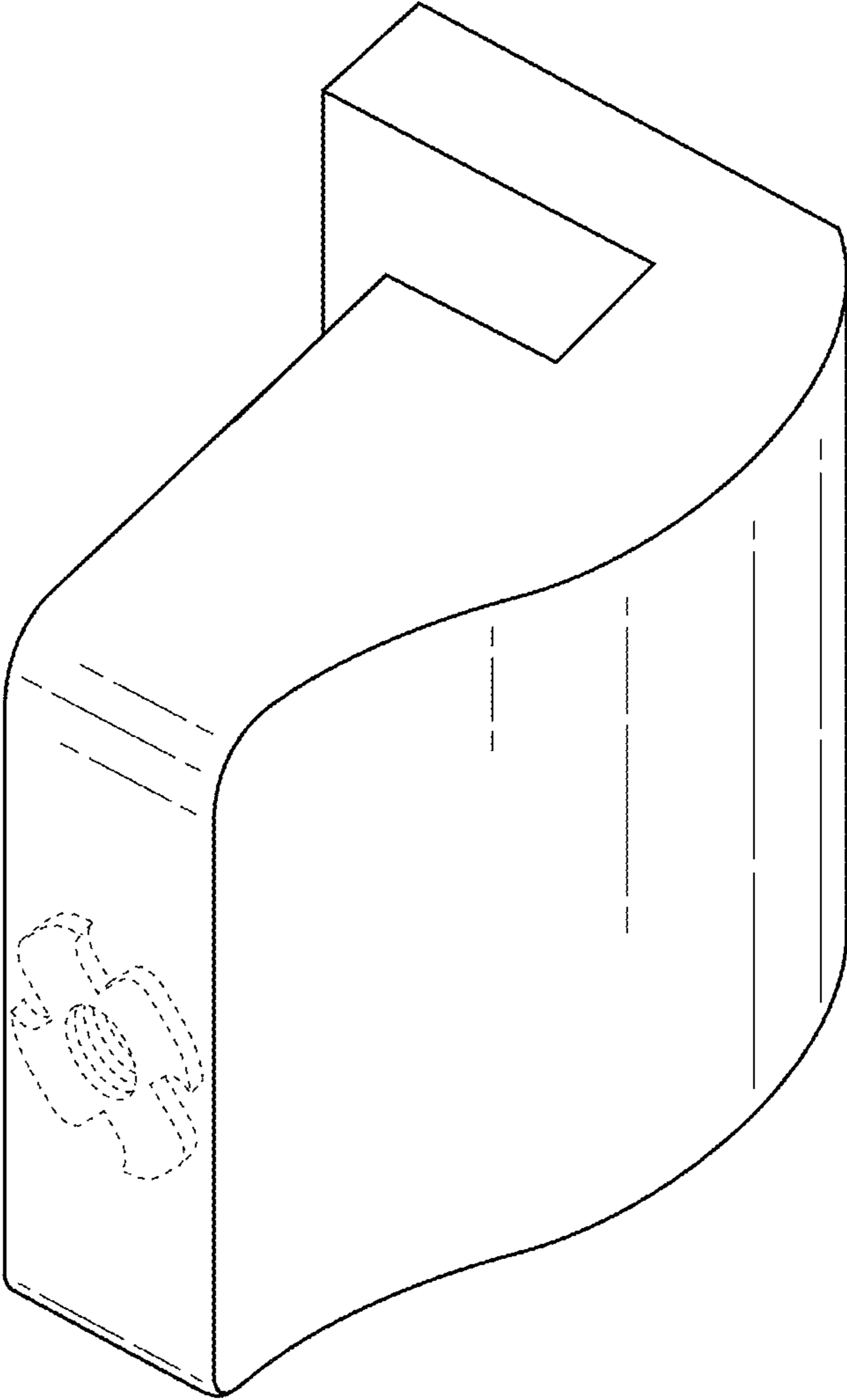

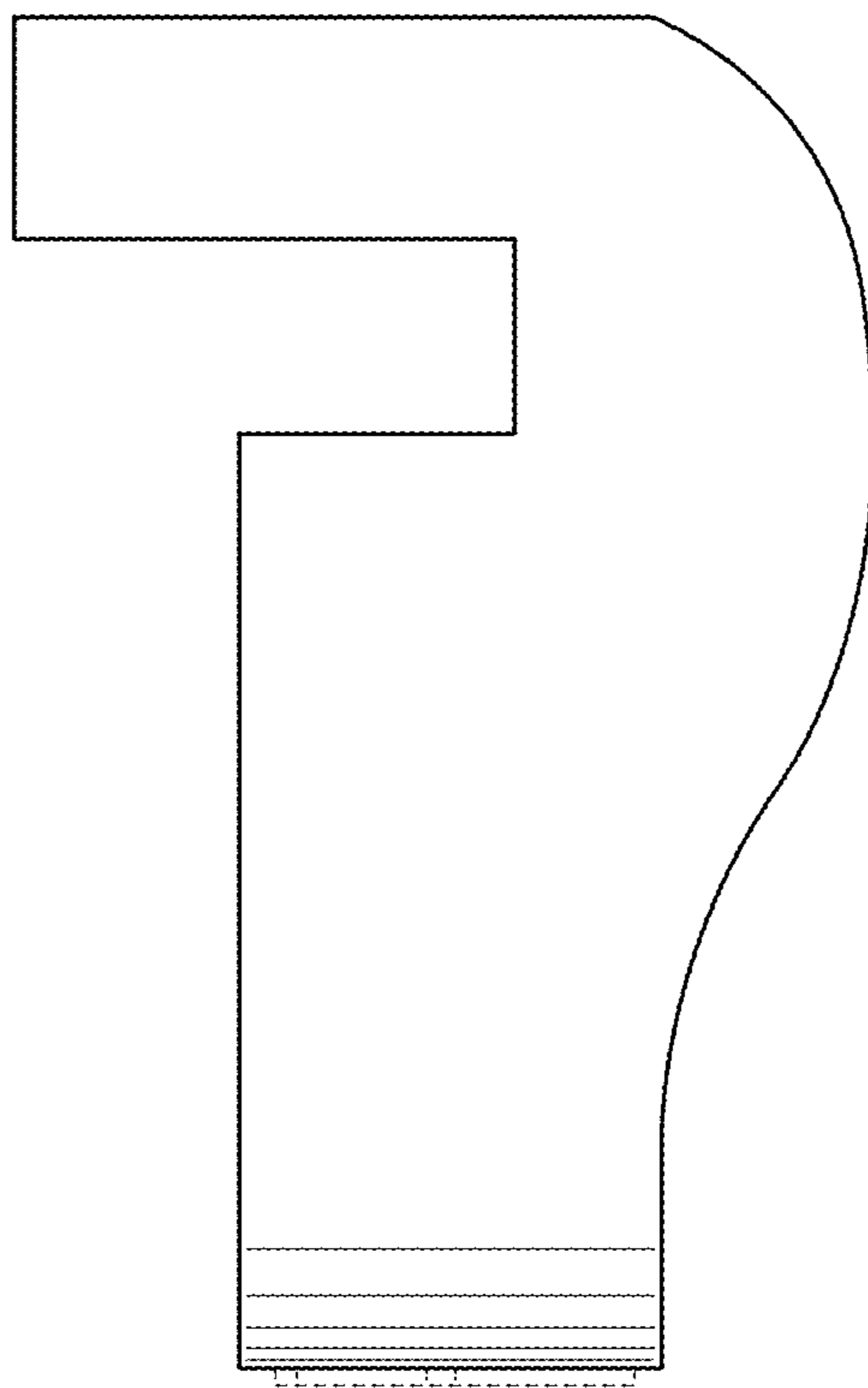
