DESCRIPTION

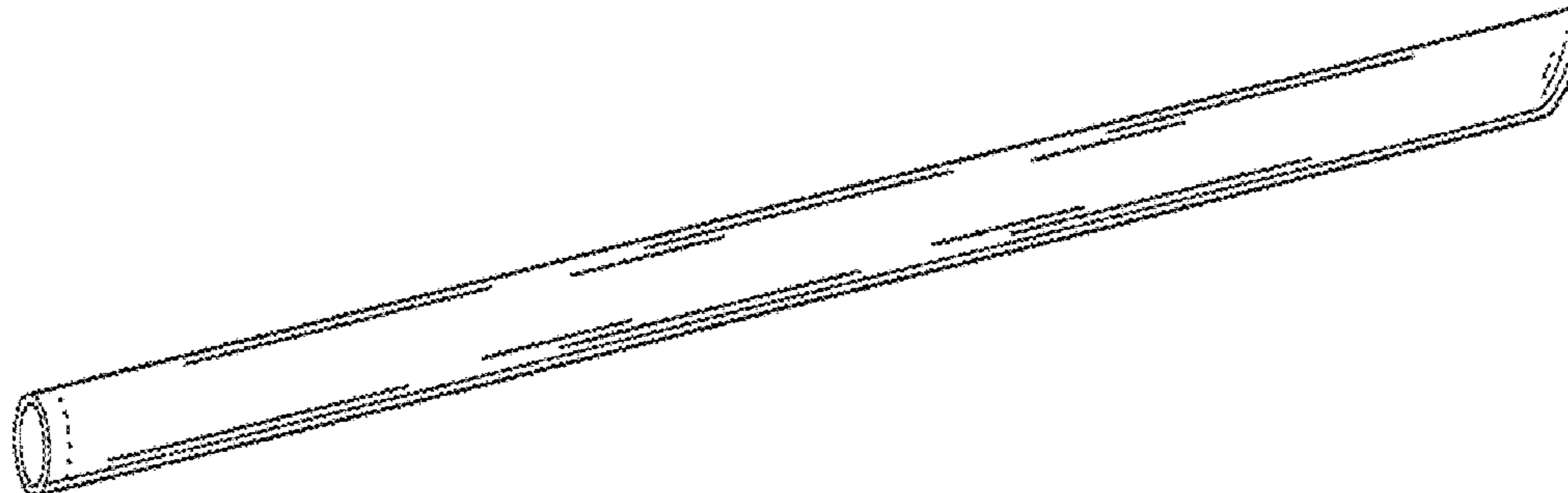
FIG. 1 is a top right front perspective view of eyewear stem protection showing my new design.

FIG. 5 is a left side elevation view of FIG. 1; the right side elevation view is the mirror image of FIG. 5

FIG. 7 is a right side elevation view in an environment.

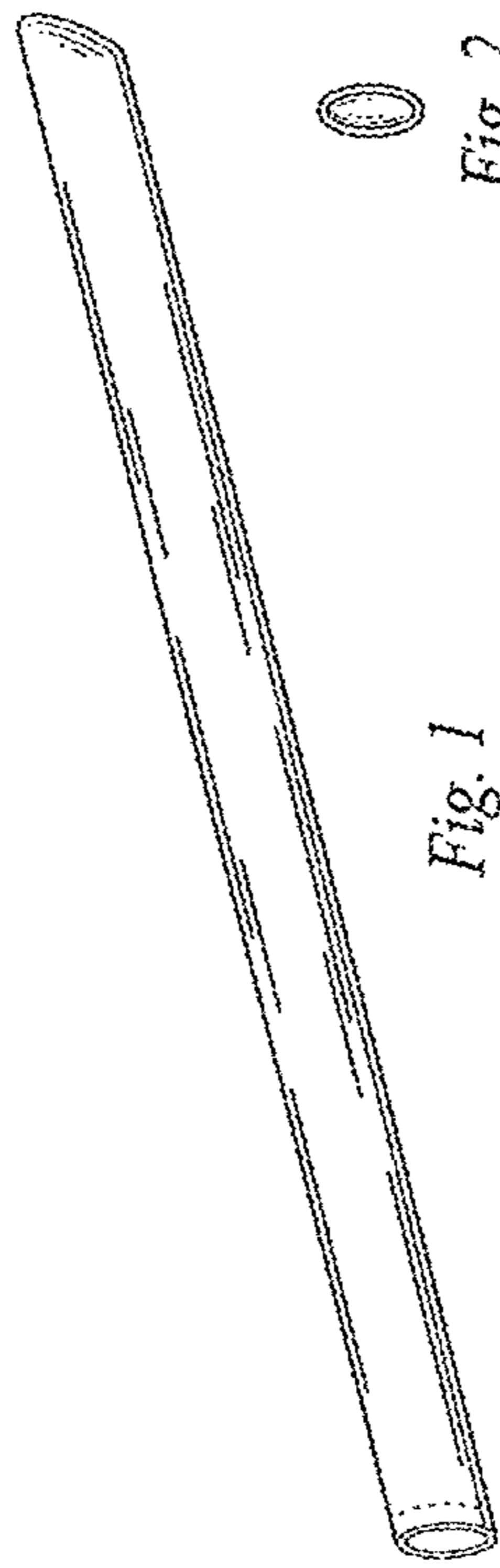

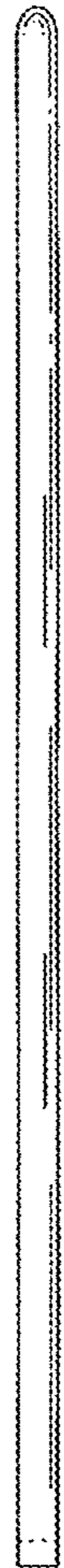

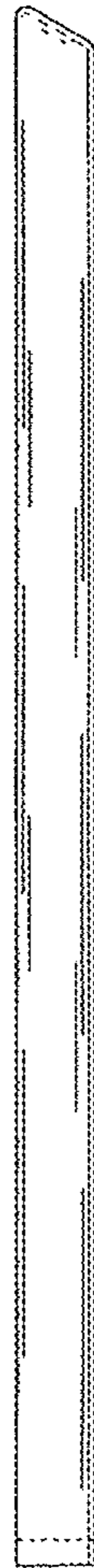

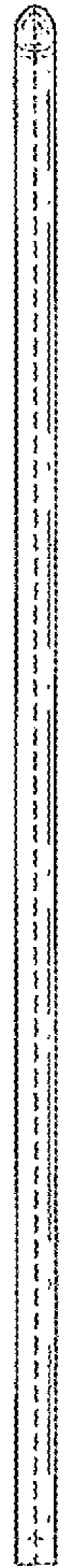

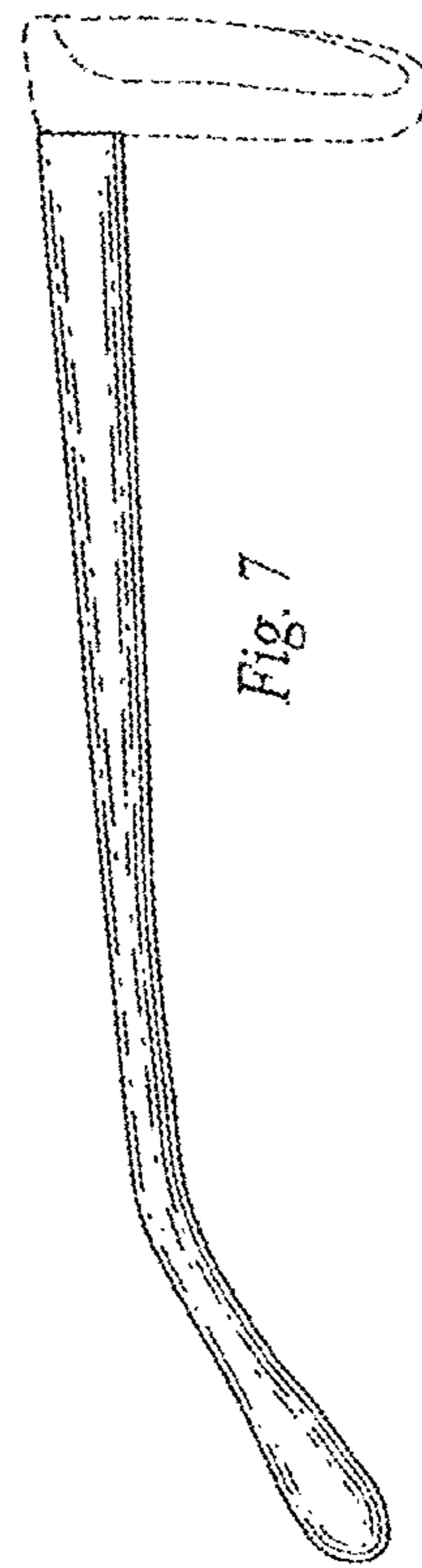
