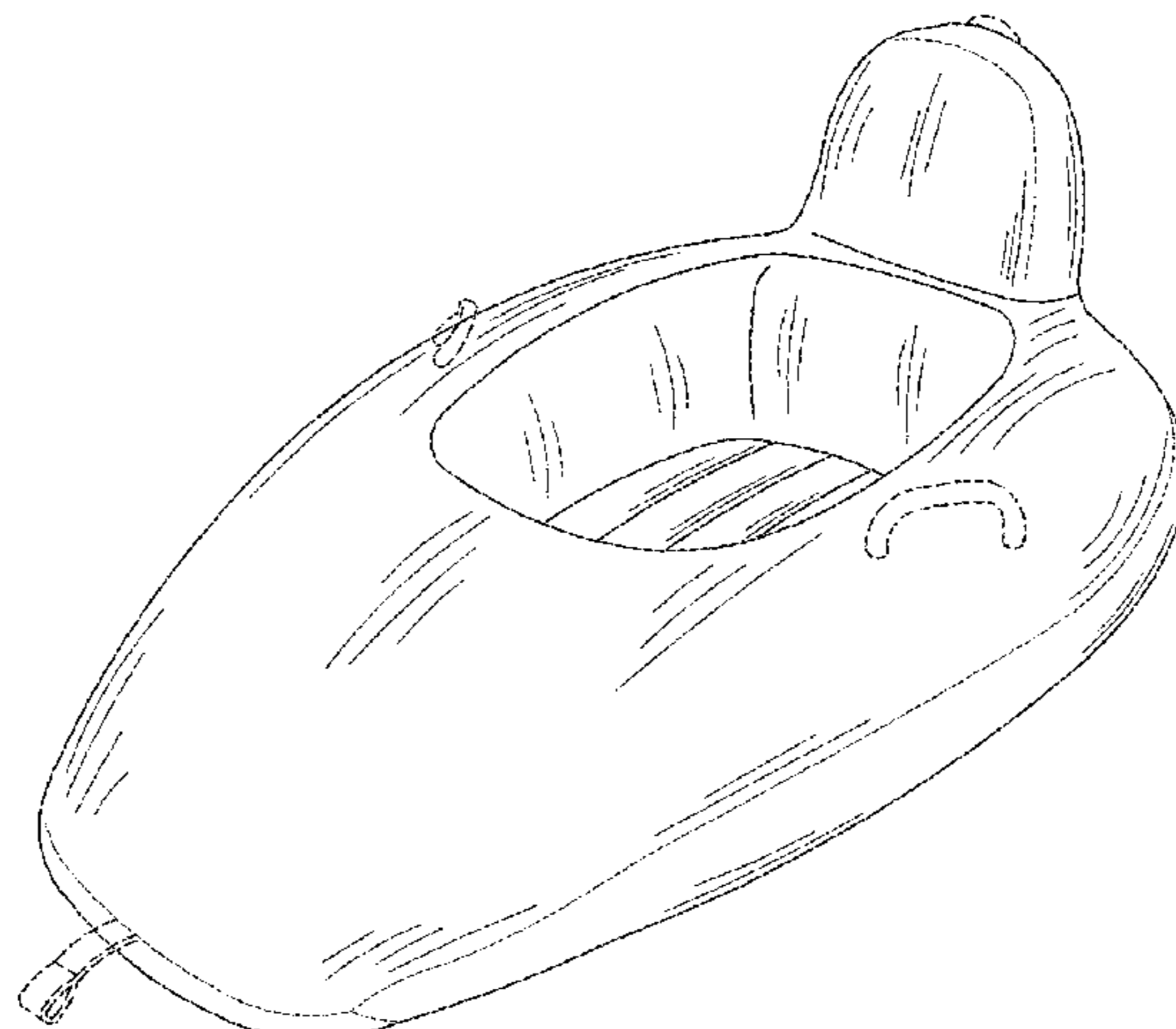
(57) **CLAIM**

The ornamental design for an inflatable towable vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing my new design; FIG. 2 is a top plan view thereof; FIG. 3 is a front elevation view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a rear elevational view thereof; and, FIG. 7 is a bottom plan view thereof. The broken lines illustrate stitching and portions of the inflatable towable vehicle. None of the broken lines form part of the claimed design.

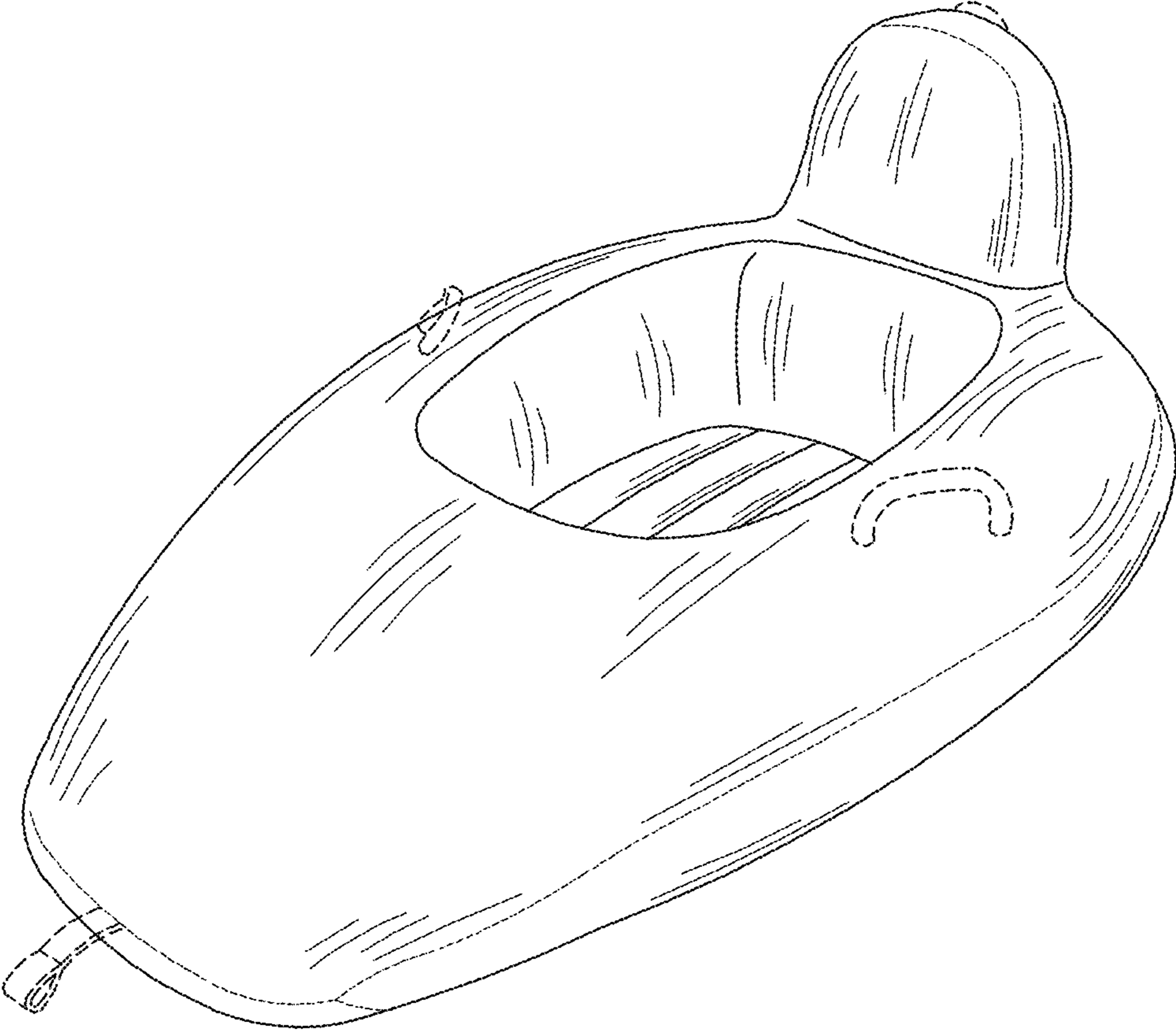

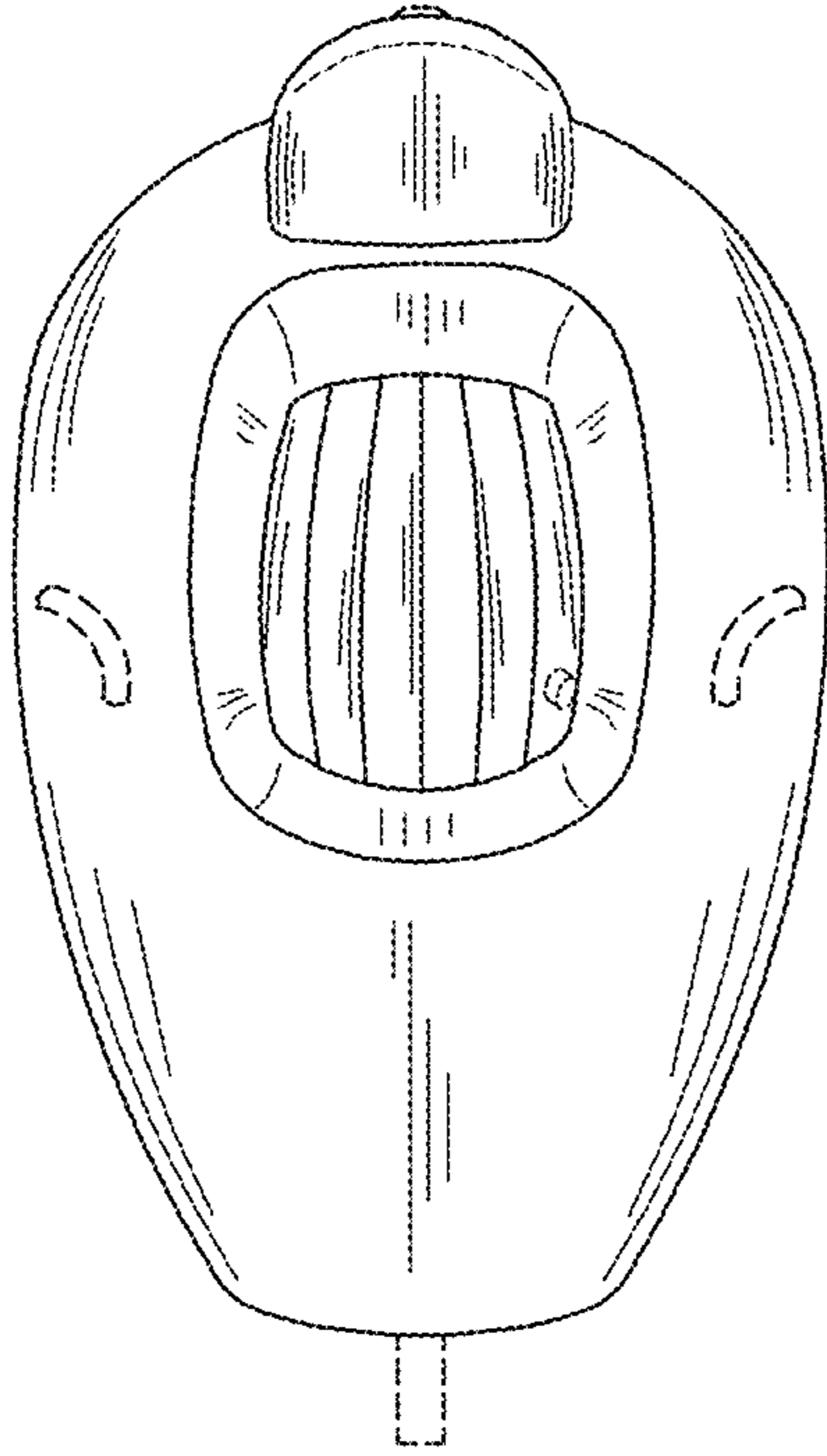

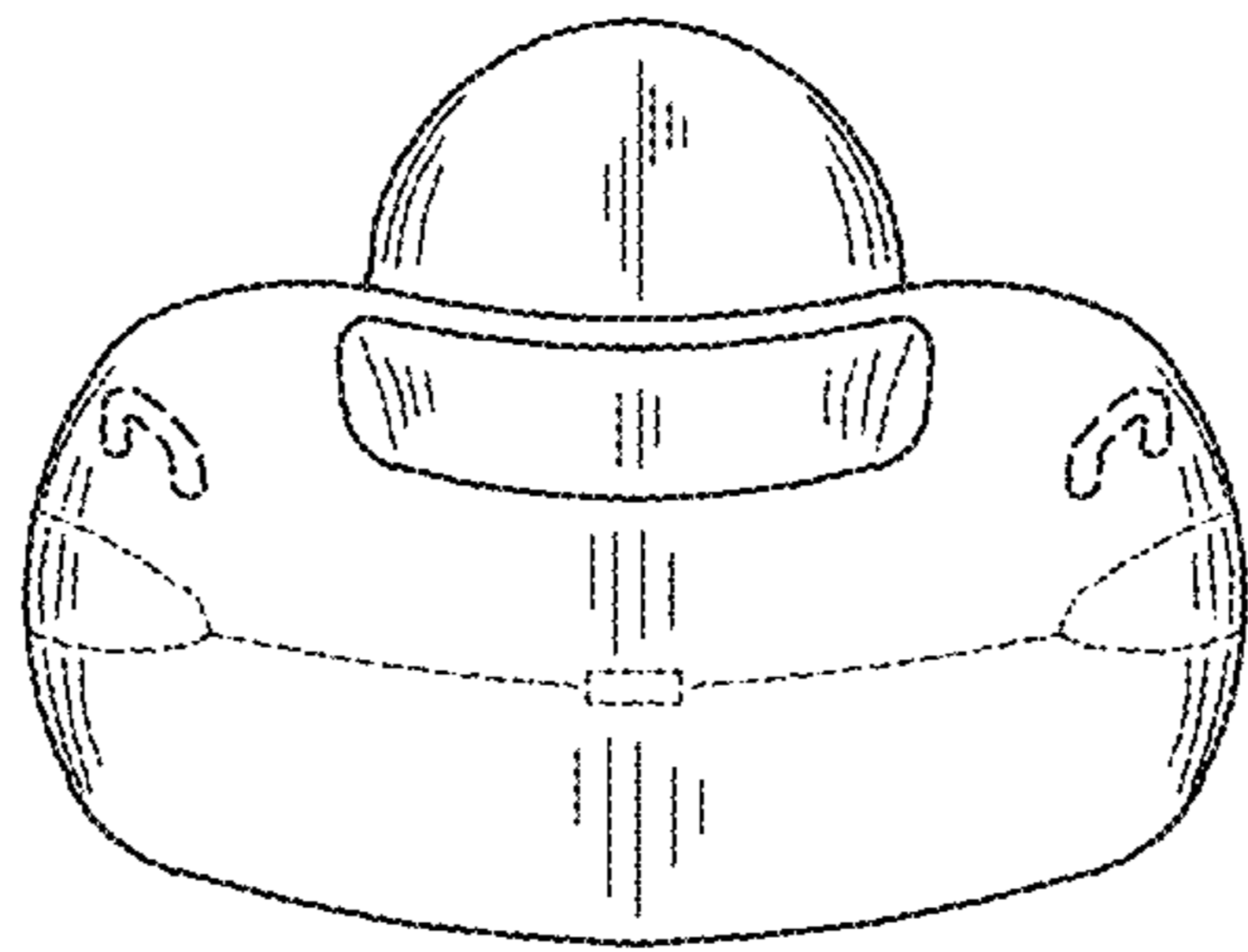

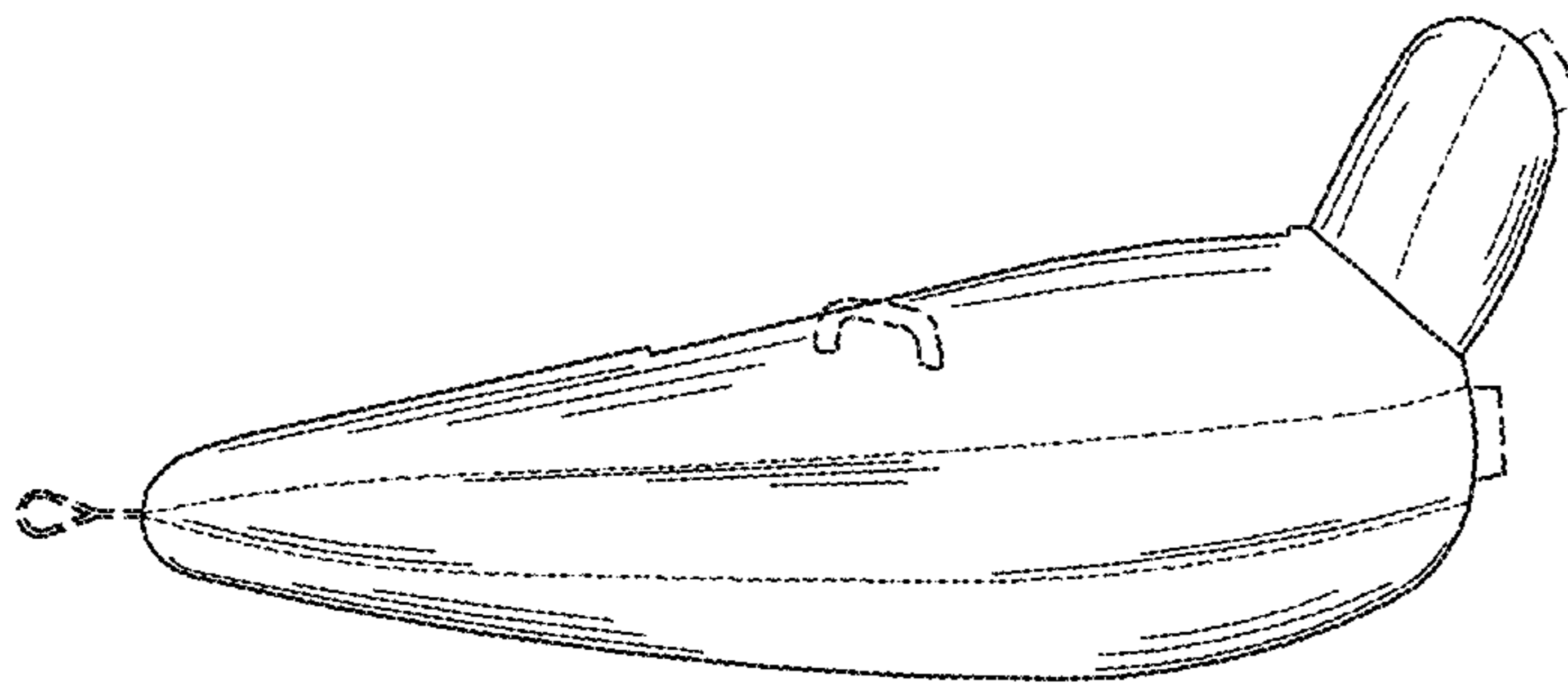

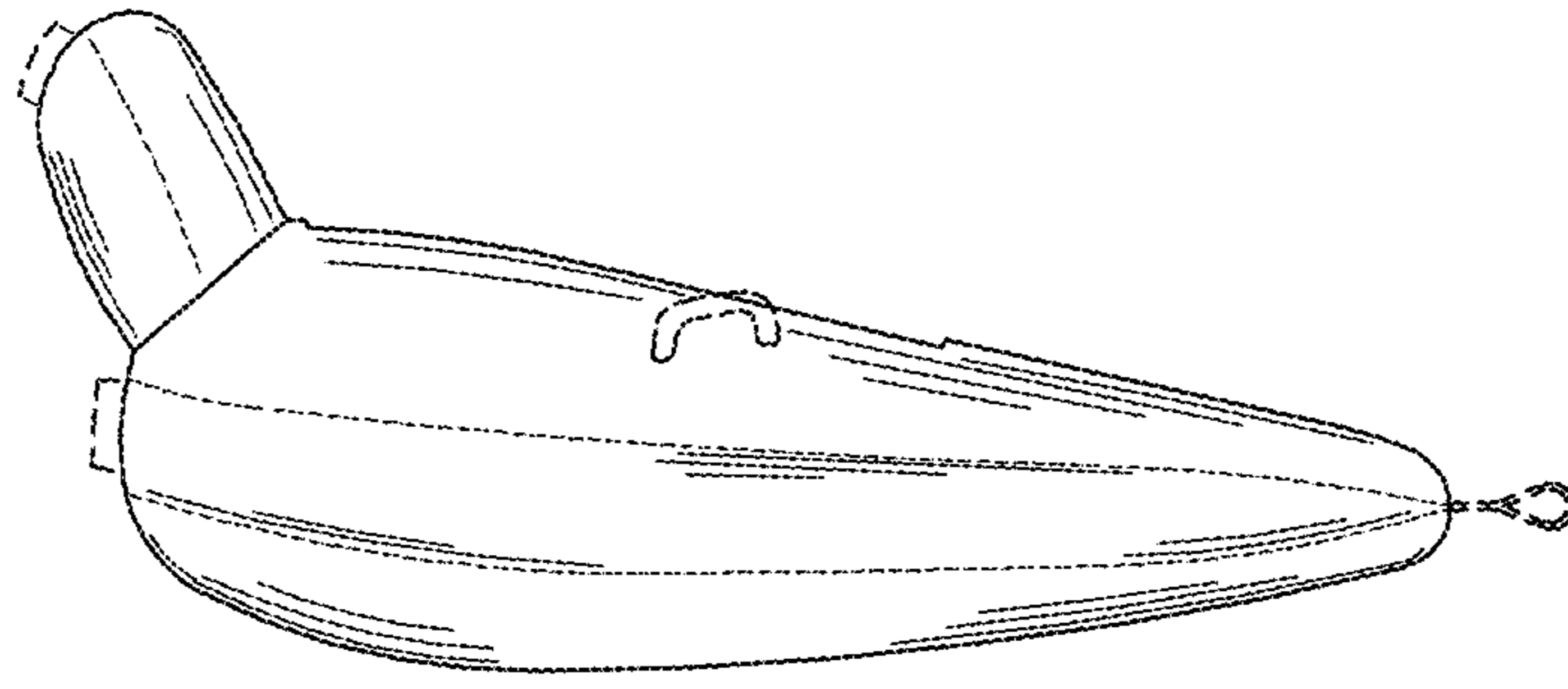

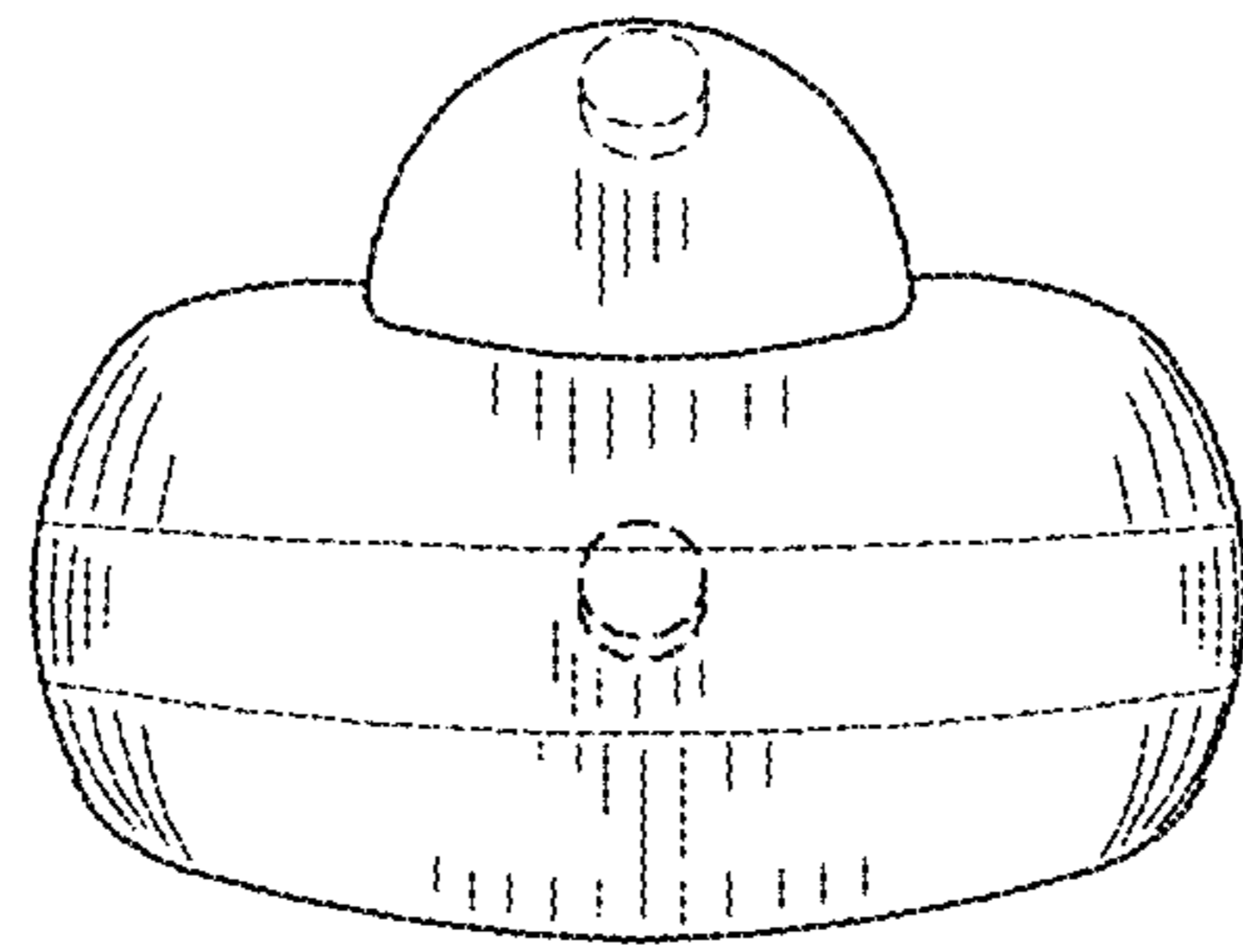

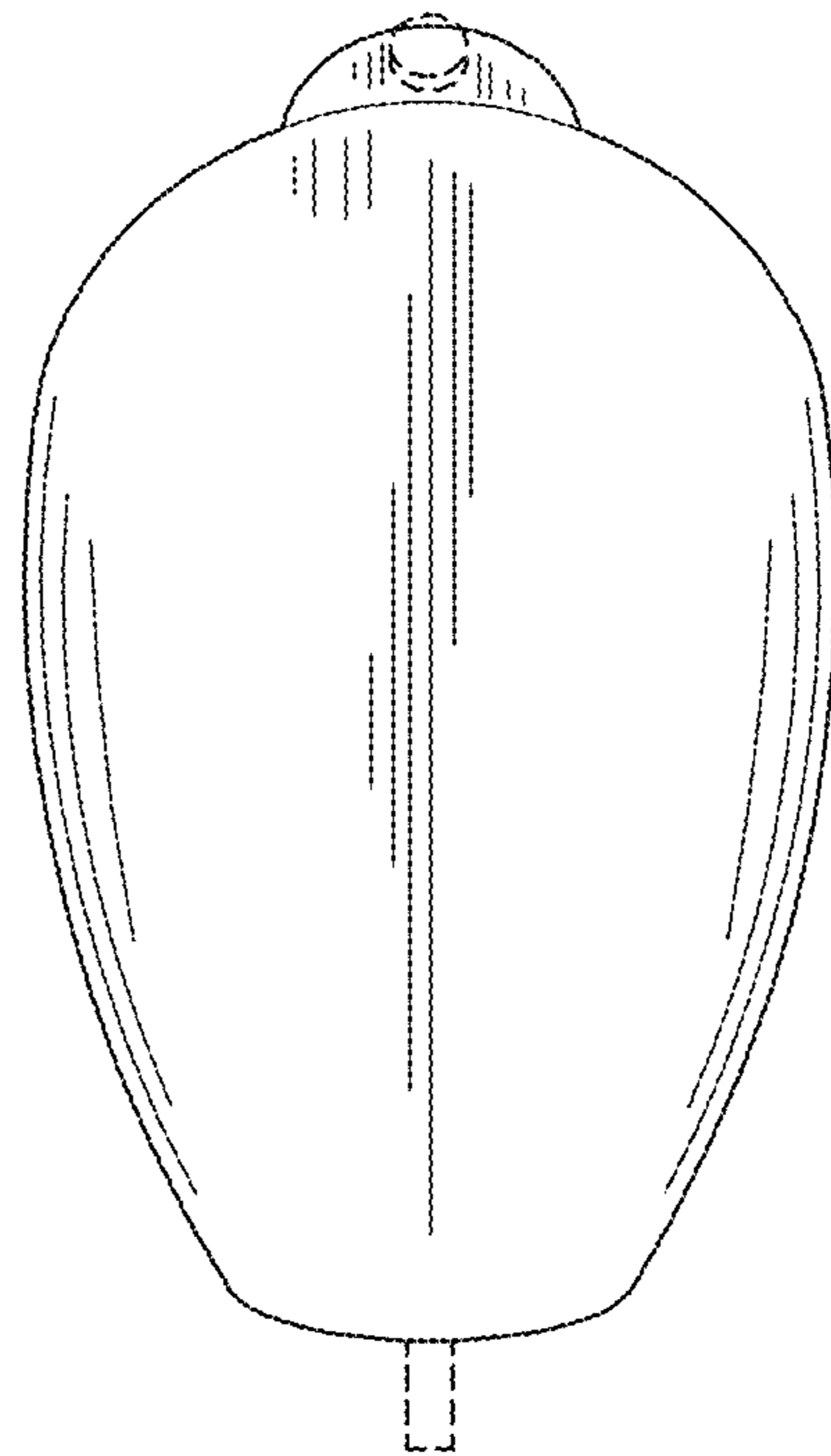
