**DESCRIPTION**

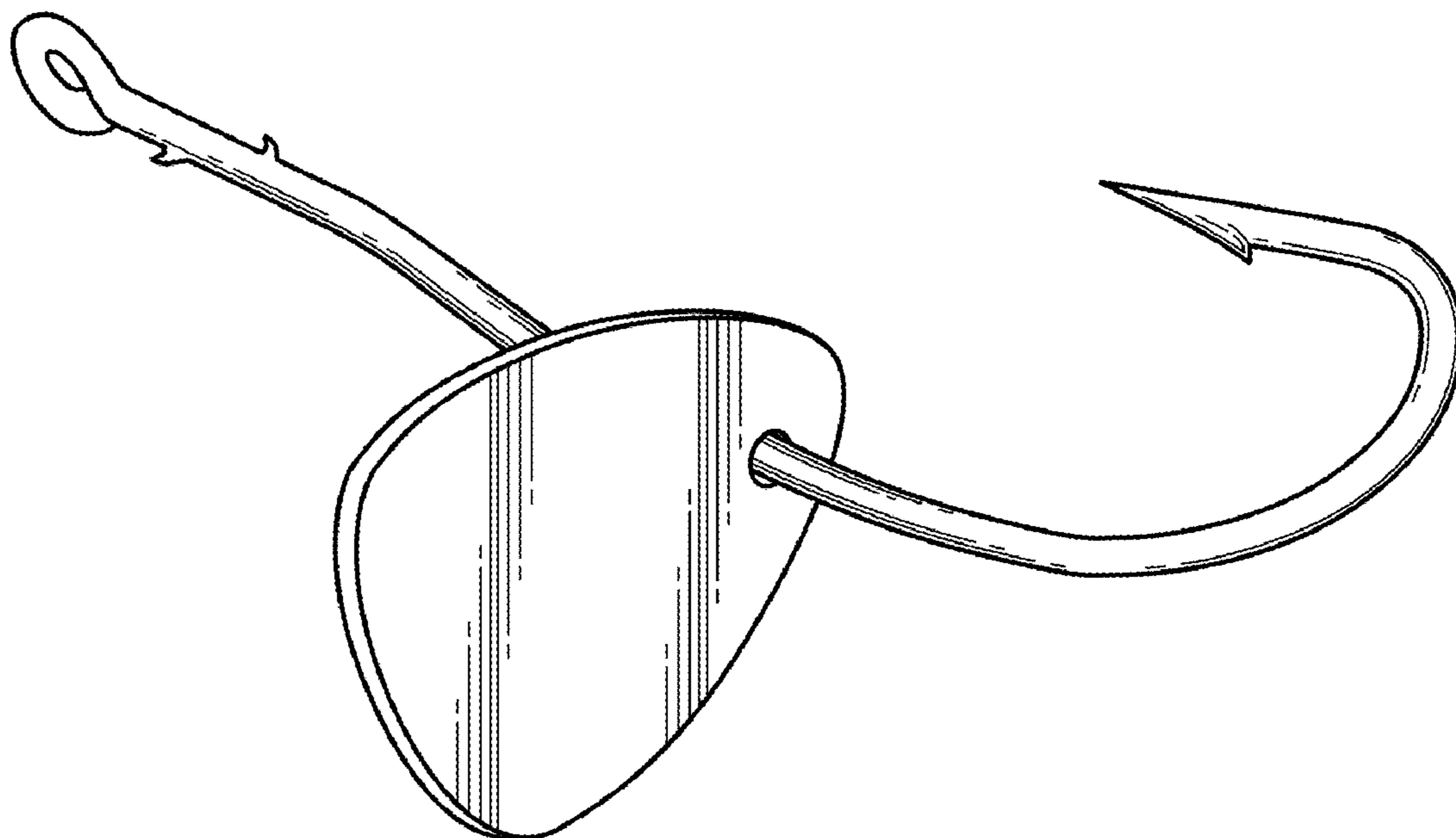
FIG. 1 is a right side elevational view of a pancake fishing sinker showing my new design;

FIG. 4 is a perspective view thereof.

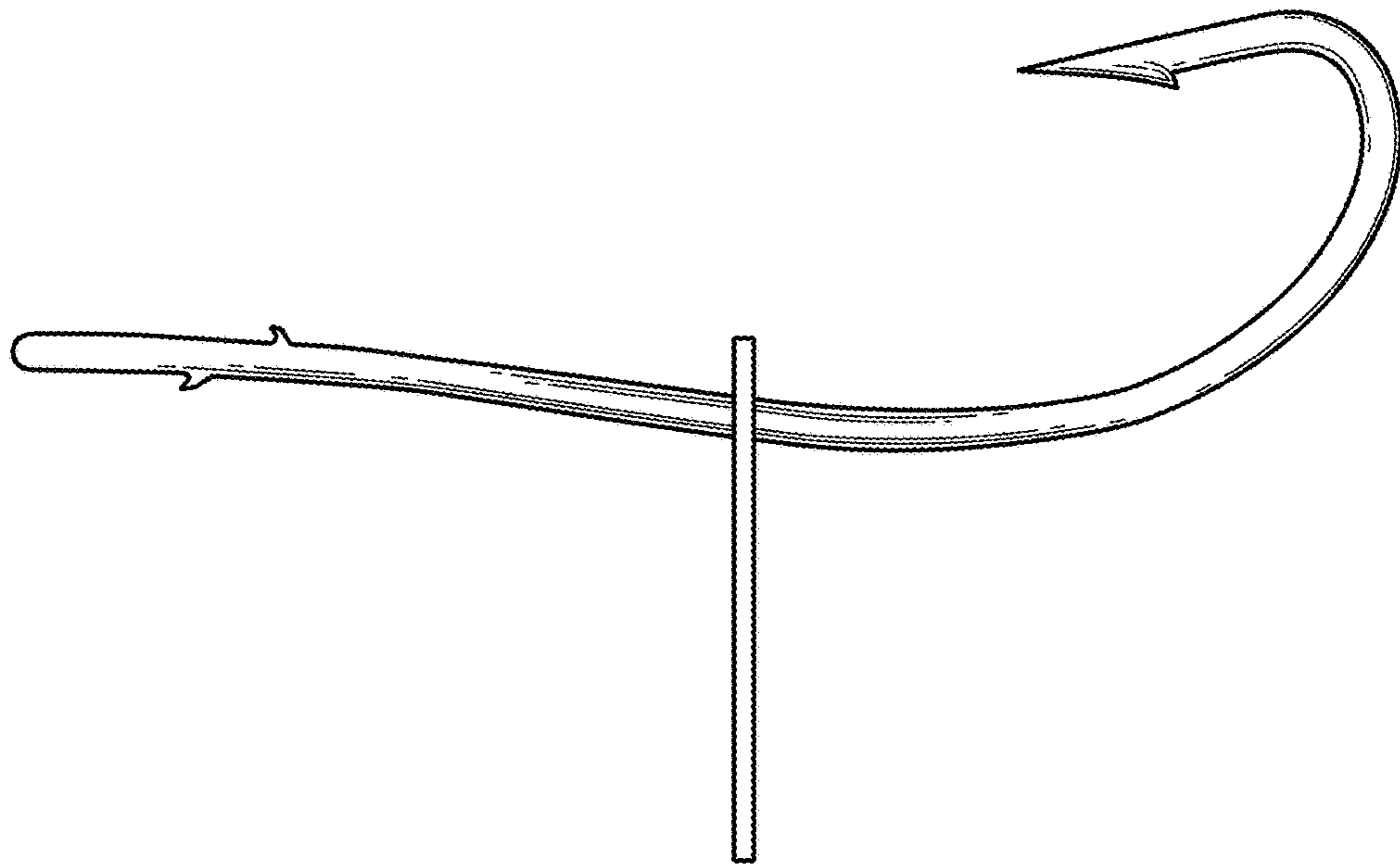

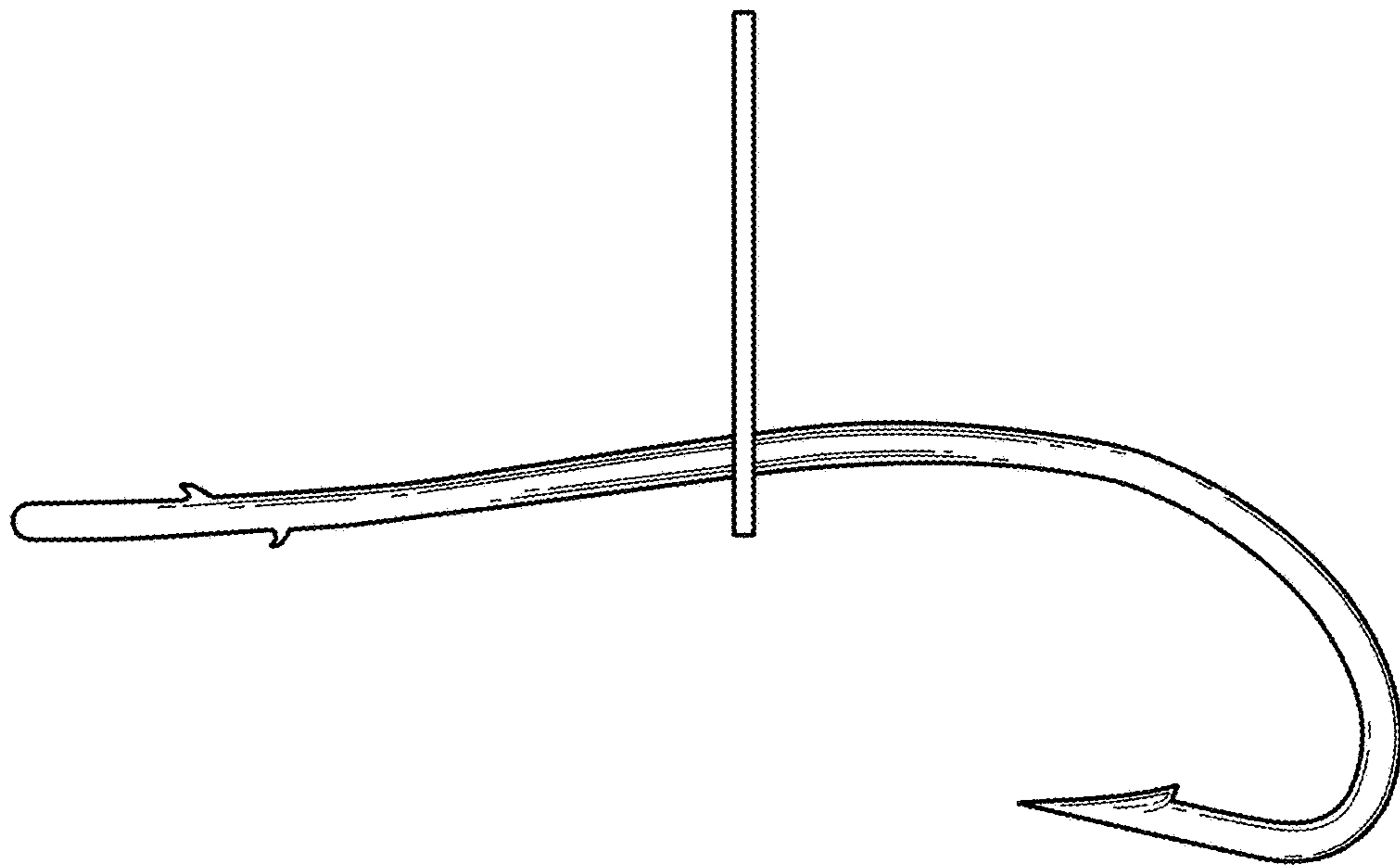

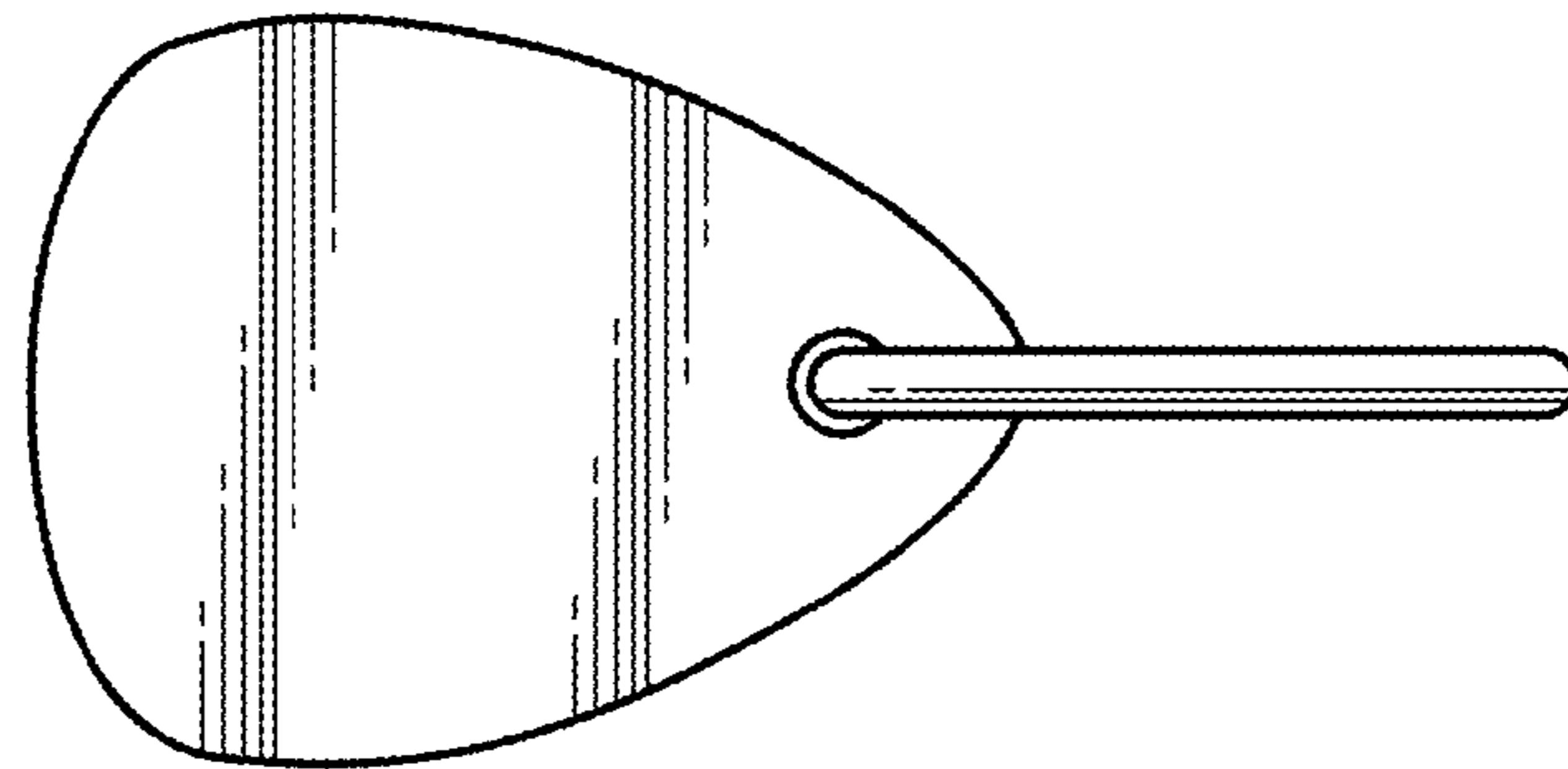




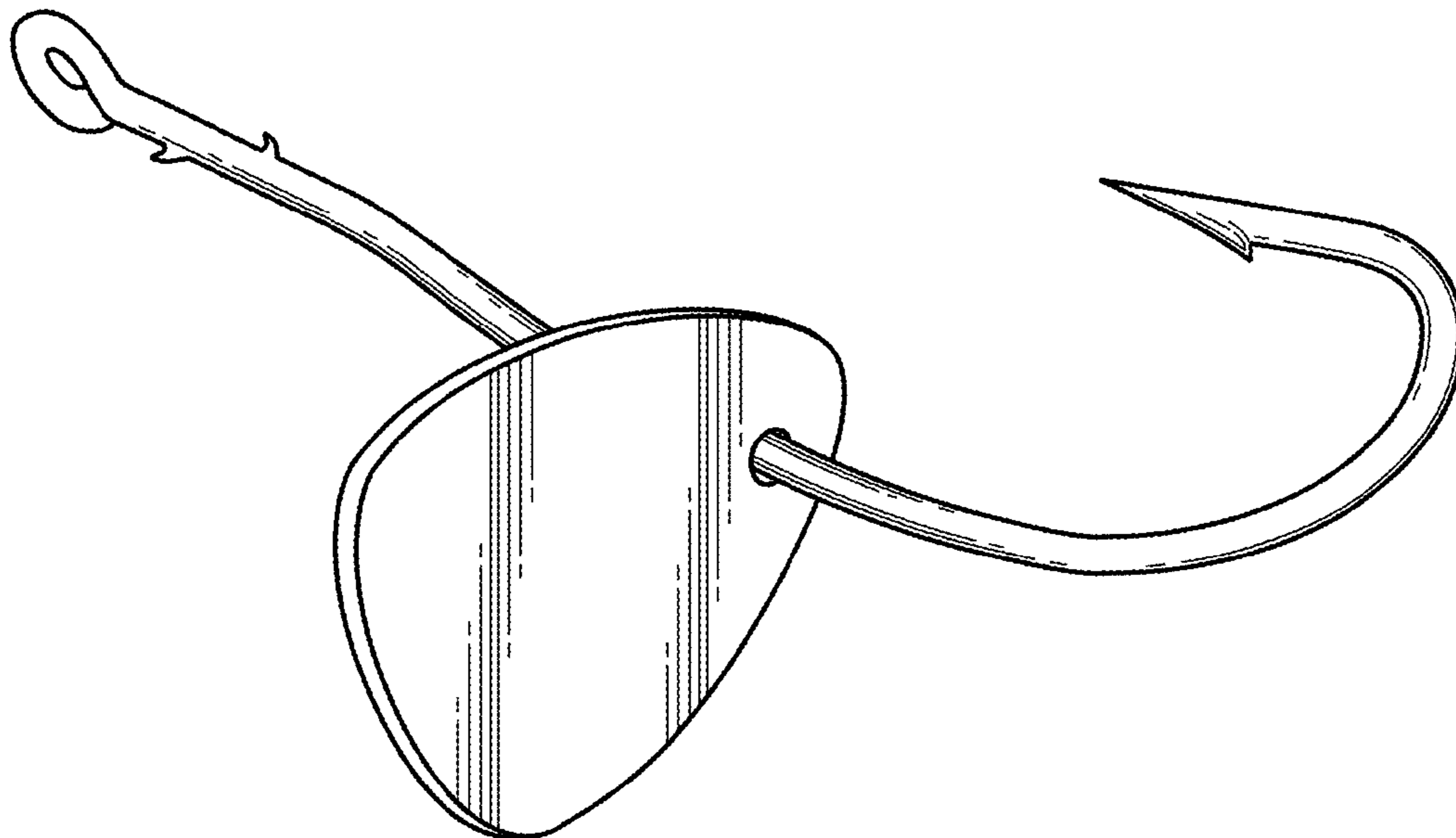
