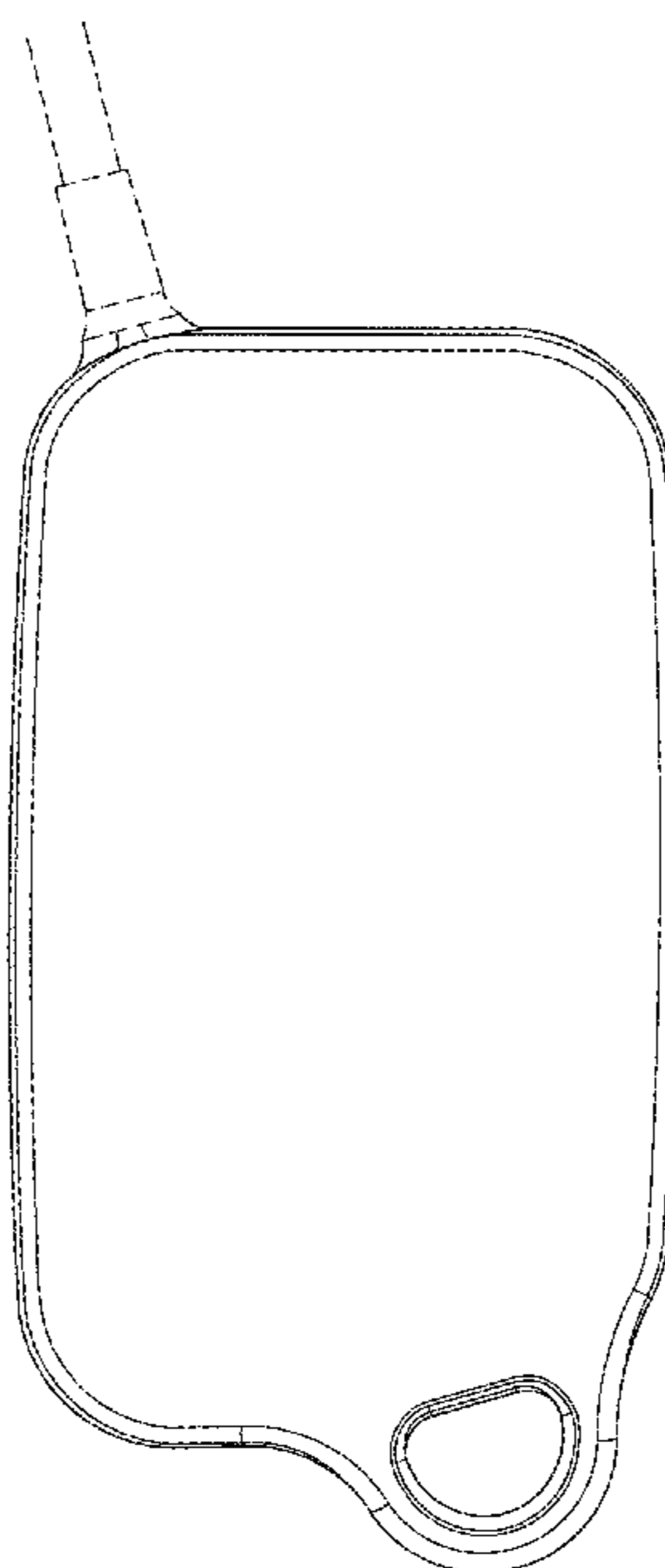
(57) **CLAIM**

I claim the ornamental design for a power pack adapted for a blood transfusion and sampling apparatus, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of the power pack adapted for a blood transfusion and sampling apparatus;  
FIG. 2 is a right side elevation view thereof;  
FIG. 3 is a left side elevation view thereof;  
FIG. 4 is a bottom plan view thereof;  
FIG. 5 is a front, bottom, left perspective view thereof; and,  
FIG. 6 is a front, top, left perspective view thereof.  
The broken lines in FIGS. 1-6 are included for the purpose of showing environmental structure that forms no part of the design.

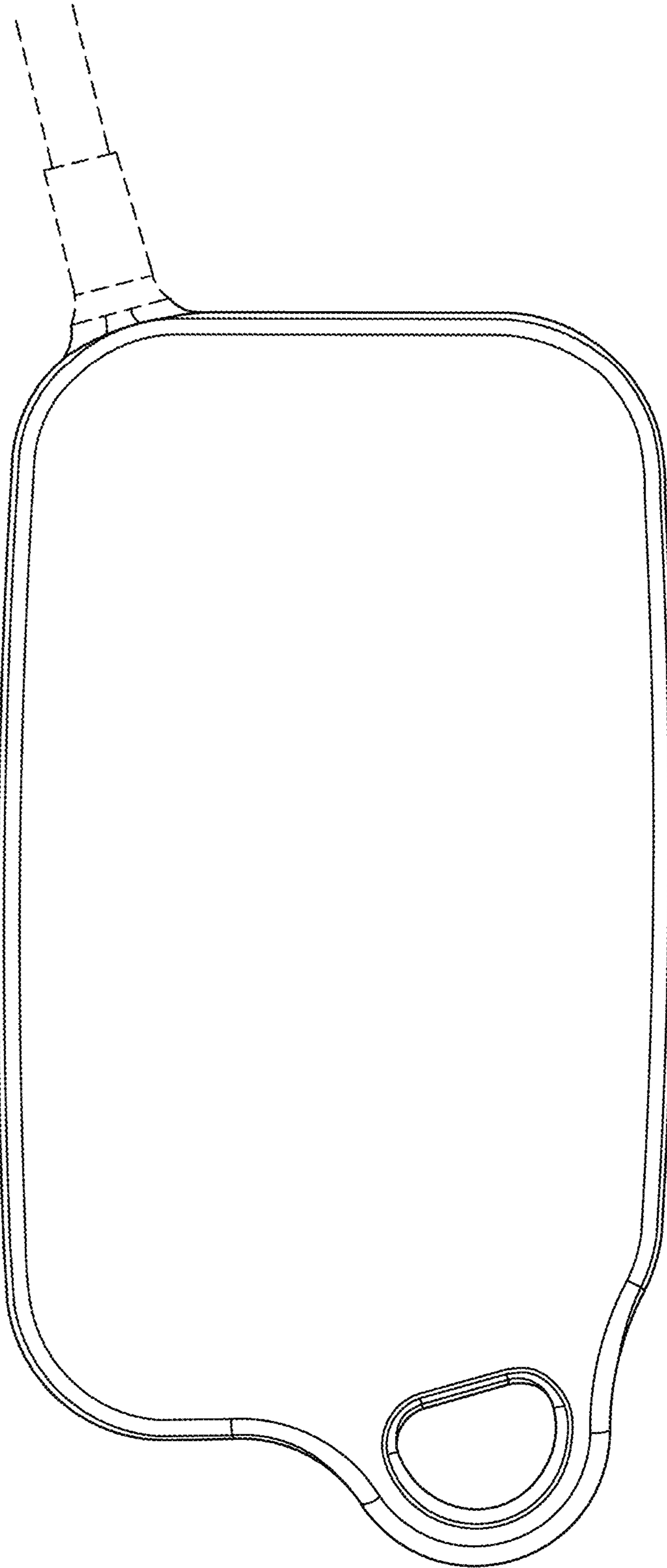

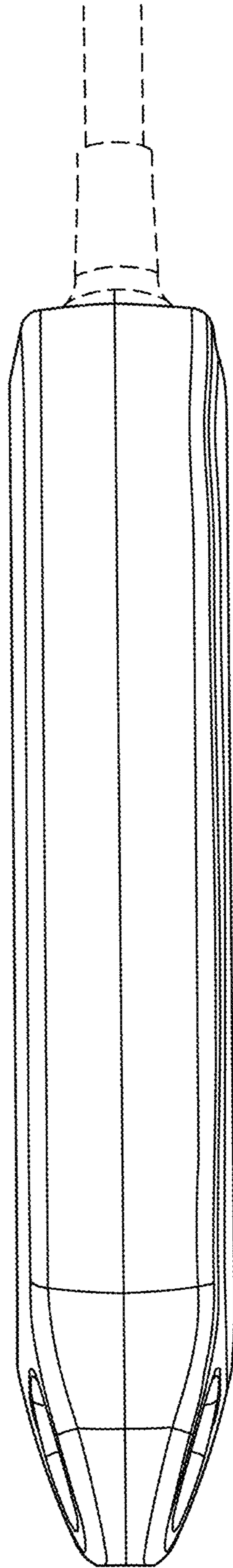
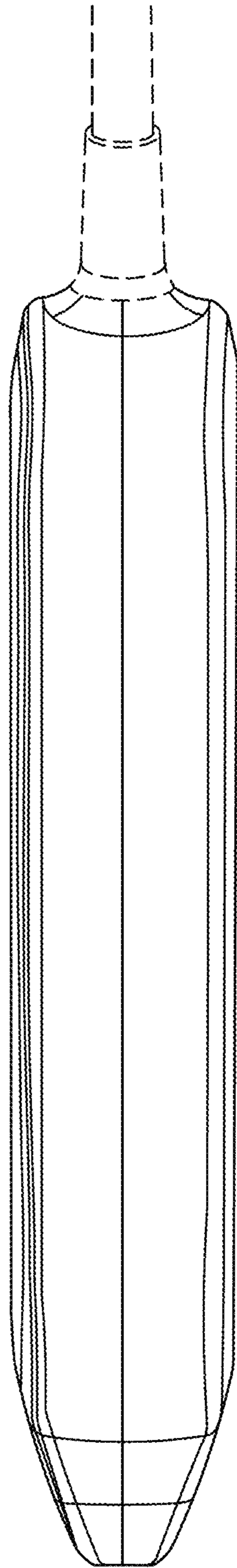

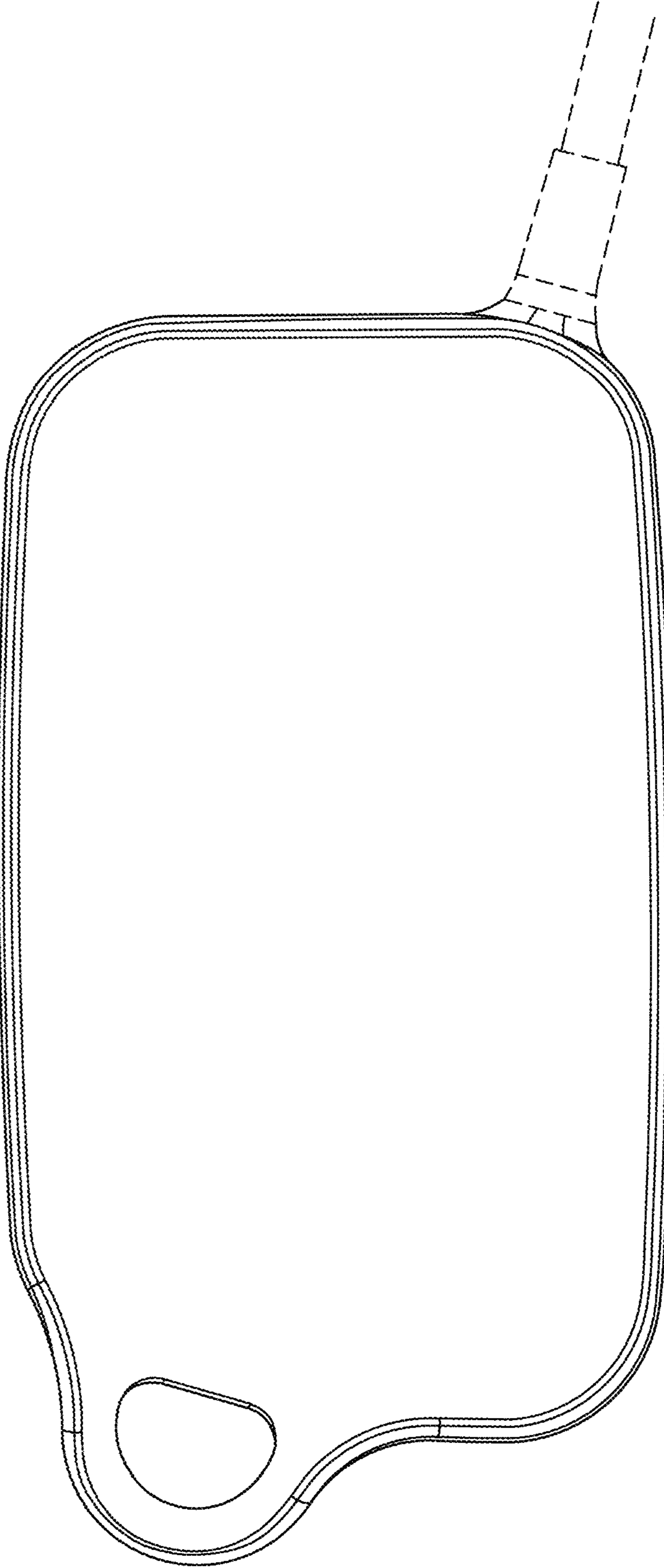

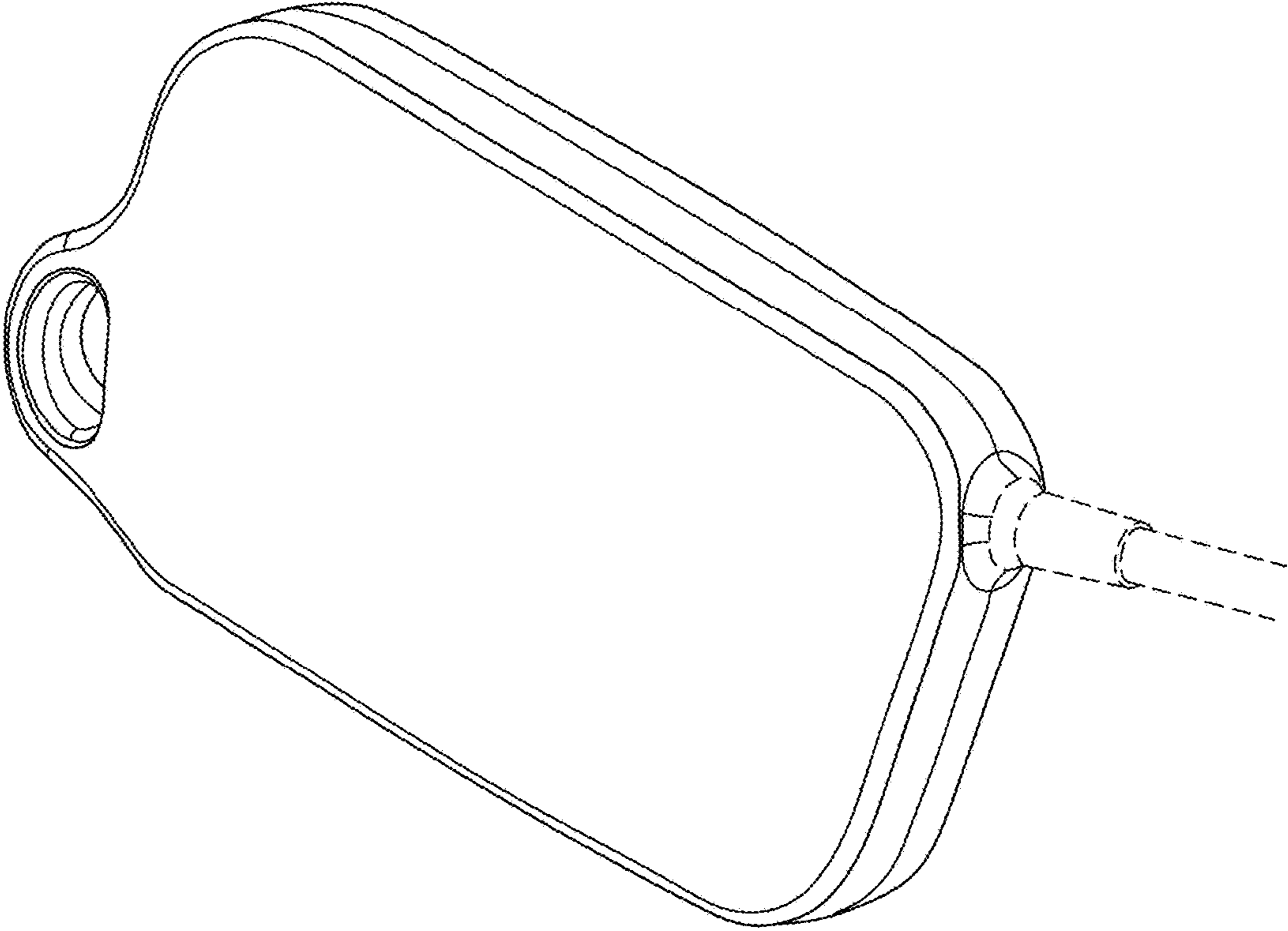

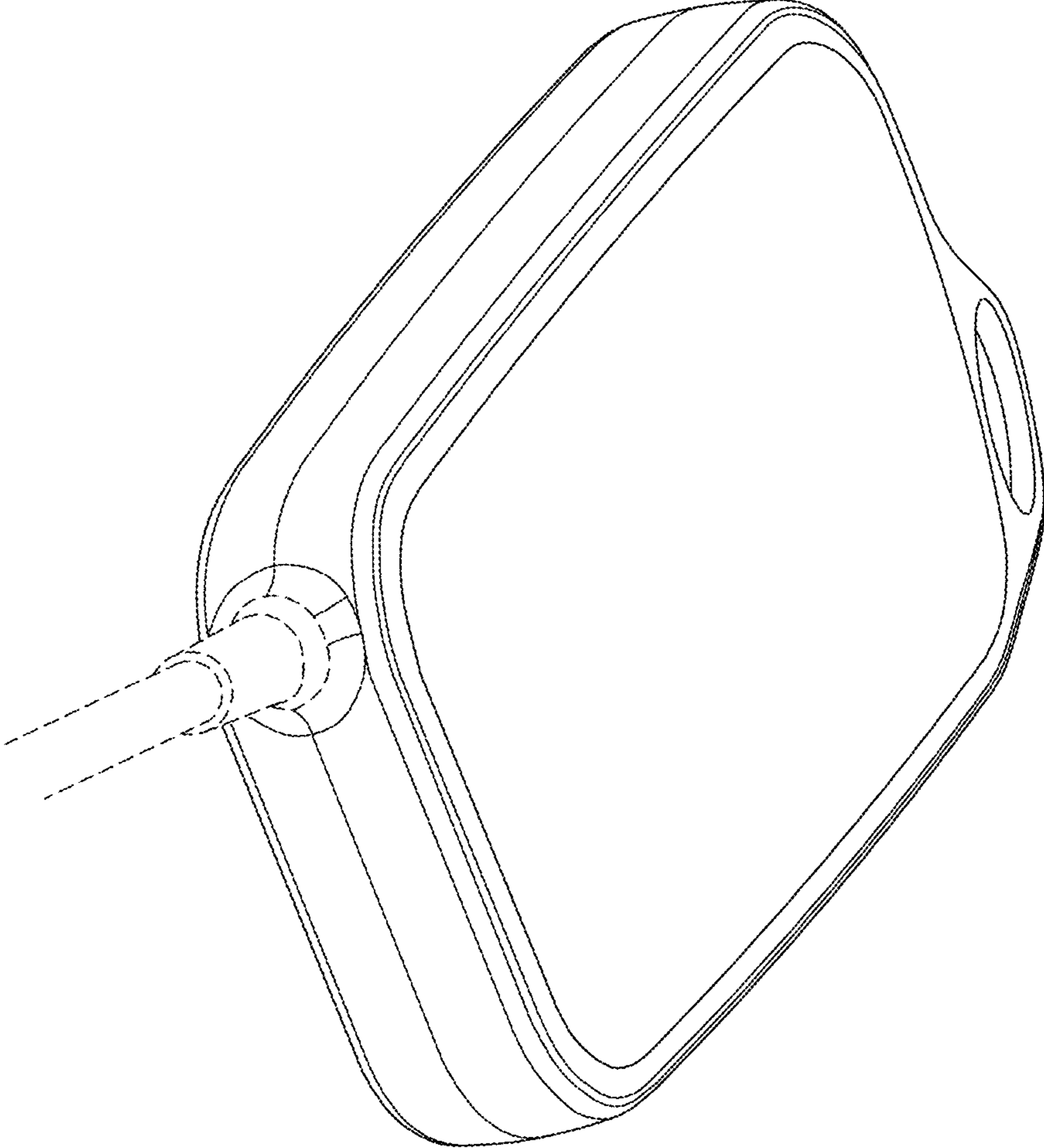
