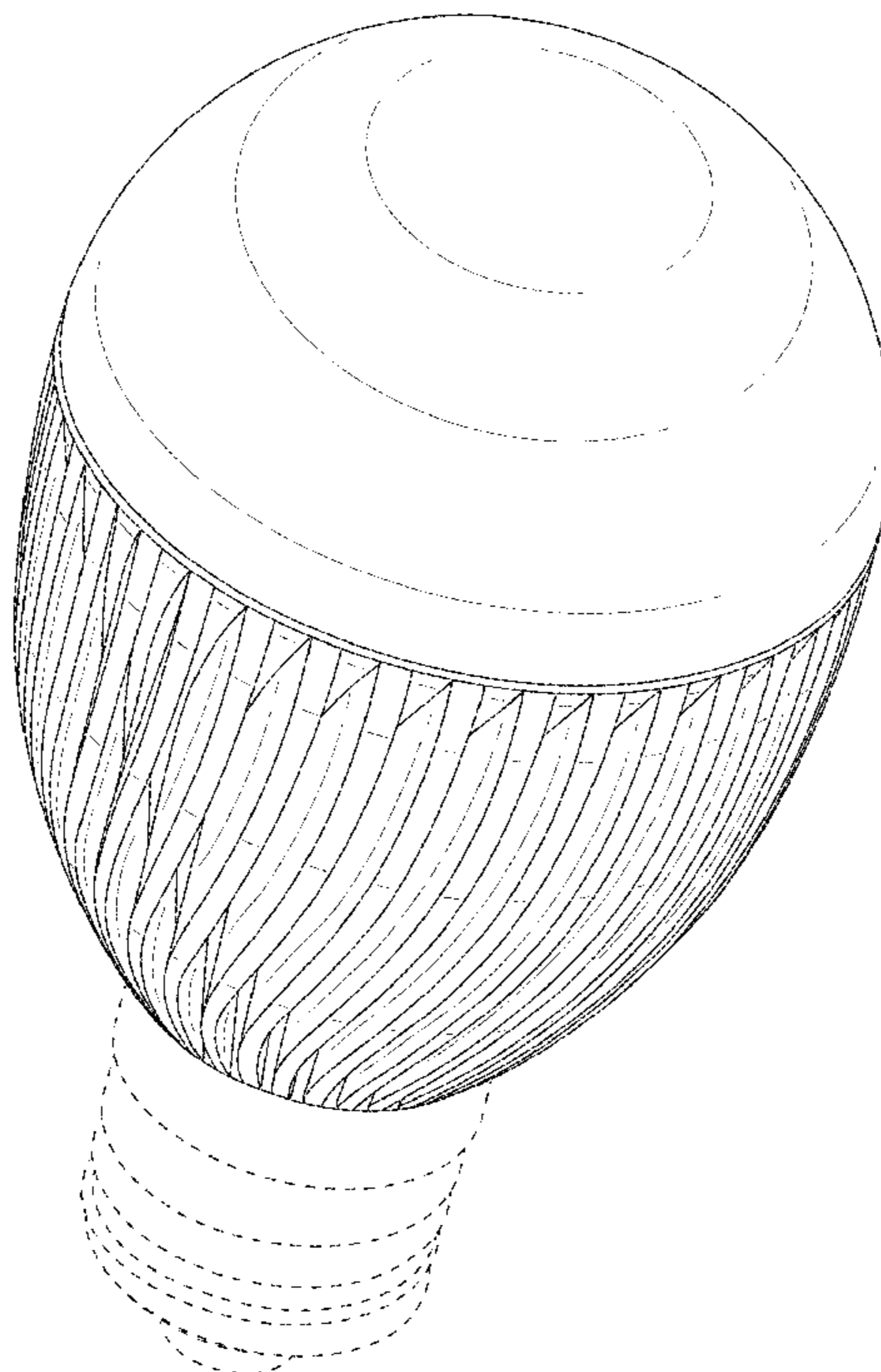
(57) **CLAIM**

The ornamental design for a light bulb, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a light bulb thereof;
 FIG. 2 is a front view of the light bulb thereof;

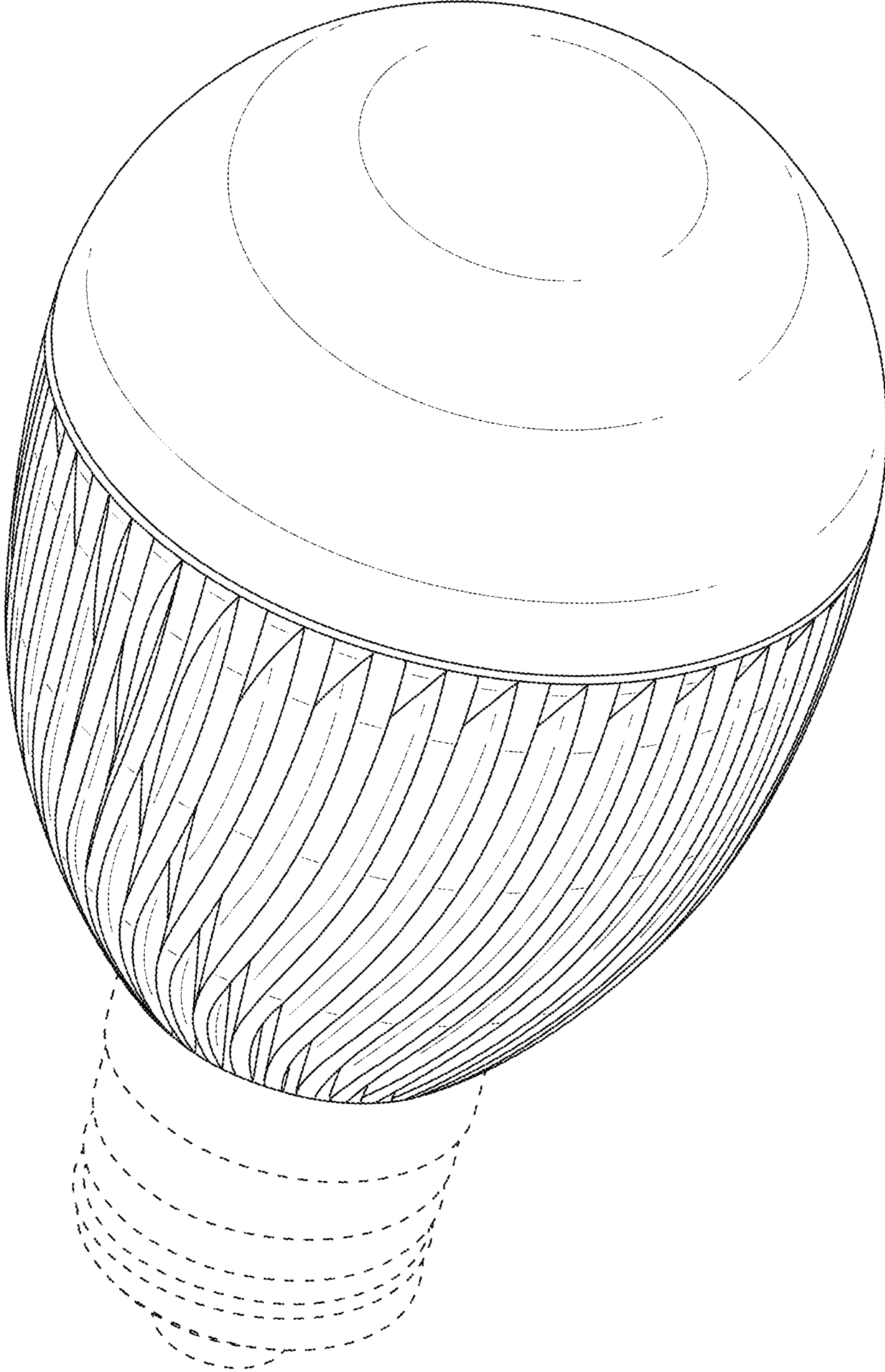

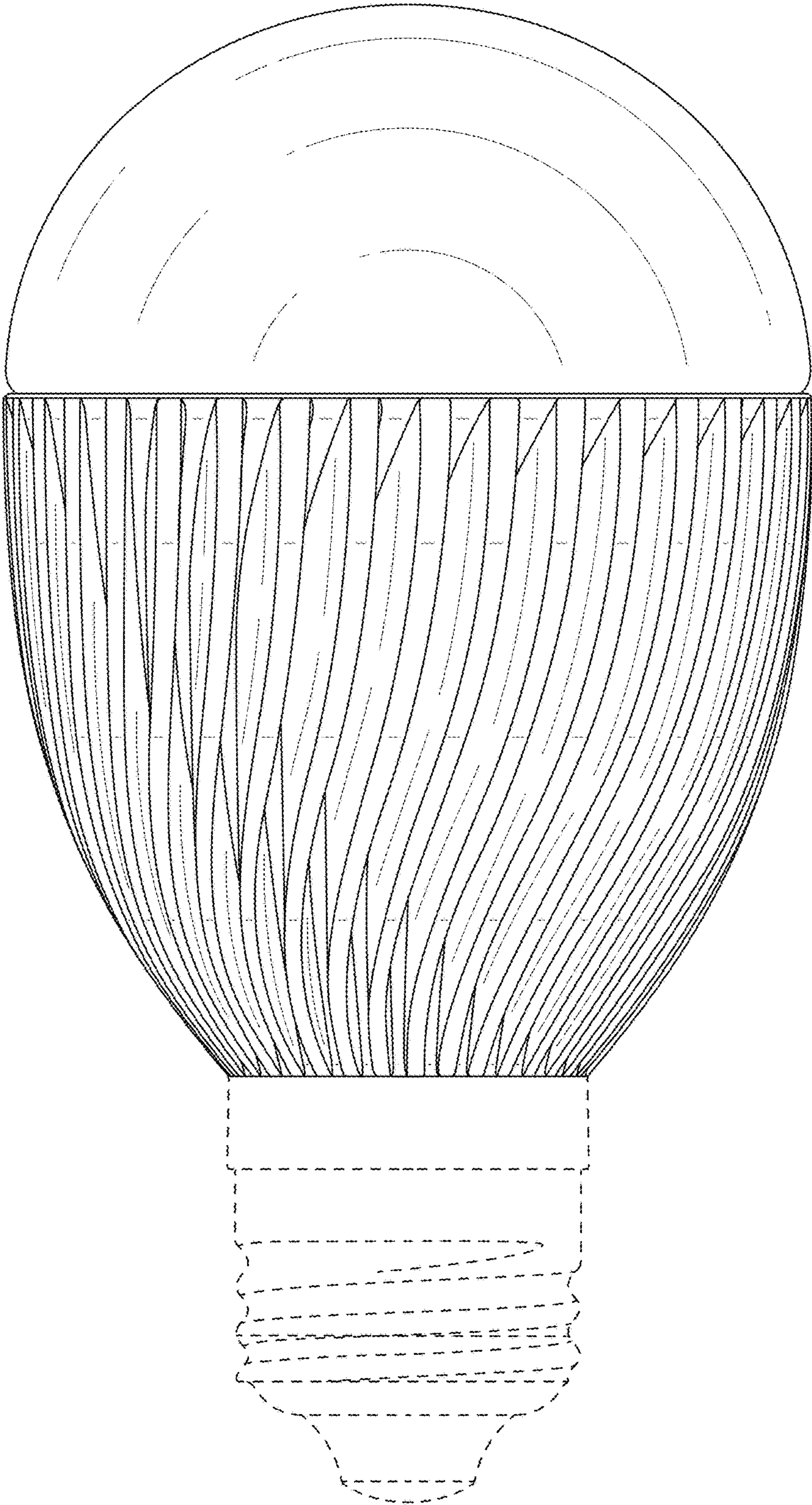

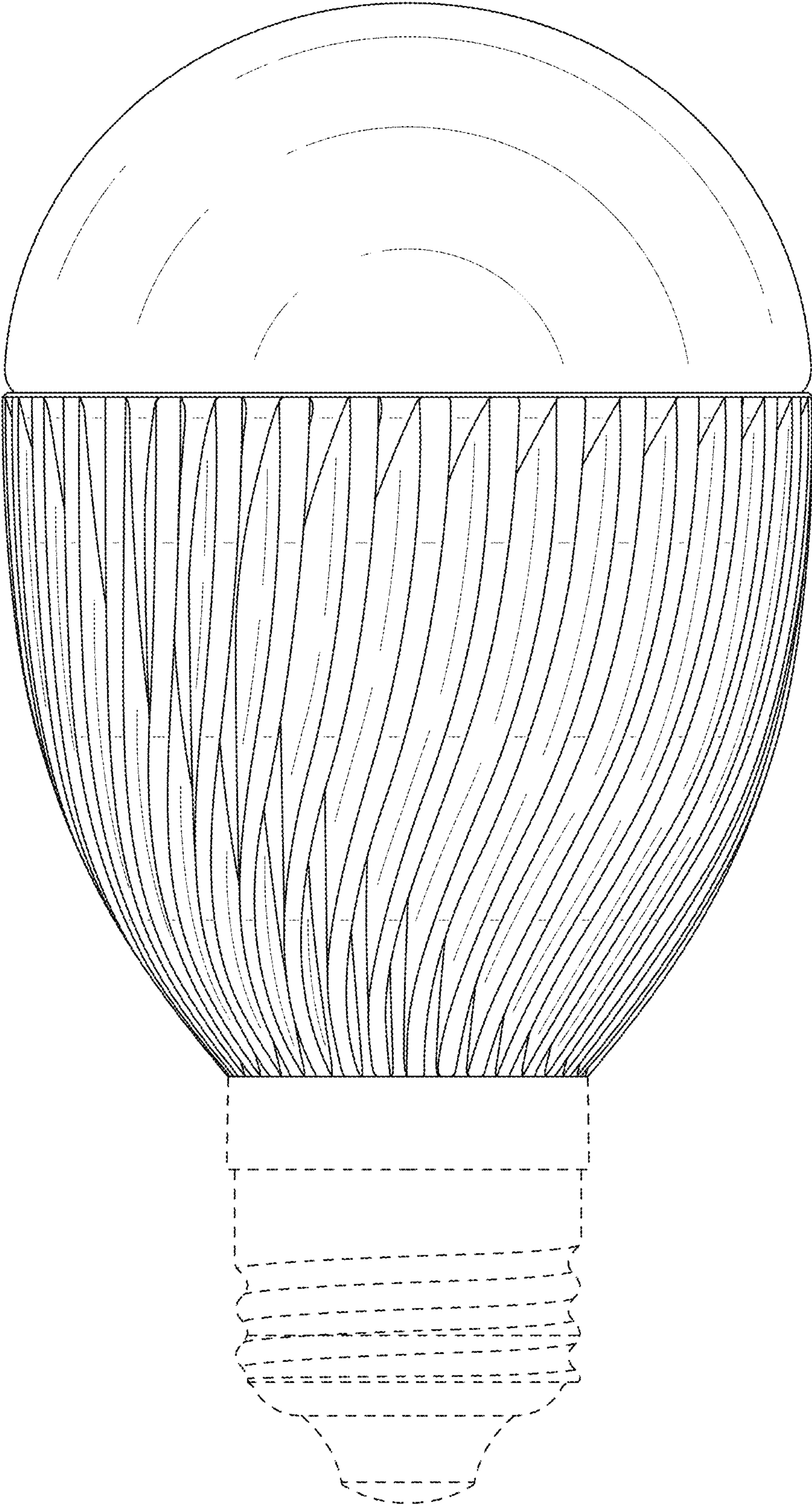

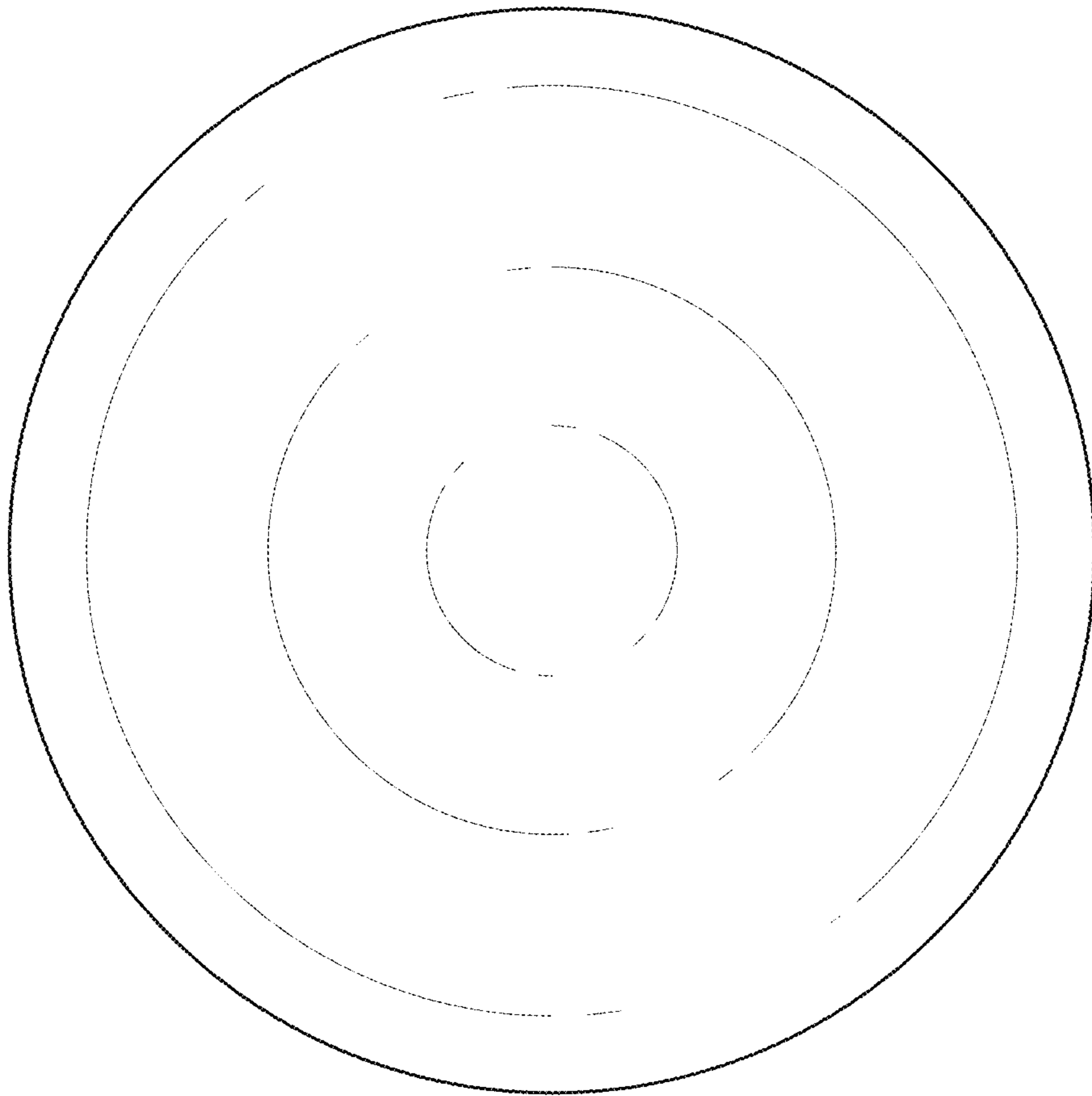

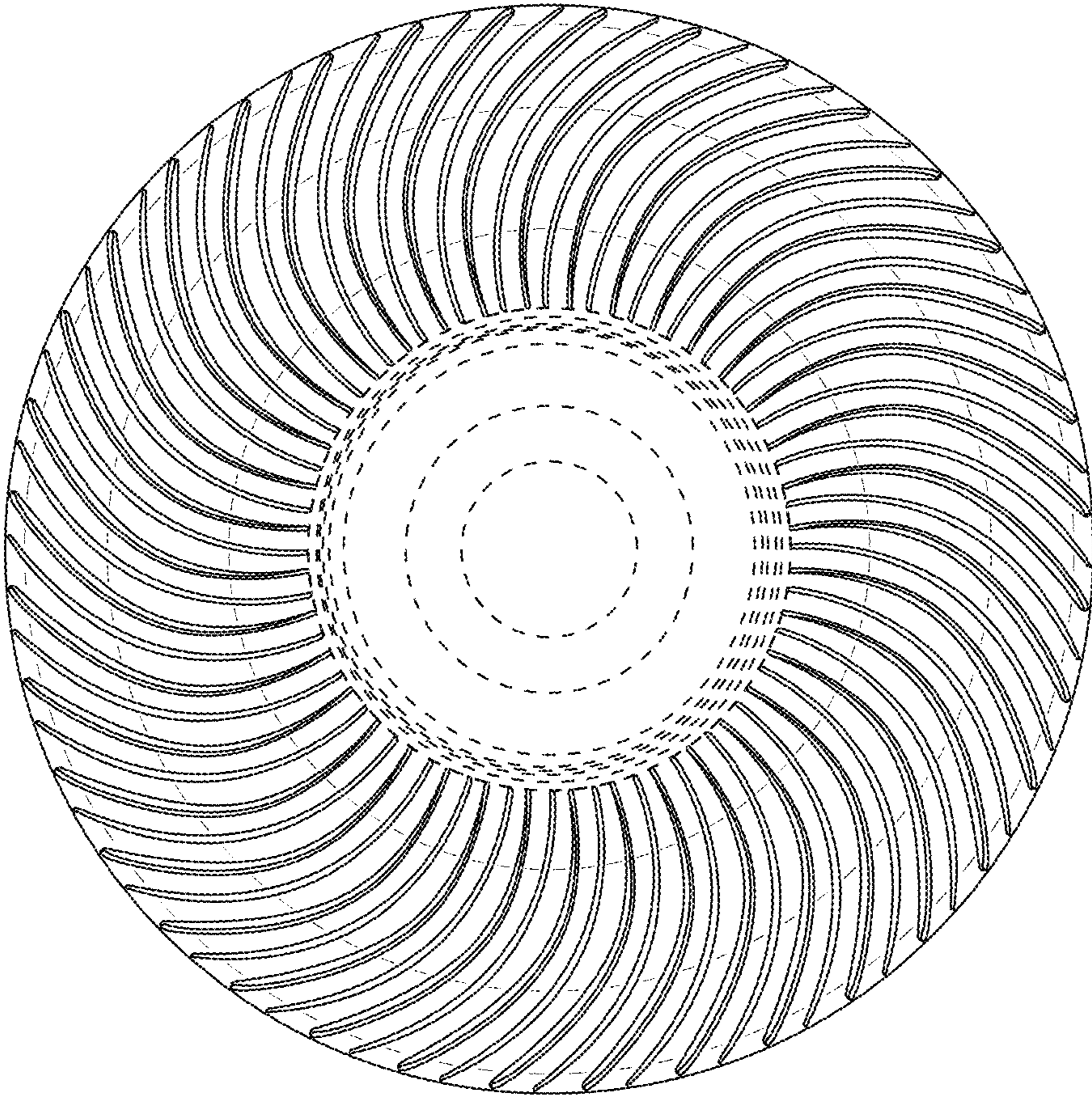

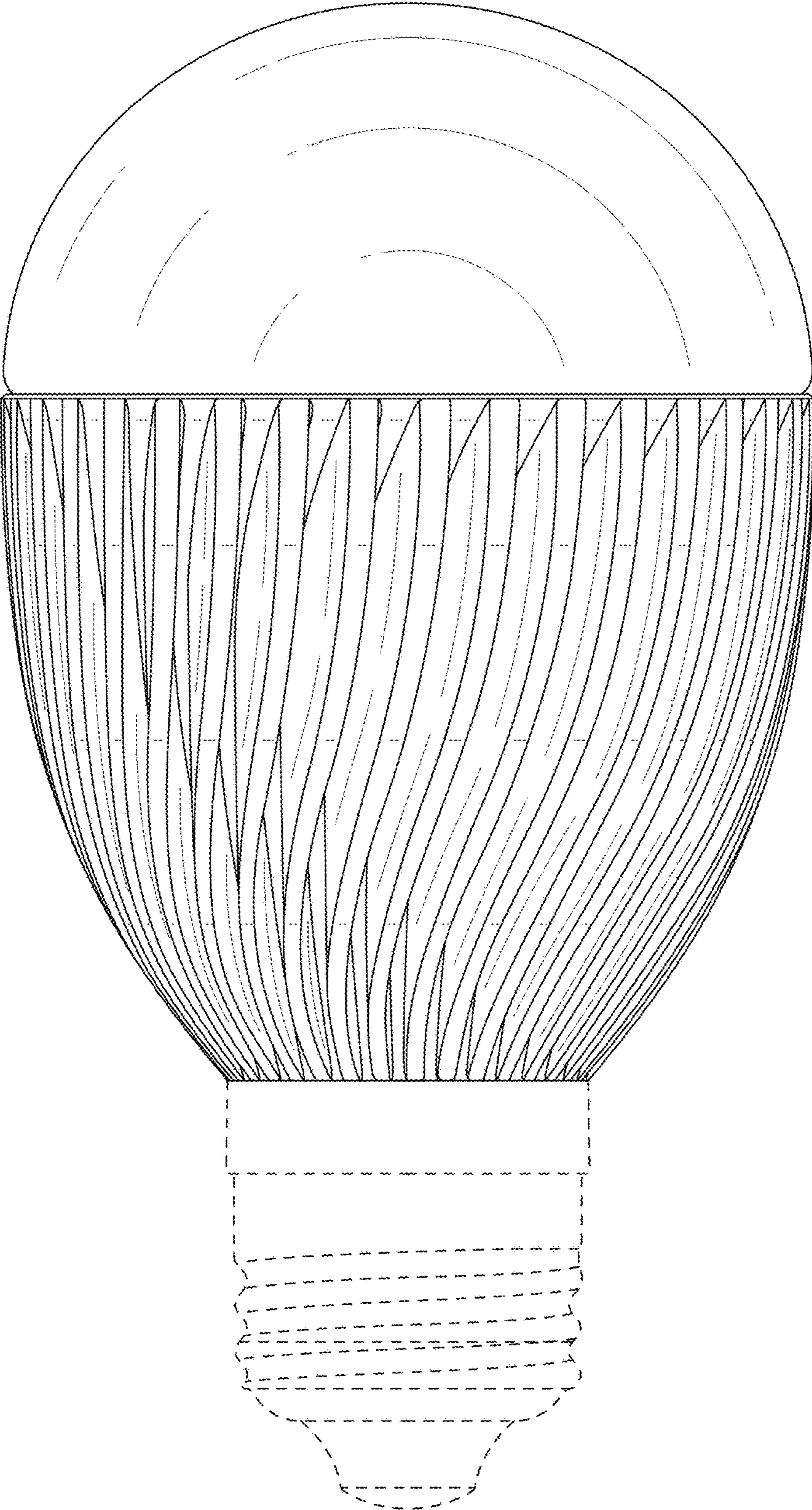

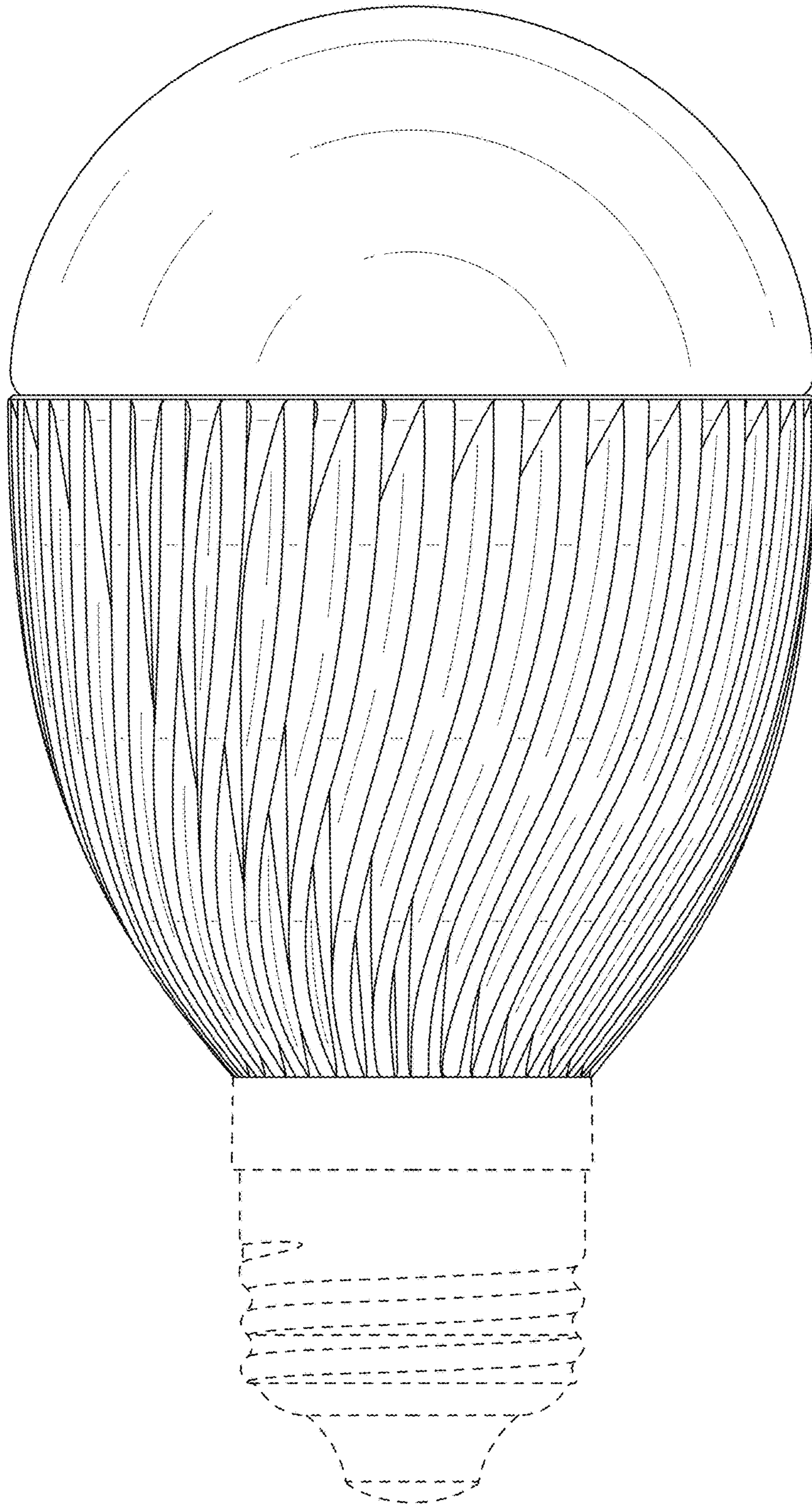
