(57) **CLAIM**

The ornamental design for an animal leash, as shown and described.

DESCRIPTION

FIG. 1 is a right side, front perspective view of a first embodiment of the animal leash, illustrating a novel design. FIG. 2 is a right side perspective view thereof, the left side being a mirror image of the right side.

FIG. 3 is a side view thereof.

FIG. 4 is a front view thereof.

FIG. 5 is the back view thereof.

FIG. 6 is the top view thereof.

FIG. 7 is the bottom view thereof.

FIG. 8 is a right side, front perspective view of a second embodiment of the animal leash, illustrating a novel design.

FIG. 9 is a right side perspective view of the embodiment illustrated in FIG. 8, the left side being a mirror image of the right side.

FIG. 10 is a side view of the embodiment illustrated in FIG. 8.

FIG. 11 is a front view of the embodiment illustrated in FIG. 8.

FIG. 17 is a side view of the embodiment illustrated in FIG. 15.

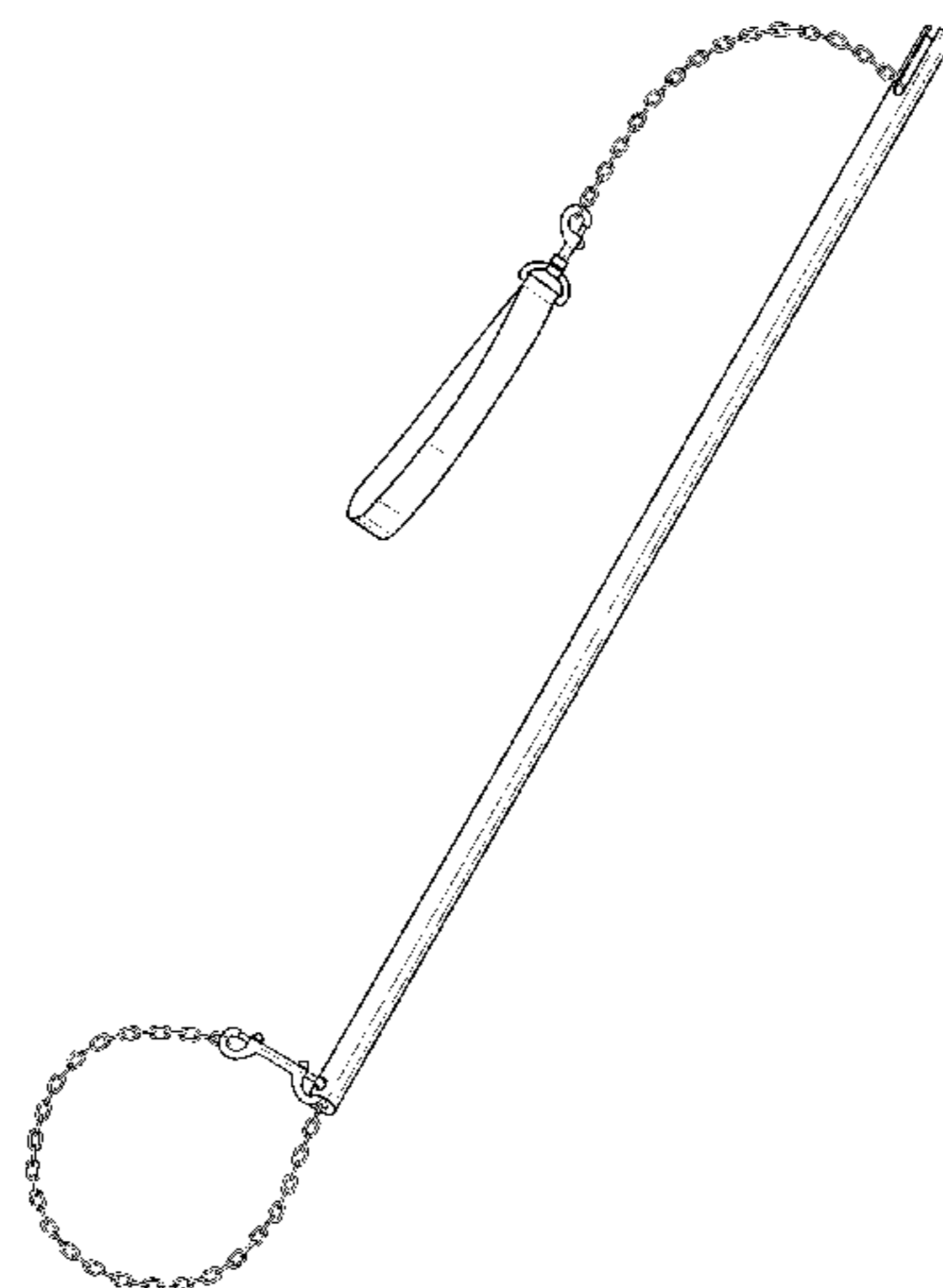
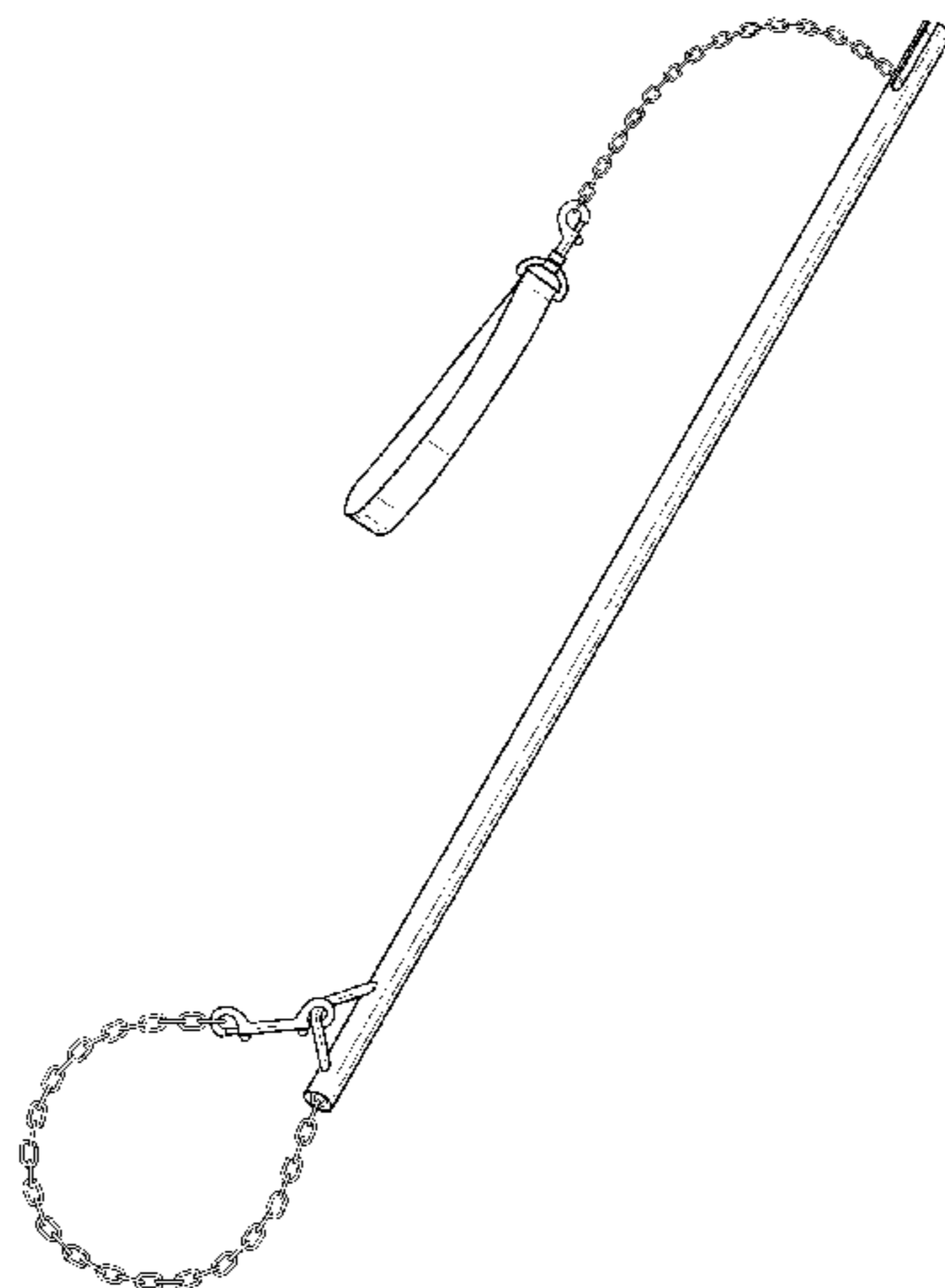
FIG. 18 is a front view of the embodiment illustrated in FIG. 15.

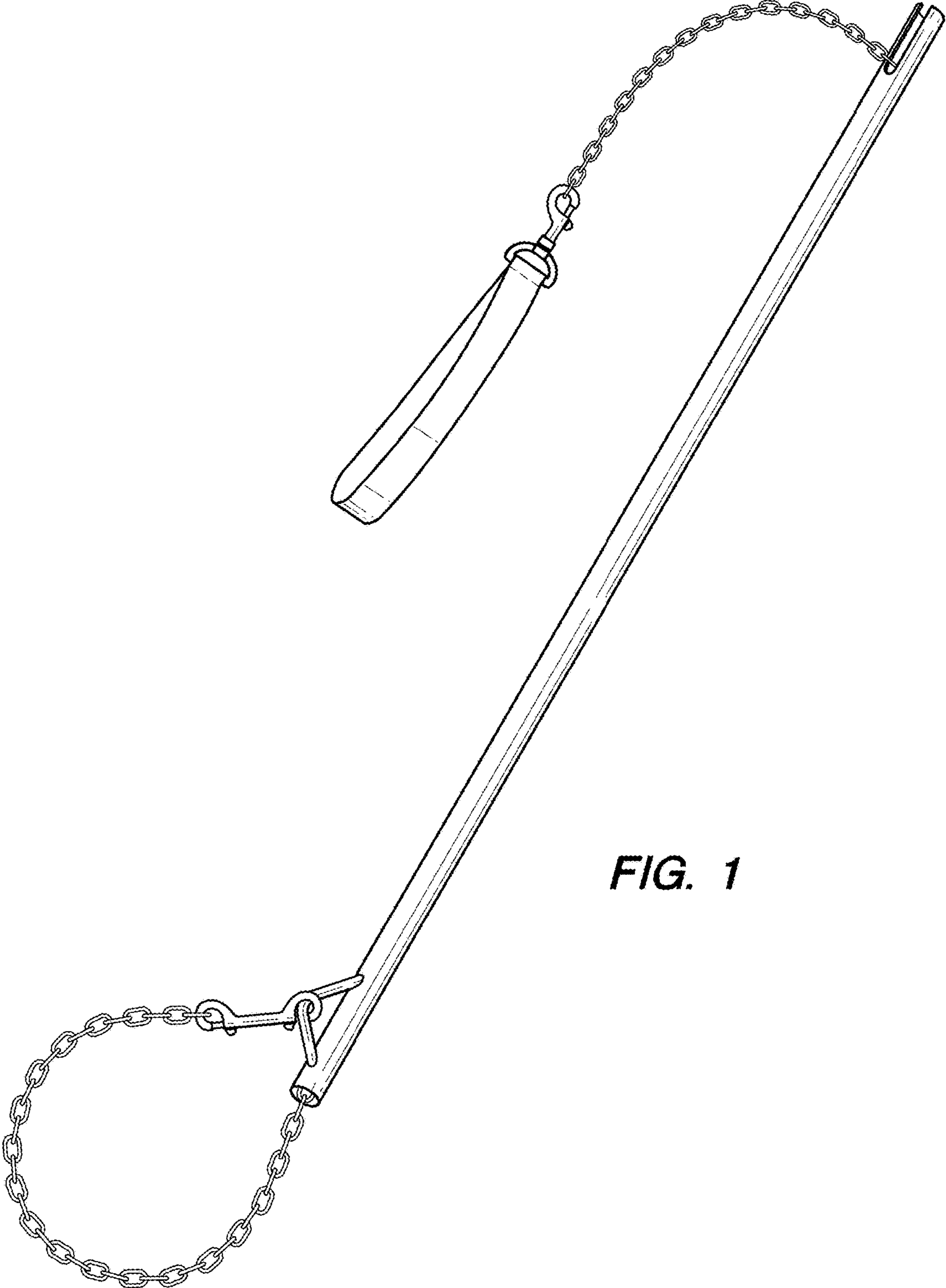

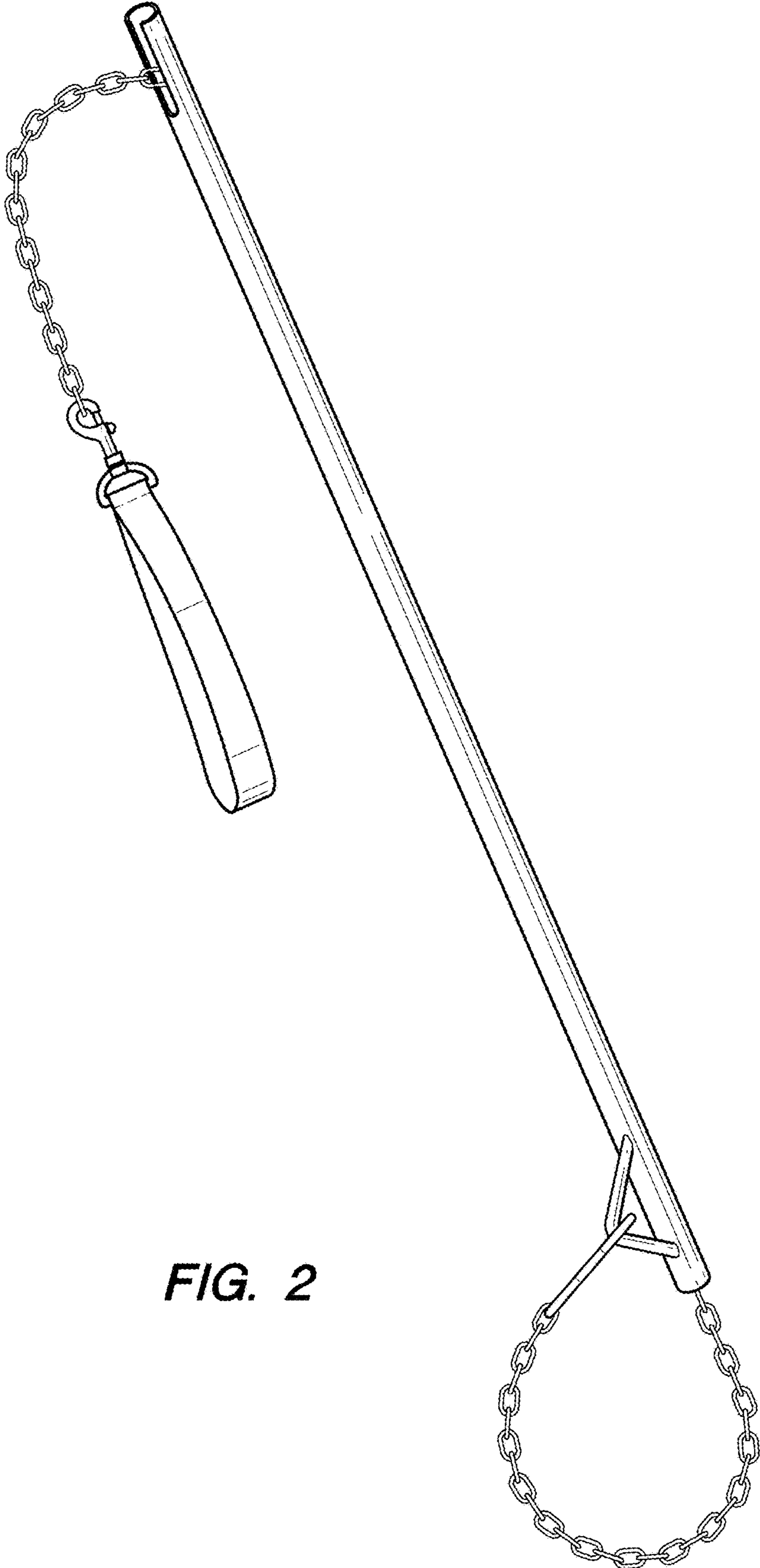

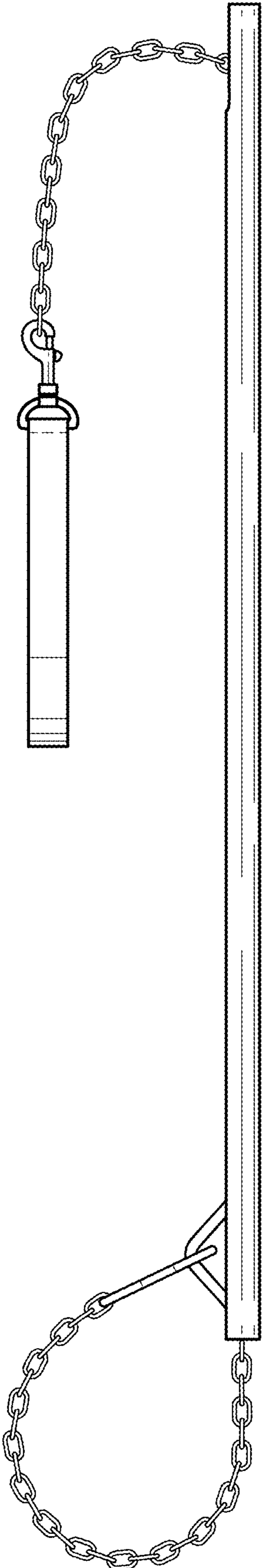

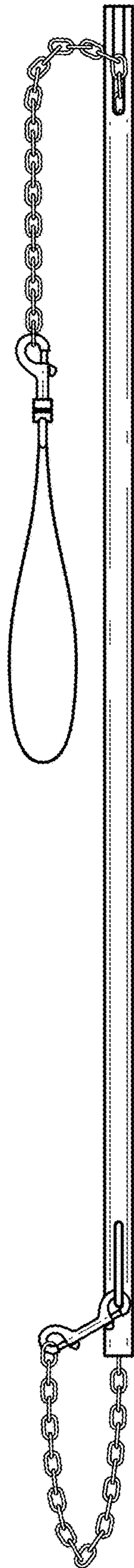

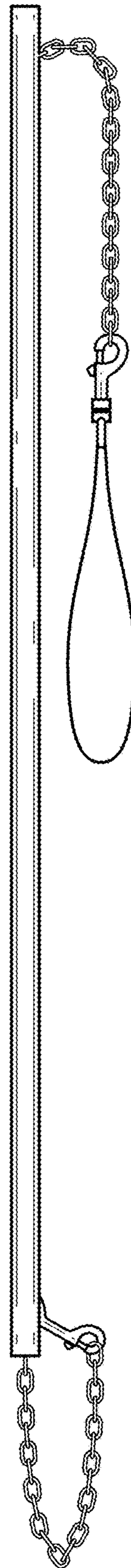

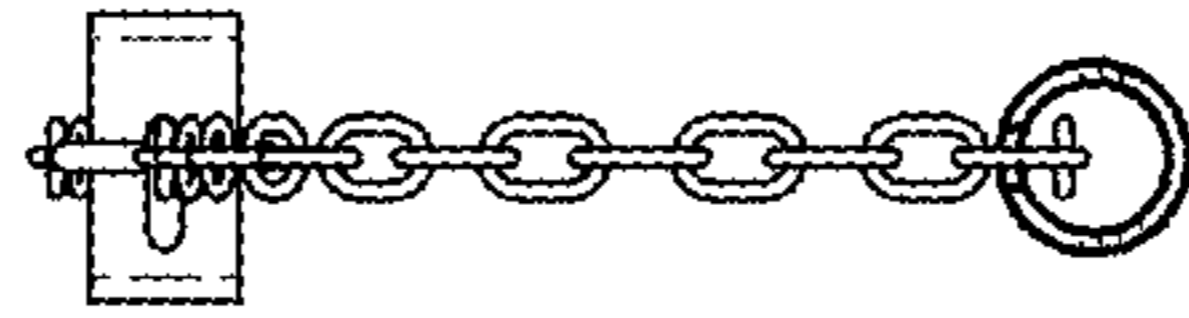

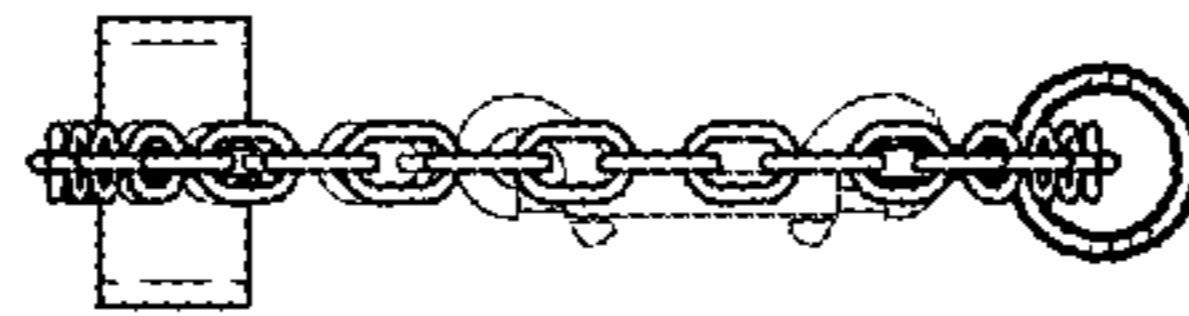

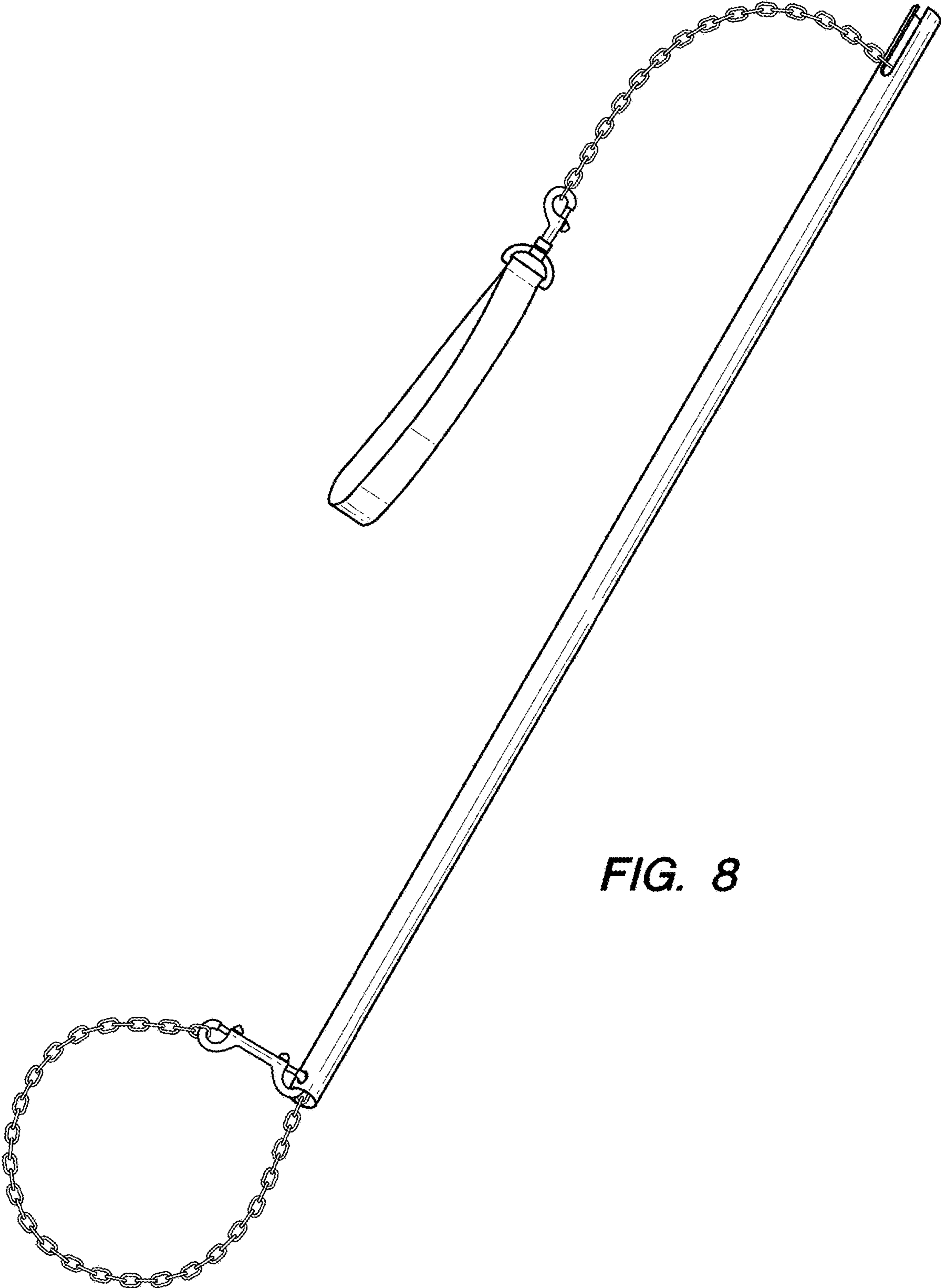

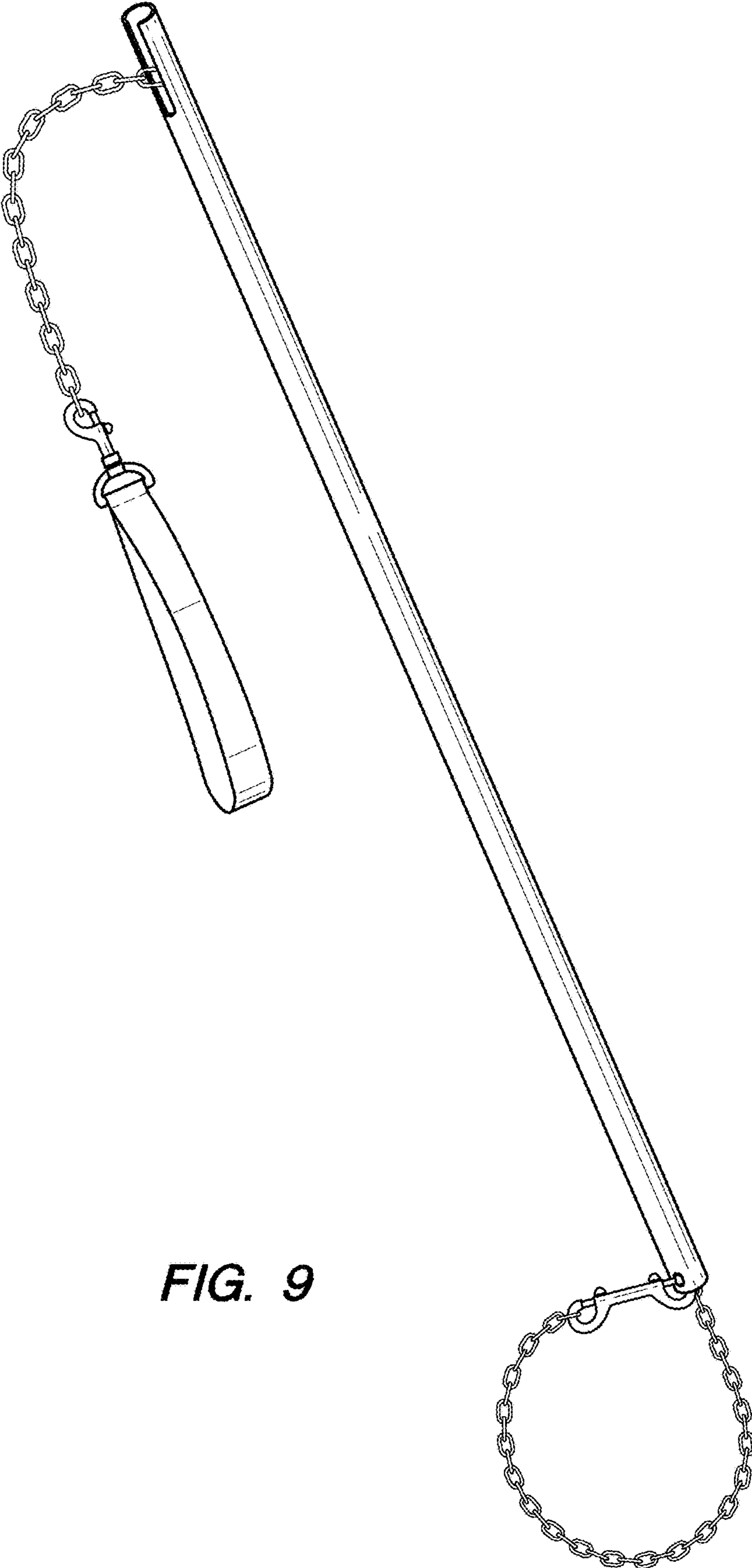

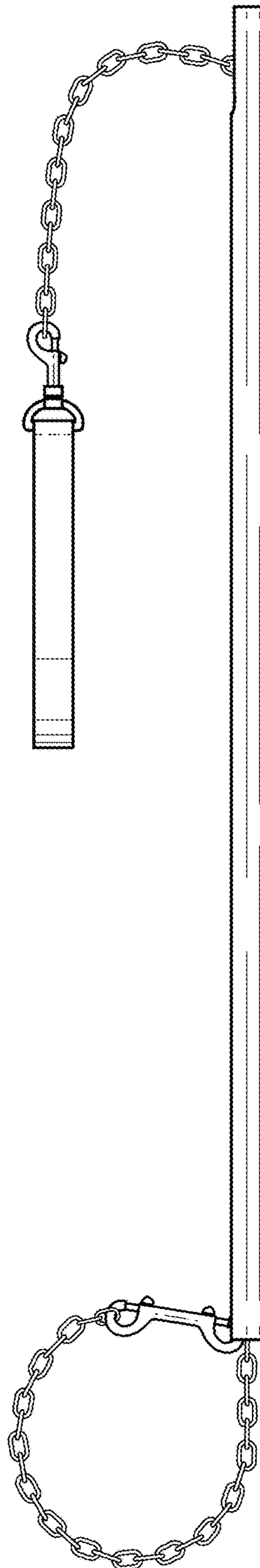

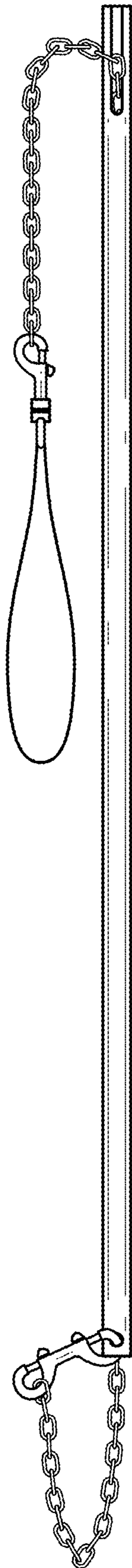

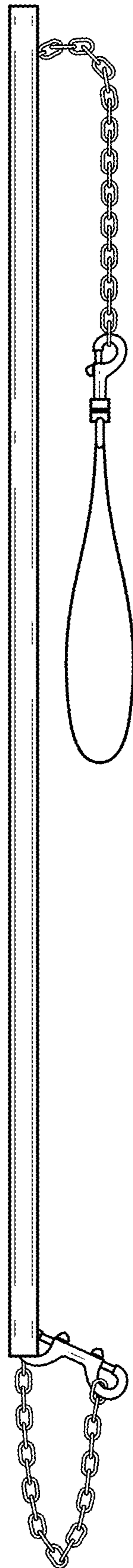

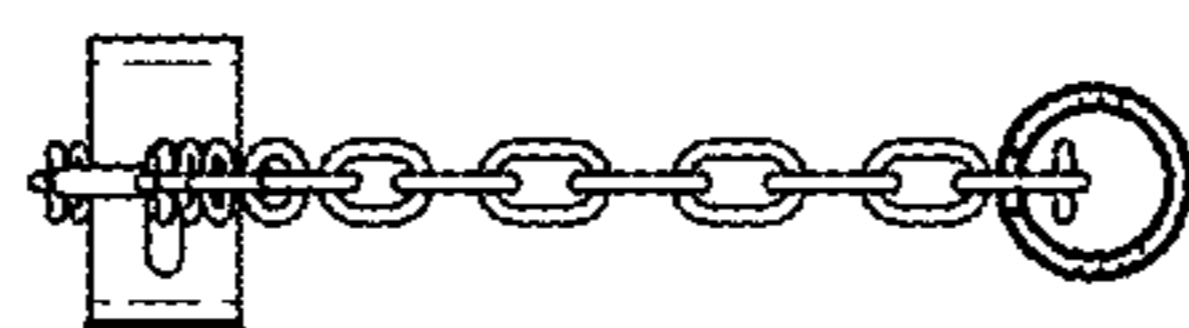

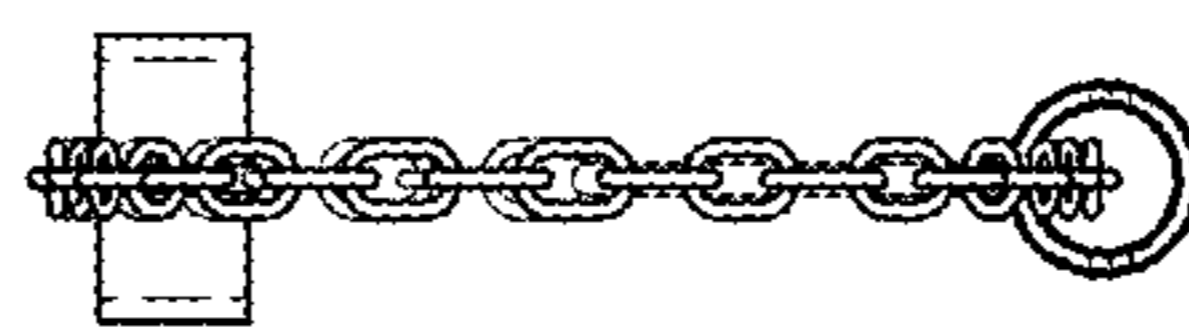

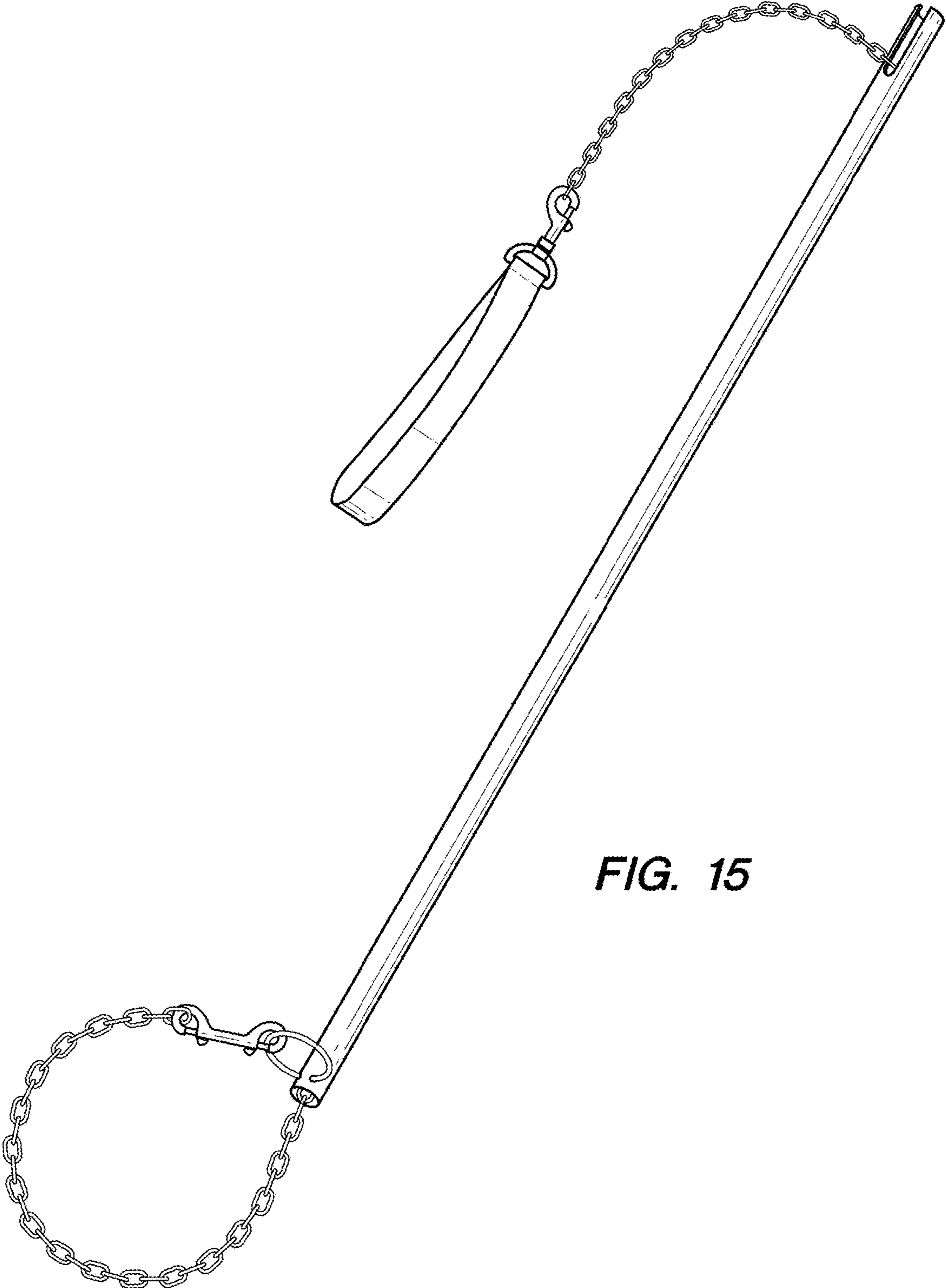

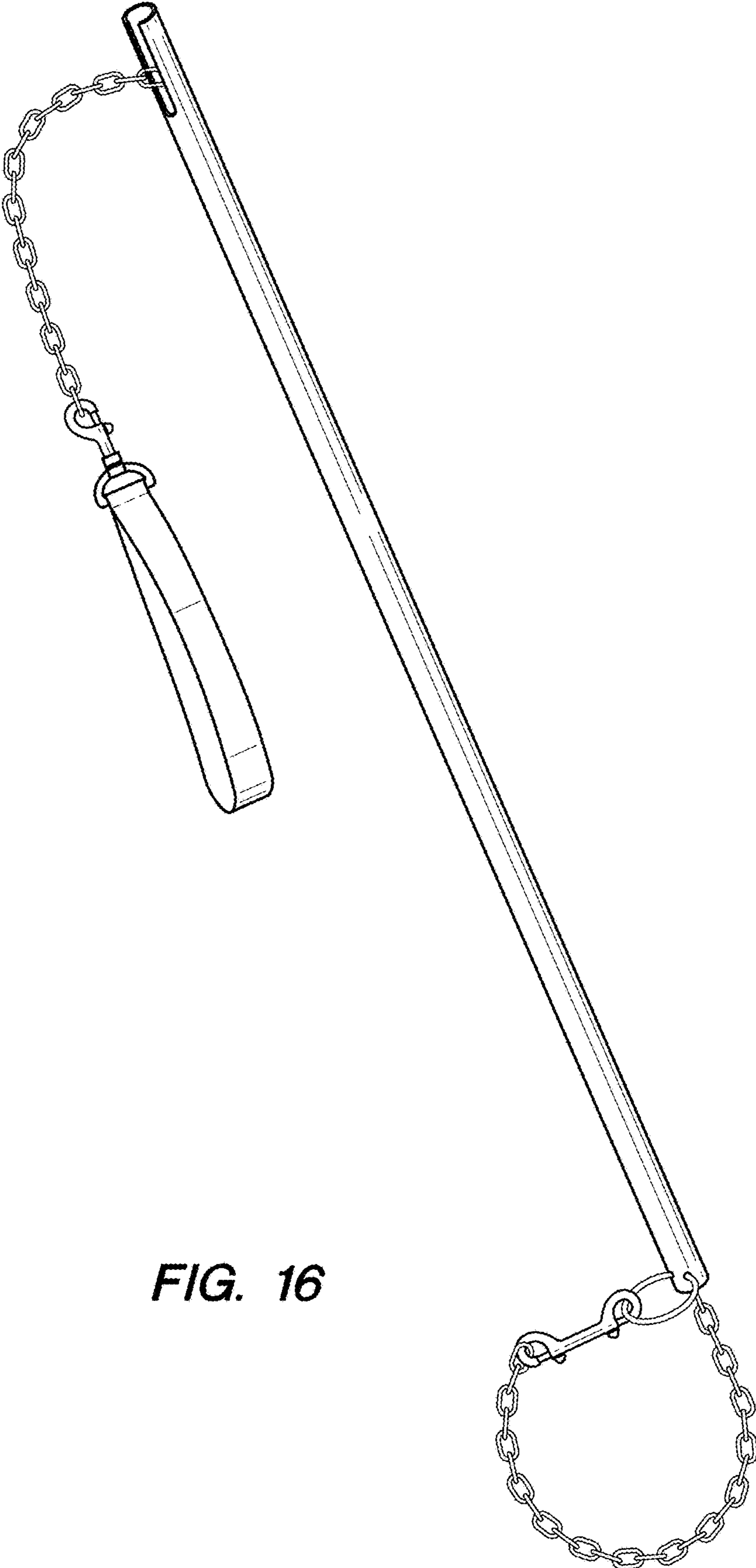

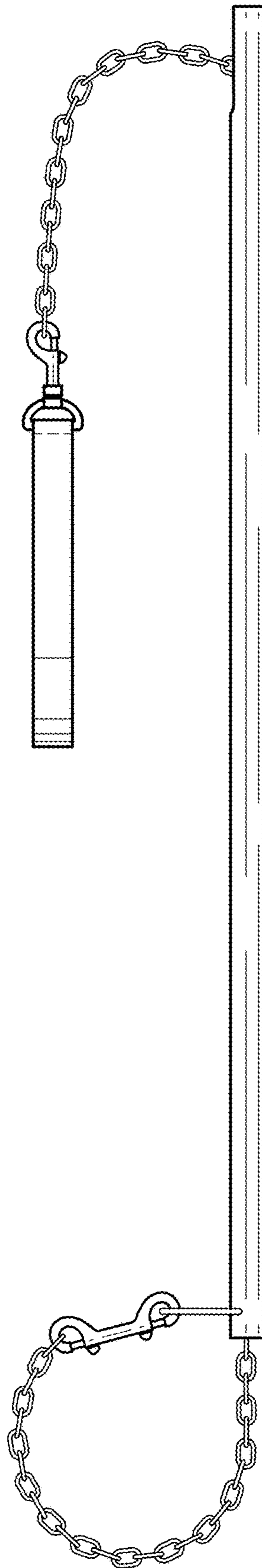

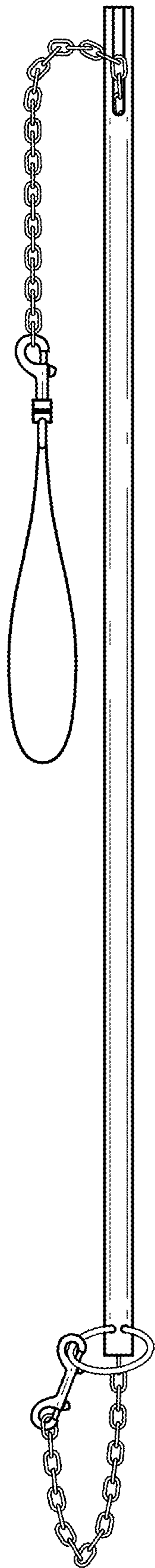

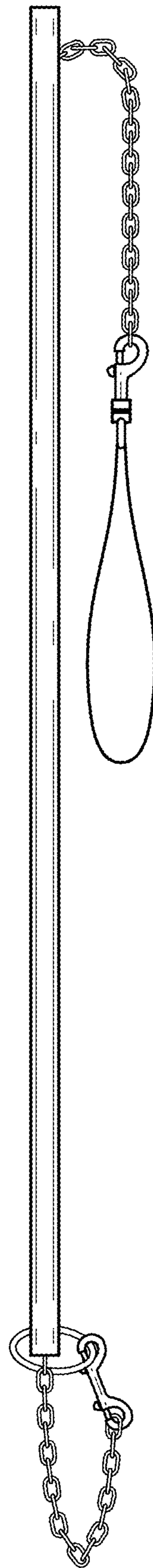

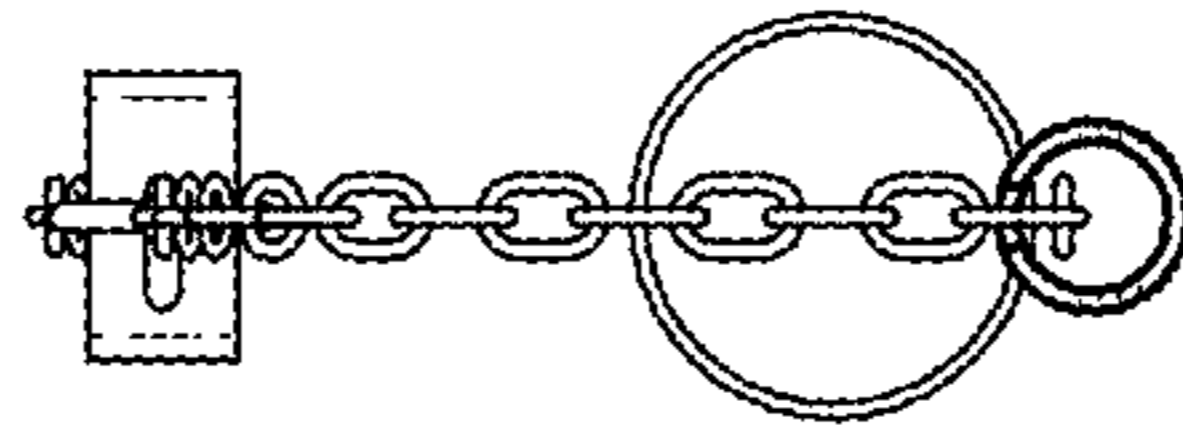

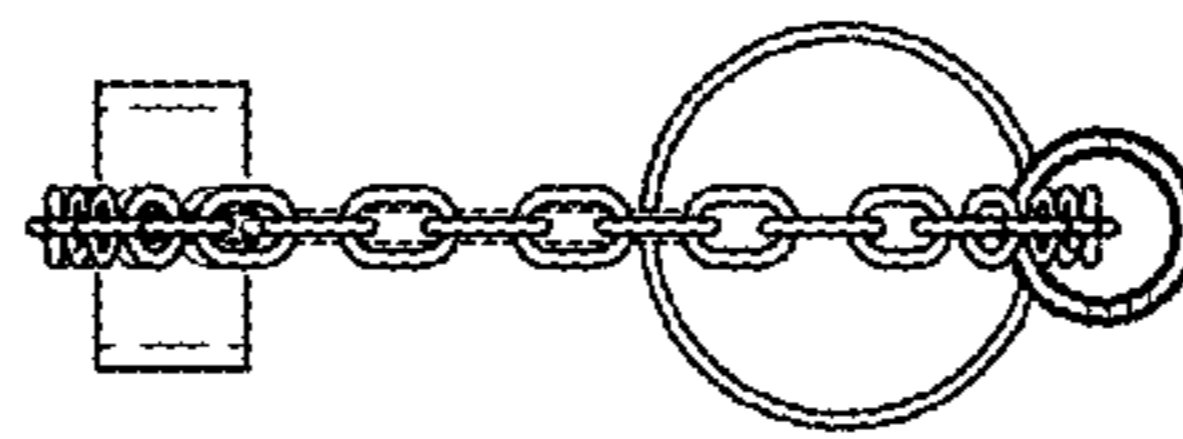
