FIG. 5 is a second top perspective view of the laundry knob of the present invention.

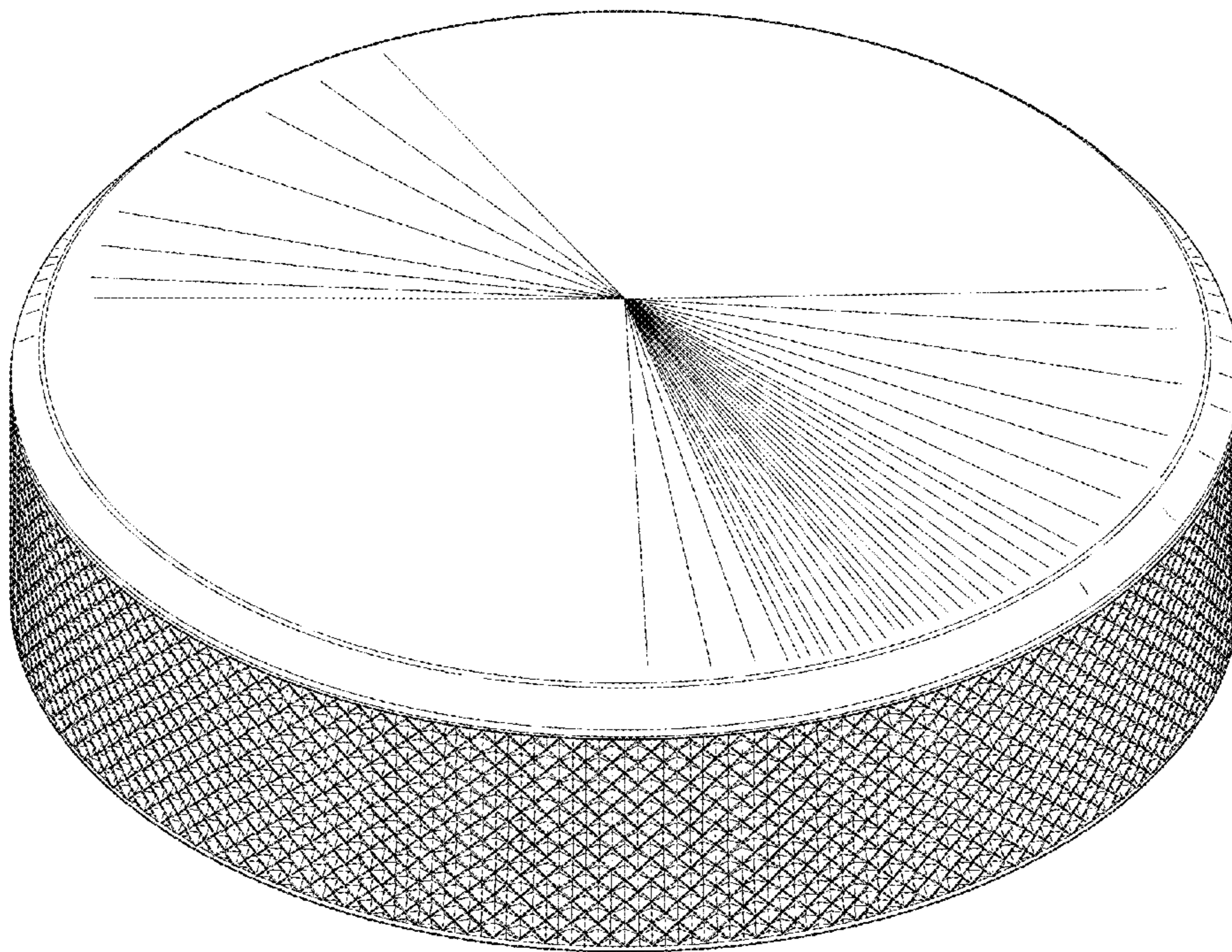

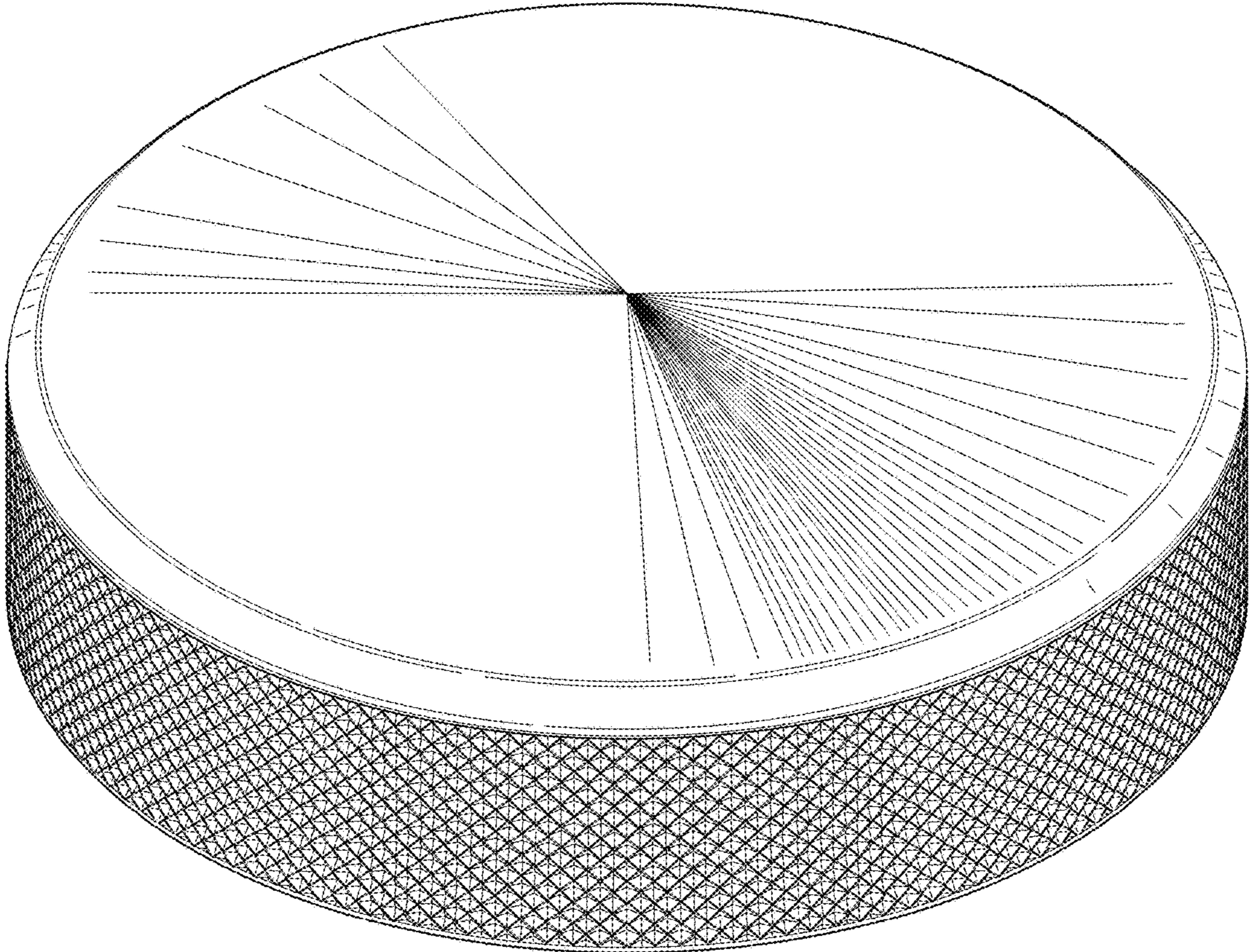

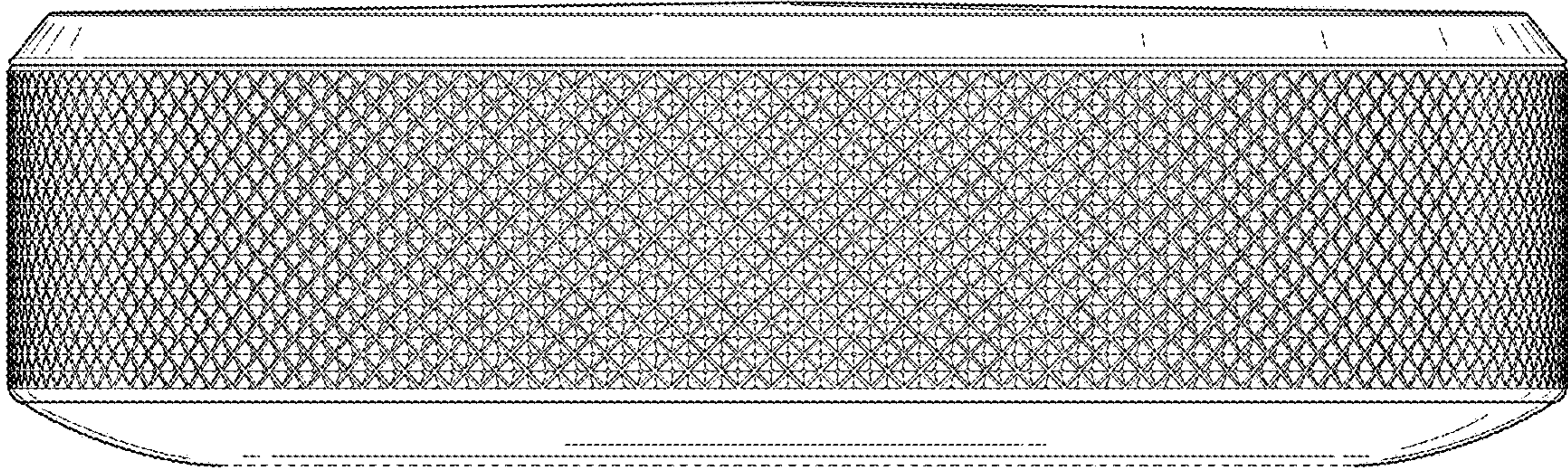

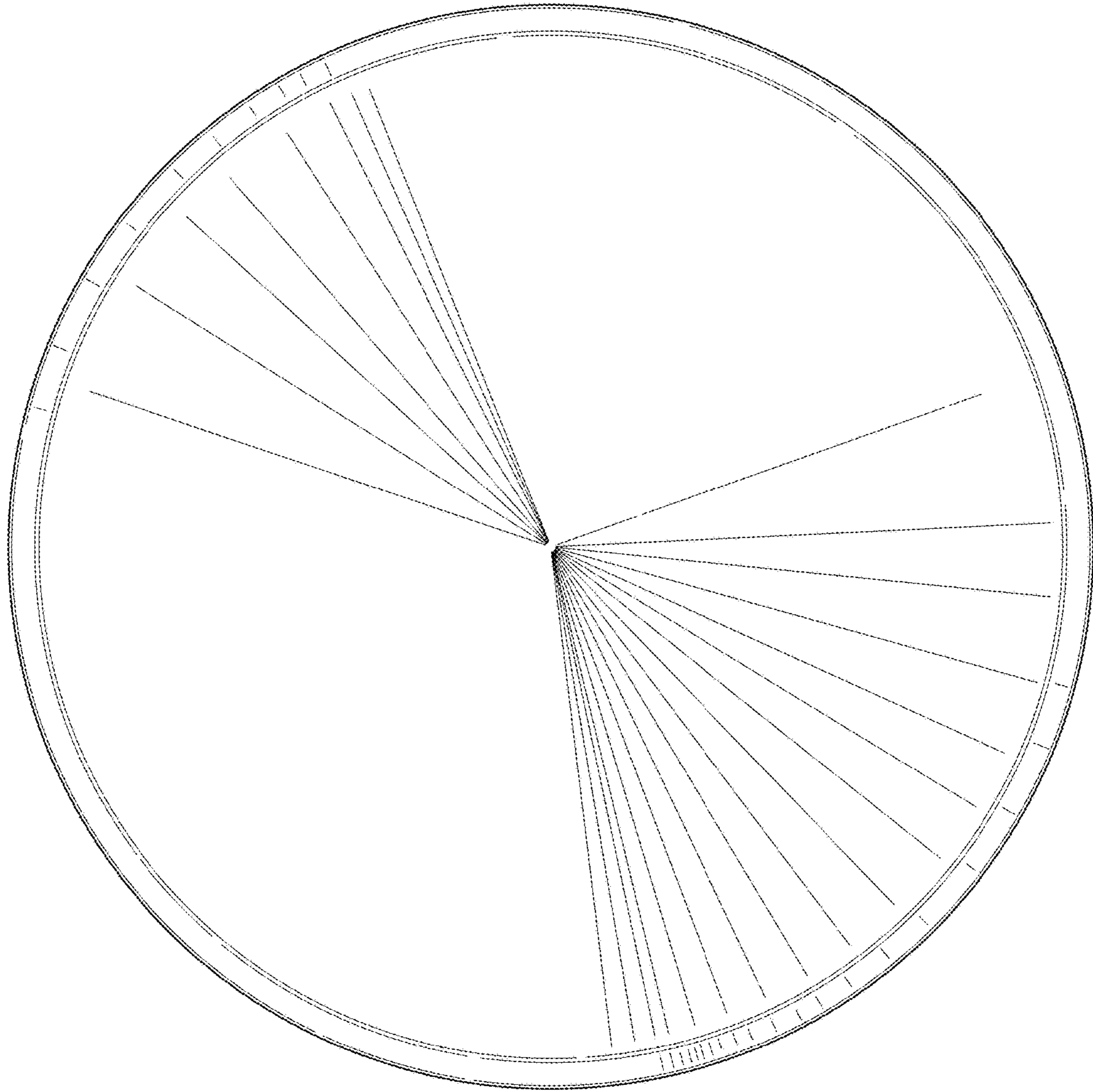

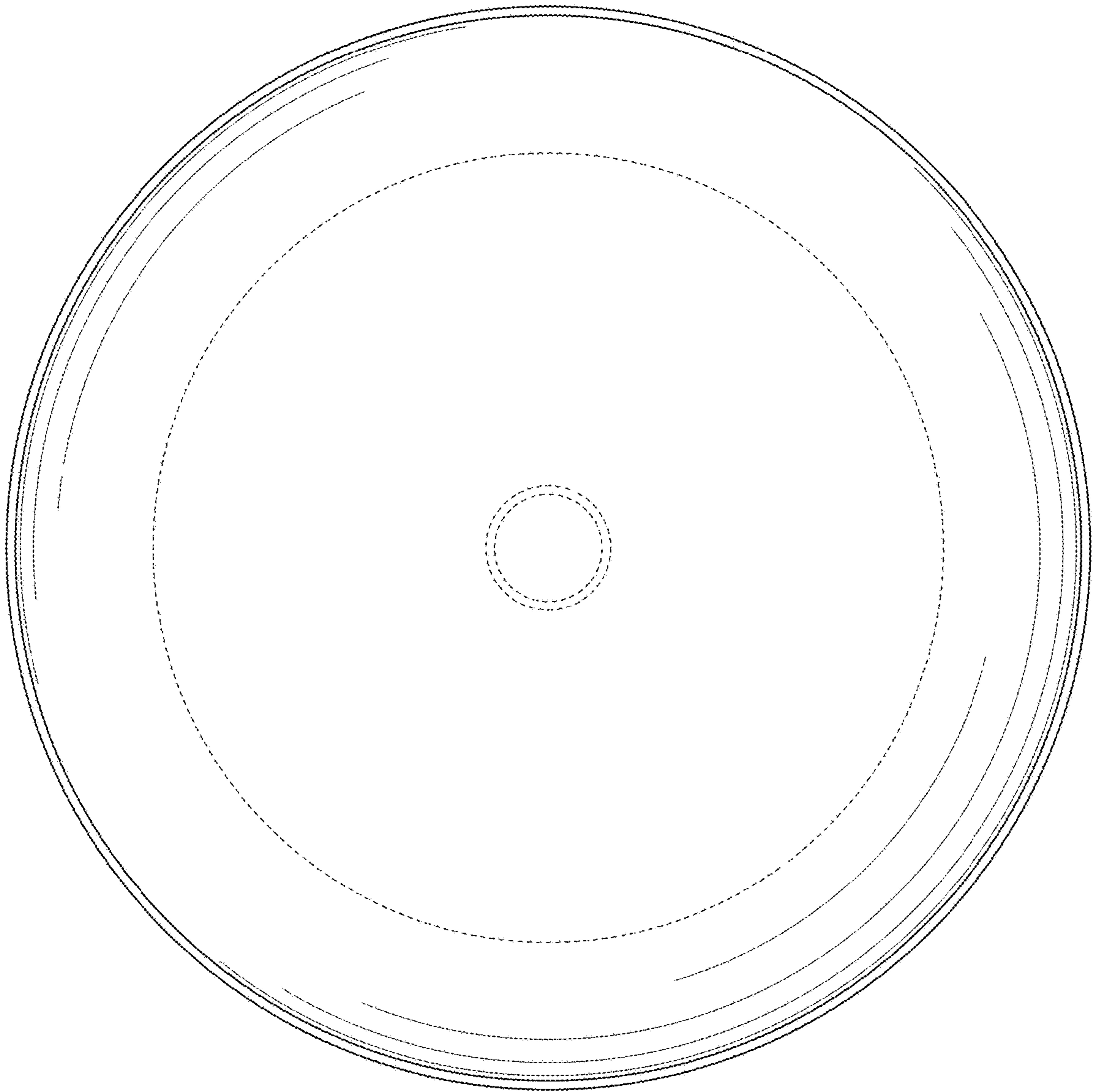

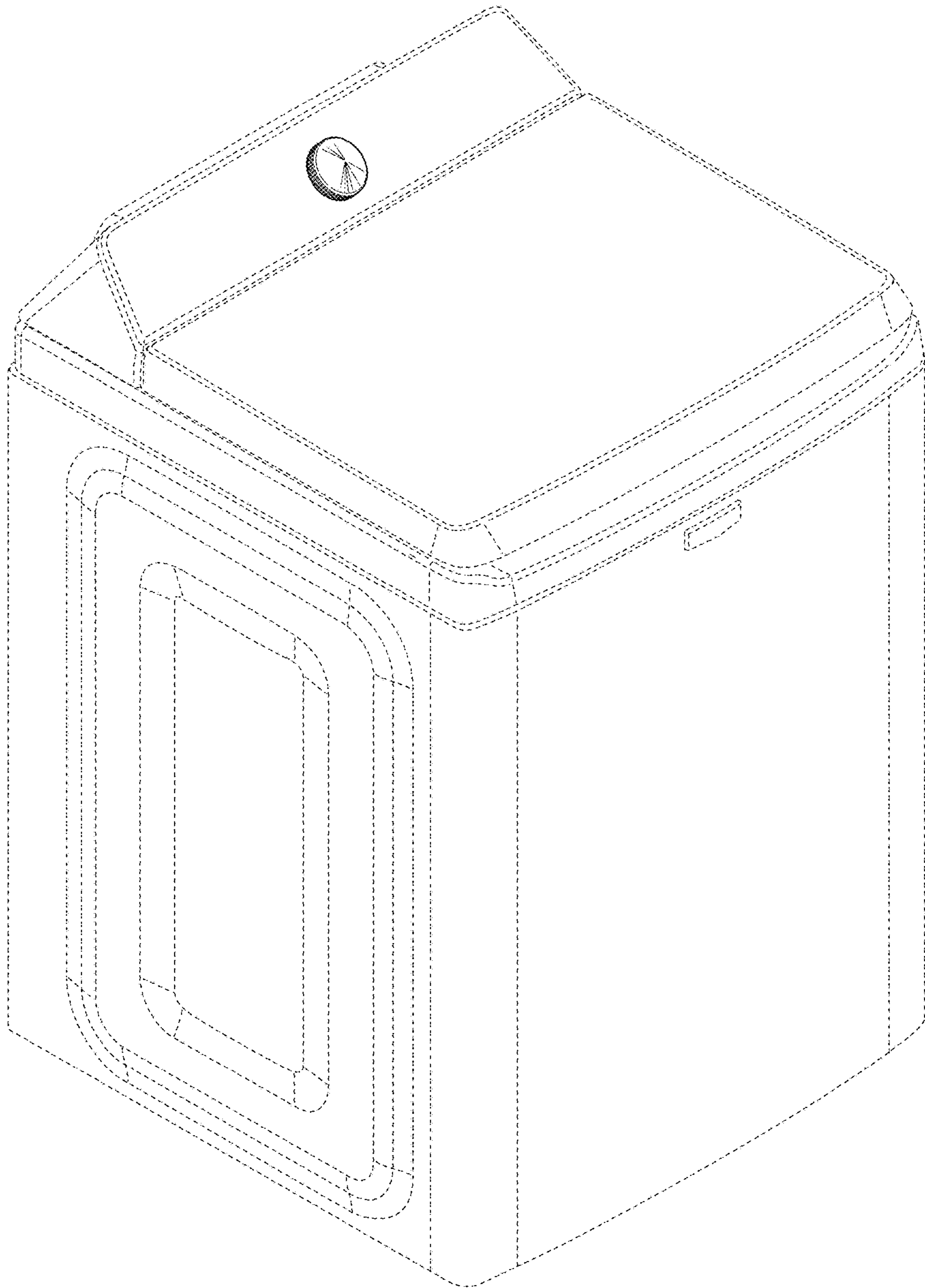
