I claim the ornamental design for an article of clothing, as shown and described.

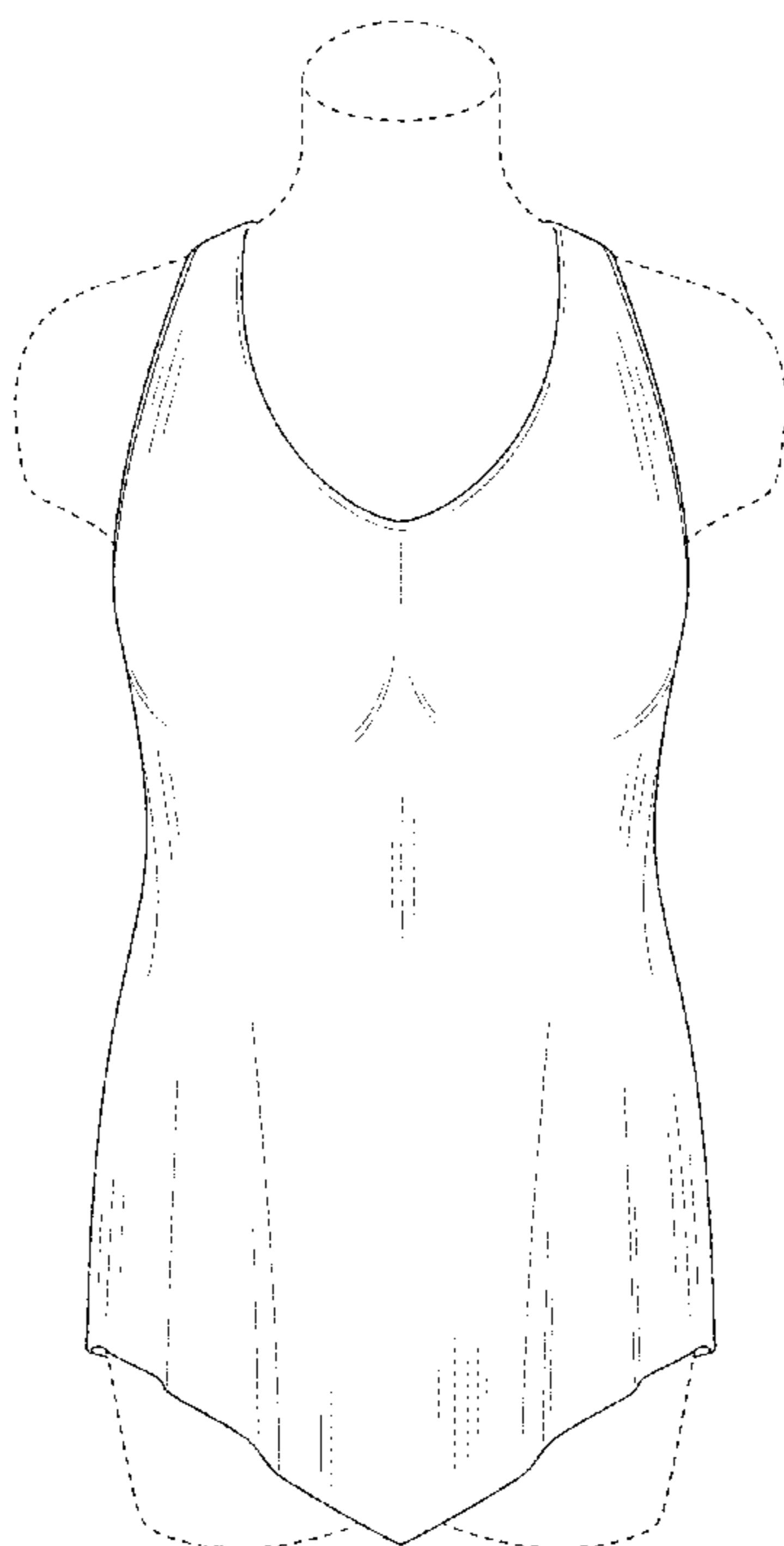
DESCRIPTION

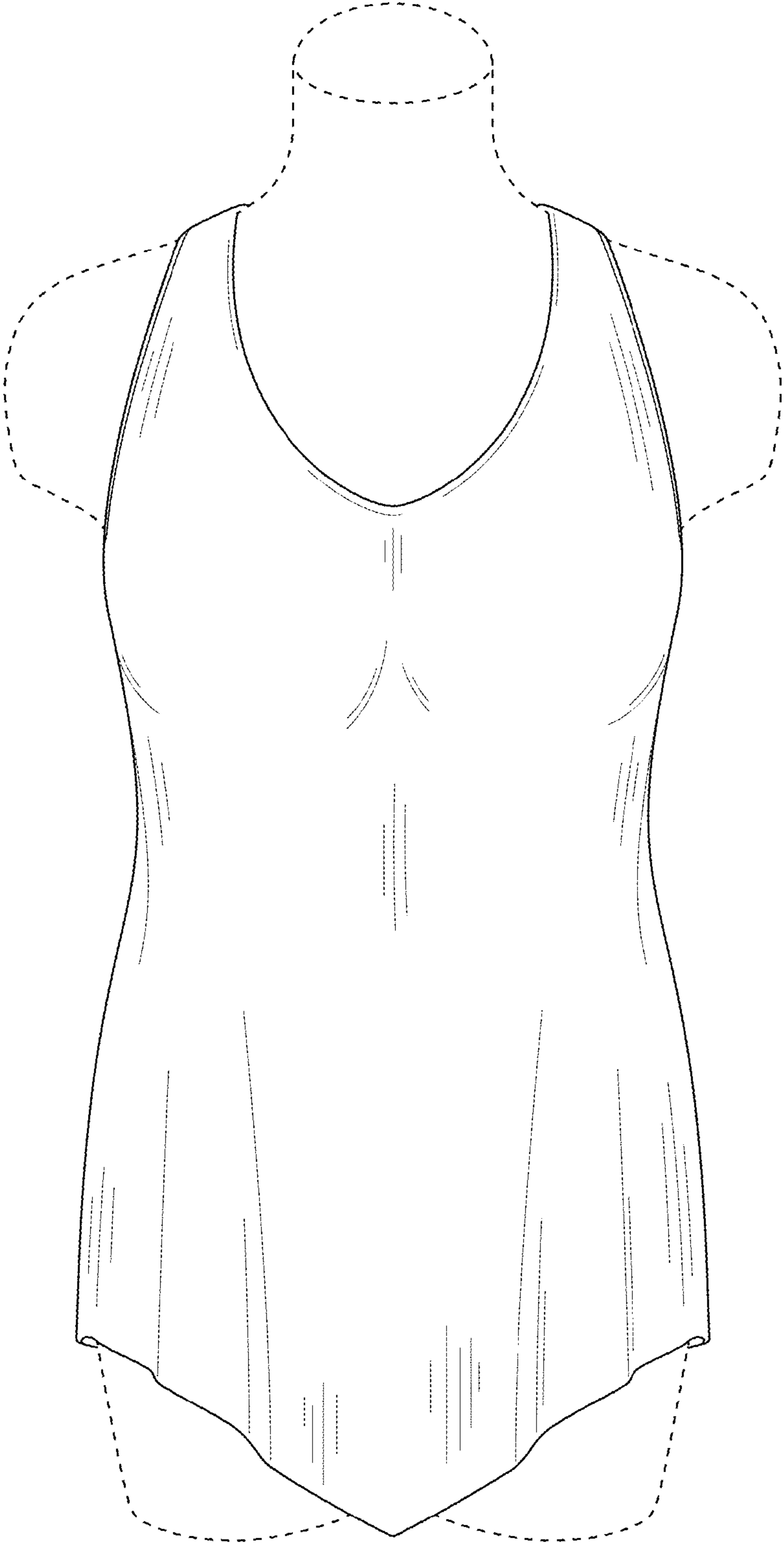

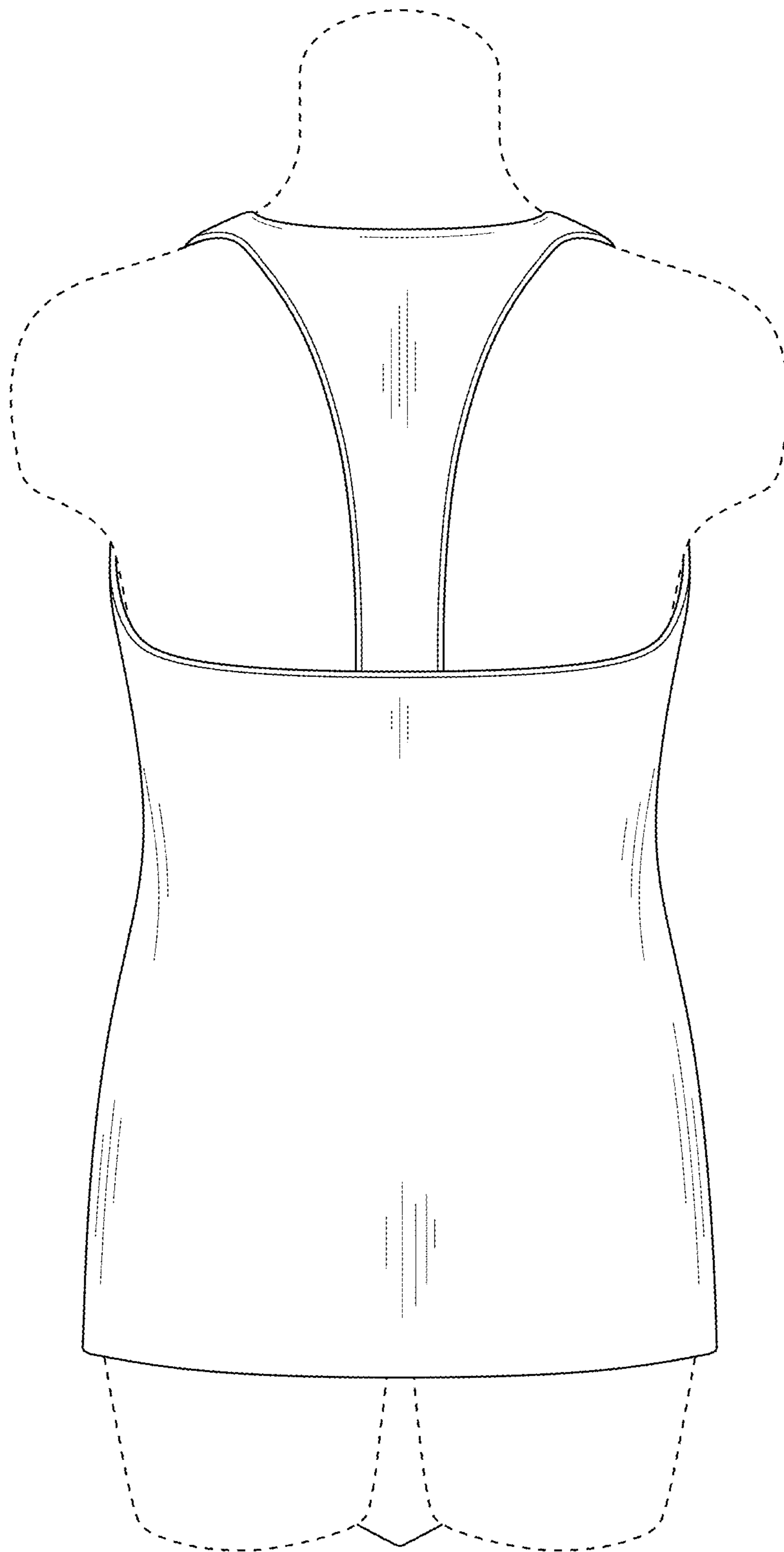

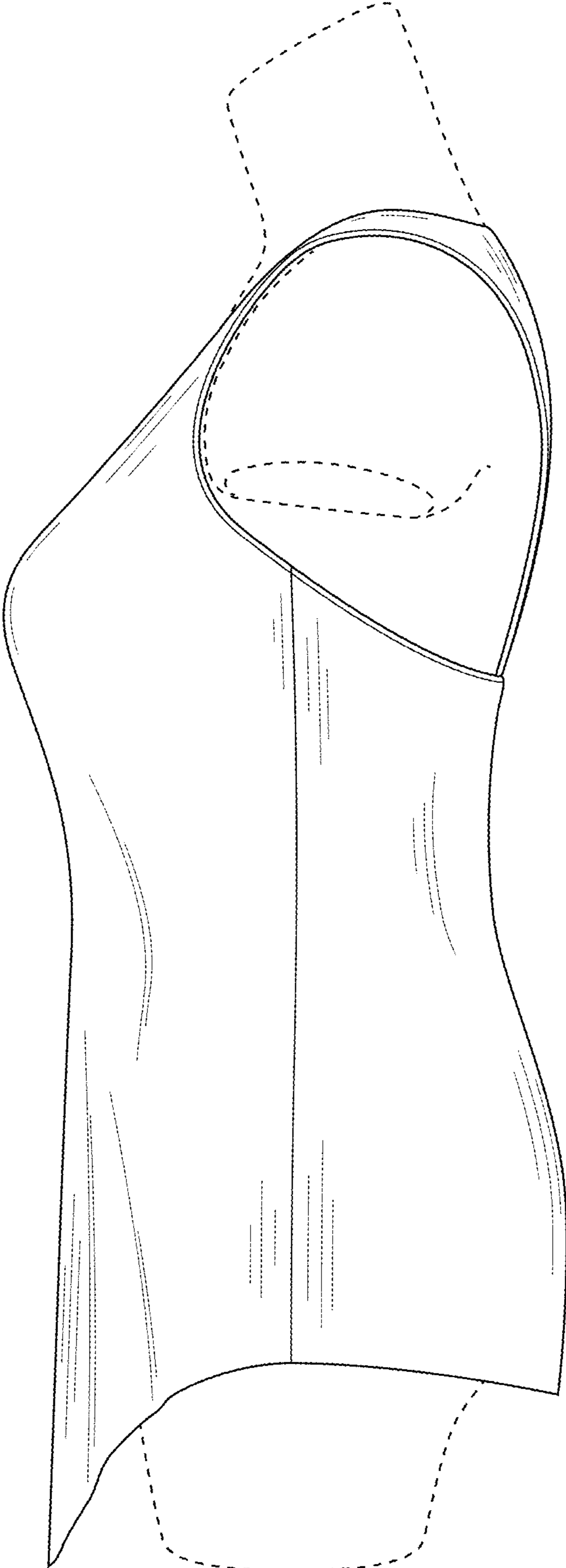

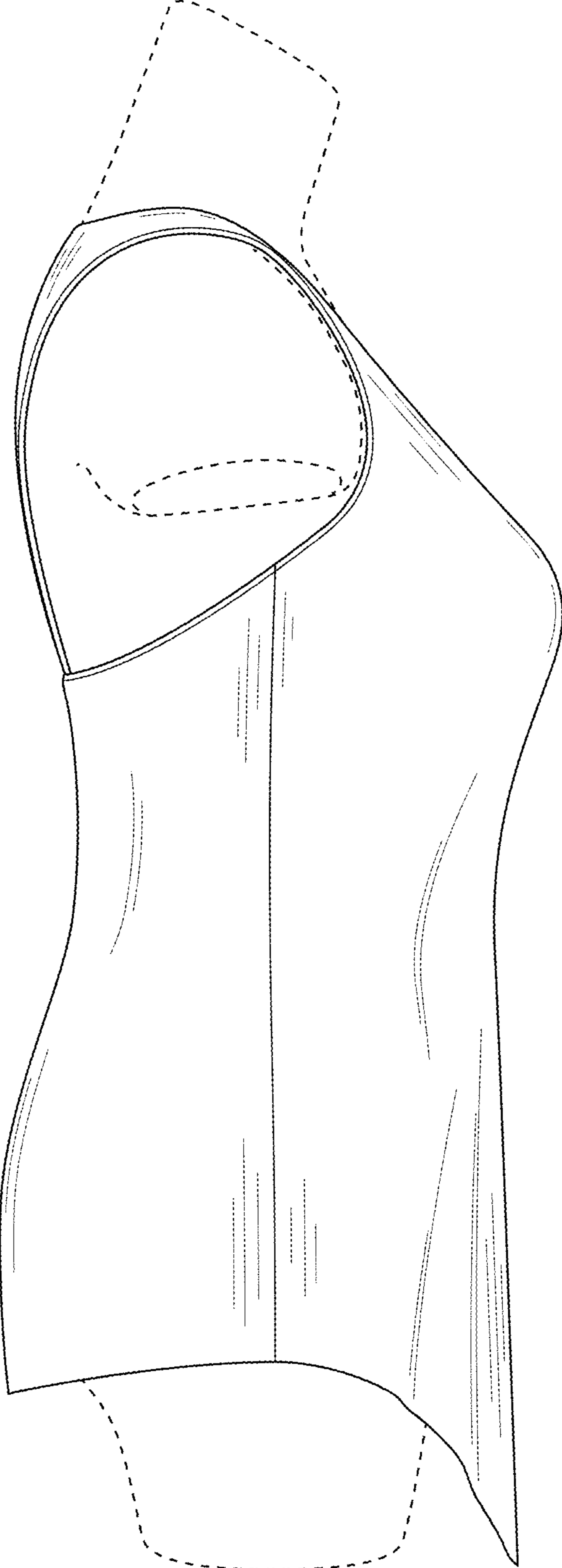
