(57) **CLAIM**

The ornamental design for a mascara removal tool case, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a mascara removal tool case showing my new design with its cover in a closed position. FIG. 2 is another perspective view showing the inside of my new design when the cover is in its fully opened position. FIG. 3 is a top plan view of the bottom of my new design with its cover in the closed position. FIG. 4 is a top plan view of the outside of the cover of my new design when the cover is in its fully open position. FIG. 5 is a front elevational view showing my new design when its cover is closed. FIG. 6 is a front elevational view showing my new design when its cover is in its completely open position; and, FIG. 7 is a back plan view showing my new design with its cover in a closed position.

The article in which the design is embodied is intended for the transport of a mascara-removal tool and its disposable accessories.

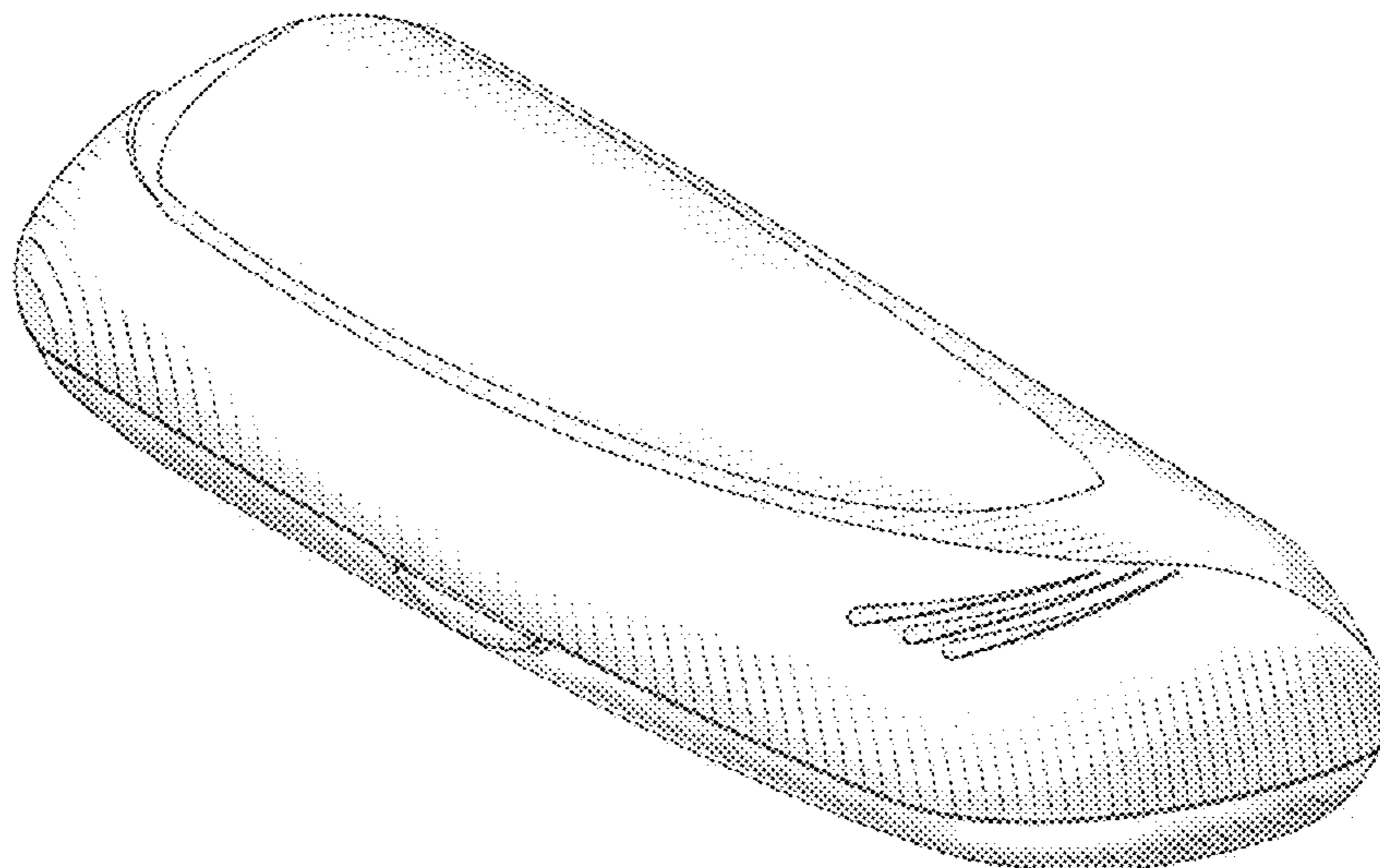

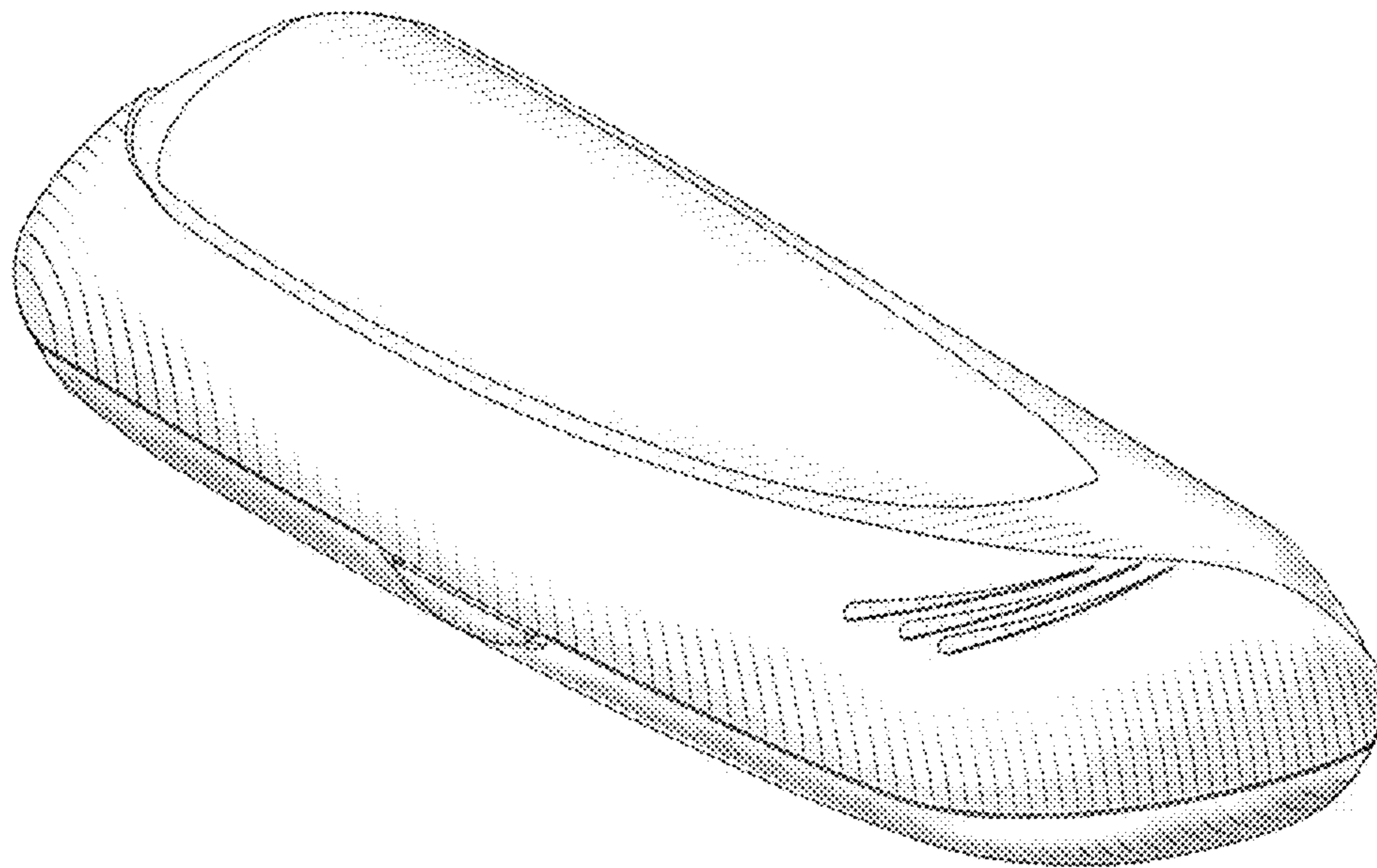

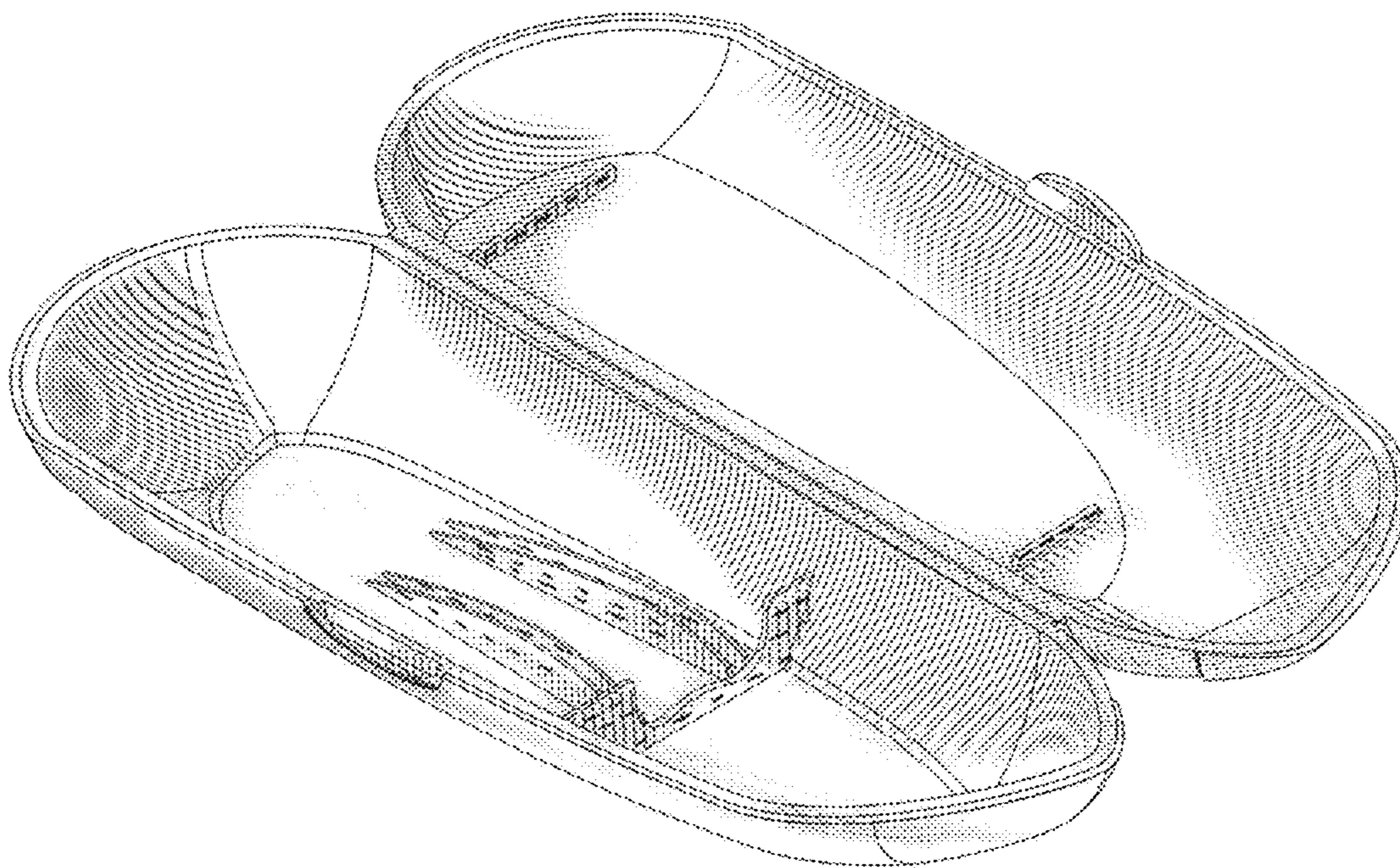

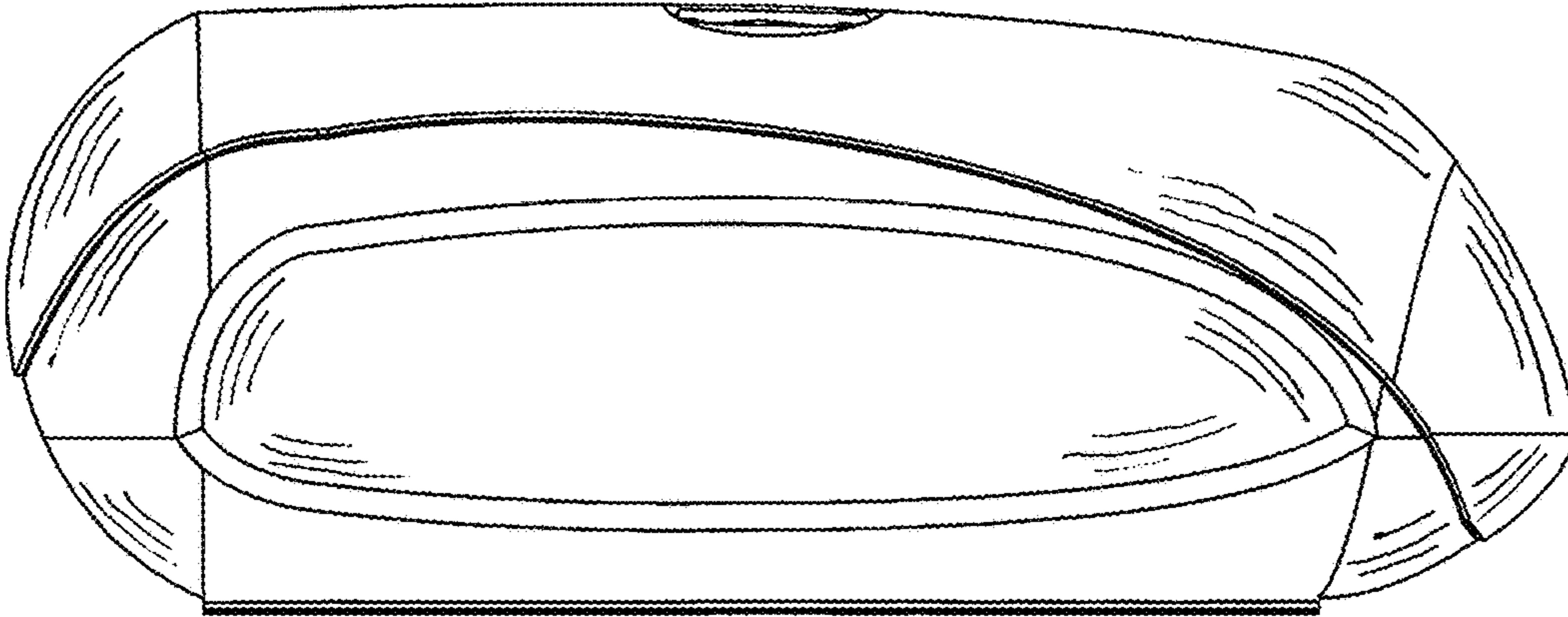

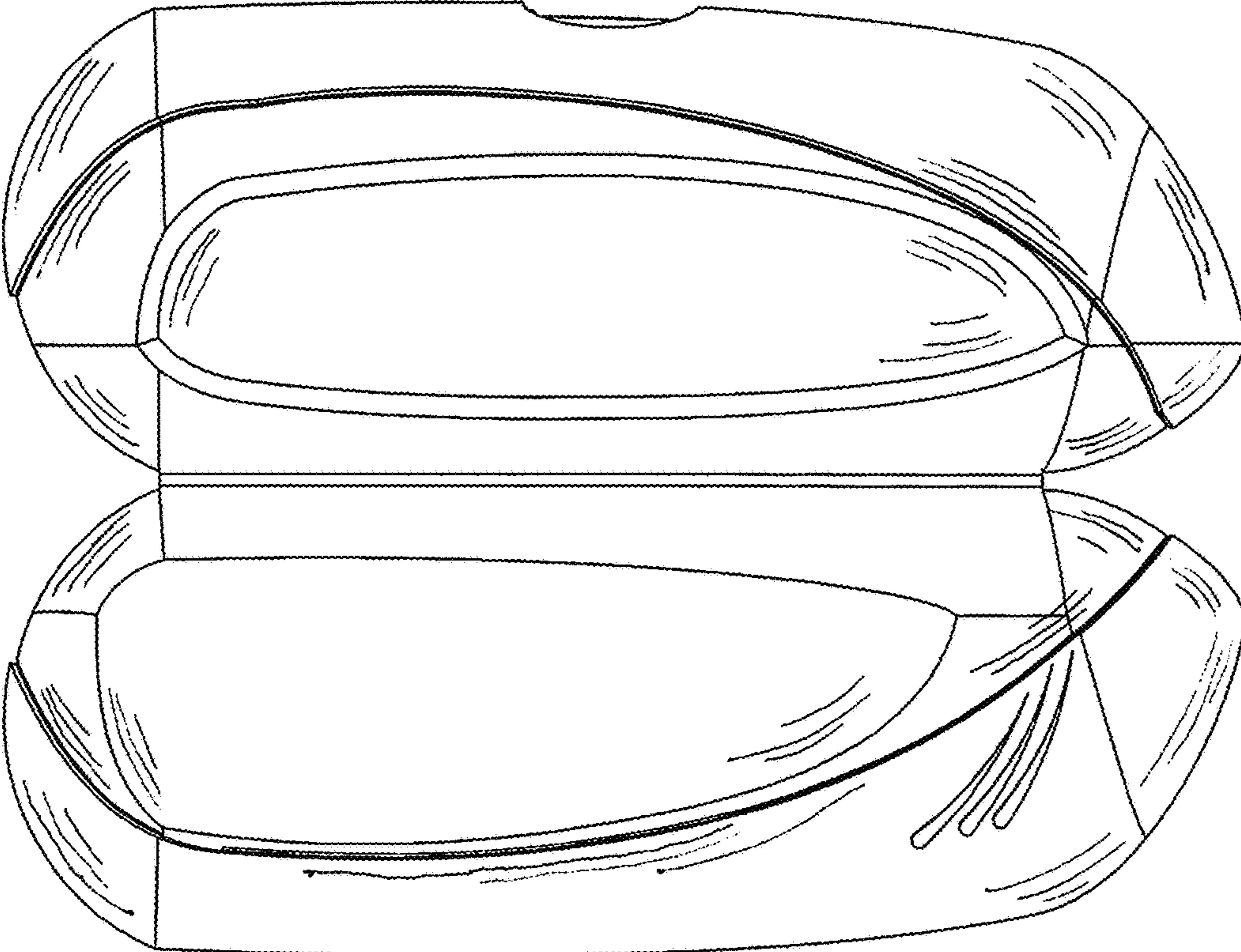

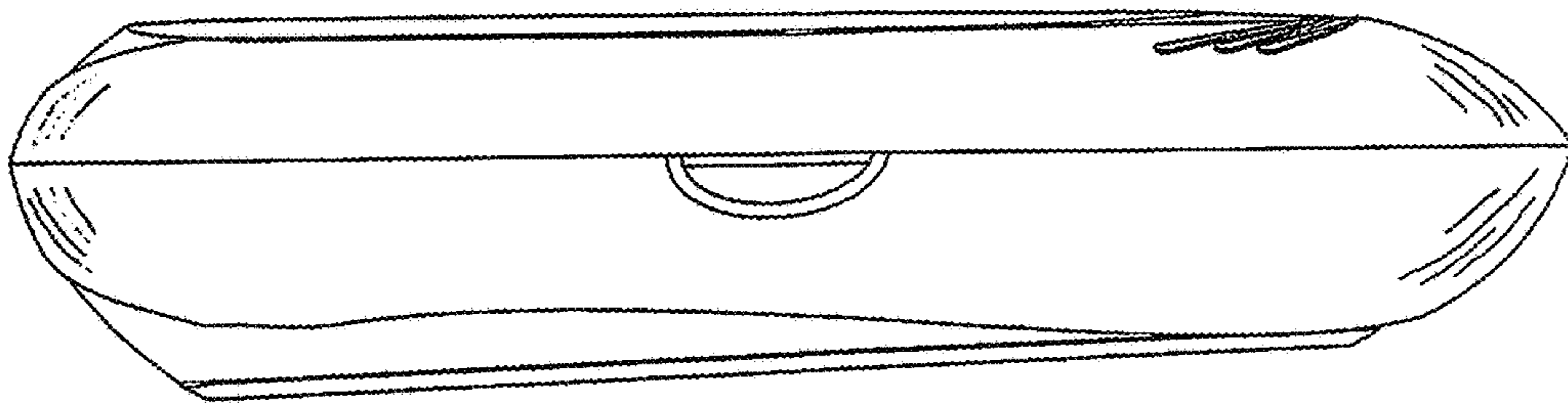

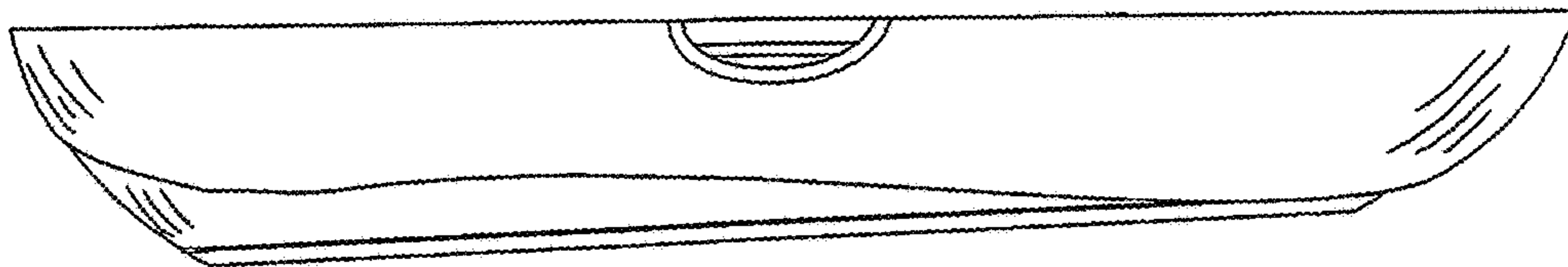
