(57) **CLAIM**

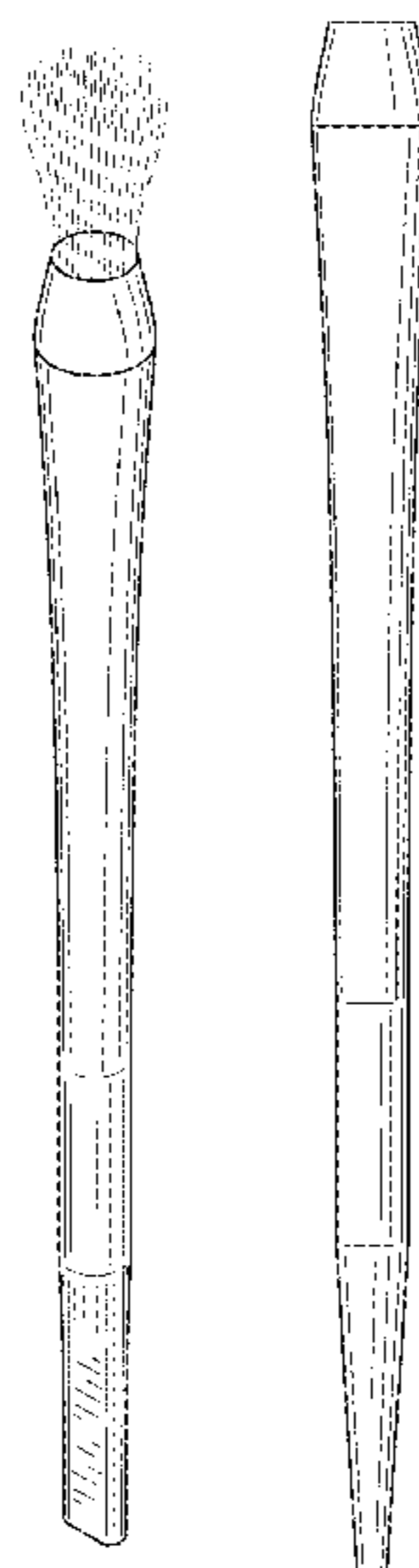
The ornamental design for a cosmetics brush, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a cosmetics brush showing my new design.
FIG. 2 is a front elevation view thereof, the rear being a mirror image;
FIG. 3 is a right side elevation view thereof, the left side being a mirror image;
FIG. 4 is a top plan view thereof; and,
FIG. 5 is a bottom plan view thereof.
The cosmetics brush is not limited to the scale shown herein. Broken lines of FIG. 1 illustrate portions of the cosmetics brush that form no part of the claimed invention.

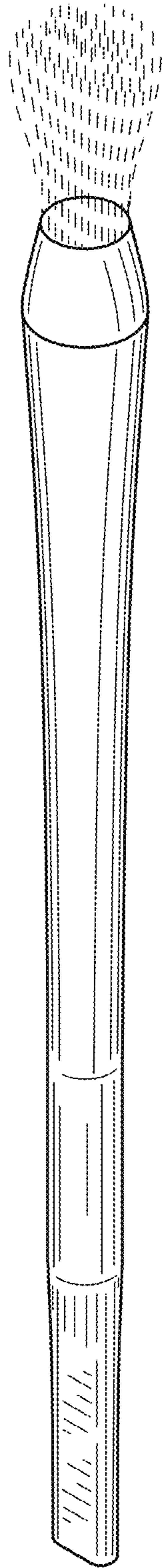

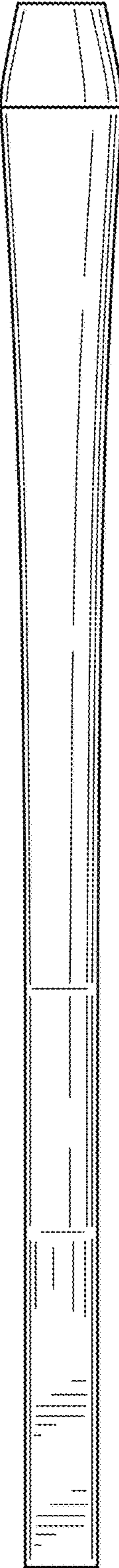

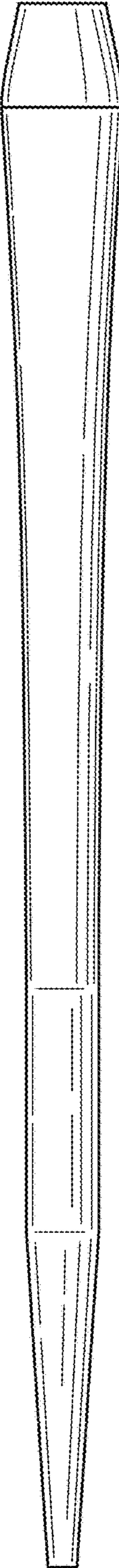

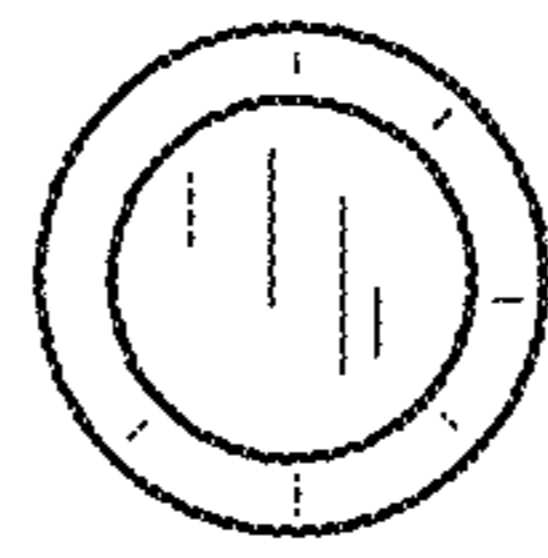

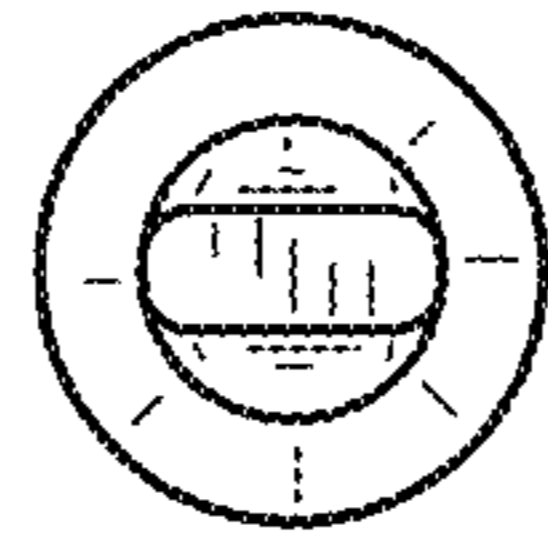
