(57) **CLAIM**

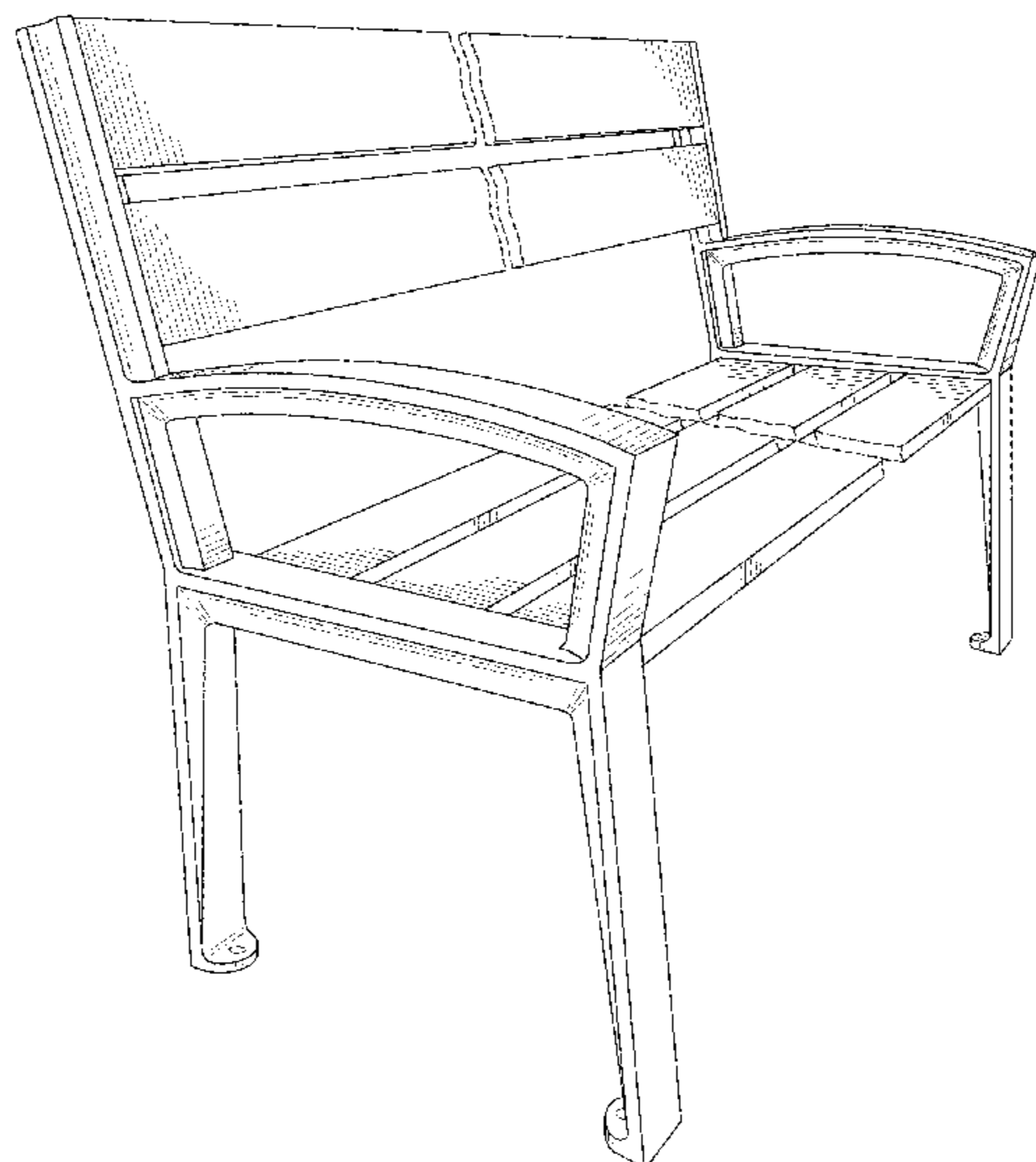
The ornamental design for a bench, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a bench embodying the present design;
FIG. 2 is a rear perspective view thereof;
FIG. 3 is a right side view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a front view thereof;
FIG. 6 is a rear view thereof;
FIG. 7 is a top view thereof; and,
FIG. 8 is a bottom view thereof.
The bench is shown as broken in the center in FIGS. 1-2 and 5-9 to indicate that the claimed bench design is of variable length.

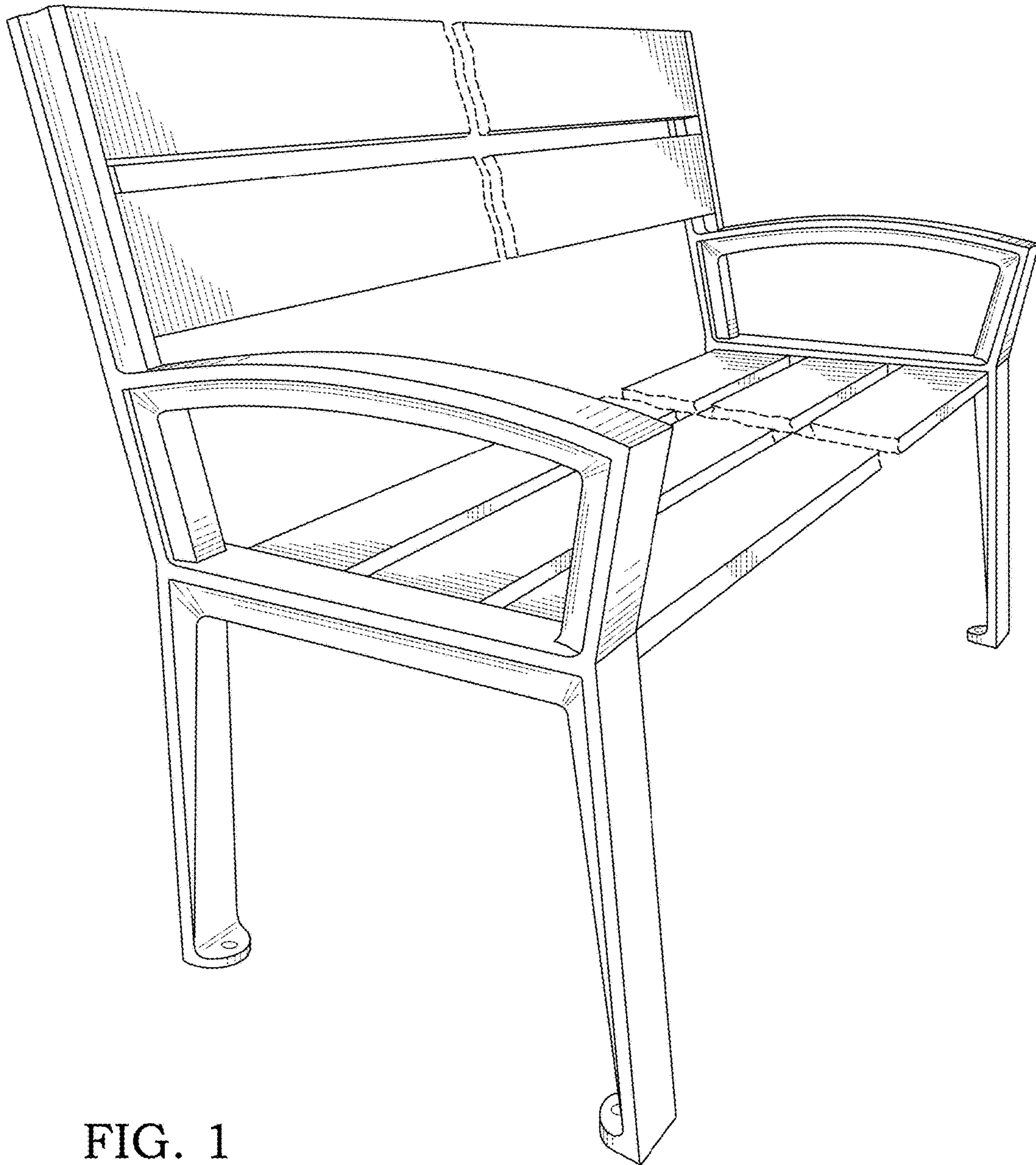

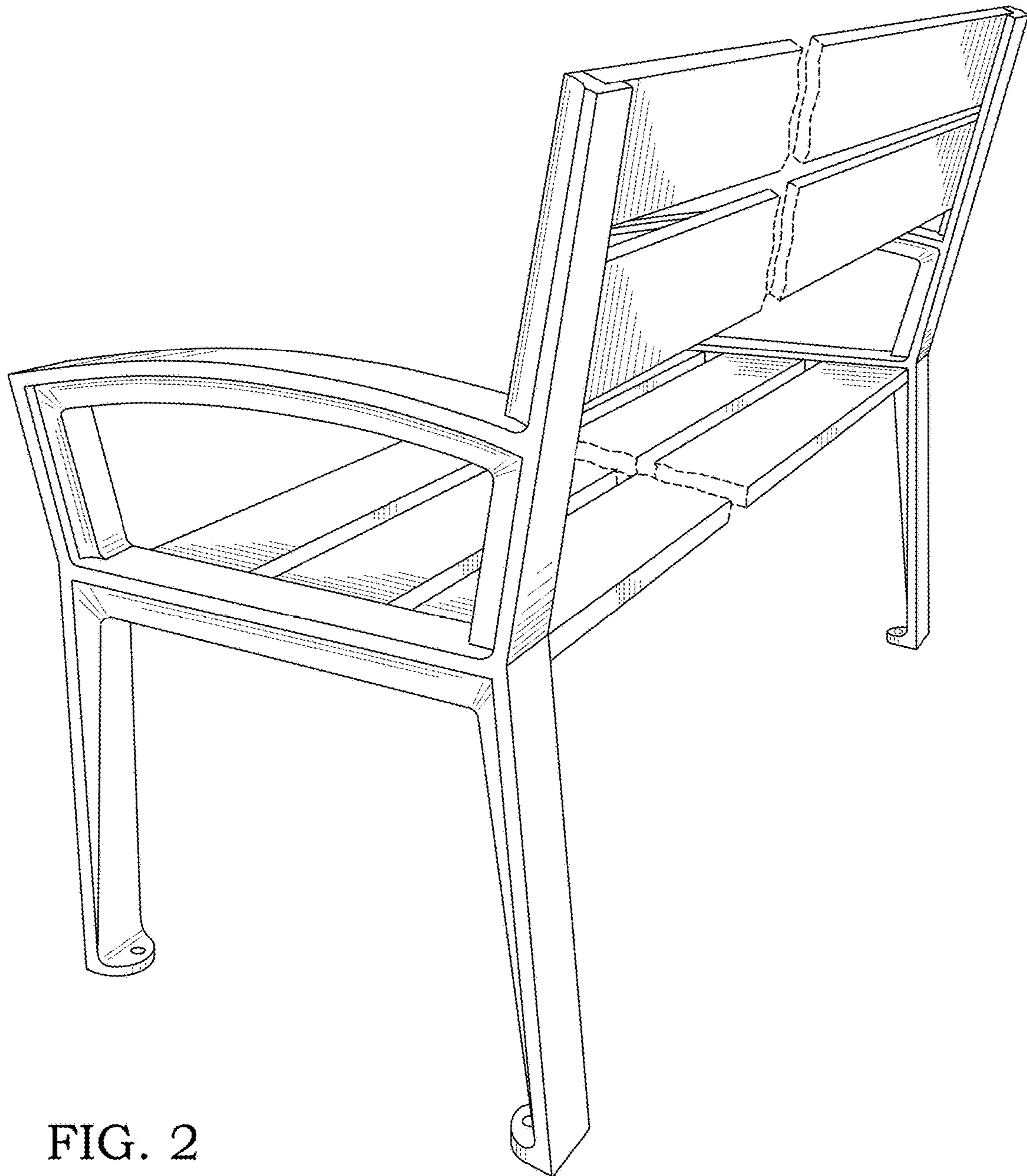

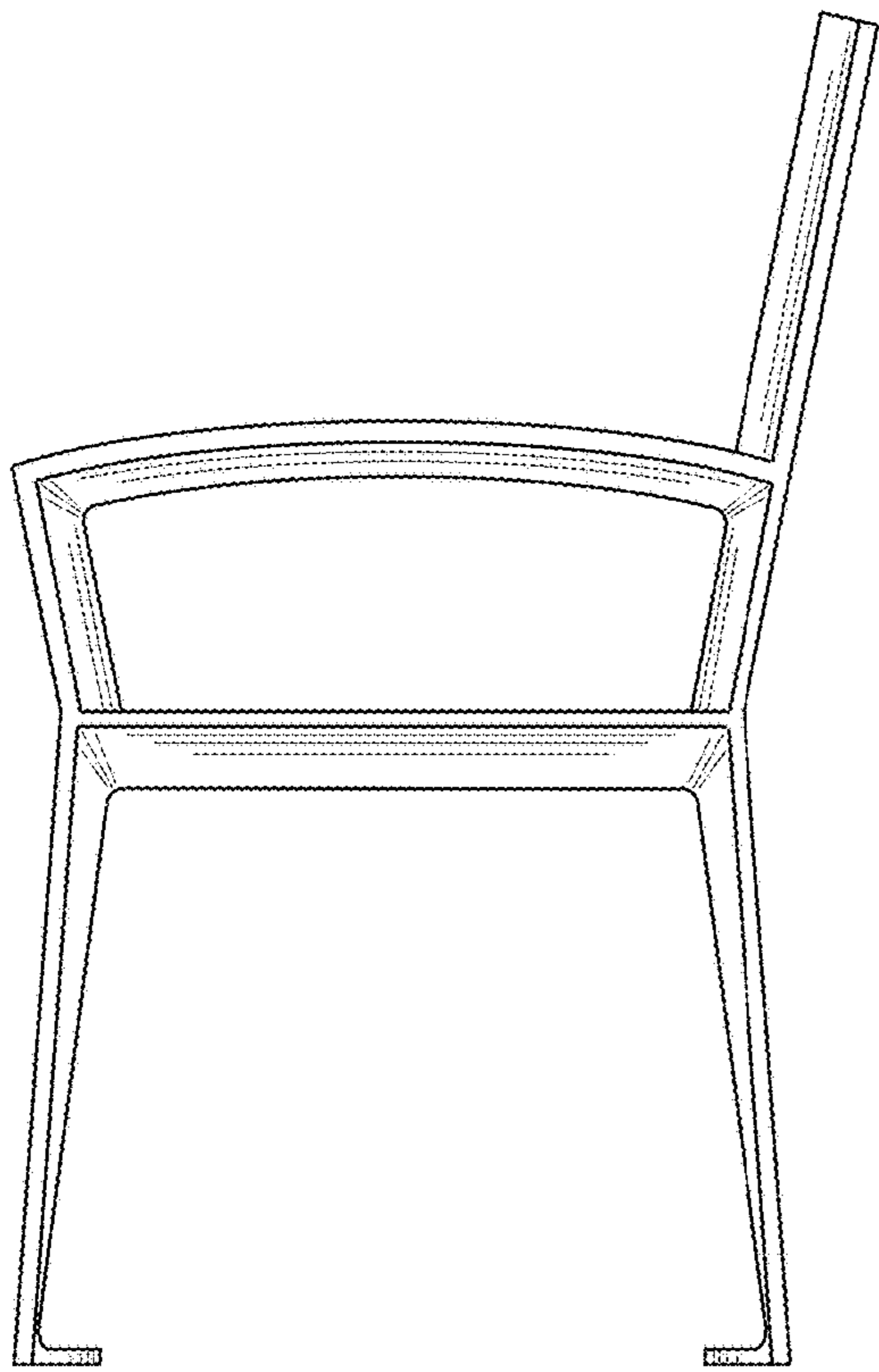

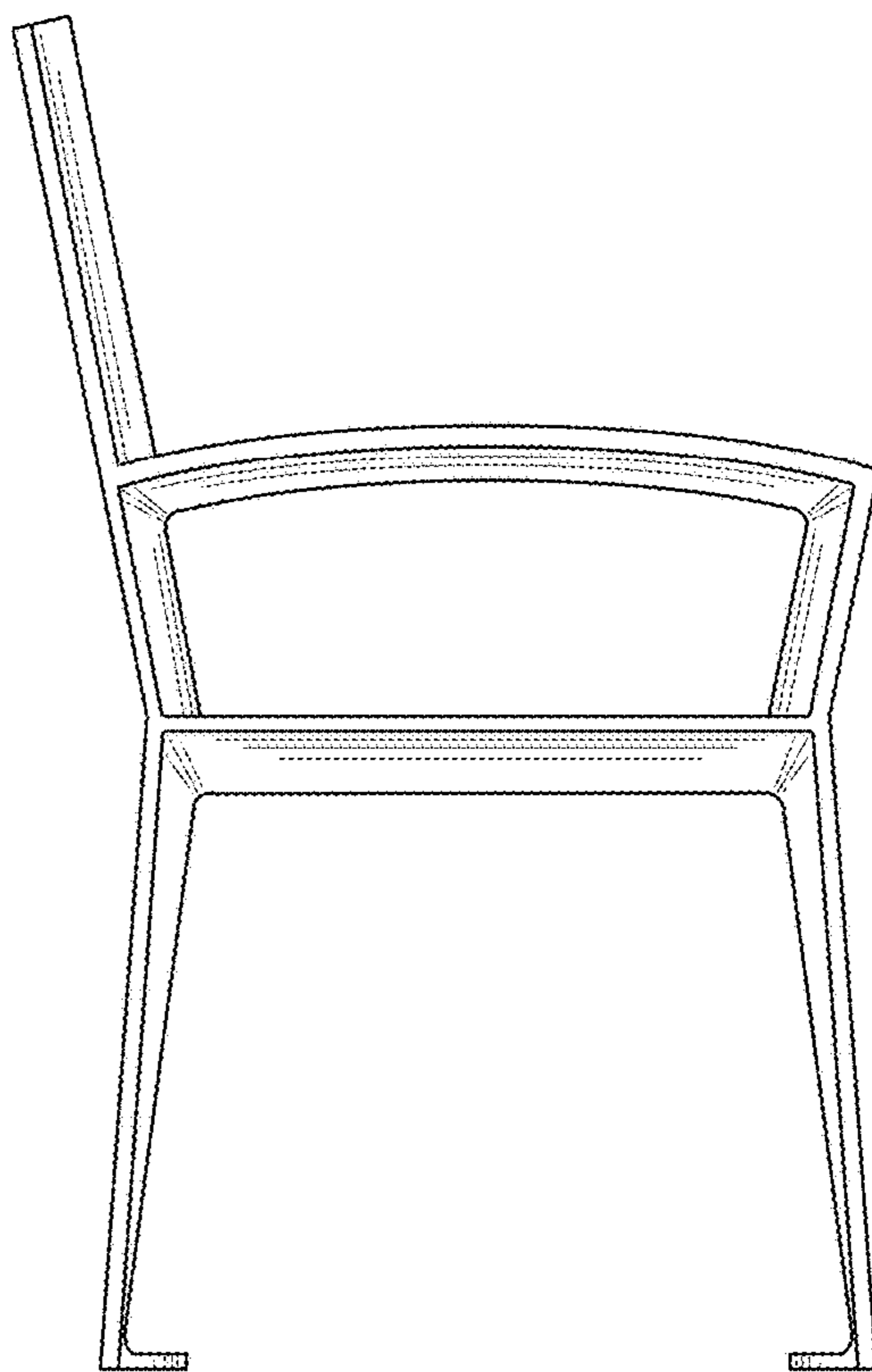

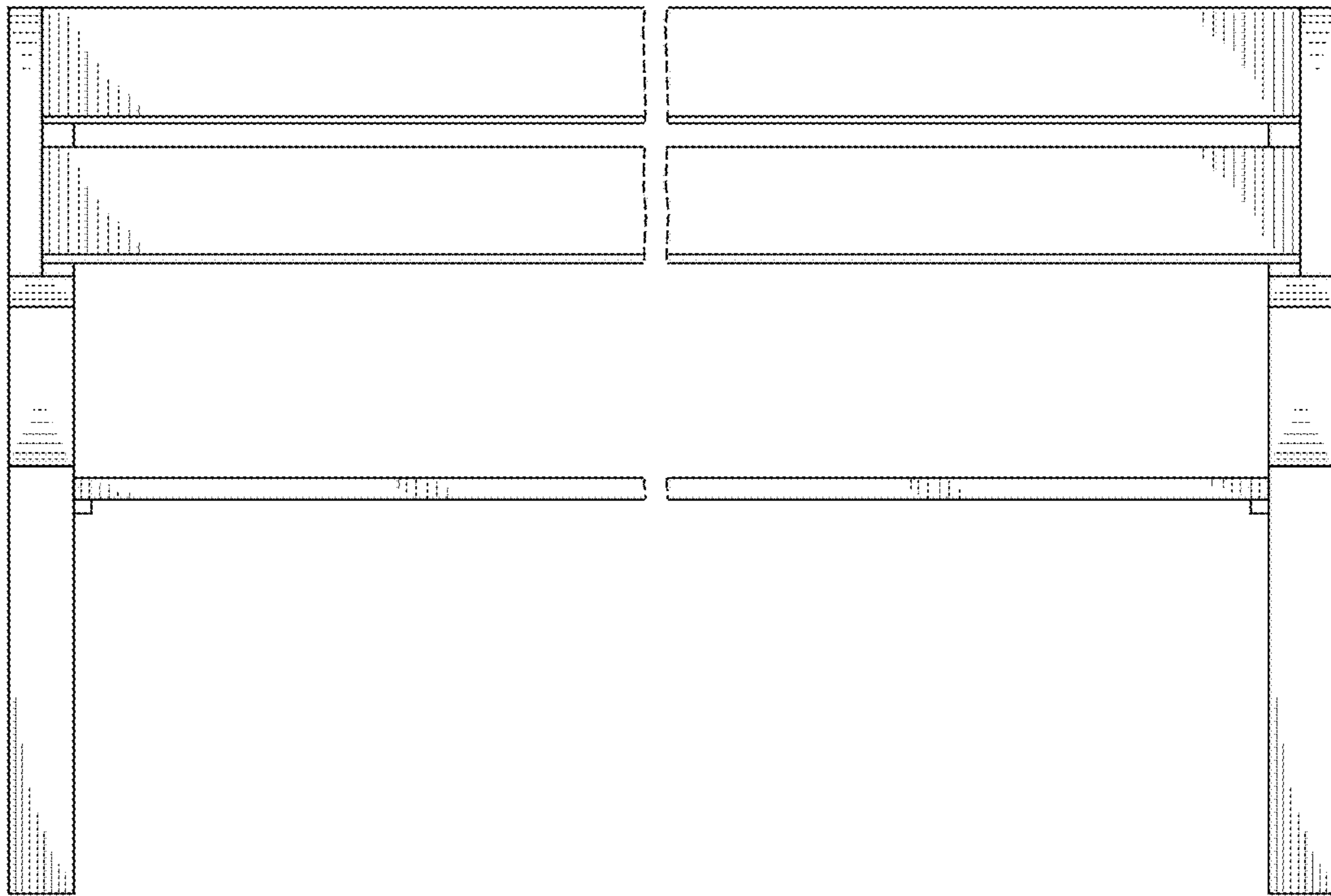

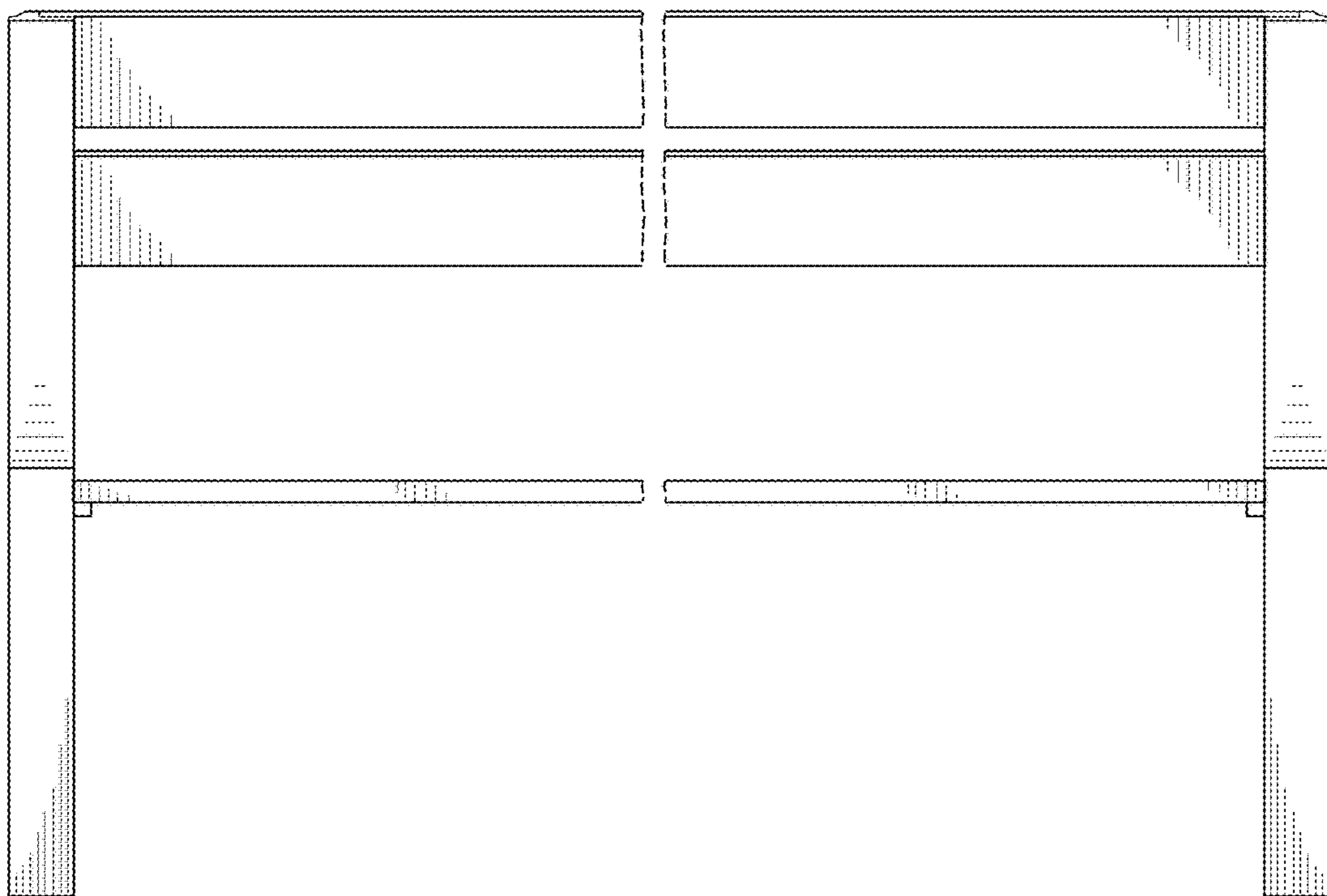

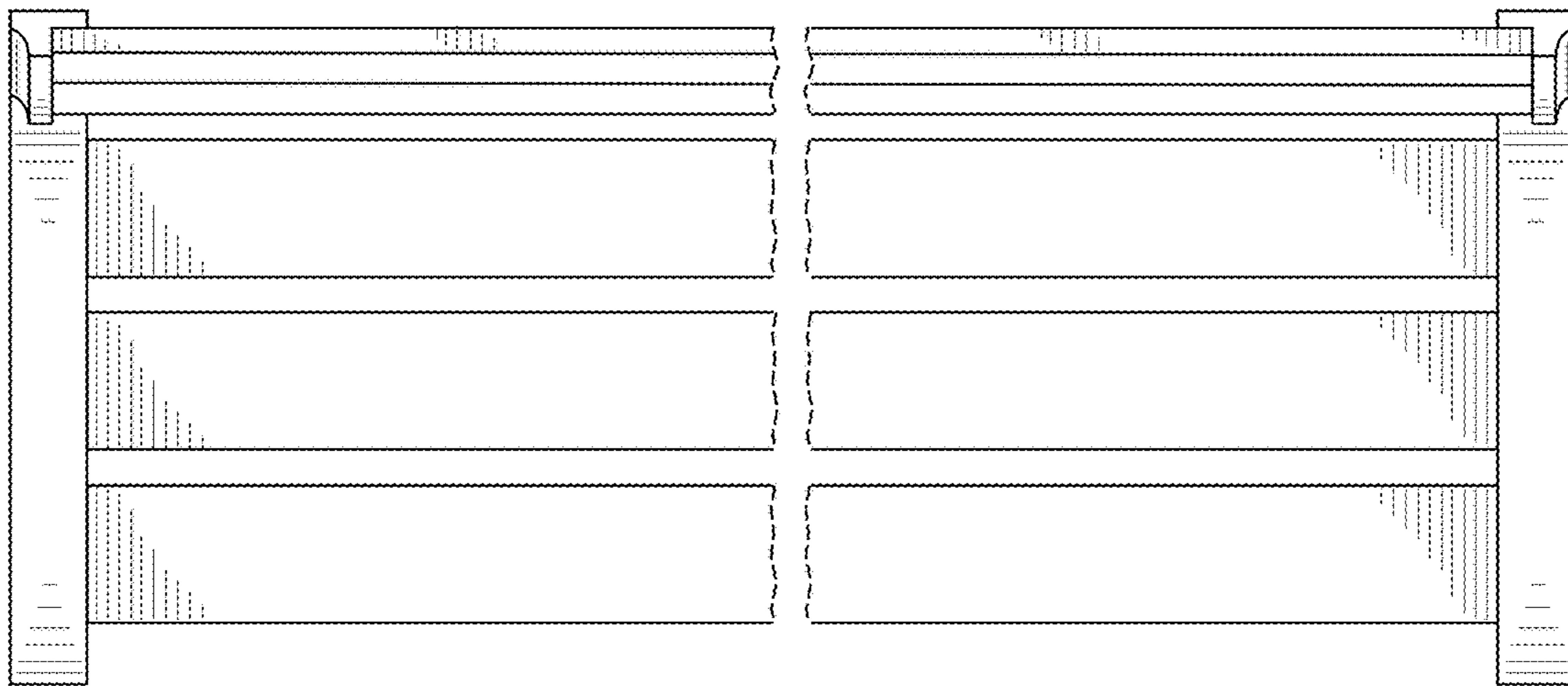

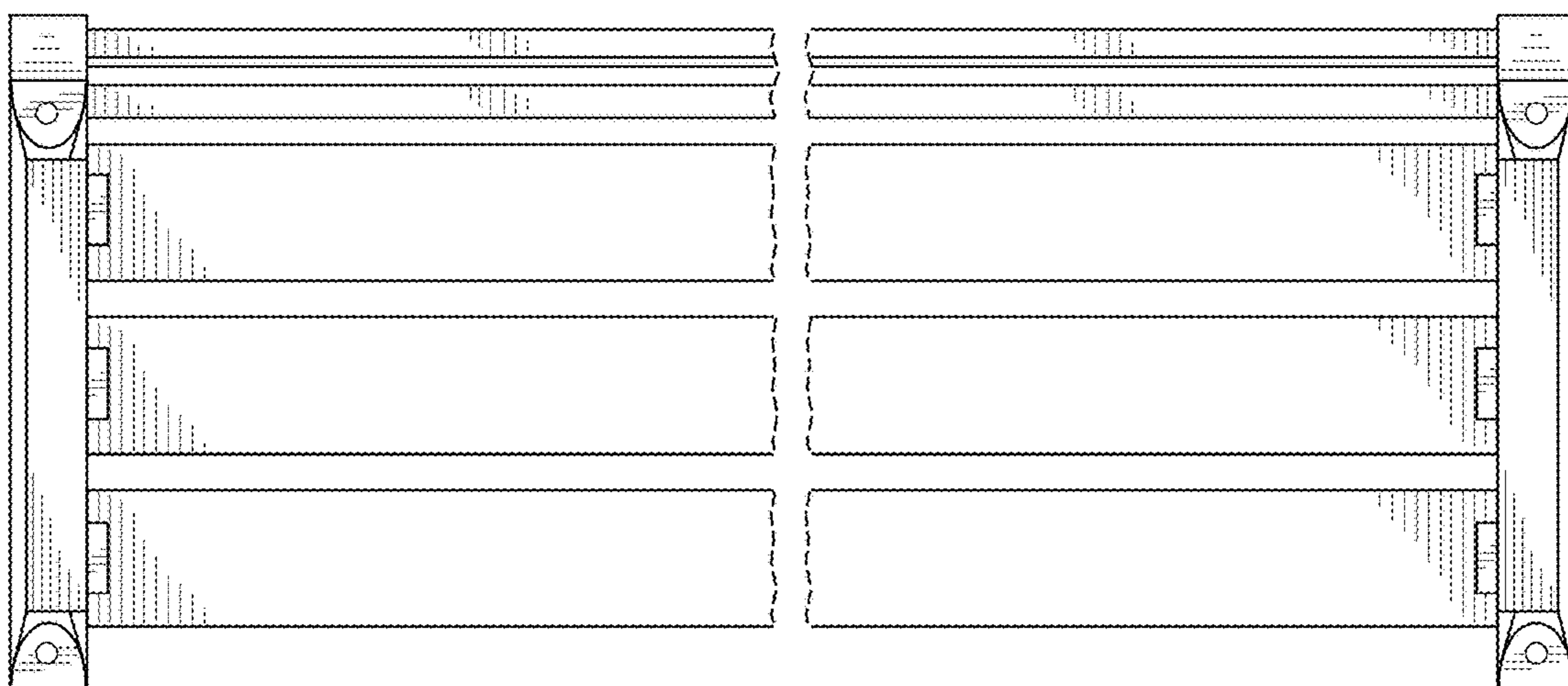
