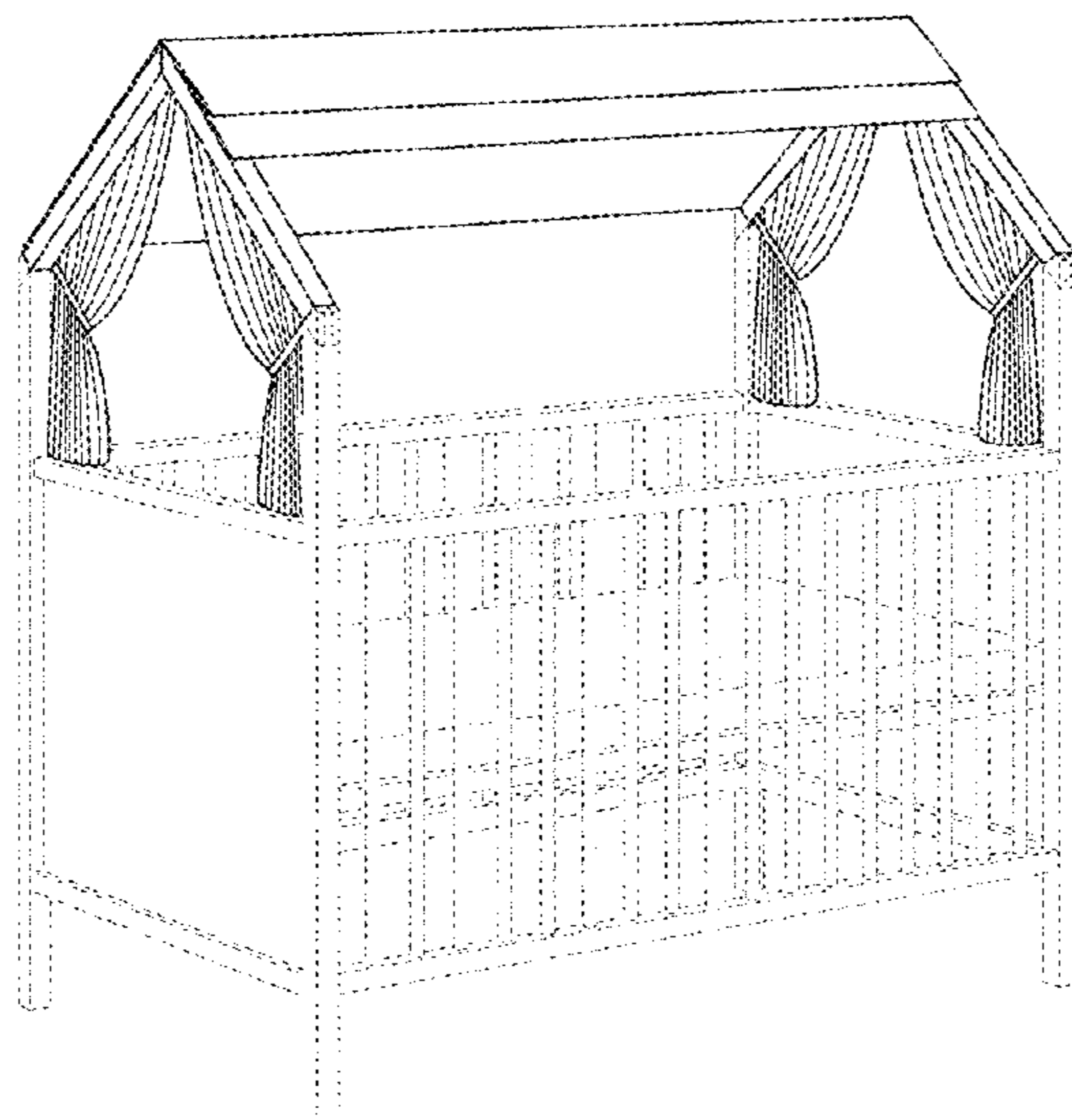
(57) **CLAIM**

The ornamental design for a crib covering, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a crib covering with curtains in a first configuration;  
FIG. 2 is a front view thereof;  
FIG. 3 is a left side view thereof;  
FIG. 4 is a rear view thereof;  
FIG. 5 is a right side view thereof;  
FIG. 6 is a top view thereof;  
FIG. 7 is a bottom view thereof; and,  
FIG. 8 is a perspective view thereof, with the curtains in a second configuration.  
The broken lines shown in the drawings illustrate environmental structure, and form no part of the claimed design.

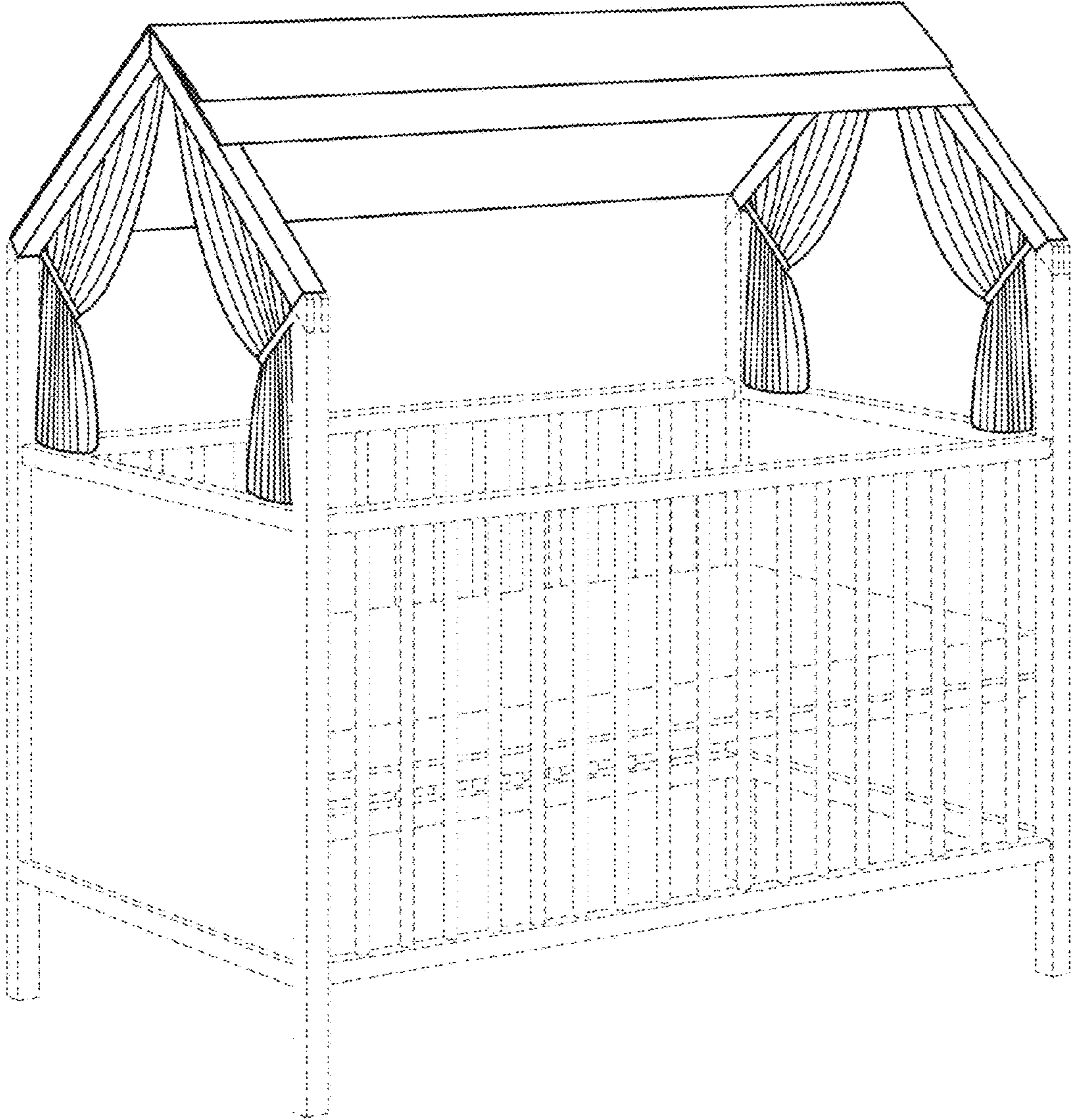

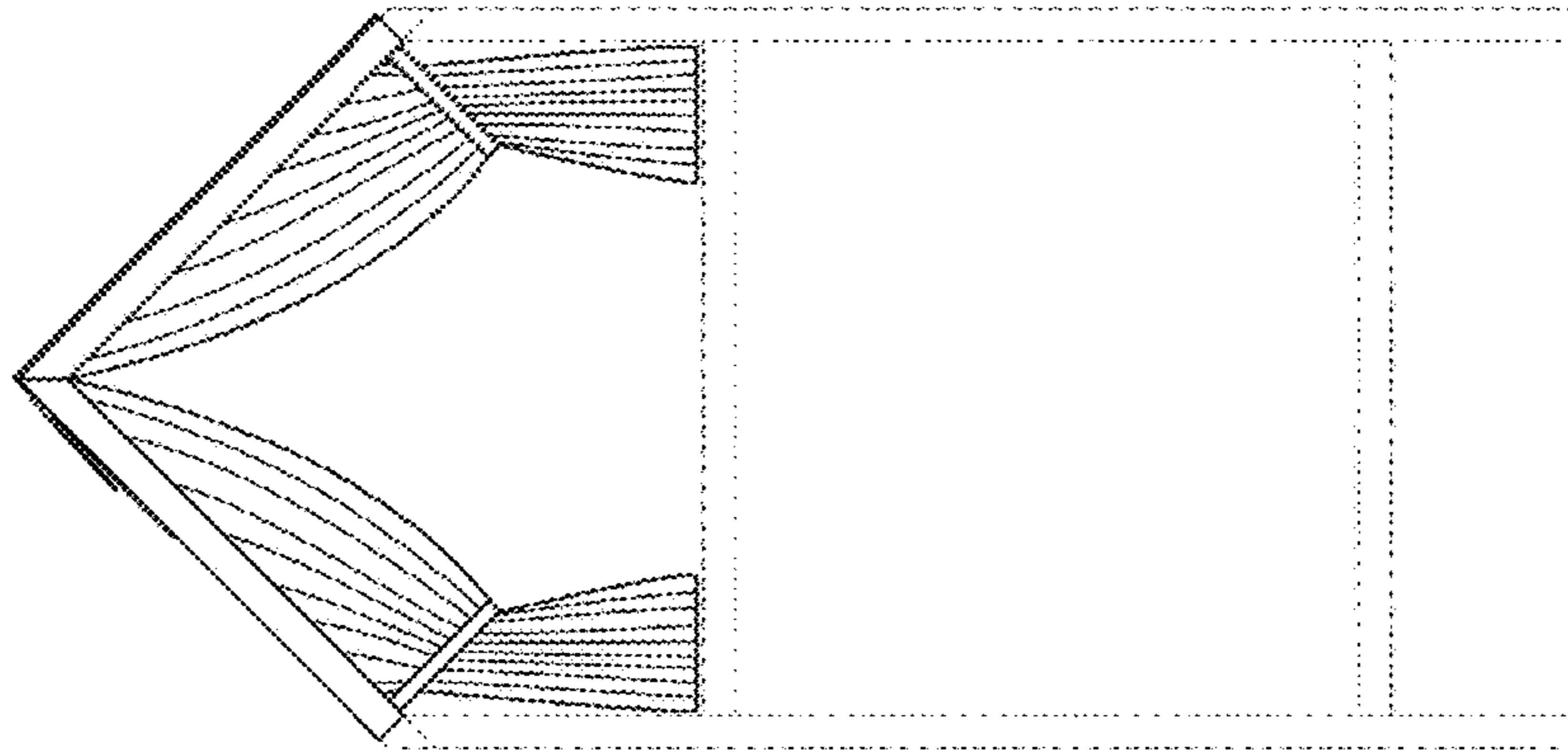

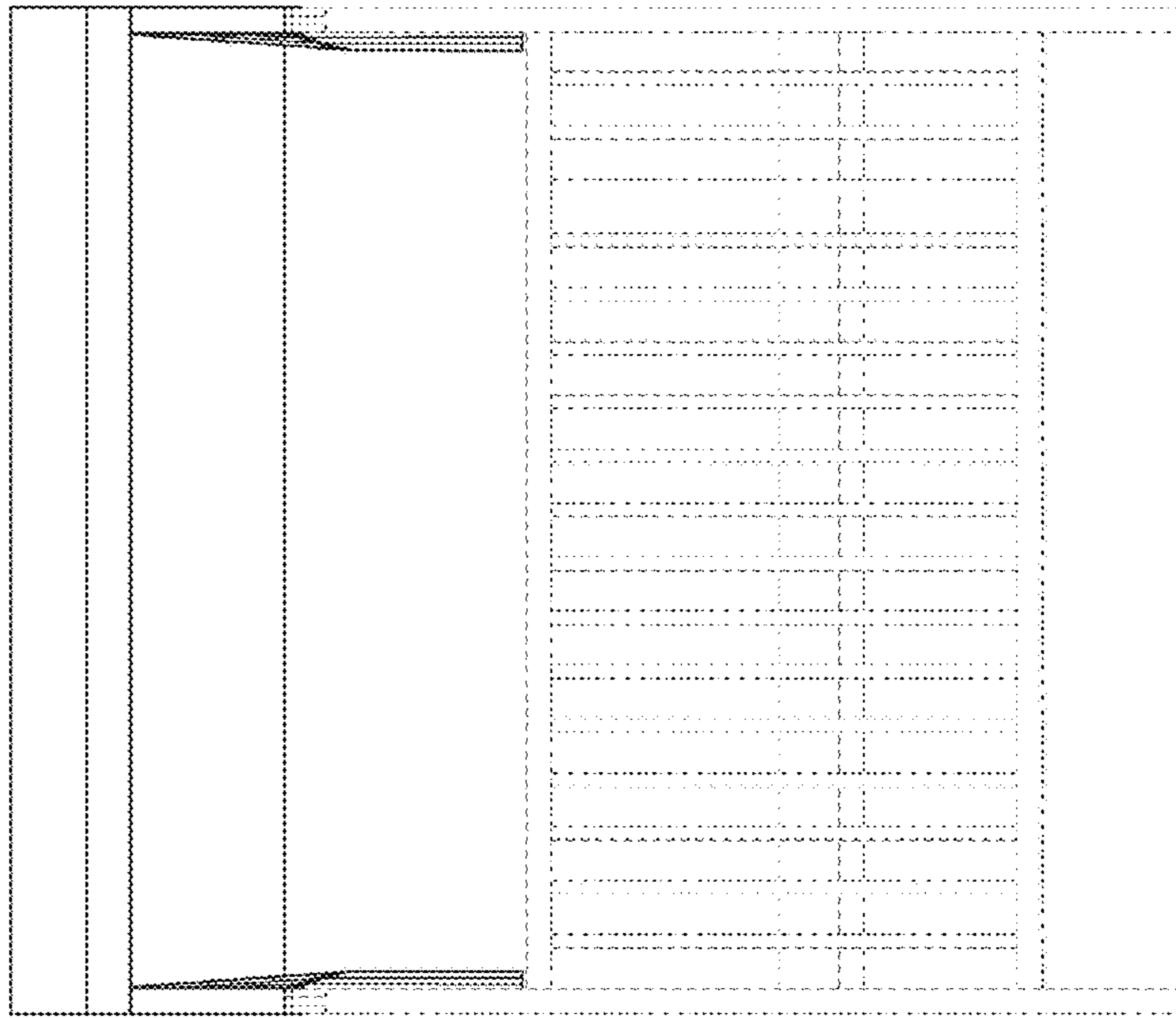

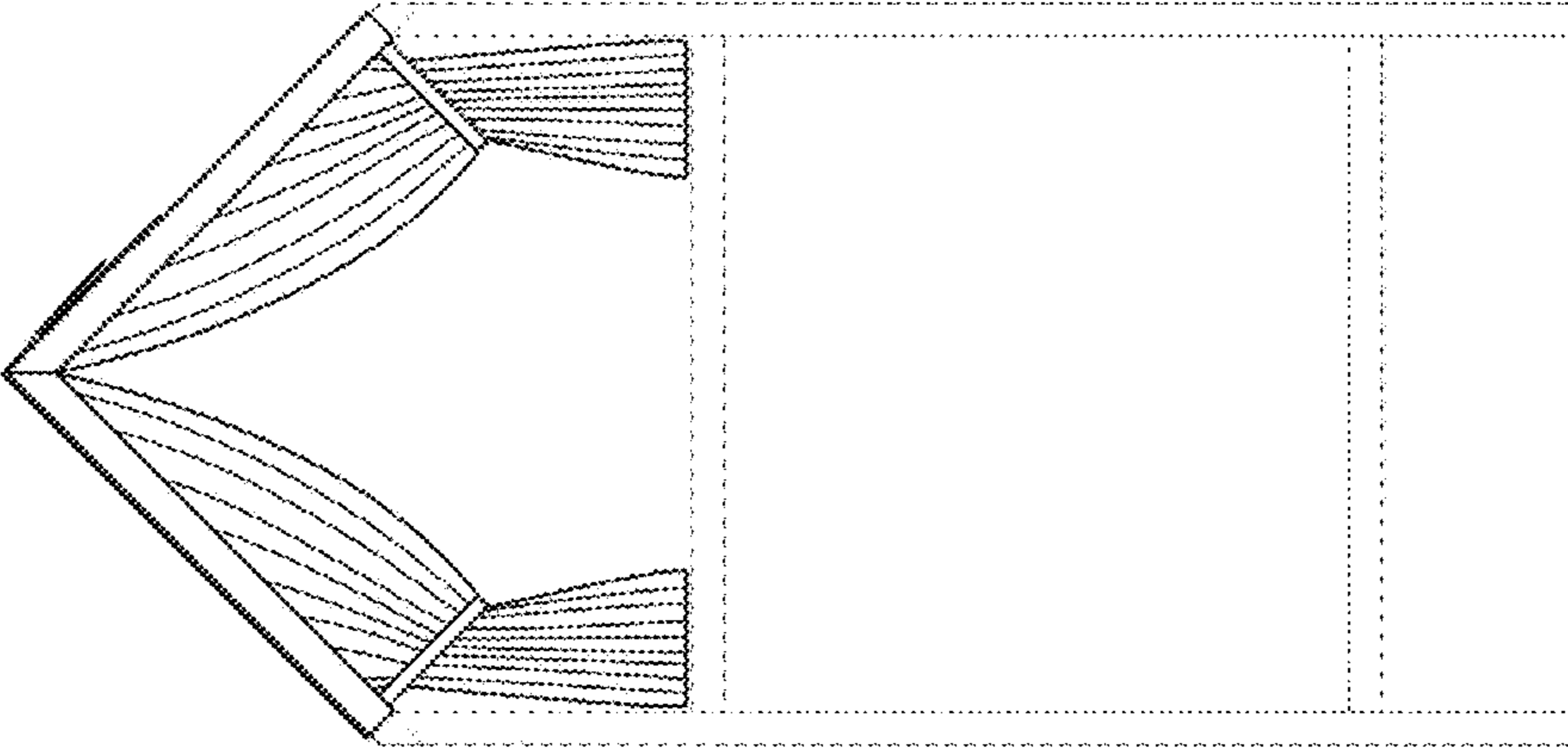
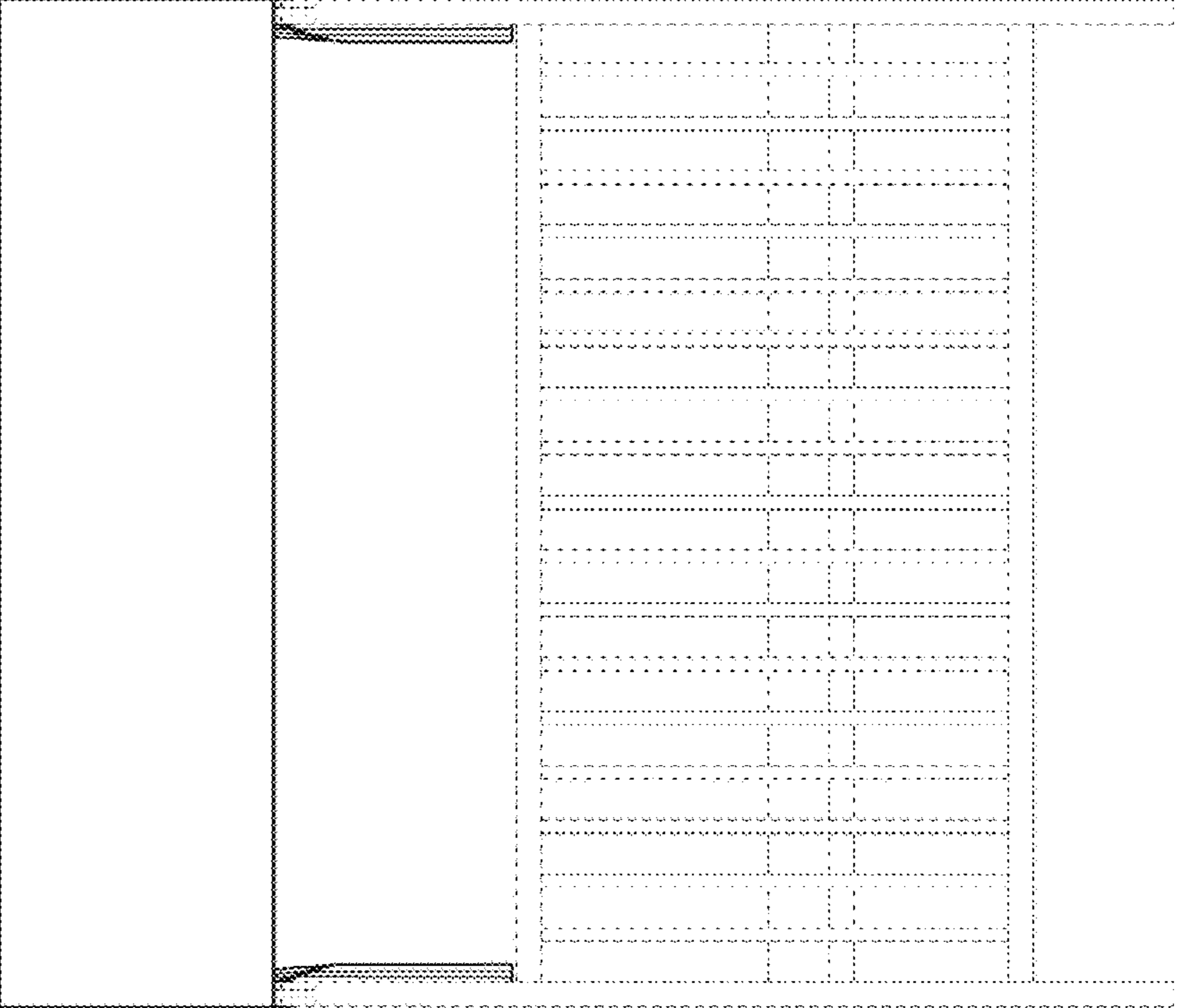

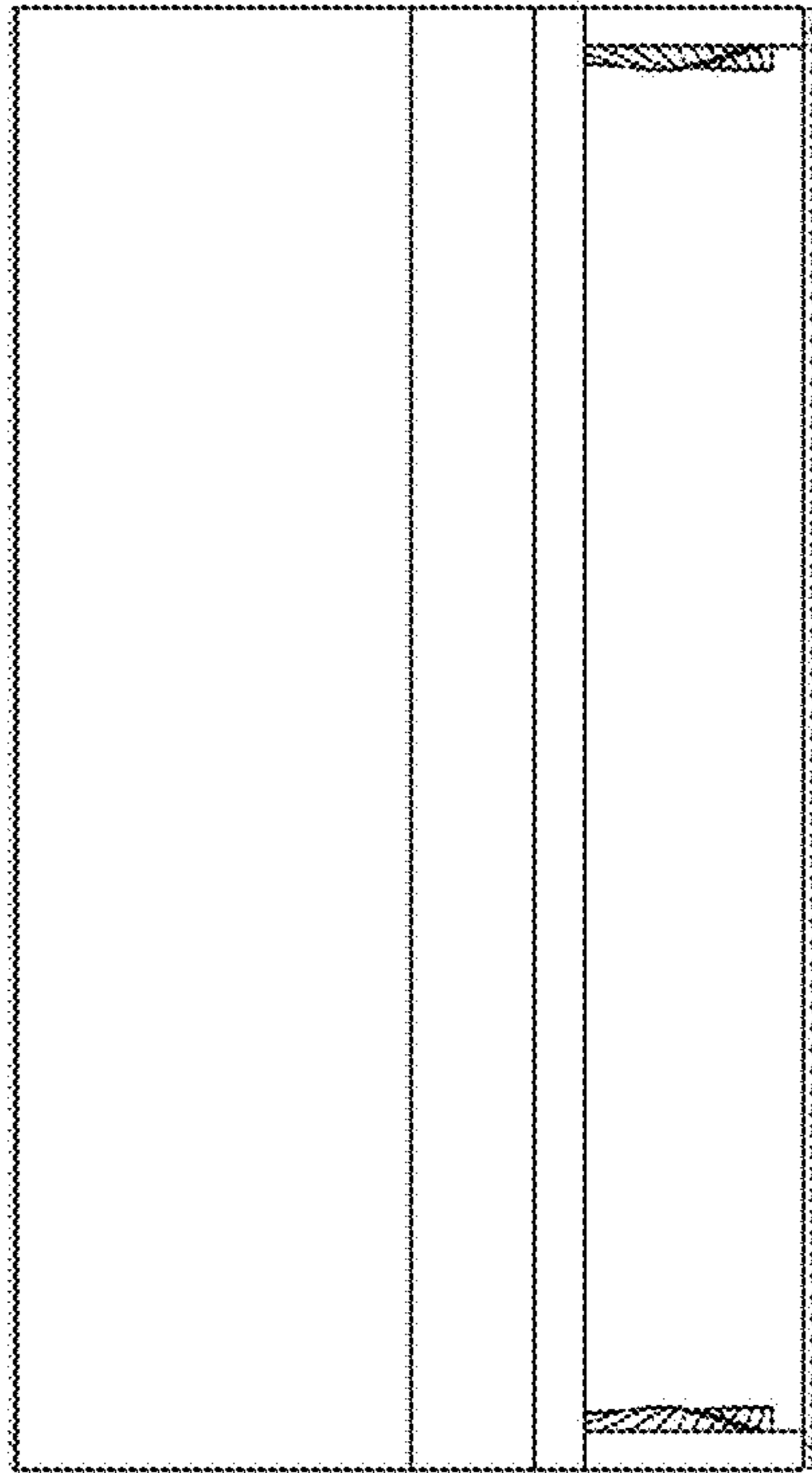

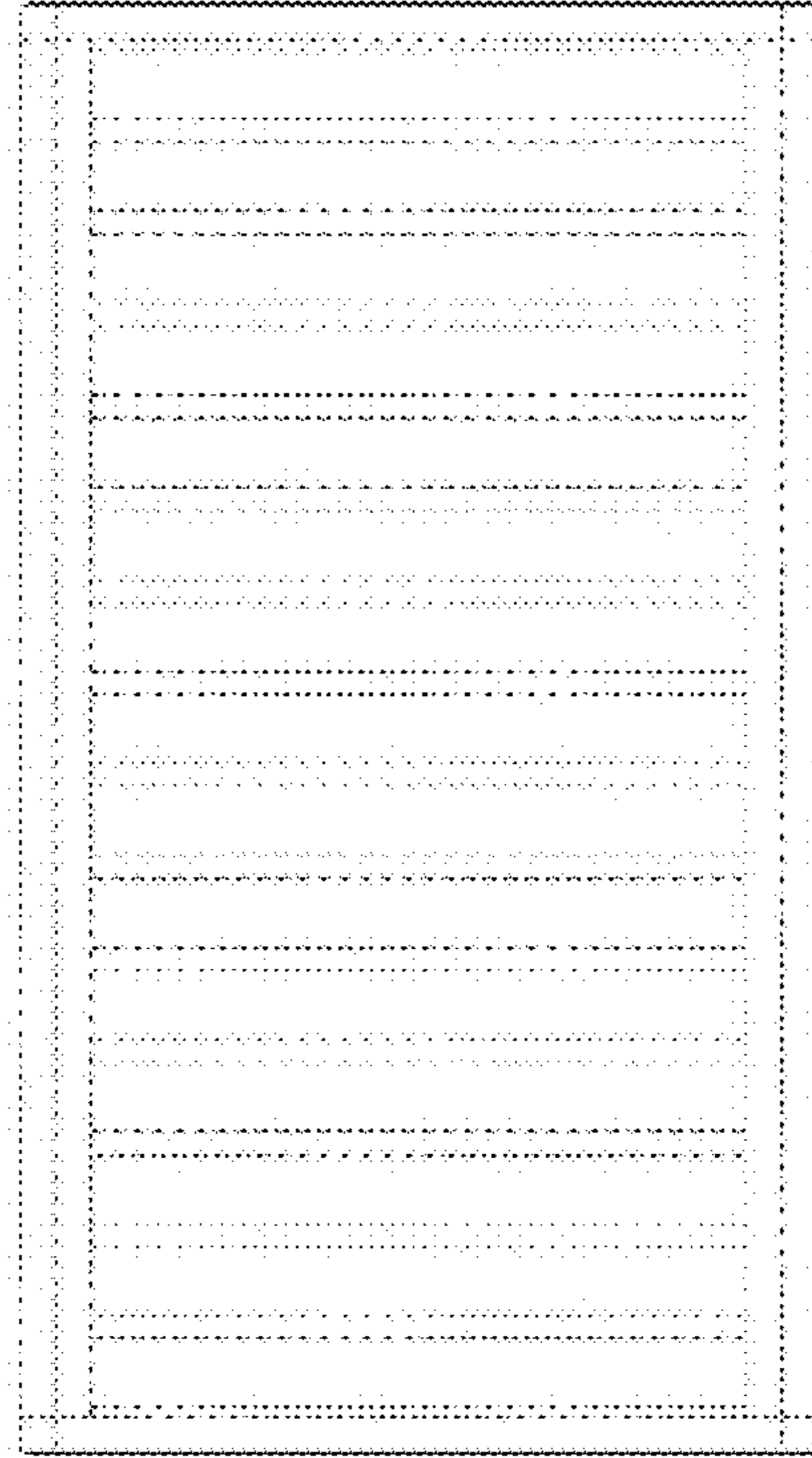
