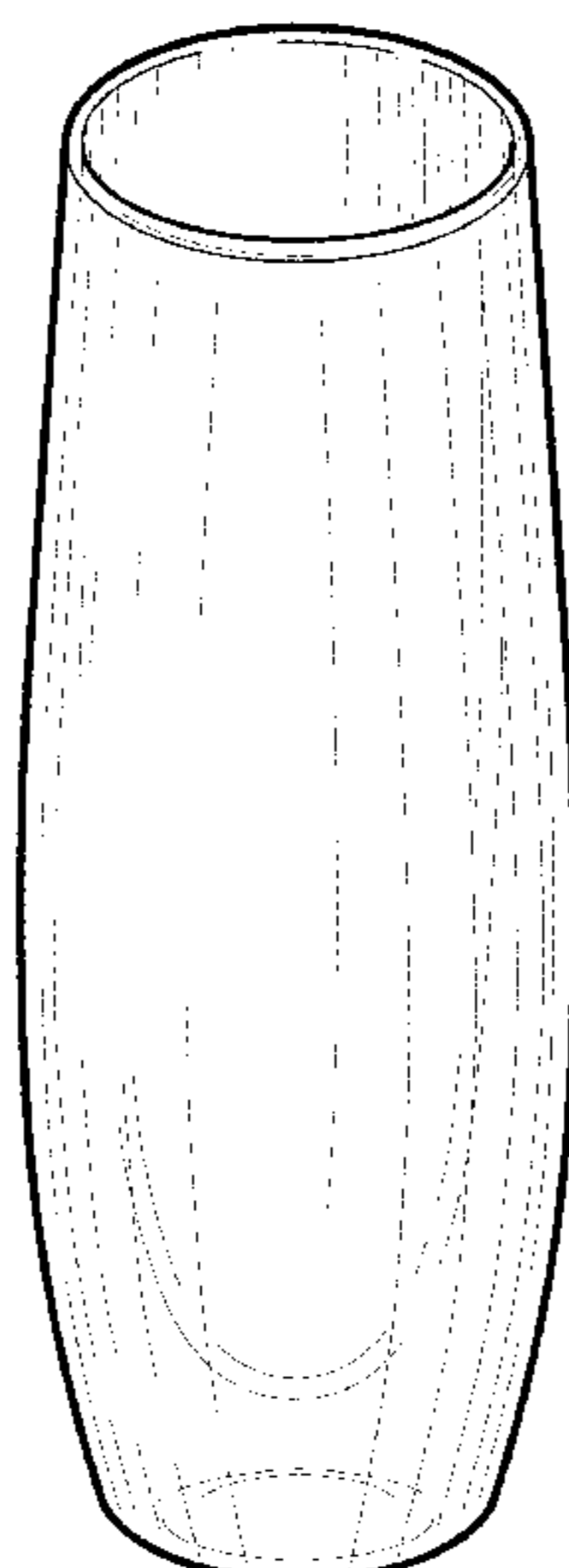
(57) **CLAIM**

The ornamental design for a champagne flute glass, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a champagne flute glass showing my new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a right side elevational view thereof, the left side being a mirror image thereof;
FIG. 4 is a front elevational view thereof, the rear being a mirror image thereof;
FIG. 5 is a bottom plan view thereof; and,
FIG. 6 is a cross-sectional view thereof, taken along section line 6-6 of FIG. 2.

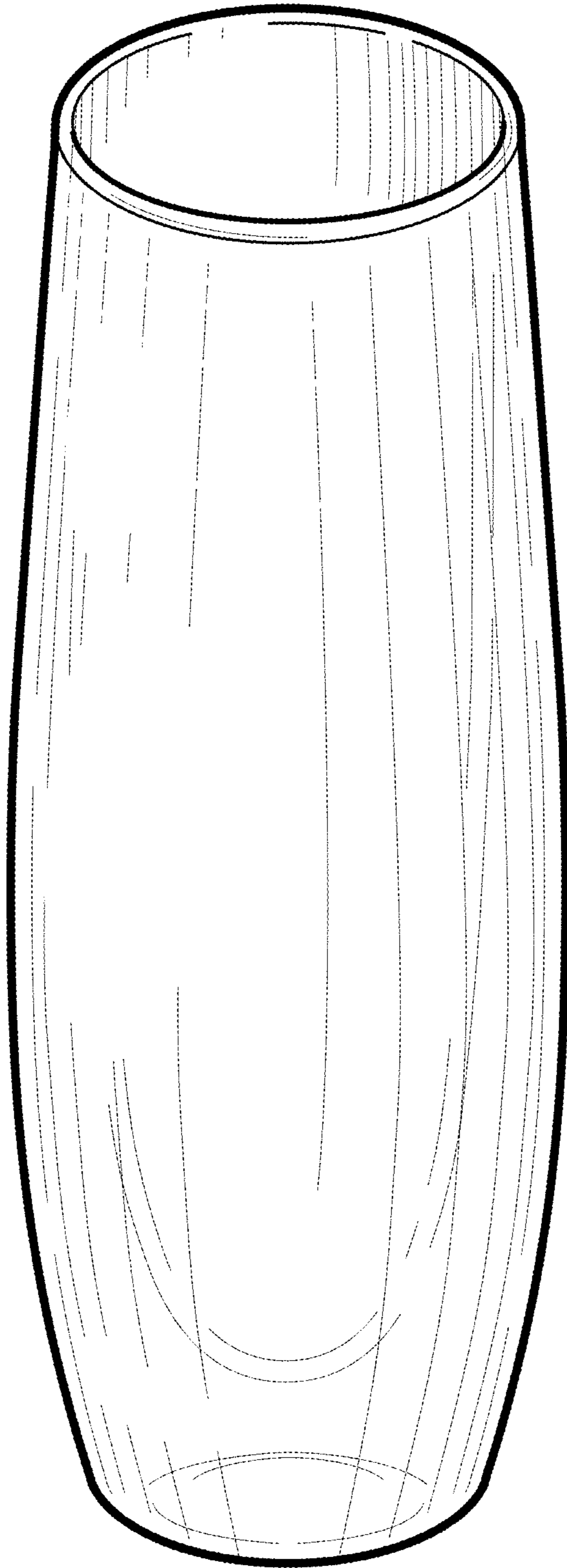

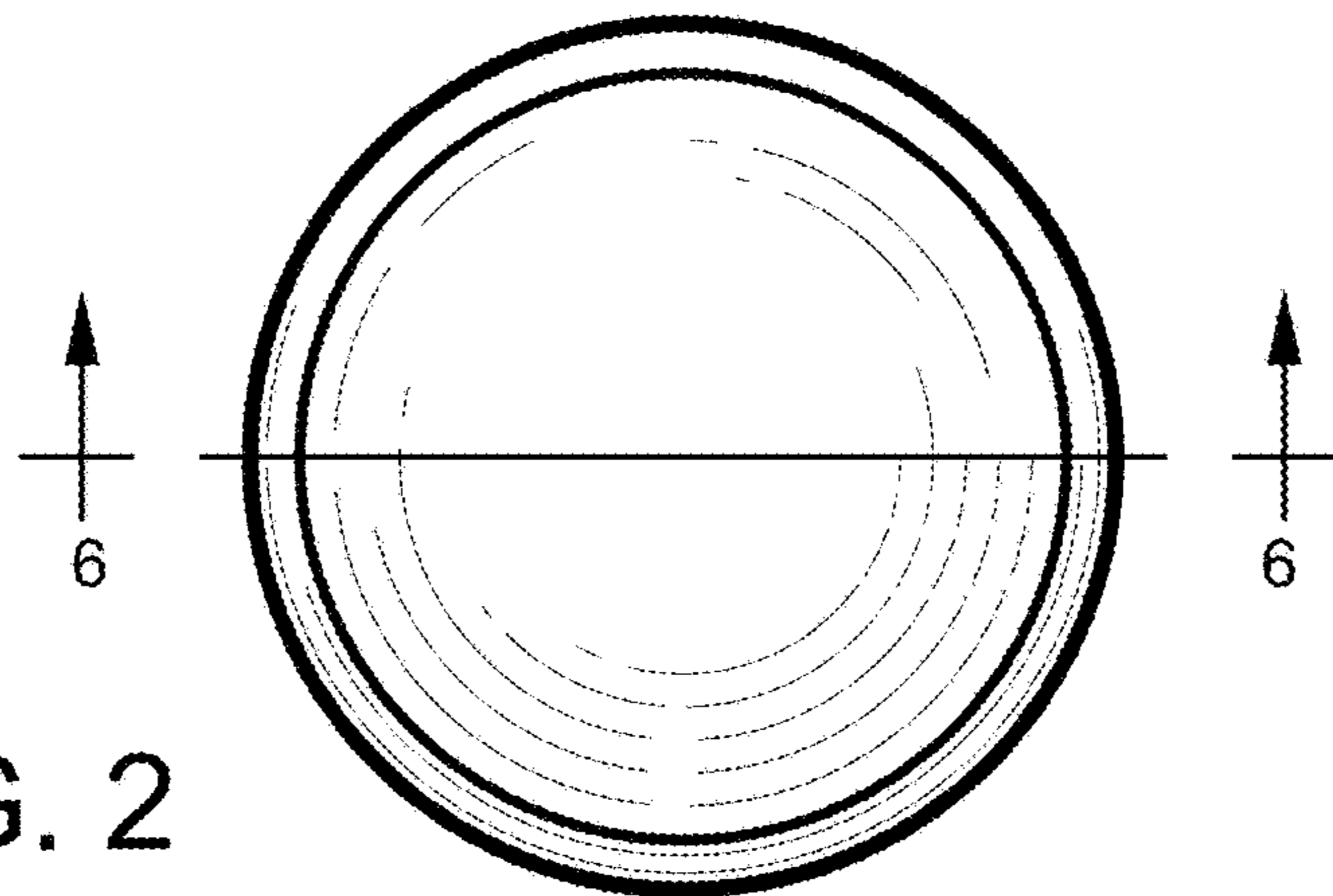

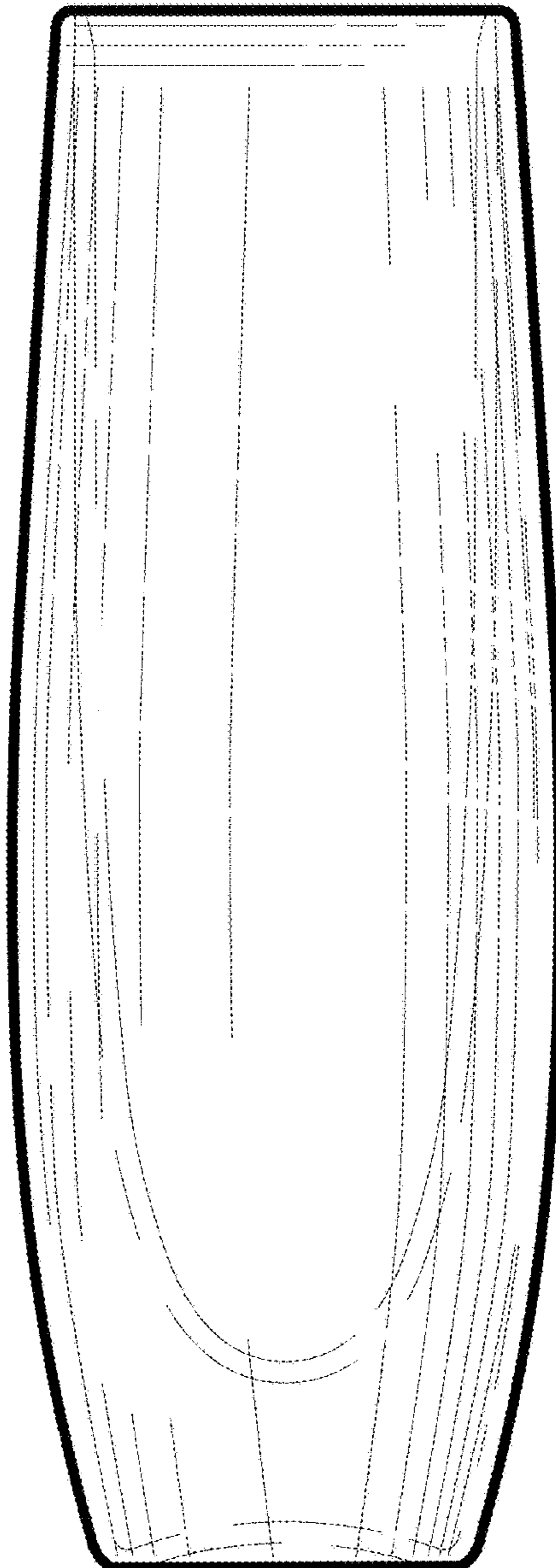

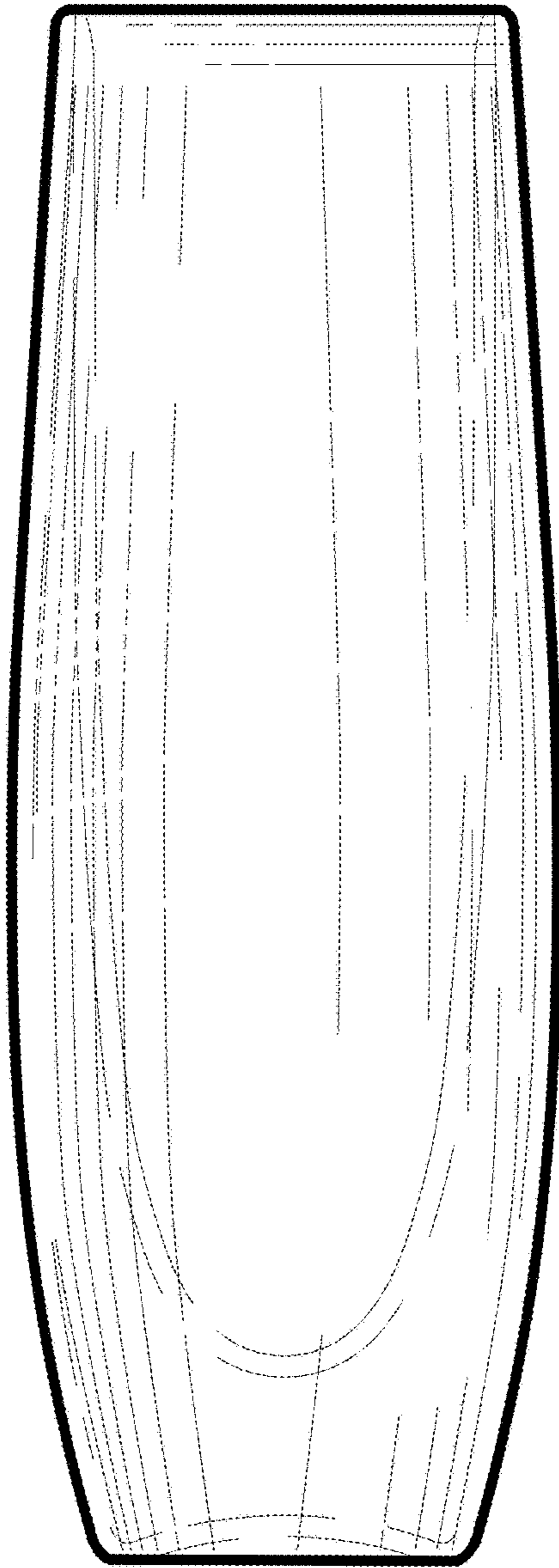

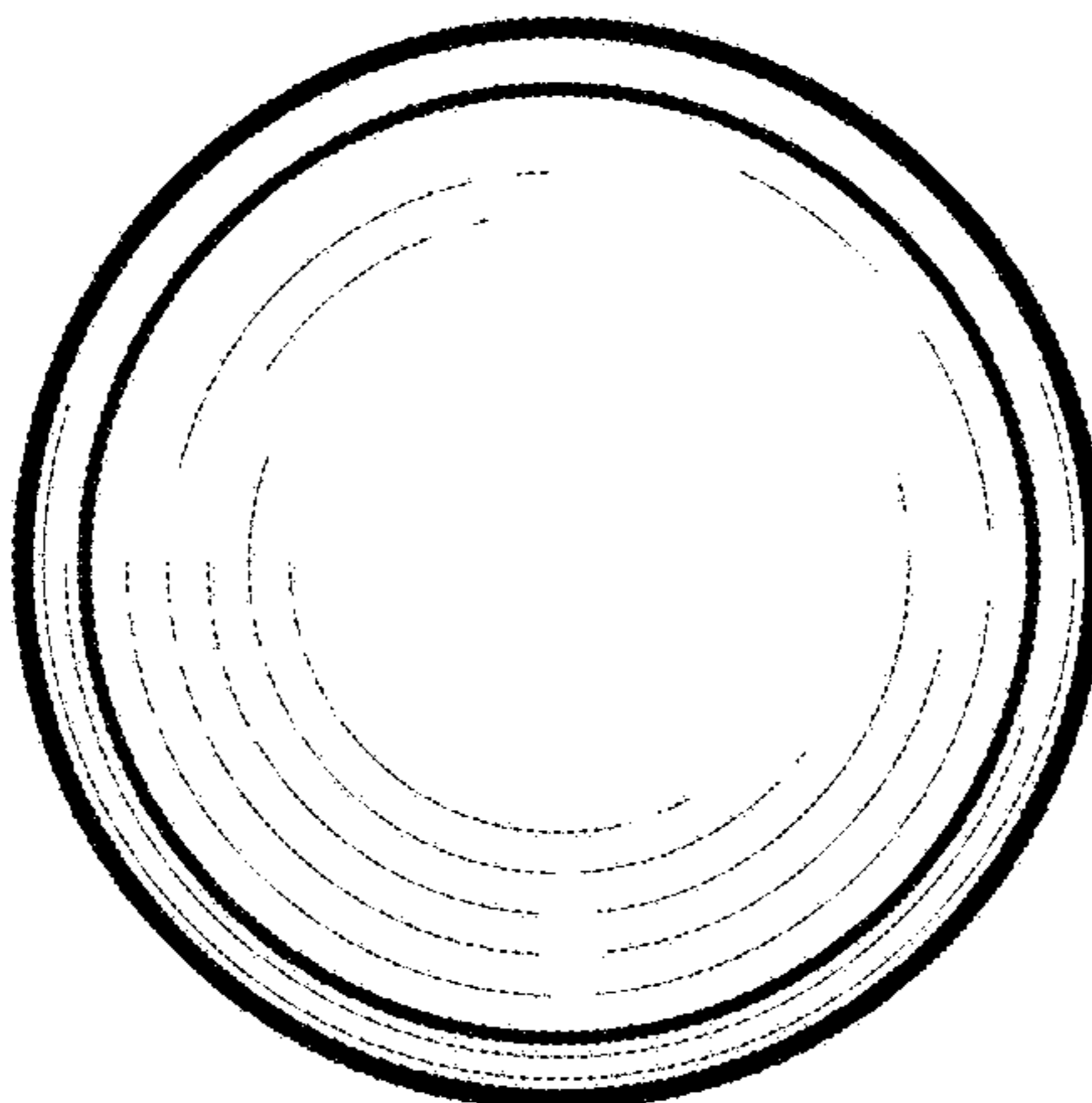

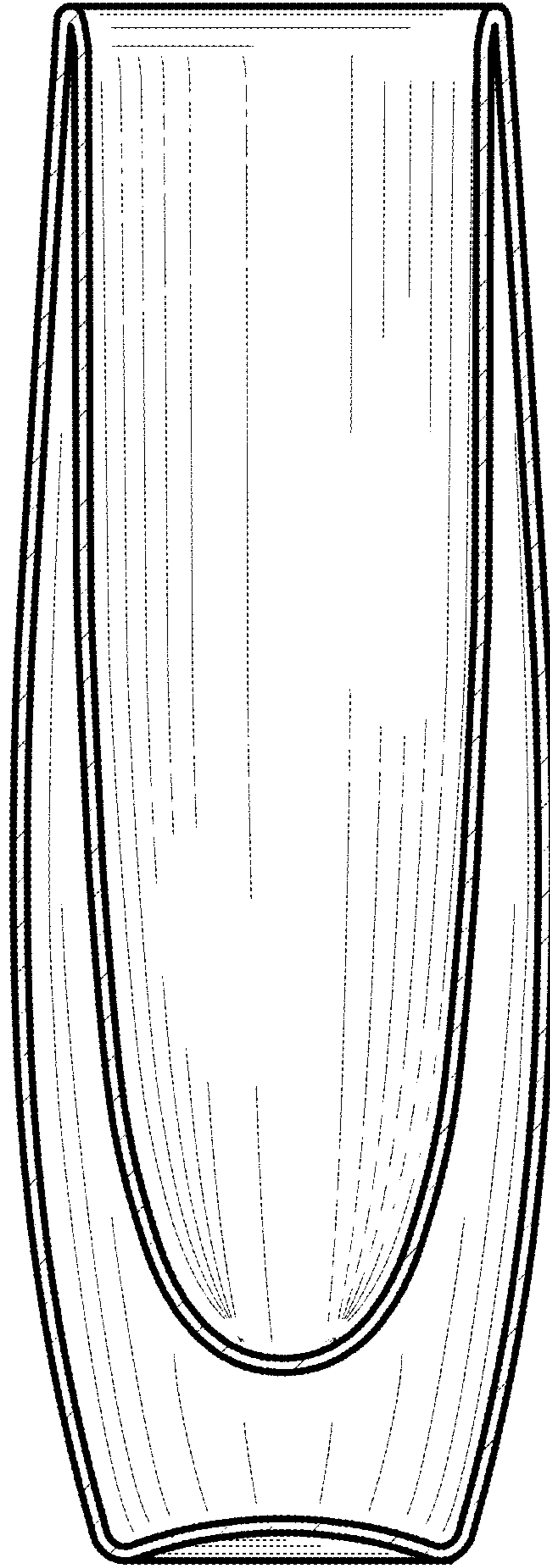
