FIG. 9 is a front view thereof.

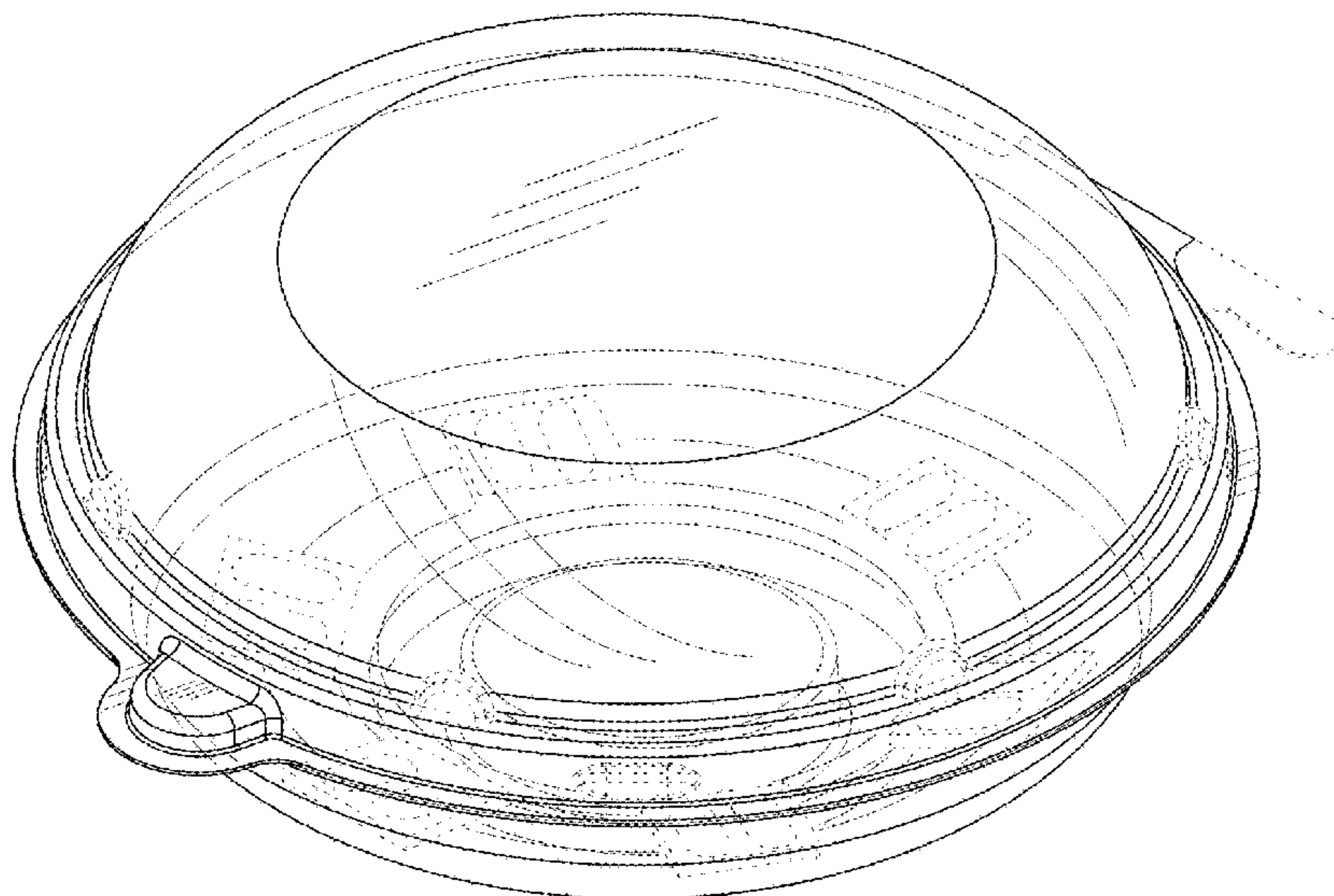
FIG. 10 is a rear view thereof.

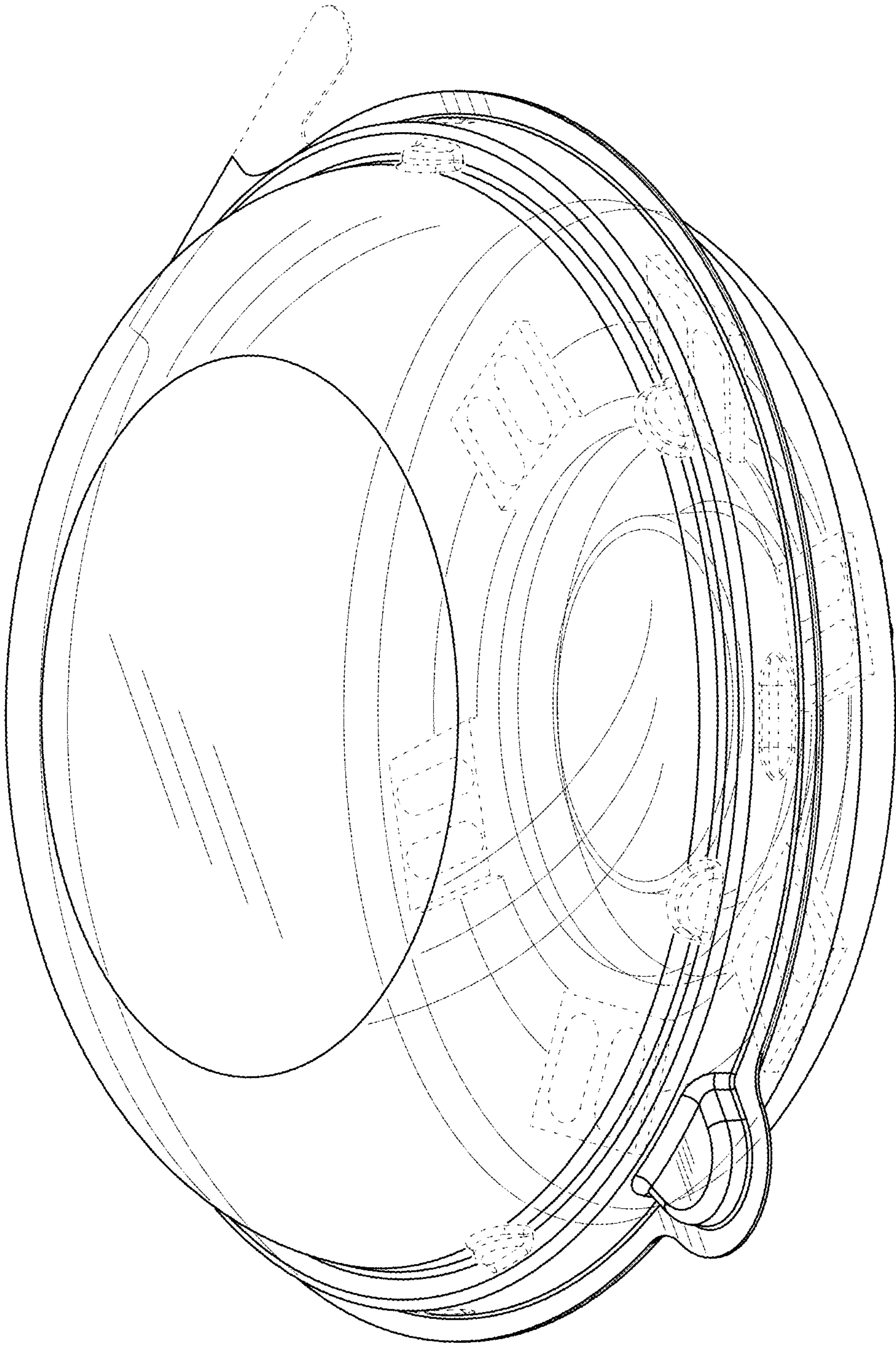

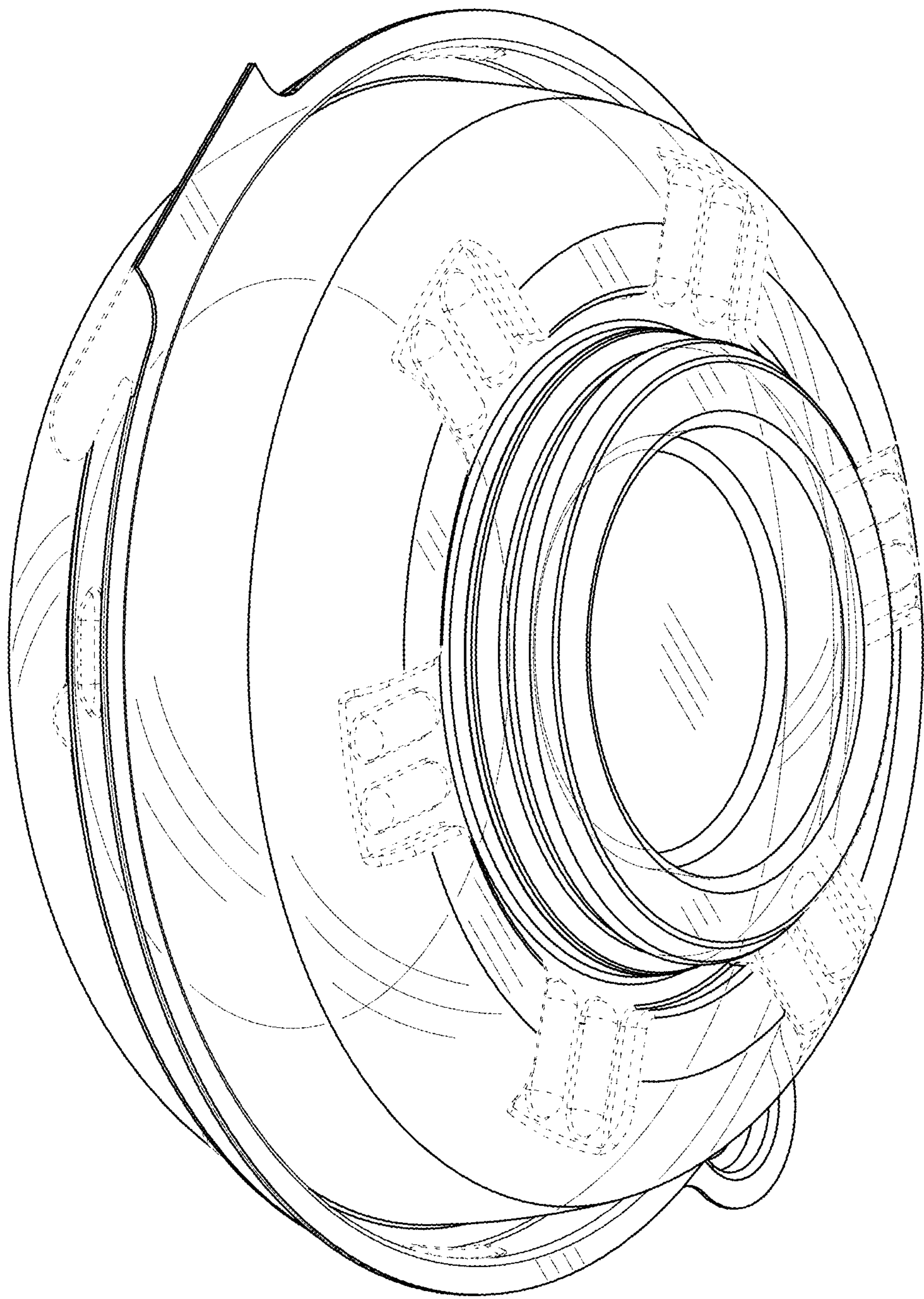

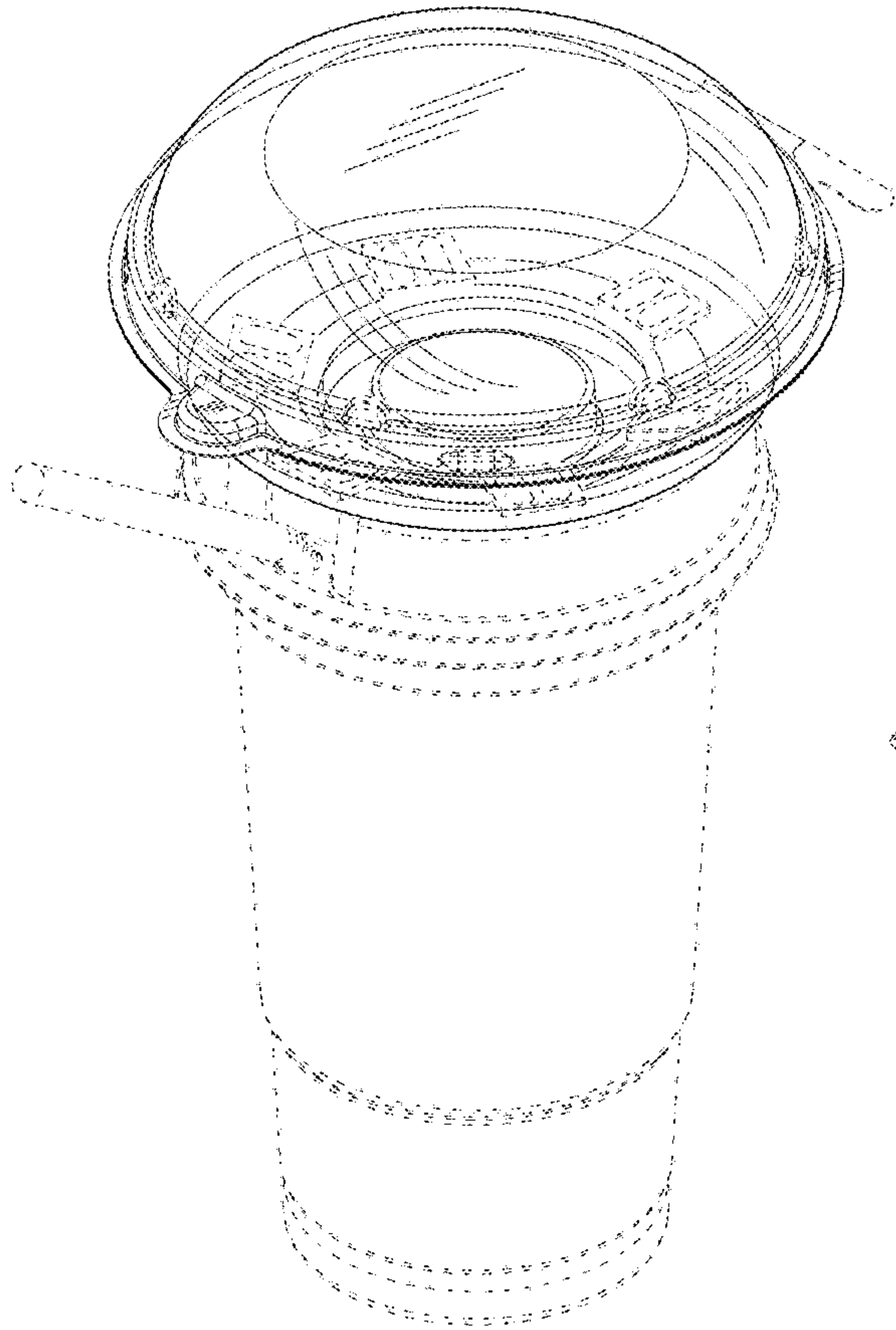

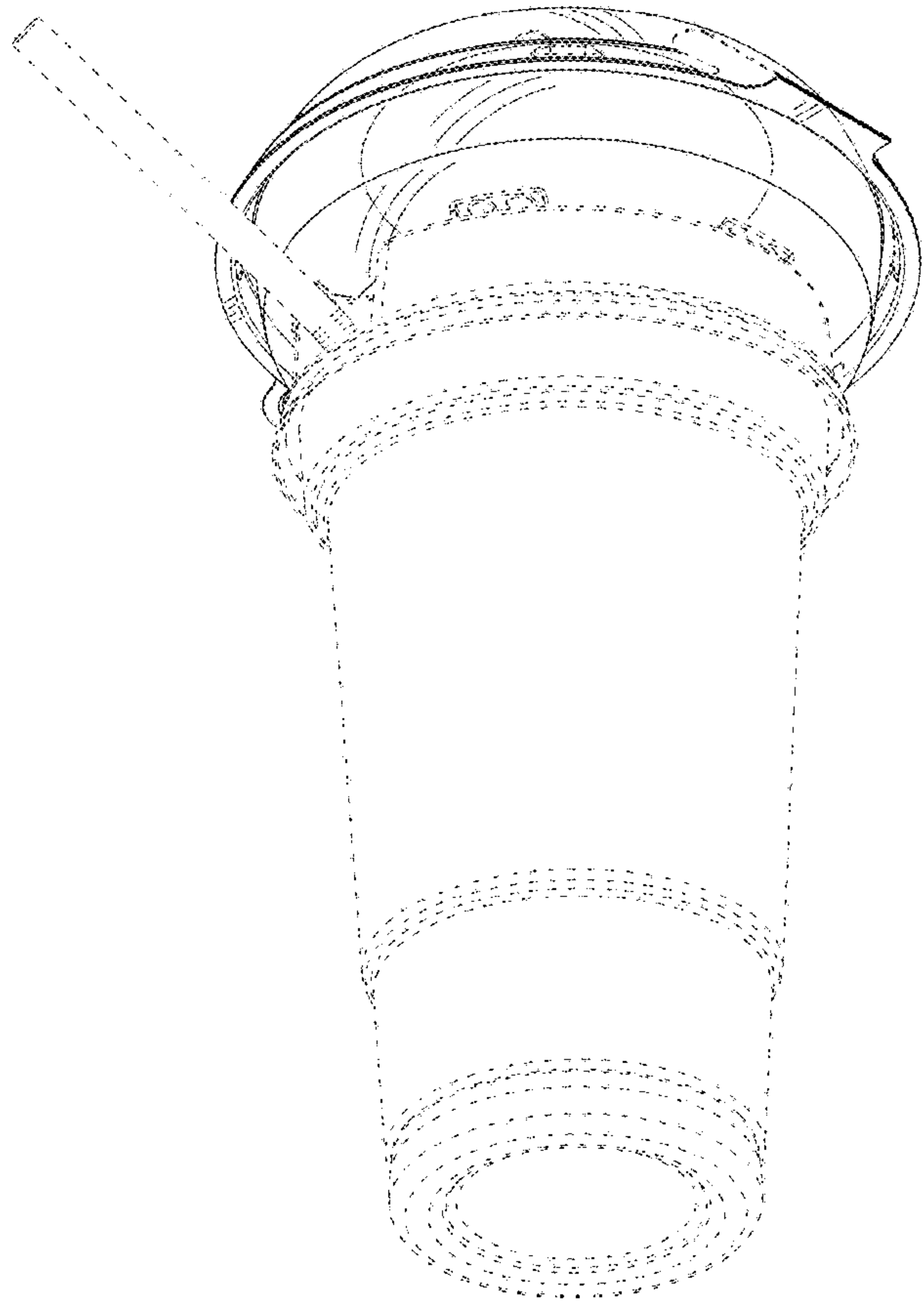

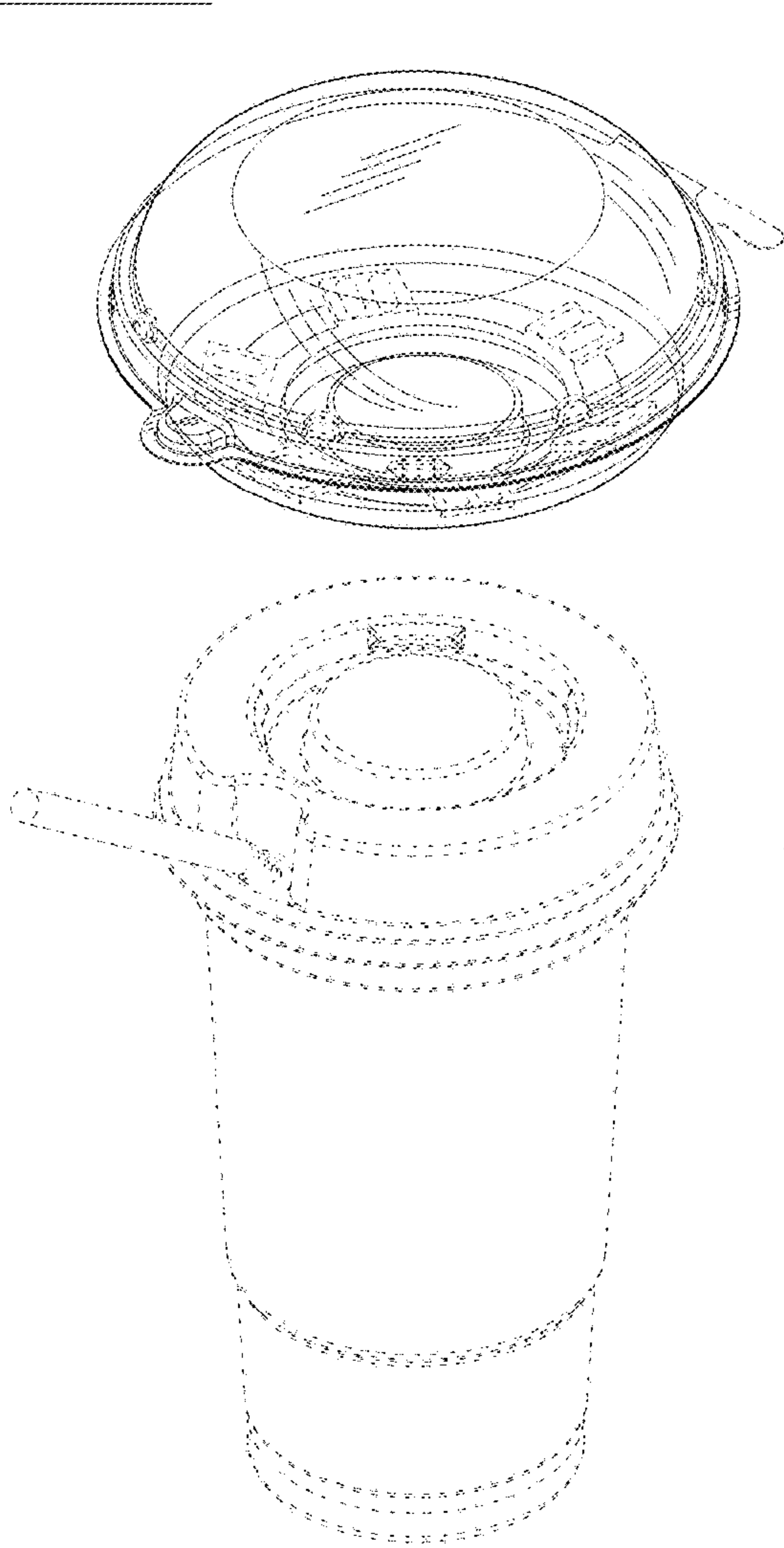

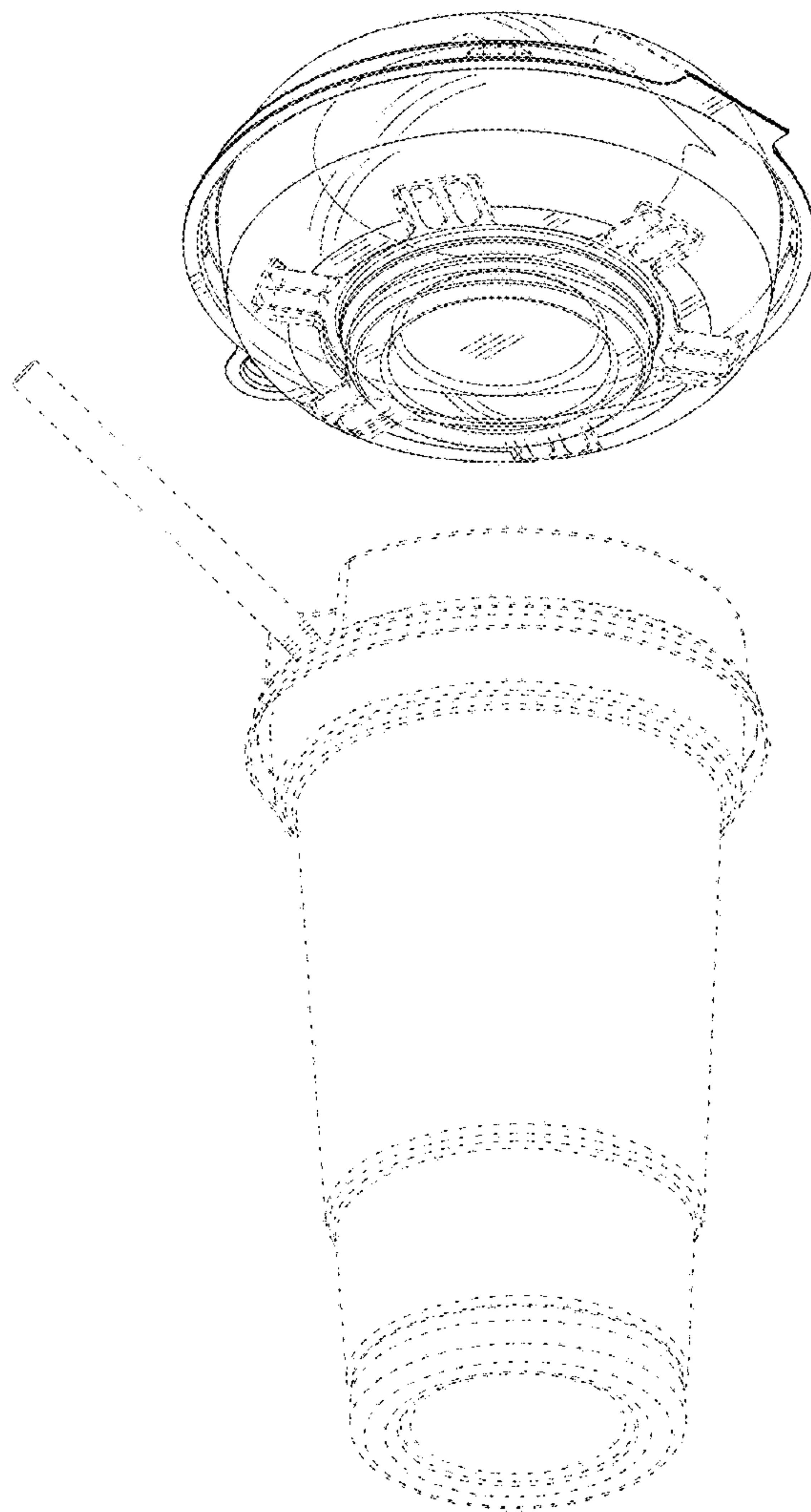

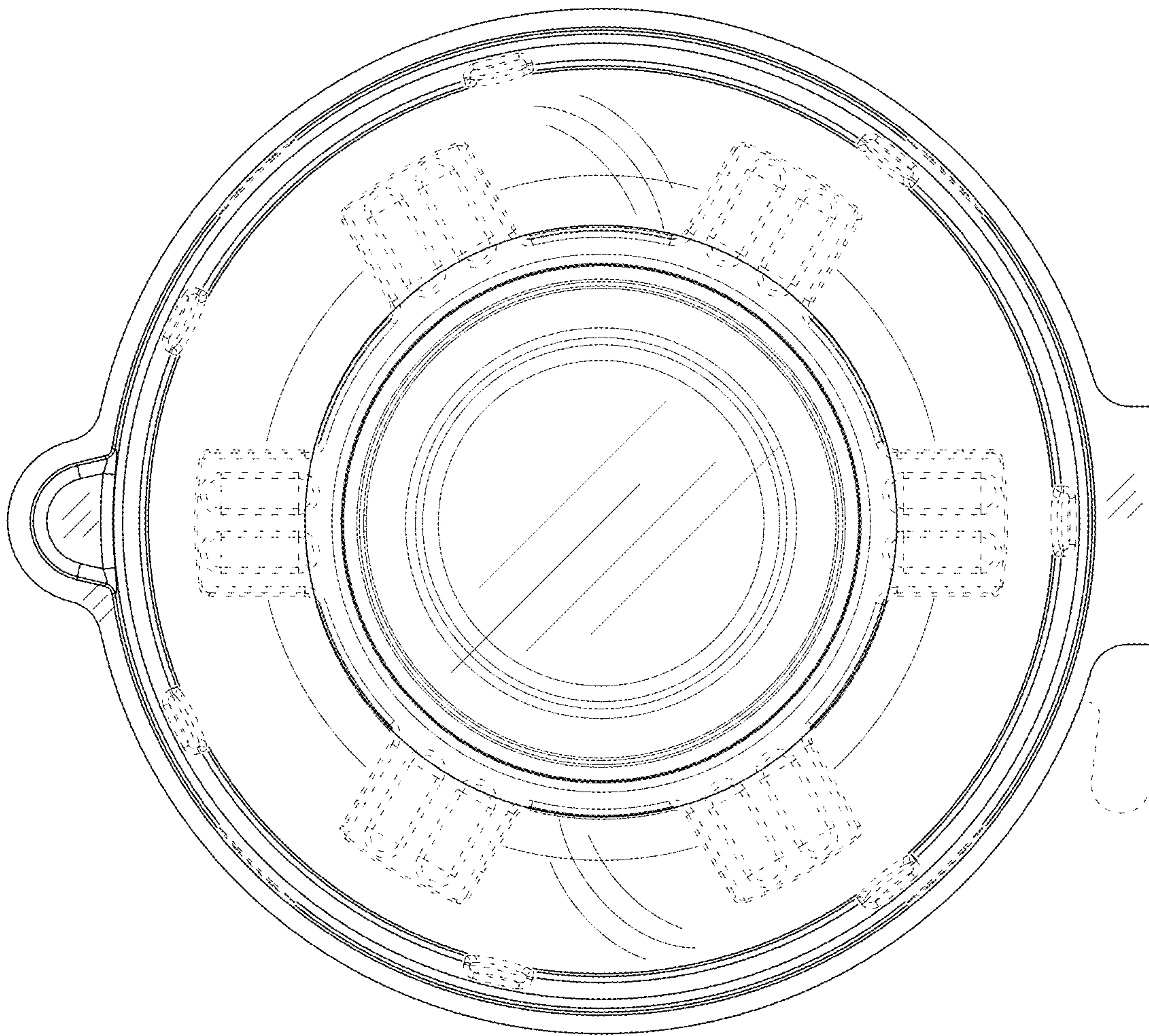

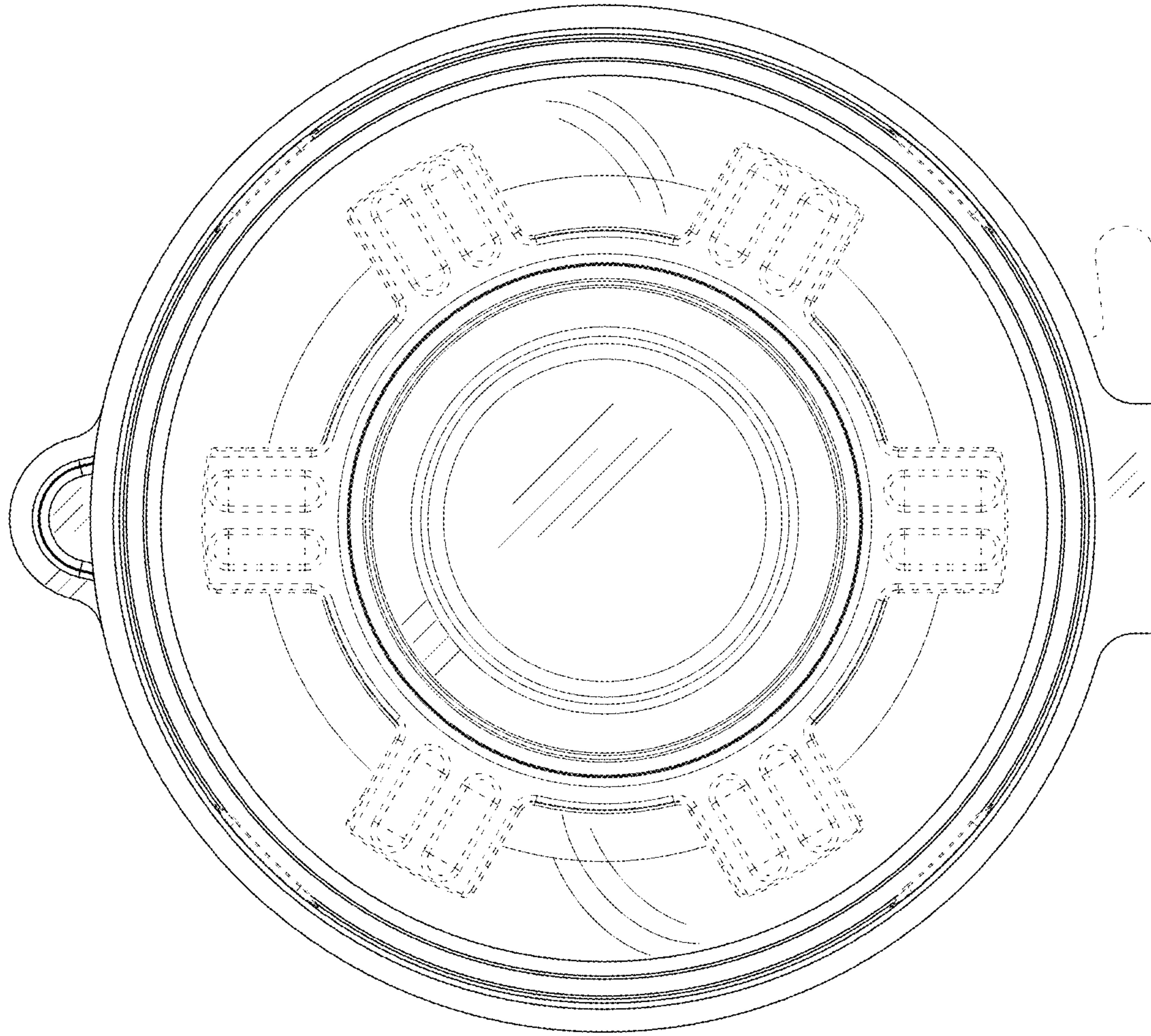

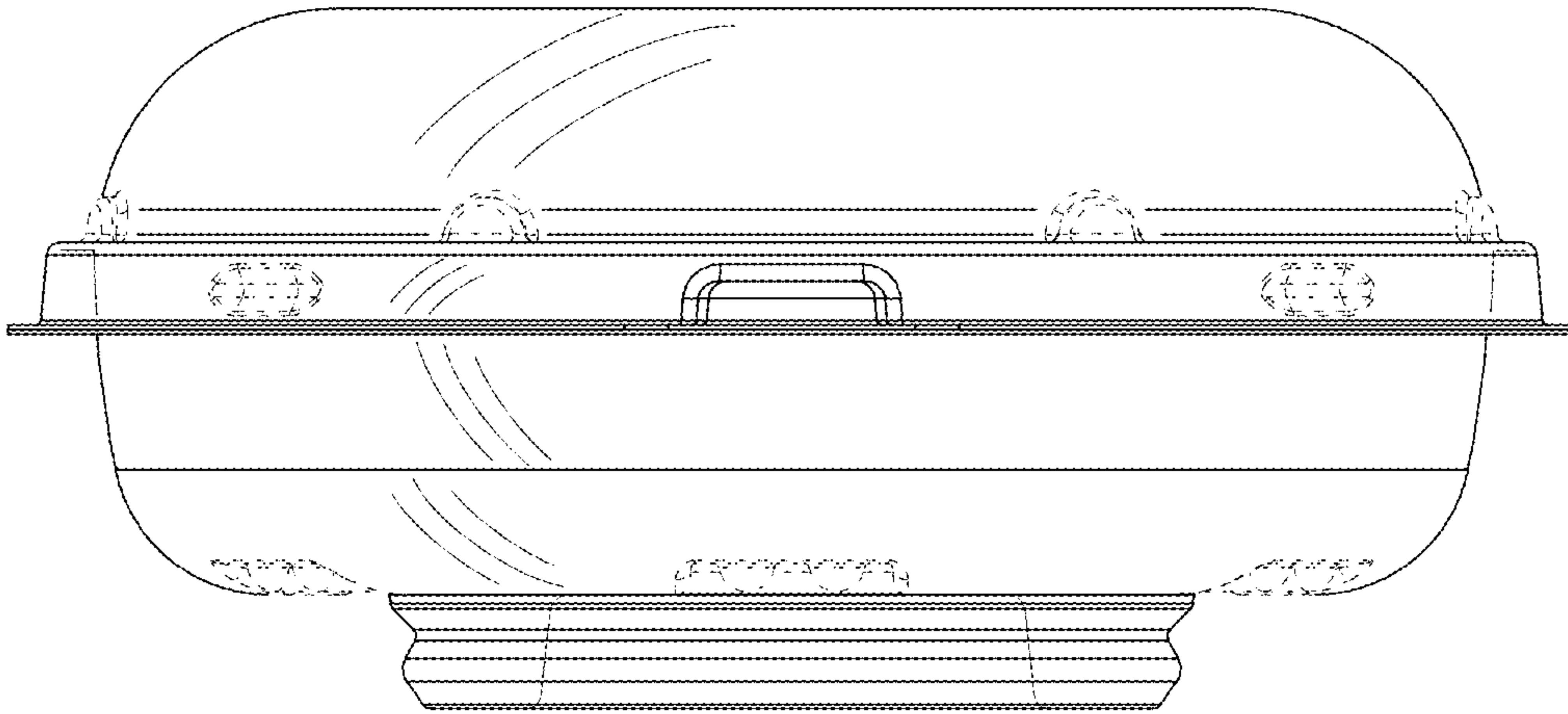

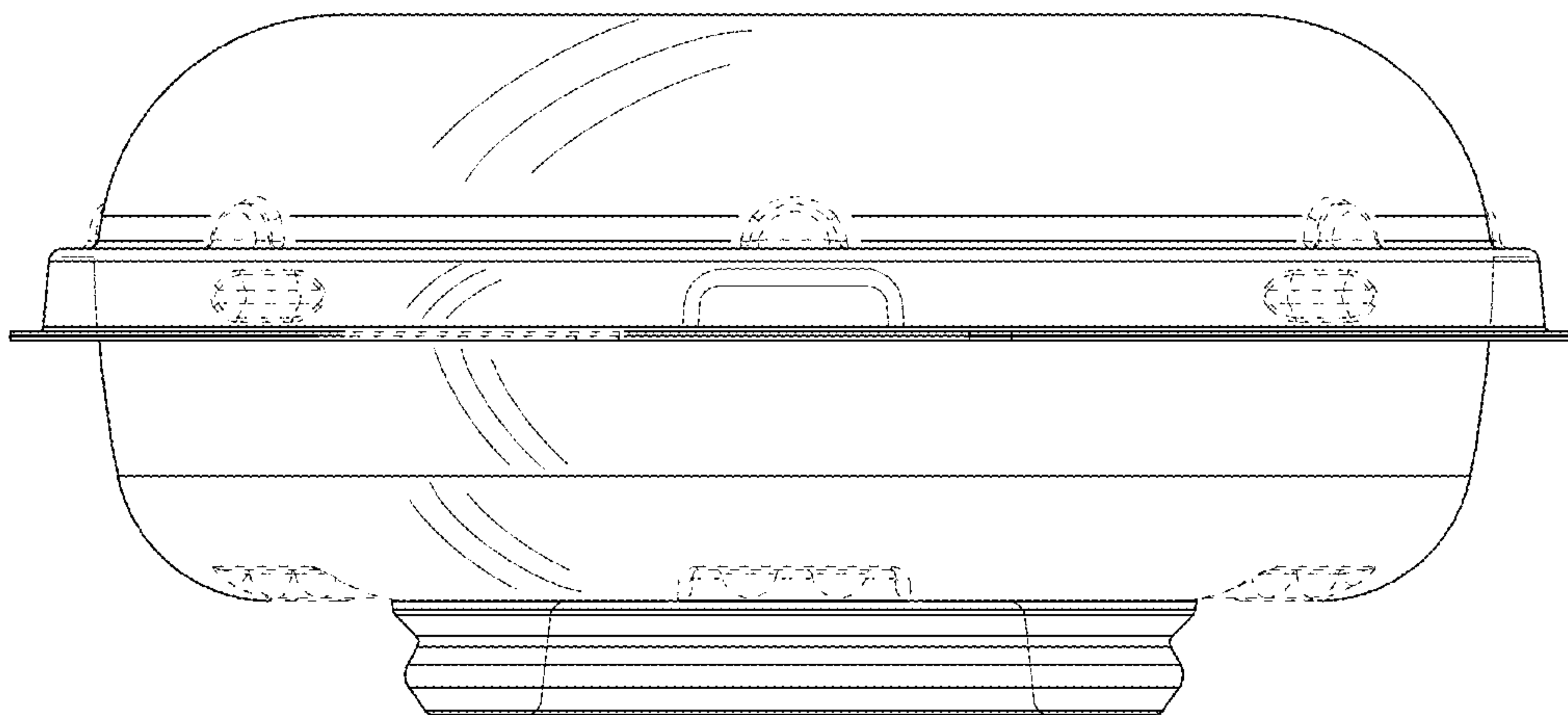

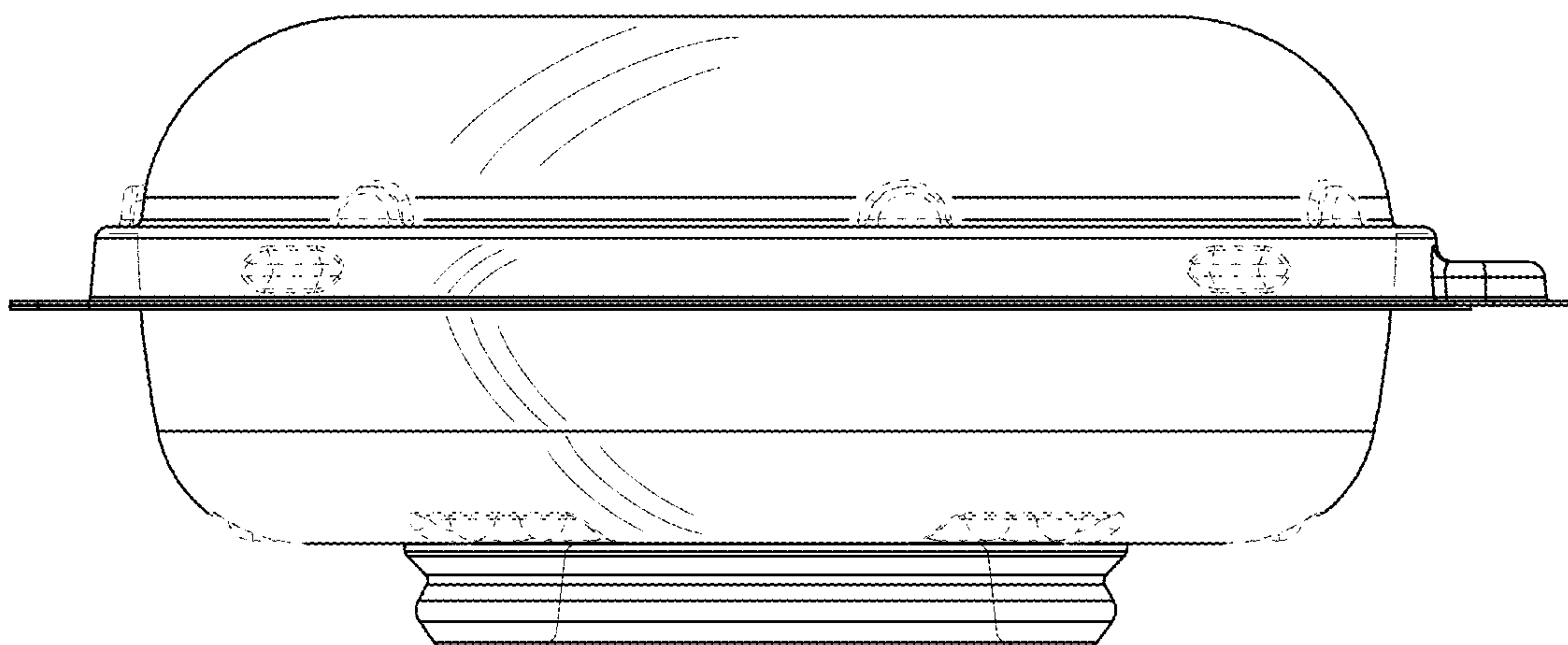

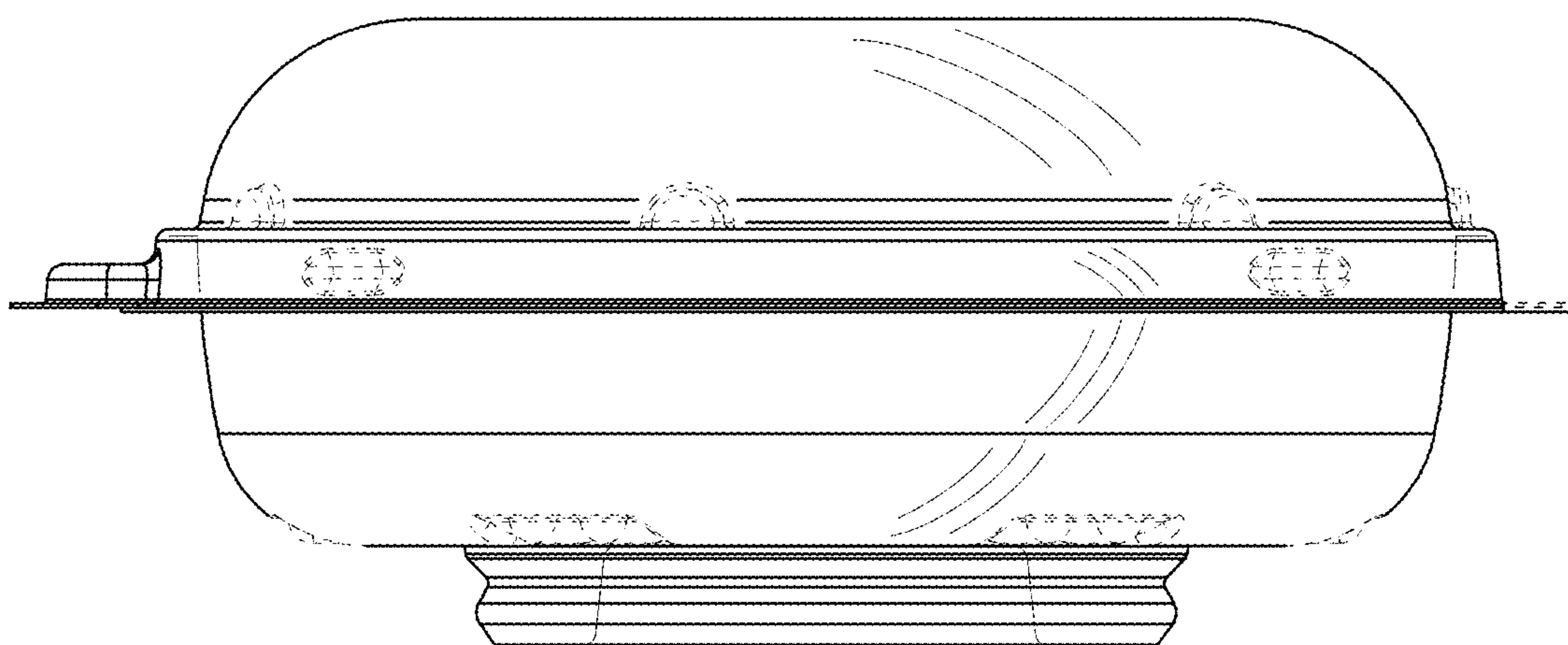
